Composite Fermions in M odulated Structures: Transport and Surface A coustic W aves

M otivated by a recent experiment of W illett et al. \mathbb{P} hys. Rev. Lett. 78, 4478 (1997)], we employ sem iclassical composite-ferm ion theory to study the e ect of a periodic density m odulation on a quantum H all system near Landau level lling factor = 1=2. We show that even a weak density m odulation leads to dram atic changes in surface-acoustic-wave (SAW) propagation, and propose an explanation for several key features of the experimental observations. We predict that properly arranged dc transport m easurements would show a structure similar to that seen in SAW measurements.

Experiments on surface acoustic waves (SAW) propagation above a two-dimensional electron gas (2DEG) [1,2] provided strong support for the composite-ferm ion approach to the compressible quantum H all state near lling factor = 1=2 [3,4]. Measurements of both absorp-

tion and velocity shift of SAW 's probe the conductivity of the 2D EG at nite wavevector and frequency [1]. In this way, W illett et al. [2] observed that the absorption (velocity shift) of the SAW as function of lling factor exhibits a maximum (m inimum) at = 1=2, im plying a maximum in the conductivity. Exactly at = 1=2, the conductivity is found to be linear in the wavevector for wavelengths sm aller than the composite-ferm ion mean free path, in agreem ent with composite-ferm ion theory.

Recently, W illett et al. observed a striking e ect in SAW measurements near = 1=2 on samples whose electronic density n(r) = n + n(x) is periodically modulated in one direction, say \hat{x} [5]. When the SAW propagates in the \hat{y} {direction, a rather weak density modulation (n=n 0.05) turns the minimum in the velocity shift at = 1=2 into a suprisingly robust maximum : Unlike the former, the magnitude and width of the latter are alm ost independent of the SAW wavevector q and the modulation period a (for su ciently small a). In contrast, the modulation has no signi cant e ect when the SAW propagates in the \hat{x} direction.

In this Letter, we analyze dc transport, SAW velocity shift and SAW absorption in modulated system snear = 1=2. We employ sem iclassical composite-ferm ion theory [3,6], which allows one to derive a Boltzm ann equation for composite ferm ions (CF's). Within this theory, one attaches two Chem-Simons ux quanta to each electron. The resulting quasi-particles { CF's { experience an e ectively reduced magnetic eld, B(r) = B (2h=e)n (r) so that a density m odulation leads to a m odulated magnetic eld B (r). Thus, experim ents on m odulated structures test a fundam ental aspect of the theory.

We rst consider dc transport in modulated systems with very large modulation period a. For such systems the current J (r) is related to the electric eld E (r) by a local resistivity tensor (x). The measurable quantity, however, is the macroscopic resistivity "ac, relating the spatially averaged current and eld. We now show that the modulation makes "ac anisotropic although locally xx = yy. The local resistivity is a function of the local density n(x) and can be written as (x) + (x), has zero spatial average. [Here and below, bars where denote quantities in the unmodulated system]. We assum e a strong m agnetic eld so that xy xx; yy, and neglect the diagonal elements of . Since the density depends only on x, the current, electric eld, and are all independent of y. Conservation of current then im plies that J_x is uniform in space. From Maxwell's equations, wehaver E = 0, which implies $v_X J_X + v_V J_V = 0$. Here, J_v is the modulated part of the current in the y direction, whose spatial average is zero. Thus [7], while $_{yy}^{mac} = yy$,

where $n_{rm s}$ is the root-m ean-square value of n, the deviation of the local electron density from its m ean value n, and we have de ned by,

In a naive D rude picture = $_{xy}$ = $_{xx}$ 1. In the quantum Hall regime, empirical observations [8] that $_{xx}$ is proportional to the derivative of $_{xy}$ with respect to the logarithm of the magnetic eld (\resistivity law"), together with the observation that $_{xy}$ is primarily determined by the lling factor , suggest that the coe cient

is in fact a constant, independent of the applied m agnetic eld, and weakly temperature dependent, of order 20 orm one for high-m obility sam ples. Thus, a weak density m odulation, while having no e ect on $\frac{m}{yy}$, strongly enhances $\frac{m}{xx}$.

An SAW transmitted above a 2DEG gives rise to a \bare" electric eld $E_{q;!}^{SAW}$, parallelto q, due to the piezoelectric e ect in GaAs. In unmodulated systems, the

screening response of the 2DEG leads to an absorption and a velocity shift of the SAW, proportional to the im aginary and real parts, respectively, of (1 + i) = m, where is the electronic conductivity at wavevector q and frequency $! = v_s q$ (v_s being the sound velocity), is the direction of q, and $m = v_s=2$, with the appropriate background dielectric constant [1,10]. As custom ary, the velocity shift is given relative to its value for = 1 . One may naively conjecture that in a modulated system should be replaced by mac. Since m ac YY $x_{xx}^{mac} = (x_{yy})^2$, such a conjecture (to be partially veried below) predicts a modulation { induced suppression of velocity shift when q_{jj} , and no e ect when q_{jj} . In strong magnetic elds m is large compared to so that a decrease in the velocity shift corresponds to an increase in the absorption and vice versa.

The local approximation obviously applies when the modulation period a is much larger than the composite ferm ion scattering length 'tr. Even when this condition does not hold the resistivity is still local far from = 1=2, where the composite ferm ion cyclotron radius is much smaller than a. Thus, away from = 1=2 we still expect the modulation to enhance the dc resistivity following Eq. (1) and similarly to enhance SAW absorption and suppress the velocity shift. Near = 1=2, however, we expect these e ects to be greatly reduced if a < 'tr, leading to a local minimum in the resistivity and SAW absorption (as a function of magnetic eld), and a maximum in the SAW velocity shift. [9] The detailed analysis we present below con ms these general expectations.

W e now proceed to study SAW propagation without assuming a local resistivity tensor. The electric eld $E_{\alpha:1}^{SAW}$ induces electronic currents and densities in the 2DEG. In linear response, the current J is related to the SAW eld by $E^{SAW} = SAW J$. The matrix SAWdiers from the electronic resistivity, , which relates the current to the total electric eld $E^{SAW} + E^{ind}$ acting on the electrons. The eld E ind due to the induced electronic charge density can be linearly related to the current by $E^{ind} = UJ$ (with U given below). Clearly, $_{SAW} = U \cdot In m \text{ odulated system s, both} \text{ and }_{SAW} \text{ are}$ non-diagonal in m om entum : an electric eld of w avevectorq induces currents and densities of wavevectors q + lp, where l is an integer and $p = 2 \hat{x}=a$. We use the notation $(_{SAW} (q))^{k1}$ for the ratio of the eld E SAW of wavevectorq + kp to an applied current J of wavevectorq + lp. The ! dependence is left im plicit since all quantities are diagonal in !. W ithout modulation, , $_{\scriptscriptstyle SAW}$, and their inverses are diagonal in the modulation indices j; l. By C oulom b's law and the continuity equation, $U^{j1} = i_{j1} \frac{(q + lp)(q + lp)}{!} \frac{2}{jq + lpj}$

The rate of energy absorption by the electrons, P , is

with $_{SAW} = \frac{1}{_{SAW}}$. The SAW velocity shift is propor-

tional to Im $(_{SAW})^{00} + _{m}$ [2,10]. A related form alism was independently developed in Ref. [11].

O ur starting point for calculating $_{\text{SAW}}$ is a Boltzm ann equation describing the sem iclassical dynam ics of CF's in a modulated potential [6]. This equation incorporates the coupling of the CF's to the Chern-Sim ons elds describing the interactions of the charges with the attached ux quanta. It is valid close to = 1=2 where the quantum m echanics of CF's can be neglected. (All relevant length scales are assumed large compared to $1=k_F$.) The Boltzmann equation is an equation for n_p (r;t), the deviation of the composite-ferm ion phase-space distribution function from its equilibrium value. Within linear response,

Here V^{sc}(x) is the self-consistent equilibrium electrostatic potential creating the modulation, $v_{\rm p}\,$ is the velocity of a composite ferm ion of momentum p and I is the impurity scattering collision integral. The equilibrium value of the phase space distribution function is the Ferm i-D irac distribution $n_p^{(0)}(\mathbf{r}) = f(\mathbf{p}^2 = 2\mathbf{m} + \mathbf{V}^{sc}(\mathbf{x}))$ with a chemical potential . The composite ferm ions are subject to a spatially modulated e ective magnetic eld B(x). The e ective electric eld $E = E^{SAW} + E^{ind} + E^{CS}$ is composed of the physical eld E^{SAW} + E^{ind}, and the Chem {Sim ons electric eld $E^{CS} = (2h=e^2)J$ 2. The m odulation enters Eq. (4) through V $^{\rm sc}$ (x), B (x), and the Ferm i velocity. The electronic current induced by E is $J(r;t) = v_p n(p;r;t)$. We emphasize that while we use com posite-ferm ion theory, we present here only m easurable electronic response functions.

The essential physics is captured by a perturbative calculation of $_{SAW}$ to second order in the density modulation n. In this calculation we consider long SAW wavelengths q'tr 1, weak disorder k_F 'tr 1 and p q. We rst consider the SAW wavevector to be q = qQ', i.e., perpendicular to the modulation wavevector. We write $_{SAW} = _{SAW} + _{and} _{_{SAW}} = _{_{SAW}} + _{.}$ Since the Boltzmann equation is a convenient tool for calculating in powers of n, we write

Since is diagonal in its superscripts, both the rightm ost and leftm ost matrices are $(_{SAW})^{00}$. We nd $(_{SAW})^{00}$ using $_{SAW} = (U)^1$. The xx element does not contribute to (5). The o -diagonal elements are larger than the yy element by a factor k_F 'tr, and are given by $\frac{xy(q)}{1+i_{yy}=_m}$. Since q'tr 1, we may approximate $_{xy}(q)$ by its q = 0 value. The biggest contribution to the rst term in (5), then, is proportional to $_{xx}^{00}$, which is what is measured in W eiss-oscillation measurements [7]. Its contribution here is smaller by a factor k_F 'tr than that of the second term in (5).

For the second term of (5) we use the Boltzm ann equation (4) to calculate to rst order in n.W e nd that as long as $k_{\rm F}a = 1$ (a condition well satisfied by the experimental system), the Hall components of ¹⁰ are

with $n_1 = (1=a) {R_a \atop 0} dx n(x) exp (i2 lx=a)$. The diagonal components ${}^{10}_{xx}$; ${}^{10}_{yy}$ are smaller by a factor of $k_F \cdot_{tr}$. By the Onsager symmetry, 01 (B) = 10 (B) [13]. These expressions, which are obvious in the local limit a \cdot_{tr} , hold irrespective of the ratio of a to \cdot_{tr} .

Eqs. (5,6) and the expression for $^{00}_{xy}$ suggest that the second term in (5) can be approximated by,

This is indeed the case, since we now show that ($_{_{\rm SAW}}$)^{ll} is dom inated by its yy element.

The response function $(_{SAW})^{11}$ relates an externally applied electric eld of wavevector q + lp to a current of the same wavevector in an unmodulated system . W ith the expression for U, one nds for the inverse of $(_{SAW})^{11}$,

Here we approximated q + lp ' lp. Since p q and $e^2=h$, the biggest element in $(s_{AW})^{11}$ is the xx m component, and, consequently, its inverse is dom inated by the yy component. If q is small enough such that $(4h=e^2)_m$ $p^2 = qk_F$ and $(pv_S) = (qv_F)$ 1 (with $v_{\rm F}$ the composite ferm ion Ferm ivelocity), then ($_{\text{SAW}}$) $^{11}_{yy}$ 1= _{yy} (lp) $(e^2=2h)^2 = xx$ (lp). The largeness of the yy element, $(_{SAW})_{yy}^{11}$, which plays an important role in our calculation, is in m arked contrast to the conductivity m atrix 11 , whose largest elements are the o-diagonal ones, due to the strong magnetic eld. This contrast re ects the fact that in the modulated system, the SAW eld E^{SAW} in the \oint direction is accompanied by a large induced eld in the & direction. The current is alm ost perpendicular to the total electric eld and hence has a sizable component in the $ightharpoonup \left\{ direction \right\}$

Finally, using (7) and (8), we nd

This is the central result of our analytical calculation. In the local limit, p $1='_{tr}$, this expression can be obtained from the analysis described above Eq. (1). An analogous calculation shows that the e ect for SAW propagation parallel to the modulation direction, $q = q^2$, is smaller by a factor of order $(k_F '_{tr})^2 = 10^3 = 10^4$. Experimentally,

indeed, the modulation has no observable e ect in this case. The modulation contribution to the macroscopic conductivity is given by a similar analysis with $_m = 1$.




FIG.1. SAW velocity shift vs lling factor for di erent modulation strengths. The SAW wavevector is $q'_{tr} = 1.2$ and them odulation wavevector $p'_{tr} = 6.W$ ith increasing modulation, the minimum in velocity shift changes into a maximum, consistent with the experimental results of Ref. [5].

We now show that the predictions of Eq. (9) are in qualitative agreem ent with key experimental results. The in uence of the modulation is essentially determined by $_{xx}$ (lp). This quantity is known, both from previous experiments [2] and from theory [3,4], to exhibit a maximum as a function of magnetic eld at = 1=2 when lpj 1='tr. Thus Eq. (9) predicts that the modulation-dependent contribution to the absorption (velocity shift) has a minimum (maximum) around = 1=2, once the modulation-independent contribution, $^{00}_{yy}$, around = 1=2 are just opposite. For strong enough modulation, it is the modulation {dependent contribution which determines the type of extrem um points at = 1=2, in agreement with the new e ect observed by W illett et al.

The analytical results are well supported by our numerical solutions of the Boltzm ann equation, which are not restricted to weak modulation or to the regime q p; $_{tr}^{1}$. Numerically, we directly compute the response to the applied SAW eld. We restrict ourselves to a modulated magnetic eld with a single Fourier component, and employ the isotropic relaxation-time approximation [12] to account for inpurity scattering. Representative results for the SAW velocity shift as function of lling factor around = 1=2 are shown in Fig.1. At zero modulation, the velocity shift exhibits the usualminimum at

= 1=2. As the m odulation is increased, the m inim um disappears and a m axim um develops in accord with the analytical conclusions above. The e ect of the m odula-

tion gets stronger as one gets farther from = 1=2. As seen in F ig.1, the m odulation induced peak in the velocity shift is more pronounced than the m inim um observed at zero m odulation, in agreement with the experiment. W e em phasize that we found sim ilar behavior over a wide range of the parameters q and p.




FIG.2. M odulation-induced maximum in the SAW velocity shift vs lling factor for di erent SAW and modulation wavevectors q and p. The parameters $(q'_{tr}, p'_{tr}, n=n)$ are for the full line (0.6, 6, 0.06), short dotted (0.6, 10, 0.07), short dashed (1.2, 6, 0.07), wide dotted (1.2, 10, 0.08), long dashed (2, 6, 0.08), and dash-dotted (2, 10, 0.11).

Experimentally, the modulation-induced peak in velocity shift was strikingly insensitive to the SAW wavevector q and the modulation wavevector p. Fig. 2 shows our results for that peak for realistic values of q and p. C learly, the width and magnitude of the peak are rather stable over a substantial parameter range { a factor 2 in modulation period and a factor 3 in SAW wavelength, in good qualitative agreement with the experiment.

There is a point of disagreem ent between our theory and the experim ent. Theoretically, the maximum in the velocity shift is primarily due to a decrease in the velocity shift away from = 1=2, rather than to an increase in its value at = 1=2. Experimentally, there seems also to be a sharp increase in $_{yy}^{00}$ at = 1=2. This may be caused by unknown physical e ects that were om itted from our model. How ever, another conceivable explanation for this di erence within our model might be that the material parameter m increases with the voltage applying the modulation, leading to an absolute increase in the velocity shift at = 1=2.

In fact, the values of m which were used to relate SAW propagation to in unmodulated samples have been much larger than the theoretical values, for reasons which are not understood [3]. Thus a dependence on the gate voltage, and perhaps on the direction of SAW propagation, is not inconceivable. An increase in the mean free path t_r for increasing gate voltage in the modulated samples would also give qualitatively similar elects.

O ur calculation for dc transport, whose result was stated below Eq. (9), predicts anisotropies in the macroscopic dc conductivity and resistivity tensors. Speci - cally, we nd that both $\frac{m}{xx}^{ac}$ and $\frac{m}{yy}^{ac}$ exhibit m inim a near = 1=2 (with the modulation in the x direction), observable in Hallbar and Corbino geometry, respectively. Transport experiments reported in Ref. [5] have not shown these e ects. However, it is not clear what are the actual current paths in this experiment. Very recent experimental results of Sm et et al. [14] are in qualitative agreement with our theory.

In conclusion, we ndwithin a sem iclassical compositeferm ion approach that a weak density modulation can dram atically a ect both dc transport properties and SAW propagation near = 1=2.0 ur results are in agreement with m any key features of the experim ental results. D etails of the calculation will be published elsewhere.
