The developm ent of Quantum Chaos in nite interacting Ferm i system s is considered. At su ciently high excitation energy the direct two-particle interaction may mix into an eigen-state the exponentially large num ber of sim ple Slaterdeterm inant states. Nevertheless, the transition from Poisson to W igner-D yson statistics of energy levels is governed by the e ective high order interaction between states very distant in the Fock space. The concrete form of the transition depends on the way one chooses to work out the problem of factorial divergency of the num ber of Feynm an diagram s. In the proposed scheme the change of statistics has a form of narrow phase transition and may happen even below the direct interaction threshold.

I. IN TRODUCTION

The investigation of chaotic properties of nite interacting quantum systems has now a few decades history [1 {7]. The Random Matrix Theory, originally introduced for modelling this problem, adequately describes the statistics of complicated high energy excitations (see Ref. [8] for an extensive review). How ever, the concrete mechanism of developing the chaotic behavior in the nite Ferm i system with increasing of excitation energy still requires the further understanding. The interest in this problem has even increased in last years in particular due to the recent explosion of activity in the eld of M esoscopic Physics (quantum dots, atom ic clusters, helium droplets etc.). The experimental observation of electronic excitations in quantum dots [9] has stimulated the progress [10{14] in theoretical investigation of chaotic disintegration of single electron excitations in this system s. The single particle excitations, being most easily produced experim entally, constitute an important part of Hilbert space of complicated system . However, the number of such states is exponentially sm all compared to the total num ber of excited states. The onset of chaos in the majority of many-particle states is the subject of this paper.

Wewill consider nite, but su ciently large Ferm isystem s. The particles are supposed to occupy almost all orbitals below the Fermi energy "F of mean eld single particle Ham iltonian [15]. The averaged single particle " $_{\rm F}$. W e w ill denote as sim ple states level spacing is the single Slater determ inant states having de nite occupation numbers (0 or 1) of all orbitals. The simple states

are mixed by the two-particle interaction and the matrix elements V are supposed to be small and Gaussian random

Here g m ay be interpreted as dim ensionless conductance in the case of quantum dot [11,12]. This simple model was in fact introduced long ago in Refs. [2,3].

Due to the weak interaction Eq. (1), the low energy excited states are alm ost unperturbed. W ith the increase of energy E the density of states grows rapidly and the exact wave functions at E are formed by many chaotically m ixed sim ple states. However, this chaotization of excited states proceeds in a very nonuniform and complicated way. For illustration we have shown on the Fig. 1 di erent energy scales relevant to this problem .

The complexity of excited state is usually characterized _k j_i(k)j⁴, by the inverse participation ratio (IPR)I =where $_{i}$ (k) is the amplitude of k-th simple excitation in the i-th exact wave function. Physically I is the e ective inverse num ber of sim ple states m ixed into exact one.

W hile the density of single particle states $_1 = 1 =$ does not depend on energy, the total density grows ex-¹ exp (2 tremely fast with E being total E=6) [16]. We use large E for the total energy of the manyparticle con guration and sm all "for the energy of singleparticle orbitals. Due to the huge num ber of states (analog of the m icro-canonical ensemble in therm odynam ics) the averaged occupation number for given orbital for arbitrarily chosen "typical" simple state is given by the usual Ferm iD irac distribution

where T = p6E = [17]. Note, that we still have not taken into account the interaction V, but only explore the wide statistics of single-Slater-determ inant states.

The low energy thresholds on the Fig. 1 correspond to the decay of single quasi-particle. Quasi-particles in quantum dot may be seen as peaks broadened by the interaction (bunches of -peaks) in the one particle spectral density up to the energy " g [10]. Above " g the broadening arise due to a decay of quasi-particle into two particles and one hole and m ay be explained by the Ferm igolden rule. Below this energy the width predicted by golden rule turns out to be smaller than three-particle level spacing. However, as it was shown recently [12] up g= lng the quasi-particle disintegrato energy " tion still proceeds through the e ective interaction with

the m any excited particle and hole states. A nonuniform distribution of the m atrix elements of e ective interaction in this case leads to a very unusual distribution of spacings between peaks and w idths of the bunches [14].

The original intention of this research was to apply the methods developed for description of quasi-particle disintegration for the investigation of the full spectrum of complicated system . However, the onset of chaos in the many-particle excitations provided us with a num ber of surprising new e ects not present in the single quasiparticle case. Only the estim ate of the e ective high orderm atrix element in the section 3 m ay be considered as straightforw ard generalization of the analogous estim ate in the Ref. [14]. In the section 2 we will show, how the direct interaction between particles may mix into one wave function an exponentially large number of simple states even inside the region of Poissonian spectrum. In the section 3 we consider the self-consistent scheme of onset of chaos based on the analysis of the scaling behavior of the direct and e ective interaction. How ever, in the following section 4 we propose an another scenario of the transition to W igner-D yson caused by the factorial divergency of the high order interaction. The detailed com parison of the features of these two scenarios is given at the end ofpaper (Sec.5).

II.M IX ING BY THE DIRECT INTERACTION

For weak interaction the strong mixing of di erent quantum states may take place only if their energies occasionally turn out to be very close. Therefore, consider rst only two states jii and jfi with energy di erence " connected by matrix element V. The simple calculation [18] gives the IPR for exact wave function jii+ jfi

Let us x the state ji and consider a set of states jf i w ith a density dn=d" = f^1 . It is convenient to introduce the interm ediate scale "0; JJ j "0 f. W ith the probability 1 2"0= f there are no nal states falling into the strip "0 < " < "0 and I = 1 up to negligible correction $V^2 = f''_0$. W ith the small probability 2"0= f one of

the states jf i enters the strip. In order to nd I in this case one has to average the Eq. (3) over the interval of energy

and then average the j V j over the ensemble of matrix elements. Combining the two contributions one nds

This simple formula is basic for our perturbative estimates. The averaging of the modulus of V for strongly non-Gaussian high order e ective matrix elements will be the main subject of the next section.

The goal of this paper is to consider the m ixing of com – plicated excited states. Occupation numbers for these states are described by the Eq. (2). The density of directly accessible states, or the density of pairs of occupied 1;2 and unoccupied 3;4 states with $"_1 + "_2 = "_3 + "_4$ which m ay be connected directly by the interaction is

Here $f_1 = f(x_1)$ (2), $x_{1;2} = "_{1;2}$ "F; $x_{3;4} = "_F$ 3;4 and we have used that 1 f(x) = f(x). The factor (2!)² accounts for the identical initial and nal particles. It is easy now to use the Eq. (5) in order to nd the IPR. However, this result may be even further im proved. Eq. (5) with f = 2 describes the situation when only for one two-by-two transition 1;2 ! 3;4 the energy di erence turns out to be of the same order of magnitude with the matrix element. In the second order in V the leading contribution to I is given by double event 1;2 ! 3;4 and 5;6 ! 7;8. How ever, as far as none of the orbitals 5 8 not coincides with any of 1 4 these two corrections are completely independent and corresponding contributions to I should be simply multiplied. E ectively, all one-particle states are chosen from T = orbitals around " $_{\rm F}$. Therefore, if the number of couples of pairs falling into the energy interval ∱jis small compared to T = one may neglect the interference between di erent direct transitions. A gain we may introduce the interm ediate scale $"_0; j j "_0$. The num ber of directly accessible nal states is $2"_0 = 2$ 1, but until $"_0 = _2$ T = the IPR is found simply as a product over these channels

Here we have averaged jV j for the Gaussian random interaction Eq.(1). This result is valid for $=g_2T=$, or $T_1 = \frac{p}{g}$. The exponentiation of the IPR is a direct consequence of the two-particle character of the interaction. It would be very inconvenient to investigate such e ects if one will consider the H am iltonian of the system as a random (sparsed) M atrix in the full H ilbert space. Surprisingly, to the best of my know ledge, the sim ple e ect Eq. (7) has not been considered yet e.g. for description of the excitations in com plex nuclei.

Due to the Eq. (7) at $E > g^{2=3}$ the num ber of com – ponents in typical wave function becomes exponentially

large. However, within the range of validity of the Eq. (7) only a sm all (also exponentially) part of close energy levels ism ixed in any exact eigenstate. Therefore this sim ple e ect is not enough for creation of full Q uantum Chaos.

III. HIGH ORDER EFFECTIVE INTERACTION

C onnections to the Eq. (7) arise after taking into account of the high order elective interaction between three-particle states, then four-particle etc. The example of corresponding tree-type Feynm an diagram is shown on Fig. 2. The tree-type diagram s are maximally enhanced due to a wide statistics of initial and nalorbitals. C ontributions from the diagram s with closed loops are small like some power of =T. Generalization of the Eq. (6) for the case of n-particle interaction gives

A gain (n!) ² accounts for the identical ferm ions. Note that (2n)! 2^{2n} (n!)² and therefore the integration over the energies x_i does not lead here to any n! suppression. This is in strict contrast with what happens for decay of quasi-particle [14], where the main suppression of the density of nalstates n arose due to the integration over the energies of nalparticles.

Su ciently more complicated turns out to be the calculation of averaged modulus of the e ective matrix element entering both the Eq. (5) and the Eq. (7). The simplest variant of the e ective interaction is given by the three-particle interaction arising in the second order of perturbation theory

Form ally this interaction m ixes together three states jli, 21, Bi. The use of the concept of e ective interaction requires that the adm ixture of the interm ediate state 121 in the total wave function is sm all compared to those of jli and Bi. Thism eans that V₁₂; V₂₃ j"ı "2j 72 ", j. The contribution to averaged IPR from strongly mixed (alm ost degenerate) jli, jli and jli should be considered separately, but this correction is small like $1 = \ln q$ com pared to the total contribution of the e ective interaction. On the other hand, we will be interested in the tail of distribution of the e ective matrix elements. For Gaussian distributed V (1) the probability to nd a large individualm atrix elem ent of the original two-particle interaction is exponentially small. The large matrix elements appears if one term in the sum in Eq. (9) occasionally has anom alously sm all denom inator J_1 "2 i All the other (random) contributions in the sum in this case may be neglected for lng 1. The result of this lengthy discussion may be summarized in the formula for the probability distribution for the elective matrix element (9)

The averaged modulus of the matrix element in this case is $\overline{y_{\text{eff}}^{(3)}}$ in g=g².

Higher order e ective matrix elements are obtained by simple adding of more intermediate states into the Eq. (9). The extensive discussions of the problem s arising while calculating the averaged value of this matrix element may be found in Ref. [14]. For example, the averaged modulus of the four-particle e ective matrix element for given Feynm an diagram is given by

Here compared to the Eq. (9) we have made the change " $_2$! " $_2$ and " $_1$ " $_3$! " $_3$. The preof variables "1 $(=g)^3$ in the Eq. (11) arose after averintegral factor aging of G aussian distributed (1) direct m atrix elements v_{ij} The upper bound for the both remaining integrals in the Eq. (11) is given by the single-particle level spacing $J'_{2;3}j < \ldots$ Due to the logarithm ic character of the integrals the order of magnitude estimate of the bounds is enough. M ore interesting is the origin of the bounds at sm all "2:3. A nalogously to what we have discussed for the three-particle interaction the formula (11) describes them ixing of four states jli, j2i, Bi, j4i in the third order of perturbation theory. The interaction of the four states may be replaced by the e ective interaction of only two jli and ji if the adm ixture of interm ediate states ji and Bi is small. This requirem ent for example for state 12i means that J_2 j ĴV₁₂j =q (weak mixing of 12i and $y_{23}V_{34}="_{3}j$ (=g)²= $j"_{3}j$ (weak mixing jli) and j"2j of pi and pi). Another two inequalities for the vector $(=g)^2=j_2^{"}j$. Combining j3i are **j"**₃j =g and **j"** ₃j all this inequalities one nds for the range of integration in the Eq. (11)

These bounds allows one to nd the averaged matrix element with the 1=lng accuracy: $\overline{\mathcal{Y}_{\text{eff}}^{(4)}}$ j (lng)²=g³. In the similar way one may consider the ve-particle, six-particle, etc. e ective interaction. Unfortunately, the system of inequalities describing the range of integratin for the interm ediate energies turns out to be su ciently more com plicated in these cases.

The form ulas like Eq. (11) m ay be used to nd again the distribution of the e ective m atrix elements. In particular for the four-particle interaction

Here the range of variation of $"_2$ and $"_3$ is the same as in the Eq. (11) Found in this way the probability distribution in the general case has the form

A lso notice the huge range of variation of $V_{eff}^{(n)}$ (14) for large n. A veraging of the m atrix element over the distribution Eq. (14) leads to

D ue to a com plicated dom ain of integration over the interm ediate energies it is di cult even to estimate the value of the overall num erical constant here. How ever, the important result of R ef. [14] is that at large n this unknown overall constant is neither large like n! nor small like 1=n!. The appearance of logarithms in the coe – cients of wave function was also observed in [19].

Like in Eq. (7) the corrections generated by the m any particle e ective interaction are naturally exponentiated at least for $T = .Thus combining_{n}$ (8) with $V_{eff}^{(n)}$ (16) we obtain instead of the Eq. (7)

In the case of short range screened two-particle interaction V $(\mathbf{r}_{p}; \mathbf{r}_{2})$ $(\mathbf{r}_{p}; \mathbf{r}_{2})$ the rst coe cient here is $F_{1} = 24$ 2= =5. This result for I m ay be compared with the perturbative result for the IPR for disintegration of the single quasi-particle in the isolated Q uantum dot found in Refs. [12{14]

where $y = ("=)^2 \ln q = q$ and " is the energy of quasiparticle. By analogy with the usual IPR, the I_q is a sum of fourth powers of the amplitudes to pd given kth quasi-particle in the i-th exact state $I_q = \begin{bmatrix} j & j & k \end{bmatrix}_1^d$. The next section will be devoted to the m ore detailed investigation of the possible properties of the scaling function F (x). For single quasi-particle the coe cients n decrease like n!¹ for large n, which m akes very in probable the disintegration of quasi-particle through delocalization transition in the Fock space.

The simple counting of the powers of E = and g in Eq. (17) leads to the following scenario of the development of chaos:

a). For $g^{2=3} < E < g= \ln g$ the Eq. (7) is valid. The number of components in typical wave function is exponentially large, but described by simple multiplication of independent direct transitions.

b). At E $g= \ln g$ all term s in the series Eq. (17) enters the game. The wave function is formed by a fractal combination of states distant in the Fock space [20]. If the resumed scaling function F will be a regular function of the argument x (like it is for the (y) (18)), the number of components of the wave function will be small compared to the total density of states and the level statistics will be close to Poissonian.

c). Starting from E g all quasi-particles constituting the wave function have enough energy to decay via usual G olden-rule. Only here the W igner-D yson statistics is evident. The more formal criteria for onset of chaos will be the requirement that the product IE $_{total}$ became of the order of 1, where $_{total}$ is the total density of states described above the Eq. (2). This condition is equivalent to the equation for unknown function F (x)

Solution of this equation gives the energy of transition to rigid spectrum somewhere within $g=\ln g < E = < g$. D ue to the exponential character of I and total most likely this will be the narrow phase transition.

IV.THE N!SCENARIO

Thus the power counting for the perturbative IPR Eq. (17) may provide us with the form ally self-consistent scenario of developing of chaos in nite Ferm i systems. Now we are going to show, how taking into account of the high order behavior of the coe cients F_n may lead to the important revision of this straightforward scheme. Unfortunately, we are not able to perform the com plete estimation of the asymptotics of F_n. Nevertheless, the catastrophic change of the mechanism of onset of chaos, which we will consider, may partly compensate the lack of rigor. Therefore, even though based on certain assum ptions, the result of this section should be considered as one of the main results of the paper.

The calculation of any term of the series in Eq. (17) consists of two main steps. First is the calculation of the density of nal states, which we were able to perform explicitly (8). The second step is the estimation of the e ective matrix element. The matrix element for a given Feynman diagram is described by the Eq. (16). A swe have told, this matrix element could not contain any n! or n!¹. However, for many-body problem and high order of perturbation theory the same initial and nal con gurations may be connected by many di erent Feynman diagram s. We have shown on the Fig. 2 the example of corresponding tree-type n-particle diagram. The total num ber of diagram s like on Fig. 2 is

Here n! is the num ber of permutations of 1^0 n⁰ nalparticles, (n 1)! is the num ber of replacem ents of (screened) Coulomb interaction lines and n^{n-2} is the number of (n 1)-segment trees connecting n points 1 n [21]. Eq. (20) gives us the num ber of diagram s of Schrodinger perturbation theory. Among the N $_{\rm d}$ trees there are many diagram s having the same set (up to permutations) of the matrix elements of two-particle interaction $V_{\rm ij}$ and di erent energy denom inators. As it was pointed out in Ref. [14], these diagram s could not be considered as statistically independent, which results in lowering of the m ixing by the high order e ective interaction. The averaged modulus of the e ective matrix element found for single Feynm an diagram (16) should be modied in the case of many interfering diagrams. However, due to a huge range of variation of the $V_{\tt eff}$ in the power law distribution Eq. (14) the average value is saturated by a rare very large uctuations of the matrix element. Therefore for n not too large the generalization of the Eq. (16) for m any diagram case is achieved by the simple multiplication by the num ber of diagram s (we will return later to the discussion of very large n). Finally, combining the Eqs. (8), (16) and (20) we nd

W e see, that the series in Eq. (17) most likely is the asymptotic series. Due to the unsatisfactory estimate of the num ber of diagram s and even the value of individual diagram we were able to draw only the upper bound for the F_n . However, it seems very unlikely that the cancellation between the diagram s of the Schrodinger perturbation theory will rem ove the factorial divergency of the coe cients of the series. In the following (if the opposite not indicated explicitly) we suppose that F_n n !. The asymptotic series, common in the Field theory and High Energy physics, usually do not cause serious troubles (see for review Ref. [22]). In all known cases one simply breaks the summation on the smallest term of the series and use this smallest term also as the order of m agnitude estim ate of the rest nonperturbative part of

the sum. The more re ned strategy will be to perform the Borel sum mation, but this procedure (up to the same nonperturbative corrections) is equivalent to the breaking of the series at the smallest term. In our example this means that one should break the sum mation in the Eq. (17) at $n_0 = \ln gE$ and the non-perturbative ambiguity in F should be

However, in the known eld-theoretical examples there exist the clear physical mechanisms (Instanton, Renormalon) which allows to understand the origin of non-perturbative corrections and the necessity of breaking the series at the sm allest term . In our m anybody quantum problem we could nd no physical motivation for the appearance of nonperturbative corrections of the kind (22) and we see no reasons for breaking the summation in the Eq. (17) at the smallest term. Of course, the Eq. (17) is not exact, but corrections to F (x) are small like $(\ln q)^{-1}$ or =E. Taking into account such corrections will help us, to sum up the original divergent series. Nevertheless, in order to make sense of our perturbative analysis of the onset of chaos in nite Ferm i system s we should nd the physically motivated cuto for the n! divergent sum . The natural cuto for F_n , which we see, is given by the total number of particles which may enter into the diagram of e ective in-E=. If $n_{max} > x^{-1}$ the teraction $n_{m ax}$ T =sum mation now goes above the smallest term of the series. The consequences of the decision to sum up the series above the sm allest term are crucial. In the standard scheme the function F (x) is described by perturbation theory at small x and became completely nonperturbative (although it still may be smooth and nite) at x 1. W ithin the new scenario F (x) blows up at

which

gives the chaotization threshold E_c (g=lng)²⁼³. This estim ate was done for the most strongly divergent series allowed by the Eq. (21). For example, if F_n (n=2)! the same calculation will lead to E_c (g=lng)⁴⁼⁵. Therefore, the more accurate conclusion from the Eq. (21) is that due to the elective interaction including all T = excited particles the series for IPR Eq. (7) blows up at some (g=lng)²⁼³ < E_c < g=lng [23].

The two important peculiarities of the emergence of Quantum Chaos follow from this "factorial" scenario:

I. The direct interaction connect only the states close in the Fock space [20]. Therefore, the Eq. (7) describes m ixing of only a small part of close levels. On the other hand, the highest order e ective interaction entering the Eq. (23) m ixes the huge number (the majority of all m any-particle excitations) of very distant simple states. Thus, divergency of F (x) due to the n! leads to the transition from Poisson to rigid (W igner-Dyson) spectrum at $E = E_c$.

II. Due to the large power of x in the Eq. (23) the grow th of F (x) with increase of energy takes place at a very narrow interval $E=E_c$ $1=n_{m \ ax}$. This m eans that the change of statistics has a form of phase transition with relative width $1=n_{m \ ax}$.

O ur description of the developm ent of chaos is su ciently based on the estim ate of $n_{m ax}$ (23). If one would be able to nd another reasons for breaking the series at a term param etrically smaller than $n_{m ax}$ T = the result for E_c will be also di erent. For example, the new cuto m ay arose due to a huge num ber of interfering diagram sEq. (20). The joint probability distribution for the sum of m any diagram swith power law individual distributions described by the Eq. (14) has a Lorentzian form [24] with the width having the form

Here we have used for the estimate of the number of independent diagram s the upper bound Eq. (20). This distribution is valid for $\frac{1}{y} \leq -g$. The function was de ned in the Eq. (14). The factor (V) = () allows to preserve the asymptotics Eq. (14) at $\sqrt[4]{y}$ j . Due to the logarithm ic character of this factor correctly accounts for the deviation from the pure power law in the distribution of single matrix elements. We see that after taking into account of the interference of di erent diagram s the power law distribution of the total matrix element becomes strongly violated at $\frac{1}{y}$ j , not at ΊVΊ g^{n+1} as in the Eq. (14). The value of F_n found with the distribution P (V) (24) becomes parametrically di erent from the estimate Eq. (21) only at n_{max}^0 $d^{1=3}$ $(g=\ln g)^{1=3}$ if one considers seriously the (even at n_{max}^0 high powers of logarithm s in the Eq. (24)). However, this new variant of the cuto leads to the same threshold for the onset of chaos as we have found before in Eq. (23). This coincidence of the results of two di erent approaches to estimation of the n_{max} may be considered as an indirect support for the transition to W igner-D yson statistics $(q=\ln q)^{2=3}$. $at E_{c}$

At least som e of the thresholds show n on the F ig.1 m ay lie above E_c . The physical meaning of these perturbative thresholds becomes less clear. Nevertheless, even above E_c one m ay try to look for e ects generated by the direct or low order e ective interaction. The highest order e ective interaction becomes in portant due to the huge combinatorics Eq. (20), but the corresponding matrix element is in general very small (up to V = $g^{n_m ax}$). Thus this high order interaction may be invisible (or at least suppressed) at small time in time-dependent problem s. For example, one may consider the time evolution of the wave packet (t), starting at t = 0 from single

Slater determ inant. The pure direct interaction in this case gives

The form alpower counting (like we have done below the Eq. (17)) gives for the range of validity of this result $g^{2=3}$ E g=lng. However, due to the logarithmic behavior of all integrals (see e.g. the Eq. (11)) all values of the high order elective matrix elements are equally important within $g^{n+1} < j = (j = 1)$ (14). Therefore, the range of validity of the Eq. (25) may be changed strongly after taking into account of the contribution from large high order elective matrix elements.

V.DISCUSSION




FIG.1. The di erent energy scales corresponding to chaotization of single-or m any-particle excited states.

The goal of this paper was to consider, how the chaotic m ixing of noninteracting eigenstates develops with increasing the excitation energy in nite weakly interacting Ferm i system s. Measured in the units of the singleparticle level spacing the energy corresponding to the onset of rigid spectrum m ay depend on only one param eter g (1). Nevertheless, even with only one param eter we were able to introduce a num ber of di erent energy scales, shown on the Fig. 1, which correspond to (or may correspond to) the di erent stages of developm ent of chaos.

The low lying thresholds on the gure "= $(g=\ln g)^{1=2}$ and "= $g^{1=2}$ are associated with the decay of single quasi-particle. These thresholds were considered in the Refs. [10{14] and their description was not the aim of this paper. However, the methods introduced in Refs. [12,14] for the investigation of below golden rule decay provides us with the useful tool for the investigation of onset of C haos in com plex many-particle excitations also.

Technically our consideration is based on the two sim – ple equations (5) and (7) for the IPR. The two noninteracting states are strongly mixed by the interaction if the corresponding energy di erence turns out to be of the sam e order of m agnitude with the matrix element. As a result, all the e ects which we consider are determined by the product of the averaged modulus of the matrix element and the density of accessible states.

The emergency of chaos in the majority of complicated states with many excited particles and holes was the main subject of this paper. This increase of chaos with the growth of excitation energy proceeds in a very complicated way, both technically and even more logically. In the simplest variant, mixing of the simple (single Slater determinant) states is caused by the direct interaction. The mixing by direct interaction opens at $E > g^{2=3}$ [25]. Due to a large number of excited particles the interaction may proceed through a large number of independent channels. This results in the exponentiation of

the IPR, as we have shown at the end of the Sec.2. Thus even the direct interaction m ay m ix together an exponentially large num ber of Slater-determ inant con gurations. How ever, this num ber is still sm all com pared to the total num ber of levels of com plicated system and the direct interaction could not cause the transition from Poisson to W igner-D yson statistics of energy levels.

An alternative to direct interaction is the transition via e ective three-particle, four-particle, etc. interaction considered in Sec. 3. The e ect of this high-order interaction is much weaker than that of the direct interaction at low energies, but they became comparable at E $g=\ln g$. A bove the energy E g=lngourperturbative approach is no more valid and we were forced to introduce the new unknown scaling function F (ln gE=g) into the exponent describing the IPR in the Eq. (17). However, if one expects that F (x 1) 1, the logarithm of the num ber of com ponents in the typical wave function q=lng will be in lng 1 tim es sm aller than at E the logarithm of the total number of states. This means that although the mechanism of mixing is changed and the number of components in the wave function became to grow much faster at E q= ln q, this threshold does not correspond to the transition Poisson (W igner-D yson.

The W igner-D yson statistics becomes evident only at E g. This energy is analogous to the golden rule threshold " $g^{1=2}$ for the decay of single quasi-particle. Roughly speaking above the E g any particle from the strip T around "F m ay decay via the golden rule.

Form ally, in order to understand, how the change of statistics proceeds between E $g= \ln g$ and E g one should analyze the high order behavior of the coe - cients F_n in the expansion of the function F (x) Eq. (17). Supprisingly, this analysis in the Sec. 4 instead of such understanding led us to the crucial revision of the considered above straightforward scheme.

First of all, as we have shown in the Sec. 4, the series in the Eq. (17) most likely is the asymptotic series. Although (21) F_n n! is only the upper bound for the F_n , it seems very unlikely that the factorial divergency of the coe cients m ay be washed out. M oreover, even if (n)!with any 0 < < 1, the results of the Sec. 4 Fn will be only slightly modi ed. The factorial divergency of the series would not be dangerous if one will sum it up e.g. via som e variant of the Borelm ethod. How ever, within the Borel prescription one is immediately faced with the problem of strange nonperturbative corrections like in the Eq. (22) (moreover that F_n are positive by construction and the series is non-Borel sum m able). Being unable to nd the physical motivation for the Borel sum mation, we were looking for other way to make sense of the divergent series. The coe cient F_n is given by the sum of n + 1-st order tree type Feynm an diagram s. Therefore, the natural cuto for the series is given by the largest diagram which may be drown with available

T = particles. Namely n_{max} T = (one more way)

to determ ine $n_{m ax}$ considered in the Sec. 4 leads to the same physical result). W ithin this scenario the $n_{m ax}$ and the scaling parameter $x = \ln gE = g$ in the Eq. (17) are two independent variables. At $x > 1 = n_{m ax}$ sum mation in the Eq. (17) goes above the sm allest term . How ever, $(g=\ln g)^{2=3}$ all n_{max} terms of up to the energy E_c the series are small. At $E = E_c$ even the broken series blows up and above E_c our perturbative approach is no m one valid. Because of the growth of F(x) at EÆ proceeds mostly due to the last terms of the series or the most complicated diagram softhe highest allowed order of perturbation theory, this threshold corresponds to narrow phase transition from Poisson to W igner-Dyson spectrum . W e have attem pted at the end of the previous section to nd rem nants of non-chaotic behavior above E_c by considering the short tim e processes. However, this issue requires a separate and m ore careful investigation.

To sum m arize, we have considered in this paper the two scenarios, how the quantum chaos may develops in the F inite Ferm i systems depending on the way one will use for the sum m ation of factorially divergent contributions from the high order e ective interaction.

If the series is summed up within the Borel prescription (i.e. broken e ectively at the smallest term) we were able to nd a few distinct stages q²⁼³ of the chaotic behavior. Below the energy the majority of eigenvectors is alm ost unperturbed. $q^{2=3}$ and g=lng direct interac-B etw een tion m ixes together the exponentially large num ber of sim ple states (7). How ever, the IPR is under theoretical control in this region and the statistics is clearly Poissonian. Above g=lng statistics of the energy levels is still Poissonian, but the IPR is described by some (unknown) scaling function F (x) (17). Transition to W igner-D yson takes place som ew here between E $q=\ln q$ and E q (see the Eq. (19)). The transition m ay be relatively nar- $(\ln q)^{-1}$. row E=E

In the second variant the cuto of the series in the Eq. (17) is determined by the number of the particles in the largest allowed Feynm an diagram and is independent of the scaling variable x. In this case the transition to W igner-Dyson takes place at E_c (g=lng)²⁼³ and is narrow like E=E =T (lng=g)¹⁼³.

To our current understanding, the second scenario is more physically motivated. However, our argumentation in this part is not completely rigorous and one still may nd the reasons for summation a la Borel of the tree diagram s. The important disadvantage (or advantage?) of the second scheme is that if it is correct, it will be probably the rst example of the phase transition caused by the factorial divergency of the series. Finally, although both of our scenarios are reach of new physical predictions, we were able to m ake only the order of m agnitude estim ates of the considered thresholds. Therefore, any experim ental con m ation (within the true experim ent, or by num erical simulations) of the m echanism s of developm ent of chaos considered in this paper are very desirable.




FIG.2. The tree type diagram contributing to high order e ective matrix element. The screened Coulomb interaction is shown by dashed lines.
