## A nalytic Solution of a Relativistic Two-dim ensional Hydrogen-like A tom in a Constant Magnetic Field

## Abstract

We obtain exact solutions of the Klein-Gordon and Pauli Schrodinger equations for a two-dimensional hydrogen-like atom in the presence of a constant magnetic eld. A nalytic solutions for the energy spectrum are obtained for particular values of the magnetic eld strength. The results are compared to those obtained in the non-relativistic and spinless case. We obtain that the relativistic spectrum does not present s states.

The study of the two-dimensional Hydrogen atom in the presence of homogeneous magnetic elds has been a subject of active research during the last years. Much work has been done in the framework of non-relativistic quantum mechanics, computing the energy spectrum for dierent magnetic eld strengths. This problem is of practical interest in discussing single and multiple-quantum well (superlattice) systems in semiconductor Physics.

The two-dim ensional Schrodinger equation, with a Coulom b potential  $\frac{Z}{r}$  and a constant magnetic B eld, perpendicular to the plane where the particle is, can be written in atom ic units as follows

Since we are dealing with a two-dimensional problem, we choose to work in polar coordinates (r;#): The angular operator operator i $\theta_\#$  commutes with the Hamiltonian (1), consequently we can introduce the following ansatz for the eigenfunction

Substituting (2) into (1), we readily obtain that the radial function u (r) satis es the second order di erential equation

where  $!_L$  = B=2c is the Larm or frequency, E is the energy, and m the eigenvalue of the angular m om entum . A general closed-form solution to (3) in terms of special functions does not exist [1] There are analytic expressions for the energy for particular values of  $!_L$  and m as, pointed out by Lozanskii [2] and m ore recently by Taut [3,4]. The advantage of having exact values of the energy spectrum for some values of the magnetic eld strength and the angular m om entum becomes clear when we use numerical methods for computing the energy for any value B and m, in particular for higher excited states (Rydberg states) and high magnetic elds, as pointed out by Taut [3].

In this article we solve the two-dimensional hydrogen atom with an homogeneous magnetic eld (perpendicular to the plane in which the electron is located) when relativistic corrections are considered. We obtain analytic solutions of the 2D K lein-G ordon and we also compute the relativistic energy spectrum for some particular values of the angular momentum m and the magnetic eld strength B: Finally, we solve the nonrelativistic problem when spin corrections are included.

The covariant generalization of the K lein-G ordon equation in the presence of electromagnetic interactions takes the form [1,5]

where g is the contravariant metric tensor, and r is the covariant derivative. Since we are working in a 2+1 spacetime, the metric tensor g written in polar coordinates (t;r;#) takes the form:

and the vector potential A associated with a Coulomb and a constant magnetic eldinteraction is

W ith the help of the vector potential (6), it is straightforward to verify that the corresponding magnetic and electric elds satisfy the invariant relations

where F is the electrom agnetic eld strength tensor, which in a (2+1) spacetime has three independent components.

Expression (7) and (8) tell us that in fact A is associated with a 2D Coulomb atom in a constant magnetic eld perpendicular to the plane where the particle is located. The corresponding E and B can be written in polar coordinates as follows:

Since the vector potential components do not depend on time or the angular variable #; we have that the wave function , solution of the K lein-G ordon equation (4) can be written as

where the function u (r) satis es the second order ordinary di erential equation

Equation (12) does not adm it an exact solution in terms of special functions, and therefore approximate methods have to be applied in order to compute the energy spectrum. It is worth noting that the 2+1 relativistic Coulomb problem can be solved in closed form [6] and the energy levels are

A lso we have that the energy spectrum of a relativistic spinless particle in a constant magnetic eld satis es the relation

We look for a series solution of eq. (12). In order to do that, after analyzing the asymptotic behavior of the solution u(r) at r = 0 and as r ! 1, we write u(r) in the form

substituting (15) into (12) and imposing that

we obtain

and for n 2 we have

Since only polynomial solutions of eq (12) are bounded as  $r \,! \, 1$ , the series given by the recurrence relation (18) term inates at a certain n when  $a_n = 0 = a_{n+1} = 0$ ;  $a_{n+1} = 0$  for any positive integer value of i. From the recurrence relation (18), we readily obtain the following relation

for those values of the eld strength B for which (15) becomes a polynomial. A first substituting (15) into (12), we obtain a system of equations which gives the permitted values of B. It is worth mentioning that the relation (19) makes sense only when

a condition that forbids the existence of the s energy levels (m = 0), this is in fact a particularity of the relativistic K lein-G ordon solution, which is not present in the standard

Schrodinger fram ework. Let us obtain the rst excited state of the relativistic K lein-G ordon 2+1 hydrogen atom. In this particular case we have that only  $a_0$  and  $a_1$  are nonzero, and the recurrence relations (17), (18) give

from which we obtain that the energy is given by the expression

for a magnetic eld B that can be obtained after substituting (24) into (19).

also, we have that for n=3 ( $a_2 \in 0$ ;  $a_n=0$ ; n>2) the corresponding energy is given by the expression

for B given by

In order to obtain the magnetic eld for which analytic solutions of eq. (3) are possible, we have to solve the system of equations given by the recurrence relation (18). The following table shows all the allowed magnetic elds for 2 n 10. Notice that for higher values of n the number of solutions increases as int (n/2).

Table 1 Energy values for all the allowed magnetic elds for Z = 1, m = 1, and a comparison with the non relativistic energy spectrum. N is the number of nodes of the radial wavefunction

A comparison with the non-relativistic energy levels, obtained with the help of the Schwartz method [7], which is a generalization of the mesh point technique for numerical approximation of functions, shows that the relativistic correction to the problem becomes noticeable when B > 100. Table 1 shows that the energy correction is smaller than  $10^{3}$  even when B = 100. From (13) and (14) we can see that for weak as well as for strong magnetic eld strengths, the rôle played by the relativistic corrections is to shift down the energy levels.

The inclusion of spin e ects can be carried out in a rather simple way with the help of the Schrodinger-Pauli equation.

which, after substituting the vector potential (6) into (28), with (r) given by (11) we obtain

where s is the spin operator which satis es the relations

$$s = 3=4;$$
  $gs_j = \frac{1}{4} (i_j + i_{ijk} s_k)$  (30)

and, for our magnetic eld strength, we have that s B can be written as

$$\mathbf{s} \quad \mathbf{B} = \frac{1}{2} _{3} \mathbf{B} \tag{31}$$

where  $_3$  is the diagonal Pauli m atrix. Eq. (29) has essentially the same form of (3). The presence of the spin introduces a shift in the energy proportional to the magnetic eld strength. For the allowed magnetic eld values reported in [3] we have that the Schrodinger-Pauli spectrum is

$$E = ! (n + 2 + m + jm j)$$

It is worth noticing that the spin contribution does not introduce any restriction on the allowed values of m. It is the relativistic contribution that forbids the existence of the s values. The inclusion of spin correction as well as relativistic e ects requires to deal with the 2+1 D irac equation in the background eld given by (9) and (10). This problem will be discussed in a forthcoming publication.
