Is the magnetic eld necessary for the Aharonov-Bohm e ect in mesoscopics?

Abstract

We predict a new class of topological mesoscopic phenomena in absence of external

magnetic eld, based on combined action of the nonequilibrium nuclear spin popula-

tion and charge carriers spin-orbit interaction (meso-nucleo-spinics). We show that

A haronov-B ohm like oscillations of the persistent current in G aA s/A lG aA s based

m esoscopic rings m ay exist, in the absence of the external m agnetic eld, provided

that a topologically nontrivial strongly nonequilibrium nuclear spin population is

created. This phenomenon is due to the breaking, via the spin-orbit coupling, of

the clock wise - anticlock wise sym metry of the charge carriers momentum, which

results in the oscillatory in time persistent current.

Persistent currents (PC) in mesoscopic rings relect the broken clock wise-anticlock wise symmetry of charge carriers momenta caused, usually, by the external vector potential. Experimentally PCs are observed when an adiabatically slow time dependent external magneticeld is applied along the ring axis [1{3}]. The magneticeld variation results in the oscillatory, with the magnetic ux quantum $_0 = \frac{hc}{e}$ (or its harmonics) period behavior of the diamagnetic moment (the PC), which is the manifestation of the Aharonov-Bohm elect (ABE).

We propose here that in a quantum ring with a nonequilibrium nuclear spin population the persistent current will exist, even in the absence of external magnetic eld. We predict the ABE like oscillations of PC with time, during the time interval of the order of nuclear spin relaxation time T_1 [4], which is known to be long in sem iconductors at low temperatures [5]. The hyper ne eld, caused by the nonequilibrium nuclear spin population [5] breaks the spin symmetry of charged carriers. Combined with a strong spin - orbital (SO) coupling, in systems without center of inversion [6,7], it results in the breaking of the rotational symmetry of diam agnetic currents in a ring. Under the topologically nontrivial spatial nuclear spin distribution, the hyper ne eld produces an adiabatically slow time variation of the Berry phase of the electron wave function, analogous to one which em erges in standard ABE in textured mesoscopic rings [8,9] and in Aharonov-Casher eect [10]. The time variation of this topological phase results in observable oscillations of a diam agnetic m om ent (the persistent current). We em phasize that this is one of a series of "m eso-nucleo-spinic" e ects, which m ay take place in m esoscopic systems with broken, due to the combined action of the hyper ne eld and spin-orbital interaction, sym m etry.

The hyper ne interactions in GaAs heterojunctions and similar quantum Hall systems attracted recently sharply growing theoretical [14] and experimental [15{17] attention. The main recent physical interest in this subject is based on a fact that

the discrete nature of the electron spectrum in these systems will result in exponentially long: T_1 expf =Tg (here is the electron energy level spacing and T is the temperature) dependence of the nuclear spin relaxation times T_1 on the system parameters, [14]. We assume here that similar law should take place also in the nanostructures with well defined size quantization of the electron spectrum. Note that in this case T_1 is very sensitive to the potential fuctuations, caused by the inhomogeneous distribution of impurities in a heterojunction [20]. Intensive experimental studies [15{17}] of this phenomenon have provided a more detailed knowledge on the hyper neinteraction between the nuclear and electron spins in heterojunctions and quantum wells. It was observed that the nuclear spin relaxation time is rather long (up to 10^3 sec) and the hyper neinteraction on the charge carriers spins is extremely high, up to 10^4 G [15,16]. Till now, however, the manifestations of the hyper ne interaction in quantum interference (mesoscopic) phenomena has not been studied.

Spin-orbit interaction plays an important role in mesoscopic physics. In disordered quantum rings it was studied in [11,12], where universal reduction of the PC harmonics was obtained. Similar conclusions were drawn in [13] where the SO interaction species for a GaAs/AlGaAs heterojunctions was studied. We show here that in such systems SO combined with the hyper neeld, produced by strongly nonequilibrium nuclear spin population can play a constructive role in creating an analog to ABe ect.

The contact hyper ne interaction is [4]:

Here $_{\rm B}$ is the Bohrm agneton, $_{\rm n}$ is the nuclear magneton, I; ;R $_{\rm i}$;r are the nuclear and the charge carriers spins and position vectors, respectively. It follows from Eq. (1), that once the nuclear spins are polarized, i.e. if $_{\rm i}^{\rm P}$ $_{\rm i}$ I $_{\rm i}$ i $_{\rm i}$ 0, the charge carriers

spins feel the elective, hyper ne eld B $_{\rm hypf}$ = B $_{\rm hypf}^{\circ}$ exp (t=T1) which lifts the spin degeneracy even in the absence of external magnetic eld. In G aA s/A IG aA s one may achieve the spin splitting due to hyper ne eld of the order of the one tenth of the Fermi energy [15,16].

Let us suppose therefore that the charge carriers spin orientation is partially polarized during the time interval of the order of T_1 . It is quite obvious that the topologically nontrivial spin texture combined with the spin-orbit interaction will result in a persistent current.

The spin-orbit interaction in G aAs/A is aAs heterostructures was widely studied both theoretically and experimentally (see [6] and references therein). The main contributions came from a) bulk inversion assymmetry and b) from the structure inversion asymmetry, rst pointed out in [7]. Since both contributions are of comparable value, in what follows we will concentrate, for simplicity, on the typical for a heterojunction Bychkov-Rashba term [7]

where = $0.6 10^9$ eV cm for holes with m = $0.5 m_0$ (m₀ is the free electron m ass) [7,18], and = $0.25 10^9$ eV cm for electrons [7,19], i ,p_i are the charge carrier spin and m omentum and is the normal to the surface. It can be rewritten in the form

h i stands for a nonequilibrium carriers spin population. Under the conditions of a topologically nontrivial orientation of A $_{\rm eff}^{\rm G\,aA\,s}$ (see the discussion below) the wave function of a charge carrier encircling the ring gains the phase shift similar to the

one in an external magnetic eld like in the ordinary ABE. This phase shift can be estimated as follows

where L is the ring perimeter. To observe the oscillatory persistent current connected with the adiabatically slow time-dependent h (t)i; L is supposed to be less than the phase breaking length. Taking the realistic values for L 3 m [3] and h i 0:05 0:1 [15,16] we estimate 2 5 10 which shows the experimental feasibility of this e ect.

The standard de nition of the spontaneous diam agnetic current is

where F is the electron free energy and $_{\rm ext}$ is the external (probe) magnetic ux. The oscillations of persistent current arise due to the exponential time dependence of the phase $_{\rm eff}^0$ expf t=T₁g in Eq. (5), with the time constant T₁ From the analogy with the standard ABE in a mesoscopic ring, we expect the following from for a persistent current in an one dimensional quantum ring at low enough (T) temperature

Here o is the initial phase value. We outline the marking dierence between the periodical time dependence of standard AB oscillations, which are observed usually under the condition of linear time variation of the applied magnetic eld and the hyper ne driven oscillations which die o due to the exponential time dependence of the nuclear polarization.

In what follows, we present the m icroscopic justication of the qualitative m odel discussed above.

The microscopic description is based on a following Hamiltonian

It describes the carriers, con ned to an one-dimensional ring of radius , placed in the (ZY) plane, in a case of inhom ogeneous SO coupling which, as will be discussed later, is one of the possible realizations of a topologically nontrivial elective vector potential Eq. (4). The ring is pierced by an external magnetic ux , B $_{\rm hypf}$ is the hyper ne eld oriented along the Z -axis. Note, that the Hamiltonian, Eq. (8), is a generalization of = const, studied in [13], for the case = (').

Let us show, within the perturbation theory, that the lh.s. of the Eq. (6) is nonzero at = 0. Since the electron Zeem an splitting in G aAs/A ls aAs, caused by the hyper ne eld, B_{hypf} at strongly nonequilibrium nuclear population, exceeds h= in micron rings, we may safely neglect the electric spin-orbital eld compared to the hyper ne one. The zero-approximation eigenfunctions and eigenvalues are, respectively

The ux-dependent rst order corrections to $"_n$ are

It follows that each level carries current if the integral in the rhs. of the Eq. (10) is nonzero. This implies topological restrictions on the function (') which are equivalent to existence of a topologically nontrivial spin texture.

Calculation of the rst order correction to the free energy is straightforward, and using the Eq. (6) the spontaneous persistent current can be found to be

is the nonequilibrium spin population introduced in the Eq. (4), and (t) is the topological phase Eq. (5). We note, that Eq. (12) is the rst term of the expansion of the phenom enological equation Eq. (7). It follows, that the direct quantum mechanical calculation con rms the existence of a spontaneous persistent current, induced by combined action of the nonequilibrium nuclear spin population and spin-orbit coupling.

Consider now the possibility of creation of a topologically nontrivial elective vector potential delength in Eq. (5). In the geometry where the vector period, Eq. (2), is normal to the heterojunction, either the nuclei polarization driven (') or the spin-orbit coupling (') should be inhomogeneous along the perimeter of the ring. Out of a variety of dierent experimental realizations let us outline the following ones.

Since the nuclear relaxation rate T_1^{-1} in G aA s/A IG aA s heterojunction is highly sensitive to the impurities distribution [20], one can achieve dierent nuclear polarization in dierent parts of a mesoscopic ring, provided the characteristic length of the impurity potential is of order of several hundreds of A , i.e. comparable to the ring width. In this conguration we expect that the mesoscopic sensitivity to a single impurity position may produce a nonvanishing phase Eq. (5).

A nother way of obtaining a nonzero circulation of the elective vector potential is creation of the slow ly varying on the scale k_F^{-1} coordinate dependent spin-orbit coupling (') connected with external potentials like boundaries, heavy atoms impurities along the perimeter of the ring and other imperfections which may locally modify the spin-orbit interaction in these systems.

To sum marize, we propose here a new, hyper ne eld driven (meso-nucleospinic) mesoscopic e ect: the Aharonov-Bohm like oscillations of a persistent current in a GaAs/AlGaAs mesoscopic ring in the absence of external magnetic eld. We note that the large (of the order of 1Tesla) hyper ne eld results in the nonequilibrium population of the charge carriers spins. The latter, under the conditions of the topologically nontrivial spatial elective vector potential distribution results in a persistent current. This current is oscillating (aperiodically) and decreasing with time during the time interval of the order of the nuclear spin-relaxation time T_1 . At low temperatures T_1 can be su ciently long and the predicted oscillations experimentally observable..
