# $M$ agnetoplasm a excitations of tw o vertically coupled dots

#### Abstract

A classical hydrodynam ic approach is used to calculate the m agnetoplasm a excitations of two vertically coupled electron dots. The electrons are conned by di erent parabolic potentials in which case K ohn's theorem is no longer valid. The equilibrium density pro les of the electrons in both dots are calculated as function of the interdot distance. $W$ e nd that for unequal con nem ents of the two dots the electron density in one of the dots becom es ring-like. T he electron densities are then used to obtain the $m$ agnetoplasm a frequencies. The oscillator strengths are calculated, and we nd that other then the center of $m$ ass $m$ odes can be excited due to the electron-electron interactions.

M odem sem iconductor technology m akes it possible to fabricate low -dim ensional nanostructuresw ith controllable chem icalcom position and geom etric structure. In arti cialatom s a num ber of electrons are con ned into a single quasi-two-dim ensional quantum dot which has been w idely studied over the past few years (see, for instance, Ref.'İ'). M ost of the w ork has focused on quantum dotsw ith a soft lateralcon nem ent potential in the heterostructure plane (2D-plane) which are the so called parabolic quantum dots. Such quantum dots exhibit a far-infrared absonption spectrum which re ects only the center ofm assm otion of the electron system which is a consequence of a generalized $K$ ohn's theorem $n_{2}^{\prime}$ W hen a magnetic eld is applied perpendicular to the plane of the quantum dot it results into tw o absonption peaks whose positions are independent of the num ber of electrons in the dot. N ote that the sam e absonption spectrum follow from a pure classical analysis. In order to reveal effects due to electron-electron interaction the con nem ent potential should be anharm onic, or band non-parabolicity e ects should be taken into account.

The other possibility to trace the in uence of electron-electron interaction on the quantum dot properties is to consider the $m$ ore sophisticated system of coupled quantum dots. An exam ple of such a system are two vertically coupled dots. The properties of such a system for $s m$ all num ber of electrons were studied previously via exact diagonalization ${ }^{\frac{3}{3}}$ or for a m odel system with an exactly solvable interaction ${ }^{\prime \prime}$ where the $m$ ain attention was on electron correlations in the ground state, $m$ agic num bers and the possibility of the appearance ofnew type ofentangled electronic states. In Ref.'1-1 it was show n that in the case ofa double dot system, containing three electrons, with di erent parabolic con nem ent potentials, the electron correlation e ects exhibit them selves in the absorption energy. T he classicaldouble dot system containing $a_{1}$ nite num ber of electrons exhibits a rich variety of rst, second and higher order transitionsiti T wo vertically aligned dots is the nite system analog of the well studied bilayer system s'l' which have been show $n$ to exhibit m uch richer physical phenom ena then 2D and 3D system s.

Such coupled dot system s can be realized for exam ple in vertically etched double quantum well structures ${ }_{r}^{\frac{1}{1}}$ parallel layers of self assem bled quantum dotsin and by using a conducting atom ic force $m$ icroscope tip above a quantum well which, can induce locally a dot structure in the quantum well and one beneath the low est barrierin. Recently, the successfiul grow th of vertically aligned dots of up to 10 layers of InA s islands separated by G aA s spacer layers were reported ${ }^{\text {2 }}$ ㄴ These experim ental attem pts are still in their infancy and to our know ledge no $m$ agneto-absorption experim ents have been perform ed yet.

The purpose of the present paper is to study the properties of the system consisting of two vertically coupled quantum dots in a uniform perpendicular magnetic eld. We calculate the electron density pro les, the spectrum ofm agnetoplasm a excitations and the corresponding power absorption. $W$ e restrict our consideration to dots $w$ th a large num ber ofelectrons. In this case the classical hydrodynam ic approach is adequate, and we follow the ideas presented in the paper of Ye and Zarem bat ${ }^{12}$ w where the single quantum dot w ith quartic con ning potential corrections was considered. A sim ilar technique was used to study one


W e consider two in nitely thin two-dim ensional circular sym $m$ etric dots which are vertically aligned and are separated by a distance a as is schem atically shown in Fig.' electrons are con ned by di erent parabolic potentials. In the hydrodynam ic approach the electrons are described by density functions $j(r)$ where $j=1 ; 2$ refers to the corresponding dot, and $r=(x ; y)$ is the position coordinate in the plane of the dot. Those electron densities create an electrostatic potential' ( $r$; z) which obeys Poisson's equation

where is the dielectric constant of the $m$ edium the electrons are $m$ oving in. We assume that is constant thrroughout the whole system which is a good approxim ation for e.g. the GaA s/A $\frac{1}{x} \mathrm{Ga}_{1 \times}$ A $s$ system.

In a purely classical approach, the electrons in both dots achieve an equilibrium distribution in which the lateral force arising from the con ning potentials is balanced by the electrostatic repulsive force due to the electrons. Equivalently, the equilibrium conditions can be expressed as the constancy of the chem icalpotential in each of the dots given by the expressions

Here the strength of the parabolic con nem ent potential is characterized by the corresponding factor $k_{i}$ which is related to the con nem ent frequency as $!_{j}=\overline{k_{j}=m}$. Here and further the symbol $m$ stands for the e ective electron $m$ ass. The di erence in the above chem ical potentials can be controlled by applying som e extemalbias potential

C ondition ( $(\underline{2}-\overline{3})$ ) together w th de nitions ( set of equations from which the equilibrium electron density pro les in the dots can be obtained. In a classical description the equilibrium electron distributions are not in uenced by an extemalm agnetic eld.

In order to obtain the excitation spectrum and the power absonption in the coupled dot system the $s m$ all harm onic deviations from the electron equilibrium density and potential functions have to be introduced

Here the symbol $!_{c}=e B=m \mathrm{c}$ stands for the electron cyclotron frequency, and ! is the frequency of the extemal perturbation, i.e. the far-infrared radiation. Poisson's equation together w ith Eqs. (2. $\overline{-} \mathbf{G})$ and $\left(\underline{2} \cdot \bar{T}_{1}\right)$ com pose the basic set for the coupled dots, from which the excitation spectrum w ill be obtained.

In order to calculate the power absonption spectrum the sam e equation set has to be used but w th the single replacem ent ' ! $\quad$ + ${ }^{\text {ext }}$, where the extemal eld potential' ext is added. Then the frequency dependent power absorption spectrum is calculated in the standard way using the follow ing expression

## III. EQUIIBRIUM PROPERTIES

The rst step in the static problem is obtained by replacing Poisson's equation (2. 2 I' ${ }^{\prime}$ ) by the hom ogeneous Laplace equation which is solved w ith the follow ing boundary conditions for the potential in the dots

As was shown in Refs. 1 this static problem is to use the $\mathrm{q}_{\mathrm{ob}} \mathrm{oblate}^{2}$ spheroidal coordinate ${ }_{q}$ system centered in the dot,

: In this coordinate system the disk corresponds to the region $=0 ; 0 \quad 1$. The advantage of this coordinate system is that the variables in Laplace's equation can be separated and the solutions can be expressed as a linear superposition of the potential

Now the static problem is reduced to the solution of an algebraic set of equations for the expansion coe cients which follow s from the equilibrium conditions.

We shall use a sim ilar approach in our coupled dot problem. In order to have the $m$ ost simple expressions for the $m$ ain part of the electron-electron interaction, nam ely the electron-electron interaction in the same dot, we introduce two coordinate system s each centered in the corresponding dot. W e rescale both coordinate system $s$, replacing $r$ ! $r R_{i}$, and introduce the oblate spheroidal coordinates in each of the dots, respectively. Next, we divide the potential into two parts ' $={ }^{\prime}{ }_{1}+{ }^{2}$, each created by the electron density in the corresponding dot, and introduce dim ensionless variables by perform ing the follow ing transform ations

H ere the sym bol w stands for the coordinate in one dot calculated in the coordinate system of the other dot. T he superscripts indicate whether the potential is created by the electron density in the sam e dot ( ${ }^{\text {dot }}$ ) or the electron density outside it ( ${ }^{\text {put }}$ ).

Laplace's equation $m$ ust not be inchuded into the set ofequations because, as is discussed above, its solutions are already know $n^{12}-2$ and can be presented as

In that case we obbtain $\mathrm{v}_{1}=\mathrm{v}_{2}=\mathrm{n}_{1}=\mathrm{n}_{2}=1$ which corresponds to the single parabolic dot solution For the general case we solved the problem num erically by $m$ eans of $Q R$-decom position of the truncated matrix ${ }_{1} 11 / 2 \mathrm{We}$ restricted our consideration to 9 potential harm onics for each dot which was su cient to
obtain an accuracy better that $0.1 \%$. W e should note that in the case of di erent con ning potentials $\& 1$ or with an applied bias eV 0 the num erical solution can not be found straightforw ardly because of the unknown ratio of the dot radii. $W$ e found by solving the boundary condition (2, in iteratively. A fter the ratio of the dot radii is found all quantities of interest can be calculated just using the scaling factors introduced in Sec.'ilin, nam ely,

Here the symbolN $=\mathrm{N}_{1}+\mathrm{N}_{2}$ stands for the total num ber of electrons in boths dots, and two scaling factors $\mid R_{0}=\left(3 e^{2} N=4 k_{1}\right)^{1=3}$ and $0=3 N=2 R_{0}^{2} \mid$ are used. The rst one corresponds to the equilibrium radius of the rst dot when allelectrons are situated in this dot.

The num erical results ilhustrating the equilibrium electron densities in the dots are show $n$
 for various distances a between the two dots. In the case when there is no extemal bias $\left(l_{1}=2\right)$ both dots have the sam e density of electrons $\left(\mathbb{N}_{1}=N_{2}=N=2\right)$. In the lim iting case of sm all distanges betw een the dots the result reduces to the single parabolic dot w ith density pro le i $1 r^{2}=R_{0}^{2}$. In the opposite case of large interdot distances we again have two parabolic dots where in the above density functions the radius is scaled by $2^{1=3}$. For interm ediate distances, how ever, the density pro le di ers from that of a single parabolic dot. This is illustrated in Fig.' dot density w ith the sam e dot size and the sam e total num ber of electrons as those for the coupled dots $w$ ith interdot distance $a=R_{0}=0: 3$. The dependence of the dot size, $R_{i}$, on the interdot separation is show $n$ in the inset of $F$ ig. $\overline{\text { th }}$. W ith decreasing interdot separation the size of the dots increases and the electron density pro le is m ore spread out. In Fig. 'isi' the density pro les for the case of di erent con ning potential strengths ( $=2,1=2$ ) are given for the sam e values of the interdot distances as in $F$ ig. 'i. i . N otioe that now the density pro les di er essentially from the single parabolic dot solution. In the case of sm all interdot distances even a ring like distribution can be obtained when the electrons in the dot w ith the weakest con nem ent are pushed outside. The above ring like distribution e ect can be even $m$ ore reinforced by applying an extemalbias. $N$ otice also that $w$ ith decreasing interdot distance electrons from dot 2 are $m$ oved into dot 1 in order to keep the chem ical potential the sam e (see inset of Fig . of the two dots on the distance betw een the two dots.

## IV. MAGNETOPLASMA EXCITATIONS

To solve the dynam ic equations $(\overline{2} \overline{2} \overline{1}),(\overline{2} \cdot \overline{1})$ and $(\overline{2} \overline{2})$ we use the sam e oblate spheroidal coordinate technique as in the static case which was described in previous section. Restricting ourselves only to those $m$ odes which can be excited in the dipole approxim ation we use the follow ing expansions for the harm onic deviations of the electron density

The symbol $=1$ is the angular $m$ om entum of the excited harm onics actually indicating the polarization of the circularly polarized electric eld. The above electron density and potential harm onics obey the sam e boundary conditions in the dots as given by Eq. ## V.POW ER ABSORPTION

We restrict our consideration to the case of weak dissipation when the m agnetoplasm a excitation spectrum can bem ost easily revealed. In that particular case the pow er absonption

In the case of weak dissipation the quantities (5.1.1) together $w$ th the $m$ ode frequencies $!_{i}$ characterise the pow er absorption. By analogy to quantum $m$ echanicalproblem $s$ they can be referred to as the classicaloscillator strengths. A s is shown in A ppendix 'AA.'. these oscillator strengths obey a general sum nule like their quantum mechanical countenparts, indicating that the interaction variation in the system leads to the redistribution of pow er absonption am ong various vibration $m$ odes while the total pow er absorption rem ains unchanged.

For the case of equivalent dots $=1$ and $1_{1}=2$ the eigenfrequencies and oscillator strengths are given in F ig. i . The frequencies in the lim iting case of a! 1 are shown in Fig.' $\mathrm{I}_{1}^{\prime}(\mathrm{a})$ as function of the applied m agnetic eld (! $\mathrm{c}_{\text {) }}$. The eigen frequencies for clockw ise circular polarization ( $=1$ ) are shown by solid curves while the dashed curves indicate the eigenfrequencies for the opposite polarization $(=1)$. In the lim it case a ! 1 of decoupled dots one nds that $W{ }_{\mathrm{ln}}^{(\mathrm{i})}=0$ and $\mathrm{V}_{\mathrm{ln}}^{(\mathrm{i})}$ is a diagonalm atrix (see Eqs. (4.9) and (4.10)). Then the eigenm odes are the basisfunctions $\mathrm{P}_{21+1}^{1}()$ and the spectrum branches can be uniquely labeled with the num bers ( $1 ;=1$ ). In this lim it the eigenfrequencies are twofold degenerate and coincide w ith the single parabolic dot frequencies presented in Ref. $1_{1}^{1} \bar{Z}$. In the low frequency region a large set ofbranches are found which correspond to the edge m odes. They are not resolved and shown up as a shaded area. In Fig. 'i'i (b) the spectrum for an interdot separation of $a=R_{0}=0: 5$ is presented. For the sake of convenience we still label the branches by the previous l-values in order to show the correspondance of the branch to its counterpart in the a! 1 lim iting case. In this case in fact severall-values are $m$ ixed. N ote that when the distance between the layers decreases the degeneracy is liffed and all branches are split into two and are shifted down in frequency except for the two branches depicted by the thick curves which correspond to the center of $m$ ass $m$ otion of the whole system of electrons in both dots. Only the latter two frequencies have non zero oscillator strengths which do not depend on the_interdot distance and are shown in Fig. $\overline{4}(\mathrm{c})$. This is in accordance w th K ohn's theorem '2'i' which can be easily generalized to our vertically aligned two dot system for the case of identical dots, i.e. = 1. T he decrease of the eigenfrequencies with decreasing interdot distance is a consequence of the increase of the repulsive interaction of the electrons in the di erent dots and is discussed in m ore detail in A ppendix '

The case of nonequivalent dots is illustrated in Figs. ${ }_{1}^{15}$, and where the results for
$=2$ and $1_{2}=2$ are presented. The frequencies for the a! 1 lim it are show $n$ in Fig.' ${ }_{-1}{ }_{-1}(a)$, and the corresponding oscillator strengths are shown in $F$ ig. ${ }_{-1}^{\prime 5}(\mathrm{~b})$. In this case the system consists of two noninteracting parabolic dots where the frequencies are scaled by the factor $P=P_{2}$. The branches are labeled $w$ ith the corresponding l-value. The non-zero oscillator strenghts are those which corresponds to the center of $m$ ass $m$ otions of the electron system $s$ in the separate dots. $N$ ote that the oscillator strengths obey the sum rule that the sum of the oscillator strengths equals 1 independent of $!_{c}$. The redistribution of the oscillator strengths between the separate dot branches actually re ects the electron num ber redistribution between the dots ( $s e \mathrm{~F}$ ig. . $\mathrm{i}_{-1}^{\overline{3}}$ ') . It is also evident that those spectrum branches which are closer to the cyclotron resonance branch (! = ! ${ }_{c}$ ) have essentially larger oscillator strengths.

The spectrum branches and the oscillator strengths change fundamentally when nonequivalent dots are put closer to each other as is shown in Fig.' $\mathrm{I}_{-1}$. N ow all the branches are shifted dow $n$ in frequency and non-zero oscillator strengths corresponding to other then the center ofm ass m otion branches start to appear. For instance, in Fig.' ${ }_{-1}(\mathrm{G})$ ) the oscillator strengths corresponding to the frequency branches ( $1=1$ ) are non-zero as shown by the curves labeled 5 and 6 . T he reason is that for nonequivalent dots the electron density distributions are far aw ay from the parabolic dot distribution (see, Fig. .
is no longer valid. N ote also from Fig. $1 \overline{1}(\mathrm{~T}(\mathrm{a})$ that the frequency shift to lower frequencies is $\mathrm{m} u \mathrm{ch}_{\mathrm{m}} \mathrm{m}$ ore pronounced as com pared to the case of equivalent dots ( F ig. $\mathrm{I}_{1 / 4}(\mathrm{~b})$ ). The above frequency shift can be even $m$ ore am pli ed when an extemal bias is applied. This is ilhustrated in F ig. $I_{1}^{1}$, where the results for $=2$ and $1_{2}=0.2$ are given. From $F$ ig ${ }_{2}^{\prime \top}(a)$ we see that now the $(l=1)$ branches start to interfere with the $(l=0)$ ones. A though there is still no intersection w the branches of the sam e polarization the branch ( $1=1,=1$ ) approaches the cyclotron resonance line ( $!=!{ }_{c}$ ) so closely that the oscillator strength (see F ig. $\mathrm{I}_{1}^{\prime}(\mathrm{b})$ ) is transferred from the m ain branch $(1=0,=1)$.

W e would like to note that in the above case of nonequivalent dots when the system no longer obeys $K$ ohn's theorem the edge $m$ odes have $s m$ all but non-zero oscillator strengths. In order to reveal those weak $m$ odes we perform ed a $m$ ore accurate dynam ic $m$ atrix diagonalisation for the case $1=2, a=R_{0}=0: 5$ and $=2$ by restricting ourselves to the $l=0$ and $l=1$ com ponents for each dot. The results for the edge $m$ odes (curves 9 and 10) together w ith the oscillator strengths for the upper $1=1 \mathrm{~m}$ odes (curves 7 and 8 ) are given in $F$ ig. ${ }^{18} \mathbf{- 1}$. W e see that the oscillator strengths becom $e$ very $s m$ all for spectrum branches $w$ hich are substantially di erent from the above $m$ entioned $!=!{ }_{c}$.
VII. CONCLUSIONS

In this paper, we have studied the $m$ agnetoplasm a excitations in tw o vertically coupled electron dots in the dipole approxim ation. W e used the classical hydrodynam ic approach which is adequate in the lim it of a large num ber ofelectrons. The con nem ent potentialw as taken parabolic in both dots. W e calculated the equilibrium electron density distribution as function of the interdot distance. As function of the $m$ agnetic eld the frequency spectrum and the corresponding oscillator strengths are calculated.

In the case of equivalent dots, i.e. both dots have the sam e parabolic con nem ent strength, the equilibrium density distribution is sim ilar to the single dot parabolic one, and due to the generalized $K$ ohn's theorem only the center ofm ass $m$ otion can be excited.

If both dots have a di erent parabolic con nem ent the electron densities can di er appreciably from the parabolic case. Even ring like electron distributions are found. D ue to the fact that both dots have di erent con nem ent potentials $K$ ohn's theorem is no longer valid and other $m$ odes then the œenter of $m$ ass $m$ otions can be excited. T he largest oscillator strengths are found for the $m$ odes closest to the cyclotron frequency. If an extemalbias potential is applied the oscillator strengths of other then the center ofm ass m odes are even $m$ ore enhanced. C rossover phenom ena can be observed in this case. For nonequivalent dots, even the edge $m$ odes have $s m$ all but non-zero oscillator strengths.

## APPENDIX B:TW O COUPLED OSC ILLATORS W ITH REPULSIVE INTERACTION

In Sec. VI it was show $n$ that all the spectrum branches show a generalbehavior, nam ely the frequencies decrease w ith decreasing interdot distance. Such behavior is caused by the repulsive interaction of the electrons belonging to di erent dots, and can be explained using the follow ing sim ple $m$ odel. $W$ e focus our attention to the center of $m$ ass $m$ otions of the
electrons of the seperate dots. In the case the dots are decoupled (a! 1) those motions can be treated as tw o independent oscillators in a magnetic eld perpendicular to the plane ofm otion. W hen the dots are put closer to each other, say, to som e distance a $R_{i}$, the interdot electron interaction can be approxim ated by

is alw ays negative what con m s that the interdot interaction ofelectrons causes a negative frequency shift, and thus, illustrates the previously obtained negative shift of the spectrum branches w th decreasing interdot distance.

The power absorption for this $m$ odel system can also easily be calculated. It reads

It can be checked straightforw ardly that the oscillator strengths obey the sum rule ${ }^{P}{ }_{i=1}^{4} f_{i}=$ 1. They show the correct qualitative behavior as function of the cyclotron frequency as show $n$
