Irreversible shape distortions by ux-pinning-induced magnetostriction in hard type-II superconductors

Exact analytical results are obtained for the ux-pinning-induced m agnetostriction in long cylinders of type-II superconductors placed in a parallel magnetic eld. New e ects are found regarding the inversible deformation of the cross-sectional area: W hereas the magnetostriction of a circular cylinder is shape conserving, it is shown that a square cross-section deforms with considerable distortion. During a eld cycle both concave, convex, and even more complicated distortions are predicted. The strong implications for the interpretation of dilatom etric observations are pointed out. The main results obtained for both the circular and square geom etry are valid for any critical-state m odel, $j_c = j_c$ (B), and we use the Bean m odel for illustration and discussion.

It was discovered by Ikuda and coworkers¹ that high tem perature superconductors (HTSCs), when placed in a magnetic eld, can respond by a giant magnetostriction. Relative changes in sample size as large as 10⁴ were observed in single crystals of Bi₂Sr₂CaCu₂O₈. To explain this deform ation, which is about two orders of magnitude larger than values reported for conventional superconductors,² they considered the stress exerted on the crystal by pinned vortices. Treating the crystal as an in nite slab of halfwidth, w, placed in a parallel applied eld, $B_a = 0$, the pinning-induced magnetostriction in the transverse direction was derived from the criticalstate m odel to be

where c is the elastic constant and B (x) the local induction. As evident from eq.(1), and also pointed out immediately by Ikuta et al., the pinning-induced magnetostriction is intimately related to the magnetization, and consequently should display similar irreversible characteristics. Following the discovery, the giant magnetostriction was observed also in single crystals of other HTSC materials,³ thus establishing the e ect as being a general phenom enon which, like the magnetization, can provide important information about the pinning properties.

M agnetostriction, as dilatations in general, are most frequently measured by displacive sensors like e.g. a capacitance dilatom eter cell. Such sensors provide an electrical signal which norm ally represents the variation in the end-to-end dimensions of a sample.⁴ A lthough very high sensitivities (10^{-12} m) can be achieved, the cells are usually designed so that distortions in shape are not accounted for, or they may even in uence the measurements in an uncontrolled way. Up to now, shape distortions in connection with the pinning-induced magnetostriction were never considered, and all data analysis

has been based on the relation eq.(1) valid for plane strain deform ations only.

In this letter we show that the pinning-induced stress indeed leads to signi cant shape distortions even in the simple geometry of an in nitely long isotropic cylinder with square cross-section. For comparison we also present the exact solution of the magneto-elastic problem for the circular cylinder where shape is conserved.




FIG.1. Flux penetration and current ow pattern in a circular (a) and square (b) cylinder in the critical-state model. The indicated magnetized states contain a ux front, illustrating that the cylinders generally are divided in shells with di erent volum e forces.

From electrodynam ics the force which drives the vorticies into the material is given by j B per unit volume. For HTSCs in the mixed state under practical conditions the current density, j, is usually set equal to (r = B) = 0as the therm odynam ic eld can be well approxim ated by B = 0.5 In the critical-state m odel one has $iii = i_1$, and a non-uniform distribution of pinned ux transmits onto the crystal a volume force density equal to $f = \frac{1}{2}$ B. In the two geom etries under consideration the symmetry of the force eld is quite di erent, see Fig.1. In contrast to the simple radial distribution shown in (a), the square cylinder in (b) is divided into four regions each containing distributed forces pointing the sam e direction. M oreover, in both cases the cylinder generally has additional divisions into shells where the forces alternate in sign - or they can even vanish - all depending on the magnetic prehistory. In all such states the force exerted on the m aterial per unit volum e is given by

The last form, expressing a purely magnetic free energy of the vortex lattice, is used in the present calculations. In the analysis the strains are assumed well below the fracture limit allowing linear elasticity theory, and hence the principle of superposition, to be applicable.

In the circular cylinder the rotational symmetry in – plies that the deformation is described by a radial displacement eld, $u_{t}(r)$. The non-vanishing components of the strain are $e_{r} = u_{r}^{0}(r)$ and $e = u_{r}=r$, which are related to the stress components, and r by $E e_r = r$ and E e = r. Here E and is the Young's modulus and Poisson's ratio, respectively.

The condition of static equilibrium is that (d $_r$ =dr) + ($_r$)=r + f = 0, which in term s of the displacement eld is expressed as

Integration twice, and using that $u_r(0) = 0$, gives

where F (r) $\frac{R_r}{_0} f(r^0) dr^0 = \mathbb{B}^2(0)$ $\mathbb{B}^2(r) = 2_0$. With the constant C determ ined by the free surface condition r(r = R) = 0, the result becomes

which is the exact solution from which a complete stressstrain picture can be expressed in terms of the ux density B (r). E g., the radial stress is given by

The eqs.(5) and (6) generalizes expressions for u_r and $_r$ derived recently⁶ only for the Bean model, $j_c(B) = constant$. W e em phasize that our results are valid for any critical-state model.

For the external dilatation, $R = R = u_r (R) = R$, one obtains from eq.(5)

This formula for the pinning-induced magnetostriction of a circular cylinder, rst found by Johansen et al., is very similar to the expression in eq.(1) for the slab. The extra factor r in the integral is a simple modi cation, which one nds analogously in the expressions for the critical-state magnetization. The factor 1 recets the stronger constraint on free expansion for the cylinder as com pared to the slab.




FIG.2. Magnetostriction, R = R (1) ($_0 j_0 R$)²=E $_0$, as function of applied eld for a circular cylinder with $j_c = j_0 \exp(\frac{1}{3}j=B_0)$. Curve (1); $B_0 = 1$ i.e. the Bean model and (2); $B_0 = _0 j_0 R = 0$ 3. The eld axis is normalized by the full penetration eld $B_p = B_0 \ln(1 + _0 j_0 R = B_0)$.

From eq.(7) analytical expressions for the various branches of magnetostriction hysteresis loops are readily derived. Figure 2 shows how R=R depends on the applied eld for two commonly used critical-state models. A s B_a runs through a complete cycle R=R displays a huge hysteresis loop where in the B ean model case both the main ascending and descending branches are linear provided a su ciently high maximum eld. Am ong other features of the B ean model results is that the maximum rem anent magnetostriction is given by

Since the remanent state has no contribution from reversible components, the above relation provides a means to infere j_c from magnetostriction measurements. In the eld range where the main branches are linear the verti-

calwidth of the hysteresis loop equals

N ote in particular that if the hysteresis width is norm alized by (R = R)_{rem} the value of j_c can be found from the

slope in a plot versus B_a w ithout know ledge of the elastic constants. The norm alized width is simply 8B_a= $_{0}$ j_cR, a result analogous to the extensively used Bean model relation between j_c and the width of the magnetization loop. Conversely will measurements of magnetostriction allow determination of the elastic parameter (1)=E if j_c is known from other measurements.

The more curved hysteresis loop resulting from the exponential model, $j_c = j_0 \exp[\frac{3}{3}\frac{1}{7}B_0]$, graph (2) in F ig 2, is usually a better description of observed m agnetostrictive behavior in HTSCs.^{3;8}. An extensive analysis with various j_c (B)-functions is subject of a forthcom ing paper, where also the rather lengthy expressions for the di erent branches in F ig 2, is presented.

A nal remark on the circular case is that the integral in eq.(7) also can be written as $_{0}^{R} r^{2} f(r) dr$, i.e., the R=R is given as the second moment of the volum e force distribution just as the j_c-bops determ ine the magnetization. One could be tempted to generalize the relation to other cylindrical geometries, and thus allow for a simple united treatment as done in magnetization calculations.⁹ However, such generalization would be incorrect, as will become evident as we now turn to the square cross-section case.

A di erent approach is chosen to analyze the magnetoelastic problem of the square cylinder. W ithin the linear elasticity approximation one can separate the treatment into an in nite number of deformations produced by in-

nitessim al square loops of the force eld (Fig.1 b). The nal result is obtained by superimposing the elastic response of the whole cylinder to each force loop. For this to be a useful approach one needs a way of adding these deform ations in a coherent manner. We rst show that this indeed is feasable for the square cylinder.




FIG.3. (a) Partial e ect of the volum e force in a square cylinder. By the shown transform ation the elastic problem can be treated analytically using superposition, see text. (b) Schem atic picture of the deform ation (strongly am pli ed) of a square cylinder in the case of (left) incom plete and (right) com plete ux penetration.

Consider the e ect of a square force loop of width dx with sides a distance x from the origin (Fig.3). The material enclosed by the loop will experience only a norm al stress, and the deform ation becom es a plane strain. The elastic response of the enclosed area is given by $E e_1 = 1$ $_2$ and E $e_2 = _2$ $_1$, where e_1 , e_2 and $_1$, 2 are the plane strain and norm al stress components, respectively. It immediately follows that the relative change in the square area equals $e_1 + e_2 = (1)$)E ¹2p where p = (1 + 2)=2 is the two-dimensional pressure. The enclosed area deform s under this pressure into another square so that a constant gap g is created along the loop. Using that p = f(x)dx, the size of this virtual gap becom es

The sign of g is so that a positive value represents a void space, whereas a negative g corresponds to an expansion of the inner square.

The contribution from this elementary deformation to the strain of the whole body is obtained by recombining

("gluing together") the parts on each side of the virtual gap. The resulting strained state is equivalent to having a pair of edge dislocations in each corner of the loop. A seach pair can be replaced by one dislocation directed along the diagonal, we conclude that the original gap space can be replaced by two slits of width $G = g^2 2$ form ing a central cross. By this transform ation the integral e ect of the entire force eld can be determ ined analytically as follows. Let y denote the distance from the center to a point on a diagonal. At this point the total gap, G, is an accumulation of the gaps G created from y and out to the corner $y = w^2 2$. The total result is therefore given by

The full deform ation is now obtained by "gluing" the virtually disrupted material together. Since $G^{0}(y) / B_{j,y}$ it follows that G(y) is not a linear function, thus proving that the pinning-induced magnetostriction does not conserve shape in the square case.




FIG. 4. G ap shape at various stages of ux penetration. (a) Increasing eld (B_a indicated) and (b) decreasing eld for $B_a=B_p = 0.8, 0.5, 0.2, 0$ (thick line), -0.2, -0.5, -0.8 -1.1.

The eq.(11) allows the gap to be calculated. In the Bean model along the increasing eld branch one nds for G $\,$ G E $_0$ (1 $\,$) $\,^1{\rm B_p}^2$ the expression

in the penetrated region. In the central M eissner area the gap is constant. The behavior is shown in Fig.4 a, and representative examples of the resulting concave deformations are illustrated qualitatively in Fig.3 b. For the fully penetrated state one sees from eq.(12) that G (y) grows linearly with B_a , while at the same time G = 0 at the corners. This produces a deformation where the concave character grows steadily with the applied eld.

The behavior of G'(y) for descending applied eld is shown in Fig.4 b. The deformation along this branch is evidently more diverse even when we om it the stage following immediately after eld reversal. The shown graphs represent only stages where j_c is reversed throughout the sample. The proles with negative G' gives rise to convex deformations. The convexity persists all the way down to the remanent state, where the distortion near the comers is vanished. Then, as the eld is reversed there is an interval where the behavior is governed by a G (y) with an oscillatory shape, thus giving a mixed type of deform ation. As the reverse eld increases in magnitude the shape again becomes concave. For B_a B_p the sam ple shape follows the sam e development as during the eld increase.

In conclusion, we have investigated and compared the pinning-induced magnetostriction in two important geom etries. In contrast to the shape-conserving circular case, which could be solved exactly, the existence of current discontinuity (d)-lines in the square case com plicates the behavior by producing shape distortion. We have predicted the appearance of convex, concave and even m ore complicated types of deform ations where the distortion is of the same order of magnitude as the overall striction. Since in most cases HTSC crystals have a rectangular shape, which always lead to d-lines in the critical-state, the distortion could easily lead to misinterpretation of dilatom etric m easurem ents. The problem should be minimized by (i) having a high aspect ratio rectangular shape so that the central part of the sam ple is described approximately by a plane strain deform ation, and (ii) designing the displacive sensor with a local contact to the long side of the rectangle in order to avoid distorted comer regions. Full analysis of the proper corrections will clearly require num erical work.
