# Irreversible shape distortions by ux-pinning-induced $m$ agnetostriction in hard type-II superconductors

#### Abstract

Exact analytical results are obtained for the ux-pinning-induced $m$ agnetostriction in long cylinders of type-II superconductors placed in a parallel m agnetic eld. New e ects are found regarding the irreversible deform ation of the cross-sectional area: $W$ hereas the $m$ agnetostriction of a circular cylinder is shape conserving, it is shown that a square cross-section deform s w ith considerable distortion. During a eld cycle both concave, convex, and even $m$ ore com plicated distortions are predicted. The strong im plications for the interpretation of dilatom etric observations are pointed out. The $m$ ain results obtained for both the circular and square geom etry are valid for any criticalstate $m$ odel, $j_{c}=j_{c}(B)$, and we use the Bean $m$ odel for illustration and discussion.

It w as discovered by Ikuda and cow orkersll that high tem perature superconductors (H TSC s), when placed in a $m$ agnetic eld, can respond by a giant $m$ agnetostriction. Relative changes in sam ple size as large as $10{ }^{4}$ were observed in single crystals of $\mathrm{B} \dot{1}_{2} \mathrm{Sr}_{2} \mathrm{CaC} \mathrm{u}_{2} \mathrm{O}_{8}$. To explain this deform ation, which is about two orders of m agnitude larger, than values reported for conventional superconductors, ${ }^{2^{2}}$ they considered the stress exerted on the crystal by pinned vortices. Treating the crystal as an in nite slab of half-w idth, w, placed in a parallel applied eld, $\mathrm{B}_{\mathrm{a}}=0$, the pinning-induced m agnetostriction in the transverse direction was derived from the criticalstate $m$ odel to be

where $c$ is the elastic constant and $B(x)$ the local induction. As evident from eq. (1, in , and also pointed out im $m$ ediately by Ikuta et al, the pinning-induced $m$ agnetostriction is intim ately related to the $m$ agnetization, and consequently should display sim ilar irreversible characteristics. Follow ing the discovery, the giant m agnetostriction was apserved also in single crystals of other HTSC m aterials, ${ }^{\frac{3}{4}}$ thus establishing the e ect as being a general phenom enon which, like the $m$ agnetization, can provide im portant inform ation about the pinning properties.

M agnetostriction, as dilatations in general, are most frequently $m$ easured by displacive sensors like e.g. a capacitance dilatom eter cell. Such sensors provide an electrical signal which norm ally represents the variation in the end-to-end dim ensions of a sam ple ${ }^{14^{4}}$ A though very high sensitivities ( $10{ }^{12} \mathrm{~m}$ ) can be achieved, the cells are usually designed so that distortions in shape are not accounted for, or they $m$ ay even in uence the $m$ easure$m$ ents in an uncontrolled way. Up to now, shape distortions in connection $w$ ith the pinning-induced $m$ agnetostriction were never considered, and all data analysis
hasbeen based on the relation eq. (11) valid forplane strain deform ations only.

In this letter we show that the pinning-induced stress indeed leads to signi cant shape distortions even in the simple geom etry of an in nitely long isotropic cylinder w ith square cross-section. For com parison we also present the exact solution of the $m$ agneto-elastic problem for the circular cylinder where shape is conserved.

From electrodynam ics the force which drives the vorticies into the $m$ aterial is given by $j B$ per unit volum e. For H T SC s in them ixed state under practicalconditions the current density, $j$, is usually set equal to ( $r \quad B$ ) $=0$ as the therm odynam ic eld can be well approxim ated by $B=0_{5}^{51}$ In the critical-state $m$ odel one has $j j=j_{c}$, and a non-uniform distribution of pinned ux transm its onto the crystal a volume force density equal to $f=j_{c} \quad B$. In the tw o geom etries under consideration the sym $m$ etry of the force eld is quite di erent, see Fig.1. In contrast to the sim ple radialdistribution show $n$ in (a), the square cylinder in (b) is divided into four regions each containing distributed forces pointing the sam e direction. M oreover, in both cases the cylinder generally has additional divisions into shells where the forces altemate in sign - or they can even vanish - all depending on the $m$ agnetic prehistory. In all such states the force exerted on the $m$ aterial per unit volum $e$ is given by

The last form, expressing a purely $m$ agnetic free energy of the vortex lattice, is used in the present calculations. In the analysis the strains are assum ed well below the fracture lim it allow ing linear elasticity theory, and hence the principle of supenposition, to be applicable.

In the circular cylinder the rotational sym $m$ etry im plies that the deform ation is described by a radial displacem ent eld, $u_{l}(r)$. The non-vanishing com ponents of the strain are $e_{r}=u_{r}^{0}(r)$ and $e=u_{r}=r$, which are related
to the stress components, and $r$ by $E e_{r}={ }_{r}$ and $\mathrm{Ee}={ }_{\mathrm{r}}$. Here E and is the Young'smodulus and P oisson's ratio, respectively.

The condition of static equilibrium is that ( $\mathrm{d}_{\mathrm{r}}=\mathrm{dr}$ ) + $(r \quad)=r+f=0$, which in term $s$ of the displacem ent eld is expressed as

Integration tw ice, and using that $u_{r}(0)=0$, gives

where $F(r) \quad R_{r} f\left(r^{0}\right) d r^{0}=B^{2}(0) \quad B^{2}(r)=2 \quad 0 . W$ ith the constant $C$ determ ined by the free surface condition $r(r=R)=0$, the result becom es

which is the exact solution from which a com plete stressstrain picture can be expressed in term s of the ux density B (r). E .g., the radial stress is given by

 $r$ derived recently ${ }^{\sigma^{6}}$ only for the Bean model, $j_{c}(\mathrm{~B})=$ constant. W e em phasize that our results are valid for any critical-state m odel.

For the extemal dilatation, $R=R=u_{r}(R)=R$, one obtains from eq. (G)

$T$ his form ula for the pinning-induced $m$ agnetostriction of a circular cylinder, rst found by Johansen et al ${ }_{4}^{1 l_{1}^{1}}$, is very sim ilar to the expression in eq. (11) for the slab. The extra factor $r$ in the integral is a simple modi cation, which one nds analogously in the expressions for the critical-state $m$ agnetization. The factor 1 re ects the stronger constraint on free expansion for the cylinder as com pared to the slab.

From eq. $\left(\bar{T}_{1}\right)$ analytical expressions for the various branches of $m$ agnetostriction hysteresis loops are readily derived. Figure 2 show s how $R=R$ depends on the applied eld for two com $m$ only used critical-state m odels. A sB a runs through a com plete cycle $R=R$ displays a huge hysteresis loop where in the B ean $m$ odel case both the $m$ ain ascending and descending branches are linear provided a su ciently high $m$ axim um eld. A m ong other features of the Bean $m$ odel results is that the $m$ axim um rem anent $m$ agnetostriction is given by

Since the rem anent state has no contribution from reversible com ponents, the above relation provides a $m$ eans to infere $j_{c}$ from $m$ agnetostriction $m$ easurem ents. In the
eld range where the $m$ ain branches are linear the verticalw idth of the hysteresis loop equals

$N$ ote in particular that if the hysteresis w idth is norm alized by $(R=R)_{\text {rem }}$ the value of $j_{c}$ can be found from the
slope in a plot versus $B_{a} w$ thout know ledge of the elastic constants. The norm alized width is simply $8 \mathrm{~B}_{\mathrm{a}}=0 j_{c} \mathrm{R}$, a result analogous to the extensively used Bean model relation betw een $j_{c}$ and the $w i d t h$ of the $m$ agnetization loop. C onversely w ill m easurem ents of m agnetostriction allow determ ination of the elastic param eter ( $1 \quad$ ) =E if $j_{c}$ is known from otherm easurem ents.

The m ore curved hysteresis loop resulting from the exponential model, $j_{c}=j_{0} \exp \left[\beta \dot{j} B_{0}\right]$, graph (2) in $F$ ig 2, is usually a better description of observed $m$ agnetostrictive behavior in H T SC sinis. An extensive analysis $w$ ith various $j_{c}$ (B)-fiunctions is sub ject of a forthcom ing paper, where also the rather lengthy expressions for the di erent branches in F ig 2, is presented.
A nal rem ark on the circular case ${ }_{R}$ is that the integral in eq. $\left[\bar{T}_{1}\right)$ also can be written as $\int_{0}^{R_{R}} r^{2} f(r) d r$, i.e., the $R=R$ is given as the second $m$ om ent of the volum e foroe distribution just as the $j_{c}$-loops determ ine the $m$ agnetization. O ne could be tem pted to generalize the relation to other cylindrical geom etries, and thus allow for a sim ple, uni ed treatm ent as done in $m$ agnetization calculations. H ow ever, such generalization would be incorrect, as will becom e evident as we now tum to the square cross-section case.

A di erent approach is chosen to analyze the $m$ agnetoelastic problem of the square cylinder. $W$ thin the linear elasticity approxim ation one can separate the treatm ent into an in nite num ber of deform ations produced by innitessim al square loops of the force eld (Fig. 1 b ). T he nal result is obtained by superim posing the elastic response of the whole cylinder to each force loop. For this to be a usefil approach one needs a w ay of adding these deform ations in a coherent $m$ anner. We rst show that this indeed is feasable for the square cylinder.

C onsider the e ect of a square force loop of $w$ idth $d x$ $w$ ith sides a distance $x$ from the origin ( $F$ ig.3). Them aterial enclosed by the loop will experience only a norm al stress, and the deform ation becom es a plane strain. The elastic response of the enclosed area is given by $E e_{1}=1 \quad 2$ and $E e_{2}=2 \quad 1$, where $e_{1}, e_{2}$ and 1 , 2 are the plane strain and norm al stress com ponents, respectively. It im $m$ ediately follows that the relative change in the square area equals $e_{1}+e_{2}=(1 \quad) E{ }^{1} 2 p$ where $p=(1+2)=2$ is the two-dim ensionalpressure. $T$ he enclosed area deform $s$ under this pressure into another square so that a constant gap $g$ is created along the loop. U sing that $p=f(x) d x$, the size of this virtual gap becom es

$T$ he sign of $g$ is so that a positive value represents a void space, whereas a negative $g$ correspondsto an expansion of the inner square.
T he contribution from this elem entary deform ation to the strain of the whole body is obtained by recom bining

("gluing together") the parts on each side of the virtual gap. The resulting strained state is equivalent to having a pair of edge dislocations in each comer of the loop. A s each pair can be replaced by one dislocation directed along the diagonal, we conclude that the original pap space can be replaced by two slits of width $G=9 \overline{2}$ form ing a central cross. By this transform ation the integrale ect of the entire force eld can be determ ined analytically as follow s. Let y denote the distance from the center to a point on a diagonal. At this point the total gap, $G$, is an accum ulation ofthe gaps $G$ created from $y$ and out to the comer $y=w \quad \overline{2}$. The total result is therefore given by

The fulldeform ation is now obtained by "gluing" the virtually disnupted $m$ aterial together. Since ${ }^{0}(y) / B j_{c} y$ it follow s that $G(y)$ is not a linear function, thus proving that the pinning-induced $m$ agnetostriction does not conserve shape in the square case.

The eq.(11) allow s the gap to be calculated. In the Bean modelalong the increasing eld branch one nds for $G \quad G E \quad 0(1 \quad){ }^{1} B_{p}{ }^{2}$ the expression

in the penetrated region. In the centralM eissner area the gap is constant. The behavior is shown in Fig. 4 a, and representative exam ples of the resulting concave deform ations are illustrated qualitatively in F ig 3 b . For the fully penetrated state one sees from eq. (121) that $G(y)$ grow s linearly w th $\mathrm{B}_{\mathrm{a}}$, while at the sam e tim e $G=0$ at the comers. This produces a deform ation where the concave character grow s steadily w ith the applied eld.
$T$ he behavior of $G(y)$ for descending applied eld is show n in F ig. 4 b . The deform ation along this branch is evidently more diverse even when we om it the stage follow ing im ediately after eld reversal. The shown graphs represent only stages where $j_{c}$ is reversed throughout the sam ple. The pro lesw ith negativeG gives rise to convex deform ations. T he convexity persists all the way down to the rem anent state, where the distortion near the comers is vanished. Then, as the eld is reversed there is an intervalw here the behavior is govemed by a

G (y) w ith an oscillatory shape, thus giving a m ixed type of deform ation. As the reverse eld increases in $m$ agnitude the shape again becom es concave. For $B_{a} \quad B_{p}$ the sam ple shape follow s the sam e developm ent as during the eld increase.

In conclusion, we have investigated and com pared the pinning-induced $m$ agnetostriction in two im portant geom etries. In contrast to the shape-conserving circular case, which could be solved exactly, the existence of current discontinuity (d)-lines in the square case com plicates the behavior by producing shape distortion. W e have predicted the appearance of convex, concave and even $m$ ore com plicated types of deform ations where the distortion is of the sam e order of $m$ agnitude as the overall striction. Since in most cases H T SC crystals have a rectangular shape, which always lead to d-lines in the critical-state, the distortion could easily lead to $m$ isinterpretation of dilatom etric $m$ easurem ents. $T$ he problem should be $m$ inim ized by (i) having a high aspect ratio rectangular shape so that the central part of the sam ple is described approxim ately by a plane strain deform ation, and (ii) designing the displacive sensor w ith a local contact to the long side of the rectangle in order to avoid distorted comer regions. Full analysis of the proper corrections will clearly require num erical w ork.
