# The Sound of Sonolum inescence

#### Abstract

We consider an air bubble in water under conditions of single bubble sonolum inescence (SBSL) and evaluate the em itted sound eld nonperturbatively for subsonic gas-liquid interface $m$ otion. Sound em ission being the dom inant dam ping $m$ echanism, we also im plem ent the nonperturbative sound dam ping in the R ay leigh $P$ lesset equation for the interface $m$ otion. $W$ e evaluate num erically the sound pulse em itted during bubble collapse and com pare the nonperturbative and perturbative results, show ing that the usual perturbative description leads to an overestim ate of the m axim al surface velocity and $m$ axim al sound pressure. The radius vs. time relation for a full SBSL cycle rem ains deceptively una ected.

## 1 Introduction

This extensive study of the sound produced in single bubble cavitation is prom pted by the recent interest in sonolum inescence (SL), ie. the conversion of extemally applied sound in a liquid into light [i]l. It has been generally accepted that the SL light em ission is intim ately connected to the dynam ics of the gas-liquid interface, though the speci cmechanism producing the light ashes has not been uniquely identi ed. $W$ e present here a nonperturbative study of the sound radiated from the subsonically $m$ oving phase boundary between the gas bubble and the liquid in which it is im m ersed. In our approach we rely on the standard treatise of the sub ject [ $[\mathbf{2}]$. A part from the im portance of sound em ission as the prim ary dam ping $m$ echanism under the extrem e conditions of sonolum inescence, the sound signal can be used as another diagnostic tool to study the bubble dynam ics. For detailed
 references to earlier work. W e proceed here in two distinct steps:

To begin with, the motion of the gas-liquid phase boundary is assum ed to be given and we determ ine the resulting sound eld.

Secondly, we consider the feedback e ect of the radiated sound eld onto the phase boundary dynam ics, i.e. we describe the $m$ otion of the bubble selfoonsistently.

The ( m ulti-)bubble cavitation has been studied intensely for som e tim e, because of im portant

experim ental conditions by $G$ aitan and $C$ num [id] perm itting the study of a single gas bubble over long periods of tim e, together w th the ability to drive it extemally by acoustic waves, has focused the experim ental interest on the single bubble sonolum inescence (SB SL) phenom enon. The rem arkable
 em itted w thin 50 ps by apparently about $10^{10}$ atom $\mathrm{s} / \mathrm{m}$ olecules from a gas bubble of sub- m radius.
$T$ he standard theoretical tool in the study of the bubble surface dynam ics is the $R$ ayleigh $P$ lesset (RP) equation, representing the $m$ otion of the gas-liquid interface by the tim e dependent (spherical)
 have been inconporated in m odem approaches: viscosity of the liquid and sound dam ping [īi]. E ects
 role in establishing the param eter regim e for stationary $S B S L$, but will not be further discussed here. In the SB SL cycle the sound em ission produced during the violent bubble collapse tums out to be the
 by the viscous friction. O nly a com paratively tiny fraction of the energy delivered to the bubble by the extemal sound wave is radiated in form of the visible light $\left[1,1,11_{1}^{1}\right]$.

W ew illuse the linear acoustic approxim ation (see Section 2.1), which describes the subsonic propagation ofdensity perturbations in a uid neglecting the e ects ofsound w ave dispersion and absonption [2].]. This approxim ation does not allow us to study situations involving shock wave form ation in the liquid. In Section 22 we solve the sound wave equation for the velocity potential exactly for any given $R(t)$. Our derivation is form ally exact provided the assum ptions of non-dissipative uid dynam ics are valid. O ur expressions account in fullfor retardation and allow an arbitrary incom ing sound eld. $T$ he key result is the exact form of the pressure am plitude radiated from the $m$ oving bubble surface into the surrounding liquid, see E q. (2, $\overline{2} \overline{1})$. In order to com pare $w$ th earlier analytical and num erical work we also derive in Section 2.3 the pertunbative expansion of our general results in pow ens of $R=C_{r}$ i.e. bubble wall velocity divided by liquid sound velocity.

In the subsequent Section 3 we describe a m odel of the bubble interior which is m otivated by the approxim ately hom ologous dynam ics observed in num erical hydrodynam ic sim ulations [1] $\overline{1}]$ : the gas density distribution and velocity eld have been found to show a simple scaling behavior, in term $s$ of the scaled radius variable $\quad r=R(t)$ and $w$ ith $v(r ; t) \quad R$, respectively. $T$ hese num erical results have recently $m$ otivated developm ent of a sem ianalytic approach for the coupled bubble-liquid system, based on a Lagrangian variationalprinciple [13, "14], of which a sim pler variant w illbe used here. This allow s to assess the order ofm agnitude of the feedback e ects of the bubble interior dynam ics.
$W$ ith this preparation we can proceed to the second step indicated above in Section 4, i.e. the derivation of a selfconsistent bubble equation of $m$ otion. There exists already a variety of equations
 the case of the extemally driven dam ped nonlinear bubble oscillations in the SBSL param eter regim e [ Section 2.W e inconporate the extemal sound eld in Section 42 according to standard experim ental conditions realized to date. In Section 4.3 we derive a nonperturbative equation, Eq. ( $(\overline{8} \overline{9})$, which is form ally valid to all orders in $R=C(<1)$, how ever, sub ject to the linear acoustic approxim ation schem e. W e inconporate the bubble interior using the van derW aals equation of state and allow also for a realistic equation of state ( $\mathrm{E} O S$ ) of the liquid. O ur derivations are based on the $N$ avier-Stokes equation and, thus, take the e ects of the liquid and gas viscosities consistently into account.

W e ilhustrate our form al results in Section 5 by studying num erically the properties of an air bubble in water extemally driven by an ultrasound eld w th system param eters in the typicalSBSL regim e $\left[\begin{array}{ll}{[1, ~} & 1 \\ 1 & 1 \\ 1\end{array}\right]$ in $W$ W e show in detail there that the various (nonperturbative) corrections inconporated in the bubble equation of $m$ otion generally result in sizeable corrections of the $m$ axim albubble surface velocity during the collapse. They tend to make the bubble collapse less violent than seen in previous perturbative descriptions. In Section 5.3 we com pute the outgoing com pression wave em itted from
the bubble surface into the surrounding liquid and consider the validity of the acoustic approxim ation. W e present nal rem arks and conclusions accom panied by a brief sum $m$ ary of our work in Section 6 .

## 2 Sound Em ission from Phase B oundaries

W e reexam ine here the sound radiation originating from a moving phase boundary betw een two nonviscous uids, separated by an idealized wall of vanishing thickness. R eferences to earlier w ork on th is
 to these approadhes, we derive exact expressions for the sound eld em itted from a sphericalboundary undergoing arbitrary $m$ otion. We begin in the next subsection by recapitulating som e aspects of nonviscous hydrodynam ics which lead to the (acoustic) approxim ation schem e used here in describing the sound generation and propagation.

### 2.1 A coustic A pproxim ation

The linear acoustic approxim ation is based on the assum ption that the sound eld causes only sm all perturbations of the am bient state of the uid characterized by a vanishing velocity eld and constant density and pressure Ref. [2].]. Thus we shall not consider here nonlinear phenom ena, such as the dispersion and absorption of sound waves in them edium and, in particular, the form ation ofsupersonic shock waves. W e shall see quantitatively in Section 5 that this schem e is fairly well satis ed, though the am plitude of the generated sound eld typically reaches up to $10^{4} \mathrm{~atm}$ near to a SBSL bubble.
$T$ he basic equations of nonviscous hydrodynam ics are:

1. The continulity equation for the uid density, which assures the conservation of $m$ ass:

where f denotes the local uid velocity.
2. The Euler equation, arising from N ew ton's equation ofm otion for a sm all uid cell:

where $P$ denotes the localpressure in the nonviscous uid and the com oving derivative is de ned by $D_{t} \quad Q+v \quad r$. Later we will consider the $N$ avier-Stokes generalization for viscous ow, see Eq. ( 5
3. In the absence of entropy production the set of equations is closed by the EoS relating the pressure to the density. For exam ple, the ideal gas EOS is:

where the adiabatic index denotes the ratio of the speci c heat at constant pressure and volum e, respectively.

H ad we allowed that the sound w aves disturb the m edium and generate entropy, we w ould require an EoS w th two variables, e.g relating the pressure to the $m$ ass and energy densities. In this case we would have to introduce additionally the energy conservation in di erential form, in order to close the set of equations.

In the follow ing we study sm all-am plitude, acoustic perturbations of an am bient state of the uid
 equations goveming the perturbations $P$; $\mathbb{F}$, we set:

where the relation betw een the velocity potential and the pressure perturbation is chosen such that the linearized Euler equation, Eq. ( $\bar{T}_{1}$ ), is autom atically satis ed. Inserting the EOS, Eq. (인), in the linearized continuity equation, Eq. (GG), and using Eq. ( $\overline{1} \overline{1} \overline{1})$, one obtains the wave equation for the velocity potential:

For simplicity, we suppress from now on the index introduced in Eq_(4).

### 2.2 O utgoing SphericalW ave D ynam ics

A ssum ing spherical sym $m$ etry and using spherical coordinates, the velocity potential is seen to satisfy the usual scalar spherical $w$ ave equation :

where we introduced the notation $X-d X=d t$. In general, the solution of the w ave equation, Eq. $\mathrm{I}_{1}^{(1) 4) \text {, }}$ w ill be com posed of a linear supenposition of in-and outgoing spherical waves. W e shall allow for the
possibility of an incom ing acoustical wave, in , e.g. as part of the extemaldriving sound eld, and rew rite E q. (1-5) in m ore detail:

where out has been substituted by an outgoing spherical wave, cf. E qs. ( $\left.\overline{1} \overline{4} \overline{1} \overline{1}_{1}\right)$; henceforth we use the abbreviation $f^{0}(x) \quad d f=d x$. The extemal eld in is kept arbitrary in the derivations to follow, but w illbe inconporated according to a physically relevant exam ple in Section 42 .

In principle, there will be also a sound eld generated by the moving phase boundary which will travel into the interior, to be re ected at the center of the bubble ( $r=0$ ), and then retum. Its description, i.e. pertaining to the bubble interior, requires a suitable modi cation of the present approach, see Section 3.
$W$ ith $R-(t)$ given by other dynam ics, our ob jective now is to determ ine im plicitly the outgoing velocity potential out. For this punpose we recast Eq. (1] $\overline{\mathbf{G}}$ ) into the form of an ordinary linear rstorder di erential equation w ith know $n$ tim e dependent coe cients:

where $\mathrm{F}_{0} \quad \mathrm{~F}\left(t_{0}\right)$ denotes the integration constant. It is $x e d$ by the requirem ent that no outgoing $w$ ave should be excited before the bubble $w a l l$ is set into $m$ otion at $t_{0}$. Therefore, $w$ ith $R-\left(t<t_{0}\right) \quad 0$, we nd $\mathrm{F}_{0}=0$. The resulting constraint $t>t_{0}$ is $m$ ost conveniently im plem ented by a step function factor (t $\quad$ ).

U sing Eqs. ( $\left.\overline{1} \overline{4} \bar{L}_{1}\right),(\overline{2} \overline{0} \overline{1})$, we can recover from the above solution the outgoing velocity potential. To
 function, if and only if $t \quad(t)=t \quad R(t)=C$ is either strictly increasing or strictly decreasing $w$ ith tim $e$. For subsonic bubble wall motion $t(t)$ is strictly increasing, since $1 \quad R=C>0$, and $e$ is strictly increasing in this case. This allow s us to perform variable substitution at will and we obtain:

$w$ here allfunctions $w$ ith in the braces are to be evaluated at the indicated tim e-argum ent $E(t \quad r=c)=s$; henceforth $L$ denotes the am bient density of the liquid. $W$ e recall that $P$ is the pressure perturbation due to the generated sound eld, to be added to the am bient pressure.

### 2.3 Series Expansion for the Sound Field

 Section 22 , involve an integration over the history of the bubble wallm otion. T hus the corresponding nonlinear di erential equation describing it selfconsistently (Section 4) could be expected to becom e nonlocal in tim e (see, how ever, Section 4.3). In any case, for su ciently slow m otion a local approxim ation can be justi ed, see Refs. popular generalization of the RP equation. Therefore, our next ob jective is a system atic expansion in pow ers of $R=C$ of our general expressions, in particular of the velocity potential, E q. (12 $\overline{2}$ ) .

W e rem ark that the exponentially sm all correction term (for $s t_{0}$ ) on the rh.s. of Eq. ( $\left.\left.\overline{3} \overline{0} \overline{0}\right)_{1}^{\prime}\right)$ can be attributed to transient contributions to the integral or, rather, to the fiunction F , Eq. (2 $\mathbf{2}_{-1}^{1}$ ), which are due to the sw itching-on of the bubble wallm otion considered in Section 22 . Since we will be m ainly interested in the nonlinear oscillatory $m$ otion of the bubble $w$ all $w$ hen all transients have died out, we can neglect this term for su ciently late tim es. T hus, we obtain:

which presents the starting point of our approxim ate evaluation of the velocity potential.

The expansion has to be carried out up to order $n=4$ in order to acquire in the $R=c$ expansion all second order term $s$. O ur result reduces to Eq. ## 3 H om ologous B ubble Interior D ynam ics

In section 4 we want to derive the equation of $m$ otion of the phase boundary (bubble surface) selfconsistently. For this purpose we need to understand the dynam ics of the interior of the bubble. In distinction to Section 2 , presently we have to take into account that the density, pressure, and velocity elds inside the bubble $m$ ay change by several orders of $m$ agnitude during di erent phases of the (periodic) bubble $m$ otion. Therefore, a linearization of the hydrodynam ic equations of $m$ otion around a hom ogeneous and time independent ambient state, as perform ed in Section 2.1, is not applicable here.

In the hydrodynam ic studies of the interior $m$ otion the em phasis has been to understand the developm ent of the extrem e conditions inside the bubble [1] [1 part of the SBSL cycle the bubble $m$ otion is (nearly) hom ologous, ie. the shape of the density distribution and the velocity eld of the gas scale in an appropriate $w a y w$ ith the radius $R$ and surface velocity $R-[\underline{1} \overline{2}]$. The num erical sim ulations in the SBSL param eter regim e indicate a hom ologous contraction (and its stability) until the onset of shock wave form ation and independently of the details of the E oS used. This stability of the hom ologous $m$ otion $m$ ay be related to the fact that only for the


W e solve the continuity and Euler equations, Eqs. (1ָ1) and (2) of Section 2.1 respectively, by approxim ating the density and velocity elds with suitable scaling functions. We neglect dissipative e ects in the bubble, such as viscosity, heat conduction, and radiation transfer especially. P resently, we are interested in a sem iquantitative analysis of the bubble interior. This seem s su cient for our later derivation of the overall bubble dynam ics: the $m$ otion is largely determ ined by the dynam ics of the uid, since only a m inor fraction of the relevant totalenergy resides in the interior at any tim e. For a detailed understanding of the $m$ icroscopic processes leading to sonolum inescence inside the bubble, how ever, the dissipative e ects will be essential ingredients.

W e observe that as the bubble goes through the cycle determ ined by the driving pressure, the shape of the $m$ atter distribution inside the bubble changes, controlled by $q$, which rem ains nearly constant during much of the cycle and changes rapidly in sign near to the bubble collapse/bounce, whenever $R=0$, where the lh s. of Eqs. ( $\overline{4} \overline{5}),(\overline{4} \overline{8} \overline{1})$, or ( $\overline{5} \overline{\mathrm{D}} \mathrm{q})$ vanishes, and $q=0$, assuring in this transition instant a (nearly) hom ogeneous density distribution. For negative values of $q$ the highest density is found at the surface, corresponding to a collapsing phase; sim ilarly, positive values of $q$ w ith the highest density at the center correspond to an expanding phase of the bubble m otion. We found that there is an approxim ate $x e d$ point $r=R \quad$ in the $m$ otion, where the average density corresponding to a hom ogeneous bubble is $m$ aintained during the entire cycle:

This will tum out to be a very useful property which we shall exploit deriving speci c num erical results in Section 52 , where we com pare the bubble dynam ics for a hom ogeneous and a hom ologous interior, respectively.

## 4 D erivation of the Bubble Equation of $M$ otion

H aving studied the e ects of a given bubble wallm otion on the exterior liquid and the bubble interior in Sections 2 and 3, respectively, we now tum to the question how this $m$ otion can be determ ined selfconsistently. That is, assum ing an extemaldriving sound eld in, wewant to derive an equation of
$m$ otion for the bubble radius $R$ as a function of tim $e . W$ e also take the bubble interior into account. Its dynam icsm ay have little in uence on $m$ ost of the cycle of stable bubble oscillations. H ow ever, in order to im prove the understanding of the nalstage of the violent collapse $[1]$ B esides the sound em ission from the $m$ oving phase boundary, which constitutes a $m$ a jor energy loss $m$ echanism, the e ect of viscous dam ping will also be inconporated here, which is of a sim ilar order of m agnitude as acoustic dam ping. D espite the fact that our considerations so far were based on the assum ption of nonviscous uid dynam ics, i.e. approxim ately free wave propagation in particular, we can include dissipative and driving forces into the equation of $m$ otion for $R(t)$ by deriving it from the $N$ avier-Stokes ( $m$ om entum balance) equation. Thus, only the backreaction of viscosity (and other dissipative transport e ects) on the wave propagation and velocity potential is neglected here.

### 4.1 T he (G eneralized) $R$ ay leigh $P$ lesset E quation

W e begin w ith the $N$ avier-Stokes equation generalizing the Euler equation, see Eq. (R)'), to the case of viscous uids $\underset{\underline{[2}}{[1]}$. For our spherically sym $m$ etric situation this equation can be written in the form :

For com pleteness, we allow for viscous dam ping in the gas inside the bubble, even though it $m$ ight at best becom e im portant during the rapid collapse and high com pression phase.

In fact, inserting here our generalresults ofSection 22 for the sound eld generated by the bubble, in particular $\mathrm{V}(\mathrm{r} ; \mathrm{t})$ and $\mathrm{P}(\mathrm{r} ; \mathrm{t})$ calculated in E qs. $\left(\underline{2} \overline{7}_{1}\right)$ and $(\underline{2} \overline{1}, \mathbf{1})$ respectively, we obtain an im portant generalization of the $R$ ayleigh $-P$ lesset equation.

In order to ilhustrate the contents of Eq. ( $6 \mathbf{6}$ (G), we proceed w ith a perturbative evaluation of term $s$ involving the generated sound eld making use of our results of Section 2.3 . U sing in Eq. (6.6.) the expansions in $R=C$, especially Eqs. $\left(\overline{3} \bar{S}_{1}\right),\left(\overline{5}_{\underline{I}} \bar{T}_{1}\right)$, we obtain the perturbative bubble equation of $m$ otion:

The dynam ics of the gas in the interior of the bubble as well as of the exterior liquid is fully incorporated in our derivation. It is based on the N avier-Stokes equation ( $\left.\overline{5} \overline{3} \bar{T}_{1}\right)$ supplem ented by the boundary condition $\mathbf{~}^{5} \overline{\mathrm{G}}$ ) relating the nom al com ponents of the stress tensor at the bubble surface. Neglecting the bubble interior am ounts to setting the underlined num erical constants in Eq. ( $(\overline{6} \overline{9})$ to zero, equivalent to neglecting $R R=2$ in $E q \cdot(\overline{6} \overline{6})$, and setting $\left.h_{G} \mathbb{P}_{G}\right] \quad 0$ in both equations. T hese apparently are sizeable corrections which w ere not considered previously. H ow ever, these term s cancel exactly, if the hom ologous dynam ics of Section 3 is applicable for the bubble interior. A lso, according to Eq. ( $\left.\underline{6}_{1} \bar{I}_{1}\right), \mathrm{h}_{\mathrm{G}}=0$ for a hom ogeneous bubble.

The in uence of the extemal acoustic driving eld is consistently taken into account in our treatm ent of the sound eld outside of the bubble. The term $s / v_{a}$, i.e. the incom ing velocity eld, or its derivatives, were neglected before; only term $s$ involving the driving pressure $P_{a}$ had been obtained. These additional term s are necessary to restore the boundary condition on the sound eld at $r=R(t)$, see the com $m$ ent after E q. ( $\underset{\sim}{6} \overline{1})$.

E xcept for a highly com pressed or, rather, very hot gas $[\underset{2}{2}]$, its bulk viscosity presents a negligible contribution in Eq. ( $\left.\overline{7} \bar{O}_{1}^{\prime}\right)$, being on the \%-level as com pared to liquid w ater at m ost. H ow ever, we also note the corrections due to the incom ing sound eld.

If we discard altogether the m odi cations just discussed, we reproduce Eqs. (9) and (10) ofR ef. [îill. In Section 5 we w ill explore num erically the e ects of the corrections presently discussed.

### 4.2 The D riving Sound Field

$H$ aving further studies of single bubble sonolum inescence in $m$ ind, we determ ine here those quantities entering our results which depend on the extemal acoustic driving eld. For typical experim ents on single bubble sonolum inescence carried out to date the driving sound frequency is approxim ately

25 Khz , which translates into a wavelength of $5: 9 \mathrm{~cm}$ given the sound velocity in water of
 extemal eld in the long-w avelength lim it.

Follow ing Ref. [ilill, we assum e a plane standing wave: $\quad=A \sin (k z) \cos (!t)$, i.e. along the $z$-axis with ! 2 and $k \quad 2==!=c$. ## 5 N um erical R esults

We now tum to a num erical study of characteristic properties of a single air bubble in water at standard laboratory conditions (STP), i.e. at the ambient tem perature $T=293 \mathrm{~K}$ and under the am bient pressure $P_{0}=1 \mathrm{~atm}=1: 01325 \quad 15 \mathrm{~kg} / \mathrm{m}^{2} \mathrm{~s}$. Solutions of the nonperturbative equation of $m$ otion ( $(8 \bar{d} \bar{q}) \mathrm{w}$ ill serve as our standard, with which other results shall be com pared.
 tension $=0: 073 \mathrm{~kg}=\mathrm{s}^{2}$ (water/air), sound velocity $\mathrm{c}=1481 \mathrm{~m}=\mathrm{s}$. T h is latter value is about $2 \%$ higher than the one which follows from the adiabatic water EOS ( 6
 viscosities of water (STP) are țָ̄]: sL $=1: 002 \quad 10 \mathrm{~kg}=\mathrm{m} \quad \mathrm{s}_{\mathrm{pLL}}=2: 91 \mathrm{sL}$.

The standard' air bubblewe study has an equilibrium radius $R_{0}=4 \quad 10 \mathrm{~m}$. The adiabatic index is $=1: 4$, characteristic of di-atom ic $m$ olecules. The equilibrium radius and the particle num ber $N$ in the bubble, or equilibrium gas density 0 , are related through the van derW aals EoS (14]) and pressure boundary condition ( $\bar{\eta} \bar{q})$ w ith $P_{L}=P_{0}$ (STP), which corresponds to the follow ing set of param eters

 which indeed $m$ ake a negligible contribution in the context of our study.

The applied driving sound eld, cf. Section 4.2, will be chosen to oscillate with the frequency
$=!=2=26 \mathrm{Khz}$ in all exam ples. Its am plitude w ill be xed at $\mathrm{P}_{\mathrm{A}}=1: 35 \mathrm{P}_{0}$, except when stated otherw ise.

In the num erical calculations we consider the above speci ed param eters as prescribed constants, but keep in $m$ ind that e.g. the sound velocity and surface tension $m$ ay change appreciably. The use of a constant adiabatic index has been questioned before [i] $]$, since various transport e ects leading to entropy production $m$ ay becom e im portant. We follow Ref. [i] in that we arti cially increase all viscosities by a factor three, which has been found necessary to $t$ the standard Rayleigh $P$ lesset equation, ie. $R(t)$, to the experim ental data obtained by lightscattering $m$ ethods $[\overline{1} \overline{1} 1$, , $1 \overline{1} \overline{1} 1]$.

In $F$ ig. 1 we show the fill cycle of the time dependent radius $R$ ( $t$ ) of the air bubble in water (full line), the bubble surface velocity $R$-(t) (dashed line), and the sinusoidal extemal driving pressure $\mathrm{P}_{\mathrm{a}}(r=0 ; t)$ according to Eq. ( $\left.\overline{1} \overline{1}_{2}^{2}\right)$ (overlaid full line together with zero line, anbitrary units), which coincides w ith the relevant long-w avelength lim it. We integrated num erically the nonperturbative Eq. ( $8 \mathbf{8} \overline{\mathrm{O}})$ for a hom ologous bubble, in which case $I=0$ according to Eq. $(\overline{8} \overline{\mathrm{O}})$. However, the gas pressure entering through Eq. ( $8(\underline{2} \mathbf{4})$ ) is evaluated here for a hom ogeneous bubble for the m om ent; we shall consider the e ect of the inhom ogeneity in Section 5.3. W e note that on the scale of F ig.1,
the $R(t)$ curves calculated $w$ ith the other equations derived in this work or the one used before in Refs. $\overline{4}, 1 \overline{1} \overline{1}, 1]$
 betw een the various equations of $m$ otion.

### 5.1 P erturbative vs. $N$ onperturbative Equations of $M$ otion

The equations of $m$ otion whidh have been used to study driven gas bubbles in liquids in the SBSL param eter regim e inconporated e ects of the sound em ission only in the low est order in $R=C$ so far, see e.g. Refs. $]_{11}^{11}, \underline{1}, 1,1$ reached during the collapse phase, which $m$ ay reach $R=C \quad 1$ ( $M$ ach 1), as indicated in $F$ ig. 1 , we study here how the various approxim ate treatm ents of sound dam ping com pare to the nonperturbative Eq. (8이). T he bubble interior is treated here as explained in the context ofF ig. 1 above. T he individual sections in $F$ ig. 2 show the surface velocity $R-(t)$ at the rstbounce (left colum n) and the second bounce (second colum n) for di erent am plitudes of the driving pressure (top to bottom ; $P_{A}$ in units of $P_{0}$ ); the origin of the tim e-axis is arbitrarily chosen for the rst bounce, the delay until the corresponding one for the second bounce is indicated in each case. T he results are obtained from the nonperturbative equation (fill line), and its lowest order in $R=C$ perturbative expansion (dashed line), cf. Eq. ( $\overline{8} \bar{T}_{1}$ ), respectively. In the latter case also the retardation shifting the tim e argum ent of the driving pressure term, see Eq. $(\overline{8} \overline{8} \overline{9})$, has been neglected, in conform ity w ith earlier w ork.

It is obvious from $F$ ig. 2 that characteristic phase shifts result w r.t. to the cycle tim ing set by the extemal driving pressure and betw een the rst and subsequent bounce(s). P hysically m ost im portant is the fact that $w$ thin the perturbative treatm ent the $m$ axim al surface velocity during the collapse is overestim ated by a considerable am ount, e.g. $250 \mathrm{~m} \mathrm{~s}^{1}$ for the rst bounce at $\mathrm{P}_{\mathrm{A}}=1: 35 \mathrm{P}_{0}$. This im plies that the collapse is signi cantly less violent than has been concluded from previous theoretical treatm ents of the bubble dynam ics. In particular, quantitative SBSL estim ates derived from models which couple the perturbatively corrected $R$ ayleigh $P$ lesset equation, cf. Eq. $\left.\overline{6}_{6} \overline{9}\right)$, to a
 this conclusion also from the various other corrections to be discussed shortly.
$T$ he origin of the retardation of the rst bounce in the perturbative approach is show in F ig. 3 to be due to the neglect in the perturbative expansion of the tim e retardation e ect. W hen the retardation is included as in Eq. ( $\left.\overline{8} \bar{B}_{1}^{1}\right)$, then the positions of the rst perturbative and nonperturbative bounce coincide. H ow ever, the perturbative expansion including the retardation e ect continues to introduce an overestim ate of the collapse velocity. This is leading to a rem aining phase shift of 15-20 ns betw een rst and subsequent bounce(s), as seen in the bottom portion of $F$ ig. 3 .

### 5.2 H om ologous vs. H om ogeneous B ubble Interior

In order to dem onstrate the in uence of the behavior of the bubble interior on the overall dynam ics of the coupled bubble-liquid system, beyond just providing the pressure resisting the collapse, we consider here how the hom ologous bubble description developed in Section 3 com pares $w$ ith the usual sim pler hom ogeneous $m$ atter distribution $m$ odel of the bubble interior.

W e exploithere the presence ofa xed point ,Eq. ( $\overline{5} \bar{Z} \bar{\prime})$, where the density rem ains nearly constant. $P$ resence of th is xed point cannot be expected in general, how ever, we presently $m$ ake th is assum ption based on our num erical experience w ith the description of hom ologous and adiabatic changes of the interior distributions. W e can evaluate Eq. ( $\overline{4} \bar{S}_{1}$ ) conveniently integrating from $R$ to R.W ith $P$ P ( ), see Eq. (4-4 $\mathbf{L}_{1}^{\prime}$ ), which denotes the gas pressure of the corresponding hom ogeneous bubble, we
obtain the follow ing approxim ate result for the hom ologous gas pressure at the bubble surface:

Employing this expression for the gas pressure in the nonpertunbative equation of $m$ otion ( $\left.\overline{8} \overline{9} \bar{g}_{1}\right)$, we nd the results depicted in Fig. 4 (filll line), where also the behavior of a hom ogeneous bubble (dashed line) is show $n$ for com parison. W e observe only a rather sm all e ect on $R(t)$, exœept for a 1.5 ns shift of them in im um. H owever, sim ilarly to the e ects illustrated in $F$ ig. 2 , we nd here another sizeable reduction of the $m$ axim al collapse speed ( $200 \mathrm{~m} \mathrm{~s}{ }^{1}$ ). Them axim um of the gas pressure at the hom ologous bubble surface is reduced by about 5\%, as com pared to the hom ogeneous one, whidh am ounts to $10^{3} \mathrm{~atm}$. H ow ever, the m axim al gas density at the surface is m uch less a ected and reaches approxim ately one half liquid density in our calculational exam ple.

### 5.3 The Sound Field of a SB SL Bubble

As a further application of our study of the sound eld im posed on and rescattered by a typical SBSL bubble we evaluate it at a given distance aw ay from the bubble, where it can be m easured by


Perturbatively, it is m ost convenient to obtain the sound pressure using Eq. (2, $\overline{2})$ or ( $\left.\overline{3} \overline{\bar{S}_{1}^{\prime}}\right)$ in the form :

where $R \quad R(t)$ and $e$ can be further evaluated $w$ th the help of Eq. $(\underline{2} \overline{4} \overline{1})$ or Eq. $(\underline{2} \overline{5})$, whichever applies. The pressure di erence on the r.h.s. here can then be com puted easily from the solution of the perturbative equation ofm otion ( $\overline{6}_{6} \overline{9}_{1}$, cf. Section 5.1 , since it is im plicitly part of it.
$T$ he result at the low est nontrivial order in $R=C$ is show $n$ in $F i g .5$, for $r=1 \mathrm{~mm}$ aw ay from the center of the bubble. W e clearly see the outgoing com pression spikes riding on the sinusoidaldriving pressure, which are caused by the bubble collapse and successive bounces. On the pressure scale of this gure (cutting o the rst $m$ axim um ) the nonperturbative result would be indistinguishable from the perturbative calculation.

W e calculate the pressure eld nonperturbatively beginning w ith Eq. ( $\overline{\underline{9}} \overline{1} 1)$, as before. H ow ever, we proceed in this case by using the pressure boundary condition, Eq. (7응), in order to calculate $P(R ; t) \quad P_{L}(R)$. The term / $\quad$, in particular, can be evaluated in the long-wavelength lim it (neglecting a cross term betw een viscosity and com pressibility) to yield $+2!{ }_{L} P_{A} \cos (!t)=\left(3 c^{2} L_{L}\right)$, while all other term s are straightforw ard to obtain from the num erical solution of the nonperturbative Eq. ( 8 8-9 $)$; cf. the rem arks explaining the calculation of $F$ ig. 1 in Section 5.1 .

In F ig. 6 we show the nonperturbative evaluation of the rst sound pressure spike at $\mathrm{r}=1 \mathrm{~m} \mathrm{~m}$. For com parison, also the som ew hat earlier and considerably stronger spike given by the perturbative calculation, cf. Fig. 5 , is shown. If we correct the calculated am plitude here for the geom etric dispersion, then the pressure at $r=0: 6 \mathrm{~m}$ reaches $4: 5$ 140atm at $m$ axim um. A pplying the generic dam ping factor of $10^{4}$ for the absonption of ( 300 M hz ) pulse travelling 1 mm , we arrive approxim ately at the pressure am plitude m easured experim entally for an SBSL bubble under sim ilar conditions as assum ed in our calculation $[\overline{1} 1,1] \overline{1} 1]$. H ow ever, another interesting aspect here is the rise tim e of the sound signal, i.e. from onehalf to m axim um am plitude, which takes only 40 ps (decay tim e 260 ps ). This is about tw o orders of $m$ agnitude below what has been resolved in the above cited experim ents.

F inally, in view of the pressure spike results presented here, it seem sworth while to check one of our basic assum ptions, which is the linear acoustic approxim ation, Section 2.1. It is underlying the linear w ave equation for the velocity potential, Eq. (1] $\left.\overline{1} \overline{1}_{1}\right)$, which form $s$ the basis of our study of the em itted sound eld. W hereas dispersion and absorption can be incorporated in a linearized approxim ation,
genuinely nonlineare ects are beyond our present scope [2].2. The linear approxim ation requires that perturbations of the am bient state of the uid are relatively sm all. Employing the adiabatic liquid EoS $\left(\overline{6} \overline{-1} \bar{j}_{1}\right)$ for water and considering the $m$ axim um of the pressure am plitude obtained here, see Fig. 6 , we obtain a maxim al com pression and ratio of sound speeds:

respectively. W hereas the com pression $m$ ay appear to be quite tolerable, the tem porary increase of the sound speed and its im plications for the dam ping of the bubble $m$ otion, when the sound pulse is launched from the collapsing bubble surface, obviously deserve further study.

Furtherm ore, one $m$ ay w onder about the behavior of the water next to the bubble surface, when it is exposed to the \cold shock" indicated by our results, i.e. several $10^{4} \mathrm{~atm}$ pressure increase w ith in less than 50 ps .

## 6 Sum m ary, C onclusions and O utlook

The aim of our present work has been to reconsider the sound em ission from the highly nonlinear, large am plitude $m$ otion of the interface betw een the gas inside and the liquid outside a cavitating bubble. P revious studies typically evaluated the radiated sound eld in low est order of a perturbation expansion in $R=c$, ie. valid for slow bubble wall m otion as com pared to the sound velocity in the liquid. Generally, it is believed that $R$-(t) reaches up to (or even exceeds) the sound velocity for extemally driven bubbles in the param eter regim ew here sonolum inescence is observed experim entally
 in particular. We anticipate that the sound signal from a nonlinearly oscillating bubble wall m ay provide an im portant additional diagnostic tool. It should re ect the essential short-tim e scale(s) of th is $m$ otion, which vary over several orders of m agnitude [4ir, 1 resolution in the ( 100 M hz$)^{1}$ range, i.e. less than about 10 ns . This m ay be particularly valuable in cases where light scattering $m$ ethods [inin, bubble wall or are not applicable at all, such as for liquid $m$ etals [G]].

W e recall that based on Section 3 we describe the bubble interior using hom ologous pro le functions for the density and velocity distributions. These allow for a m ore realistic study of the dynam ics and particular properties of the high com pression phase of strongly driven bubble oscillations, the
 of the sem ianalytic variational approach developed in Refs. [13, 1 Eq. ( 80 possible to extend this approach in order to account for the im portant e ects of heat conductivity and $m$ ass di usion.

O ur num erical exam ples obtained in Section 5 em ploy as another approxim ation the hom ologous solutionsw ith the usualadiabatic van derW aals E OS. T hese E oS becom e questionable w hen the energy density reaches the ionization regim e. The dynam ic behavior of the gas mixtures $w$ ith in a rapidly oscillating bubble, here assum ed to rem ain that of a di-atom ic gas (air), deserves further study. In parallel to the cyclic in-and outgassing from the liquid into the bubble ( $\backslash$ recti ed di usion"), it rem ains to be seen whether an essential am ount of liquid vaporizes at the bubble surface and recondenses during an oscillation cycle. Related e ects may help to explain the observed sensitivity of
 transport phenom ena within the bubble and across the phase boundary have to be incorporated whenever the $m$ otion becom es fast com pared to characteristic relaxation tim es i, R $4_{i}=i_{i}$, where 4 i denotes the scale of a corresponding gradient (e.g. m ass density, partial pressure, tem perature,
 the description of which is beyond the scope of this w ork.

O ne may speculate whether or not the liquid (w ater) may be trapped in a m etastable state w r.t. solidi cation into a high-density phase (of ice) and in which form the corresponding binding energy w ould be released most e ciently. P resum ably it stays at or close to the am bient tem perature [10]. A ssum ing an e ective sound velocity of $2000 \mathrm{~m} / \mathrm{s}$, the 300 ps m ean half w idth of the pressure pulse obtained in Section 5.3 corresponds to a spatial shell w idth of 0.6 m , i.e. about the van derW aals hard core radius em ployed in our calculations. N ear the collapsed state w ith R 0:6 m such a shell contains about $10^{11}$ water $m$ olecules, i.e. only about an order of $m$ agnitude $m$ ore particles than assum ed (in the gas) inside. Furtherm ore, the sound pulse am plitude decreases exponentially aw ay from the bubble surface (besides geom etric dispersion / 1=r) due to absonption in the liquid [2]. Then, assum ing an extrem ely conservative decay / $\exp (\quad r[m m]: 434)$, one $\mathrm{im} m$ ediately estim ates that the energy dissipated in this rst shell (proportional to square of am plitude decrease) am ounts to about $3 / 1000$ of the pulse energy. This is $m$ ore than an order ofm agnitude tim es the energy em itted in the form of visible light by a SBSL bubble $[-1]$. 1 . T he $s m$ all spatio-tem poral extension of the region where this energy has to be dissipated, and how, de nitely deserves further study. T his should provide an im proved starting point for the exploration of essential aspects of the violent bubble collapse which $m$ ay help to elucidate the nature of sonolum inescence. W e hope to com e back to one or the other of these fascinating aspects of SBSL bubbles which are especially related to their sound eld in our future work.

W e note that while in principle the e ect of a dynam ic treatm ent of the bubble interior on the behavior ofR ( t ), which we introduced in Section 52 and F ig. 4 , should be part of a fullhydrodynam ic
 of the approaches prior to our w ork. In view of the num ericalresultspresented in Section 5 it is obvious that the nonperturbative treatm ent of the em litted sound eld as proposed here, which accounts for about 50\% of the dam ping of the driven bubble oscillations, is $m$ andatory. In particular, the standard perturbative calculations tend to overestim ate the maxim ally reached surface velocity during the collapse phase considerably. T hus a crucial aspect of the \preparation phase" for the unknown light em ission process can be described m ore accurately em ploying the nonperturbative equation ofm otion derived in Section 4.3, Eq. ( $\left.\overline{8} \overline{9} \bar{q}_{1}\right)$. This seem s particularly relevant for detailed hydrodynam ic studies of the bubble interior, in which the exterior has been described by the perturbative $R$ ayleigh $P$ lesset
 by an air bubble in water (Section 5.3) t qualitatively the rst experim ental observations reported
 the lim itation of our present derivations. W hereas the bubble equation ofm otion, Eq. ( $\left.\overline{8} \bar{g}_{1}\right)$, is derived from the intrinsically nonlinear $N$ avier-Stokes equation, in the form of Eq. (79 $\bar{g}_{1}$ ) of Section 4.3, our considerations of the em ilted sound eld are based on the acoustic approxim ation (see Section 2.2). $T$ herefore, we still neglect im portant sound absorption and dispersion e ects in the liquid. U sing the realistic E OS for water, Eq. ( $6 \overline{6} \overline{3})$ in Section 4.1, we indicated in Eqs. ( $\overline{9} \overline{2} \overline{2})$ the com pression of the liquid and the corresponding increase in the density dependent sound velocity which are induced by the outgoing pressure spike next to the bubble surface. It seem $s$ desirable to study in the future the im portance of nonlinear e ects on the propagation and fate of the extrem ely strong sound pulse em itted.
$T$ here are published results on fullhydrodynam ic sim ulations of the coupled bubble-liquid system, which include especially the exterior uid $[\overline{1} \overline{1} 1]$. H ow ever, to the best of our know ledge, so far no attention has been paid to the unusual behavior of the liquid which $m$ ay be caused by the pressure spike of $10^{4}::: 10^{5} \mathrm{~atm}$ launched from the bubble surface, independently of $w$ hether there are shodk waves generated in the bubble interior or not. W e obtained such am plitudes in typical exam ples w th generic SBSL param eters, where particularly their rise tim e of only about 40 ps seem $s$ quite
astounding, but also rem in iscent of the shortness of the SB SL light pulses.
