Random Dirac Ferm ions and Non-Herm itian Quantum Mechanics

We study the in wence of a strong imaginary vector potential on the quantum mechanics of particles con ned to a two-dimensional plane and propagating in a random impurity potential. We show that the wavefunctions of the non-Herm itian operator can be obtained as the solution to a two-dimensional Dirac equation in the presence of a random gauge eld. Consequences for the localization properties and the critical nature of the states are discussed.

The eld of non-Herm itian quantum mechanics has attracted great interest recently both in its connection to anom alous di usion in random media [1], aswellas to the statistical mechanics of ux lines in superconductors [2]. At the same time, motivated in part by the connection to properties of the integer quantum Hall transition and gapless superconductors detailed investigations have been made into the critical properties of Dirac Ferm ions coupled to random gauge elds [3{11]. The aim of this letter is to identify a connection between these problem swhich explains som e of the unusual phenom ena recently reported in the behavior of two-dimensional non-Hermitian random operators [2]. This correspondence is related to a chiral symmetry of e ective Hamiltonians commonly used in the analysis of problems in non-Herm itian quantum mechanics.

The two-dimensional Hamiltonian we consider describes a particle propagating in a random scalar impurity potential, V and subject to a uniform imaginary vector potential, ih

The scalar potential, V is assumed to be real and drawn from some random distribution, P [V] which, for now, is left unspecied. Related problems have been recorded in a variety of physical situations ranging from the study of reaction di usion phenomena in biological systems [12], to advective di usion in random media [1,13,14], and the study of uctuating vortex lines in superconductors with columnar defects [2].

Rem arkably, in contrast to properties of the Herm itian operator (i.e. one in which the vector potential is real), num erical studies [2] suggest localization properties of H depend sensitively on the relative strength of h. W hile, in dimensions d 2, all wavefunctions of the Herm itian operator are believed to be localized [15], numerical evidence suggests that application of a su ciently strong vector potential, h induces a delocalization transition of states of the non-Herm itian operator. In contrast to the

situation in 1d [2,16], the mechanism and stability of the delocalization transition is not yet well understood.

Recent analytical studies have focussed on the spectral properties of the non-Herm itian Ham iltonian [17]. Treating the vector potential as a weak perturbation of the random Hamiltonian, impurity averaged properties of the Green function have been cast in the form of a functional eld integral involving a supersymmetric nonlinear -model. While capturing universal features of the complex spectrum of \hat{H} , evidence for delocalization of states was not sought. By contrast, in the present approach, we will im pose a strong im aginary vector potential, and treat the random potential as a perturbation (a regim e explored in 1d by Feinberg and Zee [16]). By doing so we will reveal an explicit connection between the Hamiltonian in Eq. (1) and the problem of Dirac ferm ions propagating in a random gauge eld. In particular, we will nd a regime of weak disorder in which it is possible to construct explicitly eigenfunctions of the non-Herm itian Ham iltonian H for individual realizations of the disorder.

In the absence of the impurity potential, the eigenfunctions of \hat{H} are plane waves with complex eigenvalues, z_0 (p) = (p² h²)=2m + ip h=m . Since the Hamiltonian is real (\hat{H} = \hat{H}), eigenvalues occur in complex conjugate pairs, a property maintained in the presence of the random potential. In the in nite system, the spectrum forms a dense support occupying the region of the complex plane jim zj $\frac{1}{2m} \frac{1}{R} e^{-z} + \frac{1}{2m} \frac{1$

where $_{0}$ denotes the constant D oS of the H erm itian H am iltonian.

Concerned with impurity averaged spectral properties of the H am iltonian, we begin by dening the G reen function $\hat{G}(z) = (z + \hat{H})^{-1}$ where z denotes the complex

argum ent. U sing (z) (1=) $\text{tr}\, \mathbb{Q}_z$ G(z), where represents the volum e, G(z) is shown to be non-analytic everywhere the DoS (z) is non-vanishing [14,18].

To properly account for non-analytic properties of the impurity averaged G reen function, previous studies [14,17,18] have emphasized the need to express the G reen function through a Hamiltonian which is explicitly Hermitian. This is achieved by constructing a matrix Hamiltonian with the 2 2 block structure

In this representation, the G reen function of the non-Herm itian operator is expressed as the o-diagonal element of the matrix G reen function, $\hat{G}(z) = \lim_{t \to 0} \hat{G}_{21}(z)$, where, denning $= 0^+$, $\hat{G} = (i + \hat{H})^{-1}$. Zero energy eigenstates of the matrix Ham iltonian \hat{H} yield eigenstates of the non-Herm itian Ham iltonian \hat{H} .

De ning Pauli matrices ~ ($_0$ = 1) which operate in the 2 2 space, the chiral sym metry of the matrix Hamiltonian, H $^{\hat{}}$ = $_3$ H $^{\hat{}}$ 3 in plies that eigenvalues, $_i$ of H $^{\hat{}}$ appear in pairs of opposite sign. Moreover, any such pair of eigenstates obeys j + $_i$ i = $_3$ j $_i$ i.

The spectrum of \hat{H} depends sensitively on the strength of the vector potential, h. In the absence of the random potential, the dispersion relation takes the form,




FIG.1. D ispersion relation, E $_0$ (p) (norm alized by v_1h) in the vicinity of zero energy shown as a function of p with $h=h\hat{e}_2$, Im z=0 and m $v_1=2h=10$. Note that the minimum scattering amplitude required to smear out the points of degeneracy is given by $h=hv_1$.

invariant under re ection about the axis parallel to h. Thus, in contrast to a H am iltonian involving a real vector potential, where the spectrum is described by a simple shift of the Ferm i sphere, the continuous degeneracy of the zero eigenvalues (the poles of the G reen function) is lifted. Instead, setting h he, zero energy states exist at only two discrete points $p_0^{(a)}$, a=1,2 [19] (see Fig. 1).

If the impurity potential is strong (i.e. ' h=h, where 'denotes the transport mean free path associated with the random impurity potential, V), unperturbed states of the clean system are strongly mixed by the disorder (see Fig. 1). In this limit, the pole structure of the impurity averaged G reen function, \hat{G} is smeared out. Correspondingly, statistical properties of \hat{H} are largely insensitive to the zero eigenvalues of E_0 (p). In this limit, one can expect the transport properties of the non-Hermitian operator to reject those of the Hermitian counterpart. Conversely, if the impurity potential is weak (' h=h) the pole structure of the spectrum in the vicinity of the zeros, $p_0^{(a)}$.

where represents the corresponding mean free scattering time of the random potential, a linearisation of the spectrum in the vicinity of the two zero eigenvalues separates the spectrum into two branches. Treating the random potential and Im z as weak perturbations, and performing a gradient expansion in

where $p_0^{(a)}=(1)^{n-1}m\ v_1e_1$, $m\ v_1=(2m\ Re\ z+h^2)^{1=2}$, and $m\ v_2=h$, the low energy, long-wavelength expansion of the (unperturbed) H am iltonian around the Fermi points $p_0^{(a)}$ generates the anisotropic D irac operator

Here we have introduced an additional set of Paulim atrices, $\sim (_0 = 1)$, that index the block structure associated with the relection symmetry. The existence of two degenerate zero energy eigenstates of $\hat{H}_D^{(0)}$ conspires with the exact chiral symmetry to yield an anisotropic Lorentz symmetry.

Being generally non-symmetric under reection, matrix elements of the random impurity potential violate the reection symmetry. Accounting formatrix elements which scatter across the Fermi surface (i.e. between the Dirac points) as well as within each subspace, the general Hamiltonian takes the form

where the impurity potentials, V (r) are real random functions with Fourier components

Equations (7,8) represent an important intermediate result of this Letter: Firstly, the low energy sector of the original Hermitian Hamiltonian (3) has been described in terms of the stochastic Dirac Hamiltonian, \hat{H}_D . Secondly, \hat{H}_D possesses the chiral symmetry $_3\hat{H}_D$ $_3$ =

 $\hat{H_D}$, a direct consequence of the chirality of the auxiliary operator (3). The signi cance of the second observation lies in the fact that the behavior of chiral D irac H am iltonians can be analyzed for individual realizations of the disorder: A swe shall see, it is possible to construct explicit solutions for the zero energy eigenfunction j_D i of $\hat{H_D}$. From these the eigenfunctions j_Z i (j_Z i) of the original non-H erm itian operator \hat{H} (\hat{H}^y) can then be obtained as

We next turn to the explicit construction of the wavefunction $_{\text{D}}$ (r). To this end we rst remove the anisotropy of the H am iltonian (7) by rescaling the coordinates according to r = (v =v)x , v = $^{p}\overline{\mathrm{v}_{1}\mathrm{v}_{2}}$. As a result \hat{H}_{D} takes the canonical form

where h = v = 1 and the two components (= 1;2), A = A + B + C are given by

The disorder in $\hat{H_D}$ appears in the form of a minimal coupling to a generally non-abelian vector potential (i.e. $B \in 0$). It is thus natural to seek a gauge transformation that removes the stochastic components of the Hamiltonian. Indeed, although the potentials, A and B are not in general of pure gauge type, the non-gauge components can be accounted for by extending the concept of gauge transformations so as to include 'axial' transformations.

Focusing on the abelian sector rst, we decompose A into a transverse (axial gauge) and a longitudinal (pure gauge) component: A = $\binom{0}{2}$ + $\binom{0}{k}$, respectively [21]. It is then straightforward to verify that

represents a solution of \hat{H}_D $_D$ = 0 for B = 0 [22]. Here, 2 C and the gauge transform ation $\exp(i_0x_2\operatorname{Im}z)$ has been used to dispose of the small imaginary component of the eigenvalue z in the non-Herm itian problem . This contribution can be absorbed into the boost' component of $\hat{}$ (9) [23].

The treatment of the non-abelian components B is conceptually similar but $\{$ due to their non-commutativity in -space $\{$ technically more involved. Referring to Ref. [24] for details, we merely state that in the presence of nite B , Eq. (10) generalizes to

Here, U (x) 2 SU (2) plays the role of the abelian gauge transform ation $\exp\left[i_{0} k(x)\right]$, whereas the vector eld ~ plays the role of the abelian axial component ? and obeys an analogous but more complicated equation [24]. Finally, f and g represent analytic functions which are xed by the boundary conditions (see below).

Equation (11) represents a non-perturbative solution to the zero energy D irac equation for any given realization of the disorder. It, therefore, allows the construction of the eigenfunctions of the non-H em it ian H am iltonian according to Eq. (9). The most important properties of D are a) that the generalized gauge factors depend in a non-local way on the spatial distribution of the disorder potential and b) that the axial gauge factors lead to an exponential disorder dependent amplication of the modulus of the wavefunction, y = y = y = 0

W hat can be said about the asymptotic behavior of the wavefunction D, and, in particular, about its localization properties? To address this question we consider the impurity averaged two-point correlation function, C (r₁ 12) $j_D(r_1)f^{q_1}j_D(r_2)f^{q_2}$. From the structure of the solution we infer that $C = F_A$ factorizes into an abelian and a non-abelian component both of which can be straightforwardly extracted from Eq. (11). To say more, it is necessary to specify both the form of the random potential distribution function, and the topology of the system. Here we focus on the therm odynam ic lim it with Gaussian white-noise distributed disorder, P [V] of uniform variance. Under these circum stances, taking f = g = 1 in Eq. (11) represents the only admissible choice [25].

De ning $g_A = (2 \ 2)^1$ as the variance of the coarse-grained Gaussian distribution for A (i.e. $\frac{1}{2}(x) \cdot \frac{1}{2}(y)$) / $g_A \ln j_A$ y), and focusing, for simplicity, on the case $g_1 = g_2 = 1$, the impurity average yields a strongly anisotropic $g_A = g_1 + g_2 = 1$, algebraic decay,

im plying that eigenstates of the non-Herm itean operator \hat{H} are critical [7,8]. Moreover, since the algebraic decay of F_A is not in uenced by $Im\ z$, we infer that the critical nature of the wavefunctions is also insensitive to $Im\ z$.

As for the non-abelian sector, the non-trivial relationship between the elds B and the elective gauge'eld, and the elds B and the elective gauge'eld, makes the calculation of the correlation function, F_B more involved (c.f. Refs. [5{7,10}]). However, although at present no rigorous statements on the long distance behavior of the correlation function F_B can be made in general, insight can be drawn from the following facts: a) The theory possesses a strong coupling xed point described by the Wess-Zumino-Novikov-Witten theory SU $_4$ (2) [5,7] (corresponding to an in nite strength of the non-abelian components of the disorder potential), and b) in this lim it [7,10], the correlation function,

is again algebraic. Note that the scaling exponent in Eq. (13) is xed solely by the number of nodes (two) in Eq. (4). Therefore, given that the wavefunctions are critical in the strongly disordered limit, it seems highly plausible that they remain critical in general.

In this Letter, we have studied the spectral properties of the two-dim ensional random Schrodinger operator in the presence of a uniform imaginary vector potential, h. M apping it to a Herm itian Ham iltonian with chiral symmetry, a gradient expansion identies properties of the non-Herm itian operator with those of a stochastic Dirac Ham iltonian $\hat{H_D}$. This correspondence allows for the explicit construction of eigenfunctions of the non-Herm itian Ham iltonian for individual realizations of the disorder. In the therm odynamic limit, the wavefunctions were shown to be delocalized along both the directions parallel and perpendicular to h.

Finally we note that the main characteristics of the wavefunction (11), long-ranged disorder dependence encoded in the gauge elds', and exponential amplication of the wavefunction modulus, can manifest them selves in more complex phenomena than that discussed in this Letter: Firstly, one can envisage system swith non-trivial topology and/or stochastic potentials with superim posed regular structures (e.g. spatially non-uniform distribution functions). In such cases the behavior of the wavefunctions may change qualitatively (e.g. to localization). Secondly, we note that the sensitivity of the modulus to disorder results in strong statistical uctuations of the wavefunctions which are large in comparison to the average. In particular, correlation functions of the moments, C acquire scaling exponents with non-linear dependence in qi, a characteristic related to multi-fractality.
