Dynam ics of V iscoplastic D eform ation in Am orphous Solids

We propose a dynam ical theory of low-tem perature shear deform ation in am orphous solids. Our analysis is based on molecular-dynam ics simulations of a two-dimensional, two-component noncrystalline system. These numerical simulations reveal behavior typical of metallic glasses and other viscoplastic materials, speci cally, reversible elastic deform ation at small applied stresses, inreversible plastic deform ation at larger stresses, a stress threshold above which unbounded plastic ow occurs, and a strong dependence of the state of the system on the history of past deform ations. M icroscopic observations suggest that a dynam ically complete description of the macroscopic state of this deforming body requires specifying, in addition to stress and strain, certain average features of a population of two-state shear transform ation zones. Our introduction of these new state variables into the constitutive equations for this system is an extension of earlier models of creep in m etallic glasses. In the treatment presented here, we specialize to tem peratures far below the glass transition, and postulate that irreversible motions are governed by local entropic uctuations in the volum es of the transform ation zones. In most respects, our theory is in good quantitative agreement with the rich variety of phenomena seen in the simulations.

I. IN TRODUCTION

This paper is a prelim inary report on a moleculardynam ics investigation of viscoplastic deformation in a non-crystalline solid. It is preliminary in the sense that we have completed only the initial stages of our planned simulation project. The results, however, have led us to a theoretical interpretation that we believe is potentially useful as a guide for further investigations along these lines. In what follows, we describe both the simulations and the theory.

O ur original motivation for this project was an interest in the physics of deform ations near the tips of rapidly advancing cracks, where materials are subject to very large stresses and experience very high strain rates. Understanding the dissipative dynamics which occur in the vicinity of the crack tip is necessary to construct a satisfactory theory of dynamic fracture. [1] Indeed, we believe that the problem of dynamic fracture cannot be separated from the problem of understanding the conditions under which a solid behaves in a brittle or ductile manner. [2[6] To undertake such a project we eventually shall need sharper de nitions of the term s \brittle" and \ductile" than are presently available; but we leave such questions to future investigations while we focus on the speci cs of deform ation in the absence of a crack.

W e have chosen to study am orphous materials because the best experiments on dynamic instabilities in fracture have been carried out in silica glasses and polymers. [7,8] W e know that am orphous materials exhibit both brittle and ductile behavior, offen in ways that, on a macroscopic level, book very similar to deform ation in crystals. [9] M ore generally, we are booking for fundamental principles that might point us toward theories of deform ation and failure in broad classes of macroscopically isotropic solids where thinking of deform ation in terms of the dynamics of individual dislocations [2,3] is either suspect, due to the absence of underlying crystalline order, or sim ply intractable, due to the extrem e com plexity of such an undertaking. In this way we hope that the ideas presented here will be generalizable perhaps to some polycrystalline m aterials or even single crystals with large num bers of random ly distributed dislocations.

We describe our num erical experiments in Section II. Our working material is a two-dimensional, twocomponent, noncrystalline solid in which the molecules interact via Lennard-Jones forces. W e purposely maintain our system at a tem perature very far below the glass transition. In the experim ents, we subject this material to various sequences of pure shear stresses, during which wem easure the mechanical response. The simulations reveala rich variety of behaviors typical of m etallic glasses [10{13] and other viscoplastic solids, [14] speci cally: reversible elastic deform ation at sm all applied stresses, irreversible plastic deform ation at som ew hat larger stresses, a stress threshold above which unbounded plastic ow occurs, and a strong dependence of the state of the system on the history of past deform ations. In addition, the molecular-dynamics method permits us to see what each molecule is doing at all times; thus, we can identify the places where irreversible molecular rearrangements are occurring.

Our m icroscopic observations suggest that a dynamically complete description of the m acroscopic state of this deforming body requires specifying, in addition to stress and strain, certain average features of a population of what we shall call \shear transform ation zones." These zones are sm all regions, perhaps consisting of only ve or ten m olecules, in special con gurations that are particularly susceptible to inelastic rearrangements in response to shear stresses. We argue that the constitutive relations for a system of this kind must include equations of motion for the density and internal states of these zones; that is, we must add new time-dependent state variables to the dynam ical description of this system . [15,16] O ur picture of shear transform ation zones is based on earlier versions of the sam e idea due to A rgon, Spaepen and others who described creep in m etallic alloys in term s of activated transitions in intrinsically heterogeneous m aterials. [17{22] T hese theories, in turn, drew on previous free-volum e form ulations of the glass transition by Turnbull, C ohen and others in relating the transition rates to local free-volum e uctuations. [20,23{25]N one of those theories, how ever, were m eant to describe the low – tem perature behavior seen here, especially the di erent kinds of irreversible deform ations that occur below and above a stress threshold, and the history dependence of the response of the system to applied loads.

W e present theory of the dynam ics of shear transformation zones in Section III. This theory contains four crucial features that are not, so far as we know, in any previous analysis: First, once a zone has transform ed and relieved a certain amount of shear stress, it cannot transform again in the same direction. Thus, the system saturates and, in the language of granular m aterials, it becom es \jam m ed." Second, zones can be created and destroyed at rates proportional to the rate of irreversible plastic work being done on the system . This is the ingredient that produces a threshold for plastic ow; the system can become \unjammed" when new zones are being created as fast as existing zones are being transform ed. Third, the attempt frequency is tied to the noise in the system, which is driven by the strain rate. The stochastic nature of these uctuations is assumed to arise from random motions associated with the disorder in the system . And, fourth, the transition rates are strongly sensitive to the applied stress. It is this sensitivity that produces memory e ects.

The resulting theory accounts form any of the features of the deform ation dynamics seen in our simulations. However, it is a mean eld theory which fails to take into account any spatial correlations induced by interactions between zones, and therefore it cannot explain all aspects of the behavior that we observe. In particular, the mean-eld nature of our theory precludes, at least for the moment, any analysis of strain localization or shear banding.

II. M O LECU LAR -D Y N A M IC S EX PER IM EN T S

A . A lgorithm

O ur num erical sim ulations have been perform ed in the spirit of previous investigations of deform ation in am orphous solids [26{29]. We have exam ined the response to an applied shear of a noncrystalline, two-dim ensional, two-com ponent solid com posed of either 10,000 or 20,000 m olecules interacting via Lennard-Jones forces. Our m olecular dynam ics (MD) algorithm is derived from a standard \NPT " dynam ics schem e [30], i.e. a pressuretem perature ensemble, with a Nose-Hoover therm ostat, $\beta1\{33\}$ and a Parinello-Rahm an barostat $\beta4,35$ modied to allow imposition of an arbitrary two-dimensional stress tensor. The system obeys periodic boundary conditions, and both the therm ostat and barostat act uniform ly throughout the sample.

Our equations of motion are the following:

Here, r_n and p_n are the position and momentum of the n'th molecule, and F_n is the force exerted on that molecule by its neighbors via the Lennard-Jones interactions. The quantities in brackets, e.g. [1] or [], are two-dimensional tensors. T is the temperature of the therm al reservoir; V is the volume of the system (in this case, the area), and N is the number of molecules. $T_{\rm kin}$ is the average kinetic energy permolecule divided by Boltzmann's constant k_B . [] is the externally applied stress, and [$_{\rm av}$] is the average stress throughout the system computed to be

where F_{nm}^{i} is the i'th component of the force between particles n and m; r_{nm}^{j} is the j'th component of the vector displacement between those particles; and V is the volume of the system. L is the bous of points which describe the boundary of the simulation cell. W hile (2.5) is not directly relevant to the dynamics of the particles, keeping track of the boundary is necessary in order to properly calculate interm olecular distances in the periodic cell.

The additional dynamical degrees of freedom in (2.1-2.5) are a viscosity , which couples the system to the therm al reservoir, and a strain rate, 🛄 via which the externally applied stress is transmitted to the system. Note that [] induces an a ne transform ation about a reference point R₀ which, without loss of generality, we choose to be the origin of our coordinate system. In a conventional formulation, [] would be equal to P[I], where P is the pressure and [I] is the unit tensor. In that case, these equations of motion are known to produce the same time-averaged equations of state as an equilibrium NPT ensemble. [30] By instead controlling the tensor [], including its o -diagonal term s, it is possible to apply a shear stress to the system without creating any preferred surfaces which m ight enhance system -size e ects and interfere with observations of bulk properties. The applied stress and the strain-rate tensor are constrained to be

sym m etric in order to avoid physically uninteresting rotations of the cell. Except where otherwise noted, all of our num erical experim ents are carried out at constant tem perature, with P = 0, and with the sam ple loaded in uniform, pure shear.

W e have chosen the arti cialtim e constants $_{\rm T}$ and $_{\rm P}$ to represent physical aspects of the system . As suggested by N ose [31], $_{\rm T}$ is the time for a sound wave to travelan interatom ic distance and, as suggested by Anderson [36], $_{\rm P}$ is the time for sound to travel the size of the system .

B.M odelSolid

The special two-component system that we have chosen to study here has been the subject of other investigations $[37\{39]$ prim arily because it has a quasi-crystalline ground state. The important point for our purposes, how ever, is that this system can be quenched easily into an apparently stable glassy state. Whether this is actually a therm odynam ically stable glass phase is of no special interest here. We care only that the noncrystalline state has a lifetim e that is very much longer than the duration of our experim ents.

Our system consists of molecules of two di erent sizes, which we call \sm all" (S) and \large" (L). The interactions between these molecules are standard 6-12 Lennard-Jones potentials:

where the subscripts , denote S or L . We choose the zero-energy interatom ic distances, a , to be

For computational e ciency, we impose a nite-range cuto on the potentials in (2.7) by setting them equal to zero for separation distances r greater than $2.5a_{\rm SL}$. The

m asses are all taken to be equal. The ratio of the num - ber of large m olecules to the num ber of sm all m olecules is half the golden m ean:

In the resulting system , it is energetically favorable for ten sm allm olecules to surround one largem olecule, or for ve largem olecules to surround one sm allm olecule. The highly frustrated nature of this system avoids problem s of local crystallization that offen occur in two dimensions where the nucleation of single component crystalline regions is di cult to avoid. As shown by Lancon et al [37], this system goes through som ething like a glass transition upon cooling from its liquid state. The glass transition tem perature is $0.3T_0$ where k_B $T_0 = e_{\rm SL}$. All the sim ulations reported here have been carried out at a tem perature $T = 0.001 T_0$, that is, at 0.3% of the glass transition tem perature. Thus, all of the phenom ena to be discussed here take place at a tem perature very much lower than the energies associated with the molecular interactions.

In order to start with a densely packed material, we have created our experimental systems by equilibrating a random distribution of particles under high pressure at the low temperature mentioned above. A fier allowing the system to relax at high pressure, we have reduced the pressure to zero and again allowed the sample to relax. O ur molecular dynamics procedure permits us to relax the system only for times of order nanoseconds, which are not long enough for the material to experience any signi cant amount of annealing, especially at such a low temperature.

W e have perform ed num erical experim ents on two different sam ples, containing 10,000 and 20,000 m olecules respectively. A llof the simulation results shown are from the larger of the two sam ples; the sm aller sam ple has been used prim arily to check the reliability of our procedures. W e have created each of these sam ples only once; thus each experim ent using either of them starts with precisely the sam e set of m olecules in precisely the sam e positions. A s will becom e clear, there are both advantages and uncertainties associated with this procedure. On the one hand, we have a very carefilly controlled starting point for each experim ent. On the other hand, we do not know how sensitive the mechanical properties of our system

m ight be to details of the preparation process, nor do we know whether to expect signi cant sam ple-to-sam ple variations in the molecular con gurations. To illustrate these uncertainties, we show the elastic constants of the sam ples in Table 1. The moduli are expressed there in units of $e_{SL} = a_{SL}^2$. (Note that the Poisson ratio for a twodimensional system has an upper bound of 1 rather than 0.5 as in the three-dimensional case.) The appreciable di erences between the moduli of supposedly identical materials tell us that we must be very careful in drawing detailed conclusions from these preliminary results.

C.Sim ulation Results: M acroscopic Observations

In all of our num erical experim ents, we have tried sim – ply to m in ic conventional laboratory m easurem ents of viscoplastic properties of realm aterials. The rst of these is a m easurem ent of stress at constant strain rate. A s we shall see, this supposedly sim plest of the experim ents is especially interesting and problem atic for us because it necessarily probes tim e-dependent behavior near the plastic yield stress.




FIG.1. Shear stress vs. strain for strainrates of 10^{-4} (solid lines) and $2 = 10^{-4}$ (dotted lines). The thicker lines which denote the simulation results exhibit both linear elastic behavior at low strain and non-linear response leading to yield at approximately $_{\rm s} = 0.35$. The thinner curves are predictions of the theory for the two strain rates. Strainrate is measured in units of $(e_{\rm SL} = m a_{\rm SL}^2)^{\frac{1}{2}}$.

O ur results, for two di erent strain rates, are shown in Figure 1. The strain rates are expressed in units proportional to the frequency of oscillation about the minimum in the Lennard-Jones potential, speci cally, in units of $!_0$ ($\mathfrak{g}_L = \mathfrak{m} \, \mathfrak{a}_{SL}^2$)^{$\frac{1}{2}$}, where m is the particle mass. (The actual frequency for the SL potential, in cycles per second, is (3 $^{12}Z^3 =$)! $_0 = 12!_0$.) As usual, the sample has been kept at constant temperature and at pressure P = 0. At low strain, the material behaves in a linearly elastic manner. As the strain increases, the response




FIG.2. Shear strain (open symbols) vs. time for several applied shear stresses (solid symbols). The stresses have been ramped up at a constant rate until reaching a maximum value and then have been held constant. The strain and stress axes are related by twice the shearm odulus so that, for linear elastic response, the open and closed symbols would be coincident. For low stresses the sam ple responds in an alm ost entirely elastic manner. For intermediate stresses the sam ple undergoes some plastic deform ation prior to jamming. In the case where the stress is brought above the yield stress, the sam ple deforms indefinitely. Time is measured in units of $(m a_{\rm SL}^2 = e_{\rm SL})^{\frac{1}{2}}$.

becom es nonlinear, and the material begins to deform plastically. Plastic yielding, that is, the onset of plastic ow, occurs when the strain reaches approximately 0.7%. Note that the stress does not rise smoothly and monotonically in these experiments. We presume that most of this irregularity would average out in larger system s. As we shall see, how ever, there may also be more interesting dynamicale ects at work here.

In all of the other experiments to be reported here, we have controlled the stress on the sample and measured the strain. In the rst of these, shown in Figure 2, we have increased the stress to various di erent values and then held it constant.

In each of these experimental runs, the stress starts at zero and increases at the same constant rate until the desired nal stress is reached. The graphs show both this applied stress (solid symbols) and the resulting strain (open symbols), as functions of time, for three dierent cases. Time is measured in the same molecular-vibration units used in the previous experiments, i.e. in units of $(m a_{SL}^2 = e_{SL})^{\frac{1}{2}}$. The stresses and strain axes are related by twice the shear modulus so that, if the response is linearly elastic, the two curves lie on on top of one another. In the case labelled (4), the nal stress is small, and the response is nearly elastic. For cases () and (2), the sam ple deform splastically until it reaches some nal strain, at which it ceases to undergo further deform ation




FIG.3. Stress and strain vs. time for one particular loading where the stress has been ram ped up to $_{\rm s}$ = 0.25, held for a time, and then released. Note that, in addition to the shear response, the material undergoes a small amount of dilation.




FIG.4. E lastic and inelastic strain vs time for the same simulation as that shown in Figure 3. The inelastic strain is found by subtracting the linearly elastic strain from the total strain. Note the partial recovery of the inelastic portion of the strain which occurs during and after unloading.

on observable timescales. (We cannot rule out the possibility of slow creep at much longer times.) In case (3), for which the nal stress is the largest of the three cases show n, the sample continues to deform plastically at constant stress throughout the duration of the experiment. We conclude from these and a number of similar experimental runs that there exists a well de ned critical stress for this material, below which it reaches a limit of plastic deform ation, that is, it \jmm s," and above which it ows plastically. Because the stress is ram ped up quickly, we can see in curves (2) and (3) of Figure 2 that there is a separation of time scales between the elastic and plastic

responses. The elastic response is instantaneous, while the plastic response develops over a few hundred molecular vibrational periods. To see the distinction between these behaviors m ore clearly, we have perform ed experiments in which we load the system to a xed, subcritical stress, hold it there, and then unload it by ramping the stress back down to zero. In Figure 3, we show this stress and the resulting total shear strain, as functions of time, for one of those experiments. If we de ne the the elastic strain to be the stress divided by twice the previously m easured, as-quenched, shearm odulus, then we can com pute the inelastic strain by subtracting the elastic from the total. The result is shown in Figure 4. Note that most, but not quite all, of the inelastic strain consists of nonrecoverable plastic deform ation that persists after unloading to zero stress. Note also, as shown in Figure 3, that the system undergoes a sm all dilation during this process, and that this dilation appears to have both elastic and inelastic components.




FIG. 5. Final inelastic strain vs. applied stress for stresses below yield. The simulation data (squares) have been obtained by running the simulations until all deform ation apparently had stopped. The comparison to the theory (line) was obtained by num erically integrating the equations of m otion for a period of 800 time units, the duration of the longest simulation runs.

U sing the simple prescription outlined above, we have m easured the nalinelastic shear strain as a function of shear stress. That is, we have measured the shear strain once the system has ceased to deform as in the subcritical cases in Figure 2, and then subtracted the elastic part. The results are shown in Fig. 5. As expected, we see only very small amounts of inelastic strain at low stress. As the stress approaches the yield stress, the inelastic strain appears to diverge approximately logarithm ically.

The naltest that we have performed is to cycle the system through loading, reloading, and reverse-loading. As shown in Figure 6, the sample is rst loaded on the curve from a to b. The initial response is linearly elastic, but, eventually, deviation from linearity occurs as the material begins to deform inelastically. From b to c, the stress is constant and the sample continues to deform inelastically until reaching a nalstrain at c. Upon unloading, from c to d, the system does not behave in a purely elastic manner but, rather, recovers some portion of the strain anelastically. W hile held at zero stress, the sam ple continues to undergo anelastic strain recovery from d to e.

W hen the sample is then reloaded from e to f, it undergoes much less inelastic deform ation than during the initial loading. From f to g the sample again deforms inelastically, but by an amount only slightly more than the previously recovered strain, returning approxim ately to point c. Upon unloading again from g to h to i, less strain is recovered than in the previous unloading from c through e.

It is during reverse loading from i to k that it becomes apparent that the deform ation history has rendered the am orphous sample highly anisotropic in its response to further applied shear. The inelastic strain from i to k is much greater than that from e to g, demonstrating a very signi cant Bauschinger e ect. The plastic deformation in the initial direction apparently has biased the sample in such a way as to inhibit further inelastic yield




FIG. 6. Stress-strain trajectory for a moleculardynamics experiment in which the sample has been baded, unbaded, rebaded, unbaded again, and then reverse-baded, all at stresses below the yield stress. The smaller graph above shows the history of applied shear stress with letters indicating identical times in the two graphs. The dashed line in the main graph is the theoretical prediction for the same sequence of stresses. Note that a small am ount of inelastic strain recovery occurs after the rst unbading in the simulation, but that no such behavior occurs in the theory. Thus, the theoretical curve from c though h unbads, rebads and unbads again all along the same line.

in the same direction, but there is no such inhibition in the reverse direction. The material, therefore, must in som e way have microstructurally encoded, i.e. partially \m em orized," its loading history.

D.Sim ulation Results: M icroscopic Observations

O ur num erical m ethods allow us to exam ine w hat is happening at the m olecular level during these deform ations. To do this system atically, we need to identify where irreversible plastic rearrangements are occurring. M ore precisely, we must identify places where the m olecular displacements are non-a ne, that is, where they deviate substantially from displacements which can be described by a linear strain eld. Our mathematical technique for identifying regions of non-a ne displacement has been described by one of us (M LF) in an earlier publication. [40] For completeness, we repeat it here.

We start with a set of molecular positions and subsequent displacements, and compute the closest possible approximation to a local strain tensor in the neighborhood of any particular molecule. To de ne that neighborhood, we de ne a sampling radius, which we choose to be the interaction range, $2.5a_{\rm SL}$. The local strain is then determined by minimizing the mean square di erence between the the actual displacements of the neighboring molecules relative to the central one, and the relative displacements that they would have if they were in a region of uniform strain "ij. That is, we de ne

where the indices i and j denote spatial coordinates, and the index n runs over the molecules within the interaction range of the reference molecule, n = 0 being the reference molecule. r_n^i (t) is the i'th component of the position of the n'th molecule at time t. We then nd the "_{ij} which m inim izes D² by calculating:

The minimum value of D² (t; t) is then the local deviation from a ne deformation during the time interval [t t; t]. We shall refer to this quantity as D²_{min}.




FIG. 7. Intensity plots of $D_{m in}^{2}$, the deviation from a ne deform ation, for various intervals during two simulations. Figures (a), (b) and (c) show deform ation during one simulation in which the stress has been ramped up quickly to a value less than the yield stress and then held constant. Figure (a) shows deform ations over the rst 10 time units, and gure (b) over the rst 30 time units. Figure (c) shows the same state as in (b), but with $D_{m in}^{2}$ computed only for deform ations that took place during the preceeding 1 time unit. In Figure (d), the initial system and the time interval (10 units) are the same as in (a), but the stress has been applied in the opposite direction. The gray scale in these gures has been selected so that the darkest spots identify m olecules for which $p_{m in} \neq 0.5 a_{SL}$.




FIG.8. C lose-up picture of a shear transform ation zone before and after undergoing transform ation. M olecules after transform ation are shaded according to their values of D $_{\rm m\ in}^2$ using the same gray scale as in Figure 7. The direction of the externally applied shear stress is shown by the arrows. The ovals are included solely as guides for the eye.

W e have found that $D_{m in}^2$ is an excellent diagnostic for identifying local irreversible shear transform ations. Figure 7 contains four di erent intensity plots of D $_{m in}^{2}$ for a particular system as it is undergoing plastic deform ation. The stress has been ram ped up to $j_s j = 0.12$ in the time interval [0,12] and then held constant in an experiment analogous to that shown in Figure 2. Figure 7(a) shows $D_{m in}^{2}$ for t = 10, t = 10. It dem onstrates that the nona ne deform ations occur as isolated sm all events. In (b) we observe the same simulation, but for t = 30, t = 30; that is, we are looking at a later time, but again we consider rearrangements relative to the inital con guration. Now it appears that the regions of rearrangem ent have a larger scale structure. The pattern seen here looks like an incipient shear band. However, in (c), where t = 30, t = 1, we again consider this later time but look only at rearrangem ents that have occurred in the preceeding short time interval. The events shown in this gure are small, demonstrating that the pattern shown in (b) is, in fact, an aggregation of many local events. Lastly, in (d), we show an experiment similar in all respects to (a) except that the sign of the stress has been reversed. As in (a), t = 10, t = 10, and again we observe small isolated events. How ever, these events occur in di erent locations, implying a direction dependence of the local transform ation m echanism .

Next we look at these processes in yet more detail. Figure 8 is a close-up of the molecular con gurations in the lower left-hand part of the largest dark cluster seen in Figure 7 (c), shown just before and just after a shear transformation. During this event, the cluster of one large and three sm all m olecules has compressed along the top-left/bottom -right axis and extended along the bottom -left/top-right axis. This deform ation is consistent with the orientation of the applied shear, which is in the direction shown by the arrows on the outside of the gure. Note that this rearrangem ent takes place without signi cantly a ecting the relative positions of m olecules in the imm ediate environm ent of the transform ing region. This is the type of rearrangem ent that Spaepen identi es as $a \setminus ow$ defect." [20] As mentioned in the introduction, we shall call these regions \shear transform ation zones."

III. THEORET ICAL INTERPRETATION OF THE MOLECULAR - DYNAM ICS EXPERIMENTS

A . Basic H ypotheses

W e turn now to our attempts to develop a theoretical interpretation of the phenom ena seen in the simulations. W e shallnot insist that our theory reproduce every detail of these results. In fact, the simulations are not yet com – plete enough to tell us whether som e of our observations are truly general properties of the model or are artifacts of the ways in which we have prepared the system and carried out the num erical experim ents. Our strategy will be, rst, to specify what we believe to be the basic fram ework of a theory, and then to determ ine which specic assumptions within this fram ework are consistent with the num erical experiments.

There are several features of our num erical experiments that we shall assume are fundamentally correct and which, therefore, must be outcom es of our theory. These are: (1) At a su ciently sm all, xed load, i.e. under a constant shear stress less than som e value that we identify as a yield stress, the system undergoes a nite plastic deform ation. The am ount of this deform ation diverges as the loading stress approaches the yield stress. (2) At loading stresses above the yield stress, the system ow svisco-plastically. (3) The response of the system to bading is history-dependent. If it is baded, unbaded, and then reloaded to the sam e stress, it behaves alm ost elastically during the reloading, i.e. it does not undergo additional plastic deform ation. On the other hand, if it is baded, unbaded, and then reloaded with a stress of the opposite sign, it deform s substantially in the opposite direction.

O ur theory consists of a set of rate equations describing plastic deform ation. These include an equation for the inelastic strain rate as a function of the stress plus other variables that describe the internal state of the system. We also postulate equations of motion for these state variables. D eform ation theories of this type are in the spirit of investigations by E. Hart [15] who, to the best of our know ledge, was the rst to argue in a mathem atically system atic way that any satisfactory theory of plasticity m ust include dynam ical state variables, beyond just stress and strain. A sim ilar point of view has been stressed by R ice. [16] O ur analysis is also in uenced by the use of state variables in theories of friction proposed recently by R uina, D ieterich, C arlson, and others. [41{46]

O urpicture of what is happening at the molecular level in these systems is an extension of the ideas of Tumbull, C ohen, A rgon, Spaepen and others. [17{21,23{25] T hese authors postulated that deform ation in am orphousm aterials occurs at special sites where the molecules are able to rearrange them selves in response to applied stresses. As described in the preceding chapter, we do see such sites in our simulations, and shall use these shear transform ation zones as the basis for our analysis. How ever, we must be careful to state as precisely as possible our de nition of these zones, because we shall use them in ways that were not considered by the previous authors.

O ne of the m ost fundam ental di erences between previous work and ours is the fact that our system is effectively at zero tem perature. W hen it is in m echanical equilibrium, no changes occur in its internal state because there is no therm al noise to drive such changes. Thus the shear transform ation zones can undergo transitions only when the system is in motion. Because the system is strongly disordered, the forces induced by largescale motions at the position of any individual molecule m ay be noisy. These uctuating forces may even look as if they have a therm al component. [47] The therm odynam ic analogy (therm all activation of shear transform ations with tem perature being som e function of the shear rate) may be an alternative to (or an equivalent of) the theory to be discussed here. However, it is beyond the scope of the present investigation.

Our next hypothesis is that shear transform ation zones are geometrically identiable regions in an amorphous solid. That is, we assume that we could | at least in principle | look at a picture of any one of the com putergenerated states of our system and identify sm all regions that are particularly susceptible to inelastic rearrangement. As suggested by Fig. 8, these zones might consist of groups of four or more relatively loosely bound molecules surrounded by more rigid \cages." But that specic picture is not necessary. The main idea is that som e such irregularities are locked in on tim e scales that are very much longer than molecular collision times. That is not to say that these zones are perm anent features of the system on experimental time scales. On the contrary, the tendency of these zones to appear and disappear during plastic deformation will be an essential ingredient of our theory.

W e suppose further that these shear transform ation zones are two-state system s. That is, in the absence of any deform ation of the cage of m olecules that surrounds them, they are equally stable in either of two con gurations. Very roughly speaking, the molecular arrangements in these two con gurations are elongated along one or the other of two perpendicular directions which, shortly, we shall take to be coincident with the principal axes of the applied shear stress. The transition between one such state and the other constitutes an elem entary increm ent of shear strain. Note that bistability is the naturalassum ption here. M ore than two states of com parable stability m ight be possible but would have relatively low probability. A crucial feature of these bistable systems is that they can transform back and forth between their two states but cannot make repeated transform ations in one direction. Thus there is a natural lim it to how much shear can take place at one of these zones so long as the zone rem ains intact.

We now consider an ensemble of shear transform ation zones and estimate the probability that any one of them will undergo a transition at an applied shear stress $_{\rm s}$. Because the temperatures at which we are working are so low that ordinary thermal activation is irrelevant, we focus our attention on entropic variations of the local free volume. Our basic assumption is that the transition probability is proportional to the probability that the molecules in a zone have a su ciently large excess free volume, say V , in which to rearrange them selves. This critical free volume must depend on the magnitude and orientation of the elastic deform ation of the zone that is caused by the externally applied stress, $_{\rm s}$.

At this point, our analysis borrows in its general approach, but not in its speci cs, from recent developm ents in the theory of granular materials [48] where the only

extensive state variable is the volum e .W hat follows is a very simple approximation which, at great loss of generality, leads us quickly to the result that we need. The free volume, i.e. the volume in excess of close packing that the particles have available for motion, is roughly

In the dense solids of interest to us here, $v_{\rm f}$ v_0 , and therefore v_0 is approximately the average volum e per particle even when the system is slightly dilated. The number of states available to this system is roughly proportional to $(v_{\rm f}=h)^{\rm N}$, where h is an arbitrary constant with dimensions of volum e | the analog of P lanck's constant in classical statistical mechanics | that plays no role other than to provide dimensional consistency. Thus the entropy, de ned here to be a dimensionless quantity, is

A form ula like (3.4) appears in various places in the earlier literature. [17,23{25] There is an important difference between its earlier use and the way in which we are using it here. In earlier interpretations, (3.4) is an estim ate of the probability that any given molecule has a large enough free volume near it to be the site at which a therm ally activated irreversible transition m ight occur. In our interpretation, (3.4) plays more nearly the role of the therm all activation factor itself. It tells us something about the con gurational probability for a zone, not just for a single molecule. When multiplied by the density of zones and a rate factor, about which we shall have more to say shortly, it becomes the transform ation rate per unit volume.

Note what is happening here. Our system is extremely non-ergodic and, even when it is undergoing appreciable strain, does not explore more than a very small part of its con guration space. Apart from the molecular rearrangements that take place during plastic deformation, the only chance that the system has for coming close to any state of equilibrium occurs during the quench by which it is formed initially. Because we control only the temperature and pressure during that quench, we must use entropic considerations to compute the relative probabilities of various molecular con gurations that result from it. The transitions occurring within shear transform ation zones are strains, and therefore they must, in principle, be described by tensors. For present purposes, how ever, we can make some sim plifying assumptions. As described in Chapter II, our molecular-dynamics model is subject only to a uniform, pure shear stress of magnitude $_{\rm s}$ and a hydrostatic pressure P (usually zero). Therefore, in the principal-axis system of coordinates, the stress tensor is:

In a more general form ulation, we shall have to consider a distribution of orientations of the shear transformation zones. That distribution will not necessarily be isotropic when plastic deform ations are occurring, and very likely the distribution itself will be a dynam ical entity with its own equations of motion. Our present analysis, however, is too crude to justify any such level of sophistication.

The last of our main hypotheses is an equation of motion for the densities of the shear transform ation zones. Denote the two states of the shear transform ation zones by the symbols + and $\$, and let n be the num ber densities of zones in those states. We then write:

Here, the R are the rates at which states transform to states. These must be consistent with the transition probabilities described in the preceding paragraphs.

The last two terms in (3.9) describe the way in which the population of shear transform ation zones changes as the system undergoes plastic deform ation. The zones can be annihilated and created | as shown by the term s with coe cients C₁ and C₂ respectively | at rates proportional to the rate s_{-s}^{\min} at which irreversible work is being done on the system. This last assumption is simple and plausible, but it is not strictly dictated by the physics in any way that we can see. A caveat: In certain circum – stances, when the sam ple does work on its environment,

 s_{-s}^{\min} could be negative, in which case the annihilation and creation terms in (3.9) could produce results which would not be physically plausible. We believe that such states in our theory are dynam ically accessible only from unphysical starting con gurations. In related theories, how ever, that may not be the case.

It is important to recognize that the annihilation and creation terms in (3.9) are interaction terms, and that they have been introduced here in a mean-eld approximation. That is, we implicitly assume that the rates at which shear transform ation zones are annihilated and created depend only on the rate at which irreversible work is being done on the system as a whole, and that there is no correlation between the position at which the work is being done and the place where the annihilation or creation is occurring. This is in fact not the case as shown by Fig. 7(b), and is possibly the weakest aspect of our theory.

W ith the preceding de nitions, the time rate of change of the inelastic shear strain, $"^{\rm in}_{-\rm s}$, has the form :

The prefactor R_0 is an as-yet unspeci ed attempt frequency for these transform ations. In writing (3.11), we have used the assumed symmetry of the system to note that, if V ($_s$) is the required excess free volume for a (+ !) transition, then the appropriate free volume for the reverse transition must be V ($_s$). We adopt the convention that a positive shear stress deforms a zone in such a way that it enhances the probability of a (! +) transition. Then V ($_s$) is a decreasing function of $_s$.

From (3.16), we see that n_1 is the stable equilibrium value of n_{tot} so long as s_{-s}^{\min} remains positive. is a characteristic stress that, in certain cases, turns out to be the plastic yield stress. A s we shall see, we need only the above form of the equations of motion to deduce the existence of the plastic yield stress and to compute some elementary properties of the system.

The interesting time-dependent behavior of the system, however, depends sensitively on the as-yet unspecie d ingredients of these equations. Consider rst the rate factor R₀. Our zero-tem perature hypothesis in plies that R₀ should be zero whenever the inelastic shear rate \prod_{s}^{n} and the elastic shear rate $\prod_{s}^{n=1} = __{s} = 2$ both vanish. A coordingly, we assume that

We can o er only a speculative justi cation for the right-hand side of (3.18). The rearrangements that occur during irreversible shear transform ations are those in which molecules deviate from the trajectories that they would follow if the system were a continuous medium

and

undergoing a ne strain. If we assume that these deviations are di usive, and that the a ne deform ation over some time interval scales like the strain rate, then the non-a ne transform ation rate must scale like the square root of the a ne rate. (D i usive deviations from sm ooth trajectories have been observed directly in numerical sim – ulations of sheared foam s, [47] but only in the equivalent of our plastic ow regime.) In (3.18), we further assume that the elastic and inelastic strain rates are incoherent, and thus write the sum of squares within the brackets. In what follows, we shall not be able to test the validity of (3.18) with any precision. M ost probably, the only properties of importance to us for present purposes are the magnitude of R₀ and the fact that it vanishes when the shear rates vanish.

Finally, we need to specify the ingredients of V and v_f . For V , we choose the sim ple form :

The right-hand side of (3.19) simply rejects the fact that the free volume needed for an activated transition will decrease if the zone in question is loaded with a stress which coincides with the direction of the resulting strain. We choose the exponential rather than a linear dependence because it makes no sense for the incremental free volume V_0 to be negative, even for very large values of the applied stresses.

Irreversibility enters the theory via a simple switching behavior that occurs when the $_{s}$ -dependence of V in (3.19) is so strong that it converts a negligably sm all rate at $_{s} = 0$ to a large rate at relevant, non-zero values of

 $_{\rm s}$. If this happens, then zones that have switched in one direction under the in uence of the stress will remain in that state when the stress is removed.

In the formulation presented here, we consider $v_{\rm f}$ to be constant. This is certainly an approximation; in fact, as seen in Figure 3, the system dilates during shear deform ation. We have experimented with versions of this theory in which the dilation plays a controlling role in the dynam ics via variations in $v_{\rm f}$. W e shall not discuss these versions further because they behaved in ways that were qualitatively di erent from what we observed in our sin ulations. The di erences arise from feedback between inelastic dilation and ow which occur in these dilational models, and apparently not in the simulations. A sim ple com parison of the quantities involved dem onstrates that the assumption that v_f is approximately constant is consistent with our other assumptions. If we assume that the increm ent in free volum e at zero stress must be of order the volume of a small particle, V_0 M 0:3. and then look ahead and use our best-t value for the ratio $V_0 = v_f$ 14:0 (see Section IIID, Table II), we nd v_f 0:02. Since the change in free volume due to a dilational strain $"_d$ is $v_f = "_d =$, where is the num ber density, and $"_d < 0.2\%$ for all shear stresses except those very close to yield, it appears that, generally,

The preceding analysis is our mathematical description of how the system jams due to the two-state nature of the shear transformation zones.  \mid grows. Eventually, all of the favorably aligned zones that can transform at the given m agnitude and direction of the stress have undergone their one allowed transformation, has become large enough to cause F in (3.24) to vanish, and plastic deformation comes to a halt.

This owing solution arises from the non-linear annihilation and creation terms in (3.9). In the owing state, stresses are high enough that shear transform ation zones are continuously created. A balance between the rate of zone creation and the rate of transform ation determ ines the rate of deform ation.

Examination of (3.22) and (3.23) reveals that the jammed solution (3.29) is stable for low stresses, while the owing solution (3.34) is stable for high stresses. There are veadjustable system parameters in our theory: , V_z "n₁, , $V_0 = v_f$, and . In addition, we must specify initial conditions for E, , and . For all cases of interest here, E (0) = (0) = 0. However, (0) = n_{tot} (0)=n₁ is an important parameter that characterizes the as-quenched initial state of the system and which remains to be determined.

To test the validity of this theory, we now must nd out whether there exists a set of physically reasonable values of these parameters for which the theory accounts for all (or alm ost all) of the wide variety of tim e-dependent phenom ena seen in the molecular-dynam ics experim ents. Our strategy has been to start with rough guesses based on our understanding of what these parameters mean, and then to adjust these values by trial and error to t what we believe to be the crucial features of the experim ents. W e then have used those values of the param eters in the equations of motion to check agreem ent with other num erical experim ents. In adjusting param eters, we have looked for accurate agreem ent between theory and experiment in low-stress situations where we expect the concentration of active shear transform ation zones to be low; and we have allow ed larger discrepancies near and above the yield stress where we suspect that interactions between the zonesm ay invalidate ourm ean-eld approxim ation. Our best-t parameters are shown in Table II.

The easiest parameter to t should be because it. should be very nearly equal to the yield stress. That is, it should be som ewhere in the range 0.30-0.35 according to the data shown in Fig. 5. Note that we cannot use (3.33) to t the experimental data near the yield point because both the num erical simulations and the theory tell us that the system approaches its stationary state in nitely slowly there. Moreover, we expect interaction e ects to be important here. The solid curve in Fig. 5 is the theoretically predicted strain found by integrating the equations of m otion for 800 time units, the duration of the longest of the simulation runs. The downward adjustment of , from its apparent value of about 0.35 to its best-t value of 0.32, has been m ade on the basis of the latter tim e-dependent calculations plus evidence about the e ect of this param eter in other parts of the theory.

Next we consider $V_z \ "n_1$, a dimensionless parameter which corresponds to the am ount of strain that would occur if the density of zones were equal to the equilibrium concentration $(n_{tot} = n_1)$ and if all the zones transformed in the same direction in unison. A lternatively, if the local strain increment " is about unity, then this parameter is the fraction of the volume of the system that is occupied by shear transform ation zones. In either way of looking at this quantity, our best-t value of 5.7% seem s sensible.

The parameter is a rate which is roughly the product of an attempt frequency and a statistical factor. The only system-dependent quantity with the dimensions of inverse time is the molecular vibrational frequency, which we have seen is of order unity. Our best-t value of 50 seems to imply that the statistical factor is moderately large which, in turn, implies that the shear transform ation zones are fairly complex, multimolecule structures. Lacking any rst-principles theory of this rate factor, how ever, we cannot be con dent about this observation.

Our rst rough guess for a value of $V_0 = v_f$ comes from the assumption that V must be about one molecular volume in the absence of an external stress, and that v_f is likely to be about a tenth of this. Thus our best-t value of 14.0 is reassuringly close to what we expected.

The parameter , a modulus that characterizes the sensitivity of V to the applied stress, is especially interesting. Our best-t value of 0.25 is alm ost two orders of magnitude smaller than a typical shear modulus for

these systems. This means that the shear transform ations are induced by relatively small stresses or, equivalently, the internal elastic modes within the zones are very soft. This conclusion is supported quite robustly by our thing procedure. A lternative assumptions, such as control by variations in the average free volume $v_{\rm f}$ discussed earlier, produce qualitatively wrong pictures of the time dependent onset of plastic deformation.

Finally, we consider $(0) = n_{tot} (0)=n_1$, the ratio of the inital zone density to the equilibrium zone density. This parameter characterizes the transient behavior associated with the initial quench; that is, it determ ines the as-quenched system's rst response to an applied stress. We can learn something about this parameter by looking at later behavior, i.e. the next few segments of a hysteresis loop like that shown in Figure 6. If, as is observed there, the loop narrows after the rst leg, then we know that there was an excess of shear transform ation zones in the as-quenched system, and that this excess was reduced in the initial deform ation. A n initial excess m eans (0) > 1, consistent with our best- t value of 2.0.

E.Com parisons between Theory and Sim ulations

W e now illustrate the degree to which this theory can and cannot | account for the phenom ena observed in the num erical experim ents.




FIG.9. Strain vs. time for simulations in which the stress has been ramped up at a controlled rate to stresses of 0.1, 0.2 and 0.3, held constant, and then ramped down to zero (solid lines). The dashed lines are the corresponding theoretical predictions.

Figure 9 sum m arizes one of the principal successes of the theory, speci cally, its ability to predict the timedependent onset of plastic deformation over a range of applied stresses below the yield stress. The solid lines in the Figure show the shear strains in three di erent simulations as functions of time. In each simulation the stress is ram ped up at the sam e controlled rate, held constant for a period of time, and then ramped down, again at the same rate. In the lowest curve the stress reaches a maximum of 0.1 in our dimensionless stress units $(e_{SL} = a_{SL}^2)$, in the middle curve 0.2, and in the highest 0.3. The dashed lines show the predictions of the theory. The excellent agreem ent during and after the ramp-up is our most direct evidence for the small value of quoted above. The detailed shapes of these curves at the tops of the ram ps, where _s drops abruptly to zero, provide som e qualitative support for our choice of the rate dependence of R_0 in (3.18). As shown in Figure 5 and discussed in the preceding subsection, the nal inelastic strains in these ram p-up experiments are also predicted adequately by the theory.

The situation is di erent for the unloading phases of these experiments, that is, during and after the periods when the stresses are ramped back down to zero. The theoretical strain rates shown in Figure 9 vanish abruptly at the bottom s of the ramps because our transform ation rates become negligably small at zero stress. In the two experimental curves for the higher stresses, how ever, the strain continues to decrease for a short while after the

stresses have stopped changing. Our theory seem s to rule out any such recovery of inelastic strain at zero stress; thus we cannot account for this phenom enon except to rem ark that it must have something to do with the initial state of the as-quenched system. A s seen in Figure 6, no such recovery occurs when the system is loaded and unloaded a second time.

In Figure 6, we compare the stress-strain hysteresis loop in the simulation (solid line) with that predicted by the theory (dashed line). Apart from the inelastic strain recovery after the rst unloading in the simulation, the theory and the experim ent agree well with one another at least through the reverse loading to point k. The agreem ent becom es less good in subsequent cycles of the hysteresis loop, possibly because shear bands are form ing during repeated plastic deform ations.

In the last of the tests of theory to be reported here, we have added in F igure 1 two theoretical curves for stresses as functions of strain at the two di erent constant strain rates used in the simulations. The agreem ent between theory and experiment is better than we probably should expect for situations in which the stresses necessarily rise to values at or above the yield stress. Moreover, the validity of the comparison is obscured by the large uctuations in the data, which we believe to be due primarily to small sample size.

Am ong the interesting features of the theoretical results in Figure 1 are the peaks in the stresses that occur just prior to the establishm ent of steady-states at constant stresses. These peaks occur because the internal degrees of freedom of the system, speci cally (t) and

(t), cannot initially equilibrate fast enough to accom odate the rapidly increasing inelastic strain. Thus there is a transient sti ening of the material and a momentary increase in the stress needed to maintain the constant strain rate. This kind of e ect may in part be the explanation for some of the oscillations in the stress seen in the experiments. In a more speculative vein, we note that this is our rst direct hint of the kind of dynam ic plastic sti ening that is needed in order to transmit high stresses to crack tips in brittle fracture. The orders of magnitude of the time scales are even roughly the same. The strain rates used here, and those that occur near the tips of brittle cracks, are both of the order of 10^7 per second.

IV.CONCLUDING REMARKS

The most striking and robust conclusion to emerge from this investigation, in our opinion, is that a wide range of realistic, irreversible, viscoplastic phenom ena occur in an extremely simple molecular-dynamics model a two-dimensional, two-component, Lennard-Jones am orphous solid at essentially zero temperature. An almost equally striking conclusion is that a theory based on the dynamics of two-state shear transform ation zones is in substantial agreement with the observed behavior of this model. This theory has survived several quantitative tests of its applicability.

W e stated in our Introduction that this is a prelim inary report. B oth the num erical sim ulations and the theoreticalanalysis require careful evaluation and im provem ents. M ost im portantly, the work so far raises m any im portant questions that need to be addressed in future investigations.

The rst kind of question pertains to our moleculardynam ics simulations: A re they accurate and repeatable? W e believe that they are good enough for present purposes, but we recognize that there are potentially in portant di culties. The most obvious of these is that our simulations have been performed with very small system s; thus, size e ects m ay be im portant. For exam ple, the fact that only a few shear transform ing regions are active at any time may account for abrupt jumps and other irregularities som etim es seen in the simulations, e.g. in Figure 1. We have performed the simulations in a periodic cell to elim inate edge e ects. W e also have tried to compare results from two systems of di erent sizes, although only the results from the larger system are presented here. Unfortunately, com parisons between any two di erent initial con gurations are di cult because of our inability, as yet, to create reproduceable glassy starting con gurations (a problem which we shall discuss next). However, we have seen qualitatively the same behavior in both systems, and assume that phenom ena which are common to both systems can be used as a guide for theoretical investigations.

A snoted in Section IIB and in Table, our two systems had quite di erent elastic moduli. (Remarkably, their yield stresses were nearly identical. It would be interesting to learn whether this is a repeatable and/orphysically

in portant phenom enon.) The discrepancy between the elastic properties of the two systems leads us to believe that, in future work, we shall have to learn how to control the initial con gurations more carefully, perhaps by annealing the systems after the initial quenches. Unfortunately, straightforward annealing at tem peratures well below the glass transition is not yet possible with standard molecular-dynam ics algorithm s, which can simulate tim es only up to about a microsecond for system s of this size even with today's fastest computers. Monte C arlo techniques or accelerated molecular-dynam ics algorithm s may eventually be useful in this e ort. [50{52]An alternative strategy may be simply to look at larger numbers of simulations.

By far the most di cult and interesting questions, however, pertain to our theoretical analysis. A lthough Figures 7 and 8 provide strong evidence that inteversible shear transform ations are localized events, we have no sharp de nition of a \shear transform ation zone." So far, we have identi ed these zones only after the fact, that is, only by observing where the transform ations are taking place. Is it possible, at least in principle, to identify zones before they becom e active?

O ne ingredient of a better de nition of shear transform ation zones will be a generalization to isotropic am orphous system s in both two and three dimensions. A swe noted in Chapter III, our functions n (t) should be tensor quantities that describe distributions over the ways in which the individual zones are aligned with respect to the orientation of the applied shear stress. We believe that this is a relatively easy generalization; one of us (MLF) expects to report on work along these lines in a later publication.

O ur m ore urgent reason for needing a better understanding of shear transformation zones is that, without such an understanding, we shall not be able to nd rst-principles derivations of several, as yet purely phenom enological, ingredients of our theory. It might be useful, for example, to be able to start from the molecular force constants and calculate the parameters V_0 and

that occur in the activation factor (3.19). These parameters, however, seem to have clear physical interpretations; thus we m ight be satisfied to deduce them from experiment. In contrast, the conceptually most challenging and important terms are the rate factor in (3.18) and the annihilation and creation terms in (3.9), where we do not even know what the functional form sought to be.

Calculating the rate factor in (3.18), or a correct version of that equation, is clearly a very fundam ental problem in nonequilibrium statistical physics. So far as we know, there are no studies in the literature that m ight help us compute the force uctuations induced at som e site by externally driven deform ations of an am orphous m aterial. Nor do we know how to compute a statistical prefactor analogous, perhaps, to the entropic factor that converts an activation energy to an activation free energy. [49]W e do know, how ever, that that entropic factor will depend strongly on the size and structure of the zone that is undergoing the transform ation.

As emphasized in Chapter III, the annihilation and creation terms in (3.9) describe interaction e ects. Even within the fram ework of our mean-eld approximation, we do not know with any certainty what these terms should be. Our assumption that they are proportional to the rate of irreversible work is by no means unique. (Indeed, we have tried other possibilities in related investigations and have arrived at qualitatively similar conclusions.) Without knowing more about the nature of the shear transformation zones, it will be di cult to derive such interaction terms from rst principles.

A better understanding of these interaction terms is especially important because these are the terms that will have to be modi ed when we go beyond the meaneld theory to account for correlations between regions undergoing plastic deform ations. We know from our sim ulations that the active zones cluster even at stresses far below the plastic yield stress; and we know that plastic yield in real am orphous materials is dom inated by shear banding. Thus, generalizing the present mean-eld theory to one which takes into account spatial variations

in the densities of shear transform ation zones must be a

high priority in this research program . Finally, we return brie y to the questions which m otivated this investigation: How m ight the dynam icale ects described here, which m ust occur in the vicinity of a crack tip, control crack stability and brittle/ductile behavior? A swe have seen, our theoretical picture of viscop lasticity does allow large stresses to be transm itted, at least for short times, through plastically deforming materials. It should be interesting to see what happens if we incorporate this picture into theories of dynam ic fracture.
