On the Stability of the Quenched State in Mean Field Spin Glass Models

A bstract

W hile the G ibbs states of spin glass m odels have been noted to have an erratic dependence on temperature, one m ay expect the mean over the disorder to produce a continuously varying \quenched state". The assumption of such continuity in temperature in plies that in the in nite volume limit the state is stable under a class of deform ations of the G ibbs measure. The condition is satis ed by the Parisi A nsatz, along with an even broader stationarity property. The stability conditions have equivalent expressions as marginal additivity of the quenched free energy. Im plications of the continuity assumption include constraints on the overlap distribution, which are expressed as the vanishing of the expectation value for an in nite collection of multi-overlap polynom ials. The polynom ials can be computed with the aid of a real-replica calculation in which the number of replicas is taken to zero.

Keywords: Mean eld, spin glass, quenched state, overlap distribution, replicas.

1. Introduction

W e consider here the quenched state of the Sherrington-Kirkpatrick (SK) spin glass model, and discuss some stationarity properties which seem to emerge in the in nite volum e limit.

The SK spin glass model [1] has spin variables i = 1, i = 1; ...; N, interacting via the H am iltonian

with J_{ij} independent norm alg aussian variables.

Sampling repeatedly spin con gurations ⁽¹⁾ from the space $S_N = f + 1;1d^N$, distributed independently relative to a common G ibbs state, one obtains a random matrix of overlaps $q_{l,m} = q_{(1)}$, with the overlap de ned for pairs of spin con gurations and ⁰ as:

The quenched free energy, at a given temperature $T = (k)^{-1}$, is determined in this model by the joint distribution of such overlaps for arbitrary number of \replicas" (copies of the spin system subject to the same random interaction).

The purported solution of the model via the Parisi ansatz [2] has a number of remarkable stability properties. Our purpose is to discuss some of these, starting from elementary continuity assumptions without assuming the validity of the proposed solution. Some results in a similar direction were previously obtained by F.Guerra [3].

Following are the main observations presented here.

- 1) We identify a stability condition, in the sense of invariance of the quenched state in the therm odynam ic lim it under a broad class of deform ations, which is satis ed by the state corresponding to the Parisi solution.
- 2) We show that a restricted version of the stability condition is a consequence of a property which make good physical sense, namely the continuity of the quenched ensemble as function of the temperature.
- 3) The restricted stability of the quenched state in plies the vanishing of expectation values for a family of overlap multireplica polynom ials. This accounts for some of the relations, though far from all, found in the Parisi solution.
- 4) We ask whether the stability condition singles the Parisi fam ily of states (the GREM models in the term inology of [4]). A considerably simplified version of such a question (concerning the characterization of the the REM states) has a positive answer [5] (in preparation).

2. Invariance of the Parisi solution.

Let us introduce the notation employed here for the quenched state, and state a remarkable invariance property of the Parisi solution.

2.a Notation for Quenched Ensembles

In disordered spin system swe encounter two distinct random structures: the spins, distributed (in equilibrium) according to the G ibbs distribution, and the random couplings (and/orrandom elds and other parameters) which a ect the G ibbs state, making it into a random measure. We denote here by < >, and in case of possible confusion by $< >_J$, the expectation value over the spins averaged with respect to the G ibbs state. An average over the couplings is denoted by Av(). The combined quenched average is a double average, denoted below by E (), over the spins and the disorder (whose probability distribution is not a ected [in the quenched case] by the response of the spin system to the random Ham iltonian).

Quantities of interest include:

(where the indices on $q_{1;2}$ have di erent meaning than those on $_{1-2}$). The second example is seen among other terms in $\frac{\varrho}{\varrho} \in \mathbb{N}^{n}$ $q_{1;2}^2$. In expressions like this the factors $J_{i;j}$ can be integrated out, e.g., through the integration by part formula (for normal Gaussian variables)

The expression can then be further reduced to an average of a suitable overlap m onom ial.

O verlap m onom ials are functions of the form ${}^{Q}_{1 \ l_{m} \ K} q^{n_{l_{m}}}_{(l); (m)}$ de ned over the product space S^K, S being the spin con guration space. Their expectation values over the corresponding product m easure on identical copies ${}^{Q}_{1 \ l_{K}} < {}^{N}_{N,J}$ are denoted by the symbol

and the full \quenched average" is denoted by E (), e.g.:

We shall often om it the explicit reference to J, to other subscripts such as tem perature, as well as to N. However, it should hopefully be clear from the context when do we refer to a nite system and when to the in nite volume limit.

Naturally, we are interested in the lim it N $!\,1$. There is no reason to expect (at low tem peratures) convergence of the state $_{\rm J}$ at given realization of the random couplings $fJ_{\rm irj}g$. However it does not seem unreasonable to expect convergence of the quenched averages of f(), where f() can be any local function of the spins. We note that elementary compactness arguments in ply that for any tem perature there is a sequence N $_{\rm k}$ which increases to 1, for which the following lim its exists simultaneously for all the overlap monomials

Our discussion will concern relations among the monom is laverages which would be valid in such lim its, under a number of assumptions (which include the existence of the lim it).

R em ark: It is possible to develop a more complete setup for the formulation of the in nite volume limit of states of the SK model, in which the limit of the quenched averages is described in term sofa probability measure on M (S) - the space of probability measures on S = f 1;+1g^N which is the space of con gurations of an in nite spin system (N being the set of natural numbers). The elements of M (S) are random states incorporating the elects of quenched disorder. We shall, however, not pursue this line here.

W e shall invoke an additional element of structure: Gaussian elds h();K() de ned over $S_{\rm N}$ with the covariances

which are independent of each other and of J, in the sense exemplied by the relation

(A nalogous relation -with $q_{i;j}$ replaced by $q_{i;j}^2$, is assumed for K .)

In the SK model (N < 1), a quantity like h() appears as the cavity eld associated with an increase in N, and K () can be found as representing the change in the action corresponding to an increase in the temperature. The two can be realized as:

where the J^0_i and $J^0_{i;j}$ are norm alG aussian variables, independent form each other and from the couplings J appearing in the H am iltonian. Based on this example, we incorporate the averages over the elds h;K under the symbol Av(), even when the average is at xed .

2.b Invariance of the Parisi solution

The Parisi solution has the property that quenched averages are not a ected by the addition to the action of terms of the form F (K (); h()), where F (;) is any smooth bounded function.

To express the above stated property, let us consider the deform ed states

where the expectation value functionals are to be interpreted as the N ! 1 limits of expectations of overlap m onom ials.

We shall not verify this statem ent here { the reader is invited to do so from the solution which is discussed in [2], references therein, and in [4] { instead we shall discuss the origin and consequences of a som ewhat restricted invariance of this kind.

3. Continuity in the tem perature and stability under deform ation The broad stability of the quenched state expressed by eq. (2.14) has not yet been rigorously derived for the SK model. We shall now nd that a somewhat restricted version of this condition follows from a natural continuity assumption.

There is a signi cant di erence between the spin {glass and the ferrom agnetic spin m odels in the e ect of a change in the tem perature on the equilibrium state. R eduction in the tem perature am ounts to increased coercion towards the low energy states of the system. If the ground state is unique, it is natural to expect the equilibrium state to vary continuously at low tem peratures. W hen there are only few ground states, one m ay expect som e discontinuities (as in the P irogov-Sinai theory [6]). However, when there is a high multiplicity of competing low energy states the result m ay be quite di erent. Indeed it is reported that for a given realization of the random H am iltonian, the equilibrium state has a very erratic dependence on the tem perature. N evertheless it m ay seem reasonable to expect that with the average over the disorder, the quenched state m ight vary continuously with .

To illum inate the consequences of the continuity assumption, let us note that due to the addition law for independent G aussian variables, the G ibbs factor determ ining the equilibrium state at the inverse {tem perature + can be presented as a sum of two independent term s:

where $A \stackrel{D}{=} B$ m eans that A and B have equal probability distributions, fJ; Jg are two independent sets of couplings, and

W ith the action cast in the form eq. (3.1), the modi ed state is seen to incorporate the e ects of a strong term (of the order of the volum e) pulling in some random ly chosen directions, when the main term itself has many competing states. The assumption of the continuity of the quenched state appears now as less obvious, and it should therefore carry some notable consequences.

A related observation can be made by considering the elects of deform ation of the state through the addition of a Gaussian eld of the type K () (eq. (2.7)). An easy computation based on the fact that

where the superscripts refer to the size and the inverse $\{\text{tem perature, the subscript indi$ cates a deform ation of the state in the sense of eq. (2.12) and, as for the eq. (2.14) theequality is understood when the two measures are restricted to the quantities independent from the deform ation variable K.

In the lim it N ! 1, the change in the tem perature on the right side vanishes. This immediately leads to the following observation.

P roposition 3.1 If in a certain temperature range the quenched averages E $^{(N;)}$ $\binom{Q}{q_{i;j}^{n_{i;j}}}$ are uniform ly continuous in , as N ! 1, and the in nite{volume limit exist for the quenched state, in the sense of eq. (2.5), then the limit E $^{()}$ $\binom{Q}{q_{i;j}^{n_{i;j}}}$ is stable under deform ations by e K , i.e.:

Let us note that the assumptions made above imply also another stationarity principle: the quenched state would be invariant under the deformation induced by $\ln 2 \cosh h$. To see that, compare the state of N + 1 particles with that of N. The trace over the \last" spin yields for expectation values of functions of the \ rst" N spins

4. A logarithm ic relation expressing the stability property

The stability condition which follows from the above discussed continuity assum ption is indeed found among the properties of the Parisi solution, along with the more sweeping stability under deformations of the more general form, as seen in eq. (2.14). This invariance property can also be cast in the form of a \logarithm ic relation", which expresses an additivity property for the marginal increments in the quenched free energy. D e nition 4.1 W e say that a random system, in the quenched state Av_N (N), has marginally-additive free energy if for any nite collection of independent G aussian elds K ⁽¹⁾; K ⁽²⁾; :::; K ⁽¹⁾ with the covariance eq. (2.7), and any smooth polynom ially bounded functions F_1 ; F_2 ; :::; F_1 , the following limits exist and satisfy

Our main observation is that the above marginal additivity of the quenched free energy is equivalent to the stability of the quenched state (in the in nite volume limit) expressed by v = v

where F is an arbitrary sm ooth bounded function.

Let us note that the expectation values of quantities involving any of the above, can be evaluated by st integrating over the extraneous G aussian variables (K). Using W ick's formula, this integration produces expressions involving the overlaps among arbitrary number of replicas, as in:

C onversely, the averages of polynom ials in replica overlaps, as $q_{1,2}^2 q_{2,3}^2$ in the above expression, can be easily expressed through the expectation values of suitable products of independent copies of the K eld.

C learly the stability in plies the marginal additivity property (of the free energy). To prove the converse, we need to show that (assuming the two limits exist)

for any integer n and polynom ial function G. (The full statem ent takes a bit more general form { involving products with di erent functions G for the di erent copies of the spin system, however by the polarization argum ent there is no loss of generality in taking the same function G for all the n replicas.) Let us note also that, by an elementary approximation argum ent, it su ces to prove eq. (4.4) for bounded functions G.

The logarithm ic property (4.1) in plies that for all "

For bounded G the function $'_N$ (") is analytical in a strip containing the real axis uniform ly in N, and the logarithm ic property eq. for every integer p. (The implication eq. (4.1)) eq. (4.10) is obvious. In the other direction the proof can be based on the analyticity argument indicated above.) It might be noted that an equation like eq. (4.10) cannot possibly hold without the average A v, unless the G ibbs state is typically supported on a narrow collection of con gurations over which the overlap function takes only the value q; 0 = 1.

Equations (4.1) and (4.10) have natural counterparts for the m ore limited stability of the quenched state, expressed by eq. (3.6). In that case $F_i(K^{(i)})$ need by replaced by $_iK^{(i)}$, for i = 2;3; ::: (thought F_1 m ay still be left arbitrary.)

It is an interesting open question whether there are states stable in the limited sense which do not full the stronger stability condition.

5.0 verlap polynom ials with zero average

We now turn to some of the in plications of the stability condition eq. (3.6) which was shown to follow from the continuity assumption. Since the free energy and its derivatives are determined through the distribution of the overlaps, it is natural to ask what consequences does the stability property have in those terms. As we shall see next, the implications include a family of relations expressed as the vanishing of the expectation value of an in nite collection of overlap polynom ials. From a combinatorial point of view, expressions with vanishing expectation are constructed by applying a certain operation to graphs representing overlap polynom ials.

We shall use the notation encountered already in eq. (4.3), where $q_{1,2}$ indicates the overlap between two spin congurations sampled from two dierent copies of the system, one in replica 1 and the other in the replica 2, subject to the same random interaction. Products of such terms can be represented by labeled graphs, introduced below. The expectation value does not depend on the particular labeling of the dierent replicas, for instance

If the quenched state is stable in the sense of eq. (3.5) the above expression tends to zero in the therm odynam ic lim it.

A swasm entioned already, the stability property is satisfied by the Parisi solution, and hence this relation, as well as those of higher order derived below, are satisfied there. The particular case of vanishing of eq. (5.5) was recently derived (for almost every beta) without any assumptions in ref. ([3]). One may also note that the vanishing of eq. (5.5) is also the lowest non-trivial identity of those listed in eq. (4.10) (corresponding to p = 4, F (K) K).

Let us present now a system atic approach for the derivation of other such relations.

O nem ay use a graphical representation in which a monom isl of the form $q_{1,2}^2 q_{2,3}$ is identified with a graph whose vertices are the replica indices f1;2;3g and the edges correspond to the overlaps, $q_{1;j}$. Such a graph willbe indicated by the symbol $(1;2)^2$ (2;3). Furtherm one, we shall consider also products involving an additional Gaussian eld (K). The graphical representation of that factor is a half-edge, represented by a singleton. I.e., (1;2) (2) and (1;2) (3) correspond to $q_{1;2}K_2$ and $q_{1;2}K_3$.

We shall use a product \ "which acts in the space of graphs as composition com bined with contraction, where possible, of the two unpaired legs. The notion may be clari ed by the following examples:

Term s of the form (1;1) can be om itted, since in our case $q_{1;1} = 1$.

The above product turns out to be commutative but not associative. The order of a graph is dened as 2 number of edges, with half-edges counting as 1=2. Let W_k denote the space of form al linear combination of graphs of order k. For G 2 W_k we denote by Q_G the corresponding element of the overlap algebra.

We de ne $:W_k ! W_{k+1}$ as the linear operator which acts on single graphs by

where V (G) is the set of vertices of G, and

where v is a new vertex not belonging to G. E.g., $_1(1;2) = (1;2)(1)$ (1;2)(3), $_1(1;2)(1) = (1;2)(1)$ (1) (1;2)(1) (3) = (1;2) (1;2)(1;3).

Following is the pertinent observation.

Proposition 5.1 For any measure of the type E (N) () = A V_N (N) and a deformation de ned in (3.6)

$$\frac{(Q^2)^2}{(Q^2)^2} E_{K}^{(N)} (Q_G) j_{=0} = E_{K}^{(N)} (Q_{2G}); \qquad (5.10)$$

for all the elements $Q_{\,G}\,$ of the overlap algebra and every N .

The proof of P roposition 5.1 is straightforward. The operation is the graphical counterpart of the usual derivative with respect to the parameter in the Boltzmann weight (where it appears in K). Such a derivative produces a truncated correlation expressed in the rule (5.9). The (5.8) is nothing but the Leibnitz rule for derivative of products. The rst di erentiation produces a sum of monomials, each containing an unpaired centered G aussian variable (K) of zero mean. The second derivative produces another unpaired variable, which is contracted with the previous one via the W ick rule. (This contraction motivates the product introduced above.)

P roposition 5.2 If in a certain temperature range the quenched averages $E^{(N;)}(Q)$ are uniformly continuous in , as N ! 1, and the in nite{volume limit exist for the quenched state, in the sense of eq. (2.5), then

$$E(Q_{2_G}) = 0$$
 (5.11)

for every element of the overlap algebra.

The uniform continuity in implies the stability for deformation eq. (3.6) which means, in particular, that the limit is a constant in . To prove the theorem we have to show that we can interchange the therm odynamical limit with the repeated di erentiation w.r.t. , in eq. (5.10). This is shown to be true in the appendix, through uniform (in N) bounds on the k-th derivatives of expectations of overlap m onom ials.

Follow ing is a related statem ent which yields a som ew hat stronger conclusion (suggesting a num erical test), which is derived under a stronger assumption.

Proposition 5.3 In the SK model, at nite values N,

$$\frac{\theta}{\theta} E^{(N)}(Q_G) = N \frac{\theta^2}{\theta^2} E^{(N)}_K(Q_G) j_{=0} = N E^{(N)}(Q_{2_G});$$
(5.12)

for every element of the overlap algebra and every N . In particular if in a certain range of the quantities $\frac{\theta}{\theta} E^{(N)} (Q_G)$ are uniformly bounded in N, and the therm odynamic limit exist in the sense of eq. (2.5), then for all the elements Q_G of the overlap algebra:

The proof of the rst equality can be obtained computing the second derivative with respect to of equation eq. (3.5) at = 0. The second equality is eq. (5.10).

A nalogous statem ents hold for other mean eld spin glass models, with the p-spin interaction H am iltonian ([7])

where J_{i_1} ; , are G aussian variables, rescaled so that the H am iltonian covariance is

(Under the above calling, H reaches values of order N. The corresponding choice for the eld K is Gaussian with the covariance $Av(K()K()) = q^p$. The denition of is unchanged.

6. C om putation with real replicas

In this section we give several characterizations of the overlap polynom ials of the form Q $_{2_{\rm G}}$ for which we prove that under certain conditions they have zero mean.

The main result is a formula which permits to compute the polynomials from a quadratic expression in the number r of real-replicas, evaluated at r = 0. To state it, let $M_r = \prod_{i \in j=1}^{r} q_{i,j}^2$, for all integers r 1. Let E () be an expectation value functional, on the algebra of overlaps, which depends only on the graph structure of the overlap m onom ials (i.e., is independent of the choice of labels). Then the quantity E ($Q_G M_r$) is quadratic in r. In the following proposition, we refer to the polynomial extension of this function to all real r.

Proposition 6.1 For any expectation value functionalE (), as above,

$$E (Q_{2_G}) = E (Q_G M_r) j_{=0}$$
: (6.1)

where the quantity E ($Q_G M_r$) is rst computed for r large enough so that all the indices appearing in Q_G do appear also in M_r and $r > \frac{1}{3}G + 1$.

To illustrate the statement, let us take: $G = q_{1,2}^2$. In this case, the left side of eq. (6.1) is given by eq. (5.5) and the right side is:

 $E (q_{1,2}^2 M_r) = 2E (q_{1,2}^4) + 4 (r 2)E (q_{1,2}^2 q_{2,3}^2) + (r 2) (r 3)E (q_{2,2}^2 q_{3,4}^2) : (6.2)$

The two coincide at r = 0 (de ned by polynom ial extension).

The proof proceeds through the explicit com putation of the left and right sides of eq. (6.1).

Lem m a 6.2 If the number of vertices in G is 1 then

$${}^{2}G = \int_{v \in v^{0}}^{X} G \quad (v;v) + 1(1+1)G \quad (0,v) = v \quad (6.3)$$

where v and v^0 are summed over the set of vertices of G and v and v^0 denote a pair of added vertices.

This is a rather explicit expression for the polynom ials corresponding to a given graph G.Two examples are:

R em ark In the above example $^2 \rm G$ is a polynom ial expression with integer coe cients whose sum is zero. That property is shared by $^2 \rm G$ of arbitrary monom ials G .

To prove the lem m a we note that by the de nition of

$$G = \bigvee_{v}^{X} G \quad (v) \quad IG \quad (\forall) : \qquad (6.6)$$

Applying this rule twice

which coincides with eq. (6.3) since (v;v) = 1 for every v.

Lem m a 6.3 If all the replica indices appearing in $Q_{\,G}\,$ are contained in the entries of the matrix M $_r$ and r > l+ 1 then

This form ula is an elementary consequence of the fact that the measure E () depends only on the isom orphism type of the graph associated to a given overlap m onom ial. The rst sum on the right side of eq. (6.8) corresponds to those overlap terms in M $_{\rm r}$ which involve only the replicas appearing in G, the other two sums are split according to whether the number of vertices not in G is 1 or 2.

The two previous lem m as prove Proposition 6.1.

7.Comments

We have seen that elementary continuity assumptions on the quenched state, in ply a stability property for the in nite volume limit of the SK (and other mean-eld) spinglass models. A particular implication is the vanishing of the expectation values of certain multi-overlap polynomials, which form an in nite dimensional family. We also saw a related condition expressed through an explicit decay rate for the expectation values of suitable quantities.

These observations are consistent with the Parisi theory. However, the family of identities discussed here does not yet perm it the reconstruction of the joint probability distribution from that of a single overlap, as is the case under the Parisi Ansatz.

It has been pointed out that within the replica-symmetry-breaking approach the vanishing of the expectation values of the polynom ials discussed here (${}^{2}G$) requires only the so called \replica{equivalence" assumption, which says that in the matrix Q (de ned in [2]) each row is a permutation of any other. We thank I.K ondor and M.M ezard for calling our attention to this point. See [9] for a recent account on replica-equivalence.

An interesting question is whether the stability property is the stationarity condition for som e variational principle. This is related to the main question which emerges at this point, which is whether stability im plies the GREM state structure [4]. We study a restricted version of this question in a separate paper [5].

A.Appendix

In this appendix we show that the $\lim it N ! 1$ can be interchanged with the di erentiation, in formula (5.10). This is seen in two steps. The rst is a general criterion.

Theorem 1.1 Let F_n () be a sequence of functions de ned over the interval 2 [1;1], which:

a) converge pointwise:

We om it the proof of this basic criterion. (For m = 1 it can be proven by using uniform approximations for $\frac{d}{d}F_n$ () in terms of the dimensions $\mathbb{F}_n(+) = \mathbb{F}_n()$, and the rest is by induction.)

The stability stated in Proposition 3.1 am ounts to an (a) type condition for F_n () = $E_K^{(N)}(Q)$ where Q is any overlap monomial. The limit is a constant function. The above principle will allow us to conclude that under the assumption of Proposition (3.1) $E(Q_{2_G}) = 0$, as soon as we show that the derivatives are uniform by bounded (i.e., establish condition (b)). Following is a detailed version of that statement.

P roposition 1.2 Let Q be an overlap monom ial which involves r replicas. Then, for any $N\ <\ 1$,

Proof: The expectation value of Q are expressed as $E_{K}^{(N)}(Q) = Av_{N} Q_{N;K}$ with a nite product $K = \frac{1}{1;1;1;1} < S_{K}^{(i)}$. Using standard formula for the derivative, standard bounds on the truncated correlations (see for instance Theorem II.12.6 in [8]), and the fact that $j_{2}j_{1}$

Since K can be arbitrarily large, we face here a m inor version of the \large eld problem ". However, it can be resolved by the following estimate,

For the set factor, an elementary calculation gives the bound $e^{(1+)^2}$. For the second factor we get

where we used rst the Jensen inequality and then the fact that $\langle K \rangle$ is a gaussian variable of covariance 1.
