Transverse force on a quantized vortex in a superconductor

The total transverse force acting on a quantized vortex in a type-II superconductor determ ines the H all response in the mixed state, yet a consensus as to its correct form is still lacking. In this paper we present an essentially exact expression for this force, valid in the superclean limit, which was obtained by generalizing the recent work by Thouless, Ao, and N in p.J. Thouless, P.Ao, and Q.N in, Phys. Rev. Lett. 76, 3758 (1996)] on the M agnus force in a neutral super uid. We nd the transverse force per unit length to be f = K + V, where $e_n + e_s$ is the sum of the mass densities of the norm al and superconducting components, K is a vector parallel to the line vortex with a magnitude equal to the quantized circulation, and V is the vortex velocity.

The discovery of high-temperature superconductivity has stimulated a renewed interest in the statistical mechanics and dynamics of vortices in type-II superconductors [1]. Despite the trem endous progressm ade, how ever, the answer to one of the simplest questions, namely, the form of the equation of motion for a single isolated vortex, remains controversial. If we let R (t) denote the position in the xy plane of the center of a straight vortex line as a function of time, then the classical equation of motion can be written as

Here we have taken the circulation vector K of the vortex (a vector parallel to the vortex with a magnitude equal to the circulation [2]) to be along the z direction. The rst two terms on the right-hand-side of (1) are to include all forces linear in the vortex velocity. Here fp represents the pinning force due to disorder (averaged over an area set by the size of the vortex core), and $f_{\rm d}\,$ includes the various \driving" forces possible, such as the Lorentz force, which may depend on the density of the norm aland superconducting components n_s and n_n , and therefore on the vortex position R, but do not depend on the vortex velocity. The equation of motion (1) also describes a vortex in a Bose or Ferm i super uid, where f_p m ight describe the force from an externally imposed wire as in a V inen-like experiment [3], and f_d would include the super uid-velocity-dependent part of the M agnus force [4] and possibly other vortex-velocity-independent contributions [5].

The di culty concerns the determ ination of the coe cients M , , and , which describe the vortex effective m ass per unit length, viscous dam ping force per unit length, and nondissipative transverse force per unit length, respectively. O fparticular interest and especially controversialisthe coe cient , which in a neutral superuid has been recently shown by Thouless, A o, and N iu [6] (hereafter referred to as TAN) to be = _sK , where s is the mass density of the super uid component far from the vortex core, and K is the quantized circulation. For a vortex in a neutral Bose super uid with q quanta of circulation, this coe cient is simply = qhn_s, with n_s the super uid number density away from the core, whereas in a (paired) Ferm i super uid = $\frac{1}{2}$ qhn_s. The TAN result shows that the transverse force is universal, independent of the detailed m icroscopic structure of the vortex and its interaction with the norm al component of the uid. The universality of the nondissipative transverse force is not found in som e approxim at m icroscopic calculations, how ever, which obtain coe cients that reduce to the TAN result only in certain lim its [7{9].

In this paper we calculate the nondissipative transverse force on a quantized vortex in a charged super uid or superconductor by following the method of TAN [6]. Initially, we shall consider a system with translational invariance, and to address a more realistic model of a superconductor we include afterwards a periodic potential from the lattice, assuming the lattice constant b is small compared with the coherence length . In both cases we nd the transverse force per length to be given by

$$f = K \quad V ; \qquad (2)$$

where = $_{n} + _{s}$ is the total mass density of the uid away from the core, K is the quantized circulation vector de ned above, and V is the constant vortex velocity. M ost relevant is the fact that, as in TAN, our results for this superclean limit of a superconductor also indicate a universal vortex-velocity-dependent part of the transverse force. In the notation of Eqn. (1), we nd = K. For a vortex with q trapped ux quanta $_{0}$ hc=2e we can write this as $= \frac{1}{2}$ qhn, where n is the total density of the uid far from the core. The reason that the transverse force in the charged case di ers from that for the neutral super uid, which has a coe cient $_{s}$ instead of , is related to the M eissner e ect, as will be explained

, is related to the M eissner e ect, as will be explained below .

The Ham iltonian for the charged super uid or superconductor is taken to be

is the Ham iltonian for N bosons or ferm ions with negative charge e, interacting with each other and with a uniform positive background charge, and (in G aussian units)

with T^{ij}(r) (^{ij}jcj¹ + rⁱr^jjcj³)=2c; is the currentcurrent interaction, which, as rst noted by D arw in [10], correctly accounts for the electrodynam ics in the transverse gauge through order v²=c². The U in (4) is a C oulom b interaction term, and in the case of a superconductor also contains an additional short-ranged attractive interaction to produce superconductivity. A lso, H_b n^d d³r e²n jc_n rj¹ accounts for the interaction with the uniform positive background charge en. The full H am iltonian also contains a cylindrically sym m etric pinning potential V centered at position R [11].

Before proceeding it is important to note that the Hamiltonian (3), with the current-current interaction term, provides an accurate model of a charged superuid or superconductor. In particular, we show in the appendix that it exhibits a M eissner e ect with the conventional London screening length.

We shall follow TAN and calculate the force on the vortex by expanding the time-dependent wave function, given by $ih(t_i) = H R(t) j(t)i$; in a basis of instantaneous eigenstates satisfying H (R) (R) = (R) : We shall assume a three-dimensional E (R) system with the z direction along K. The system is assumed to be in nite in the x and y directions, and L is the thickness in the z direction, which is also the length of the vortex. In the absence of the pinning potential the system is therefore translationally invariant in the x and y directions. The translational invariance allows the instantaneous eigenfunctions to be taken as R (r₁; _N ;)r= (r₁ R; N;rR);where $_{\rm N}$) rare the eigenfunctions with the pinning (r₁; potential centered at the origin. Initially, at a time t_0 , a vortex is assumed to be bound to the pinning potential at R $(t_0) = R_0$ in a state characterized by the density $f j (R_0)ih (R_0)j$; where f is the occum atrix pation probability of state . The force on the vortex is F = f h (t) r_RHj (t) i; where j (t) i is the solution of the time-dependent Schrodinger equation starting out in j (R (t_0)) i. Following Ref. [6] we obtain a transverse force equal to

where $(r; r^0)$ is the one-particle density matrix and L is the thickness of the system in the z direction. In (6) we choose the radius a of the integration contour to be much larger than the London penetration depth .

The integrand in (6) is proportional to the canonicalmom entum density. The current-current interaction term (5) has played no role up to this point, and, indeed, the expression (6) in the two-dimensional limit is identical to that obtained by TAN for the neutral super uid. How ever, the resulting force is di erent, as can be seen by writing (6) in terms of the canonicalmom entum density, which leads to a transverse force per unit length equal to

The TAN result for neutral super uids is obtained by writing the momentum density as $j = {}_n v_n + {}_s v_s$ and assuming that the viscous normal component does not circulate [12]. In the case of a charged super uid or superconductor, however, the gauge-invariant momentum density $j + \frac{e}{c}nA$ vanishes in the region containing the integration contour because of the M eissner e ect (see Appendix), and we therefore obtain (2).

O ur conclusion suggests that both the norm aland superconducting components of the uid contribute to the total transverse force. However, we would like to emphasize that the model considered here does not include disorder, and, as such, leads to a norm alcomponent having an in nite conductivity. This neglect of disorder may be responsible for the dependence of the transverse force instead of the usual s.

Finally, we would like to remark that the result (2) holds even in the presence of a lattice, as long as the coherence length or vortex core size is large compared with the lattice constant. To demonstrate this we add a periodic potential term $_{n} v(r_{n})$ to H $_{0}$ and expand the instantaneous eigenstates in a basis of localized W annier functions a (r l) for the relevant band,

Here 1 labels the sites of the lattice, and the coe – cients $^{\rm R}$ (l₁; $_{\rm N}$) lare taken to be completely sym – metric or antisymmetric. Assuming that we are at the minimum of a band with an isotropic elective mass m , we see that the envelope function $^{\rm R}$ (r₁; $_{\rm N}$) resatises a Schrodinger equation with a Ham iltonian given by (3) apart from the replacement of min H $_0$ with m (the mass in H $_1$ is not changed). This is the standard elective mass approximation, and it leads to

is a one-particle density matrix constructed from the envelope functions.

Unfortunately, the integrand in (9) is not proportional to the actual canonical momentum density j(r), the latter having uctuations on the scale of the lattice constant b. However, it is possible to prove that when any local single-particle operator like the current density is averaged over a length scale larger than the localization length of the W annier functions (assumed to be of the order of b), but sm aller than the characteristic length scale over which the envelope functions vary, the expectation value is correctly given by e (r; r^0) [13]. In other

words, the structure on the scale of the lattice constant is not described correctly by the envelope functions, but coarse-grained quantities are. Now, because the line integral of the actual canonicalm om entum is quantized, it is possible to write it as

where both radii a_1 and a_2 are much larger than and their di erence is larger than b. The integrals over a and z on the right-hand-side of (11) have the e ect of averaging the azim uthal component of j. Therefore, the actual circulation is correctly given by the line integral of the coarse-grained m om entum, which, in turn, is correctly given by the envelope functions. Hence, (9) leads to the transverse force (2), as stated.

The total transverse force per unit length on the vortex m ay be obtained by adding the conventionalLorentz force term $f_L = \frac{e}{c} n v_e$; leading to

A lternatively, we can write this as

where v_p is the velocity of the positively charged substrate, usually taken to be at rest. The rst term in (13) is the Lorentz force, given by the interaction of the Galilean-invariant current with the magnetic eld, while the second term is a Magnus force that acts on the substrate. This interpretation is in agreement with the early picture of ux line motion in type-II superconductors given by Nozieres and V inen in the late sixties [14]: The Magnus force on the vortex may be thought as the Kutta-Joukow ski hydrodynam ic lift force due to the circulation of the electron uid around the vortex. Far from the vortex the circulation is reduced but an increase in the Lorentz force exactly compensates this de ciency. The Magnus force reaction is eventually carried away by the positive substrate.

APPENDIX A: MEISSNER EFFECT IN THE RPA APPROXIMATION

A s m entioned above, it is important to establish that the D arw in H am iltonian provides an accurate m odel of a charged super uid or superconductor; in particular, that it exhibits a M eissner e ect with the conventional London penetration depth.

This can be demonstrated by treating the currentcurrent interactions in an RPA-type approximation and calculating the current induced by a weak applied vector potential,




FIG.1. RPA approximation for the correlation function ij (i!, ;q). Here the solid lines denote the exact G reen's functions for H₀ and the zig-zag lines represent the current-current interaction T^{ij} (g).

The zero-frequency linear response function ij is the sum of a retarded current-current correlation function $^{ij}_{R}$ for a system described by the H am iltonian H $_0$ + H $_1$,

and a diam agnetic term . Our RPA approximation corresponds to a sum mation of the diagram s shown in Fig. 1 for the imaginary-time current-current correlation function ^{ij} (i!_n;q), which are the most divergent term s as q ! 0. In this approximation we nd

where $_{0}^{ij}$ is the corresponding response function for the system without current-current interactions, as described by H₀, and T^{ij}(q) = 4 ($^{ij}jqj^2$ qⁱq^jjqj⁴)=c is the Fourier transform of T^{ij}(r).

The response function ^{ij} can be used to relate the total vector potential A_{tot} $A_{ext} + A_{ind}$, the sum of an external and induced part, to A_{ext} itself,

Because ! = 0 here, (A 3) tells us about m agnetic screening. Now, $_{0}^{ij}$ is known to have some general properties in the q ! 0 lim it, re ecting the presence of o -diagonal long-range order. In particular,

in this lim it [15], resulting in

where $(m c^2=4 n_s e^2)^{\frac{1}{2}}$ is the usual London penetration depth. Thus, the current-current interaction term leads to a conventional M eissner e ect.
