H ubbard m odel on d-dim ensional hypercubes: Exact solution for the two-electron case

The H ubbard model is exactly solved for two particles $w$ ith opposite spins on d-dim ensional hypercubes. It is show $n$ that the spectrum can be separated into tw o parts: a trivial (U -independent) part resulting from sym $m$ etries of hypercubes and a non-trivial part expressed as a single-im purity problem on a set of nite chains of size $d^{0}+1\left(d^{0} \quad d\right)$. The exact expression for the one-particle G reen's function is given. Finally, we discuss the extension of these results to standard hypercubic lattices w th periodic boundary conditions.

O ne of the most widely used models to describe strongly correlated ferm ions system $s$ is the Hubbard m odel and its various extensions. Unfortunately, only lim ited exact inform ation about its physicalproperties is available. For the one-dim ensional lattice the celebrated solution of Lieb and W u [1] provides the exact eigenspectrum of the $m$ odel. In the opposite lim it of large dim ensions investigated very recently [2], som e alm ost exact results have also been obtained. H ow ever, for interm ediate dim ensions, and particularly for the very im portant tw o-dim ensional case believed to be relevant to high- $\mathrm{T}_{\mathrm{c}}$ superconductivity, very little is at our disposal. M ost of the results reported so far have been obtained either from num erical solutions on very sm all clusters (sub ject to im portant nite-size e ects) or by using a variety of approxim ate analyticalm ethods (w ith dom ains of validity and/or system atic errors di cult to evaluate) [里.

In this paper we present an exact solution for the $H$ ubbard modelw th rst-neighbor hopping term $t$ and onsite interaction energy $U$

for two particles with opposite spins on a d-dim ensional hypercube $d$. The hypercube $d$ is de ned as the set of $\mathrm{N}=2^{\mathrm{d}}$ sites whose d coordinates are either 0 or 1 . A though our solution is yet lim ited to the tw o-electron case, to exhibit exact results for a truly interacting system in dim ension greater than one is clearly of prim ary interest. T his is particularly true since hypercubes are related to usual cubic lattioes $w$ ith periodic boundary conditions: 2d is topologically equivalent to a d-dim ensional hypercubic lattice of linear size equal to 4 w th periodic boundary conditions, noted $\mathrm{Z}_{4}^{\mathrm{d}}$ (i.e., 2 is equivalent to the 4 -sites ring, 4 equivalent to the 2-dim ensional 44 clusterw ith periodic conditions [4, 5 ], etc..), while $2 d+1$ is equivalent to tw o translated linked copies of $Z_{4}^{d}$. To solve the above H am iltonian we rst use an abelian subgroup
of the full d point group, to block-diagonalize the initial $m$ atrix of size $2^{2 d}$ into $2^{d}$ blocks of size $2^{d}$. $Q$ uite interestingly, these sm aller subm atriges correspond to a sim ple fam ily of e ective one-electron H am iltonians de ned on $d^{0}\left(d^{0} \quad d\right)$, som e ofw hich having a single-im purity site. In a second step, we show how to fiurther reduce these $m$ atrices into $s m$ aller blocks of size $d^{0}+1$ (instead of $2^{d}$ ), corresponding to nite chains of size $d^{0}+1 \mathrm{w}$ th one im purity site at one end and new speci chopping term $s$. U sing a standard approach for im purity problem swe provide a closed expression sum rule for the eigenspectrum. W e also derive the exact expression for the one-particle G reen's function. Finally, the extension of these results to hypercubic lattioes $w$ ith periodic boundary conditions is brie y discussed.

Let us de ne $d$, an abelian subgroup of the full $d$ point group, generated by the $d$ re ections into perpendicular ( $d$ 1) dim ensional planes $m$ eeting at the $d$ centre,

where $E$ is the identity operator. It is easy to show that d has $2^{\mathrm{d}}$ elem ents (ow ing to the com m utativity betw een the $m$ irror operations), and that the onbit of a generic point under $d$ is a hypercube $d$. Let us num ber the d elem ents $L$ by integers betw een 0 and $2^{\text {d }} 1$, in the follow ing way: L being a product of $m$ irrors i, let $L$ be the num ber, w ritten in base-two, whose corresponding $i^{\text {th }}$ digits are equal to one $(1$ is $L=1,123$ is $\mathrm{L}=7$, etc...). Let us also locate the sites according to their num bering in base-tw $O$ : $T$ he $i^{\text {th }}$ coordinate is equal to the $i^{\text {th }}$ digit. Now, the action of the sym $m$ etry operation $L$, onto a site $s$, noted as the \special product" L $s$, can be explicited: each tim e a digit equals 1 in L, it sw itches the corresponding digit in s. For exam ple, in 3 dim ensions, $7 \quad 1=6$, w ith corresponds in coordinates to $123(0 ; 0 ; 1)=(1 ; 1 ; 0)$. To construct the irreducible representations (irreps) and the character table of $d$, it is useful to rem ark that this group is isom orphic to $d$ tim es the tensorial product $w$ ith itself of the
two－elem ent group $Z_{2}=\mathrm{fE} ; 1 \mathrm{~g}=1$［⿴囗⿱一一 $]$ ．This is noth－ ing else than the group theory countenpart of the natural construction of $d$ as two displaced copies of $d_{1}$ ．The d irreps are easily obtained as tensor products of the two irreps 0 and 1 of $Z_{2}$ ．As an illustration，the char－ acter table fo $2=Z_{2} \quad Z_{2}$ is shown in $T$ able $\ddagger$ ．All the irreps are uni－dim ensional（ d is abelian），and the character table is identical to standard H adam ard m atri－ ces［7］，which are orthogonalm atrices w ith elem ents 1 （note also that lines and colum ns of $H$ adam ard $m$ atrices represent the non－interacting one－electron onbitals of the problem ）．N ote that the $\mathrm{N}\left(=2^{\mathrm{d}}\right)$ irreps can also be labelled by integers $M$ ，through their base－tw o decom po－ sition，by ordering the di erent occurences of $Z_{2}$ in the tensorial product，and xing the corresponding digit to 0 or 1 ，whether the irreps 0 and 1 occur．

Let us consider rst the one－electron tight－binding spectrum w ith hopping term $t$ ．Each eigenstate belongs to a given irrep of $d$ ，and reads

where $m_{m}$ ；r is the number of digits equal to 1 sim ul－ taneously in $M$ and $r$（we have used the above de ned special product to denote the action of the sym $m e-$ try operation $R$ onto the basis kets）．Since all the sites are equivalent，it is su cient to consider the interaction of the site number 0 w ith its d rst neighbors which have exactly one digit equal to 1 and belong to the set $\mathrm{V}_{\mathrm{d}}=\mathrm{fv}_{\mathrm{j}}=2^{j} ; j=0::: \mathrm{d} 1 \mathrm{~g}$ ．As a result，one nds that the eigenenergies read

where $\mathrm{N}_{\mathrm{M}}$ is the num ber ofdigits equal to 1 in M ．Since M runs from 0 to $2^{\mathrm{d}} 1$ ，the a spectrum consists of $d+1$ levels，from $d t$ to $d t$ ，w ith equal spacing $2 t$ ．T he degeneracy of a $E_{M}$ level is the standard binom ial coef－ cient counting the num ber of sets of $\mathrm{N}_{\mathrm{M}}$ digits am ong d．A s d tends to in nity，one recovers a gaussian－shaped spectrum，as for the in nite－dim ensional cubic lattice．

Let us now consider the two－electron case（electrons $w$ th opposite spins）．The full H am iltonian m atrix，of size $2^{2 \mathrm{~d}}$ ，is readily block－diagonalized into $2^{\mathrm{d}}$ blocks of size $2^{\text {d }}$ ，associated w ith each representation M ．For a given $M$ ，one constructs a basis $w$ ith $2^{d}$ kets $M$ ； $1>$

It is clear that U only occurs in $\langle\mathrm{M} ; 0 \mathrm{NV}$（U） M ； 0$\rangle$ ， while the kinetic part reads

In the latter expression, we have decoupled the term $s$ where the \# spin jumps ( rst part) from those where the " spin jumps. In the latter part (sum over $j$ ) the only nonvanishing term corresponds to $r \quad l=v_{j} \quad r \quad{ }^{0} l$ ! $l^{0}=V_{j} \quad 1$, which $m$ eans land Ineighbors (recall that the group is abelian and its elem ents are their ow $n$ inverse). O ne nally gets that the nonvanishing kinetic term s read

The block $m$ atrix associated to the irrep $M$ corresponds therefore to an e ective one-electron tightbinding H am iltonian, w th sites labelled by $l$, kets $\mathbb{M}$; l> and hopping term s given by the above expression 7). A sim ple case is provided by the identity irrep $M=0$, for which ${ }_{r}^{M}=1$ for any $r$. The e ective $H$ am iltonian $H{ }^{(0)}$ corresponds to a hypercube $d$, w ith one \im purity" site ( $w$ ith diagonalterm $U$ ) and a constant hopping term $2 t$. W enow show that the other irreps correspond to e ective H am iltonian $H^{(M)}$ on hypercubes $d^{0}$ w ith $d^{0}<d$. O ne has to evaluate the right-hand part of equation (7). By de nition of the $v_{j}$ ( $m$ irrorswhich connect a site to one of its rst neighbors), $r$ and $v_{j} r d i$ er by one digit, which depends on $j$, not on $r$. If this digit takes the value 1 in the base-two decom position of $M$, then ${\underset{r}{M}}_{M}^{M}{\underset{V}{j}}^{M}=1$ for any $r$, and the corresponding $H^{(M)} m$ atrix elem ent vanishes. $H^{(M)}$ therefore corresponds to $a d$ in which fam ilies of paralleledges have been cut (those orthogonal to the $m$ irrors labelled by the digits 1 in the decom position of M ). Figure 1 displays graphically this general result for $d=2$ and $d=3$.


Fig. 1. G raphical illustration of the e ective H am iltonian $H^{(M)}$ associated w ith the irrep M. Full circles correspond to im purity sites $w$ ith a diagonal term $U$, full edges to hopping term $s$ equal to $2 t$, and dotted lines to the edges which are cut in the given irrep.
a) $d=2$, the four irreps, corresp onding to one square $w$ ith one im purity, tw o tim es tw o segm ents, one containing an im purity site, and nally four isolated sites (one being an im purity w ith a diagonal term U).
b) the case $d=3$. Four irreps am ong the eight are shown.

So, at this step, the spectrum is solved in tem s of one-electron tight-binding $m$ odels on hypercubes of di$m$ ension lower or equal to $d$. The only non-trivial part corresponds to those part, in the hypercube decom position, which contain the im purity site 8]. W e now show how to further greatly reduce their com plexity.

To do that it is convenient to re-express the e ective H am iltonian H (hereafterw w illdrop the superscript ( 0 ) since only the $M=0$ case has nally to be considered) in the one-electron basis, Eq. 3). It is easy to verify that $H$ can be written in the form

where $D \operatorname{iag}()$ is a diagonalm atrix whose entries are the $2^{d}$ free electron-solutions of the hypercube $w$ th hopping $2 t$ (solution at $U=0$ ) and $I_{N}$ is the $N \quad N$ matrix with unit entries for all $i$ and $j$. T he latter part is nothing but a projection operator on the eigenstate j $\mathrm{v}_{0}>\mathrm{w}$ th energy $U$ and $H$ can be rew ritten

To proceed further we de ne for each subspace corresponding to a given value ${ }_{i}(d+1$ subspaces of degeneracy $g_{i}$, the binom ial coe cient) a basis consisting of the norm alized vectors $v_{1}^{(i)}=\frac{1}{\overline{g_{i}}}(1 ;::: ; 1)$ and a set of vectors $\mathrm{fv}_{\mathrm{k}}{ }^{(\mathrm{i})} ; \mathrm{k} \in 1 \mathrm{~g}$ spanning the subspace orthogonalto $\mathrm{v}_{1}^{(\mathrm{i})}$. In this new basis only the $(\mathrm{d}+1)$ vectors $\mathrm{v}_{1}$ have a non-zero overlap $w$ th $\dot{J}_{0}>$, and $H$, ofdim ension $2^{\text {d }}$, decom poses into a diagonalm atrix having $2^{d} \quad(d+1)$ trivial solutions i, and a residual U-dependent part, noted H, given by the $m$ atrix of linear size $(d+1) \mathrm{w}$ ritten in the form

where $j v$ has com ponents $v_{i}=\mathrm{p} \overline{\mathrm{g}_{\mathrm{i}}=\mathrm{N}}$ and the 's represent now the ( $\mathrm{d}+1$ ) distinct free-electron energies:

An altemative representation consists in going back to the basis where the potential operator $V$ is diagonal. $H$ is then found to be tridiagonal (one-dim ensional tightbinding $m$ odel) $w$ ith $\circ$-diagonalhopping term given by $t_{i ; i+1}=2 t \overline{(d \quad i)(i+1)} ; \quad i=0$ to $d \quad 1$ and a diagonalU -contribution at the initial site (here num bered $0)$. In other words, the problem is $m$ apped onto a singleim purity problem on a nite chain of linear size ( $d+1$ ). $F$ igure 2 illustrates this result ford 3.

It is known that eigenspectrum of single-im purity problem s can be expressed under the form of a sum rule expression using the K oster-Slater approach (G]. This result can be brie y re-obtained as follow s. First, the follow ing operator identity 10] is invoked

where $z$ is an arbitrary com plex number and $G_{v v}^{(0)}$ the unperturbed $G$ reen's function given by $G_{v v}^{(0)}(z)=<$ $\mathrm{vj}\left(\begin{array}{ll}\mathrm{H}_{0} & \mathrm{z}\end{array}{ }^{1} \mathrm{j} \gg\right.$. Then, using this identity the fully interacting $G$ reen's function, $G$ vv $(z)$, can be w ritten as

Eq. 14) is the nal closed expression determ ining the non-trivial part of the spectrum. It is easily show $n$ that this equation adm its $(\mathrm{d}+1)$ distinct solutions we shall denote as $S$ pect $^{(d)}(\mathrm{U})$.

To sum $m$ arize, the set of $2^{2 d}$ eigenvalues of the hypercube $d$ consists of a $U$-dependent part given by the collection of the non-trivial spectra at dim ensions low er or equal to $d$ :

(note that here the binom ial coe cient counts the num ber of occurences of ${ }_{i}$ hypercubes $w$ ith an im purity site in the decom position of the initial $d$, see Fig (1) and a trivial U -independent part given by :

w ith degeneracy:
the prime in ${ }^{P}{ }^{0}$ indicating that the sum $m$ ation over $i$ is done with an increm ent of two. Form ula (17) can be obtained by tracing back the contributions due to the different irreps and those issued from the intemalsym $m$ etry of hypercubes (trivial solutions extracted when passing
from Eq.(9)) to Eq. (10)). The ground-state energy is not degenerate and corresponds to the low est solution in Spect ${ }^{(d)}$ ( $U$ ). N ote also that in the lim it of large dim ensions, and after proper renom alization of the param eters of the H am iltonian, an in nite-dim ensional $m$ odel can be de ned, as done recently for a num ber of correlated ferm ions m odels, see [0].

Let us now consider dynam ical properties. W e are interested in evaluating the one-particle $G$ reen's function de ned by

where j $0>$ denotes the one-particle ground-state consisting of one electron of given spin and $a_{k}^{+}$creates one electron of opposite spin in a one-particle state, noted $k$. $H$ ereafter, $k$ varies from 0 to $d$ and labels one of the ( $d+1$ ) degenerate subspaces of the one-electron problem, the ground-state corresponding to $k=0$. Now , rem ark that vector $a_{k}^{+} j_{0}>$ belongs to the subspace corresponding to the decom position on hypercubes of dim ension ( $d \quad k$ ). $T$ here exist $2^{k}$ di erent fam ilies of hypercubes having such a dim ension (See, g. fi) am ong which only one has the U-im purity site. A ccordingly, we get the follow ing result

Now, we need to evaluate the fundam ental quantity $G_{0}^{\left(d^{0}\right)}(z ; U) w$ th $H$ am iltonian 10$)$, the dim ension $d^{0}$ ranging from 0 to $d$. For that we note that the ket $j 0>$ $a_{0}^{+} j_{0}>$ represents the ( rst) basis elem ent corresponding to the diagonalenergy 0 in representation (10). P rojecting out identity (12) onto vector $j 0>$ and expressing the di erent quantities in term $s$ of the non-interacting spectrum we get:

This equation together w ith Eqs. (11) and 19) give the exact one-particle $G$ reen's function of the problem.

Generalization of this approach to higher llings is presently under investigation. W e have already found that the existence of large fractions of $U$-independent eigenvalues is still valid for som e speci c llings. H ow ever, the underlying structure for the $U$-dependent part of the spectrum is $m$ ore di cult to elucidate.

B ack to the tw o-electron case, we would like to $m$ ention that, by using rotations instead of re ections, a sim ilar calculation can be done for standard d-dim ensional hypercubic lattices of linear size $L$ and periodic boundary conditions $\left(\mathrm{Z}_{\mathrm{L}}^{\mathrm{d}}\right)$. W e have found that the problem
can still be $m$ apped onto a fam ily of $L^{d}$ single-im purity one-electron e ective problem s de ned on the very sam e lattioe, $\mathrm{Z}_{\mathrm{L}}^{\mathrm{d}}$. Each irrep corresponds to a value of a d dim ensionalinteger vector $\left.M^{\top} \quad M_{i}=0::: L \quad 1\right)$, orm ore physically, to a value for the totalm om entum $K=\frac{2}{L} M^{T}$. The only di erence betw een irreps lies in the value of the hopping term which depends explicitly on Mr . M ore precisely, for each irrep labelled by K, Eq. 14) now reads

w ith $\mathrm{K}=\frac{2}{\mathrm{~L}} \mathrm{M}$ and $\mathbb{K}=\frac{2}{\mathrm{~L}} \mathrm{M}$. In contrast w ith hypercubes, the sum in Eq. 21) runs over $L^{d}$ values and cannot be further reduced. N ote that, since the e ective hopping term varies w th the irrep (and can even vanish), both localized and resonant states (irreps by irreps) $m$ ay be present. Finally, it is worth noticing that in the $d=1$ case the $B$ ethe ansatz equations for tw o particles [1]]:
