## Hubbard model on d-dimensional hypercubes: Exact solution for the two-electron case

The Hubbard model is exactly solved for two particles with opposite spins on d-dimensional hypercubes. It is shown that the spectrum can be separated into two parts: a trivial (U-independent) part resulting from symmetries of hypercubes and a non-trivial part expressed as a single-impurity problem on a set of nite chains of size  $d^0 + 1$  ( $d^0 - d$ ). The exact expression for the one-particle G reen's function is given. Finally, we discuss the extension of these results to standard hypercubic lattices with periodic boundary conditions.

One of the most widely used models to describe strongly correlated ferm ions systems is the Hubbard model and its various extensions. Unfortunately, only lim ited exact inform ation about its physical properties is available. For the one-dimensional lattice the celebrated solution of Lieb and W u [1] provides the exact eigenspectrum of the model. In the opposite lim it of large dim ensions investigated very recently [2], som e alm ost exact results have also been obtained. How ever, for interm ediate dimensions, and particularly for the very important two-dimensional case believed to be relevant to high-T<sub>c</sub> superconductivity, very little is at our disposal. Most of the results reported so far have been obtained either from num erical solutions on very sm all clusters (sub ject to important nite-size e ects) or by using a variety of approxim ate analytical methods (with domains of validity and/or system atic errors di cult to evaluate) [3].

In this paper we present an exact solution for the H ubbard m odel with rst-neighbor hopping term t and onsite interaction energy U

for two particles with opposite spins on a d-dimensional hypercube d. The hypercube d is defined as the set of N = 2<sup>d</sup> sites whose d coordinates are either 0 or 1. A linear solution is yet limited to the two-electron case, to exhibit exact results for a truly interacting system in dimension greater than one is clearly of primary interest. This is particularly true since hypercubes are related to usual cubic lattices with periodic boundary conditions: 2d is topologically equivalent to a d-dimensional hypercubic lattice of linear size equal to 4 with periodic boundary conditions, noted  $Z_4^d$  (i.e., 2 is equivalent to the 4-sites ring, 4 equivalent to the 2-dimensional 4 4 clusters ith periodic conditions [4,5], etc..), while  $_{2d+1}$  is equivalent to two translated linked copies of  $Z_4^d$ . To solve the above H am iltonian we rst use an abelian subgroup

of the full d point group, to block-diagonalize the initial matrix of size  $2^{2d}$  into  $2^d$  blocks of size  $2^d$ . Quite interestingly, these smaller submatrices correspond to a simple family of electric one-electron H amiltonians de ned on  $d^0$  (d<sup>0</sup> d), some of which having a single-impurity site. In a second step, we show how to further reduce these matrices into smaller blocks of size  $d^0 + 1$  (instead of  $2^d$ ), corresponding to nite chains of size  $d^0 + 1$  with one in purity site at one end and new speci c hopping terms. U sing a standard approach for in purity problem swe provide a closed expression sum rule for the eigenspectrum. We also derive the exact expression for the one-particle G reen's function. Finally, the extension of these results to hypercubic lattices with periodic boundary conditions is brie y discussed.

Let us de ne  $_{\rm d}$ , an abelian subgroup of the full  $_{\rm d}$  point group, generated by the d re ections into perpendicular (d 1) dimensional planes meeting at the  $_{\rm d}$  centre,

where E is the identity operator. It is easy to show that d has 2<sup>d</sup> elements (ow ing to the commutativity between the mirror operations), and that the orbit of a generic point under d is a hypercube d. Let us number the d elements L by integers between 0 and  $2^d$  1, in the following way: L being a product of m irrors i, let L be the number, written in base-two, whose corresponding i<sup>th</sup> digits are equal to one  $(_1$  is L = 1,  $_{1 2 3}$  is L = 7, etc...). Let us also locate the sites according to their num bering in base-two: The ith coordinate is equal to the i<sup>th</sup> digit. Now, the action of the symmetry operation L, onto a site s, noted as the \special product" s, can be explicited: each time a digit equals 1 in L, it switches the corresponding digit in s. For example, in 3 dimensions, 7 1 = 6, with corresponds in coordinates to 1 2 3 (0;0;1) = (1;1;0). To construct the irreducible representations (irreps) and the character table of d, it is useful to remark that this group is isom orphic to d times the tensorial product with itself of the

two-element group  $Z_2 = fE$ ;  $_1g = _1$  [6]. This is nothing else than the group theory counterpart of the natural construction of d as two displaced copies of  $d_1$ . The d irreps are easily obtained as tensor products of the two irreps  $_0$  and  $_1$  of  $\mathbb{Z}_2$ . As an illustration, the character table fo  $_2 = Z_2 Z_2$  is shown in Table I. All the irreps are uni-dimensional ( $_{\rm d}$  is abelian), and the character table is identical to standard H adam ard m atrices [7], which are orthogonal matrices with elements 1 (note also that lines and colum ns of H adam ard m atrices represent the non-interacting one-electron orbitals of the problem). Note that the N (= 2<sup>d</sup>) irreps can also be labelled by integers M, through their base-two decom position, by ordering the di erent occurences of  $Z_2$  in the tensorial product, and xing the corresponding digit to 0 or 1, whether the irreps  $_0$  and  $_1$  occur.

Let us consider rst the one-electron tight-binding spectrum with hopping term t. Each eigenstate belongs to a given irrep of  $_{\rm d}$ , and reads

where m  $_{\rm M}$   $_{\rm ;r}$  is the number of digits equal to 1 simultaneously in M and r (we have used the above de ned special product to denote the action of the sym metry operation R onto the basis kets). Since all the sites are equivalent, it is su cient to consider the interaction of the site number 0 with its d rst neighbors which have exactly one digit equal to 1 and belong to the set  $V_d$  =  $fv_j$  =  $2^j;j$  = 0:::d 1g. As a result, one nds that the eigenenergies read

where  $N_{\rm M}$  is the number of digits equal to 1 in M . Since M runs from 0 to 2<sup>d</sup> 1, the  $_{\rm d}$  spectrum consists of d+1 levels, from dt to dt, with equal spacing 2t. The degeneracy of a  $E_{\rm M}$  level is the standard binom ial coefficient counting the number of sets of  $N_{\rm M}$  digits among d. As d tends to in nity, one recovers a gaussian-shaped spectrum , as for the in nite-dimensional cubic lattice.

Let us now consider the two-electron case (electrons with opposite spins). The full Ham iltonian matrix, of size  $2^{2d}$ , is readily block-diagonalized into  $2^{d}$  blocks of size  $2^{d}$ , associated with each representation M. For a given M, one constructs a basis with  $2^{d}$  kets M;1>

It is clear that U only occurs in < M ;0 J (U ) M ;0 > , while the kinetic part reads

In the latter expression, we have decoupled the terms where the # spin jumps ( rst part) from those where the " spin jumps. In the latter part (sum over j) the only nonvanishing term corresponds to  $r = v_1 r {}^{0}1!$  $1^0 = v_1$ , which means land  $\frac{1}{2}$  neighbors (recall that the group is abelian and its elements are their own inverse). One nally gets that the nonvanishing kinetic term s read




Fig. 1. Graphical illustration of the e ective H am iltonian H  $^{(\mbox{M}\ )}$  associated with the irrep M  $% (\mbox{M}\ )$  . Full circles correspond to im purity sites with a diagonal term U, full edges to hopping term s equal to 2t, and dotted lines to the edges which are cut in the given irrep.

The block matrix associated to the irrep M corresponds therefore to an e ective one-electron tightbinding H am iltonian, with sites labelled by 1, kets M; 1> and hopping term s given by the above expression (7). A simple case is provided by the identity irrep M = 0, for which  $\frac{M}{r} = 1$  for any r. The e ective H am iltonian H <sup>(0)</sup> corresponds to a hypercube d, with one \impurity" site (with diagonal term U) and a constant hopping term 2t. W enow show that the other irreps correspond to e ective Ham iltonian H  $^{(M)}$  on hypercubes  $d^0$  with  $d^0 < d$ . One has to evaluate the right-hand part of equation (7). By de nition of the vi (mirrors which connect a site to one of its rst neighbors), r and vi r di er by one digit, w hich depends on j, not on r. If this digit takes the value 1 in the base-two decomposition of M , then  $\frac{M}{r} \frac{M}{v_i r} =$ 1 for any r, and the corresponding H (M ) matrix element vanishes. H  $^{(M)}$  therefore corresponds to a  $_{d}$  in which fam ilies of parallel edges have been cut (those orthogonal to the m irrors labelled by the digits 1 in the decomposition of M). Figure 1 displays graphically this general result for d = 2 and d = 3.

So, at this step, the spectrum is solved in terms of one-electron tight-binding models on hypercubes of dimension lower or equal to d. The only non-trivial part corresponds to those part, in the hypercube decom position, which contain the impurity site [8]. We now show how to further greatly reduce their com plexity.

To do that it is convenient to re-express the e ective Ham iltonian H (hereafter we will drop the superscript (0) since only the M = 0 case has nally to be considered) in the one-electron basis, Eq.(3). It is easy to verify that H can be written in the form

where D iag ( ) is a diagonalm atrix whose entries are the 2<sup>d</sup> free electron-solutions of the hypercube with hopping 2t (solution at U = 0) and  $I_N$  is the N N m atrix with unit entries for all i and j. The latter part is nothing but a projection operator on the eigenstate  $y_0 > w$  ith energy U and H can be rew ritten


with  $(v_0)_i = \frac{p_1^1}{N}$   $i = 1; \dots; N$ : To proceed further we de ne for each subspace corresponding to a given value i (d + 1 subspaces of degeneracy  $g_i$ , the binom ial coe cient) a basis consisting of the normalized vectors  $v_1^{(i)} = \frac{1}{q_i} (1; \dots; 1)$  and a set of vectors  $fv_k^{(i)}$ ; k  $\in$  1g spanning the subspace orthogonal to  $v_{\scriptscriptstyle 1}^{({\rm i})}$  . In this new basis only the (d + 1) vectors  $v_{\scriptscriptstyle 1}$  have a non-zero overlap with  $jv_0 >$ , and H, of dimension  $2^d$ , decom poses into a diagonalm atrix having  $2^d$  (d+ 1) trivial solutions i, and a residual U-dependent part, noted H , given by the matrix of linear size (d + 1) written in the form

where  $j_{v}$  > has components  $v_{i} = \int \overline{g_{i}} = N$  and the 's represent now the (d+1) distinct free-electron energies:

An alternative representation consists in going back to the basis where the potential operator V is diagonal. H is then found to be tridiagonal (one-dimensional tightbinding model) with o -diagonal hopping term given by  $t_{i;i+1} = 2t^{r}$  (d i) (i+1); i = 0 to d 1 and a diagonal U-contribution at the initial site (here num bered 0). In other words, the problem is mapped onto a singleimpurity problem on a nite chain of linear size (d + 1). Figure 2 illustrates this result for d 3.

It is known that eigenspectrum of single-impurity problems can be expressed under the form of a sum rule expression using the Koster-Slater approach [9]. This result can be brie y re-obtained as follows. First, the following operator identity [10] is invoked

where z is an arbitrary complex number and  $G_{vv}^{(0)}$  the unperturbed G reen's function given by  $G_{vv}^{(0)}(z) = \langle vj(H_0 z)^1 j v \rangle$ . Then, using this identity the fully interacting G reen's function,  $G_{vv}(z)$ , can be written as

Searching for poles of  $G_{vv}$  (z) we get

Eq.(14) is the nal closed expression determ ining the non-trivial part of the spectrum. It is easily shown that this equation adm its (d + 1) distinct solutions we shall denote as Spect<sup>(d)</sup> (U).

To sum marize, the set of  $2^{2d}$  eigenvalues of the hypercube  $_d$  consists of a U-dependent part given by the collection of the non-trivial spectra at dimensions lower or equal to d:

(note that here the binom ial  $\infty$  e cient  $\infty$  unts the num ber of occurences of  $_i$  hypercubes with an impurity site in the decomposition of the initial  $_d$ , see Fig.1) and a trivial U-independent part given by:

the prime in  $P_0$  indicating that the sum mation over i is done with an increment of two. Formula (17) can be obtained by tracing back the contributions due to the different irreps and those issued from the internal symmetry of hypercubes (trivial solutions extracted when passing from Eq.(9)) to Eq.(10)). The ground-state energy is not degenerate and corresponds to the lowest solution in Spect<sup>(d)</sup> (U). Note also that in the lim it of large dimensions, and after proper renorm alization of the parameters of the Ham iltonian, an in nite-dimensional model can be de ned, as done recently for a number of correlated ferm ions models, see [2].

Let us now consider dynam ical properties. W e are interested in evaluating the one-particle G reen's function de ned by

where j<sub>0</sub> > denotes the one-particle ground-state consisting of one electron of given spin and  $a_k^+$  creates one electron of opposite spin in a one-particle state, noted k. Hereafter, k varies from 0 to d and labels one of the (d+1) degenerate subspaces of the one-electron problem, the ground-state corresponding to k = 0. Now, remark that vector  $a_k^+$  j<sub>0</sub> > belongs to the subspace corresponding to the decom position on hypercubes of dimension (d k). There exist  $2^k$  di erent fam ilies of hypercubes having such a dimension (See, g.1) am ong which only one has the U-in purity site. A coordingly, we get the following result

Now, we need to evaluate the fundamental quantity  $G_0^{(d^0)}(z;U)$  with H am iltonian (10), the dimension  $d^0$  ranging from 0 to d. For that we note that the ket  $jD > a_0^+ j_0 >$  represents the (rst) basis element corresponding to the diagonal energy  $_0$  in representation (10). Projecting out identity (12) onto vector jD > and expressing the dimension quantities in terms of the non-interacting spectrum we get:

This equation together with Eqs.(11) and (19) give the exact one-particle G reen's function of the problem .

Generalization of this approach to higher llings is presently under investigation. We have already found that the existence of large fractions of U-independent eigenvalues is still valid for some speci c llings. However, the underlying structure for the U-dependent part of the spectrum is more di cult to elucidate.

Back to the two-electron case, we would like to mention that, by using rotations instead of relections, a sim – ilar calculation can be done for standard d-dimensional hypercubic lattices of linear size L and periodic boundary conditions ( $Z_{L}^{d}$ ). We have found that the problem can still be mapped onto a family of L<sup>d</sup> single-in purity one-electron e ective problems de ned on the very same lattice,  $Z_{L}^{d}$ . Each irrep corresponds to a value of a d-dimensional integer vector M (M<sub>i</sub> = 0 :::L 1), or more physically, to a value for the total momentum  $K = \frac{2}{L}M$ . The only dimensional integer vector more between irreps lies in the value of the hopping term which depends explicitly on M. More precisely, for each irrep labelled by K, Eq.(14) now reads

where the non-interacting energies (K) are given by

with  $\mathcal{K} = \frac{2}{L}M'$  and  $\mathcal{K} = \frac{2}{L}n$ . In contrast with hypercubes, the sum in Eq.(21) runs over  $L^d$  values and cannot be further reduced. Note that, since the elective hopping term varies with the irrep (and can even vanish), both localized and resonant states (irreps by irreps) may be present. Finally, it is worth noticing that in the d = 1 case the Bethe ansatz equations for two particles [1]:

with  $E = 2t(\cos k_1 + \cos k_2)$  and  $k_1 + k_2 = \frac{2}{L}M$  (M = 0:::L 1) can be recovered from Eq.(21) after simple but tedious algebra.
