Disorder E ects in CA-Models for Trac Flow

A b stract. We investigate the elect of quenched disorder in the Nagel-Schreckenberg model of traction of tractions. Spatial inhomogenities, i.e. lattice sites where the braking probability is enlarged, are considered as well as particle disorder, i.e. cars of a disorder maximum velocity. Both types of disorder lead to segregated states.

1 Introduction

The form ation of tra c jams is one of the fundamental problems of tra c ow theory. Tra c jams can form spontanously as well as due to hindrances, e.g. road works or slow cars. A lthough these hindrances often cover only a small part of the road, they can cause large jams, or, in a more physical language, one observes macroscopic e ects due to local defects in the system. This behaviour is one of the characteristic properties of nonequilibrium systems. In the context of driven lattice gases one can distinguish in principle two types of defects: 1) lattice defects, e.g. sites where the mobility of particles is reduced, and 2) particle defects, for example 'slow' particles.

For the sim plest model for a driven lattice gas in one dimension, the asymmetric exclusions process (ASEP)[1], it has been shown that both types of defects can cause phase transitions. Slow particles, i.e. particles with a reduced hopping rate, determine completely the owat small densities. Moreover, if the distribution of the hopping rates full ls certain conditions, one can show analytically that the variance of the distance distribution has a logarithmic divergence at the transition density [2,3,4,5].

A lso lattice defects in the A SEP have been investigated extensively [6,7,8,9,10,11]. Im plem enting lattice defects one can observe three dierent phases: A high and a low density phase, where the average ow of the homogeneous system is recovered, and a segregated phase at intermediate densities, where the ow takes a constant value. Despite extensive e ort, exact analytical results exist only for a special type of update [12], but approximative descriptions are in reasonable agreement with simulation results.

In this work we generalize the results of the ASEP to the Nagel-Schreckenberg (NaSch) model of trace ow (for a detailed explanation of the model see [13,14]). Compared with the ASEP, the particles (cars) can hop more than one site in a single update step and the update rules are applied in parallel to all cars. Therefore slow cars can be considered in two ways. First, one can think of cars with a smaller maximum velocity and second, of cars with an enlarged braking probability. This has been done very recently and analogous results to the $v_{max}=1$ case have been found [15]. In contrast to [15] we discuss the case of two dierent maximum velocities in the third chapter. In the next chapter we show simulation results for the NaSch model with defect sites, in plan ented as sites where the braking probability of cars is higher compared to the rest of the lattice. An alternative choice has been used in [16], where a 'speed limit' in a part of the lattice has been considered.

2 Defect Sites




Fig.1.Fundam entaldiagram of the NaSch model with a single defect site. The model parameters are given by $v_{max}=2$ (maximum velocity), p=0.25 (braking probability), $p_d=0.75$ (braking probability at the defect site) and L=3200 (system size).

As already mentioned above, in this chapter we show simulation results of the NaSch modelon a lattice with defect sites. Fig. 1 shows the fundamental diagram

of a system with a single defect site. O byiously we can distinguish three dierent phases depending on the density. In the high and low density phases the average ow of the defect system s takes the same value as in the homogeneous system. For intermediate densities the ow is constant and limited by the capacity of the defect site.

This behaviour of the average ow can be explained looking at the density pro le. In the high and low density phase only local deviations from a constant pro le can be observed, but at intermediate densities one observes a separation into macroscopic high and low density regions. Changing the global density




Fig. 2. Density proles in the three phases. In the high (red, = 0.60) and low (blue, = 0.10) density phases only local inhom ogenities occur near the defect site (the defect site is located at $x_d = 1600 = L = 2$), but for interm ediate densities one observes phase separation (green, = 0.30). We used the same parameters as in Fig. 1.

within the segregated phase, the bulk densities in the high ($_{\rm h}$) and low density region ($_{\rm l}$) remain constant, only the length of the high and low density region changes. Consequently the average ow is constant in the segregated phase, because the average density in the vicinity of the defect site does not depend on the global density.

Near the average position of the shock the density prole decays exponentially from $_h$ to $_1.\,T$ herefore one can introduce a length scale , which corresponds to the magnitude of the pictuations of the shock position. For $v_{max}>1$ we found numerically that $\stackrel{}{L}$ for all densities in the segregated phase we took into account. This scaling behaviour is already known for the ASEP at $\,\,6\,$ 0.5. The modiled scaling behaviour $\,\,L^{1=3}$ at $\,=\,$ 0.5 was not found for $v_{max}>1$. This conim since that the reduction of uctuations is a consequence of the particle-hole symmetry [6].

A good estim ate for the plateau value of the $\,$ ow for the case of $v_{n~ax}=1$ can be obtained using the assumption that the system is separated into two regions of constant density, where the results from the homogeneous system can be used. Using an argumentation similar to [10] we obtain the plateau value of the average $\,$ ow:

The bulk value of the density in the high (low) density region the density is given by $_h=\frac{q}{q+q_d}$ ($_1=\frac{q_d}{q+q_d}$) with q=1 p and $q_d=1$ p_d. The shock is located at $r=x_d$ $\frac{h}{h-1}L$ if r=0 or at $r^0=L$ rif r<0. This approximative treatment of the defect system is in a resonable agreement with the simulation

results for large system sizes (for a m ore detailed discussion see [18]). In principle one could treat higher velocities in the same way, but unfortunately no exact analytical description of the hom ogeneous system has been found by so far.

3 Particle defects

In order to study the e ect of slow cars on the throughput of single lane tra c, we discuss a system which consists of fast cars with maximum velocity $v_f=3$ and one slow car with $v_s=2$.




Fig.3. Fundam ental diagram of a system with one slow car (dots) compared with fundam ental diagrams of the corresponding homogeneous systems. The maximum velocity of the slow car is given by $v_s=2$ and of the other cars by $v_f=3$. The braking probability of all cars is p=0.5.

In Fig. 3 the fundam ental diagram of this system is compared with the fundam ental diagram of the analogous hom ogeneous systems. Obviously for low densities the ow is given by $J_{\rm l}(\)=\ (v_{\rm s}\ p)$ in a agreement with the homogeneous system with $v_{\rm max}=2$. Compared to the homogeneous system one observes the linear density dependence also for larger values of the average density. The average ow depends linearly on the global density if $J_{\rm l}(\)$ $J_{\rm v_f}(\)$ holds, where $J_{\rm v_f}(\)$ denotes the stationary ow of the homogeneous system with fast cars. Deviations from this form that are observable near the intersection point of $J_{\rm l}(\)$ and $J_{\rm v_f}(\)$, are due to the nite size elects.




Fig.4. Density pro le relative to the position of the slow car. The data are obtained for the following set of parameters: $v_s=1$, $v_f=2$, p=0.5 and, =0.1.

The reason for the stability of the free ow regime in the mixed system is the gap in front of the slow car in the stationary state. In Fig. 4 the density pro le relative to the position of the slow car is shown. O bviously a large jam behind the slow car appears and the density in front of the slow car vanishes. Therefore the slow car can move with its free ow velocity very p. This velocity determines the velocity of the whole jam and therefore the average velocity of the cars is

In addition to the macroscopic form, two details of the density prole have to be discussed. Behind the slow car one observes an oscillating amplitude of the density prole. These oscillations are well know from the spatial correlation function of the homogeneous system for small pland densities near $_{\rm C}=1=(v_{\rm max}+1)$ [19]. Obviously the slow car synchronizes the motion of the faster cars. Furthermore we want to discuss the decay of the density prole at the end of the jam. For nite values of the braking probability the jam length is uctuating. These uctuations are responsible for the nite size elects discussed above, because temporarily the gap in front of the slow car vanishes due to uctuations of the jam length. Measurements of the jam length show that the uctuations scale according to L $_{\rm J}$ L. Due to the subextensive scaling of the uctations the segregated states are observable up to $_{\rm J}$ if L ! 1 , where $_{\rm J}$ denotes the bulk density of the jam .

4 Sum m ary

The investigation of local defects in the NaSch model has shown that these defects can change the macroscopic properties of the model. In the case of lattice defects three phases occur analogous to the ASEP (i.e. $v_{m~ax}=1$) with continuous time update. The segregated phase also exists for higher maximum velocities, but some details of the density probe are changed. In the low density regime one observes an oscillating probe as a consequence of the parallel update. The anomalous scaling of the actuations of the shock position found for the ASEP at = 0.5 is absent for $v_{m~ax}>1$, for all parameter combinations that have been taken into account. This result conoms the picture that the particle-hole symmetry is essential for the reduction of accounts.

Particle defects also produce phase separated stationary states at low densities. These states consist of a large jam behind the slowest vehicle and a large gap in front of the slowest car. The velocity of the 'm oving' jam is completely determined by the free ow velocity of the slow car. The formation of large clusters due to slow cars can also be observed in two-lane trace, but due to lane changing the lifetime of the large clusters is nite (at least for low densities). Nevertheless it has been shown, that already a small concentration of slow cars changes leads to a drastic reduction of the average ow at low densities [20].

Our results show that the system poperties can change completely, if local disorder is taken into account. These results might also be important for an understanding of the behaviour of real trace which are often determined by 'imperfections'. Such imperfections are not only the defects considered here, but also other deviations from an ideal system, e.g. ramps or a nite system size.
