## N onequilibrium relaxation of the two-dimensional Ising model: Series-expansion and M onte Carlo studies

We study the critical relaxation of the two-dimensional Ising model from a fully ordered con guration by series expansion in time t and by M onte C arlo simulation. Both the magnetization (m) and energy series are obtained up to 12-th order. An accurate estimate from series analysis for the dynamical critical exponent z is di cult but compatible with 22. We also use M onte C arlo simulation to determ ine an e ective exponent,  $z_e$  (t) =  $\frac{1}{8}$ d ln t=d ln m, directly from a ratio of three-spin correlation to m. Extrapolation to t! 1 leads to an estimate z = 2:169 0:003.

#### I. IN TRODUCTION

The pure relaxational dynam ics of the kinetic Ising m odel with no conserved elds, which is designated as m odelA in the Hohenberg-Halperin review [1], has been studied extensively by various approaches. Unlike som e of the other m odels in which the dynam ical critical exponent z can be related to the static exponents, it seem s that z ofm odelA is independent of the static exponents (how ever, see Ref. [2]). In the past twenty years, the num erical estim ates for the dynam ical critical exponent z scattered a lot, but recent studies seem to indicate a convergence of estim ated values. Our studies contribute further to this trend.

We review brie y some of the previous work on the com putation of the dynam ical critical exponents, concentrating mostly on the two-dimensional Ising model. The conventional theory predicts z = 2[3], where is the critical exponent in the two-point correlation function,  $G(\mathbf{r}) / \mathbf{r}^{d+2}$ . For the two-dimensional Ising model, this gives z = 1.75. It is known that this is only a lower bound [4]. It is very interesting to note that series expansions [5{10] gave one of the earliest quantitative estim ates of z. Dammann and Reger [10] have the longest hightem perature series (20 term s) for the relaxation tim es so far, obtaining z = 2:183 0:005. However, re-analysis of the series by A dler [11] gives z = 2:165 0:015. There are two types of eld-theoretic renorm alization group analysis: the -expansion near dimension d = 4 [12,13] and an interface model near d = 1 [14]. It is not clear how reliable when it is interpolated to d = 2. Real-space renorm alization group of various schem es has been proposed in the early eighties [15{18], but it appears that there are controversies as whether som e of the schemes are wellde ned. The results are not of high accuracy com pared to other methods. Dynamic Monte Carlo renormalization group [19{22] is a generalization of the equilibrium M onte Carlo renorm alization group m ethod [23]. The latest work [22] gives z = 2:13 0:01 in two dimensions. Equilibrium M onte C arlo m ethod is one of the standard m ethods to estim ate z [24{28]. However, long simulations (t L<sup>z</sup>) are needed for su cient statistical accuracy of the time-displaced correlation functions. The analysis is quite di cult due to unknown nature of the correlation functions. Nonequilibrium relaxation [29{34], starting from a completely ordered state at  $T_{c}$ , has nice features. The analysis of data is more or less straightforward. The lattice can be made very large, so that nitesize e ect can be ignored (for t  $L^{z}$ ). The catch here is that correction to scaling due to nite t is large. Recently, the idea of dam age spreading [35{39] has also been em ployed. M ethods based on statistical errors in equilibrium Monte Carlo simulation [40], nite-size scaling of nonequilibrium relaxation [41,42], and nite-size scaling of the eigenvalues of the stochastic matrix [43,44] are used to compute the exponent. A recent calculation with a variance-reducing M onte C arlo algorithm for the leading eigenvalues gives prediction [44] z = 2:16650:0012. This appears to be the most precise value reported in the literature.

The high-tem perature series expansions for the relaxation times are often used in the study of Ising dynamics. In this paper, we present a new series which directly corresponds to the magnetization (or energy) relaxation at the critical tem perature. Our series expansion method appears to be the only work which uses time t as an expansion parameter. The generation of these series is discussed in Sections II and III. Dynam ical scaling m entioned in Section IV forms the basis of the analysis, and the results are analyzed in Section V. W e feel that the series are still too short to capture the dynam ics at the scaling regime. We also report results of an extensive M onte C arb simulation for the magnetization relaxation. We nd that it is advantageous to compute an e ective dynam ical critical exponent directly with the help of the governing master equation (or the rate equation). The

simulation and analysis of M onte C and data are presented in Section VI. We summarize and conclude in Section VII.

#### II. SER IES EXPANSION METHOD

In this section, we introduce the relevant notations, and outline our method of series expansion in time variable t. The formulation of single-spin dynam ics has already been worked out by G lauber [45], and by Yahata and Suzuki [5] long time ago. To our knowledge, all the previous series studies for Ising dynam ics  $[5\{10\}]$  are based on high-temperature expansions of some correlation times. As we will see, expansion in t is simple in structure, and it o ers at least a useful alternative for the study of Ising relaxation dynam ics.

W e consider the standard Ising model on a square lattice [46] with the energy of a conguration given by

where the spin variables  $_i$  take 1, J is the coupling constant, and the sum mation runs over all nearest neighbor pairs. The therm al equilibrium value of an observable f () at temperature T is computed according to the Boltzm ann distribution,

The equilibrium statistical-mechanical model de ned above has no intrinsic dynamics. A local stochastic dynamics can be given and realized in M onte C arlo simulations [47]. The dynamics is far from unique; in particular, cluster dynamics [48] di ers vastly from the local ones.

A sequence of M onte C arb updates can be viewed as a discrete M arkov process. The evolution of the probability distribution is given by

where W is a transition matrix satisfying the stationary condition with respect to the equilibrium distribution, i.e.,  $P_{eq} = P_{eq}W$ . A continuous time description is more convenient for analytic treatment. This can be obtained by xing t = k=N, and letting t = 1=N ! 0, where N =  $L^2$  is the number of spins in the system. The resulting di erential equation is given by

where is a linear operator acting on the vector P ( ;t), which can be viewed as a vector of dimension  $2^N$ , indexed

by . If we use the single-spin-ip G lauber dynam ics [45], we can write

The ip rate  $w_j(j)$  for site j depends on the spin value at the site j as well as the values of its nearest neighbor spins k.

The full probability distribution clearly contains all the dynam ic properties of the system . Unfortunately its high dimensionality is di cult to handle. It can be shown from the master equation, Eq. (4), that any function of the state (without explicit t dependence) obeys the equation

Note that the time dependence of hfi is only due to P (;t). For the series expansion of this work, it is sufcient to look at a special class of functions of the form  $A = \int_{j2A} j$ , where A is a set of sites. In such a case we have

W ith this set of equations, we can compute the n-th derivative of the average magnetization h  $_0\,i_t$ . A form al solution to Eq. (8) is

This equation or equivalently the rate equation, Eq. (11), form s the basis of our series expansion in time t.

A few words on high-tem perature expansions are in order here. They are typically done by integrating out

the time dependence the nonlinear relaxation time can be de ned as

The equilibrium correlation time (linear relaxation time) can be expressed as

where = N km<sup>2</sup> $i_{eq}$  is the reduced static susceptibility. The average is with respect to the equilibrium distribution, P<sub>eq</sub>(). A suitable expansion in small parameter  $J=k_B T$  can be made by writing  $L = L_0 + L$ .

It is clear that we can also perform the K aw asakidynam ics with a corresponding rate. Of course, since the m agnetization is conserved, only energy and higher order correlations can relax.

A very convenient form for the G lauber transition rate, Eq. (6), on a two-dimensional square lattice is

where the site 0 is the center site, and sites 1, 2, 3, and 4 are the nearest neighbors of the center site. At the critical tem perature,  $\tanh K_c = \frac{1}{2}$  1, we have  $x = \frac{5}{2}$  = 24 and  $y = \frac{1}{2}$  = 24.

# III.COM PUTER IM PLEMENTATION AND RESULTS

A series expansion in t amounts to noting the derivatives evaluated at t = 0:

The derivatives are computed using Eq. (11) recursively. A general function is coded in C programming language to nd the right-hand side of Eq. (11) when the conguration  $^{\rm A}$ , or the set A, is given. The set A is represented

as a list of coordinates constructed in an ordered manner. By specializing the ip rate as given by Eq. (15), and considering each site in A in turn, the con gurations on the right-hand side of the rate equation are generated in three ways: (1) the same con guration as A, which contributes a factor (coe cient of a term ) of 1; (2) a set of con gurations generated by introducing a pair of nearest neighbor sites in four possible directions, with one of the sites being the site in A under consideration, and making use of the fact  $\frac{2}{i} = 1$ . We notice that the site in A under consideration always gets annihilated. Each resulting con guration contributes a factor of x; and (3) same as in (2) but two more sites which are also the nearest neighbors of the site in A under consideration are introduced. This two extra sites form a line perpendicular to the line joined by the rst pair of neighbor sites in (2). Each of this conguration has a factor of y. It is instructive to write down the rst rate equation, taking into account of the lattice symmetry (e.g.  $h_{ii} = h_{0i}$ , for all i):

The core of the computer in plan entation for series expansion [49] is a symbolic representation of the rate equations. Each rate equation is represented by a node together with a list of pointers to other nodes. Each node represents a function h<sup>A</sup> i, and is characterized by the set of spins A. The node contains pointers to the derivatives of this node obtained so far, and pointers to the \children" of this node and their associated coe – cients, which form a symbolic representation of the rate equations. The derivatives are represented as polynom ials in y. Since each node is linked to other nodes, the computation of the n-th derivative can be thought of as expanding a tree (with arbitrary number of branches) of depth n.

The traversal or expansion of the tree can be done in a depth- rst fashion or a breadth- rst fashion. Each has a di erent computational complexity. A simple depthrst traversal requires only a sm all am ount of m em ory of order n. How ever, the time complexity is at least exponential, b<sup>n</sup>, with a large base b. A breadth- rst algorithm consumes m em ory exponentially, even affer the num ber of the rate equations has been reduced by taking the symmetry of the problem into account. The idea of dynam ic program ming can be incorporated in the breadthrst expansion where the interm ediate results are stored and referred. To achieve the best perform ance, a hybrid of strategies is used to reduce the computational com plexity:

Each con guration (pattern) is transform ed into its canonical representation, since all con gurations related by lattice symmetry are considered as the same con guration.

W e use breadth- rst expansion to avoid repeated computations involving the same con guration. If a con guration has already appeared in earlier expansion, a pointer reference is made to the old conguration. Each con guration is stored in memory only once. How ever, storing of all the distinct congurations leads to a very fast grow th in memory consumption.

The last few generations in the tree expansion use a simple depth-rst traversal to curb the problem ofmemory explosion.

Parallel computation proves to be useful. The longest series is obtained by a cluster of 16 Pentium ProPCs with high speed network connection (known as Beowulf).

The program is controlled by two parameters D and C.D is the depth of breadth-rst expansion of the tree. W hen depth D is reached, we no longer want to continue the norm al expansion in order to conserve memory. Instead, we consider each leave node afresh as the root of a new tree. The derivatives up to (n D )th order are com puted for this leave node. The expansion of the leave nodes are done in serial, so that the mem ory resource can be reused. The parameter C controls the number of last C generations which should be computed with a simple depth-rst expansion algorithm. It is a simple recursive counting algorithm, which uses very little memory, and can run fast if the depth C is not very large. In this algorithm the lattice symmetry is not treated. The best choice of parameters is D = 6 and C = 2 on a DEC AlphaStation 250/266. The computer time and memory usage are presented in Table I. As we can see from the table, each new order requires more than a factor of ten CPU time and about the same factor for memory if m em ory is not reused. This is the case until the order D + C + 1, where no fresh leave-node expansion is made. There is a big jump (a factor of 60) in CPU time from 9th order to 10-th order, but with a much smaller increase in memory usage. This is due to the change of expansion strategy. Finally the longest 12-th order series is obtained by parallel computation on a 16-node Pentium Pro 200 M H z cluster in 12 days. The number of distinct nodes generated to order n is roughly  $\frac{1}{100}11^n$ . To 12-th order, we have exam ined about 1010 distinct nodes. The series data are listed in Table II.

#### IV.DYNAM ICAL SCALING

The traditional method of determining the dynamical critical exponent z is to consider the time-displaced equilibrium correlation functions. However, one can alternatively look at the relaxation towards therm al equilibration. The basic assumption is the algebraic decay of the magnetization at  $T_c$ ,

This scaling law can be obtained intuitively as follows. Since the relaxation time and the correlation length are related through / z by de nition, after time t, the equilibrated region is of size  $t^{1=z}$ . Each of such region is independent of the others, so the system behaves as a nite system of linear length  $/ t^{1=z}$ . A coording to nite-size scaling [50], the magnetization is of order = on a nite system of length . Each region should have the same sign for the magnetization since we started the system with all spins pointing in the same direction. The totalm agnetization is equal to that of a correlated region, giving m / t = z.

The same relation can be derived from a more general scaling assumption [51],

By requiring that m(t; ) is still nite as the scaling argument  $t^{z} = 0$  and  $t^{z} = 0$  with xed t, we get Eq. (20).

Equation (20) is only true asymptotically for larget. It seems that there is no theory concerning leading correction to the scaling. As a working hypothesis, we assume that

The M onte Carlo simulation results as well as current series analysis seem to support this with near 1.0 ther possibility might be z = 2 with logarithm ic correction [52].

#### V.ANALYSIS OF SERIES

A generalmethod for extending the range of convergence of a series is the P ade analysis [53,54] where a series is approximated by a ratio of two polynomials. We rst look at the poles and zeros of the Pade approxim ants in variable s = t = (t + 1) for m. Since t varies in the range of [0;1 ), it is easier to look at s, which m aps the interval [0;1) to [0;1). There are clusters of zeros and poles in the s-interval (1;2) which corresponds to negative t. But interval [0;1) is clear of singularities, which gives us hope for analytic continuation to the whole interval [0;1). If we assume the asymptotic behavior m / t <sup>a</sup>, then d ln m =dt = a=t a (1 s) for large tors ! 1. Thism eans that the Pade approxim ant should give a zero around s = 1. W e do observe zeros near 1. But it is typically a pair of zeros o the real axis together with a pole at the realaxis near 1, or som etim es, only a pair of real zeros. These com plications make a quantitative analysis di cult.

Since we know the exact singular point (corresponding to t = 1), we use the biased estimates by considering the function

An elective exponent  $z_e$  (t) is defined by  $z_e$  (t) = =( F(t)) = 1=(8F(t)).

A gain we prefer to use the variable s to bring the innity to a nite value 1. Due to an invariance theorem [53], the diagonal P ade approxim ants in s and t are equal exactly. For o -diagonal P ade approxim ants, s is m ore useful since the approxim ants do not diverge to in nity.

W e use m ethods sim ilar to that of D ickm an et al. [55] and A dler [11]. The general idea is to transform the function m (t) into other functions which one hopes to be better behaved than the original function. In particular, we require that ast ! 1, the function approaches a constant related to the exponent z. The rst transform ation is the Eq. (23). A second fam ily of transform ations is

where p is a real positive number. O ne can show that the two functions are related by

where is an adjustable parameter, and F can also be replaced by  ${\rm G}_{\rm p}$ . If the leading correction to the constant part is of the form t  $\,$ , the transform ation will elim in this correction term .

The transform ation of the independent variable t to other variable is important to improve the convergence of the Pade approxim ants. We found that it is useful to consider a generalization of the Euler transform,

The parameter is adjusted in such a way to get best convergence among the approximants. Since for  $t \mid 1$  or  $u \mid 1$ , a Pade approximant near u = 1 is an analytic function in u, which implies that the leading correlation is of the form t. Note that = 1 corresponds to the Euler transformation (u = s when = 1).

One of the fundam ental di culties of the transform ation method is that one does not know a priori that a certain transformation is better than others. Worst still, we can easily get m isleading apparent convergence am ong di erent approxim ants. Thus, we need to be very careful in interpreting our data. Speci cally, we found that Eq. (23) gives less satisfactory result than that of Eq. (24), where the independent variable t is transform ed into u according to Eq. (27). Figure 1 is a plot of all the Pade approximants of order [N;D], with N 4,D 4, and N + D12, as a function of the parameter , for  $G_1$  (t = 1). Good convergence is obtained at = 1.217 with z 2:170. The estimates z vary only slightly with

p, at about 0.005 as p varies from 0.5 to 2. Using F (t) of Eq. (23), the optimal value is = 1.4 with z 2.26. Using the function H does not seem to improve the convergence. Even though the value 2.170 seems to be a very good result, we are unsure of its signi cance since there are large deviations of the P ade approximation to the function F (t) for 1=t < 0.2 from the M onte C arlo result of F ig.2.

An objective error estimate is dicult to give. Estimates from the standard deviation of the approximants tend to give a very small error but incompatible among di errent methods of analysis. Dierrent Pade approximants are de nitely not independent; we found that [N;D] Pade is almost equal to [D;N] Pade to a high precision. A conservative error we quote from the series analysis is 0.1.

A nalysis of the energy series is carried out similarly with m replaced by h<sub>0</sub> <sub>1</sub>i 2=2, where the constant  $\overline{2}=2$  is the equilibrium value. The large t asymptotic behavior is t  $^{1=z}$  [56]. Both F and G functions give com – parable results, better convergence is obtained for > 1. The value for z is about 2.2, but good crossing of the approxim ants are not observed. We feel better analysis m ethod or longer series is needed.

#### VI.MONTE CARLO SIM ULATION

O ur m otivation for a M onte C arlo calculation was to check the series result. It turns out that the data are su ciently accurate to be discussed in their own right. Such an improved accuracy is achieved by using Eq. (19), which perm its a direct evaluation of the elective exponent  $z_e$  (t).

We compute the magnetization  $m = h_0 i$ , energy per bond  $h_{0-1}i$ , and the three-spin correlation  $m_3 = h_{1-2-3}i$  where the three spins are the nearest neighbors of a center site having one of the neighbor m issing in the product. W ith these quantities, the logarithm ic derivative, Eq. (23), can be computed exactly without resorting to nite di erences. From Eq. (19) we can write (at  $T = T_c$ )

The above equation also de nes the e ective exponent  $z_{\rm e}~$  (t) which should approach the true exponent z as t ! 1 .

The estimates for the elective exponent based on the ratio of one spin to three-spin correlation, Eq. (28), have smaller statistical errors in comparison to a nite di erence scheme based on m (t) and m (t+1). Error propagation analysis shows that the latter has an error 5 times larger. Both methods su er from the same problem that

error z / t. Thus, working with very large t does not necessarily lead to any advantage.

In order to use Eq. (28), we need exactly the same ip rate as in the analytic calculations, namely the G lauber rate, Eq. (6). The continuous time dynamics corresponds to a random selection of a site in each step. Sequential or checker-board updating cannot directly be compared with the analytic results. However, it is believed that the dynamical critical exponent z does not depend on the details of the dynam ics.

We note that a M onte Carlo simulation is precisely described by a discrete M arkov process while the series expansion is based on the continuous m aster equation. However, the approach to the continuous limit should be very fast since it is controlled by the system size the discreteness in time is  $1=L^2$ . We have used a system of  $10^4$   $10^4$ , which is su ciently large. A part from the above consideration, we also checked nite-size e ect. C learly, as  $t > L^2$ , nite-size e ect begins to show up. We start the system to t = 99. For t < 100, we did not nd any system atic nite-size e ect for L  $10^3$ . So the nite-size e ect at L =  $10^4$  and t < 100 can be safely ignored.

Figure 2 shows the M onte C arb result for the e ective exponent as a function of 1=t. The quantities m, m<sub>3</sub>, and h<sub>0</sub> <sub>1</sub>i are averaged over 1868 runs, each with a system of  $10^8$  spins. The total amount of spin updating is comparable to the longest runs reported in the literature. B ased on a least-squares t from t = 30 to 99, we obtain

$$z = 2:169 \quad 0:003:$$
 (29)

The error is obtained from the standard deviation of few groups of independent runs. An error estimate based on the residues in the linear least-squares t is only half of the above value, which is understandable since the points in Fig. 2 are not statistically independent.

In Fig. 2, we also plot a series result for the F (t), obtained from the [6,6] Pade of  $G_1$  (u) and Eq. (25). Substantial deviations are observed for 1=t < 0.2, even though in the 1=t! 0 lim it, both results are almost the same. This casts some doubts on the reliability of the series analysis. We note that the t ! 1 lim it of the function F (t) is invariant against any transform ation in t which m aps t = 1 to 1. Thus, the discrepancy m ight be elim inated by a suitable transform ation in the Pade analysis.

### V II. C O N C LU S IO N

We have computed series for the relaxation of magnetization and energy at the critical point. The same method can be used to obtain series at other temperatures or for other correlation functions. The analyses of the series are non-trivial. We may need much more terms before we can obtain result with accuracy comparable to the high-tem perature series. We have also studied the relaxation process with M onte C arlo simulation. The ratio of three-spin to m agnetization is used to give a num ericalestim ate of the logarithm ic derivatives directly. This m ethod gives a m ore accurate estim ate for the dynam ical critical exponent.




