## Collective Excitations in High-Tem perature Superconductors

C ollective, low-energy excitations in quasi-two-dim ensional d-wave superconductors are analyzed. While the long-range C oulomb interaction shifts the charge-density-wave and phase modes up to the plasm a energy, the spin-density-wave excitation that arises due to a strong local electron-electron repulsion can propagate as a damped collective mode within the superconducting energy gap. It is suggested that these excitations are relevant to high- $T_c$  superconductors, close to the antiferrom agnetic phase boundary, and may explain some of the exotic features of the experimentally observed spectral-density and neutron-scattering data.

An important aspect of superconductivity is concerned with collective modes as they may modify low-energy properties of superconductors [1]. In principle, these excitations are either attributed to a symmetry transform ation under which the system is invariant or to a spontaneously broken continuous sym m etry. O ne m ight then expect that, in addition to the usual charge and spin uctuations, collective modes associated with the phase and the amplitude of the superconducting order param eter are im portant. Yet, in conventional superconductors with a momentum-independent energy gap, collective modes have essentially no practical signicance regarding the low-energy properties of the superconductors mainly because the long-range Coulomb interaction causes the phase mode to appear at the plasm a energy [2]. The only mode that is not di usive at long wavelengths is the am plitude mode, but it has no direct coupling to charge or spin degrees of freedom making its observation dem anding [3].

M oreover, excitonic states that are bound pairs of quasiparticles have been predicted to exist in superconductors [4]. Such states appear in angular-momentum channels other than the one in which the Cooper pairing occurs. Theoretically, they should be present once the electron-electron interaction has an attractive partial-wave component with a given angular momentum. Nonetheless, there is no experimental evidence for these kind of states possibly because of their small binding energy [5].

W hile for most phenomena collective excitations in conventional superconductors can be ignored  $\mid$  for instance, the superconducting energy gap in the electronic spectrum at the Ferm i energy is not a ected by these modes  $\mid$  there are both theoretical and experimental reasons to expect that high- $T_c$  superconductors may behave dierently in this respect. Theoretically, the energy gap has a strong momentum dependence and there is a large local electron-electron repulsion which may qualitatively change the nature of collective excitations and allow new ones to develop that are not related to the broken gauge symmetry. Ex-

perim entally, neutron-scattering studies [6] in superconducting La<sub>1:6</sub> xNd<sub>0:4</sub>Sr<sub>x</sub>CuO<sub>4</sub> have established the existence of elastic peaks in the magnetic structure factor  $\frac{1}{2}$ ) and  $(\frac{1}{2};\frac{1}{2})$ at wave vectors  $(\frac{1}{2})$ ) (m easured in units of 2 =a), providing direct evidence for (di usive) spin-density-wave uctuations in high-Tc superconducting materials. These excitations can be regarded as a m anifestation of uctuating charge stripes and antiphase spin domains which have shown to provide a natural explanation for the unusual features observed in angleresolved photoem ission experim ents [7]. We may also arque that they account for the broad \bosonic" feature in the electronic spectral density near the  $(\frac{1}{2};0)$  and  $(0;\frac{1}{2})$ points seen only in the underdoped materials [8].

In this Note, we exam ine under what conditions collective excitations develop in d-wave superconductors and what are their experim ental im plications, when the quasiparticle picture is appropriate. Our most important observation is that d-wave superconductors close to the antiferrom agnetic phase boundary support a low-energy spin-density-wave mode. As a consequence of the superconducting energy gap, this mode can propagate coherently with reduced damping, unlike its precursor in the normal state where only a diusive spin-density wave is realized. It can be excited by magnetic processes making it observable, for instance, by inelastic neutron scattering. The mode is \massive" because rotational symmetry in spin space is not broken. Under speci c conditions, how ever, the mass of the mode may vanish and may even become negative signaling an instability of the superconducting ground state against a spontaneous creation of a spin-density-wave state.

Consider, for example, the Hamiltonian

where  $n_r = \frac{y}{r}$  , is the electron number operator at site r,  $t_{rr^0}$  is the tunneling-matrix element between sites r and  $r^0$ , is the chemical potential, and v(r) is

an instantaneous electron-electron interaction. In describing superconducting order, it is useful to express the Ham iltonian in the form H =  $H_{BCS} + H_{int}$ , where the BCS and interaction Ham iltonians are

Here,  $_{p}$   $_{k}$  =  $(_{k}$ "  $_{k\#}$ )  $_{k\#}$  is the Gor'kov-Nambu spinor,  $_{k}$  =  $_{r}$   $_{t_{r_{0}}}$ 0  $_{q}$  is the single-particle energy relative to the chem ical potential, and  $_{q}$ 0 =  $_{r}$   $_{r}$ 0  $_{r}$ 0  $_{r}$ 1. The ferm ion operators in real and momentum spaces are related by the unitary transformation  $_{r}$  = N  $_{r}$ 1  $_{k}$ 2  $_{k}$ 3  $_{k}$ 4  $_{r}$ 6  $_{r}$ 7 where N is the number of sites in the system . Also, suppose that there exists a wave vector Q such that  $_{k+Q}$   $_{k}$ 7  $_{k}$ 7  $_{k}$ 9; i.e., the Fermi surface is approximately nested. This kind of situation may qualitatively arise in lightly doped high-T $_{c}$ 5 superconductors. For illustrative purposes, let only the nearestneighbor tunneling matrix element be non-zero so that  $_{k}$ 4 =  $_{2}^{1}$ 4 (cosk $_{x}$ 4 + cosk $_{y}$ 4) , where W is the half bandwidth and a is the lattice spacing. Therefore, at half lling ( = 0), Q = Q0, where Q0 ( =a; =a).

The energy gap  $\,_{k}$  is determined by requiring that the interaction H am iltonian does not give any self-energy corrections to the energy gap [9]. This condition leads to the gap equation,

where  $\hat{G}$  (p;!) = 1=(!^0 p^3 + p^1) denotes the G reen's function of the BCSpH am iltonian. We use the notation in which  $p = N^1 p$  (d!=2) and p = (p;!).

In order to determ ine whether the system can support collective excitations, consider an elective two-particle interaction ^ that describes mutual scattering of two quasiparticles. The poles of the elective interaction then yield the energy and lifetime of two-particle collective excitations. In the ladder approximation, the Bethe-Salpeter equation for ^ may be written formally as

On a square lattice, it is convenient to de ne orthogo-(k) in terms of which the vertex funcnal functions tions and the electron-electron interaction can be expanded [10]. For example,  $v(k k^0) = U + V_1 [\cos(k_x)]$  $k_x^0$ )a +  $cos(k_y k_y^0)$ a] may be written as  $v(k k^0)$  = (k)  $(k^0)$ , where, for = 0, v = U is the onsite electron-electron interaction and, for = 1;:::;4,  $v = V_1 = 2$  is the nearest-neighbor electron-electron interaction. Below, we will assume that the on-site interaction is repulsive, U > 0, and the nearest-neighbor interaction is attractive,  $V_1 < 0$ , as should be appropriate for a phenom enological model descriping high-Tc superconductors. 0, a further factorization can be shown to occur; namely, particle-hole and particle-particle channels decouple. This means that, for  $q=\varrho$ , the subspace  $f_k^{()}g$  decouples from  $f_k^{(0)};_k^{(+)}g$  and, for q=0, the same occurs for  $f_k^{()}g$  and  $f_k^{(0)};_k^{(+)}g$ . This is particularly convenient because  $k^{(-)}$  determines the d-wave gap function,  $k=(k-1)^{(-)}k$ . At zero temperature, Eq. (3) becomes

We note that the energy of the half bandwidth and N<sub>F</sub> = N () is the density of states at the Fermi energy in the normal state.$ 

The collective excitations are described by the poles of the e ective two-particle interaction, Eq. (6), and they are conveniently classied by the symmetry properties of the system. The Hamiltonian (2) possesses a number of sym metries which lead to conserved currents. First, gauge sym m etry, generated by the transform ation  $_k$ !  $_{k}^{0} = e^{i' \hat{a}}$  k, yields charge conservation. On general grounds, one then expects that there is a collective mode associated with the phase of the superconducting order parameter. However, due to the long-range nature of the Coulomb interaction, the Anderson-Higgsmechanism shifts it at sm allm om enta to the plasm a energy. Second, the sym m etry transform ation,  $k = e^{(k)}$  is associated with an amplitude mode of the order parameter [11]. In contrast to s-wave superconductors, this mode is always over-dam ped in d-wave superconductors. Third, spin-rotational sym metry leads to a new mode in the particle-hole sector, which is driven by the on-site Coulomb repulsion. As an example, consider a cylindrical Ferm i surface and a wave vector q = Q nesting two given k points with vanishing quasiparticle energies. For  $y_1$ ; the energy of the collective excitation is

sures the magnitude of the particle-hole symmetry breaking in the density of states N ( ) at the Fermi energy and o describes the contribution due to the mixing between the particle-hole and particle-particle channels. For U;  $y_1$  j W, it can be expanded as  $Q = \frac{(1)}{Q} + \frac{(2)}{Q}$ , where  $\frac{(1)}{Q}$  2  $\frac{v_1}{W}$   $\frac{2}{2}$  and  $\frac{(2)}{Q}$   $\frac{v_1}{W}$   $\frac{2}{Q}$   $\frac{0}{Q}$ . For < 0, the collective excitation remains massive  $( \circ > 0)$  for all values of  $V_0 = U$ , down to the point where the superconductor becomes unstable. The excitation is dam ped, because it overlaps with the quasiparticle continuum. For the other values of q, the continuum does not necessarily start from zero but at some nite value  $\#_q$  min<sub>k</sub> (E<sub>k</sub> + E<sub>k+q</sub>). It is then possible to have collective excitations with an in nite lifetime, when  $_{\rm q} < \#_{\rm q}$ . The exact nature of the collective excitation is deduced by exam ining its coupling to the spin operator  $S_z(q) =$  $y \wedge z^{(0)}$  k+q, where  $z^{(0)} = \frac{1}{2} z^{(0)}$ . That the mode is a spin-density wave becomes evident by computing the spin correlation function,  $(q; ) = hT S_z (q; )S_z (q; 0)i$ ,




FIG.1. The energy  $_{\rm q}$  of the spin-density-wave excitation as a function of wave vector q at zero tem perature for U=W = 0.485 and V $_{\rm 1}$ =W = 0.608. Here, the superconducting energy gap is  $_{\rm 0}$ =W = 0.1 and the chemical potential is chosen so that the density of holes equals 10% (relative to half lling). The excitation energy  $_{\rm q}$  is computed numerically from the exact result, Eq. (8).

Speci cally, its tem poral Fourier transform is given by the formula

where the column vector j z i is de ned as ha j z i =  $\frac{1}{2}$  [%]  $_{ij}$  0. In the lim it ! 0, our result reduces to the form obtained by non-conserving approximation [12], when the energy spectrum has particle-hole symmetry at the Ferm i energy. However, for energies > 0 or in the absence of particle-hole symmetry, one must use the general result, Eq. (8). Note that, by incorporating the mixing of the particle-hole and particle-particle degrees of freedom, 0 accounts for, for example, the elect of any two-particle, spin-triplet excitations [13] at the momentum Q. Similar calculation shows that no resonance develops for the charge response near q = Q.

The most favorable conditions for observing these excitations are most likely found in underdoped high- $T_{\rm c}$  superconductors close to the antiferrom agnetic phase boundary. In the antiferrom agnetic phase, the above collective mode is replaced by the Goldstone mode of the antiferrom agnet. Interestingly, for  $U^{>}V_{0}$ , the system is unstable against a spontaneous creation of quasiparticle-quasihole virtual bound states at q=Q. This implies a phase transition to an antiferrom agnetic state. In contrast to d-wave superconductors, the W ard identity [3,11] excludes the spin-density-wave collective mode in conventional superconductors with a momentum independent gap function.

To obtain a quantitative understanding of the dispersion relation of the collective mode, we resort to num erical methods. Figure 1 shows the energy of the spindensity wave as a function of wave vector near half lling with hole density equal to 10%. The minimum value of the excitation energy,  $_{\rm q}$ =2  $_{\rm 0}$  ′ 0.08, is located at the wave vector q ′ (0.95 =a; =a), in plying that the

superconductor becom es un stable against a spontaneous creation of an antiferrom agnetically ordered state with vertical (horizontal) antiphase domain walls. In contrast to neutron scattering data [6] in superconducting  $\text{La}_{1:6} \ _{x} \text{Nd}_{0:4} \text{Sr}_{x} \text{CuO}_{4} \text{ which show that the mean separa-}$ tion 'between antiphase domain walls should scale with the hole density x as '' a=2x, we nd that ' is m ore than by a factor of two longer than the experim ental one. (In the present approximation, 'also depends on 0.) The failure to predict correctly the dom ain-wall periodicity is sim ilar to the problem of describing the static, incomm ensurate stripe order in the Hartree-Fock approximation [14]. A Ithough at zero tem perature exciting vertical spin-density-wave uctuations requires the least amount of energy, the rotation of their orientation relative to the underlying lattice constitutes a relatively soft mode; see Fig. 1. For example, the excitation energy at the saddle point  $q = 0.98Q_0$  is about 60% larger than the m in im um energy required to excite a verticalm ode. The form of the dispersion relation  $\ _{\text{q}}$  is a ected by the lifetim e e ects: the troughs clearly visible in Fig. 1 m ark the boundaries between damped (  $_{\rm q}$  >  $\#_{\rm q}$ ) and undamped (  $_{\rm q}$  <  $\#_{\rm q}$ ) excitations. For example, the excitations with  $q = Q_0$ and  $0.940_{0}$  are undamped whereas the excitation with  $q = 0.97Q_0$  is dam ped.

Figure 2 illustrates the behavior of the im aginary part of the spin correlation function, Eq. (8). The collective excitation produces a distinctive resonance structure in (q; ) at energies speci ed by the dispersion relation, q. At low energies, the resonance becomes narrower as the excitation energy q decreases. However, in the vicinity of the (=a; =a) point, for example, the collective excitation appears below the onset energy of the two-particle continuum #q. A coordingly, the collective excitation would acquire an in nite lifetime yielding a resolution-limited peak in  $^{0}(q;)$  also, below this onset energy, the usual quasiparticle contribution to  $^{\circ\circ}$ (q; ) would vanish | if the lifetime of quasiparticles were in nite. Clearly the collective mode is an important new feature describing the low-energy spin correlation function [15].

In a d-wave superconductor, strongly-scattering im purities induce virtual bound states [16] by modifying the local potential energy of electrons at the impurity site. In addition, they may also change local Coulomb interaction between electrons at the impurity site. Such an e ect can be accounted for by including the term  $U_{im p} n_{r_0} n_{r_0 \#}$ , where  $r = r_0$  is the location of the  $im - r_0 m$ purity. A straightforward calculation shows that this e ect leads to a virtual bound state with the energy Ž U<sub>c</sub>=U<sub>im p</sub> 1, where  $U_c$  $1= N_F$  . In  $\infty n$ trast to an impurity potential, the impurity interaction has a critical value Uc, below which the ground state is nonmagnetic and the spin quantum number of the resonance state equals to  $\frac{1}{2}$ , and above which the impurity becomes magnetic in the sense that one electron spin is




FIG. 2. The imaginary part of the spin correlation function  $^{\odot}(q;\;)$  as a function of (a) the wave vector q with =2  $_0=0.13$  and (b) and  $q_x$  with  $q_y==$  a at zero temperature for U=W = 0.485 and V1=W = 0.608. A small broadening of resonances is obtained by sum ising a nite energy resolution of magnitude =W = 3  $10^3$  due to quasiparticle lifetime e ects. Here, the superconducting energy gap is  $_0$ =W = 0.1 and the chemical potential is chosen so that the density of holes equals 10% (relative to half lling).

trapped to the impurity site.

Finally, one may ask whether excitonic states of bound pairs of quasiparticles are feasible in d-wave superconductors. It is im mediately clear that while the elective interaction has an attractive partial wave in the (extended) s-wave channel, it is nevertheless too weak near half lling to support any excitons with the same angular quantum number. It is only far away from half lling that these states might appear as virtual bound states because of the proximity to a superconducting state with extended s-wave symmetry.

In conclusion, we have shown that d-wave superconductors can support propagating collective modes that are best described as spin-density waves. It is then natural to anticipate that the most favorable conditions for detecting them are found close to the antiferrom agnetic phase boundary. Furthermore, superconducting uctuations couple particle-hole and particle-particle excitations allowing the latter ones to be probed by the usual means. This coupling is particularly in portant if the two excitations are (nearly) degenerate.

- [15] Further contact with experiments [6] can be made by noting that in purity moments pin the spin-density-wave mode leading to a frozen spin order. The resulting incommensurate, elastic peaks in magnetic scattering are expected to disappear at a temperature  $T_{\rm p}$ , which scales with the binding energy and therefore decreases as  $_{\rm Q}$  increases. Thus,  $T_{\rm p}$  decreases with the increasing hole density.
