The edge theory of ferrom agnetic quantum Hall states

Abstract

We propose an elective low-energy theory for ferrom agnetic Hall states. It describes the charge degrees of freedom, on the edge, by a (1 + 1) dimensional chiral boson theory, and the spin degrees of freedom by the (2 + 1) dimensional quantum ferrom agnet theory in the spin-wave approximation. The usual chiral boson theory for spinless electrons is modiled to include the charge degrees of freedom with spin. Our total, bulk plus edge, elective action is gauge invariant and we ind a generalized "chiral anom aly" in this case. We describe two, charged and neutral, sets of edge spin-wave solutions. The spreading of these waves is much larger than the one for the charge (edge) waves and they have linear dispersion relations.

I. IN TRODUCTION

The bulk properties of the quantum Hall system s at lling fraction 1=m, m = odd, in the presence of low magnetic elds have been subject of many theoretical and experimental investigations in recent years. The spin degree of freedom plays an important role in these system s. Here we focus on properties of the boundary of these system s, which, in a special way, reject bulk properties. In the spinless case this rejection was already described by W en [1]. The low-energy (bulk) physics of these systems is identical to the one of 2D quantum ferrom agnets with spin waves as excitations. Due to exchange the spins of electrons in the ground state are all aligned in the same direction and the low est lying excitations are one-spin-ip (spin wave) excitations which leave the charge of the system unchanged. The low est lying charged excitations are topologically non-trivial skyrm ion excitations [2] for which a local change in the charge density that characterizes them, is accompanied by a local change in the spin density. This scenario, in which a nite number of overtuned spins follows the creation of the charged excitations is supported by experimental ndings [3].

On the other hand the physics of the boundary of quantum H all system s w ithout the spin degree of freedom is well understood [1]. In fact for any quantum H all system, including the one which edge physics we would like to understand, it is expected that the charge dynam ics is reduced to the edge of the system. This is maybe an oversim plication with respect to a general experimental situation where sharp edges (i.e. edges with steep con ning potential) are not always present. Still the elective one-space-dimensional edge theory - chiral boson theory of quantum H all systems has received considerable experimental support in recent years.

Here we present a low-energy e ective theory of quantum Hall ferrom agnetic systems which describes the charge degrees of freedom restricted to live only on the edge and lowest lying excitations of the bulk - neutral spin waves. We show that, under special conditions (and as solutions of the theory), edge spin waves exist, whose characteristic width is sm aller than the one of bulk spin waves, which spread throughout the whole system. These excitations, edge spin waves, are characterized by gaps which are sm aller than the Zeem an gap and linear dispersion relations. We not two classes of these waves, wich we call, charged and neutral edge spin waves. O ne way to induce the charged edge waves is to subtract or add som e charge to the edge. By a redistribution of the charge and, sim ultaneously, spin of the system on the edge (in the manner of spin textures as described rst in [2]) neutral edge spin waves are possible.

II.EFFECTIVE LOW -ENERGY FIELD THEORY W ITH CHARGE DEGREES OF FREEDOM ON THE EDGE AND SPIN WAVES

In this section, we will rst rederive the edge theory for spinless electrons [1] using the dual form of the Chem-Sim ons eld-theory description of quantum H all systems (at lling fractions 1=m where m is an odd integer. Then we will use the dual form of the Chem-Sim ons form ulation of the ferrom agnetic quantum H all systems (at the same lling fractions with the spin degree of freedom taken into account) to derive a low energy elective theory which describes not only the edge of these systems, but also low est lying excitations in their

bulk - spin waves. At the end we will dem onstrate the gauge invariance of our total, bulk plus edge, action when perturbing external electrom agnetic elds are present in it.

A. The edge theory of spinless quantum Hall system s

The system s that we consider are at lling fractions 1=m where m is an odd integer. We start with the dual form ulation of the Chern-Sim ons elective description of these systems. In the Chern-Sim ons form ulation the problem of the 2D electron system in magnetic eld is mapped to a problem of bose liquid with a long-range interaction described by a statistical gauge eld. The vortex excitations of the bose uid correspond to the quasiparticle excitations of quantum H all systems. In the dual form the vortex excitations (i.e. uxes of the gauge eld in the preceding form ulation) are viewed as particles, and the charge -current density becomes ux of some new gauge eld. The rst terms of the Lagrangian density in the dual form are:

The third term couples the vortex current-density J^v; = 0;1;2,

to the gauge eld A (according to the interchanged roles of uxes and particles). In 2.3 is the phase of the bose eld in the form er (non-dual) formulation and the vortex current-density is non-zero only if is a nonanalytic function of coordinates i.e. $0 \in 0$ for some and .

If our system has a boundary the action for a general gauge transform ation A !A + @ for which is not zero at the boundary is not gauge invariant (i.e. charge conserving). Any electric eld along the boundary will produce a current norm all to the boundary because of the nonzero value of the Hall conductance. But with restricted gauge transform ations for which = 0 on the boundary we may use this action to derive, as was already done in [1], the kinetic term of the edge theory Lagrangian. These gauge transform ations describe a well-de ned boundary problem, in which some of the physics of the quantum Hall system s due to perturbing external electrom agnetic elds is not present. N am ely, by making all previously gauge dependent quantities on the edge gauge independent i.e. physical, we are deriving an elective edge theory that gives the right physics when charge exchange between the bulk and edge is absent [4,5]. (W e defer description of the total action with perturbing electrom agnetic $% \left({{\mathbb{R}}^{n}} \right)$ elds which is explicitly gauge invariant to subsection II C .)

First we neglect the last term in 2.1 (as a higher order term in derivatives), regard the equation of motion for A_0 as a constraint, and take $A_0 = 0$. The constraint is

simply saying that any deviation in the charge density of the system is due to the creation of vortices. The solution of this equation, up to a gauge transform ation is

W e assume that there are no vortices in the bulk of the system so that is analytic. When we plug in the solution 2.5 in the remaining term of the Lagrangian (we do not consider the term with A^{ext}):

exactly the kinetic term of the chiral boson theory, if we consider the system to be de ned in the lower half-plane with y = 0 as a boundary. We get only the kinetic term of the edge theory because we started from the theory in which we neglected term s that bring dynam ics. We might expect that the following term in small momentum expansion on the edge is

with a nonuniversal coupling v. This term gives dynamics to the edge theory and together with 2.8 m akes the chiral boson theory Lagrangian density. Thus, we can conclude that the eld - phase of the bosonic eld in the standard Chem-Sim ons formulation on the boundary plays the role of the chiral boson eld.

B.E ective low -energy eld theory of ferrom agnetic quantum H all states

The Lagrangian density of the Chern-Sim ons theory for ferrom agnetic quantum Hall states in the dual form is [6,7]:

A gain the charge current-density as a function of the statistical gauge eld A is given by the relation 2.2. Now quasiparticle current-density consists of two contributions: vortex and skym ion: $J = J^v + J^s$. As before vortex excitations do not change the spin con guration of the ferrom agnetic H all states. Skym ions, on the other hand, which lie lower in the energy spectrum, represent excitations followed by reversal of electron spins in the system. The vortex current-density is given by 2.3 where again is the phase of the bosonic eld of the standard Chem-Sim ons form ulation, and the skym ion current-density [6,7] is:

The eld z is the two component spinor of the standard Chem-Sim ons formulation [6], in which the bosonic eld is decomposed in an amplitude, phase, and spinor part:

The spinor part describes the spin degree of freedom of the bosonic eld associated with the original electron eld.

The fourth, extra term with respect to spinless case in the Lagrangian density is the nonlinear sigm a model term with $n = \overline{z} \cdot z$, where x; y; and z are Paulim atrices. s is the stiness constant. This term represents the cost in the exchange energy when the ground state ferrom agnetic con guration is modiled.

The fifth term is the Zeeman term with constant $= \frac{g_B}{2}B$ where B is the external magnetic eld.

To get the low-energy, e ective theory which includes the edge physics, we repeat steps that we described in the previous subsection in the spinless case. The constraint equation in this case, as we vary A_0 is:

Now we assume that is analytic so that no vortex excitations in the bulk are allowed. We do not make any restrictions on z. By plugging in the solution 2.14 in the begining Lagrangian 2.10 with $A_0 = 0$ and without the second and the last term we get surface term s:

The eld can not be found anym ore in the bulk Lagrangian. Therefore pure charge degrees of freedom i.e. those that are not followed by a change in the spin con guration are now

restricted to live only on the boundary of the system. (This coincides with the microscopic physical picture that we have of these systems. The pure charge (quasihole) excitations, which lie higher in the energy spectrum than skyrm ion excitations, in the bulk, can be found in the low energy approximation on the edge of the system. There, on the edge, their excitation energy is smallest (in fact goes to zero). [8]) In 2.15 we see the most important result of this derivation, namely a nontrivial coupling between the spin and charge degrees of freedom on the edge of the system.

In the bw-energy approximation that we make (i.e. neglecting the last term in 2.10) we nd that the charge current is equal to the sum of skyrm ion and vortex currents. A swe do not have vortex currents in the bulk of the system, the condition that the skyrm ion current norm alto the boundary is zero is equvalent to the dem and that the charge current norm al to the boundary is zero. In the absence of any external electrom agnetic elds besides the uniform magnetic that de ness the problem, we will require that no charge can leave the system i.e. the skyrm ion current norm alto the boundary is zero. In that case

By considering couplings with external elds we may also conclude that these gauge-invariant expressions up to some appropriate constants represent charge density and current on the edge similarly to the the spinless case. Then 2.21 form ally expresses the physical fact that the charge current and density on the edge have contributions followed by changes in the spin con guration on the edge. Therefore we expect that under inclusion of a charge-density interaction term (which describes the dynamics on the edge) so that the Lagrangian density is

we have a complete low-energy description of the charge degree of freedom on the edge. The equation of motion for on the edge simply tells us that the charge on the edge drifts with velocity v along the edge in only one direction as it should be in a quantum Hall system.

W e neglected the term s of order higher than two in ; the single condition 2.29 ensures that all of them are zero at the boundary.

positive, satisfy the equation in the bulk, but the condition 2.29 forces to be zero. Therefore, in the case of a pure quantum ferror agnet, the constraint of the spin conservation on the boundary, does not allow the existance of the edge spin excitations.

Now, we will sum marize our e ective theory for a quantum Hall system with a boundary, having in mind the speci c geometry in which the system is in the lower half of the plane. The bulk Lagrangian density (in the spin wave approximation) is given by

In our previous derivation we assumed that only the vector potential of the constant magnetic eld is present in 2.40 and, therefore, the eld A did not have any dynamics; by the equation of motion of the action it was constrained to satisfy m ${}^{ab}\theta_a A_b = {}^{ab}\theta_a A_b^{ext}$. Because of the absence of the perturbing external electrom agnetic elds the whole dynamics of the system was on the edge described by the chiral boson theory (the rst two terms in 2.42).

III. SOLUTIONS OF THE FIELD THEORY

W hen (f = 0; = 0; x i.e.) there are no charge excitations on the boundary, the spin waves 2.32 are solutions of the bulk and surface equations. W hen = 0, i.e. there are no spin excitations in the system; the only solutions of the equations are charge density waves of the chiral boson theory.

respectively. For $f = f(x + v_c t)$, the general solution of 3.1, we have

A.Charged edge spin-wave solutions

The solution of the form 2.36 of the equation 3.6 with = const exists only if j_0 is, by itself, a constant, i.e. if there is a constant charge density along the boundary of the system. For the ground state $j_0 = 0$, and the previous condition (with $j_0 \notin 0$) means that some (extra) charge is added to ($j_0 > 0$) or subtracted from the system ($j_0 < 0$). Plugging in the form 2.36 into 3.6, and using 3.3, we obtain the following candidates for solutions with equal to

For $j_0 ! 0$ the second solution is unacceptable because our elective theory assumes (spatially) slow by varying quantities, which is not the case with the solution with large.

A lso, we may notice boking at 3.8 asymmetry between $j_0 > 0$ and $j_0 < 0$ case. One way to understand the asymmetry is to rst consider the single particle picture of adding and subtracting charge to the edge of these systems. In this picture of systems without spin, adding or subtracting charge is always equivalent to simple shifts (translations) of the boundary. In the case of the systems with spin there is an additional possibility to add charge as shown in Fig.1.

We believe that this single particle picture is behind the many body state - charged edge spin-wave for $j_0 > 0$. This can be supported by the following consideration. First, we may try to interpret the solution as a solution of a generalized pure-spin (quantum -ferrom agnet) problem, in which the second and third term in 3.6 correspond to some surface terms in that problem. For a nite Zeem an coupling and in the small-momentum approximation, the solution with $j_0 > 0$ corresponds to the following term:

with an electric magnetic eld $B_{eff} = (\frac{j_0}{0})B$ on the boundary. As we add electrons, we electricity create a magnetic eld in the opposite direction of the external magnetic eld. This magnetic eld makes possible the creation of the spin edge solution. As we add more electrons (j_0 larger) the electric magnetic eld increases in its magnitude and favors edge spin waves localized near the boundary (larger). Therefore the edge-spin-wave, one-spin

ip will be more localized on the boundary if there are more pairs (see Fig.1) each of them energetically unfavorable because each of them consists of two electrons in the same orbital.

The corresponding term (in the pure-spin problem) for the second solution (with $j_0 < 0$) is

It is of the opposite sign than the gradient term in the bulk and, therefore, favors the solution which disorders the spin con guration of the ground state and, we expect as it is usual in these systems, that it is also followed by a redistribution of the charge on the boundary.

We also expect that these charged edge spin-waves can be created without any change in the total charge of the system i.e. by simple redistributions of the ground-state charge on the boundary where j_0 is a parameter that characterizes them. Therefore, when considering the total energy of excitations we will neglect the energy term of the chiral boson Lagrangian. Then the surface contribution is

Because $_0 = \frac{1}{2 \text{ m}}$ the last term in 3.13 is always negative, and at $k = 0 \text{ E}_{tot}$ is always lower than the constant Zeem an term . When 3.8 is substituted for in the expression 3.13, the energy 3.13 is of the following form

(where c's do not depend on k). By having a linear term in k this dispersion relation is asymmetric around k = 0.

B.N eutral edge spin-wave solutions

We de ne the neutral edge spin-waves by requiring that the eld , which lives on the boundary, associated with pure (not carryng also spin) charge degrees of freedom, is zero (=0). As a consequence there is one less surface equation to be satis ed, because the constraint equations 3.1 and 3.2 can not be satis ed simultaneously. And, as we will see, the constraint also implies bosing one of the two (charge and spin) local conservation laws. N am ely, local spin currents norm alto the boundary will be nonzero in general. It will be also shown that these excitations are neutral i.e. the total change in the charge of the system, when these excitations occur, is zero.

W ith the condition = 0 the charge current and density on the boundary are proportional to

These charge degrees of freedom must satisfy 3.1, and from that it follows that the dispersion relation for the waves is $w = v_c k$. This dispersion relation follows when a general solution that is a superposition of the waves of the form 2.36 is considered. The frequency of the wave is also equal to 3.3. This enables us to nd in this case. It is given by the following expression

i.e. in the small-momentum approximation $\frac{q}{\frac{1}{2}s}$. But the waves do not satisfy 32, which, in the spin-wave approximation, is equivalent to the condition 2.29. This means that the spin currents normal to the boundary of the system are, in general, nonzero and exchange of the spin of the system with outside is allowed. Nevertheless, $J_y^3 = 0$ (see 2.35) everywhere on the boundary and, also, the total spin of the system is conserved, i.e.

A lthough the bulk excitation energy ($w = v_c k$) is gapless, these excitations have a gap. To see this we have to calculate their total energy and include the surface contribution 3.11, with given by 3.16. As a nalresult we have:

The requirement $E_{tot} > 0$ for each k xes the allowed range of the parameters in 3.18 and in the theory. The excitations are allowed to propagate in both directions, though, the spectrum is assymetric around k = 0 because of the presence of the linear term in E_{tot} . The gap (the sm allest excitation energy for certain k) of these excitations is always sm aller than the Zeem an gap.

To prove the neutrality of these excitations we start with a general edge spin-wave solution:

In the spin-wave approximation we have

C learly, the total change in the charge of the boundary,

is of the same amount, but of opposite sign than the one in the bulk ($Q_{bulk} = \frac{R_{+1}}{1} dx \frac{R_0}{1} dy_{bulk}$ (x;y;t)).

At the end of this section we would like to comment on the nature of these neutral edge spin waves. As they are completely skymmionic, their charge is fully specified by their spin con guration. Their spread increases with the decreasing of the Zeem an energy, which is well known skymmion property. As they carry xed (unit) amount of spin they vanish when the Zeem an coupling is zero. Due to the close relationship between their charge and spin and linearity of the chiral boson dispersion relation, the dispersion relation of these spin waves is also linear.

IV.CONCLUSIONSAND DISCUSSION

In conclusion, we proposed an elective edge theory for ferrom agnetic quantum Hall states. It describes their (1 + 1) dimensional charge degrees of freedom by a chiral boson theory and their (2 + 1) dimensional spin degrees of freedom by the elective theory of a quantum ferrom agnet in the spin-wave approximation. We found two classes of the edge spin-wave solutions. The class with the charged edge spin waves is obtained by removing or adding electrons to the edge of the system. The second class of the neutral edge spin waves does not require any change in the total charge of the system. A llthese edge spin excitations are characterized by linear dispersion relations and gaps in the excitation energy.

We did not consider most-general surface terms for the spin degrees of freedom which would be present in a most-general theory, because we wanted to emphasize and exam ine the in uence of the terms that describe the charge degrees of freedom. The latter terms, collected in the chiral boson theory, give a complete elective description of the charge degrees of freedom on the edge.

Ref. [9] pointed out that for small Zeem an energies and soft con ning potentials a reconstruction (from narrow and spin polarized edge) to the edge with spin textures should occur. Because of our assumption of the edge with the same polarization as that of the bulk, our theory is valid only for steep enough (see for estimates in [9]) con ning potentials.

At the end we would like to comment on the relationship between our work and the recent work concerning edge excitations and edge reconstruction at = 1 [10]. There,

the Hartree-Fock procedure was used to determ ine the energy spectrum of some proposed edge spin- ip excitations. (In fact a special form of these excitations was not suggested in Ref. [11].) These excitations reconstruct the edge when the Zeem an energy is sm all and the con ning potential softened. They are followed by an outward movement of charge and exist even at zero Zeem an energy. The latter property is not shared by our neutral edge excitations and charged edge excitations for $j_0 > 0$ and therefore, they should not be confused with the ones of Ref. [10]. (The neutral edge waves even require, as we described, special boundary conditions to exist.) On the other hand the detailed description of the charged edge excitations for $j_0 < 0$ (which can be associated with the outward movement of charge) is impossible in the scope of our theory. The theory gives only an inkling of the possible instability of the ground state with respect to their creation.
