On the distribution of the total energy of a system of non-interacting ferm ions: random matrix and sem iclassical estimates

Abstract

We consider a single particle spectrum as given by the eigenvalues of the W igner-D yson ensembles of random matrices, and ll consecutive single particle levels with n fermions. A ssum ing that the fermions are non-interacting, we show that the distribution of the total energy is G aussian and its variance grows as n² logn in the large-n limit. Next to leading order corrections are also computed. Some related quantities are discussed, in particular the nearest neighbor spacing autocorrelation function. C anonical and grand canonical approaches are considered and compared in detail. A semiclassical formula describing, as a function of n, a non-universal behavior of the variance of the total energy starting at a critical number of particles is also obtained. It is illustrated with the particular case of single particle energies given by the imaginary part of the zeros of the R iem ann zeta function on the critical line. I. IN TRODUCTION

Consider a system of n interacting ferm ions. The ground state total energy m ay offen be well approxim ated by m acroscopic m ethods, a prototype of these being the Thom as Ferm i approxim ation. A side from the well-known expansion containing the volum e energy, surface energy, etc, these m ethods can be further in proved by the inclusion of additional system atic quantum e ects, like for example shelle ects related to some symmetries of the system (see for instance [1]). Once all these contributions have been taken into account, one would like to have some estimate of the remaining \irreducible" discrepancies between the calculated and m easured total energies due to non-system atic e ects. These discrepancies m ay be viewed as uctuations observable as some parameters of the system are varied, like for example the total num ber of particles or any other relevant external parameter.

On the other hand, it has been established that statistical properties of system s whose classical analog is chaotic are well described by eigenvalues of ensembles of random matrices (see for instance [3]). It seems therefore reasonable to suggest that an extrem e estimate of the above mentioned uctuations may consist of modeling the single particle spectrum by the spectrum of a random m atrix of the W igner-D yson type. This may be a crude approxim ation because the statistical properties of the low -lying energy levels of the single particle sequence m ay not be well described by a random matrix approach. A nother shortcoming of such a model is connected to the fact that, for simplicity, we x to a constant the average density of single particle states, and ignore its variations with energy. In its simplest version, the m odelm ay apply either when only properties around the Ferm i level are considered or when particles are enclosed in a 2-dimensional box. However, inclusion of a variation (increase) of the density of single particle energies can be taken care of. This model may also be relevant in studying the energy distribution of system s of interacting ferm ions trapped in a chaotic enclosure, like for example the variations of the total energy of n electrons contained in a quantum dot as the shape of the dot is varied by some external potential or the variation produced when varying a magnetic eld.

To be speci c, consider an ordered sequence of energy levels $x_0 < x_1 < :::< x_i < :::$ Let s_1 ; s_2 ; s_3 ; ::: be the distances between consecutive eigenvalues,

We assume that the sequence is stationary and we set the mean spacing D to one. We are interested in the statistical properties of the \ground state" energy X_t of a system of n non-interacting ferm ions resulting from adding the \single particle" energies x_i of the i = 1;2; :::;n occupied states

where x_0 has been taken as the energy origin. Consider now an ensemble of single particle spectra which for the moment we let unspecied. We expect under very general conditions the probability distribution of X_t to be Gaussian in the large n limit. This, by the central limit theorem, is obviously true for a set of uncorrelated levels. For (correlated) eigenvalues of Gaussian ensembles of random matrices this has also shown to be true, in fact in a more general context [4]. As a numerical illustration, Fig. 1 displays the probability distribution of X_t for n = 300 computed for a Gaussian orthogonal ensemble of random matrices. Our purpose is to derive expressions for the average and the variance of X_t , thereby specifying completely the \ground-state" energy distribution.

The rst physical situation we consider is when the number n of particles is xed. This case, which we call \canonical" by analogy to conventional statistical mechanics, is treated in section II. From the mathematical point of view it is related to the autocorrelation function of consecutive spacings, a poorly known quantity which is not a two-point measure. Another possibility is to consider the typical uctuations of the total energy of the occupied levels contained in an energy interval of given length. In this case the number n of levels uctuates from sample to sample around its mean value. This alternative \grand canonical" problem will be treated and compared to the canonical one in section III. The grand canonical case has the advantage of being expressible in term softhe spectral two-point correlation function. A sexpected we nd that both approaches give the sam e asymptotic increase of the variance of the total energy (proportional to $n^2 \log n$ in the large-n lim it).

The results of sections II and III correspond to the \universal regim e" as given by random matrix theory. In section IV we use standard sem iclassical techniques to show that generically for ballistic { as opposed to di usive [5] { systems there is a saturation e ect, namely a crossover from the n^2 logn to a n^2 growth of the variance of the total energy as a function of n. This new regime holds when the number of particles is larger than a system – dependent critical value and is accompanied by non-universal oscillations around the mean growth for which we give an explicit expression. To illustrate this point with a particular example, we have considered the unphysical but interesting in its own and explicitly com – putable case where the single particle energies are given by the imaginary part of the zeros of the R iem ann zeta function on the critical line. Section V summarizes the results and gives som e perspectives.

II. CANON ICAL VARIANCE

Statistical averages over the ensemble are denoted by the symbol hi. The mean value hX $_{\rm t}{\rm i}$ is

The main quantity of interest in this expression is the autocorrelation function I(k) of spacings of consecutive levels,

The stationarity of the spectrum in plies that I(k) depends only on the relative index k and that $hs_i^2 i = hs^2 i$, for all i. Performing the sum s over the index i

For n = 1 the variance takes the value $2(1) = hs^2 i$ 1. All the non-trivial information is contained in the autocorrelation of spacings; a detailed study of this function will be made in the next subsection. The extreme case of a uniform uncorrelated sequence of levels is particularly simple since I(j) = 1 for all j, and it follows from Eq.(2.2) that

W hen the nearest neighbor spacing distribution of the uncorrelated sequence is $P(s) = \exp(s)$ then $h_s^2 i_{1,1}$ in Eq.(2.3) is equal to 2.

A. The autocorrelation function of spacings I (j)

For G aussian ensembles (GE) of random matrices, the quantities entering Eq.(2.2) can be expressed as

where E (j;s) is the probability that a random ly chosen interval of length s contains exactly j eigenvalues [6]. The functions E (j;s) can be written in terms of an in nite product of the eigenvalues of an integral equation involving spheroidal functions and only numerical tables of these functions for low values of j and a limited range of s exist. Therefore the integrals in (2.4) cannot be computed analytically and explicit expressions for the I (j) are not available. Some numerical estimates of the integrals (2.4), to be used in what follows, are [6]

where = 1;2 and 4 denote the three types of GE, orthogonal (GOE), unitary (GUE) and symplectic (GSE) respectively. Numerical estimates of I(j) exist for low values of j. For instance, for j = 1 [6]

For our purpose the functions I (j) for arbitrary j are needed and the following ansatz

w ill be m ade. The constants in Eq.(2.7) are, in principle, dependent on the sym m etry class of the GE considered (=1, 2, 4). Eq.(2.7) is one of the basic equations of this paper. The simple functional dependence on j is consistent with the requirement that two su ciently far apart consecutive spacings should be uncorrelated. Moreover, general considerations suggest that odd powers of j m ay be excluded. A swe will now show, the three parameters entering Eq.(2.7) m ay be uniquely determined by requiring the correct asymptotic behavior of the uctuations in the length of an interval containing a xed number of levels.

Consider for that purpose the statistical uctuations in the length S of a spacing m ade of n consecutive nearest-neighbor spacings, $S = \sum_{i=1}^{X^n} s_i$. The spacing variance ² of S can be expressed in term s of the I(j) in the following manner

Would one have retained a 1=j term in the ansatz, the leading order term would have been of order n logn.

A di erent quantity, closely related to the spacing variance 2 (n), is the num ber variance 2 (L) de ned as the variance of the num ber of levels contained in an interval of given length L taken at random. This quantity is known analytically for the three G aussian ensembles and has in the large-L lim it the asymptotic behavior [6]

Consider now more carefully the relation between the spacing and the number variances. The values that the number variance takes at integer values of its argument are, for large n, related to the spacing variance through [8]

This equation indicates that: (i) as expected from their de nition, the leading order term s of both quantities coincide and, (ii) the next-to-leading order term s di er by a constant (1=6), irrespective of the symmetry class .

Eq.(2.14) completely determ ines all the unknown coe cients in Eq.(2.7). In fact, consistency with Eq.(2.14) in poses the following conditions in Eq.(2.11)

Using Eq.(2.5) these two constants take the values = 0.02027; 0.03013; 0.00997 and = 0.04483; 0.02550; $4 \ 10^5$ for = 1;2 and 4, respectively.

In order to test the accuracy of Eq.(2.7) we have computed numerically the autocorrelation function I(j) for orthogonal as well as unitary random matrices. As can be seen from Fig. 2 the agreement between the ansatz and the numerical simulations for = 2 is very good. Because the overall agreement is of similar quality we do not show the analogous curve for GOE. As an additional quantitative test let us mention that when expression (2.7) is evaluated at j = 1 it reproduces the values in Eq.(2.6) with a 1 10^3 error for any . This is remarkable if one keeps in mind that only asymptotic information has been used when determining the parameters in the ansatz (2.7).

In a previous study of the autocorrelation function of the spacings 0 dlyzko [9] has quoted a conjecture proposed by Dyson: I (j) $1 = 2^{-3}$ (see also chapter 16 in [6]). This ansatz coincides to low est order with Eq.(2.7). A side from considerations related to accuracy, let us emphasize that the inclusion of a term of higher order (like $1=j^4$ or $1=j^6$) in (2.7) is essential in order to obtain the correct asymptotic behavior for 2^{-3} (n) as well as, as we shall see later, for 2^{-3} (n). This is so because these higher order terms ensure the vanishing of the linear term in Eq.(2.11).

Eq.(2.7) is consistent with known relationships satis ed by the autocorrelation function. For example, the sum rule

valid for GE of random matrices [10] is equivalent to the condition A = 0 in Eq.(2.15) (i.e., the vanishing of the linear term of ² (n) [11]).

B.Variance of the total energy

We have now the necessary ingredients to compute the variance of the total energy. Replacing in Eq.(2.2) the ansatz (2.7) and using the de nition of the DiG amma and PolyG amma functions it follows that

Notice that, as it happened for 2 (n) with the term s of order n logn and n, the functional form of the ansatz (2.7) together with the m ethod by which the parameters , and have been determ ined insure the vanishing of the term s of order n³ logn and n³ of the variance of the total energy. That the remaining leading order behavior n² logn in Eq.(2.17) is correct is further con red by the fact that it coincides with the asymptotic result obtained from the linear statistic theory (see section III). This behavior is in contrast with the faster grow th of order n³ of an uncorrelated spectrum (cf Eq.(2.3)). The di erence is of course due to the rigid nature of the GE spectra.

Fig. 3 shows for GOE the comparison of numerical results with Eq.(2.17) for the variance of the total energy as a function of n. The overall agreement is good (for 50 the relative error is less than 2%). The theoretical curve is sensitive to the precise value of hs^2i which enters in the denition of and , and is known only up to the third digit (cfEq.(2.5)). For comparison we have also plotted in Fig. 3 the leading-order term of 2° , which clearly fails to reproduce accurately the numerical results in the interval of n displayed (the error is of the order of 10% at n 50).

In the previous analysis we have taken a single particle level (x_0 in (1.1)) as the reference energy. In some physical applications it m ay be more appropriate to measure energies with respect to an arbitrary origin, which will not coincide with a single particle level but rather will lie in a random position between two of them. As shown in Appendix A when this construction is adopted, namely lling n successive levels located just above this origin, Eq.(2.1) giving the mean value of the energy is modiled as follows n(n + 1)=2 ! $n^2=2$, whereas for the variance of the energy one has

Notice that both sides of (2.18) have the same leading order, though di erent coe cients for higher order term s.

III.GRAND CANONICAL VARIANCE

Here we treat a slightly di erent problem with respect to the previous section. Instead of xing the number of occupied levels, we consider an energy interval of given length 2L and compute the energy variance for the single particle energies $x_1; :::; x_n$ contained in it (to follow conventional notation, in this section we will denote the length of the energy interval by 2L, whereas in the previous section we were denoting it by L). The length 2L of the energy interval is now kept xed but the number n of levels contained in it may now vary from sample to sample. This is a particular example of a more general class of problem s usually called \linear statistic" in random matrix theory [12], dealing with the distribution of a variable W of the form

Here D is the mean level spacing (assumed to be constant; it will be set to one at the end), Y_2 the two-level cluster function, $b(k) = \begin{bmatrix} R_1 \\ 1 \end{bmatrix} Y_2(x) \exp[2i kx] dx$ the form factor and '(k) the Fourier transform of f(x)

(f (x) is assumed to be zero outside the interval [L;L]).

To compute the number variance via Eq.(3.3), one must choose f(x) = 1, as D yson and M ehta did. For our purpose, namely to compute the variance of the total energy, f(x) should be chosen as follows

In Eq.(3.4) we have chosen to measure the energy with respect to the lower (or equivalently upper) end of the energy interval considered. This, which is som ewhat natural and analogous to Eq.(1.1), is by no means compulsory and the reference may be taken at any given point of the energy axis. The variance of the total energy depends on the location of the reference point, them inimum being obtained when it is at the center of the interval. A general relation connecting the variance at di erent reference points is given in Appendix B.

Let us now consider the case of a large (average) number n of levels contained in the interval. Though we are using for notational simplicity the same symbol as in the canonical case, for grand canonical expressions n will mean the expectation value hni = 2L=D. Therefore, in contrast to the canonical case, it takes continuous values. Following Ref. [12], we split the integral in Eq.(3.3) in two parts

where we have used the parity of the integrand. The parameter is chosen such that 1=L 1=D. For k < , D k is always much smaller than one and the form factor can be approximated by [6]

On the other hand, for k > we have kL 1 and the function '(k) shows rapid oscillations as compared to the variations of the form factor. We then replace the product '(k)'(k) in the second term of the rhs. of Eq.(3.6) (denoted $V_E^{(b)}$) by its average value over k

Collecting the two terms we obtain the nalexpression for the variance which we express in terms of the average number n of levels contained in the interval and the constant C (cf (2.13)) (we put moreover D = 1)

Let us now compare grand canonical and canonical results. When the sequence considered is large (n 1), we expect the energy variance computed for a xed number n of occupied levels (², canonical) to be equal to the energy variance when the xed length of the energy interval contains on the average n levels (V_E , grand canonical). The comparison of Eqs.(3.9) and (2.17) shows that indeed to leading order $V_E = ^2$ (the same leading order behavior has been obtained in Ref. [13] for the particular case of GOE employing D yson B row nian motion). However the correction term s are di erent. It is interesting to note that the next to leading order corrections di er, as in Eq.(2.14) for the number and spacing variances, by a constant independent of

To conclude this subsection let us point out that exact expressions for the energy variance can be computed in the grand canonical approach for any value of n without assuming that it is large. For example for the unitary case (= 2) from the de nition Eq.(3.3), using Eq.(3.5) and the fact that

where Ci(x) and Si(x) are the CosIntegral and SinIntegral functions [7], respectively. V_E (n) grows like n^3 for n ! 0 (remember that here n is a continuous variable) and then switches to the n^2 log n behavior for larger values of n.

IV . SEM IC LA SSICAL TREATMENT: NON-UNIVERSALITIES

A.Chaotic System s

The strength and vitality of random matrix theories rely heavily on the universality of some of its predictions. As a counterpart it is poorly adapted to capture some system – speci c features. However special tools have been developed for that purpose to study system s whose classical analog is chaotic. Indeed, one of the important achievements of sem iclassical theories has been to determ ine the lim its of validity of the universal regime as described by random matrix theories by including system -dependent corrections [14]. Our purpose now is to adapt these methods, which have been developed for the form factor and are thus applicable to the grand canonical case, to the study of the variance of the total energy.

Our starting point will be Eq.(3.3) written in a slightly di erent form

Here K () = 1 b() and we have used the parity of the integrand. For simplicity we restrict in the following to system s having no time reversal symmetry (= 2). The results can be easily generalized to the other symmetry classes.

In the previous section we computed the universal behavior of the variance of the total energy by inserting in (4.1) the random matrix spectral form factor (cf Eq.(3.11) for the unitary ensemble). It is possible however to give a more accurate description of the form factor based on sem iclassical approximations. For system s having a classical analog the key ingredient is a formula expressing the spectral density (E) = $(E = E_j)$ as a sum over

the classical periodic orbits

Here h (E) $i_E = 1=D$ is the spectral average density of states, $A_{p,r} = T_p = \int \det(M_p^r - 1) j$ is an amplitude that depends on the period T_p and the stability matrix M_p of the primitive orbit p, r are the repetitions and S_p is the action [15]. We restrict our considerations to chaotic systems for which periodic orbits are isolated and unstable.

U sing Eq.(4.2) for the density of states Berry $[\!14]$ proposed the following form for K () for chaotic system s

where h is P lanck's constant and = TD =h is the (rescaled) time m easured in units of the H eisenberg time. The main physical ingredient entering this formula is a classical sum rule due to H annay and O zorio de A lm eida [16] which takes into account the exponential proliferation of long periodic orbits as well as their ergodicity. As a consequence of this as well as other sem iclassical considerations the form factor for times larger than a certain critical time becomes \universal" (i.e., coincides with random matrix theory). The situation is di erent for short periodic orbits which do not display this universality and whose contributions, explicitly written down in Eq.(4.3), produce system -dependent deviations from random matrix theory for < . U sually the parameter is chosen in order to satisfy min 1, where min = $T_{min}D$ =h is the rescaled period of the shortest periodic orbit.

The contribution of short periodic orbits to the variance of the total energy is obtained by replacing K () for < in Eq.(4.1), with the result

For times > we can repeat the same steps as in the previous section (the form factor coincides with GUE), with the important di erence however that now there is a cuto in the integral (4.1) at = . The variance of the total energy m ay now be written in the following form

 $V_E^{(2)}$ is the contribution to the variance due to the lower limit at = in the integral (4.1). A side from the system-dependent parameter , its functional form is general. $V_E^{(3)}$ is obtained from (4.4) using the explicit form (3.5) of the Fourier transform ' and contains detailed system-specie c information.

The energy variance as a function of the number of particles exhibits now two di erent regimes. For n $1 = V_E^{(2)}$ and $V_E^{(3)}$ are of order (n)² and can therefore be neglected. The energy variance is then given by the random matrix expression. For n 1 = these two terms can no longer be neglected and there is a crossover to a di erent regime, not described by random matrix theory. This is clearly seen for n 1 = when there is an alm ost perfect cancellation between $V_E^{(1)}$ and $V_E^{(2)}$, leading to

From Eq.(4.6) for $V_E^{(3)}$ we then see that now the variance instead of growing as $n^2 \log n$ like in random matrix theory, saturates and increases as n^2 . The prefactor is not constant but shows non-universal oscillations as a function of n described by the short-periodic-orbit contributions. In order to determ ine its average value over n we replace each oscillating term between curly brackets in Eq.(4.6) by its mean value (which is equal to one). Then, denoting this average by an upper bar

where the last sum extends over all orbits satisfying $rT_p < h = D$. An estimate of $V_E^{(3)}$ may be obtained by replacing this sum by an integral weighted by the density exp ($h_{K\,S}T$)=T over the period T of the periodic orbits ($h_{K\,S}$ is the Kolm ogorov-Sinai entropy) [15]. This approximation, which is not well justi ed in this regime of \short periodic orbits", will be shown however to give good results for the zeros of the Riemann zeta function (see next subsection). Then using the Hannay-O zorio de Almeida sum rule jdet (M_p^r 1)j! exp ($h_{K\,S}T$) one has

Thus in this approximation the average of the energy variance in the non-universal regime is determined by a single parameter, namely the rescaled period of the shortest periodic orbit.

Not only is the average of the energy variance determ ined by the shortest period. For $n = m_{in}$ the contribution of the term $\sin(nr_p)=(nr_p)$ in Eq.(4.6) is negligible for any p. Then, in this limit, each oscillating term within curly brackets is again equal to one and therefore the energy variance itself is given by the rh.s. of Eq.(4.9). In summary, in the non-universal regime the energy variance shows, superimposed to an n^2 growth, oscillations

whose am plitude is dam ped with increasing n. As the num ber of contributing term s in (4.6) dim in ishes, the structure of the oscillations becomes more regular and eventually only the lower frequencies survive just before the complete extinction of the oscillations.

It is worth noticing also that the dam ping of the oscillations is a rem arkable peculiarity occurring only when the reference point used to measure the single particle energies is at one border of the energy interval considered. For example, setting the origin at the center of the interval, no dam ping is found and the am plitude of the uctuations remains constant as a function of n. This latter behavior with non-universal oscillations of constant am plitude is sim ilar to what happens for the other two-point measures mainly considered so far, namely the num ber variance and the D yson-M ental least square statistic [14,17].

It would be valuable to test the previous results (and in particular Eq.(4.5)) as a function of n for a real physical system, like for example by locating of the order of 100 particles inside a billiard of nanom etric size as in the coulom b blockade experiments in quantum dots [18]. A nother possibility, not related to experiments but which can be explicitly computed, is the R iem ann zeta function.

B.Application to the R iem ann zeta function

This function constitutes a paradigm in the eld of quantum chaos. There are many reasons for that. On the one hand the density of zeros of (1=2 + iE) as a function of E may be expressed through the equation

The sum here goes over all the prime numbers p = 2;3;5;::: and $h \in i_E = 1=D = (1=2) \log (E=2)$ (we are system atically ignoring here problem s related to the convergence of the series). Eq.(4.10) has the same structure as Eq.(4.2) and this suggests a dynam ical interpretation of it. On the other hand, it has been shown numerically [9] and proved in some cases and demonstrated by heuristic arguments in others [19,9,14,20] that m any statistical properties of the critical zeros of that function coincide with the GUE results of random m atrix theory.

Because of the resemblance of the properties of the critical zeros of the R iem ann zeta function with those of the eigenvalues of a real chaotic system, and because of the possibility of performing explicit computations for that function, our purpose now is to use the imaginary part of the zeros as the \single particle spectrum " of some unknown physical system. As a rst test of the results obtained in this paper we have considered the nearest neighbor spacing autocorrelation function I (j) for a set of 50 000 zeros located around the 10^{12} th zero of (1=2+12) (the set starts at E₀ = 267653395648.8475:::) computed by 0 dlyzko [9]. The values of I (j) for low j, shown in Fig. 2, are in good agreement with those obtained from the total energy as a function of the number of occupied levels. Before presenting the results we need to compute explicitly the third term in the rhs. of Eq.(4.5), denoted $V_{E}^{(3)}$. An analogous contribution for the number variance of the R iem ann zeta function was already considered in [17].

By comparing Eqs.(4.2) and (4.10) one can see by analogy that the period of the period is should be idential to the logarithm of the prime numbers, $T_p = \log p$, and moreover h = 1. Then the rescaled period is $_p = \log p = \log (E_0=2)$ and, from (4.10), $\hat{A_{p,r}} = 2_p = (D p^{r=2})$. Then, as for any dynamical system, it is expected that K () behaves in a universal manner for >, while \sm all" prime numbers should contribute with non-universal terms for <. From the expression of $V_E^{(3)}$ in Eq.(4.6) and using the above mentioned identications we get

For the zeros we are considering we have $m_{in} = \log 2 = \log (E_0 = 2)$ 0.028. We then choose

= 0.2 for the num erical com parisons, which leads to a maximum prime num ber p_{max} = 131 in the sum in Eq.(4.11).

In order to magnify the e ect of non-universal corrections we have plotted in Fig. 4 the normalized quantity V_E (n)=(n²=2²) as a function of n (we set D = 1). The solid line represents the theoretical prediction (4.5) with the third term of the r.h.s. given by Eq.(4.11). Superim posed to this curve the norm alized variance computed num erically from the zeros of the Riem ann zeta function is also shown. The agreem ent between the num erical results and the theoretical prediction is remarkable and the two curves are alm ost indistinguishable. A loo displayed is the normalized GUE energy variance given by Eq.(3.12). The saturation e ect with respect to random matrix theory is clearly visible for a number of levels larger 5. For higher values of n som e oscillations are observed. These oscillations are than n well reproduced by the prime-number contributions (4.11). As predicted by the theory a damping of the oscillations is observable and illustrated in the inset in a wider range and on an expanded scale. The theory and num erical data are again in perfect agreem ent. For large values of n the curve tends to the constant 4:60, which is in very good agreem ent with the theoretical value given by Eq.(4.9), 1 $\log_{min} = 4:56.$

It is also interesting to display as a function of n the behavior of the canonical energy variance ² for the zeros of the R iem ann zeta function. As was mentioned in the introduction, this variance is not a two-point measure and therefore the sem iclassical theories developed for the form factor do not apply. We could again expect that, even in the non-universal regime, for a large number of particles the canonical and grand canonical variances are very closely related. Fig. 4 shows that indeed this is the case. The normalized energy variance ²=(n²=2²) presents the same non-universal oscillations in the saturation regime as V_E (shifted how ever to a low er average value). The non-universal features in ² imply via Eq.(2.2) their presence in the autocorrelation function I (j). This is con med by a study of 0 dlyzko who has observed signi cant oscillatory deviations with respect to random matrix theory for large values of j [9], attributed to e ects due to primes.

As can be seen in Fig. 4 the behavior of the two variances 2 and V_E is quite di erent for n sm all. This di erence is an (uninteresting) manifestation of the discreteness of n in the canonical case.

A ssum ing that the single particle spectrum is given by the eigenvalues of a random m atrix, we have determ ined the typical uctuations of the total energy of a system of noninteracting ferm ions. On the light of the original applications of random m atrix theory this approach m ay look at rst sight very unnatural. Indeed, these theories were originally applied to (nuclear) m any body system s in spectral regions and for properties unrelated to the m ean eld, like for example neutron resonances of the compound nucleus. Here we are som ehow adopting the opposite point of view, namely to start with an independent particle m otion m odeled by random m atrix theory and neglect completely residual interactions. Surprisingly, there are physical situations for which this extreme view seems also to be fruitful, as should become clear by the end of this section.

Two slightly di erent approaches have been investigated. In the rst one, denoted \canonical", we consider the uctuations of a xed number n of occupied levels. These uctuations are shown to be directly related to the autocorrelation function of consecutive spacings, for which we have proposed an ansatz. The parameters entering the ansatz have been determined from the asymptotic behavior of the uctuations of the spacing variance ² (n). The canonical variance of the total energy is then computed, including corrections up to order one. The leading-order term is found to be n² log n=(²).

In the second { \grand canonical" { approach, the total energy variance of the single particle levels contained in an interval of given length has been considered. C ontrary to the previous case, here the num ber of occupied levels is not xed. We have computed the grand canonical variance in the lim it of a large num ber of levels contained in the interval. A leo an exact result has been given for = 2. B oth variances have the same leading-order behavior, but the higher order corrections are di erent.

This di erence in the higher order term s, and more generally the connection between canonical and grand canonical quantities, have been studied in detail and play a central role in the present study. Among the form erwe have considered the spacing variance ² and the energy variance ², while the number variance ² and the energy variance V_E belong to the latter. The connection (2.14) between the spacing and number variances has been essential in implementing the ansatz (2.7). As already discussed in [8], Eq.(2.14), though asymptotic, remains a good approximation for any value of n. This is also con med by our results. In fact, computing the di erence to higher orders we nd

. In contrast, for the other two quantities Eq.(3.10) is not a good approximation for small n. Computing the difference to higher orders we nd

where the constants have been determined in Section IIA.

These relations between canonical and grand canonical quantities are those predicted by random matrix theory, and thus applicable in principle only in the universal regime (for example, Eq.(5.1) describes the di erence between the dot-dashed and the long dashed curves in Fig. 4). But suprisingly we nd that Eqs.(2.14) and (5.1) always hold, irrespectively of the regim e considered. This \universality in the non-universal regim e" is illustrated in Fig. 5 where both di erences for the zeros of the R iem ann zeta function are plotted (as we have m entioned before, a transition to a non-universal regim e appears for m 5), and presum ably it can be traced back to the validity of general incom pressibility conditions for a uid [21,8]. An immediate and interesting consequence of this observation is that the non-universal corrections for canonical quantities (for which no explicit theory is available) ought to be identical to those of grand canonical quantities. The consequences of this remark and in particular the presence of non-universal contributions in the behavior of the I (j)'s are under study.

The sim plicity of periodic orbit theory in the interpretation of physical phenom ena has demonstrated its power in di erent branches of physics. A well-known example is the prediction [22] and the experimental conmation in metallic clusters [23] of supershell e ects in the density of states which can be basically understood in terms of a beating produced by two short periodic orbits of a spherical cavity having similar lengths. For irregularly shaped clusters, for which our model may be a starting point, the possibility of having almost degenerate short periodic orbits is not excluded. However it is unclear how robust this situation may be under small perturbations, like for example the addition of particles to the system. As already mentioned, similar and perhaps more promising possibilities exist in the physics of quantum dots.

O ther systems for which the present study may be relevant concerned in usive systems in mesoscopic physics, like the motion of electrons in a disordered piece of metal. Due to the presence of impurities, in this case the dynamics of the electrons is not ballistic but rather described by a random walk. For short times the non-universalities are not related to short periodic orbits but to the return probability of a di usive motion. This can be incorporated in the short time behavior of the form factor [24]. In particular it does not lead to the saturation e ect discussed here and presum ably gives rise, for the variance of the total energy, to similar e ects as the ones observed for the number variance [25] which are governed by the di usion constant and the space dimensionality.

In nuclear physics there are some estimates of the uctuations of the binding energies due to non-system atic e ects. W hen the m acroscopic part as well as shell corrections are substracted out from the measured total energy it is found that the rm s. of the remaining uctuations is about 0.5 M eV for heavy nuclei [1]. Since the total binding energy for those nuclei is about 1000 M eV, the relative uctuations due to non-system atic e ects are of order $R_{exp} = 0.5$ 10^3 . W ith the present model, since n' logn = for = 1 andrf=2, we obtain a theoretical estimate of the relative uctuations R th < X ₊ > 7 10^{3} for n 200 which overestim ates the experim ental value by an order of magnitude. Before considering this disagreem ent as signi cant obvious e ects neglected here like the energy variations of the mean level spacing should be taken into account.

It will lie between two levels, denoted by x_0 and x_1 . Call $s_1 = x_1$ x_0 and d the (random) distance between x_1 and O. F ill the n successive levels located just above O and de ne the total energy X_t (n) with respect to O:

APPENDIX.B

The energy variance is not independent of the reference point used to measure the energy. In the grand canonical case, when an arbitrary point a is used as reference point, f(x) in Eq.(3.1) should be taken as

It follows from the de nition of the energy variance (3.2) and (B.1) that the variance V_{E_0} with the reference point at the center of the energy interval considered and the energy variance V_{E_a} with the origin at x = a are related through the equation

where 2 is the num ber variance. This is an exact relation valid for any statistical sequence of energy levels (uncorrelated, GE, etc).

Setting a = L in Eq.(B 2), using Eq.(3.9) and the asymptotic form of the number variance (2.12) we obtain for the variance with reference at the center of the interval

Because V_{E_0} and 2 are positive de nite, Eq.(B.2) shows, incidentally, that the energy variance reaches a minimum when the reference point is at the center of the interval.
