Form factors in the half- lled H ubbard m odel

W e consider dynam ical spin-spin correlation functions in the one dimensional repulsive half-lled Hubbard model. W e propose an exact expression for the two spinon form factor of spin operators. W e use this to derive the two spinon contribution to the dynam ical structure factor.

I. IN TRODUCTION

The calculation of dynam ical correlation functions is one of the main challenges in low dimensional theories of statistical and condensed matter physics. The large distance behaviour (corresponding to very low energies) can be e ectively extracted for critical theories by using bosonization or Bethe Ansatz and conform al eld theory techniques [1{4]. The results obtained in this way for m odels like the H eisenberg X X Z chain have been successfully applied to neutron scattering experiments of quasi-1D magnetic insulators, see e.g. 5,6]. However, from an experim ental point of view not only very low energies are of interest. In m agnetic m aterials described by the spin-1=2 Heisenberg model [5,6] the scattering continuum is m easured up to energies of twice the exchange, which is outside the realm of reliability of the above methods. It therefore would be useful to have a method for the calculation of (Fourier tansform s of) correlation functions at all energy scales. A nother setting that is outside the realm of the above methods are systems with a spectralgap, see e.g. [6{9]. Som e system s with spectral gap can be dealt with by the form factor approach to quantum correlation functions [10{13,9]. The advantage of this method is that it is in principle not constrained to very low energies. The form factor approach can also be implemented for critical systems, in particular this has been done for the Heisenberg XXX chain [14,15]. The results are useful for the analysis of the observed twospinon scattering continuum in magnetic insulators like $KCuF_3$. In the present paper we consider the problem of calculating form factors in the one dimensional half-lled Hubbard model. In a way this model is the \parent" of the Heisenberg model used for the description of the aforem entioned m agnetic insulators: the charge sector is gapped and the spin sector for large repulsion between electrons is described by an e ective H eisenberg H am iltonian. However, if the system is probed at energy scales of the order of the C oulom b repulsion e.g. by photoem ission experiments, which measure the single-particle spectral function, the itinerant nature of the system emerges and it is necessary to calculate correlation functions in the half-led Hubbard chain in order to describe the experiments. In the present context it is of particular interest to calculate form factors of the electronic creation and annihilation operators, as these results could be directly applied to the ARPES data of [16]. The easier problem of determ ining form factors of the spin operators in the Hubbard model is the subject of the present work.

W e consider the repulsive half lled Hubbard model [17]. The Ham iltonian is (U > 0)

This Ham iltonian exhibits an SO (4) symmetry [18], i.e. it commutes with the generators

The complete spectrum of low -lying excitations was determ ined in [19]. It consists of pairs of scattering states of four elementary excitations, which form the fundamental representation of SU (2) SU (2). There is a doublet of uncharged, gapless spin-1/2 particles called spinons. Their energy and momentum (as functions of the rapidity variable) are given by [20,19]

where $J_{0;1}$ are Bessel functions. The other two elementary excitations carry charge e but no spin. They are called holon and antiholon and have a gap proportional to U. Their energy and momentum are

II. DYNAM ICAL STRUCTURE FACTOR

In this paper we consider the dynam ical structure factor, which is the Fourier transform of the dynam ical spinspin correlation function and which is measured by inelastic neutron scattering. The form factor expansion is given by

where the labels $"_j$ enumerate the four possible elementary excitations. Our notation is the following: " = denotes a spinon with spin up/down, " = 1; 1 denotes an antiholon/holon. As excitations involving holons and antiholons have gaps the main contribution to the correlation function (6) comes from multi{spinon excitations. By virtue of related results obtained in other gapless models [21] we expect that the main contribution is due to excitations involving only two spinons. Because of the spin-SU (2) symmetry the 2-spinon contribution is of the form

 \mathbbm{W} e propose the following expression for the two-spinon form factor

Here c is the usual common constant factor in all form factors. We presently cannot determ ine its exact num erical value although it is possible to obtain an estimate by considering various sum rules. Let us now provide some evidence for the validity of (8). For integrable relativistic quantum eld theories one generically has a form factor expansion of the form (6), (7) for correlation functions of local operators. The form – factors them selves are determ ined by the following set of axiom s [10,11]

A xiom 1. The form factors have the symmetry property

A xiom 3. In the absence of bound states the only singularities of f($_1$;:::; $_n$) $_{"_1$;:::;"_n} for n 3 are at the points $_i = _j + i$, i > j. These singularities are rst order poles (annihilation poles) with residues

Here S () is the 2-particle scattering matrix of the theory under consideration. Although these axioms are based on crossing symmetry and relativistic energymomentum relations, there is evidence that the axioms hold true even for form factors of certain nonrelativistic lattice models. In particular, it was shown by Pakuliak [2] that the known form factors [14] of the XXZ Heisenberg lattice model full llA xiom s1–3. We believe that this will be true for integrable models of statistical mechanics and condensed matter physics as long as the ground state is a singlet under the action of an in nite dimensional symmetry algebra like a Yangian or U_q ($g_1^d(2)$). In particular, the form factor (8) can be seen to full lA xiom s1–3

We think that the fact that (8) fulls (12) is a good indication for the correctness of the $\minimal form factor"$ A (). The full result (8) can be checked exactly in the lim it U ! 1, where the half-led Hubbard model (1) reduces to the isotropic spin-1/2 Heisenberg chain

where the exchange is given by J = 1=U. The spinon form factors for thism odelhave been calculated in [14,15]. The dynam ical structure factor can be represented in the form (6), where the sum is over all spinon states. The 2-spinon contribution is [15]

It is a straightforward to see that in the lim it U ! 1 $S_2(!;p)$ indeed reduces to $S_2^{X \times X}$ (!;p). The U ! 1 lim it of "_s() and $p_s()$ is derived for example in [25]. We believe that (8) is correct for any value of U > 0. In [23] an independent derivation for form factors of ⁺ in the isotropic H eisenberg XXX chain (14) was given by using representation theory of a central extension of a double of the sl(2)-Yangian. For this purpose ⁺ can be represented as the density of one of the zeroth level Yangian generators (E₀ in the notation of [24]). Because the spin part of the Yangian [24] of the H ubbard m odel is the same as in the XXX case, we believe that the XXX result can be \lifted" to the half-lled H ubbard m odel in the way presented above.

In order to perform the integrals over $_{1,2}$ in (7) we need to discuss some properties of the continuum of twospinon excited states. Energy and momentum are given by

where $_{1,2} 2$ (1;1). The upper boundary is obtained by taking $_1 = _2$ and the lower one by taking $_1 = 1$. We denote the respective dispersion relations by $!_{U,L}$ (p). In Fig.1 we plot the 2-spinon continuum for U = 5.

In the rst B rillouin zone there is a unique solution (1; 2) to the set of equations

as long as ! is chosen within the interval (! $_{L}$ (p); ! $_{U}$ (p)). This allow sus to taken the integrals over $_{1,2}$ in (7) with the result

where (x) is the H eaviside function. Due to the com plicated relation between energy/m om entum and the spectral parameter we have not been able to sim plify (20) further. It is however in a form that can be readily analyzed num erically. Let us rst discuss constant m om entum scans, i.e. the behviour of S (!; p) as a function of ! for xed p. At the antiferrom agnetic wave vector p = the singularity at zero frequency is

The power-law behaviour in the !! 0 lim it agrees with the result obtained from nite-size corrections and conformal eld theory [1]. In Fig.2 we plot $S_{2q}(!;)$ on a logarithm ic scale. One can see that the $\frac{1}{!}$ $\log \frac{1}{!}$ behaviour holds even for relatively large values of !.

In Fig.3 we plot $S_2(0.3;p)$ as a function of the momentum p. Obviously the dynamical structure factor is nonzero only if intermediate states with energy ! = 0.3 and momentum p are available i.e. inside the dispersion of the 2-spinon continuum shown in Fig.1.

F inally, let us discuss consequences of our results for the attractive H ubbard m odel. It is known that the half-

led repulsive Hubbard model can be mapped to the half-led attractive Hubbard model by means of the unitary transform ation de ned by

under which H (U) goes to H (U) and the spin (2) and eta-pairing operators (3) get interchanged. The repulsive ground state is m apped into the attractive one [26], which in turn implies that the two spinon states considered above get m apped into the charge-wave states discussed in [19] (which have up to a shift in m om entum by the same dispersion as the two spinon states). As a consequence we can obtain from (8) the two charge-wave contribution to pairing and density-density correlation functions in the attractive half-led H ubbard m odel

where $n_m = c_{m,"}^y c_{m,"} + c_{m,\#}^y c_{m,\#}$. The analysis of the corresponding Fourier transforms is identical to the one carried out above for the dynam ical structure factor.

III. CONCLUSIONS

We have proposed an exact expression for the two spinon form factor of spin operators in the half-led Hubbard chain. We explicitly calculated the corresponding contribution to the dynam ical structure factor. Our proposal (8) can be extended to multispinon form factors of spin operators [27]. We think that very recent developments [28] in the calculation of form factors in integrable lattice models will make it possible to prove (8) rigourously and also lead to the determ ination of form factors of the ferm ion operators in the near future.
