# Exact G eneral Solutions to Extraordinary N -body P roblem s

The $N_{P}$ boody problem in which the force on the $I$ th body is $F_{I}=k{ }_{J} m_{I} m_{J}\left(x_{J} \quad x_{I}\right)=r^{3}$ where $r$ is the tim e dependent radius of the whole system is solved exactly for all in itial conditions. H ere, $w$ riting $\bar{x}$ for the position of the barycentre, $r^{2}=M \quad 1^{1} \quad{ }_{I} m_{I}\left(x_{I} \quad \bar{x}\right)^{2}$.

A lso solved are all N boody problem s for which the potential energy is of the form $V=V(r)$ for any function $V$ where $r$ is given above. The rst problem is the special case $V / r^{1}$. In all cases $r$ vibrates for ever, just like the radius to a body which has angular $m$ om entum about a centre of attraction due to the potential V (r). V iolent R elaxation does not occur in these system S . W hen r vibrates as in a highly eccentric orbit the exact solution should prove to be a useful test of N boody codes but a severer test follow s.

W e show further that when $F_{P^{T}}$ is supplem ented by an inverse cubic repulsion betw een each pair of bodies $k^{O^{0}}{ }_{J \notin I} m_{I} m_{J}\left(x_{J} \quad x_{I}\right)=\left(x_{J} \quad x_{I}\right)^{4}$ there is still no dam ping of the fundam ental breathing oscillation which perform $s$ its non-linear periodic $m$ otion for ever. $T$ his is a special case of continually breathing system $s$ w th potentials $\mathrm{V}_{0}(\mathrm{r})+\mathrm{r}^{2} \mathrm{~V}_{2}\left(\left(\mathrm{X}_{\mathrm{I}} \quad \mathrm{X}_{\mathrm{J}}\right)=\mathrm{r}\right)$.

A rem arkable new statistical equilibrium is found for system $s$ whose size is continually changing!

## 1. Introduction

In 1995 one of us (Lynden-Bell, R M . 1995, 1996) showed that the classical statisticalm echanics of system s of $N$ bodies interacting through m utualpotential energies of the form

could be exactly calculated for any chosen function F. By choige of a suitable fiunction $F$, she found a case $w$ th a sim ple phase transition which w as calculated for any N .

W hen the particles are of equalm ass and when $q_{I} m$ easures the displacem ent of the $I^{\text {th }}$ particle from the barycentre $\bar{x} ; q_{I}^{2}=N \quad m$ ay be rew ritten as a m utual

$M$ ore than 300 years previously $N$ ew ton showed that the $N$ boody problem in which the force on body I due to body $J$ was

could be exactly solved w th all the interactions present $(\mathbb{N}$ ew ton (1687), see also C handrasekhar (1995)). N ew ton's case corresponds to a potential energy

$W$ hen the $m$ asses are equal the expression (1.3) is the linear $\mp$ case of expression (1.1) by virtue of (12).A s the statistical m echanics associated $w$ ith expression (1.1) is stillbeautifuleven when $F$ is any non-linear function, we are led to $w$ onder whether N ew ton's exact solution to the N boody problem could be generalised to cover potential energies of the form $V=V(r)$. H ere $V$ is any function and $r$ is the $m$ ass $w$ eighted root $m$ ean square size of the system

Follow ing this idea we found a beautiful dynam ics in 3N dim ensional space which precisely mim ics nom alonbit theory in 3 dim ensions.

## 2. Solutions to the $N$ boody $P$ roblem $s$

The rst 3 com ponents of $r$ involve the position of particle 1 and the next 3

These quantities are not just norm al angular $m$ om enta. T hey involve am ong others the x com ponent of particle 1 multiplied by the rate of change of the x com ponent of particle 2 , i.e., $\mathrm{x}_{1} \mathrm{x}_{2}$ and also such term s as $\mathrm{x}_{1} \mathrm{y}_{2}$, etc. Only when both and are in the range $1,2,3$ does $L$ reduce to components of the norm al angular $m$ om entum of particle 1 (in that case). T he trace of the square of the antisym $m$ etric tensor $L$ is

N otice that if we were in 3 dimensions $L^{2}$ would be just (rrrir so it would then be the square of the speci c angular $m$ om entum. $W$ e shall refer to M L as the totalhyper-angular-m om entum and M L as the hyper-angular-m om entum. Taking the inner product of equation (2.5) w ith $\underline{r}$ and integrating, we obtain the energy equation

$T$ his we recognise as the equation ofm otion of a particle ofm ass $M$ and angular m om entum M L in the central potential V (r). Equation (2.11) is of course its energy equation and it $m$ ay be integrated in the form

which gives the standard relation for the periodicy function $r(t)$. Equation (2.13) integrates nigely for the standard cases $V / 1=r, V / r^{2}$ and the isochrone $\mathrm{V} /(\mathrm{b}+\mathrm{s})^{1} \mathrm{where} \mathrm{s}^{2}=\mathrm{r}^{2}+\mathrm{b}^{2}$. These potentials $m$ ay be supplem ented by an extra term in $r^{2}$ giving a $r^{3}$ supplem entary force but they com prise the only central orbits that can be solved involving nothing $m$ ore com plicated than trigonom etric functions (Eggen et al. 1962, Evans et al 1990). T here are $m$ any others that involve elliptic functions, etc., but for them the expression (2.13) is as sim ple as the function. W e shall retum to (2.13) later but for the present we $m$ erely note that it determ ines the periodicy function $r(t)$.

By analogy w ith norm al central orbits the form of equation (2.12) strongly suggests that we invent an angle such that

just as in ordinary orbit theory.W e de ne by (2.15) and so there is no constant of integration. It gives as a function of $r$, or $r$ as a periodic function of . Thus we have determ ined scalar r but we need to nd all com ponents of the 3 N vector $r$ to determ ine the $m$ otion com pletely. A though $V^{0}(r)=r m$ ay now be regarded as a known function of $t$ nevertheless the form of (2.5) does not at rst look very encouraging, except for $N$ ew ton's case for which $V=\frac{1}{2} k M^{2} r^{2}$ so $V^{0}(r)=r$ is constant. H ow ever, a w onderful sim plicity will em erge for the general case too. For a m om ent we discuss N ew ton's case. Equations lim ited to this case w ill have the letter $N$ appended to the equation num ber. Evidently (2.5) becom es

so each com ponent of r vibrates harm onically, all w ith angular frequency $\mathrm{P} \overline{\mathrm{kM}}$. $T$ hus each body orbits in an ellinse centred on the barycentre and moving with it and the wholem otion relative to the barycentre is periodic w ith period $2=\overline{\mathrm{kM}}$. $N$ ew ton obtained this solution by realising that the linear law of attraction, when suitably $m$ ass weighted, gave a net total force on each particle due to all the others which was directed tow ard the barycentre and in constant proportion to distance from it.

A sim ilar sim plicity em erges in the general case $w$ hen $w e$ solve for $\hat{r}=r=r$ as a function of . To do this we write

case, and for the hyper $-K$ eplerian case V / $1=r$, the $m$ agnitude $r$ is also periodic $w$ ith period 2 in . Butm ore generally, as in the isochrone, $r$ is periodic but $w$ ith a period that is incom $m$ ensurable with 2 (in general). The general solution of (2.18) is given by

Take $m_{1}$ to be $q$ the largest $m$ ass; choose $\bar{B}>3$ and $\overline{\mathrm{A}}>3$ arbitrarily, but set $\bar{A}_{j}={ }_{I>1} \frac{\bar{m}_{I}}{m_{1}} \bar{A}_{3 I} 3+j$ for $j=1 ; 2 ; 3$ and a sim ilar relation for $\bar{B}_{j}$. T hus relative to the centre ofm ass every particle's orbit becom es a centred ellinse after a universal scaling by $r^{1}$. This rescaling factor is tim e-dependent and $r$ behaves like the radius to a particle in a central orbit which is an eccentric ellipse in the $K$ eplerian case. $T$ his is our $m$ ain result.

D i erentiating (2.22) w th respect to $t$ one nds that (using $r^{2}-=L$ )

It is of interest here to count constants of integration. A and B together have 6 N com ponents but (2.20) and (2.21) give nine constraints, thus there are $6 \mathrm{~N}-9$ freedom s so far. In the solutions for $r(t)$ and $r()$ there are three further constants
$L ; E$ and $t_{0}$. Thus $r(t)$ depends on $6 N-6$ constants. To these we may add the constants $\bar{x}_{0}$ and $u$ involved in the $m$ otion of the centre of $m$ ass, and our nal solution depends on 6 N arbitrary constants. This equals the num ber of initial positions and velocities that determ ine the m otion, which veri es that we have the general solution.

The solution is only fully explicit when we can carry out the integrations (2.13) and (2.15) which determ ine $r$ and.$W$ e do not need this for $N$ ew ton's case because we already gave the solution. W hen V / r ${ }^{1}$, the hyper $K$ eplerian case, it is actually sim pler to follow H am ilton's treatm ent of the problem w ith h is eccentricity vector later used by R unge in 1919 and Lenz in 1924 (see H am ilton 1845, Laplace 1799, G oldstein 1976, or C handrasekhar 1995). T his w as certainly know $n$ to Laplace and B emoulliand can be traced to $N$ ew ton. $T$ hem ethod avoids the aw kw ardness of having to treat the elliptic, parabolic and hyperbolic cases separately. W ith $V=\mathrm{kM}^{2}=\mathrm{r}$ equation (2.5) becom es

This is our prime result and gives the $\mathrm{x}_{\mathrm{I}}$ via (2.4) and (2.2). Relative to the centre ofm ass each particle's orbit lies in a plane and elim inating in favour of coordinates $x$ and $y$ in that plane we nd it is a conic section. W hen $e<1$ the ellipse has in general neither its focus nor its centre at the centre of mass. This is clear from the geom etrical interpretation given in the note added in proof.

The relationships betw een r; and $t$ are given as usual by $K$ epler's equation which one $m$ ay derive from (2.13) and from (2.28K) and (2.31K):

(a) StatisticalEquilibrium of a system in large am plitude oscillation

In one sense it is sunprising that a system $m$ ay achieve a statistical equilibrium while its scale continues to oscillate (or in the unbound case evolve). H ow ever this only occurs for these special system $s$ in which the large scale oscillations separate from the rest of the dynam ics and only then $w$ hen the potential $V_{2}$ is su ciently com plicated to give quasi-ergodic motion in $\hat{r}$. O nce the r motion has been separated $O$, we have shown that the $m$ otion of $Q$ f follows from $a$ Lagrangian in tim e and that $V_{2}$ can be any function of the norm alised relative coordinates, so it can achieve the necessary com plications. Since the Q I m otion pays no attention to the r motion there is no reason why it should not achieve such an equilibrium. W hether such an equilibrium is a therm alequilibrium or not depends on sem antics. T he quantity shared by the di erent $Q$ I is not energy but hyper-angularm om entum, $\mathrm{M} \mathrm{L}^{2}$, and the tim e is replaced by but, as we shall see, the equilibrium rem ains at allphases of the oscillation and does not depend on the tim escale of the relaxation as com pared $w$ th the period ofoscillation. In $m$ any respects it is a true generalisation of the usual concept of statistical equilibrium albeit $w$ ith su cient di erences to $m$ ake it interesting. $W$ e have $N$; $Q$ I sub ject to the 4 constraints

## 4. C on clu sions

It is natural to ask whether the new form of equilibrium (3 25) can be generalised to the H ubble ow of relativistic cosm ology and to look for connections
w ith the interesting fact that the cosm ic background radiation rem ains in equilibrium during cosm ic expansion and creates no entropy while a classical gas creates entropy during uniform expansion due to its bulk viscosity. T hese are beyond the scope of this paper but we hope they show that exploration of som ew hat esoteric N ło ody problem s can have considerable interest outside classical dynam ics. R eaders w ill have appreciated the beauty of these N -body problem s treated exactly in 3N dim ensions as well as the novelty of the unusualstatisticalm echanics of system sw ith isotropic expansions as seen in the distribution (325) where the velocities are those relative to the tim e-dependent ow as given by (324).

G eom etrical Insight gives greater clarity. From (2.5), the problem is a central one both in 3 N dim ensions and for each particle. Together the initial $r$ and $\underline{r}$ de ne a plane in 3 N dim ensions through the centre. The central force lies in that plane so all the motion continues in it. The $m$ otion is just planar $m$ otion under the potentialV (r) so we get the usualorbit. T he orbit ofeach particle is the projection of th is 3N planar orbit onto the orbitalplane of that particle (that has $m$ ost of the 3 N coordinates $x e d$ at zero). Thus in all cases the particle orbits are projections of the 3N planar orbit which is a fam iliar one. If this is an ellipse w ith the barycentre as its focus, then the particle orbit will be the projected ellipse but the projection does not preserve the barycentre as its focus. Sim ilarly if the 3N orbit is a rosette, the individualparticle orbits w ill be pro jected rosettes, i.e., rosettes betw een sim ilar ellipses. T hat will happen for $m$ ost potentials, e.g., the isochrone.
