# Low tem perature structuralm odel of hcp solid $C_{70}$

#### Abstract

W e report interm olecular potential energy calculation for solid $\mathrm{C}_{70}$ and determ ine the optim um static orientations of $m$ olecules at low tem perature which are consistent $w$ ith the $m$ onoclin ic structural $m$ odel proposed by us in an earlier report [Solid State C om mun., 105, 247 (1997)]. This m odel indicates that the $\mathrm{C}_{5}$-axis of the m olecule is tilted by an angle $18^{\circ}$ from the m onoclinic b -axis in contrast w th the m olecular orientation proposed by Verheijen et al.[J. Chem. Phys., 166, 287 (1992)] where the $\mathrm{C}_{5}$-ax is is parallel to the $m$ onoclin ic $b$-axis. In th is calculation we have inconporated the e ective bond charge C oulom b potential together with the Lennard-Jones potential betw een the $m$ olecule at the origin of the $m$ onoclinic unit cell and its six nearest neighbours, three above and three below. The $m$ inim um energy con guration for the m olecular orientationstums out to be at $=18^{\circ},=8^{\circ}$ and $=5^{\circ}$ where, and de ne the molecular orientations.

$T$ he orientationalordering transform ation in solid $C_{60}$ is well understood ${ }^{\text {L2 }}$. P otential energy calculations using only the Lennard-Jones potentialderive the low, tem perature structure of solid $C_{60}$ to be orthorhom biol ${ }^{2}$, in sharp contradiction w ith the experim entally observed sim ple cubic structure. Lu et all could successfully derive the sim ple cubic structure for the low tem perature phase of solid $\mathrm{C}_{60}$ by adding a Coulomb potential term to the Lennard-Jones potential. T his C oulom b interaction between neighbouring $m$ olecules arises from the e ective charges at the single bonds and the double bonds of the m olecules in the ordered phase at low tem perature. In the case of solid $\mathrm{C}_{70}$, the elongated $m$ olecular shape causes much greater diversity in the structural phase transform ation sequence as well as in the orientational ordering ofm olecules. O ne ofthe rst experim entalstudies ofstructuralphase transform ation, on cooling, in solid $\mathrm{C}_{70}$ is by Verheijen et all $\mathrm{l}^{14}$ and they reported the follow ing sequence of phase transform ations
fec $)^{\star}$ in $\mathrm{hqp}-1$ (c/a 1.63) $)^{\star}$ hqp-2 (c/a 1.82)广 monoclinic
where the foc is the high tem perature phase and the m onoclinic is the low tem perature phase. T he lattice param eters reported for the m onoclinic unit cell are, $\mathrm{a}=$ $\mathrm{c}=19.96 \mathrm{~A}, \mathrm{~b}=18.51 \mathrm{~A}$ and $120^{\circ} \mathrm{w}$ th space group P $112_{1} / \mathrm{m}$. They proposed a structural m odel for this $m$ onoclinic structure in which the orientation of the long axis ( $\mathrm{C}_{5}$ ) of the static $m$ olecules is parallel to the m onoclinic b -axis (i.e., the original hcp c-axis). Subsequently, they have also carried out the potential energy calculation using the atom -atom Lennard-Jones potential and the corresponding result,w as in agreem ent w ith their model. Later, $Q$ ue et all pointed out that the unique angle for a monoclinic structure $w$ th space group P $112_{1} / \mathrm{m}$ cannot be $120^{\circ}$, but should be less than $120^{\circ}$ which is not consistent $w$ th the m olecular orientations proposed by Verheijen et al. They have carried out a detailed group theoretical analysis of librations in solid $C_{70}$ and proposed an orthornom bic structure for
which the tw o space groups $P$ bnm or $P$ nm a have the sam e R am an modes. N elissen et alla have carried out a har$m$ onic lattioe dynam ical calculation using the LennardJones potentialw hich proposed that the structure ofsolid $\mathrm{C}_{70}$ should be $m$ onoclinic at low tem perature $w$ th space group $P 2_{1} / \mathrm{m}$. This structure requires tw O independent angles which they de ned as 1 and 2 and pointed out that for their structure $1+2$ should be $36^{\circ}$. Later, A gterberg et all have pointed out that the calculation of $N$ elissen et al. can also adm it of an orthorhom bic structure w th space group Pbnm. In another detailed study using the anisotropic interaction potential betw een two $\mathrm{C}_{70} \mathrm{~m}$ olecules in term s of $C$ ayley $K$ lein param eters, they have con m ed that the structure fould be orthoriom bic with space group Pbom or Pbnm' ${ }^{\text {' }}$. The experim ental results of van Sm aalen et allí1 also conclude in favour of an orthorhom bic structure w ith space group Pbnm of the solid $\mathrm{C}_{70}$ at low tem perature. It is to be noted that this structure has resulted by a tw o step transform ation from, the idealh.c.p. phase at high tem perature. Oh et allol have reported detailed potential energy calculations using $G$ irifalco-Lennard-Jonespotential for di erentm olecular orientations depicting various possible structures of the solid and the corresponding lattioe param eters. They have com pared their results w ith experim ental reports by others ${ }^{101}$. They reported two possible transform ation sequences on cooling, viz.,

or, ficc hqp II ${ }^{*}$ hqp (III, IV) $)^{*} \mathrm{~m}$ ono
where the foc is the high tem perature phase and the m onoclinic is the low tem perature phase. H ere hcp I IV correspond to the c/a ratios of the unit cells which are $1.84,1.61,1.50$ and 1.53 respectively. T he ortho I and II correspond to the lattice param eters, $\mathrm{a}=162 \mathrm{~A}$, $\mathrm{b}=\mathrm{c}=14.0 \mathrm{~A}$ and $\mathrm{a}=16.0 \mathrm{~A}, \mathrm{~b}=14.4 \mathrm{~A}, \mathrm{c}=$ 14.8 A respectively. The m onoclinic structures in both cases are the sam e and correspond to the $\mathrm{C}_{5}$-axis of orientation being parallel to the $b-a x$ is of the unit œll. This
is sim ilar to the $m$ olecular orientation in the $m$ onoclinic structure predicted by Verheijen et al $l^{\frac{n_{1}^{1}}{1}}$, but the lattioe param eters in the two reports are signi cantly di erent. P ickholz et al ${ }^{11}$, while using atom -atom Lennard-Jones interaction in their calculation, obtain the low tem perature structure to be hcp w ith c/a 1.77, instead of a m onoclinic structure. The m olecular orientations in their m odelare, how ever, parallel to the unit cell c-axis. Sprik et all ${ }^{12}$ have carried out constant pressure m olecular dynam ics calculations incorporating Lennard-Jones potential together w ith the bond charge Coulomb potential in a phase transform ation study of foc solid $\mathrm{C}_{70}$. $T$ heir result indicates a tw o step transform ation, viz., foc \% in $)^{*} \mathrm{~m}$ onoclinic which is in excellent agreem ent with the experim ental results reported by Christides et all ${ }^{3!}$. In the low tem perature m onoclinic phase predicted by these authors, the molecules in altemate layers of the structure are oriented parallel to the (111) direction and to the (110) direction respectively. W e have reported in our earlier paper ${ }^{14}$ that the ideal hcp (c/a 1.63) solid $\mathrm{C}_{70}$ undergoes a single step transform ation, on cooling, to a monoclinic phase which is in contrast with the two step transform ation reported by Verheijen et al ${ }^{1_{4} 4_{1}}$. W e con jectured that the single step transform ation im plies sim ultaneous freezing of the $m$ olecular rotations around their long axes ( $\mathrm{C}_{5}$-axes) and the short axes ( $\mathrm{C}_{2}$-axes), as com pared to sequential freezing, which results in a tw o step transform ation. T he form er is likely to lead to a different $m$ onoclinic structure as com pared to the latter ${ }^{4,5}$ W e had proposed a structuralm odel, consistent w ith the lattice param eters for the $m$ onoclinic structure $m$ easured from our x-ray di ractogram (XRD) at 100 K , wherein the $m$ olecular $C_{5}$-axis has a tilt of about $18^{\circ}$ from the m onoclinic $\mathrm{b}_{\mathrm{m}}$-axis. O ur recent experim ental studies on, the kinetics of phase transform ation in hap solid $\mathrm{C}_{70}{ }^{1} 5$ show that, except for very slow cooling rates, a tw o step transform ation invariably results. Such a tw o-step transform ation $m$ ay be sim ilar to that reported by Verheijen et all ${ }^{14}$ and C hristides et all ${ }^{13131}$. The low tem peraturem onoclin ic structures and the $\mathrm{C}_{70} \mathrm{~m}$ olecular orientations reported by these authors $m$ ust, therefore, correspond to som e local potential energy $m$ inim a of the system raised above the globalm inim um by $m$ isorientation stresses.

In this paper, we report the results of the potentialenergy calculation pertaining to the $m$ onoclinic structure obtained by us from our 100 K XRD. Since the cooling rate was very slow (typically, $0.0033 \mathrm{~K} / \mathrm{m}$ in.) the m onoclinic structure determ ined from our experim ent is expected to be close to the equilibrium structure at low tem perature. In this calculation, we have considered the interactions betw een the seven $m$ olecules, one at the origin $(0,0,0)$ of the $m$ onoclinic unit cell and the rem aining six at the six nearest neighbour positions, three above and three below the basalplane. T he orientation of the $m$ olecules has been de ned using the angles, , and , as explained later. T he nalorientation of the olecules, as obtained by locating the $m$ inim um of the potentialenergy has $=18^{\circ},=8^{\circ}$ and $=5^{\circ}$.
$T$ he structure of our $C_{70}$ sam ple at room tem perature is ideal hqp ${ }^{16}$ and the XRD pattem of this structure has been analysed in detail in an earlier work ${ }^{171}$. The hcp lattice constants are, $\mathrm{a}_{\mathrm{h}}=\mathrm{b}_{\mathrm{h}}=10.53 \mathrm{~A}, \mathrm{c}_{\mathrm{h}}=17.26 \mathrm{~A}$ and $h=120^{\circ}$. The 100 K pattem ts well to a monoclinic structure $w$ th lattice param eters, $\mathrm{a}_{\mathrm{m}}=10.99 \mathrm{~A}$, $\mathrm{b}_{\mathrm{m}}=16.16 \mathrm{~A} \mathrm{r}_{\mathrm{m}}=9.85 \mathrm{~A}$ and $\mathrm{m}=107.75^{\circ}$ and space group P $2_{1} / \mathrm{m}$. It is clear that the follow ing correspondence of lattice param eters is appropriate in going from the hqp to the $m$ onoclinic: $C_{h}$ shrinks and form $s b_{m}, b_{h}$ increases and form $s a_{m}$, and $a_{h}$ shrinks to form $C_{m}$. This correspondence is show $n$ in $F$ ig.1. The hexagonal angle
$h$ can be seen to reduce to the $m$ onoclinic unique angle
m by a shear along the direction show $n$ by the arrow $s$ in Fig. 1 (b). It can be seen that the above correspondence indicates a tilt of the $\mathrm{C}_{5}$-axis of $\mathrm{C}_{70} \mathrm{~m}$ olecules by an angle of approxim ately $18^{\circ}$ from the $\mathrm{b}_{\mathrm{m}}$-axis of the m onoclinic unit cell (see Fig. 1 (b)).

In this calculation we have used the Lennard-Jones potentialtogetherw inh the bond charge C oulom b potential. Follow ing Lu et al ${ }^{131}$ in the ordered state of the solid there is less charge density distribution around the C C single bonds (long bonds) com pared to that around the $\mathrm{C}-\mathrm{C}$ double bonds (short bonds). Such a charge density difference on the surface of the $m$ olecule leads to short range interm olecular C oulom b interaction which decays as 1/ $R^{5}$ at long distances in the case of $\mathrm{C}_{70}$. In this calculation we have used the sam e nota, tion for the interaction sites as was done by Sprik et all ${ }^{12}$ in their calculation for the foc solid $\mathrm{C}_{70}$. T he Lennard-Jones centres are taken to be the carbon atom s sites (C sites: c c = 3.4A ) as well as the $m$ id-points of the electron-rich $C-C$ double bonds ( D sites: $\mathrm{DD}^{2}=3.6 \mathrm{~A}$, whereas $\mathrm{CD}=3.5 \mathrm{~A}$ ) and the $m$ agnituude of the interaction has been taken as, $=2.964 \mathrm{~m}$ eVI
The e ective charge around the single-ponds are assum ed to be localised around the $C$ sites $1^{21}$. Though in $C_{70} \mathrm{~m}$ olecules, there are ve types of $C$ sites, for the sake of sim plicity allC sites can be treated to be of the sam e type as in the case of $\mathrm{C}_{60}$. If a C site carries an e ective charge $q_{c}$, the corresponding value at the $D$ sites $w i l l$ be $q_{D}=-2 q_{C}$. The values of these e ective charges are fractions of the electronic charge, e.g., $q_{c}=0.175 \mathrm{e}$ and $q_{D}=-0.35 e^{12!}$. The bonds around the equatorial region of the $m$ olecule have a length interm ediate betw een the length of a single bond and a double bond and, therefore, are term ed as interm ediatebonds (or, Ibonds). For these bonds, $I=3.5 \mathrm{~A}$ and $q_{I}=0.5 q_{D}$. Since the polar cap of the $m$ olecule consists ofboth long bonds and short bonds, the C oulomb interaction is stronger at the tw o opposite poles of a m olecule in the ordered phase. Therefore the bond charge interaction betw een two m olecules in adjacent planes is dom inated by the polar caps and can be term ed "polar cap" interaction. T he coordinates of the 70 carbon atom $s$ in the molecule were generated from data available in published literature ${ }^{2}$ a, . The total interaction potentialbetw een any tw o $\mathrm{C}_{70^{3}}{ }^{3} \mathrm{~m}$ olecules is given by

where the subscript $x$ indicates interaction sites, e.g., C , $D$, or, $I$, and $r_{1 i ; 2 j}$ are the coordinates of the atom $s$, $\mathrm{b}_{1 \mathrm{~m} ; 2 \mathrm{n}}$ coordinates of bond centres and $\mathrm{q}_{\mathrm{m} ; \mathrm{n}}$ are e ective bond charges (e.g., $q_{c}, q_{D}$ and $q_{I}$ ).

Using the above interaction potentials between the seven nearest neighbourm olecules for the lattice param eters $m$ easured from our $100 \mathrm{~K} x$ xay di ractogram, we optim ise the $m$ olecular orientations $w$ ith respect to the unit cell param eters by $m$ in im ising the totalenergy. T he $m$ olecular orientations are de ned using the polar coordinates and, where is the polar angle, i.e., the angle betw een the $\mathrm{b}_{\mathrm{m}}$-axis and the m olecular long axis and is the azim uthal angle. Further minim isation of the potentialenergy has been perform ed by varying the angle ( ) which de nes the body rotation (spin) of the $m$ olecules around their $\mathrm{C}_{5}$-axes of the six m olecules above and below the basalplane relative to the $m$ olecule at the origin of the $m$ onoclinic unit cell.

W e calculate the potential energy per cluster for each con guration of the seven $m$ olecules de ned by the values of between $0^{\circ}$ and $90^{\circ}$, between $0^{\circ}$ and $180^{\circ}$, and between $0^{\circ}$ and $72^{\circ}$. In $F$ ig 2, we show the variation of potential energy $w$ ith respect to , and . $C$ learly, for $=8^{\circ}$ and $=5^{\circ}$ the potential energy is m in im um at $=18^{\circ}$. This result is consistent w ith the $m$ odel we proposed for the $m$ olecular orientation in the m onoclinic unit cell experim entally $m$ easured by us $\mathrm{s}^{14!}$. $T$ he $m$ inim um potential energy per cluster obtained for our m odel is -3.923 eV which is signi cantily low er than other calculations reported in literature ${ }^{4+1 i_{2}}-1$. It is to be m entioned here that there are two other m inim a w ith respect to at $54^{\circ}$ and $88^{\circ}$ (not shown in the gure). $T$ hough these three $m$ inim a have energy values com parable to each other, the energy barriers betw een them are nearly 0.04 eV which is too large to spontaneously ip the $m$ olecule from one $m$ inim um to the other at low tem peratures ( 100 K ). T hese $\mathrm{m} u$ ultiple m in im a indicate that the system $m$ ay have degenerate states w ith respect to , or, that they $m$ ay even correspond to di erent structures which can be obtained by applying som e extemal driving force, e.g., pressure etc. The degeneracy $m$ ay arise as a consequence of the repulsive interactions betw een the $C-C$ bonds as indicated by Sprik et a. ${ }^{211}$. in their extended m odel. Since the present calculation is based on the static orientations of $m$ olecules ( $m$ olecular static calculation) the study of the structural transform ation or the change of $m$ olecular orientations $w$ ith tem perature cannot be carried out by this $m$ ethod. A detailed $m$ olecular dynam ics calculation is needed for this purpose which is in progress. Nevertheless, we argue that the equilibrium low tem perature structure will be consistent $w$ ith the $m$ olecular $\mathrm{C}_{5}$-ax is tilted aw ay from the
unit cell long axis, because of the polar cap interaction, as proposed in the present $m$ odel and supported by the potential eneroqy calculation, rather than being oriented parallel to ith $^{4}, 5 \mathrm{~L}$. . W e recall from the introductory section, that the m olecular dynam ics calculation of Sprik et all ${ }^{2!}$ leads to tw o com peting orientations for the $m$ olecules. A pictorial view of the optim ised static orientation of the seven $m$ olecules for our $m$ onoclinic lattioe param eters is show $n$ in $F$ ig.3. This picture is generated using a public dom ain softw are M O LD RAW.

In conclusion, our results of potential energy calculation using the Lennard - Jones potential together with the bond charge Coulomb potential support the, structuralm odel proposed by us in our earlier paper14. The calculation shows that the $m$ inim um potential energy state appears $w$ ith a tilt of the $\mathrm{C}_{5}$-axis of the m olecule $w$ ith respect to the $m$ onoclinic long axis ( $\mathrm{b}_{\mathrm{m}}$-axis) by an angle of $18^{\circ}$. Furtherm inim isation of the interaction energy between the neighbouring $m$ olecules has been carried out using an angle which de nes the rotational con guration of the $m$ olecule around its own $\mathrm{C}_{5}$-axis. The m olecular orientations obtained from our calculation have an im plication of signi cant polar cap interaction betw een the nearest neighbourm olecules in adjacent planes. T he bond charge interaction is thus seen to play a key role in determ ining the equilibrium low tem perature structure of solid $C_{70}$. O ur calculations show also that the structuralm odel proposed by us corresponds to the m ost stable low tem perature structure of solid $\mathrm{C}_{70}$ reported so far.
