K inetic approach to the G aussian therm ostat in a dilute sheared gas in the therm odynam ic lim it

Abstract

A dilute gas of particles with short range interactions is considered in a shearing stationary state. A Gaussian them ostat keeps the total kinetic energy constant. For in nitely many particles it is shown that the therm ostat becomes a friction force with constant friction coecient. For nite number of particles N, the uctuations around this constant are of order $1 = \frac{P}{N}$, and distributed approximately Gaussian with deviations for large uctuations. These deviations prohibit a derivation of uctuation-dissipation relations far from equilibrium, based on the Fluctuation Theorem.

The interest in the relation between non-equilibrium statistical mechanics and microscopic equations of m otion, which already occupied Boltzm ann, has revived in recent years, on the one hand due to the developm ent of chaos theory, but even more due to results from non-equilibrium molecular dynamics [1,2]. The main focus in the eld is on stationary states. A stationary state, if it is not the equilibrium state, is the result of an external driving force. But this force perform s work on the system, so it heats up (viscous heating, 0 hm ic heating). In simulations this is often remedied by the introduction of a mechanical therm ostat: one adds a friction force, \mathbf{v}_{i} in the equation of motion for the velocity \mathbf{v}_{i} of each particle i, to keep the energy constant. For the therm ostat variable there are several choices. One could take it constant, but then one only gets a constant energy on average. It is also possible to have time dependent, such that the total kinetic energy is constant (iso-kinetic G aussian therm ostat) or the total energy is constant (iso-energetic G aussian therm ostat) [2]. N either of these therm ostats are very realistic, as the dissipation of the heating would more likely occur at the boundary, where the system is in contact with a heat bath, say. O ther boundary form ulations where the driving force and the therm ostat are combined have also been studied [3,4]. One hopes the choice of the therm ostat doesn't matter in the therm odynamic limit. The equivalence of a constant therm ostat, the iso-kinetic therm ostat and iso-energetic therm ostat was proposed by G allavotti [5].

The extra term in the equations of motion destroys the Liouvillian character of the ow: a given volume in phase space will not retain that volume. As the available phase space is usually nite, this means that on average over time the volume either stays constant (conservative case) or contracts (dissipative case). In a dissipative system a stationary state can exist only on a course grained scale, the dissipation continues forever but on ever ner scales. This dissipation happens at a rate called the phase space contraction rate which is proportional to the average of the therm ostat variable . This rate can be identied [6,7] with the inversible entropy production [8]. If we make this identication with a physical quantity, the precise in plan entation (iso-kinetic, iso-energetic, constant, :::) of the therm ostat should not in uence the average of in the therm odynam ic lim it. C ohen [9] suggested that a mechanical and a physical therm ostat may give the same results as long as the rate of heating is much less than the rate at which heat can be transported to the wall and absorbed there. This suggests that when the rate of heating becomes to large, the therm ostat does make a di erence. At that point one also expects the assumption of local equilibrium underlying non-equilibrium therm odynamics to break down, and the entropy production may no longer have the form that was used to identify it with \cdot .

We want to know which them ostat to use for analytic treatment of dilute gases in nonequilibrium stationary states. A swe are interested in the limit of many particles, having to use an dependent on all these particles would certainly make work more dicult. In other analytic work on non-equilibrium stationary states, one simply takes a constant [10,11]. A sketch of a proof of the equivalence of a Gaussian iso-kinetic them ostat, a Gaussian iso-energetic them ostat and a Nose-Hoover them ostat, was already given by Evans and Sarm an [12]. In this paper, we will demonstrate the equivalence of an iso-kinetic Gaussian them ostat and a constant them ostat in the them odynam ic limit using kinetic theory on the Boltzm ann level (i.e. at low densities) for a sheared system of short range interacting particles. We consider a dilute gas of N particles in d dimensions, under shear: the gas is contained between two plates a distance 2L apart (Fig. 1). The two plates are moving in opposite directions with a velocity L. For not too large one expects that a linear velocity pro le will develop, so that the uid velocity at y is y?.

We are interested in bulk properties, so we let L go to in nity, while the shear rate and the density are xed. To show the equivalence of the constant therm ostat and the G aussian therm ostat, it would in principle su ce just to take the horizontal dimensions in nite, but this way we can also move the boundary conditions to in nity. In the real physical system, as L get larger, the lam inar ow becomes unstable and the system eventually develops turbulence. However, the therm ostats we will consider assume the stability of the lam inar ow [2], and suppress turbulence.

There is a well known and often used set of equations for molecular simulations that describe shear, the SLLOD equations [2]:

in which $q_i; p_i$ are the phase space coordinates of particle i, is the therm ostat variable and \mathbf{F}_i represents the forces between the particles. The mass of the particles is taken to be one. The shear rate is constant, but is not. It is constructed such that the kinetic energy $K = \sum_{i}^{P} k p_i k^2 = 2$ in the system is exactly constant, which gives

This is the iso-kinetic Gaussian therm ostat. Note that depends on the positions and momenta of all the particles.

The interpretation of Eq. (1) is that p_i is the peculiar velocity of particle i with respect to the local uid element that has velocity yx. In the laboratory frame, a reasonable set of equations to write down is

This particular form of the therm ostat term is chosen because a linear velocity prole is expected, and we want the tem perature to be constant, so the kinetic energy in the frame that moves with that local velocity is to be dissipated. A Boltzmann equation for the one-particle distribution function will give an appropriate description at low densities. This equation has to be supplemented by the boundary condition that the average velocities at the boundaries y = L are L. To get rid of the L dependence, one can transform the velocities to peculiar velocities: $p_i = v_i \quad y_i x$. The average (peculiar) velocity now has to be zero at the boundaries, so when L ! 1 they have to be zero at in nity: this is the same boundary condition as for the standard Boltzmann equation. The transform ation to peculiar velocities the SLLOD equations:

II.K IN ET IC APPROACH

A.E ective motion of the therm ostat

The Gaussian therm ostat involves an which depends on the position and velocity of every particle, and so it varies in time. We'll now derive equations of motion for the therm ostat forwhich we do not need to know all these positions and velocities, by introducing one extra therm ostat variable . The derivation is in two steps: rst we consider free ight, and then we take into account the e ect of collisions.

During free ight F is zero so the therm ostat is given by

There is a conserved quantity

A fler change of variables to X = 1 = (2) and P = =, this conserved quantity takes on a Ham iltonian form H (X; P) = $\frac{1}{2}P^2$ X. The equations of motion are X- = P and P- = 1. The general solution, transform ed back to , has the form

So far, we only considered free ight. The duration of a free ight is very small in a system of N particles: it is of the order of (N) 1 , where is the collision frequency of a single particle. In a collision, changes by an amount:

where primes denote the value of the variables after collisions and first he collision parameter, i.e. $fi = (p_{21}^0 \quad p_{21}) = kp_{21}^0 \quad p_{21}k$. As K is of order N, is of order N⁻¹. itself is of order one. The denition makes of order one. During a typical free ight time of one particle, every particle in the system has collided once on average. In each collision two particles are involved, so N = 2 collisions have taken place in the system during this time. Thus, during one free ight time, the therm ostat got N = 2 changes of order N⁻¹ and this adds up to an e ect of order one, because, as we will see, the average of is non-zero.

W e will see later that the e ect of the therm ostat depending on all the particles { an unphysical idea in some sense { results just in a uctuating therm ostat with well de ned mean and distribution. W e are interested in this distribution. It will depend on the distribution of , which depends on the velocity distribution in the system, which in turn is a ected by the therm ostat distribution. But som e general properties can already be derived without this subtle interplay.

W e want to write down a Boltzm ann equation for the probability distribution function F (;t) of the therm ostat:

where $p_{21} = p_2$ p_1 . B is the rate of collisions with fi given that the colliding particles have relative velocity p_{21} . It can be expressed in the di erential cross section $s(fi; p_{21})$, which m easures the number of de ected particles per unit solid angle around p_{21}^0 when a beam of particles of unit density is incident on one other particle. In d dimensions:

where $\hat{p}_{21} = p_{21} = kp_{21}k$. The last factor is the Jacobian that arises because we integrate over \hat{n} while s is defined per unit solid angle of p_{21}^0 . Strictly, we ought to take $p_2 = p_1 + \hat{x}(y_2 = y_1)$ instead of p_{21} , but in the Boltzmann approach the two particles are taken at the same position when they collide. In an Enskog-type approach this would matter.

To proceed, we need an expression for P in terms of F and the one particle distribution function f(p), which we will take normalized to one. For f, we can also write down a Boltzm ann equation, so we will have a system of two coupled Boltzm ann equations for f and F. To derive the standard Boltzm ann equation [13] for f, one uses the Stosszahlansatz that

states that the two-particle distribution function $f_2(p_1; p_2)$ is proportional to the product of the one particle distribution functions $f(p_1)f(p_2)$, i.e. that the two particles are uncorrelated when they collide. We want a generalization of the Stosszahlansatz for P, but setting P $(p_1; p_2;) = f(p_1)f(p_2)F()$ can't quite be right for the following reason.

The Stosszahlansatz can be generated by taking the phase space density (fp_ig) to be ${}^{Q}{}_{i=1}^{N}$ f (p_i), i.e. all the particles are uncorrelated (arguably, this is too strong a condition, but it will serve to make our point). Let

This will serve as our Stosszahlansatz. We insert it in the collision integral and perform the integration:

Some typical trajectories in phase space are plotted in Fig.2, both with and without the e ect of collisions. When (a;b) \notin 0, it is no longer possible to derive the equations of motion from a Hamiltonian: the motion is dissipative, and there exists a xed point $_{0} = (_{0};_{0})$, defined by

Physically, one expects the system to heat up without a therm ostat, so the therm ostat should act as a friction: $_0$ is positive. To consider the stability of the xed point, we linearize the equation of motion around it. W riting = $_0 +$, we get

The eigenvalues of the matrix are $3_0 = \frac{2}{0} + 2_0 \cdot \frac{1}{0}$ is positive, so the xed point is stable only if $_0 > 0$, consistent with the physical expectation. Furthermore, from the de nitions

in Eq. (3) and Eq. (5), one can see that $\frac{2}{0} < 0$, so the eigenvalues are complex and the xed point is a stable spiral. If we take an initial distribution within the dom ain of attraction, all points will end up in this xed point. Thus, in the stationary state, the distribution of the therm ostat is a delta function at $_{0}$:

B.Boltzm ann equation for the one particle distribution function

A swem entioned, the analysis is not complete without a second Boltzm ann equation, for the one particle distribution function f(p;t). The di cult part a priori is what to do with the free ight term p_i . The analysis of the therm ostat variables how ever showed that the is, in the stationary case, a constant, so we just replace by $_0$:

In some analytic work [10,11], a constant is also used and its value is determined by dem anding that the second moment $kpk^2i = kpk^2f(p)dp$ is a conserved quantity. This yields

Combined with Eq. (9), we see that indeed $(_{0};_{0}) = (;)$ given by Eq. (11) and Eq. (12), is the self-consistent solution.

III. THERM OSTAT FLUCTUATIONS

When N is nite, there are uctuations around the therm ostat value $_0$. One can see that the rst correction, on the right hand side of Eq. (8) has a di usive form, with a di usion coe cient of order N⁻¹. Combined with the drift towards a xed point from the left hand side, this will make the therm ostat distribution F peaked around this point, with a width of order N⁻¹². For large N the width is so sm all that the linearized equation, Eq. (10) is a good approximation for most of the distribution. For a linear xed point, the distribution would be G aussian. So the distribution F (;) will become G aussian for large N, except in the tails, where the linearized equation does not hold.

The Gaussian nature of the distribution also carries over to the nite time average of ,

For large times , the therm ostat will spend a long time in the neighborhood of the xed point $(_0;_0)$, so will also be G aussian distributed for large N, but, again, with deviations for large uctuations. This all is in accordance with what one would expect from a central limit theorem.

Bonetto et al. [14] nd a Gaussian distribution for , but mention that the Gaussian was not what they expected, in fact, that it couldn't be Gaussian, because it would give a kind of generalized uctuation-dissipation relation (see also [15]) when combined with the uctuation theorem of Gallavotti and Cohen [16].

However, the deviations from the Gaussian nature at large uctuations prohibit this derivation of far-from -equilibrium uctuation-dissipation relations. The uctuation theorem states that the probability (p) of nding that is p $_0$, divided by the probability that it is p $_0$, satisfies for large ,

The result was found for A nosov system s, but has been found in num erical simulations [17] and in Langevin equations [18] too, and seems to have a broader validity [19]. Combined with a Gaussian form of , one gets a relation between the variance and the mean of the

distribution, i.e. a kind of uctuation-dissipation relation. The variance can be linked to a correlation function and (generalized) G reen-K ubo form ulas emerge [14]. But for these to hold, the G aussian character has to be guaranteed for negative also, and the central lim it theorem, nor an extension of the analysis given here, could justify that. Recently this was adknow ledged by Searles and E vans [20] and the G reen-K ubo relations far from equilibrium were refuted in their m olecular dynam ics simulations. This does not totally explain the results of B onetto et al [14], who get a G aussian (p) for just 10 particles, the G aussian clearly covering negative p as well. There are of course uninvestigated prefactors in the widths of the G aussian and in range of validity.

Only when we are near equilibrium the uctuation theorem and the central lim it theorem can be combined, provided we rst take the lim it of the external eld going to zero before we take the therm odynam ic lim it, even though we can take a large number of particles throughout. In such a scheme, the distribution (p) is centered almost around zero, such that it always applies to some negative p.

$\ensuremath{\operatorname{IV}}$. C O N C LU S IO N S

We have treated the G aussian them ostat in a sheared system of short range interacting particles at low density using kinetic equations. We found that in the therm odynam ic lim it, the therm ostat force becomes a friction force with a constant friction coe cient. The value of this constant was shown to be consistent with the requirement that the second moment of the one particle distribution function is conserved. This conclusion did not depend on a smallness of the shear rate, so it applies also far from equilibrium. The constant friction force has been used in other work [10,11] and the results from those should apply equally to G aussian therm ostatted systems, in the therm odynam ic lim it.

We brie y discussed nite N corrections. These give rise to uctuations of the friction coe cient around its mean, of the order of $1 = \frac{1}{N}$. The uctuations are close to G aussian for large N, except for very large uctuations away from the mean. Far-from -equilibrium G reen-K ubo relations rely in one derivation at least [14] on the uctuation theorem [16], which concerns large uctuations. The breakdown of such G reen-K ubo relations recently found by Searles and E vans [20] has its origin in the deviations from the G aussian nature for large uctuations. Near equilibrium one doesn't need the large uctuations.




FIG.1. Velocity pro le in a gas under shear




FIG.2. Some typical trajectories of the therm ostat. The rst gure is without collisions, the second one is with collisional averages a and b set to the arbitrary values of 0:18 and 0:04, respectively.
