Physics on the edge: contour dynam ics, waves and solitons in the quantum Halle ect

We present a theoretical study of the excitations on the edge of a two-dimensional electron system in a perpendicular magnetic eld in terms of a contour dynamics formalism. In particular, we focus on edge excitations in the quantum Halle ect. Beyond the usual linear approximation, a non-linear analysis of the shape deformations of an incompressible droplet yields soliton solutions which correspond to shapes that propagate without distortion. A perturbative analysis is used and the results are compared to analogous systems, like vortex patches in ideal hydrodynamics. Under a local induction approximation we not that the contour dynamics is described by a non-linear partial differential equation for the curvature: the modified Korteweg-de Vries equation.

### I. IN TRODUCTION

The theoretical description of many-body systems is often best realized in terms of collective modes, i.e. the familiar sound waves in solids or plasmons in charged system s. Collective modes become especially important when their energies are lower than competing singleparticle excitations. Som etim es, however, both singleparticle and collective modes in the bulk of a system are gapped or scarce and these systems are often referred to as \incom pressible." This incom pressibility can be real or a convenient lim it due to large di erences in relevant length-or time-scales, as in the case of the macroscopic motion of a liquid. Under these conditions, one can usually focus our attention on the motion of the boundaries of the system, which will generally have softer modes, with frequencies much lower than those in the bulk (e.g. surface waves in a liquid droplet travel at speeds considerably slower than sound waves).

Concentrating on the motion of the boundary of the system has a considerable advantage: the reduction in the dimensionality of the problem often permits simpler analytical treatm ent, or a trem endous reduction in the e ort needed to num erically solve or simulate the problem . A ssociated with this incompressibility, however, one usually ndsmicroscopic conservation laws that translate into global constraints on the whole system, even when the microscopic dynamics is completely local (e.g. the volum e of a liquid droplet is conserved). These global constraints enter the edge dynamics through Lagrange multipliers associated with the conserved quantities. These conservation laws are often evident when the motion of the system is observed, and it is interesting to see how they are embedded in the dynamics of the boundary; that is, how these essential aspects of the problem are related to the laws of motion of the edges.

These shape deform ations, and their dynam ics, have played an important role in the understanding of numerous problems in diverse elds of physics. The incompressibility is rejected in the existence of a eld which is piecewise constant, so that there is a sharp boundary between

two orm ore distinct regions of space with dierent physical properties. This eld can be of classical origin like the density of a liquid or the charge density of a plasm a, or it can originate in the quantum mechanical properties of the system, like the magnetization of a type-II superconductor. There are various examples where these questions are relevant, such as waves on the surface of a liquid,  $^2$  (the motion of non-neutral plasmas, bw lying \rotation-vibration modes of deformed nuclei, the evolution of atmospheric plasma clouds, pattern formation in ferromagnetic uids, vortex patches in ideal uids, and two-dimensional electron systems (2DES) in strong magnetic elds.

The edges of a two-dimensional electron system (2DES), and in particular the edges of a quantum Hall (QH) liquid, present a unique opportunity to study the dynam ics of shape deform ations in a clean and controlled environment. The 2DES in the QH state is incompressible, so that the electron density is approximately piecewise constant, suggesting that a contour dynamics approach to studying the droplet excitations is viable. The lack of low-lying excitations eliminates dissipative elects, further simplifying the treatment of the problem. In addition, the charged nature of the system facilitates the excitation and detection of deformations of the droplet.

In this paper we will form ulate the study of the excitations of a droplet in a 2DES as a problem in contour dynam ics. In the usual treatm ent of the edge excitations, 13 a linearization of the equation of motion is done at early stages, thus lim iting the applicability to small deform ations of the edge of the system from an unperturbed state. In this paper we consider non-linear term s which are present in the full contour dynam ics treatment. We rst present perturbative results for non-linear deform ations of the 2DES shape. For the sake of comparison, and as means of veri cation, we also apply this method to the vortex patch case, which has well known exact9 and num erical 1 solutions. We then show that the local induction approximation to the full contour dynam ics generates the modi ed Korteweg-de Vries (m KdV)<sup>15</sup> equation for the curvature dynamics; the mKdV equation also arises in studies of vortex patches<sup>12</sup> and suspended liquid droplets.<sup>4</sup> The m K dV dynam ics conserve an in nite number of quantities, including the area, center of mass, and angular momentum of the droplet, <sup>16</sup> so that our local approximation to the nonlocal dynam ics preserves the important conservation laws. The m K dV equation also possesses soliton solutions, including traveling wave solutions.

In Sec. II we present a brief review of the hydrodynamics of a two-dimensional electron system in a strong perpendicular magnetic eld and analyze the bulk and edge excitations in the linear approximation. Sections III and IV and analyze in more detail the dynamics and kinem atics of these edge m odes, and ask what conditions must be satis ed so that a large edge deform ation is able to travel without any dispersion, that is, preserving its shape. The question is posed in terms of a non-linear eigenvalue problem and is solved perturbatively to fth order in the deform ation in Sec. V (for completeness, we also solve the analogous problem of vortex patch deformations in Appendix B). Some solutions and limiting cases are then presented in Sec. VI. An alternative approach to nd non-dispersive or invariant deform ations of the edge, namely the local induction approximation, is developed in Sec. VII, where results are also compared with the perturbative approach of Secs. V and VI.

## II.HYDRODYNAM ICS OF A TW O-D IM ENSIONAL ELECTRON SYSTEM

Consider a 2DES in a perpendicular magnetic eld. Treated as a classical uid, the system is characterized by the electron density  $n\left(r\right)$  and velocity  $v\left(r\right)$ . If we neglect dissipative e ects (which is essentially correct in the quantum Hall regime), the dynamics is determined by the Euler and continuity equations:

where  $!_c = eB = m_e$  is the cyclotron frequency and is the dielectric constant of the medium . The rst term on the right-hand side of Eq. (1) represents the Lorentz force, the second is the Coulomb interaction, and E  $_{\rm ext}$  is the electric eld due to the background positive charge, gates, etc.

Consider rst the possible bulk collective excitations in a uniform system. These are oscillations of the density around the equilibrium solution v=0, n=n. If we consider small amplitudes and Fourier analyze Eqs. (1) and (2), we not that

that is, bulk m agnetoplasm ons are gapped, and in the Q H regim e can be neglected since h! $_{\rm c}$  17m eV 200K at B = 10 T (in G aAs), whereas T 1K.We will disregard them from now on and concentrate on the excitations at the edge which, as we shall see, have considerably lower energies.

The theory of sm all deform ations of the edge has been extensively studied.  $^{17}$  {20 The main conclusion is that for strong magnetic elds, when Landau level quantization becomes important, the only low-lying modes are edge modes which propagate in only one direction along the edge of the 2DES. We further classify these modes into the \conventional" edge magnetoplasm on mode, with a singular dispersion relation:  $^{17}$

where k is the mode wave-number, 0.5772 is the Euler constant, and a is a short-distance cut-o (the largest of the transverse width of the 2DES, the magnetic length, or the width of the compressible edge-channel). In addition, for wide compressible edges, \acoustic" modes can be found:

These results are approximately correct as long as inertial and conning terms are negligible. The rst requires that  $n^2 = m_e a$  ! $_c^2$ , which is usually true in quantum Hall conditions. In addition, the elects of the conning potential have been neglected. While the conning potential is essential for long-term stability and is usually not negligible when compared to interactions, its elect is mainly reduced, in the simplest cases, to an additional  $v_{\rm ext}$  k term in the frequencies, where the external velocity is given by

## III. DYNAM ICS OF THE EDGE MODES




FIG. 1. A charged incompressible liquid in a magnetic eld. We assume a piecew ise constant electron density (n=n inside, while n=0 outside the droplet). The parameterization R ( $\prime$ ; t), the tangent t and normal n unit vectors to the boundary are indicated; s is the arc-length and the tangent angle.

Consider the case when the edge between bulk and vacuum is sharp. The electronic density has some constant value n inside the edge and vanishes outside (see Fig. 1). Since the edge is essentially one-dimensional only the edge magnetoplasmon is important (and even in more general cases this mode is the most readily

observable  $^{17;21}$ ). Following the derivation of the edge magnetoplasm ons  $^{17;20}$  we neglect inertial terms in Eq. (1), thus obtaining an equation for the electron velocity:

where A is the area of the droplet (see Fig. 1).

Let us now concentrate on the \internal" velocity given by the rst term in Eq. (8). We should note that the neglected external velocity  $v_{\rm ext}$  derived from the conning eld Eq. (7)] is important for long term stability of the system, and will modify the propagation velocity. In general, it could also change the shape of the modes, yet one can devise situations in which this ect is not important, i.e. a linear conning potential in a rectilinear in nite edge, or a parabolic potential for a circular droplet.

For an incompressible 2DES with a piecew ise constant density, the density can be taken outside the integral; then using Stokes' theorem, the area integral can be transformed into a line integral over the boundary = @A of the electron liquid:

and we de ned the unit norm alvectorn (§) for later use. The short distance singularity in the integrand is cut o at a length scale  $r_0$ . Equation (9) form s the basis of our contour dynam ics treatment | it expresses the velocity of the edge in terms of a nonlocal self-interaction of the edge.

We see that: (i) the dynam ics is chiral, being determined by the tangent vector; (ii) the uid contained

within is incompressible, so that the area is conserved. It is interesting to note similar traits were found in the past for the dynamics of vortex patches;  $^{9}$  {12 indeed, it is this analogy which inspired the present work. A detailed description of the vortex patch case, and stressing the similarities and dierences with the shape deformations of the 2DES is presented for completeness in Appendix B.

# IV . K IN EM AT IC S OF UN IFORM LY PROPAGATING DEFORM AT ION S

Having determined the velocity of the electron liquid, we now focus on the motion of the 2DES boundary. The velocity of a point on the boundary can be written in terms of the normal and tangential components,

The tangential velocity W (s) is largely irrelevant, as it solely accounts for a reparam etrization of the curve; the boundary motion is determined by the normal component of the velocity.




FIG.2. A uniform ly propagating edge deform ation. The boundary satis es R (';t) = R (' t).

We now ask whether there are modes which propagate along the boundary with no change in shape. Previous work  $^{17}$  has focused on small perturbations of a straight, in nite edge. Here we consider deform ations of a circular droplet of incompressible electrons (the non-linear deformation of a straight in nite edge is discussed in Appendix F). A uniform ly propagating mode is, in this case, characterized by a boundary that moves like a rotating rigid body (see Fig. 2), namely, the radius of the boundary satis es

where ' is the azim uthal angle, and is the angular frequency of the boundary rotation. This translates into a condition for the normal velocity:

We seek surface shapes R (') (see Figs. 1 and 2) that rotate uniform ly, satisfying Eq. (13). Consider the following parameterization of the surface:

We seek frequencies and coe cients  $b_1$  that satisfy Eqs. (18) and (19). The solutions to this non-linear eigenvalue problem represent edge modes that propagate without any dispersion.

## V.SOLVING THE NON-LINEAR EIGENVALUE PROBLEM | PERTURBATIVE APPROACH

Unfortunately, it has not been possible to solve exactly the non-linear eigenvalue problem for  $b_1$  and as written in Eqs. (18) and (19). We therefore seek a perturbative solution by expanding the right-hand side of Eq. (18) in powers of  $b_1$ . This allows us to to go beyond the linear approximations used in the past, and we have succeeded in calculating shape deformations to 0  $b_1^4$ ] and angular frequencies to 0  $b_1^5$ ]. Expanding the non-linear eigenvalue problem to find order, we not the condition

Since the equation to be solved results from an expansion in powers of  $b_1$ , it is su cient to solve Eq. (20) perturbatively, by expanding in powers of the largest one cient  $b_1$ . Let us assume that

4. Fourth-order terms provide coupling to both second and fourth harm onics:

5. The fth-order term follows the same pattern. The couplings to higher harm onics is quite complex and we chose not to pursue it. We show only the correction to the eigenvalue:

Note that the largest term in the perturbative expansion corresponds to the lowest harmonic and that higher order elements preserve the rotational symmetry  $C_L$  (rotations by 2 =L) of the initial term.

## VI. SOLUTIONS FOR THE TWO-DIMENSIONAL ELECTRON SYSTEM

We now show some invariant shapes for the 2DES (see Secs. III and IV). Coe cients  $b_1$  and frequencies  $^{\sim}$  are obtained using the form ulofSec.V and matrix elements Q,R,S,T and U calculated in Appendix A.

Table I sum m arizes these results for states of rotational sym m etry  $C_L$ , with L=2, 3, 4 and 5. Some particular shapes obtained from these coe cients and Eq. (14) are shown in Fig. 6 [for a comparison with similar states for vortex patches see Figs. 8 and 9].

For large deform ations, the appearance of oscillations indicate that higher order terms are needed, since the perturbative method corresponds to a truncation of the Fourier decomposition [Eq. (14)]. An alternative approach, based on a local induction approximation, pro-

vides a better description in those cases. This alternative formulation is presented in Sec. V II.

It is interesting to note that the linear result for the frequency is [see Eqs. (25) and (A3)]

where the last sum can be related to the digamma function  $^{22}$  (jl)  $\pm 1=2$ ). This linear result has been previously derived by several authors;  $^{18}$  corrections are 0  $\mathbb{D}_{1}^{2}$ ]. For a direct comparison with Eq. (5), which corresponds to the large-1 limit, we substitute the asymptotic expansion for the sum in Eq. (30); multiplication by R<sub>0</sub> yields the propagation velocity:

#### VII.LOCAL INDUCTION APPROXIMATION

As we have seen, the motion of the edge is determined by the velocity of the uid at the surface. The nonlocal equation for the velocity of the boundary, Eq. (9), can be turned into a dierential equation for the curvature of the boundary if we concentrate on the local contributions. This local induction approximation (LIA)<sup>26</sup> was explored by Goldstein and Petrich in a series of papers dealing with the evolution of vortex patches. The situation is considerably more favorable in this problem, due to the more rapid decay of the interaction [l=r for charges vs. ln(r) for vortices, see Eqs. (9) and (B3)]. Figure 1 de nes most terms used in this section.

The LTA corresponds to the introduction of a large distance cut-o in the expression for the velocity of the boundary v[r(s)] Eq. (9)]:

It is worth noting that since the rate of change of the area A of the droplet is  $A_{\,t}\!=\!-ds\,U$  (s) [see Eq. (D 8)], the L IA with  $U_{\rm L\,IA}$  /  $_{\rm S}$  (or any exact di erential) autom atically conserves area. This is not surprising since we started with an incompressible system, but shows that the local approximation used has not introduced an obvious error. It is also interesting to realize that the perimeter L of the curve derived from these velocities is conserved as well:  $L_{\,t}\!=\!-ds\,(\,U\,+\,W_{\,s})=0$  [see Eq. (D 7)].

The time evolution of a curve in two dimensions is given quite generally by the integro-di erential equation  $^{16;27}$  (see Appendix D)

The mKdV dynamics are integrable, with an in nite number of globally conserved geometric quantities, 12 the most important of which are the center of mass, area, and angular momentum of the droplet.

Them K dV equation possesses a variety of soliton solutions, including traveling wave solutions and propagating \breather" solitons (see Appendix F). Here we will focus on the traveling wave solutions of Eq. (39) of the form




FIG.3. A uniform ly propagating edge deform ation. The curvature satis es (s;t) = (z), with z = s ct.




FIG.4. Some possible potentials V () and corresponding schem atic solutions for the shape of the boundary. Potentials with two real zeros may have physical solutions: (a) Curvature is xed, the solution is a circle; (b) Curvature is positive de nite, the boundary is convex; (c) Positive and negative curvatures. (c) Potentials with four zeros have solutions with unphysical self-intersections.

This problem is thus analogous to a particle moving in a quartic potential (Fig. 4). The integrals involved can be expressed in terms of elliptic integrals  $^{22}$  and depend crucially on the nature and location of the zeros of V (). For curves with nite perimeter and no self-crossings we not that it is necessary to have two real and two complex zeros:  $_{\text{max}}$ ,  $_{\text{min}}$ , and  $(_{\text{max}} + _{\text{min}}) = 2$  i (see Appendix E). Note that  $_{\text{max}}$  and  $_{\text{min}}$  correspond to the maximum and minimum curvatures of the boundary.

It is evident that the resulting curves are invariant under rotations by 2 =1, that is the curves have  $C_1$  sym metry. The curves thus generated can be characterized by (1;  $_{\text{m ax}}$ ;  $_{\text{m in}}$ ) or m ore conveniently, although indirectly, by the sym m etry, the area and the perim eter of the curve.




FIG.5. Illustration of the boundary conditions in plied by Eq. (47). Top: after lperiods L of the curvature (s), the tangent angle increases by precisely 2 . Bottom: the resulting deformed boundary.




FIG. 6. Uniform by rotating shapes of a 2D ES. Solid lines: solutions of the m K dV equation obtained from the local induction approximation. Dotted lines: solutions obtained using the perturbative expansion. The values of the coe cient b<sub>1</sub>, and the ratio of curvatures  $m_{in} = m_{ax}$  are: (a)  $b_2 = 0.073$ ; = 0.4; (b)  $b_2 = 0.19$ ; = 0; (c)  $b_2 = 0.36$ ; = 0.2; (d)  $b_3 = 0.027$ ; = 0.4; (e)  $b_3 = 0.10$ ; = 0.2; (f)  $b_3 = 0.29$ ; = 0.45; (g)  $b_4 = 0.014$ ; = 0.4; (h)  $b_4 = 0.089$ ; = 0.4; (i)  $b_4 = 0.24$ ; = 0.56.

The full lines in Fig. 6 show some uniform ly rotating soliton shapes, calculated from Eqs. (44) and (48). These are essentially identical with Goldstein and Petrich's 16 soliton solutions for the vortex patch problem, but the more local nature of the interaction in the 2DES case should guarantee a better correspondence with the exact solutions including non-local terms. Indeed, the curves resulting from the perturbative method and the LIA are quite close, even for considerable deformations of the boundary. For larger deform ations the perturbative results show artifacts due to the limited number of Fourier com ponents. The advantage of the LIA becom es evident in this case, since it is an expansion in powers of the curvature and not the deform ation, and thus allows for relatively large long-wavelength deform ations. More signi cantly, the LIA and the resulting integrable dynam ics allow one to uncover geometrical conservation laws which would be hidden in a perturbative calculation.<sup>28</sup> This advantage comes at a price: the detailed inform ation on frequencies is obscured by the introduction of the long distance cut-o and by the gauge transform ation of the tangential velocity W, while the frequency is easily obtained in the perturbative calculation.

#### V III. C O N C LU S IO N S

A contour dynam ics form ulation of the excitations on the edge of a two-dimensional electron system in a magnetic eld has allowed us to demonstrate the existence, beyond the usual linear regime, of shape deformations that propagate uniformly. A local approximation to the nonlocal dynamics shows that the curvature of the edge of the droplet obeys the modiled Korteweg-de Vries equation, which has integrable dynamics and soliton solutions. Earlier studies of edge channels in QH samples have shown the presence of nonlinear waves, but in Ref. 29 the nonlinearity originates in the variations of the strength of the conning eld (the  $E_{\rm ext}$  of Sec. II), whereas here we concentrate on nonlinear elects originating in geometrical elects.




FIG.7. Soliton excitations travel without shape changes. In a circular QH system  $^{24}$  with non-contact probes it is possible to observe repeated signals. While a gradual decrease of the amplitude is always expected due to residual dissipation, dispersive and non-dispersive modes may be distinguished by the preservation of the general shape and width of the non-dispersive modes.

Since these solutions are dispersionless, it may be possible to distinguish them from linear edge waves in time-of-ight measurements of the type depicted in Fig. 7. In a circular QH system 24 a voltage pulse applied to a gate produces an edge deformation. The deformation propagates along the edge of the system in one direction and is detected, i.e. by means of a capacitive probe. For this geometry, the pulse comes back repeatedly and it is possible to observe it after numerous passes. While a gradual decrease of the amplitude is always expected due to residual dissipation, dispersive and non-dispersive modes may be distinguished by the preservation of the general shape and width of the non-dispersive modes.

On the theoretical side, it would be interesting to con-

nect our hydrodynam ic treatm ent of these edge solitons with eld-theoretical treatm ents of edge excitations. 18;19

Higher order terms are long and uninspiring.

## APPENDIX B:COMPARISON WITH THE VORTEX PATCH CASE

For the sake of comparison, we draw analogy to the case of a vortex patch, a two-dimensional, bounded region of constant vorticity  $!_p$  surrounded by an irrotational uid. The vorticity can either be distributed, as in a regular uid, or concentrated in individual vortices, in the case of a super uid (in this case it is clear that the hydrodynam ic treatment will be valid only for length-scales larger than the inter-vortex spacing). The important thing is that in ideal uids the area of the vortex patch is conserved due to Kelvin's circulation theorem,  $^{26}$  and therefore the vortex patch is essentially incompressible. Figure 1 can be used to describe this case by replacing the electron density n by the vorticity  $!_p$ .

The steady state solution in this case is clearly a circle, and small deform ations of the boundary travel along the boundary itself, as has been known for a long time. One can also ask what happens when the deform ations are large: are there modes that do not change shape, i.e., solitons? One such solution has been known since K irchho 's time: an ellipse with constant vorticity will rotate uniform ly in an ideal uid. Numerical calculations by Deem and Zabusky<sup>12;11</sup> in the 70's obtained additional invariant shapes.

For inviscid incompressible uids, the equations of motion for the uid are simply given by:

The arguments presented in Secs. III and IV are now applied mutatism utandis to this case. The only dierence with the 2DES comes from the fact that the kernel

in the interaction is now logarithm ic, and Eq. (9) is then replaced by Eq. (B3). We see that, as in the 2DES case (Secs. III and IV), the dynam ics is chiral, being determined by the tangent vector; and since the uid contained within is incompressible the area is conserved. The normal velocity of the contour is then given by




FIG. 8. The l=2 stationary deform ations of a vortex patch. D otted line: the K ircho ellipse. Full line: perturbative solution. (a)  $b_2=0.2$ , (b)  $b_2=0.3$ .




FIG. 9. Vortex-patch \eigenstates" with L = 3 and L = 4. (a)-(d) 0 btained num erically by D eem and Zabusky [ gures are scanned from Ref. 11]; (e)-(h) D eterm ined perturbatively. The lowest harmonic  $b_L$  is taken in each case from Table I of Ref. 11:  $b_3$  = 0.096,  $b_3$  = 0.11,  $b_4$  = 0.048 and  $b_4$  = 0.070 respectively. The solutions are essentially identical and are too close to compare electively in the same picture.

We then apply the results of Sec. V, to determ ine the amplitude of the lowest harm onics for the vortex-patch case, using the appropriate matrix elements Eqs. (B5) { (B7)]. These results are summarized in Table II, and some of the resulting invariant shapes are shown in Figs. 8 and 9.

It has long been known  $^9$  that an elliptical region of vorticity in an otherw ise irrotational uid, namely the K irchho ellipse, rotates uniformly with angular frequency  $= (!_p=4) (1 \quad B=a^2)$ , where (a+b) and (a-b) represent the maximum and minimum radii respectively (see Appendix C). A simple analysis shows that both frequency and angular components  $b_1$  shown in Table II exactly match a series expansion of the ellipse. Figure 8 compares the perturbative results with the exact solution. Even for relatively high deformations both results are in reasonable agreement.

In the case of deform ations with higher angular de-

pendences there are no analytic solutions beyond the linear approximation. In this case, the angular frequencies are given to zeroth-order in the deformation by = (m 1)=2m, which coincides with the values for  $\mathbb{Q}_1^V$  [see Eqs. 25 and B5]. Numerical solutions by Deem and Zabusky for 1=3; 4 also compare favorably with the perturbative results, as can be seen in Fig. 9. In fact, the angular velocities determined from Table II coincide with those shown in Ref. 11 to all signicant gures of that paper.

APPENDIX C:THE KIRCHHOFF ELLIPSE AS A SOLUTION OF A CONTOUR DYNAM ICS PROBLEM

It is illustrative to show, starting from the contour dynam ics, that an ellipse is indeed an invariant deform ation for a vortex patch. A dditionally it can be shown that this is an inherent property of the logarithm ic kernel  $\mathbb{E}q.B3$ ] and that an ellipse it is not a solution for the 2DES.




FIG.10. Param etrization of a closed curve by a param eter de ned on a xed interval. The illustration shows the arc-length s, the normal and tangential unit vectors  $\mathbf{n}$  and  $\mathbf{t}$  and the tangent angle .




FIG.11. Examples of closed boundaries for the solutions corresponding to four real zeros of V ( ). Note that all curves cross them selves at least once and are not physical solutions for the problem of interest.

Since there is no cubic term in the potential V ( ), the sum of all roots must vanish. That leaves only one free parameter in each case, once the minimum and maximum curvatures are xed. As mentioned in Sec. V II, this free parameter is determined by the boundary condition that the curve is closed and without self-crossings. For the case of four real zeros, it is not possible to nd solutions that satisfy these conditions. It is still possible to nd beautiful closed curves (Fig. 11), but these do not correspond to physical solutions for the problem under consideration. The case with two real and two complex conjugate solutions does have physical solutions and is discussed in detail in Sec. V II.

## APPENDIX F:THE STRAIGHT INFINITE EDGE

In Sec.VII we discussed the invariant shapes of a closed curve when the curvature satis es a modi ed Kortewegde Vries equation (39). Single soliton solutions where

the curvature satis ed (s;t) = (s ct) were obtained by twice integrating Eq. (39), thus resulting in Eq. (41), which can then be reduced to a simple problem in quadratures [Eq. (42)] and the solutions for the curvature in terms of Jacobi elliptic functions were discussed in that context [see also Appendix E].

In the case of an in nite curve, however, and all its arc-length derivatives should vanish as s! 1, and the constants of integration a=b=0 in Eqs. (41) and (43), so that V () =  $^4$ =4 c $^2$ . The traveling wave solutions can then be found as

Unfortunately these curves represent a small loop traveling along the boundary, and self-crossing solutions are not possible for the boundary of a physical system.

It is, however, possible to have more complicated solutions that have a traveling envelope with time dependent oscillations within it. One such example is the \breather" solution, 15 which loosely speaking, corresponds to a pair of bound solitons:




FIG.12. A breather soliton for k=2 and l=1. In this time sequence t=0:125.
