Entropy and typical properties of N ash equilibria in two-player gam es

We use techniques from the statistical mechanics of disordered systems to analyse the properties of N ash equilibria of bin atrix games with large random payom atrices. By means of an annealed bound, we calculate their number and analyse the properties of typical N ash equilibria, which are exponentially dominant in number. We not that a random ly chosen equilibrium realizes almost always equal payo s to either player. This value and the fraction of strategies played at an equilibrium point are calculated as a function of the correlation between the two payom atrices. The picture is complemented by the calculation of the properties of N ash equilibria in pure strategies.

G am e theory seeks to m odel problem s of strategic decision-m aking arising in econom ics, sociology, or international relations. In the generic set-up, a number of players choose between di erent strategies, the combination of which determ ines the outcome of the game speci ed by the payo to each player. Contrary to the situation in ordinary optim ization problem s, these payo s are in general di erent for di erent players leading to a competitive situation where each player tries to maxim ize his individual payo . One of the connerstones of m odem econom ics and game theory is therefore the concept of a N ash equilibrium [3], see also [4], which describes a situation where no player can unilaterally im prove his payo by changing his individual strategy given the other players all stick to their strategies. How ever this concept is thought to su er from the serious draw back that in a typical gam e-theoretical situation there is a large number of N ash equilibria with di erent characteristics but no means of telling which one will be chosen by the players, as would be required of a predictive theory.

This conceptual problem already shows up in the paradigm atic model of a bim atrix gam e between two players X and Y where player X chooses strategy i 2 (1:::N) with probability x_i 0 and player Y chooses strategy j 2 (1:::N) with probability y_j 0. The vectors $x = (x_1; ...; x_N); y = (y_1; ...; y_N)$ are called mixed strategies and are constrained to the (N 1)-dimensional simplex by norm alization. For a pair of pure strategies (i; j) the payo to player X is given by the corresponding entry in his payo m_patrix_{aj} whereas the payo to player Y is given by b_j . The expected payo to player X is thus given by $x(x;y) = \sum_{i,j} x_i a_{ij} y_j$ and analogously for player Y. Every player has the intention to maxim ize his own payo . A Nash equilibrium (NE) (x;y) is defined by

since in this situation there exists nomixed strategy x which will increase the expected payo to X given Y does not alter his strategy and vice versa for Y. Thus no player has an incentive to unilaterally change his strategy.

A part from applications in econom ics, politics, sociology, and mathematical biology, there exists a wide body of mathematical literature on bimatrix games concerned with fundamental topics such as exact bounds for e.g. the number of NE [5] and e cient algorithms for locating them [6]. For games even of moderate size a large number of NE are found, forming a set of disconnected points. In general the diment NE all correspond to diment payo s to the players.

However many situations of interest are characterized by a large number of possible strategies and complicated relations between the strategic choices of the players and the resulting payo s. In such cases it is tempting to model the payo s by random matrices in order to calculate typical properties of the game. This idea is frequently used in the statistical mechanics approach to complex systems such as spin glasses [7,8], neural networks [9], evolutionary models [10], or hard optim ization problems [11]. Recently this approach has been used to investigate the typical properties of so-called zero-sum games [12].

In this Letter we investigate the properties of N ash equilibria in large bim atrix gam es with random payo s, i.e. with random entries of the payo matrices. U sing techniques from the statistical mechanics of disordered systems we estimate the number of NE with a given payo . We nd that the NE are exponentially dominated in number by equilibria with a certain payo .

In this approach characteristics of the gam e are encoded in the distribution of payo matrices { with only a few parameters { instead of the payo matrices them selves. Clearly the choice of the probability distribution to be averaged over can in uence the results. However a number of sim plifying observations may be made: the two payo matrices may be multiplied by any constant or have any constant added to them without changing the properties of the gam e in any material way. Thus there is no loss of generality involved in considering payo s of order N¹⁼² and of zero mean. We assume that the entries of the payo matrices at di erent sites are identically and independently distributed. In the therm odynamic limit one mds that only the matrices two moments of the payo distribution are relevant so the entries of the payo matrices may be considered to be G aussian distributed. The only property of the distribution of payo s which is not may be the entries of the payo matrices to be drawn random ly according to the probability distribution.

Thus for = 1 one nds a Dirac-delta factor $(a_j + b_{ij})$ in (2) corresponding to a zero-sum game. = 0 corresponds to uncorrelated payo matrices and = 1 gives the so-called symmetric case $a_j = b_{ij}$ where the two players always receive identical payo s. The parameter consequently describes the degree of similarity between the payo s to either player and m ay be used to continuously tune the game from a zero-sum game to a purely symmetric one. The form er admits no cooperation at all between the players. Negative correspond to an on average competitive situation, whereas for increasing there are more and more pairs of strategies which are bene cial to both players.

As a starting point for the statistical mechanics calculations, we remark that (1) is equivalent to the set of inequalities

Due to the non-negativity of the probabilities x_i and y_j this directly results in the local equations specifying a NE with payo s x and y

We introduce real-valued variables x and y with $x_i = x_i$ (x_i) (where (x) is the H eaviside step-function) and likew ise for y_i . Then the last conditions (4) may be written as

i.e. we have constructed indicator functions I_i^x and I_i^y which are zero at a NE (x;y) and non-zero elsewhere [13]. The number N (x; y) of NE with payo s x and y may thus be calculated from

where the mixed strategies have been rescaled to $i_{j}x_{i} = i_{j}y_{j} = N$ for convenience. Although we expect an exponential number of NE, so $\ln N$ is an extensive quantity, we calculate the so-called annealed average $\ln \overline{N}$ instead

of the quenched one $\overline{\ln N}$. This gives an exact upper bound to the typical number of NE at given payo s^1 . Using integral representations of the delta functions in (6), averaging over the disorder (2), and introducing the order parameters $q^x = N^{-1} + \frac{1}{i} x_i^2$ (x_i), $R^x = N^{-1} + \frac{1}{i} x_i x_i$ (x_i), and similarly for player Y we obtain

Here we have used the assumption that the normalizing determinant k det (B) k = k $\frac{e(1^x, 1^y)}{e(x, y)}$ k is self-averaging and is e ectively uncorrelated with the rest of expression (7) and m ay therefore be averaged over the disorder independently of the rest of the expression [13]². We obtain

where the fraction of strategies played with non-zero probability $p_x = N^{-1} P_{i}$ (x_i) is determined self-consistently by introducing p_x , p_y and their conjugates \hat{p}_x , \hat{p}_y in (7). A fler the transformation $iq^{x_{iy}}$! $q^{x_{iy}}$ and similarly for $E^{x_{iy}}; \hat{p}^{x_{iy}}; R^y$, the integrals over $x; \hat{x}; y; \hat{y}$ may be performed. In the limit of large payomatrices N! 1, the integrals over the order parameters are dominated by their saddle point. Furthermore (7) is now symmetric under an interchange of the players, and the maximum (and hence exponentially in N dominating) number of NE is found at equal payomator is to each player. Thus it makes sense to restrict the analysis to the case x = y = . We obtain

From this expression the statistical properties of the entire spectrum of player-sym metric NE m ay be deduced. In the therm odynam ic limit, a random ly chosen NE will give the payo $y = y = x = \arg \max S$ () with probability one, because the number of NE with this payp N (; p) = expfN m axS () g is exponentially larger than the number of all other NE. Similarly, the self-overlap $q = x_i^2 = y_j^2$ and the fraction of strategies played with non-zero probability $p = p_x = p_y$ will take on their saddle-point values of (9) evaluated at the maximum of S () with probability one.

¹The annealed approximation does not dier by more than 3% in the entropy and by 10% in the order parameters from the results of the more complicated replica calculation of the quenched average, which will be presented elsewhere.

²This assumption ha been veried by explicitly including the calculation of the elective normalizing determinant into the disorder average.




FIG.1. The entropy S of the NE which exponentially dom inate the spectrum S (). The analytic results are compared with num erical simulations for N = 18 averaged over 100 sam ples.

Figure 1 shows the entropy S at the maximum of S () as a function of . The num erical results were obtained by enum erating all NE for N = 18 [6,14]. Given that enum eration is only possible for sm all sample sizes, the agreem ent between the annealed approximation and the num erical results is quite good.




FIG.2. The pays (solid line) and the fraction p of strategies played with non-zero probability (dashed line). The analytic results are compared with numerical simulations for N = 50 averaged over 200 samples.

Figure 2 shows the payo and the fraction p of strategies played with non-zero probability again as a function of . The num erical results were obtained for N = 50 by using the iterated Lem ke-H ow son algorithm [15,6], which locates a single but typical NE. The deviation between analytic and num erical results m ay be accounted for by the use of the annealed calculation and nite-size e ects.

For zero-sum games (= 1) there is only a single NE [12] so S = $_0$ = 0, and the payo is zero due to the symmetry between the players. As is increased the number of NE rises. The maximum of the typical number of NE is reached for the case of symmetric games, where S = $_1$ 0:362. This result may be compared with a rigorous upper bound derived using geometric methods [5,6], which states that for any non-degenerate N -by-N bimatrix game with large N there are at most e^{0:955N} equilibrium points. Thus the typical-case scenario investigated here does not saturate this bound.

The increase of with may be understood as follows: At increasing the outcome of a pair of strategies (i; j) which is bene cial to player X say, tends to become more bene cial to player Y. As a result players focus on these strategies and the payo to both players rises. By the same token the fraction p of strategies which are played with non-zero probability at a NE decreases with and the self-overlap of the mixed strategies q increases.

Even though the properties of the NE at a given are dominated by the peak of S (), there is an important qualitative di erence between the curves of di erent values of . For $1 < \leq 59$, S () reaches its

maximum and then decreases crossing the S = 0 axis at some point. For > c however, S (! 1)! 0+ and p! 0+. Hence there is an exponential number of NE o ering an arbitrarily large (but nite) payo to either player.

This observation can be corroborated by considering the extrem e case of pure strategy N ash equilibria (PSNE) (i; j) where each player only plays a single (pure) strategy [16], i.e. $x_i = N_{1^0i}$; $y_j = N_{j^0j}$; $8i^0$; $j^0 = 1$; ...; N. A coording to (3), a PSNE corresponds to a site (i; j) which is simultaneously a maximum of the column a_{i^0j} and a maximum of the corresponding row of b_{ij^0} . The average of the number M of PSNE is thus given by

where p(a;b) denotes one of the G aussian factors in (2).




FIG. 3. A verage number \overline{M} of PSNE for N = 25;50;100 (full, dashed, dotted lines). The lines show analytical result (10), the sym bols num erical results, averaged over 1000 sam ples. Inset: Num erical results for the logarithm of \overline{M} (circles) and of $\overline{M^2}$ $\overline{M^2}$ with = 0.25;0.5;0.75 (bottom to top) against ln N. The dashed lines show the asymptotic slope 2 = (1 +) of \overline{M} .

Figure 3 shows the average number of PSNE as well as its variance as a function of . For N ! 1 one nds from (10) that M scales with N² = (1+), so the number of PSNE vanishes for < 0, at = 0 there is on average 1 PSNE, and for > 0 the number of PSNE diverges. The increase of the number of PSNE with may be understood as follows. At low , a and b are anticorrelated, so in the extrem e case = 1 a PSNE corresponds to a site (i; j) which is simultaneously a maximum of the column a_{i^0j} and a minimum of the row $a_{ij^0} = b_{ij^0}$. In the therm odynamic limit, such points are exponentially rare. For large , the condition for a PSNE is much easier to full ll and in the case = +1, there is always at least one PSNE, namely the maximum entry of $a_{ij} = b_{ij}$.

Note that apart from the point = 0, the number of PSNE is also self-averaging as the relative sample-to-sample uctuations of M are found to vanish in the large N -lim it. Furtherm ore for all > 1 the typical PSNE payo s to leading orders of N are found to be independent of , they are $N(2 \ln N \ln \ln N + O(1))$.

In conclusion we have used methods from the statistical mechanics of disordered systems to describe the typical properties of N ash equilibria in bin atrix gam eswith large random payo matrices. We not that in the therm odynamic limit for a random ly chosen N ash equilibrium quantities such as the fraction of strategies played with non-zero probability, the self-overlap of the mixed strategies and most importantly the payo to either player take on a specie c value with probability 1. We have analytically calculated these quantities in the annealed approximation as a function of the properties of N ash equilibria in pure strategies were calculated as a limiting case. A number of extensions of this work may be considered, including the case where the players have dimenting the random set of strategies at their disposal and the generalisation to gam es of several players.
