Dynamics of a Ring of Di usively Coupled Lorenz O scillators

A bstract

We study the dynam ics of a nite chain of di usively coupled Lorenz oscillators with periodic boundary conditions. Such rings possess in nitely many xed states, some of which are observed to be stable. It is shown that there exists a stable xed state in arbitrarily large rings for a xed coupling strength. This suggests that coherent behavior in networks of di usively coupled system s m ay appear at a coupling strength that is independent of the size of the network.

1 Introduction

Lattices of coupled dynam ical system s have been studied in m any di erent contexts: as discrete versions of partial di erential equations of evolution type [10], [22], m odels of neuronal networks [6], [18] and phase lock loops [4], and in statistical mechanics [14]. The particular problem of synchronization and emergence of coherent behavior in lattices of di usively coupled, chaotic, continuous time dynam ical system s has received m uch attention recently due to its applications in neuroscience [1], [18], and chaotic synchronization [19], [16].

A nalytical results in the literature suggest that the coupling strength necessary for the appearance of coherent behavior in networks of chaotic systems grow with the size of the network [5],[4],[15]. For instance, estimates of A fraim ovich and Lin [5] suggest that the coupling strength necessary to synchronize a lattice of generalized forced D u ng systems grows as a high power of the size of the lattice. Since stable, coherent states in lattices may frequently be viewed as instances of generalized synchronization [19], one might guess that the appearance of dynam ically stable states of this type also requires that the coupling grow s with the number of oscillators in the system. This would make it unlikely that such networks are of in portance in nature, since the coupling strength in realistic systems cannot be varied by orders of magnitude.

In contrast to these theoretical results, the num erical experim ents of H uerta, et. al. [18] indicate that partial synchronization m ay appear in certain networks of chaotic system s at a nearly constant coupling strength, regardless of the size of the network. In particular,

[18] considered a system with about 10^4 coupled neurons. Each neuron was modeled by a system of three nonlinear, ordinary di erential equations which, when uncoupled, underwent chaotic motion. They observed a variety of di erent stable, coherent motions including a number of states that exhibited roughly periodic patterns. It is the goal of this paper to show rigorously that such such stable, coherent states can occur in arbitrarily large system s of coupled chaotic oscillators at a coupling strength which is independent of the size of the system .

Since the Lorenz system is one of the paradigm s of chaotic ow s, we have chosen a ring of di usively coupled Lorenz equations for our investigations. The system s in the ring evolve according to the equations

where $x_i = x_{i-1} - 2x_i + x_{i+1}$ with the index i taken modulo n is the discretized Laplacian with periodic boundary conditions. The constants = 10; r = 27, and = 8=3 are chosen so that each uncoupled system would be in the chaotic regime. Following the work of [18], we will focus on the case $d_x \in 0$, $d_y = d_z = 0$. As shown in [19], such a ring is synchronized identically for su ciently large values of d_x . We will be concerned with the case when d_x is su ciently large for coherent spatial structures to emerge in the chain, but insu cient to synchronize the ring.

The paper is organized as follows: Typical spatial structures observed in numerical experiments are described in section 2. In particular, we give examples of stable stationary states, traveling waves, and breathers. In section 3 a general framework for the study of xed states in chains and rings of dynamical systems is discussed. We show that the existence of such states can be reduced to the study of periodic solutions of reversible dynamical systems on \mathbb{R}^n . We then apply these results to two di erent cases, including the chains of coupled Lorenz oscillators (1), to show that a large number of xed states can be expected in such rings. The conditions under which these states are stable are investigated in section 5. We then show how F loquet theory can be used to reduce the stability question in lattices of arbitrarily m any oscillators to the study of the spectrum of a matrix of xed size (but depending on a parameter { the \quasi-m om entum ".) F inally, in section 6 we im plem ent this program to rigorously construct an example of a spatially periodic stable xed state which rem ains stable for rings of arbitrary size.

2 Num erical Experim ents

Num erical experiments were performed on a Sun SuperSparcusing the num erical integration program XPP. Several dierent integration methods were used to check the validity of the results. These included xed and variable step Runge-Kutta methods of varying order and the Gearm ethod.

At very low values of the coupling constant d_x , the individual system s in the ring behaved as if they were uncoupled. As the coupling strength was increased the behavior of the ring became m ore coherent. Since the discrete Laplacian acts to synchronize neighboring

system s in the ring, these results agree with our expectations. A s was emphasized in the introduction, the onset of the coherent behavior occurred at coupling strengths which seem ed to be independent of the number of oscillators in the ring. Some of the typical structures observed in these num erical experiments are discussed below.

2.1 B reathers

If some of the system s in the ring are nearly stationary, while others are undergoing oscillations we say that the oscillating system s form a breather. Since we are considering rings of nite size, it is not expected that any single system in the ring is stationary, unless the entire ring is stationary.

An example of a system with two breathers is shown in gure 1. It is interesting to note that in these states each of the individual systems undergoes oscillations that are nearly periodic, and that there is a strong spatial dependence on the motion. Loosely speaking the motion of each individual system is trapped in a region close to one of the 'lobes'' of the Lorenz attractor. No stable states in which all systems in the ring are trapped in the vicinity of only one \lobe'' has been observed. Sim ilar breathers have been studied in coupled m ap lattices in [8], while occurrences of nearly periodic behavior with pronounced spatial patterns in lattices of chaotically bursting neurons have been observed num erically by M J. Rabinovich, et. al. [23].

A nother interesting feature of breathers, which is also shared with other types of solutions of this network, is that frequently nonadjacent systems synchronize without synchronizing with the oscillators that lie between them. The synchrony is usually not exact, however this may be due to numerical errors in the calculations. Due to the many symmetries of the system this sometimes seems to be due to the stability of an invariant manifold corresponding to a partially synchronized state in the chain as discussed [19]. In other cases the state does not appear to be symmetric, and it is unclear what the mechanism behind this synchronization is.

It is important to note that some of the qualitative features of the dynam ics remain una ected by the size, or the coupling strength in the ring. Figure 2 shows stypicaltim eseries of the x variable at four di erent coupling values in a ring of 32 oscillators. Note the sm ooth envelope and regularity of the oscillations, as well as the agreem ent of the tim escales am ong the di erent tim eseries. These general features remain unchanged as the num ber of system s in the ring is varied, as long as the coupling is below the synchronization threshold and above the value necessary for the appearance of coherent behavior.

2.2 Stable Stationary States

In num erical experim ents with rings of 8 to 52 systems stable steady states were observed for a variety of initial conditions for $d_x > 10$. Typical stable xed states are shown in gure 3.

For certain values of the coupling it appears that all initial conditions lead to one of the stationary states of the system. The basins of attraction of the stationary states seem to be intertwined in a complicated way in this case, as shown in gure 3. The same is true for other stable states of the system. Sm all changes in the initial values of the parameters, and changes in the initial values of the integrating m ethods can result in very di erent asymptotic behavior of the

system. This situation is similar to that of attractors with riddled basins of attraction [7], and was also observed in num erical simulations of networks of chaotically bursting neurons [18].

2.3 Traveling Pulses

Traveling pulses were observed in the ring only when $d_x \notin 0$ and $d_y \notin 0$. A typical traveling pulse is shown in gure 4. The pulse oscillates as it propagates along the chain, and is thus a periodic, rather than a xed state in a moving coordinate fram e. This can be seen in the tim escries in gure 4.

3 A General Fram ework for the Study of Steady States

System (1) is a special case of a lattice discrete or continuous tim e dynam ical system

where $j 2 Z^{D}$, $u_{j} 2 R^{p}$ and $fu_{j}g^{s} = fu_{i} : ji j g$ sg. In the following discussion we will use the convention that in u_{i}^{k} the subscript $i 2 Z^{D}$ denotes the position in the lattice, while the superscript 1 k p denotes the component of the vector u_{i} . Such system s have been studied by m any authors [2], [10], [22] as discrete versions of partial di erential equations of evolution type.

We will mainly be concerned with systems continuous in time with D = 1 and s = 1. These are simply chains of systems coupled to their nearest neighbors. The special case of rings, that is chains of nite size with periodic boundary condition will be the focus of our attention. A state in a ring of n systems corresponds to a state of period n in the spatial variable in an in nite chain.

A steady state of a chain given in (2) is determined by

in the continuous, respectively discrete case. W e will study system s that satisfy the following condition:

0 for all values of ; ; then either there exists a point (a;b;c) 2 R^{3p} such that F (a;b;c) = 0 and therefore a function G (;) such that F (; ;G (;)) = 0, or F (; ;) = 0 has no solutions and there are no xed points of (2). If such a function G exists and we de ne $u_{j+1} = G(u_j;u_{j-1}), x_j = u_j$ and $y_j = u_{j-1}$ this leads to the following dynam ical system on R^{2p} :

The steady states of (2) are given by the x-coordinates of the orbits of (5). In general, the function G m ay not be unique, in which case more than one system of the form (5) is needed to determ ine all the xed points of the chain. An equivalent argument holds in the case of discrete time.

Since the function G can assume any form, not much can be said about such systems in general. The subclass of chains of systems with the following type of coupling is easier to analyze.

De nition 3.1 A nearest neighbor coupling of a chain of systems is said to be symmetric if $(u_{j-1}; u_{j}; u_{j+1}) = F(u_{j+1}; u_{j}; u_{j-1})$.

This simply means that a system in the chain is coupled to its left and right neighbor in the same way. For instance the couplings $u_j = u_{j-1} - 2u_j + u_{j+1}$ and $u_j = u_{j-1}u_{j+1} + u_j$ are of this type. The stationary states of symmetrically coupled chains are related to the following class of dynamical system s:

Denition 3.2 Given a dieomorphism : R^{2p} ! R^{2p} and an involution $R : R^{2p}$! R^{2p} such that the dimension of the xed point set of R is pwe say that is R-reversible if

The dynamical system de ned by $x_{i+1} = (x_i)$ is also said to be R-reversible.

The relation between symmetrically coupled chains and reversible systems is given in the following

Theorem 3.3 The xed states of a symmetrically coupled chain of systems satisfying condition 1 correspond to the orbits of a dynamical system of the form (5) which is R-reversible and volume preserving. For such a system R (x;y) = (y;x), with x;y 2 R^p.

P roof: The arguments for the continuous and discrete case are virtually identical, so only the rst will be considered. Equation (3) together with the assumption that the coupling is symmetric implies that

where $x_j = z_j = u_j$, $y_j = u_{j-1}$ and $w_j = u_{j+1}$. The action of these systems is shown schematically in gure 5.

Let R(x;y) = (y;x) and (x;y) = (G(x;y);x) so that the dynamical systems in (9) is generated by . By the denition of this die on orphism

Since R is an involution with Fix(R) = f(x;y) : x = yg the dieomorphism and the dynamical system it induces on the plane are R-reversible.

To prove that the map is volum e preserving notice that

By the de nition of the function G we know that F (;;G(;)) = 0 so that di erentiating with respect to leads to

 D_3F is an invertible matrix by C ondition 1, so that $D_2G = D_1F(D_3F)^{-1}$. By assumption the system is symmetric so that $D_1F = D_3F$ at all points in R^{3p} and hence $D_2G = I$. Since

it follows that det D = 1 and the dieom orphism is volume preserving. }

R-reversible systems have many properties that facilitate their study. We will make use of several of these sum marized in the following proposition adopted from [12]

Proposition 3.4 Let R and be as in De nition (3.2).

- a. If p 2 Fix (R) and ^k (p) 2 Fix (R), then ^{2k} (p) = p. Such periodic points will be referred to as symmetric periodic points.
- b. Let $p \ge Fix(R)$ be a xed point of , then $R(W^{u}(p)) = W^{s}(p)$ and $R(W^{s}(p)) = W^{u}(p)$ so that if $q \ge W^{u}(p) \setminus Fix(R)$ then q is a hom oclinic point.
- c. If p 2 Fix (R) is a xed point of such that W ^u (p) intersects Fix (R) transversally at a point q, then there exist in nitely m any sym m etric periodic points in any neighborhood of p.

4 Steady States In the Case of Discrete Laplacian Coupling

For a chain of systems of the form $u^0 = f(u)$ coupled through a discrete Laplacian $u_j = (u_{j-1} - 2u_j + u_{j+1})$ the equation (2) takes the form

and the dynam ical system (5) takes the form

where c = 0 in the case of continuous time and c = 1 in the case of discrete time. The following proposition follows immediately from these denitions

P roposition 4.1 The xed points of (16) are of the form $x_i = y_i = u_0$ where u_0 is any solution of the equation f(u) = 0 in the continuous time and f(u) = u in the discrete time case. Thus all xed points of (16) lie on $Fix(\mathbb{R}) = f(x;y) : x = yg$ and are in 1-1 correspondence with the steady states of an uncoupled system in the chain.

The xed points of (5) correspond to states of the chain that are constant in space and time and proposition 4.1 shows that the only such states fu_jg_{j2Z} in the case of a discrete Laplacian coupling are given by $u_j = u_0$ for all j 2 Z where u_0 is a xed point of an uncoupled system of the chain $u^0 = f(u)$. Since the xed points of (16) are $(u_0; u_0) 2$ Fix (R) this allows us to make use of proposition $3.4 c^1$.

M oreover we can apply Theorem 3.3 directly in this case to conclude that the map de ning the xed points is R-reversible and volume preserving.

R em ark: It is interesting to note that if the xed states of a chain of one dimensional system s are determined by a dynamical system of the form (16) on R^2 and $(x_0; y_0)$ is a xed point of (16) then the discriminant of the characteristic polynomial of D $(x_0; y_0)$ is

Since det D $(x_0; y_0) = 1$ we can conclude the following:

- a. In the case of discrete time the eigenvalues of D (x₀; y₀) are on the unit circle when $f^{0}(x_{0}) > 1$ and $d > (f^{0}(x_{0}) 1)=4$) or $f^{0}(x_{0}) < 1$ and $d < (f^{0}(x_{0}) 1)=4$).
- b. In the case of continuous time, the eigenvalues of D $(x_0; y_0)$ are on the unit circle for su ciently large positive d when f $^0(x_0) > 0$ and for su ciently large negative d when $f^0(x_0) < 0$,

By a theorem of Birkho (see for example [20]) since is area preserving, the dynamical system (16) will generically have in nitely many periodic orbits in any neighborhood of $(x_0; y_0)$. Any such periodic orbit will correspond to a xed state of (15) which is periodic in space, i.e. in the variable j.

The condition det D $(x_0; y_0) = 1$ is not su cient to guarantee that D $(x_0; y_0)$ will have eigenvalues on the unit circle if (16) is not a dynam ical system on the plane. Additional

where $g(u_{j-1};u_j;u_{j+1})$ is a symmetric coupling vanishing on the linear submanifold of R^{3p} dened by $u_{j-1} = u_j = u_{j+1} = 0$. Such systems can be analyzed using the approach of this section

inform ation needs to be considered to conclude the existence of such periodic orbits in this case.

Example 1: Consider a chain of tent maps coupled through a discrete Laplacian described by the equation $u_i^0 = f(u_i) + u_j w$ ith

This is a discrete dynamical system with xed states determ ined by a homeomorphism of the plane given in (16) with c = 1.

The only xed points of (16) are (0,0) and (2/3, 2/3) by proposition 4.1. Since in this case the dynam ical system (16) is linear in each of the two halves of the plane x < 1=2 and x = 1=2 the analysis of the dynam ics around the xed points is straightforward. A direct calculation shows that in the region x < 1=2 there is a family of invariant ellipses whose major axis lies on the diagonal $D = f(x;y) \ge R^2 : x = yg$ and on which the action of (16) is a rotation. As d is increased, these ellipses become more eccentric.

The xed states of the chain corresponding to these orbits are not dynam ically stable. If $\hat{u} = f \hat{u}_j g_{j2Z}$ is a xed state in the chain such that $\hat{u}_j < 1=2$ for all j then around this state the dynam ics of the chain are described by:

The spectrum of the operator 2 + d is the interval [2 4d;2] and so \hat{u} cannot be stable, and would not be observed in num erical experiments.

Besides these invariant ellipses, this system will also typically have in nitely many periodic orbits, and will exhibit complicated behavior, as the following argument shows. A simple calculation shows that the point p = (2=3;2=3) is hyperbolic for all values d > 0. Since the dynamics is piecewise linear the stable and unstable manifold can be calculated explicitly. W^u(p) will consist of a ray contained in the halfplane x > 1=2 and a second more complicated part which is constructed as follows. The rst section of W^u(p) is a line A, as shown in gure 6. The part of A contained in the halfplane x < 1=2 is rotated along the invariant ellipses around the origin to the line A⁰ under forward iteration. The subsequent in ages of A⁰ are lines that are rotated further. Therefore $f^{n_0}(A^0)$ intersects the diagonal D for some n_0 . W henever the angle of this intersection is not a right angle W^u(p) will intersect W^s(p) transversely since by proposition 3.4 b the stable manifold is the relation of the unstable manifold through the diagonal W^u(p). This shows that com plicated dynam - ics of (16) can be expected and in plies the existence of in nitely many periodic as well as spatially chaotic states in the chain of tent maps.

Example 2: Next we consider the chain of di usively coupled Lorenz system (1) with $d_y = d_z = 0$. This system does not satisfy condition 1, how ever after setting the right{hand side of equations (1) to 0 and using the second and third equation in (1) to eliminate the

variables y_i and z_i the following equation for a xed state is obtained

The function on the left hand side of equation (20) satis as condition 1, and we can proceed as in the previous example.

Equation (20) de nes the following dynamical system on the plane

O rbits of period n of this system are in 1{1 correspondence with the steady states in the ring of n Lorenz system s. The two xed points of (23) are (0,0) and ((r 1); (r 1)) = (8:326; 8:326) which both lie on F ix (R).

The following de nition from [12] will be used in the remainder of the argument.

D e nition 4.2 A compact region H in the plane is called over owing in the y-direction for a function F if the image of any point $(x_0; y_0) \ge int(H)$ lies strictly above the line $y = y_0$.

Notice that any point in the interior of H $\,$ either leaves H or is asymptotic to a periodic point on the boundary of H .

Theorem 4.3 The map (23) has a hom oclinic point and in nitely many periodic points for all 0 < d = 20.

Proof: Let p denote the xed point (p (r 1); p (r 1)) of (23), G the ray y = (r 1) with x > (r 1), and D = f(x;y) : x = yg the diagonal in \mathbb{R}^2 . The in age of the triangular region W bounded by D and G lies between the two cubics

Consider the region F (W) \ W = H depicted in gure 7. Let $(x_0; y_0) 2$ int(H) and consider the vertical line segment l passing through $(x_0; y_0)$ and connecting G and D. The image of l is a horizontal line segment connecting F (G) and F (D) contained in the line $y = x_0$. Any point of this line segment lies above the line $y = y_0$. Therefore H is over owing in the y direction.

Since int (F (H) int (H)) and int (H) lie on opposite sides of D, any point in H must have an iterate which either lies on D or crosses D. A direct calculation shows that one branch of W $^{\rm u}$ (p) enters H. Since H is over owing in the y direction, W $^{\rm u}$ (p) must either

cross D or be asymptotic to the xed point (0;0) creating a saddle-saddle connection. The second possibility can be excluded as follows:

The eigenvector of the linearization of F around (0,0) corresponding to the stable direction is $v_1 = (1; \frac{d}{d + 130 + 2^9 + 65^2})$. The vector $v_2 = (1; \frac{d + 260}{d})$ is tangent to F (D) at (0,0). A direct computation shows that for 0 < d < 20 the vector v_1 points to the left of v_2 and so the tangent to W $^{\rm s}$ (0;0) at (0,0) does not point into H . This situation is depicted schematically in gure 8 and excludes the possibility that W $^{\rm u}$ (p) is asymptotic to (0,0).

By proposition 3.4 b the fact that W $^{\rm u}$ (p) m eets D in plies the existence of a hom oclinic point.

By proposition 3.4.c in the case of R-reversible systems an in nite number of periodic points exists whenever W^u (p) crosses D transversely at a hom oclinic point. If this point of intersection is not transverse then a transverse intersection of W^u (p) and D can be produced nearby by an argument given in [12, p. 261].

Num erical investigations suggest that the theorem remains true for arbitrarily large values of d.

This theorem shows that rings of Lorenz systems coupled through the rst variable can be expected to have many periodic stationary states. Numerical computations of W^u (p) suggest that even more complicated stationary states can be expected (see gure 9). However it is unclear whether any of them are stable. Numerical investigations show that not only are they stable, but their basins of attraction occupy a large portion of phase space. We next address the problem of stability of these xed states.

5 Stability of Steady States in a R ing

The study of stable xed states in a chain of oscillators is not new. They are described in [13], [6] as instances of oscillator death in a chain of neural oscillators, in [4] as synchronous states of phase lock loops, and conditions for the stability of complex stationary states in general lattices are given in [3]. The situation presented here is di erent in that an explicit periodic stationary state is analyzed in a case where the m ethods from the theory of parabolic partial di erential equations used in [13] are not applicable, and the conditions proposed in [3] cannot be veri ed. In addition, since the coupling strength is neither very large nor very sm all, there is no obvious perturbative approach to the problem.

Even if some of the xed states in a ring of n system s are stable it can not be concluded that stable equilibria exist in arbitrarily long rings of such system s. If a stable xed state is viewed as a special case of synchronization, one m ight guess from results in A fraim ovich and L in [5] that the coupling necessary to have stable steady states in longer rings increases as a power of the size of the ring. It has already been argued that this is not realistic from a physical view point, and we will show below that it is not the case.

In the following sections we will concentrate on the speci c example of a ring of Lorenz systems coupled in the x variable discussed in example 2 of the last section. However the ideas presented can be applied to any chain of symmetrically coupled systems for which condition 1 holds.

The linearization of each of the Lorenz equations around a point $\hat{v}_i = (\hat{x}_i; \hat{y}_i; \hat{z}_i)$ when

It is in general not possible to compute the eigenvalues of this matrix analytically. As mentioned above, we are speci cally interested in coherent states in networks with arbitrarily many oscillators. Given a periodic stationary state in a chain of n oscillators, an easy way to obtain a periodic stationary state in arbitrarily long chains is to repeat this state. In particular, if \diamond is a xed state in a ring of n oscillators then repeating these values K times to obtain $\diamond^{(K)} = f \diamond; \diamond; ::; \diamond g$ produces a steady state in a chain of K n oscillators. W e refer to such a state as the K -multiple of the steady state \diamond . An example of a stationary state and its 4-multiple is given in gure 10. W e next derive conditions under which all K -multiples of a stable steady state are them selves stable and demonstrate that these conditions hold in a particular case.

The linearization around the steady state $0^{(K)}$ leads to the following stability matrix:

In general it is in possible to compute the spectrum of this 3K n $\,$ 3K n m atrix. However in the present instance B loch wave theory, provides a way of expressing the eigenfunctions of a larger system with a periodic dependency as the eigenfunctions of a smaller system . As usual, this reduction is accompanied by the introduction of an additional parameter into the equations. Here the B loch wave approach will be used to reduce the problem of computing the eigenvalues of the 3K n $\,$ 3K n m atrix D $_{\phi^{(K)}}$ F for arbitrary K to the computation of the eigenvalues of an 3n matrix dependent on a parameter t.

This implies that the eigenvalues of $D_{\uparrow^{(K)}}F$ are the same as the eigenvalues of the 3n 3n matrices D (q) for 1 q K n. The 3n 3n matrix D (q) is easier to handle than the 3K n 3K n matrix $D_{\uparrow^{(K)}}F$.

To conclude that any K -multiple of a stable xed state v_0 of a ring of n oscillator is stable it is su cient to show that the eigenvalues of the matrix D (q) have negative realpart for all values of q and K. To simplify the calculations we can replace the argument q 2 Z by a continuous parameter t 2 R by replacing the matrices E (q) with the matrices

in the expression for D. If we can show that D (t) has eigenvalues with negative real part for all t 2 R then the same is true for D (q) for any values of K and q in Z.

The following lemma about the class of matrices of type (33) will be used in the next section.

6 An Example

This section gives a computer assisted proof that any K -multiple of a particular stable xed state in a ring of four Lorenz system is stable. The proof involves the use of interval arithmetic and the following theorem s about the convergence of the Newton-Raphson-K antorovich method. The computations were performed using M athematica's implementation of interval arithmetic.

then the equation f(x) = 0 has a solution in R.

The argument will proceed as follows: First a steady state of the ring is found using interval arithmetic. Next it is shown that the characteristic polynomial p_D (;t) of the matrix D (g) in (33) corresponding to this steady state has roots with negative realpart for $t = \frac{1}{4}$. Finally it is proved that p_D (;t) does not have roots on the imaginary axis for any t2 R. Since the roots of a polynomial depend continuously on its coe cients this implies that the roots of p_D (;t) cannot cross into right half of C. By the results of section 5 this implies that all K-multiples of the xed state under consideration must be stable.

In the following intervals of numbers will be denoted with overbars to distinguish them from real numbers, and make the notation less cumbersome. For instance denotes an interval and the interval [3:16524;3:16533] is denoted $\overline{3:165}$.

Numerical investigations with the program XPP show that a stable state in a chain of four oscillators coupled with d = 1.5 occurs close to $\hat{x} = (\hat{x}_1; \hat{x}_2; \hat{x}_3; \hat{x}_4) = (-6.4114408, 7.3696656, 8.1984129, 7.3696656).$ Notice that the orbit of (23) describing this state is not symmetric in the sense of proposition 3.4 although it is mapped into itself under R. This numerically obtained solution is used as an initial guess in M athematica's implementation of Newton's method to determ ine the roots x_a^i of the set of equations

A lthough M athem atica can be instructed to nd roots to an arbitrary precision, so far only oating point arithm etic was used so that none of the results are rigorous yet.

At this point all the quantities in the computations are redened as intervals rather than oating point numbers and using interval arithmetic and theorem 6.2 we nd an interval around each x_a^i in which the roots of equation (38) must lie. These bounds are now rigorous. In section 5 it was shown that a xed state and all of its K -multiples are stable if the polynom ial p_D (;t) corresponding to that state has roots with negative real part for all t2 [0; =2]. Using interval arithmetic it is shown that

In the next step the roots of the polynom $ialp_D$ ($;_{\overline{2}}$) are found. To employ M athem atica's in plem entation of N ew ton's method we need a polynom ial with coe cients that are oating point numbers rather than intervals. F loating point numbers inside the intervals which determ ine the coe cients of the polynom $ialp_D$ ($;_{\overline{2}}$) can be chosen to de ne a polynom $ialp_D^a$ ($;_{\overline{2}}$) which approximates p_D ($;_{\overline{2}}$). The roots of $fr_i^ag_{i=1}^{12}$ of p_D^a ($;_{\overline{2}}$) are now found using N ew ton's method.

The complex intervals² containing the roots of p_D (; $\frac{1}{2}$) are found by using theorem 6.1. We set z_0 equal to complex intervals around r_i^a and use complex interval arithmetic to nd the radius K₀ and check the conditions of the theorem for each root r_i^a . The 4 real roots and 4 complex pairs obtained by this procedure are given in the table below.

Since intervalarithm etic was used in these calculations, these estim ates are now rigorous. The rem ainder of the argum ent shows that these roots will not cross the imaginary axis as t varies.

By lemma 5.1 the characteristic polynom $ialp_D$ (;t) takes the following form when evaluated on the imaginary axis:

Since the roots of p_D (;t) depend continuously on the parameter t, if p_D (;t) has roots with positive realpart for som e t_1 then there must exist a t_0 such that p_D (;t₀) has a root on the imaginary axis. In other words there must exist a $_0$ such that

W e will use interval arithmetic to show that this cannot happen. The polynom $ialp_D$ (;t) is split into a real and complex part to avoid using complex interval arithmetic in the numerical calculations since complex interval arithmetic leads to much rougher estimates than real interval arithmetic.

By G responsing theorem the eigenvalues of the matrix D (t) lie in the union of discs $C_i = fz : jz$ $D_{ii}j < R_ig$ where D_{ij} are the entries in the matrix D (t) and $R_i = \int_{j=1, j \in i}^{12} D_{ij}j$. A direct computation shows that the intersection of $[\frac{12}{i=1}C_i$ with the imaginary axis is contained in the interval [17i;17i] and it is therefore su cient to show that p_D^R (;t_0) and p_D^I (;t_0) are not zero simultaneously for any value of t and 2 [17;17].

Since the coe cients of p_D (;t) are $\frac{1}{2}$ periodic in t, it is su cient to show that (40) is not satis ed for any 2 [17;17] and t2 $[0;\frac{1}{2}]$. This is shown by subdividing these intervals into a su cient number of subintervals n and t_m so that [17;17] [${}_{i=1}^{N}$ n and $[0;\frac{1}{2}]$ [${}_{m=1}^{M}t_m$ with the property that the intervals p_D^R ($n;t_m$) and p_D^I ($n;t_m$) do not contain zero simultaneously for any given pair of subintervals n and t_m . Therefore the roots of p_D (;t) stay in the left half plane for all t2 R and all K-multiples of the xed state under consideration are also stable.

The paths of the roots of p_D (;t) as t is varied are shown in gure 11.

$$C' = \begin{cases} 2 & 3 \\ c_{2;2} & \cdots & c_{2;m} \\ 6 & c_{3;2} & \cdots & c_{3;m} \\ \vdots & \vdots & \vdots & \vdots \\ c_{n;2} & \cdots & c_{n;m} \end{cases}$$

by an argument identical to the one given in the second paragraph of sublemma (A 1). The only nonzero factors that can be chosen from column 1 are therefore c_{m+1} : (m+1) =

 $c_{m+1;1} = de^{it}$ and $c_{(K-1)m+1;(K-1)m+1} = c_{(K-1)m+1;1} = de^{it}$. We therefore have the following two subcases:

Case 2a: If $c_{m+1;1} = de^{it}$ is chosen it cancels the term $c_{1,m+1} = de^{it}$ that was chosen as the rst factor in the product. In this case we are again in the situation of sublem m a A 2 using Laplace expansion as in case 1, and so this product will not depend on t.

The contributions to the characteristic polynom ial from C ase 1 and 2a are time independent and therefore enter the term $\sum_{i=(K-1)m+1}^{Km} i$ in (35). The remainder of the lemma follows from induction.

Case 2b: If the assumptions of Case 2 hold and $c_{(K-1)m+1}$; (K-1)m+1 = $c_{(K-1)m+1}$; $(m+1) = c_{(K-1)m+1}$; $(jm+1) = de^{it}$ then if a permutation leads to a nonzero product in (43) it must satisfy (jm+1) = (j+1)m + 1 for all j < K 1. This simply means that any nonzero product of this kind contains all the entries c_{jm+1} ; $(j+1)m+1 = de^{it}$ as factors. This assertion is proved as follows:

The factor $c_{1,m+1}$ is contained in the product by assumption. Assume that (lm + 1) = (l+1)m + 1 for all l < j. It will be shown that in this case (jm + 1) = (jm + 1)m + 1 which will complete the induction argument.

By assumption the $((j \ 1)m + 1) = jm + 1$. The only nonzero elements in columns jm + 2; ::: (j + 1)m come from the submatrix

and since an entry from row jm + 1 has already been chosen, the coe cients $c_{jm + 2}$; (jm + 2); :::; $c_{(j+1)m}$; ((j+1)m) must all come from this submatrix. The only nonzero entries remaining on row jm + 1 are $c_{jm + 1}$; $(j = 1)m + 1 = de^{it}$ and $c_{jm + 1}$; $(j = 1)m + 1 = de^{it}$. By the induction hypothesis we can exclude the rst possibility and we are left to conclude that $c_{jm + 1}$; $(j = 1)m + 1 = de^{it}$ for any 1 < j < K is a coe cient in any nonzero product in the case 2b.

This shows that any permutation f of the type described in C as 2b contributes a factor $e^{K \operatorname{it}}r($) to the characteristic polynom ial (35).

Case 3: The only remaining nonzero entry in row 1 of matrix C is $c_{1;(K-1)m+1} = de^{it}$. An argument identical to the one presented in case 2 shows that any permutation leading to a nonzero summand in (43) must satisfy either $c_{(K-1)m+1;(K-1)m+1} = c_{(K-1)m+1;1} = de^{it}$ or $c_{(K-1)m+1;(K-1)m+1} = c_{(K-1)m+1;(K-2)m+1} = de^{it}$ which again leads to two subcases:

Case 3a: If $c_{(K-1)m+1}$; $((K-1)m+1) = de^{it}$ the situation is virtually identical to case 2a. Laplace expansion and sublem m a A 2 show that the contributions to the characteristic polynom ial are independent of t.

Case 3b: If $c_{(K-1)m+1}$; $((K-1)m+1) = de^{-it}$ the situation is similar to case 2b. A parallel argument shows that all the terms de^{-it} in the matrix must be coe-cients in any nonzero product. Moreover due to the properties of the matrix, to each product $e^{K-it}r()$ from case 2b corresponds a product $e^{K-it}r()$ from this case. Since these are the only time dependent contributions to the characteristic polynomial the lemma is proved.




Figure 1: A stable state of two breathers in a ring of 16 Lorenz system s coupled through the x variable at $d_x = 15$. The rst series of gures shows a snapshot of the x variables of the di erent system s at di erent points of one oscillation. In these gures, the position of the oscillator in the ring is given on the x-axis, while $x_i(t)$ is given on the y-axis. The tim eseries of $x_1(t)$ and $x_5(t)$, which are nearly periodic, are given below.




Figure 2: Typical tim eseries of x_{15} (t) at coupling strengths $d_x = 5;15;20;25$ from top to bottom . M any features of the system remain similar at di erent coupling values. The oscillations have a sm ooth envelope, a feature that is typical to solutions for coupling strengths at which the network behaves coherently, but is not synchronized exactly. Even the transients that precede a stable xed state have similar shapes.




Figure 3: The system is very sensitive to initial conditions. The eventual stable state in a chain of 32 oscillators with $d_x = 40$ is shown. Only one initial condition $x_0(0)$ is di erent for each gure -it was incremented by 0.01. Very di erent states are reached. This suggests that the basins of attraction are intertwined in a complicated way. The stable states in these gures are typical, although xed states with one \hump" are more comm on than states with more \humps".




Figure 4: The wave when $d_x = d_y = 6$. This seems to be a globally stable solution of the equations.




Figure 5: The action of the two systems in equation (9)




Figure 6: The invariant circles around (0,0) give way to complicated behavior close to (1/2, 1/2) due to the transversal intersection of W $^{\rm u}$ (2=3;2=3) and W $^{\rm s}$ (2=3;2=3).




Figure 7: The region H is bounded by the two cubics F (D) and F (G) and D. The gure on the left W corresponds to the case d = 20. For d > 20 + these curves do not bound a compact region.




Figure 8: If W^u (p) coincides with the stable manifold of the origin then v_1 must be tangent to W^u (p) at the origin. Since v_1 points outside of H this is impossible.




Figure 9: A numerical approximation of the manifold W $^{\rm u}$ (p) is shown on the right. The complex structure of the manifold suggests complicated behavior on some invariant set of points.




Figure 10: The xed state that will be used as an example, and its 4-multiple.




Figure 11: A num erical computation of the paths that the 8 complex eigenvalues with sm allest real part trace out as t varies. Only one eigenvalue in the complex conjugate pair is shown. Notice the sm all trace of the eigenvalue with the least negative real part.
