# D ynam ics of a R ing of D i usively C oupled Lorenz O scillators

A bstract
W e study the dynam ics of a nite chain of di usively coupled Lorenz oscillators w ith periodic boundary conditions. Such rings possess in nitely $m$ any xed states, som e of which are observed to be stable. It is shown that there exists a stable xed state in arbitrarily large rings for a xed coupling strength. This suggests that coherent behavior in netw orks of di usively coupled system smay appear at a coupling strength that is independent of the size of the netw ork.

## 1 Introduction

Lattices of coupled dynam ical system $s$ have been studied in $m$ any di erent contexts: as discrete versions of partialdi erentialequations ofevolution type 10], 22, m odels of neuronal netw orks [6], [18] and phase lock loops [4], and in statisticalm echanics [14]. T he particular problem of synchronization and em ergence of coherent behavior in lattices of di usively coupled, chaotic, continuous tim e dynam ical system $s$ has received $m$ uch attention recently due to its applications in neuroscience [1], 18], and chaotic synchronization 19], 16].

A nalytical results in the literature suggest that the coupling strength necessary for the appearance of coherent behavior in netw orks of chaotic system $s$ grow $w$ ith the size of the netw ork [5],[4], [15]. For instance, estim ates of A fraim ovich and Lin [6] suggest that the coupling strength necessary to synchronize a lattice of generalized forced Du ng system s grows as a high power of the size of the lattice. Since stable, coherent states in lattices $m$ ay frequently be view ed as instances of generalized synchronization 19], one $m$ ight guess that the appearance of dynam ically stable states of this type also requires that the coupling grow swith the num ber of oscillators in the system. This would make it unlikely that such netw orks are of im portance in nature, since the coupling strength in realistic system s cannot be varied by orders ofm agnitude.

In contrast to these theoretical results, the num erical experim ents of H uerta, et. al. 18] indicate that partial synchronization $m$ ay appear in certain netw orks of chaotic system $s$ at a nearly constant coupling strength, regardless of the size of the netw ork. In particular,

18] considered a system with about $10^{4}$ coupled neurons. Each neuron was m odeled by a system of three nonlinear, ordinary di erentialequations which, when uncoupled, underw ent chaotic $m$ otion. They observed a variety of di erent stable, coherent motions including a num ber of states that exhibited roughly periodic pattems. It is the goal of this paper to show rigorously that such such stable, coherent states can occur in arbitrarily large system s of coupled chaotic oscillators at a coupling strength which is independent of the size of the system.

Since the Lorenz system is one of the paradigm sof chaotic ow $S$, we have chosen a ring ofdi usively coupled Lorenz equations for our investigations. T he system $s$ in the ring evolve according to the equations

where $x_{i}=x_{i} \quad 2 x_{i}+x_{i+1} w$ ith the index $i$ taken $m$ odulo $n$ is the discretized Laplacian w th periodic boundary conditions. The constants $=10 ; r=27$, and $=8=3$ are chosen so that each uncoupled system would be in the chaotic regim e. Follow ing the work of 18], we will focus on the case $d_{x} \in 0, d_{y}=d_{z}=0$. A s shown in [19], such a ring is synchronized identically for su ciently large values of $d_{x}$. W e will be concemed w th the case when $d_{x}$ is su ciently large for coherent spatial structures to em erge in the chain, but insu cient to synchronize the ring.

The paper is organized as follow s: Typical spatial structures observed in num erical experim ents are described in section 2. In particular, we give exam ples of stable stationary states, traveling waves, and breathers. In section ${ }^{3}$ a generalfram ew ork for the study of $x e d$ states in chains and rings of dynam ical system $s$ is discussed. W e show that the existence of such states can be reduced to the study of periodic solutions of reversible dynam ical system $s$ on $R^{n}$. W e then apply these results to two di erent cases, including the chains of coupled Lorenz oscillators (1), to show that a large num ber of xed states can be expected in such rings. T he conditions under which these states are stable are investigated in section 5. We then show how F loquet theory can be used to reduce the stability question in lattices of arbitrarily $m$ any oscillators to the study of the spectrum of a matrix of xed size (but depending on a param eter \{ the \quasim om entum ".) Finally, in section 6 we im plem ent this program to rigorously construct an exam ple of a spatially periodic stable xed state which rem ains stable for rings of arbitrary size.

## 2 Num erical Experim ents

N um ericalexperim ents were perform ed on a Sun SuperSparc using the num erical integration program XPP. Several di erent integration methods were used to check the validity of the resulte. These included xed and variable step R unge $K$ utta $m$ ethods of varying order and the $G$ earm ethod.

At very low values of the coupling constant $d_{x}$, the individualsystem $s$ in the ring behaved as if they were uncoupled. As the coupling strength was increased the behavior of the ring becam e $m$ ore coherent. Since the discrete Laplacian acts to synchronize neighboring
system $s$ in the ring, these results agree w ith our expectations. A s w as em phasized in the introduction, the onset of the coherent.behavior occurred at coupling strengthsw hich seem ed to be independent of the num ber of oscillators in the ring. Som e of the typical structures observed in these num erical experim ents are discussed below.

### 2.1 B reathers

If som e of the system $s$ in the ring are nearly stationary, while others are undergoing oscillations we say that the oscillating system $s$ form a breather. Since we are considering rings of nite size, it is not expected that any single system in the ring is stationary, unless the entire ring is stationary.

A n exam ple of a system with two breathers is shown in guref. It is interesting to note that in these states each of the individual system $s$ undergoes oscillations that are nearly periodic, and that there is a strong spatial dependence on the m otion. Loosely speaking the $m$ otion of each individual system is trapped in a region close to one of the lobes" of the Loren $z$ attractor. N o stable states in which all system $s$ in the ring are trapped in the vicinity of only one \lobe" has been observed. Sim ilar breathers have been studied in coupled $m$ ap lattices in 家], while occurrences of nearly periodic behavior with pronounced spatial pattems in lattices of chaotically bursting neurons have been observed num erically by M .I. Rabinovich, et. al. 23].

A nother interesting feature ofbreathers, which is also shared w ith other types of solutions of this netw ork, is that frequently nonadjacent system s synchronize w ithout synchronizing w ith the oscillators that lie betw een them. T he synchrony is usually not exact, how ever this $m$ ay be due to num erical errors in the calculations. D ue to the $m$ any sym $m$ etries of the system this som etim es seem $s$ to be due to the stability of an invariant $m$ anifold corresponding to a partially synchronized state in the chain as discussed [19]. In other cases the state does not appear to be sym $m$ etric, and it is unclear what the $m$ echanism behind this synchronization is.

It is im portant to note that som e of the qualitative features of the dynam ics rem ain una ected by the size, or the coupling strength in the ring. Figure 2 show stypicaltim eseries of the $x$ variable at four di erent coupling values in a ring of 32 oscillators. $N$ ote the $s m$ ooth envelope and regularity of the oscillations, as w ell as the agreem ent of the tim escales am ong the di erent tim eseries. These general features rem ain unchanged as the num ber of system $s$ in the ring is varied, as long as the coupling is below the synchronization threshold and above the value necessary for the appearance of coherent behavior.

### 2.2 Stable Stationary States

In num erical experim ents $w$ ith rings of 8 to 52 system $s$ stable steady states were observed for a variety of initial conditions for $d_{x}>10$. Typical stable xed states are show $n$ in gure 3.

For certain values of the coupling it appears that all in itial conditions lead to one of the stationary states of the system. The basins of attraction of the stationary states seem to be intertw ined in a com plicated way in this case, as show $n$ in gure 3. The sam e is true for other stable states of the system. Sm all changes in the initial values of the param eters, and changes in the integrating $m$ ethods can result in very di erent asym ptotic behavior of the
system. This situation is sim ilar to that of attractors $w$ ith riddled basins of attraction [7], and was also observed in num erical sim ulations of netw orks of chaotically bursting neurons 18].

### 2.3 Traveling Pulses

T raveling pulses w ere observed in the ring only when $d_{x} 0$ and $d_{y} \in 0$. A typicaltraveling pulse is shown in gure 4. The pulse oscillates as it propagates along the chain, and is thus a periodic, rather than a xed state in a m oving coordinate fram $e$. This can be seen in the tim eseries in gure 4 .

## 3 A G eneralFram ew ork for the Study of Steady States

System (1) is a special case of a lattice discrete or continuous tim e dynam ical system

where $j 2 Z^{D}, u_{j} 2 R^{p}$ and $f u_{j} g^{s}=f u_{i}$ : $\ddot{i} \quad j j \quad s g$. In the follow ing discussion we will use the convention that in $u_{i}^{k}$ the subscript i $2 Z^{D}$ denotes the position in the lattioe, while the superscript $1 \quad k \quad p$ denotes the com ponent of the vector $u_{i}$. Such system $s$ have been studied by $m$ any authors [2], 10], 22] as discrete versions of partial di erential equations of evolution type.

We willmainly be concemed with system $s$ continuous in time $w$ ith $D=1$ and $s=1$. $T$ hese are sim ply chains of system s coupled to their nearest neighbors. T he special case of rings, that is chains of nite size $w$ ith periodic boundary condition $w$ ill be the focus of our attention. A state in a ring of $n$ system $s$ corresponds to a state of period $n$ in the spatial variable in an in nite chain.

A steady state of a chain given in (2) is determ ined by

 0 for allvalues of ; ; then either there exists a point $(a ; b ; c) 2 R^{3 p}$ such that $F(a ; b ; c)=0$ and therefore a function $G(;)$ such that $F(; \quad ; G(;))=0$, or $F(; ~ ; ~)=0$ has no solutions and there are no xed points of (A). If such a function $G$ exists and we de ne $u_{j+1}=G\left(u_{j} ; u_{j 1}\right), x_{j}=u_{j}$ and $y_{j}=u_{j 1}$ this leads to the follow ing dynam ical system on $\mathrm{R}^{2 \mathrm{p}}$ :

The steady states of (2) are given by the $x$-coordinates of the orbits of (5). In general, the function $G$ m ay not be unique, in which casem ore than one system of the form (5) is needed to determ ine all the xed points of the chain. An equivalent argum ent holds in the case of discrete time.

Since the function $G$ can assum e any form, not $m$ uch can be said about such system $s$ in general. The subclass of chains of system s w ith the follow ing type of coupling is easier to analyze.
De nition 3.1 A nearest neighbor coupling of a chain of system $s$ is said to be sym $m$ etric if $F\left(u_{j 1} ; u_{j} ; u_{j+1}\right)=F\left(u_{j+1} ; u_{j} ; u_{j 1}\right)$.
$T$ his sim ply $m$ eans that a system in the chain is coupled to its left and right neighbor in the sam e way. For instance the couplings $u_{j}=u_{j 1} \quad 2 u_{j}+u_{j+1}$ and $u_{j}=u_{j 1} u_{j+1}+u_{j}$ are of this type. The stationary states of sym $m$ etrically coupled chains are related to the follow ing class of dynam ical system s:
De nition 3.2 G iven a di eom onphism : $R^{2 p}!R^{2 p}$ and an involution $R: R^{2 p}!R^{2 p}$ such that the dim ension of the $x e d$ point set of $R$ is $p$ we say that is $R$-reversible if

Theorem 3.3 The xed states of a sym m etrically coupled chain of system s satisfying condition 1 correspond to the orbits of a dynam ical system of the form (5) which is R-reversible and volum e preserving. For such a system $R(x ; y)=(y ; x)$, with $x ; y 2 R^{p}$.
$P$ roof: The argum ents for the continuous and discrete case are virtually identical, so only the rst willbe considered. Equation (3) together w ith the assum ption that the coupling is sym $m$ etric im plies that

$R$-reversible system $s$ have $m$ any properties that facilitate their study. W e w illm ake use of several of these sum $m$ arized in the follow ing proposition adopted from 12]

## 4 Steady States In the C ase of D iscrete Laplacian C oupling

For a chain of system s of the form $u^{0}=f(u)$ coupled through a discrete Laplacian $u_{j}=$ $\left(u_{j} 1 \quad 2 u_{j}+u_{j+1}\right)$ the equation (2) takes the form

where $c=0$ in the case of continuous time and $c=1$ in the case of discrete time. The follow ing proposition follow s im m ediately from these de nitions

P roposition 4.1 The xed points of 16) are of the form $x_{i}=y_{i}=u_{0}$ where $u_{0}$ is any solution of the equation $f(u)=0$ in the continuous time and $f(u)=u$ in the discrete time case. Thus all xed points of 16) lie on $F i x(R)=f(x ; y): x=y g$ and are in 1-1 correspondence with the steady states of an uncoupled system in the chain.

The xed points of (5) correspond to states of the chain that are constant in space and tim e and proposition 4.1 show sthat the only such states $f_{j} g_{j 2 z}$ in the case of a discrete Laplacian coupling are given by $u_{j}=u_{0}$ for all $j 2 \mathrm{Z}$ where $u_{0}$ is a xed point of an uncoupled system of the chain $u^{0}=f(u)$. Since the xed points of 16) are ( $u_{0} ; u_{0}$ ) 2 $F$ ix $(R)$ this allow s us to $m$ ake use of proposition 3.4. (7 .
$M$ oreover we can apply $T$ heorem 3.3 directly in this case to conclude that the m ap de ning the xed points is $R$-reversible and volum e preserving.
$R$ em ark: It is interesting to note that if the xed states of a chain of one dim ensional system s are determ ined by a dynam icalsystem of the form 16) on $R^{2}$ and ( $x_{0} ; y_{0}$ ) is a xed point of (16) then the discrim inant of the characteristic polynom ial ofD $\left(x_{0} ; Y_{0}\right)$ is

b. In the case of continuous tim e , the eigenvalues of ( $\mathrm{x}_{0} ; \mathrm{y}_{0}$ ) are on the unit circle for su ciently large positive $d$ when $f^{0}\left(x_{0}\right)>0$ and for su ciently large negative $d$ when $\mathrm{f}^{0}\left(\mathrm{x}_{0}\right)<0$,

By a theorem of B irkho (see for exam ple 20]) since is area preserving, the dynam ical system 16) w ill generically have in nitely many periodic orbits in any neighborhood of ( $\mathrm{x}_{0} ; \mathrm{Y}_{0}$ ). A ny such periodic onbit will correspond to a xed state of (15) which is periodic in space, i.e. in the variable $j$.

The condition det $D\left(x_{0} ; y_{0}\right)=1$ is not su cient to guarantee that $D\left(x_{0} ; Y_{0}\right) w$ illhave eigenvalues on the unit circle if 16) is not a dynam ical system on the plane. A dditional

inform ation needs to be considered to conclude the existence of such periodic orbits in th is case.

This is a discrete dynam ical system with xed states determ ined by a hom eom onphism of the plane given in 16) w ith $\mathrm{c}=1$.

The only xed points of (16) are $(0,0)$ and $(2 / 3,2 / 3)$ by proposition 4.1. Since in this case the dynam ical system (16) is linear in each of the tw o halves of the plane $x<1=2$ and $x \quad 1=2$ the analysis of the dynam ics around the xed points is straightforw ard. A direct calculation show sthat in the region $\mathrm{x}<1=2$ there is a fam ily of invariant ellipses whose $m$ a jor axis lies on the diagonal $D=f(x ; y) 2 R^{2}: x=y g$ and on which the action of 16) is a rotation. A s d is increased, these ellipses becom e m ore eccentric.

The xed states of the chain corresponding to these onbits are not dynam ically stable. If $\hat{u}=f \hat{u}_{j} g_{j 2 z}$ is a xed state in the chain such that $\hat{u}_{j}<1=2$ for all $j$ then around this state the dynam ics of the chain are described by:

The spectrum of the operator $2+d$ is the interval [2 $4 d ; 2]$ and so $\hat{A}$ cannot be stable, and would not be observed in num erical experim ents.

B esides these invariant ellipses, this system will also typically have in nitely $m$ any periodic orbits, and w ill exhibit com plicated behavior, as the follow ing argum ent show s. A simple calculation show $s$ that the point $p=(2=3 ; 2=3)$ is hyperbolic for all values $d>0$. Since the dynam ics is piecew ise linear the stable and unstable $m$ anifold can be calculated explicitly. $W^{u}$ (p) will consist of a ray contained in the halfplane $x>1=2$ and a second $m$ ore com plicated part which is constructed as follows. The rst section of ${ }^{4}{ }^{u}$ (p) is a line A, as shown in gure 6. The part of A contained in the half plane $x<1=2$ is rotated along the invariant ellipses around the origin to the line $A^{0}$ under forw ard iteration. The subsequent im ages of $A^{0}$ are lines that are rotated further. Therefore $f^{n_{0}}\left(A^{0}\right)$ intersects the diagonal $D$ for som e $n_{0}$. W henever the angle of this intersection is not a right angle $W{ }^{u}(p) w i l l$ intersect $W{ }^{s}(p)$ transversely since by proposition $3.4 . b$ the stable $m$ anifold is the re ection of the unstable $m$ anifold through the diagonalW ${ }^{u}(p)$. This show $s$ that com plicated dynam ics of (16) can be expected and im plies the existence of in nitely $m$ any periodic as well as spatially chaotic states in the chain of tent $m$ aps.

Exam ple 2: N ext we consider the chain of di usively coupled Lorenz system (13) w ith $d_{y}=d_{z}=0$. This system does not satisfy condition 1 , how ever after setting the right \{ hand side of equations (1) to 0 and using the second and third equation in (1) to elim inate the

C onsider the region $F(\mathbb{W}) \backslash W=H$ depicted in gure7. Let ( $\mathrm{X}_{0} ; \mathrm{y}_{0}$ ) 2 int $(\mathrm{H})$ and consider the vertical line segm ent l passing through ( $\mathrm{x}_{0} ; \mathrm{y}_{0}$ ) and connecting G and D . The im age of $l$ is a horizontal line segm ent connecting $F(G)$ and $F(D)$ contained in the line $y=x_{0}$. A ny point of this line segm ent lies above the line $y=y 0$. Therefore $H$ is over ow ing in the $y$ direction.

Since $\operatorname{int}(F(H) \quad \operatorname{int}(H))$ and int (H) lie on opposite sides of $D$, any point in $H \mathrm{~m}$ ust have an titerate which either lies on D or crosses D. A direct calculation show s that one branch of $W^{u}(p)$ enters $H$. Since $H$ is over ow ing in the $y$ direction, $W^{u}(p)$ m ust either
cross $D$ or be asym ptotic to the xed point $(0 ; 0)$ creating a saddle-saddle connection. T he second possibility can be excluded as follow s:
$T$ he eigenvector of the linearization of $F$ around $(0,0)$ corresponding to the stable direction is $v_{1}=\left(1 ; \frac{d}{d 130+2 \overline{65^{2} d}}\right)$. The vector $v_{2}=\left(1 ; \frac{d 260}{d}\right)$ is tangent to $F(D)$ at $(0,0)$. A direct computation shows that fro $0<d<20$ the vector $v_{1}$ points to the left of $v_{2}$ and so the tangent to $\mathrm{W}^{\mathrm{s}}(0 ; 0)$ at $(0,0)$ does not point into H . This situation is depicted schem atically in gure 8 and excludes the possibility that $W^{u}(p)$ is asym ptotic to $(0,0)$.

By proposition 3.4.b the fact that $W^{u}(p) m$ eets D im plies the existence of a hom oclin ic point.

By proposition 3.4.c in the case of $R$-reversible system $s$ an in nite num ber of periodic points exists whenever $W{ }^{u}$ (p) crosses $D$ transversely at a hom oclinic point. If this point of intersection is not transverse then a transverse intersection ofW ${ }^{u}$ ( $p$ ) and D can be produced nearby by an argum ent given in 12, p. 261]. \}

N um erical investigations suggest that the theorem rem ains true for arbitrarily large values of d.

This theorem show sthat rings of Lorenz system scoupled through the rst variable can be expected to have $m$ any periodic stationary states. $N$ um erical com putations of $W^{u}$ (p) suggest that even $m$ ore com plicated stationary states can be expected (see gure 9). H ow ever it is unclear whether any of them are stable. N um erical investigations show that not only are they stable, but their basins of attraction occupy a large portion of phase space. W e next address the problem of stability of these xed states.

## 5 Stability of Steady States in a R ing

The study of stable xed states in a chain of oscillators is not new. They are described in [13], 6] as instances of oscillator death in a chain ofneural oscillators, in [4] as synchronous states of phase lock loops, and conditions for the stability of com plex stationary states in general lattices are given in 3]. The situation presented here is di erent in that an explicit periodic stationary state is analyzed in a case where the $m$ ethods from the theory of parabolic partial di erentialequations used in 13] are not applicable, and the conditions proposed in 3] cannot be veri ed. In addition, since the coupling strength is nether very large nor very sm all, there is no obvious perturbative approach to the problem .

Even if som e of the xed states in a ring of $n$ system s are stable it can not be concluded that stable equilibria exist in arbitrarily long rings of such system s. If a stable xed state is view ed as a special case of synchronization, one $m$ ight guess from results in A fraim ovich and $L$ in (5] that the coupling necessary to have stable steady states in longer rings increases as a power of the size of the ring. It has already been argued that this is not realistic from a physical view point, and we w ill show below that it is not the case.

In the follow ing sections we w ill concentrate on the speci c exam ple of a ring of Lorenz system s coupled in the $x$ variable discussed in exam ple 2 of the last section. H ow ever the ideas presented can be applied to any chain of sym $m$ etrically coupled system $s$ for which condition 1 holds.

It is in general not possible to com pute the eigenvalues of this $m$ atrix analytically. A s m entioned above, w e are speci cally interested in coherent states in netw orksw ith anbitrarily m any oscillators. G iven a periodic stationary state in a chain of n oscillators, an easy way to obtain a periodic stationary state in anbitrarily long chains is to repeat this state. In particular, if $\hat{v}$ is a xed state in a ring of $n$ oscillators then repeating these values $K$ tim es to obtain $\hat{v}^{(K)}=f \hat{v} ; \hat{v} ;::: ; \hat{v} g$ produces a steady state in a chain of K n oscillators. W e refer to such a state as the $K$ m ultiple of the steady state $\hat{v}$. A $n$ exam ple of a stationary state and its 4 m ultiple is given in gure 10. W e next derive conditions under which all $\mathrm{K}-\mathrm{m}$ ultiples of a stable steady state are them selves stable and dem onstrate that these conditions hold in a particular case.

In general it is im possible to com pute the spectrum of this $3 \mathrm{~K} n \quad 3 \mathrm{~K} \mathrm{n} \mathrm{m}$ atrix. H ow ever in the present instance $B$ loch wave theory, provides a way of expressing the eigenfunctions of a larger system w th a periodic dependency as the eigenfunctions of a sm aller system. A s usual, this reduction is accom panied by the introduction of an additionalparam eter into the equations. H ere the B loch w ave approach will be used to reduce the problem of com puting the eigenvalues of the $3 K n \quad 3 K n m$ atrix $D_{\forall(K)} F$ for arbitrary $K$ to the com putation of the eigenvalues of an $3 n \quad 3 n \mathrm{~m}$ atrix dependent on a param eter $t$.

## 6 An Exam ple

This section gives a com puter assisted proof that any $K$ m ultiple of a particular stable xed state in a ring of four Lorenz system is stable. T he proof involves the use of interval arithm etic and the follow ing theorem s about the convergence of the N ew ton R aphson$K$ antorovich $m$ ethod. $T$ he com putations were perform ed using $M$ athem atica's im plem entation of interval arithm etic.

The argum ent will proceed as follow s: First a steady state of the ring is found using interval arithm etic. $N$ ext it is show $n$ that the characteristic polynom ial $p_{D}(; t)$ of the $m$ atrix $D(q)$ in 33) corresponding to this steady state has roots $w$ ith negative real part for $t={ }_{4}$. F inally it is proved that $p_{D}(; t)$ does not have roots on the im aginary axis for any $t 2 \mathrm{R}$. Since the roots of a polynom ial depend continuously on its coe cients this im plies that the roots of $p_{D}(; t)$ cannot cross into right half of $C$. By the results of section 5 th is implies that all $K \cdot m$ ultiples of the $x e d$ state under consideration $m$ ust be stable.

In the follow ing intervals of num bers w ill be denoted w ith overbars to distinguish them from real num bers, and $m$ ake the notation less cum bersom e. For instance denotes an interval and the interval $[3: 16524 ; 3: 16533]$ is denoted $\overline{3: 165}$.

N um erical investigations w ith the program XPP show that a stable state in a chain of four oscillators coupled with $d=1: 5$ occurs close to $\hat{x}=\left(\hat{x}_{1} ; \hat{x}_{2} ; \hat{x}_{3} ; \hat{x}_{4}\right)=(-6.4114408$, $7.3696656,8.1984129,7.3696656)$. N otice that the orbit of 23) describing this state is not sym $m$ etric in the sense of proposition 3.4 although it is $m$ apped into itself under R. This num erically obtained solution is used as an initial guess in $M$ athem atica's im plem entation of $N$ ew ton's $m$ ethod to determ ine the roots $x_{a}^{i}$ of the set of equations

A though $M$ athem atica can be instructed to nd roots to an arbitrary precision, so far only oating point arithm etic w as used so that none of the results are rigorous yet.

At this point all the quantities in the com putations are rede ned as intervals rather than oating point num bers and using interval arithm etic and theorem 62 we nd an interval around each $x_{a}^{i}$ in which the roots ofequation 38) m ust lie. These bounds are now rigorous.

In section 5 it was shown that a xed state and all of its $\mathrm{K} m \mathrm{~m}$ ltiples are stable if the polynom ial $p_{D}(; t)$ corresponding to that state has roots $w$ th negative real part for all t 2 [0; =2]. U sing interval arithm etic it is show $n$ that

In the next step the roots of the polynom ial $p_{D}(;-\overline{2})$ are found. $T o$ em ploy $M$ athem atica's im plem entation of $N$ ew ton's $m$ ethod we need a polynom ial with coe cients that are oating point num bers rather than intervals. $F$ loating point num bers inside the intervals which determ ine the coe cients of the polynom ialp $\left.D_{(i}^{2}\right)$ can be chosen to de ne a polynom ial $p_{D}^{a}(i \overline{2})$ which approxim ates $p_{D}(i \overline{2})$. The com plex intervald containing the roots of $p_{D}(; \overline{2})$ are found by using theorem 6.1. $W$ e set $z_{0}$ equal to com plex intervals around $r_{i}^{a}$ and use com plex intervalarithm etic to nd the radius $K_{0}$ and check the conditions of the theorem for each root $r_{i}^{a}$. The 4 real roots and 4 com plex pairs obtained by this procedure are given in the table below.

The tim eseries of $\mathrm{x}_{1}(\mathrm{t})$ and $\mathrm{x}_{5}(\mathrm{t})$, which are nearly periodic, are given below .

The oscillations have a sm ooth envelope, a feature that is typical to solutions for coupling strengths at which the netw ork behaves coherently, but is not synchronized exactly. Even the transients that precede a stable xed state have sim ilar shapes.
