# Scaling transform ation and probability distributions for nancial time series

#### A bstract

The price of nancial assets are, since [1], considered to be described by a (discrete or continuous) time sequence of random variables, i.e a stochastic process. Sharp scaling exponents or unifractal behavior of such processes has been reported in several works [2] [3] [4] [5] [6]. In this letter we investigate the question of scaling transform ation of price processes by establishing a new connexion between nonlinear group theoretical methods and multifractal methods developed in mathematical physics. Using two sets of nancial chronological time series, we show that the scaling transformation is a non-linear group action on the moments of the price increments. Its linear part has a spectral decomposition that puts in evidence a multifractal behavior of the price increments.

#### 1 Introduction

One of the pillars of modern physics is the covariance of theories under certain group actions. What is particular to a given application, such as initial and boundary conditions usually breaks the symmetries of the theory. The symmetry group of observed data is therefore usually much smaller than the covariance group of the theory. An example is hydrodynamics where the equations are invariant under space-time translation and scaling, but where the solutions are not, in general, invariant. For theories that are

covariant under scaling (to be specie, we can think of Navier-Stokes or K orteweg-De V ries equation) the situation is clear: the scaling properties, such as the spectral decomposition of the solution at each time are given by the scaling properties of the initial condition, the boundary conditions and external forces. The study of scaling transform ation properties in the domain of economics and nance is more complicated because the evolution equations (or even the theory) governing the dynam ics are largely unknown. It is thus not possible, in this case, to separate these scaling properties into a general property of an underlying theory and into what is particular to the situation under study. The observed nancial chronological data results at least to some extent, of the particularities of each market and not only from a general abstract dynamics. Therefore there is no a priori reason to expect the data to exhibit simple properties under scaling transform ation. Keeping this simple observation in mind, we will base our analysis of the scaling transform ation on m ethods adapted to physical system swith complex behavior:

- i) Multifractal analysis of fully turbulent systems introduced in [7] and within that approach further developed inversion techniques developed in [8] (see also [9]).
- ii) Non-linear group representation theory developed in [10] and applied to many non-linear evolution equations in mathematical physics (see [11] for recent contributions).

We apply these methods to two sets of nancial chronological series:

- 1) Foreign exchange rate DM/\$: The data set provided by O lsen and A ssociates contains worldwide 1,472,241 bid-ask quotes for US dollar-G erm and mark exchanges rates from 1 O ctober 1992 until 30 September 1993. Tick by tick data are irregularly spaced in recorded time. To obtain price values at a regular time, we use linear interpolation between the two recorded time that immediately precede and follow the regular time. We obtain in this way, for a regular time of 15 seconds, 1;059;648 data. Our study focuses on the average price which is the mean of the bid and ask price.
- 2) Stock index CAC 40: The data set provided by the \Societe de Bourse Francaise" contains 1;045;890 quotes of the CAC 40 index from 3 January 1993 until 31 D ecem ber 1996. Tick by tick data are regularly recorded every 30 seconds, during opening hours (everyday from 10 am until 5 pm except week ends and nationalholidays). Our data base consist of the daily registers to which a constant has been subtracted such that the value at 10 am is equal to the value of the previous day at 5 pm. The subtracted jump process (with jumps at xed times) can be analyzed on its own. This separation allows for a ner analysis of the rest of the process.

Using these data sets, we obtained three new results. First, the scaling transform ation of the moments of the observed probability distribution is a non-linear representation that is well approximated by a linear representation, for small scaling parameters. This linear representation turns out to be diagonal. Secondly, the function of the order of the moment, dened by the spectrum of the generator is (non trivially) concave. This shows, by denition [7], that the data are multifractal. Note that the concavity in the case of FX market (DM/\$) can partially be deduced from [12] and is con med, independently of our work, by [13]. Our third new result is an explicit expression of the family of probability distributions of price increments corresponding to discrept time increments.

For larger values of the scaling param eter, the linear approxim ation breaks down and the non linear terms of the representation has to be considered. The analysis of this letter can also be applied to the SP 500 index, where the results should be compared to the (unificatal) scaling behavior found in [4]. It should also be compared with the, from the point of view of nance, more fundamental approach of stochastic time transformation (subordinate processes) that were applied to SP 500 [14] [15]. These points are left for future investigations.

## 2 The mathematical framework

We suppose that the nancial variable is described by a stochastic process  $(u(t))_{t=0}$  such that the set of increments u(t+) u(t), de ned transform ation property under scaling of the time increment , 7 a , a > 0. To avoid complications, irrelevant for the quite crude application reported in this letter, we suppose that  $(u(t))_{t=0}$  is stationary. Moreover, we will only consider the absolute value ju(t+ ) u(t) jof increments. Let 0. This means that for each (scaling) a > 0, there is w() = ju() u(0)j $a m ap T_a of the set W = fw()j$ Og such that  $T_a$  (w ( )) = w (a ). A group action T of the scaling (dilatation) group D (the set of strictly positive real num bers) on the set W is then de ned, i.e  $T_{ab}(x) = T_a(T_b(x))$  and  $T_e(x) = x$ for a; b 2 D; x 2 W, where e=1 is the identity element in D. In the cases under consideration in this letter, it follows from the observed time series that the estim ated probability distribution  $p_{w(\cdot)}$  in R of w() is dierent for di erent > 0. This is enough to ensure the existence of the action T, and m or eover show s that T gives a group action T, on the set M =  $fp_{w(\cdot)}$ of probability distributions, de ned by  $T_a(p_{w(i)}) = p_{w(a)}$ .

The group action T is not linear, in spite of its appearance. To explicit properties of the scaling action T, we change the coordinates of the

elements in M . As in the case of fully developed turbulence, we use the m om ents as coordinates. For q 2  $\mbox{M}_1$ , let the m om ent vector be the sequence S (q) =  $(S_r(q))_{r=0}$ , where  $S_r(q) = \int_0^r x^r q(x) dx$  and r 2  $\mbox{R}^+$ . Here we suppose that the set M of probability m easures is such that  $S_r(q)$  exists for all orders r and m or eover that q is determined by its m om ents of order r 2 R  $^+$  (w high is the case if for example the Fourier Transform of elements in Mare quasi. analytic). Let S be the image (in the space C (R+) of continuous real functions on  $\mathbb{R}^+$ ) of M under the coordinate transform ation S. The im age U of the group action T is given by  $U_a = S T_a S^1$ , ie  $U_a (S(p_{w()})) = S(p_{w(a)})$ . In the case U is a linear diagonal representation, it has the form  $U_a = U_a^{(1)}$ , where for given real numbers  $_{r}$  with  $r 2 R^{+}$ :

for a 2 D and m 2 C  $(\mathbb{R}^+)$ , m<sub>r</sub> corresponding to a moment of order r. We note that f r jr 2 R + g is the spectrum of the generator of the representation U (1). When U is a nonlinear perturbation of U (1), there are algorithms perm itting its construction. However they are outside the scope of this letter [10] [11]. For commodity we denote  $s_r() = S_r(p_{w()})$  which is the r-th component of U (S  $(p_{w(1)})$ ). An accurate and explicit approximation of the inverse transform ation S  $^{-1}$ , of the m om ent vectors  $\mathbf{s}_{\mathrm{r}}$  ( ) to probability distribution  $p_{w(\cdot)}$  has been developed in [8] [9] [16]. This perm its to obtain directly from experim ental data, an explicit formula for the family  $M = fp_{w(\cdot)}g_{>0}$ of probabilities. In fact, for each  $2 R^+$  we can determ ine an element  $p_{w(\cdot)}$ by the formulas:

where  $r 2 R^+$ .

#### 3 R esults




Figure 1: (1A):  $\ln s_r$ () vs  $\ln$  for r=1:::10 in the case of FX DM/\$ index. The scaling law  $\ln s_r$ () =  $A_r+_r\ln$  displayed as straight lines for 12896 m inutes (delim ited by the orange arrow) gives  $_r$  as the slope. (1B):  $_r$  determined by scaling law in the case of FX DM/\$ index.

When the representation U is linear it follows from expression (1) that  $\ln s_r() = A_r + r \ln$ , where  $A_r$  and r are independent of . Figure (1A) shows that, in the case of FXDM/\$, this is satisfed, to a good approximation with time increments and moments of order rin the interval 11




Figure 2: (2A):  $\ln s_r$ () vs  $\ln$  for r=1:::10 in the case of CAC 40 index. The scaling law  $\ln s_r$ () =  $A_r + _r \ln$  displayed as straight lines for 1 2048 m inutes (delim ited by the orange arrow) gives  $_r$  as the slope. (2B):  $_r$  determ ined by scaling law in the case of CAC 40 index.

m inutes and 1 r 10. In contrast, for CAC 40 the domain of validity of the linear approximation also contains the small values of : 1 2048 m inutes and 1 r 10 (see gure (2A)). Outside this domain in the (r; ) plane, the linear representation approximation breaks down. Inside the domain of validity of the linear representation approximation, the spectrum of the generator is presented in gure (1B) (resp. (2B)) in the case of FX DM/\$ (resp. CAC 40). The function r 7 r is in both cases (non trivially) concave, which by de nition (see [7]) shows that the system has a multifractal behavior.

Finally, we present in gure (3A) and gure (3B) (resp. gure (4A) and gure (4B)) probability densities (MAM) given by (2) and (3), for = 8 m inutes and =  $512 \, \text{m}$  inutes in the case of FXDM/\$ index (resp. CAC40). In all the cases, the experimental probability distribution is well approximated, for a large range of price increments, by the corresponding probability distributions in the family  $fp_{w()}g_{>0}$  constructed by the inverse method developed in [9] and [16]. Other commonly used probability distributions are also presented in the gures for illustration.




Figure 3: (3A): Presentation of the probability density function at = 8 m inutes for FX DM/\$ index and comparison with empirical data. (3B): Same presentation at = 512 m inutes for FX DM/\$ index.




Figure 4: (4A): P resentation of the probability density function at = 8 m inutes for CAC 40 index and comparison with empirical data. (4B): Same presentation at = 512 m inutes for CAC 40 index.
