Spin transport properties of the quantum one-dimensional non-linear sigm a model: an application to Haldane gap system s

Spin transport properties of the quantum one-dimensional non-linear sigm a model are studied based upon the Bethe ansatz exact solution for the O (3) sigm a model and the 1=N -expansion approach for the O (N) sigm a model. It is shown that the spin transport at nite temperatures is ballistic and there is no spin di usion in this system. A possible mechanism for the spin di usion observed in the NMR experiment of the Haklane gap system AgVP₂S₆ by Takigawa et al. [Phys. Rev. Lett.76, 2173 (1996)] is also discussed. The inclusion of the spin-phonon interaction accounts for the experimental results qualitatively.

I. IN TRODUCTION

The spin di usion in the H eisenberg spin chain is a long-standing issue in the studies of magnetism ¹. For the X X Z H eisenberg chain with spin s = 1=2, there is a strong piece of evidence for the absence of the spin di usion in the massless state.^{2 {5} In the case that the spin s is an integer, there exists an excitation gap, as predicted by H aldane many years ago using the mapping to the one-dimensional(1D) quantum O (3) non-linear sigm a model.⁶ T hus it is expected that the spin transport properties at low temperatures are quite di erent from those of the s = 1=2 H eisenberg chain. Recently, it was observed in the NM R experiment for the H aldane gap system, AgVP₂S₆, by Takigawa et al. that a di usive behavior appears in long wavelength spin-spin correlation functions⁷. In order to explain the experiment, Sachdev and D am le showed that a sem iclassical analysis of the quantum 1D O (3) non-linear sigm a model gives a di usive behavior in the spin correlation function at low tem peratures⁸. However, the 1D quantum O (3) sigm a model is an integrable model, and exactly solvable in terms of the B ethe ansatz m ethod.⁹ The spin current is conserved, and thus it is expected that the spin di usion is absent in this model. A lihough we can not calculate correlation functions directly by using the B ethe ansatz m ethod, the spin transport properties are also probed by the D nude weight, nam ely, the zero frequency part of the spin conductivity. The calculation of the D nude weight for exactly solvable m odels was recently extended to the mite tem perature case by Fu jin oto and K awakam i¹⁰.

nite tem peratures, the system shows a ballistic transport rather than a di usive one. One of the purposes of this paper is to discuss the exact D rude weight of the 1D quantum 0 (3) sigm a model at nite tem peratures based upon the Bethe ansatz method. Our nding is that the Drude weight is non-vanishing at nite tem peratures, and that the spin transport is ballistic. We will also con m this result by utilizing the 1=N -expansion analysis for the O (N) non-linear sign a model. For large N, we can calculate the spin correlation function perturbatively. We will show that the W ard-Takahashi identity for the current vertex operators leads to a ballistic form of the spin correlation function, and that the spin di usion does not exist. Thus in order to explain the spin di usion observed in the Haldane gap system AgVP₂S₆, we need to introduce a coupling with som e other degrees of freedom, such as interchain couplings, or spin-phonon interaction, etc. M oreover a rem arkable feature of this experiment is the existence of a tem peraturedependent cuto frequency, which can not be explained by the pure non-linear sign a model. The second purpose of this paper is to investigate a possible mechanism of the spin di usion in this system . The interchain coupling J^0 of this material is so small, $J^0=J$ 10⁵, that it is unlikely to give rise to the observed spin di usion? We will try to explain the experimental results by introducing the coupling with phonons. We will show that the inclusion of the spin-phonon interaction gives, at least qualitatively, a ne explanation for the spin di usion and the presence of the tem perature-dependent cuto frequency observed in $A gV P_2 S_6$.

The organization of this paper is as follows. In Sec.II, the exact D rude weight at nite tem peratures is derived based upon the Bethe ansatz solution. In Sec.III, the non-di usive behavior of the spin correlation function is argued by using the 1=N -expansion of the O (N) sigm a model. In Sec.IV, we discuss a possible mechanism for the spin di usion observed in the NMR experiment taking into account a coupling with phonons. Sum mary and discussions are given in Sec.V.

II. THE BETHE AN SATZ EXACT SOLUTION FOR THE 0 (3) SIGMA MODEL AND THE FIN ITE TEM PERATURE DRUDE WEIGHT

In this section, we will derive the exact D rude weight of the quantum 1D O (3) non-linear sigm a model at nite tem peratures using the Bethe ansatz exact solution. The action of the O (3) non-linear sigm a model is given by,

where $n = (n_x; n_y; n_z)$ is a unit vector, $(n)^2 = 1$. The elementary excitations of this model are massive triplets interacting with each other.¹¹ The Bethe ansatz exact solution for this model was obtained by W iegm ann a decade ago.⁹ In order to obtain the D rude weight for the spin conductivity, we need to use the twisted boundary condition introducing the ux which couples with spin degrees of freedom ^{13;14}. The Bethe ansatz equations under the twisted boundary conditions are given by,⁹

where p and q are de ned by the eigen values of the N oether current operator l = n $(p = v; l^2 = p(p + 1), l_z = p q, and m / exp(2 = g)=g$. The total energy in the presence of a magnetic eld h is given by

The therm odynam ic properties are obtained by using the string hypothesis for the solutions of the rapidities. As was shown by W iegmann, is real, and n;k = n + i (n + 1 - 2k)=2, k = 1;2;...;n? The D rude weight at nite tem peratures is derived from the nite size corrections to the therm odynam ic B ethe ansatz equations. In order to calculate the nite size corrections, we expand the real part of the rapidities in $1=L_{r}^{10;15}$

Substituting these rapidities into eqs.(2) and (3), and taking a continuum limit, we obtain the coupled integral equations which determ ine the spectrum of the system. The zeroth order contributions in 1=L give the conventional therm odynamic Bethe ansatz equations which were rst obtained by T svelik¹²

The D rude weight at nite temperatures is given by the second derivative of the energy spectrum with respect to the Aharonov-Bohm ux $^{16}_{\prime}$

Here h i is a therm allowerage. Note that the D rude weight D de ned above is di erent from the second derivative of the free energy which is related to a M eissner fraction.¹⁷

This expression is similar to that for the Hubbard model.¹⁰

A.Low tem perature expansion

We now derive the temperature dependence of D in the low temperature limit. We consider the case of the non-vanishing magnetic eld h \in 0. In this case, from eq.(10) we nd "() > 0. Thus, at low temperatures, eq.(9) is reduced to

Thus the D rude weight is non-zero at nite tem peratures. This result implies that the spin transport of the 1D quantum 0 (3) non-linear sigm a model in the low tem perature region is ballistic, and that the spin di usion does not exist.

B.H igh tem perature expansion

Here we consider the D rude weight in the high temperature lim it. A lthough in the su ciently high temperature region, the non-linear sigm a model is not related to the s = 1 H eisenberg spin chain, it is interesting to check that the spin di usion does not occur in the non-linear sigm a model even in the high temperature lim it. We invoke the standard m ethod for the high temperature expansion of the B ethe ansatz solution developed by Takahashi.¹⁹ For this purpose, it is convenient to rewrite eqs.(7), (8), (9) and (10) into the following form.

Note that D in the high tem perature lim it has the same tem perature dependence as that of the 1D Hubbard model. Since even in the high tem perature lim it, the D rude weight is non-zero, it is expected to be non-vanishing in the whole tem perature region. Therefore the spin di usion does not exist in the 1D quantum O (3) non-linear sigm a model. This is the m ain conclusion of this section.

III. 1-N - EXPANSION APPROACH TO THE SPIN DYNAM ICS OF THE O (N) SIGMA MODEL

In the previous section, we have calculated the D rude weight at nite tem peratures which is a probe for transport properties. However in order to discuss the spin di usion, it is desirable to study spin-spin correlation functions directly. This issue is not tractable in term softhe Bethe ansatz m ethod. M oreover, there is a criticism by Buragohain and Sachdev against the approach exploited in the previous section.²⁰ They claim ed that the calculation of the D rude weight from the nite size spectrum m ay not give the correct therm odynam ic limit at nite tem peratures. Thus, in this section, we will discuss spin-spin correlation functions with the use of the 1=N expansion m ethod for the quantum 1D O (N) sigm a m odel,^{21;22} and check the consistency with the results obtained by the Bethe ansatz m ethod in Sec.II. The 1=N expansion is utilized by several authors in the study of H aldane gap system s.^{23 {25} A though the O (N) sigm a m odel with large N is not related to the H aldane gap system s, the qualitative properties of the excitation are sin ilar to those of the O (3) sigm a m odel. It is expected that the results obtained for the O (N) sigm a m odel with large N m ay give a qualitative understanding of the O (3) sigm a m odel.

W e are mainly concerned with the spin lattice relaxation rate $1=T_1$, which is given by

where (q; !) is the retarded spin correlation function, $hS^{z}(q; !)S^{z}(q; !)^{h}$, and A (q) is a structure factor. It is known that in Haldane gap system s, the main contribution to $1=T_{1}$ comes from the uniform part of spin-spin correlation functions for q $0^{7,25}$. It is given by the correlation function of the uniform magnetization vector l = n $Q_{n} = v$. That is,

For su ciently large N, the excitation in the O (N) sigm a model is massive N-plet bosons interacting weakly with each other via a coupling constant of order O (1=N).²¹ Thus we can calculate the correlation function by the perturbative expansion in terms of 1=N. The G reen's function of the free massive N-plet bosons n is given by,

The lowest order self-energy correction of which the diagram is shown in Fig.1, is easily evaluated as Im^R c(!=T) exp(2m=T) (c, a constant) for small! and $p = 0^{24}$. If this damping elect is su ciently large, it leads to the dilusive form of the correlator for the medd,

Naively thinking, it seems that this correlation function gives rise to a di usive behavior of $1=T_1$. However this expectation is not correct. l is the conserved current of the non-linear sigm a model which satis as the continuity equation $\ell_t l + \ell_x j = 0$, where j vn ℓ_n . Therefore a W ard-T kahashi identity holds for these current operators. The W ard-T kahashi identity ensures the cancellation of the self-energy corrections with vertex corrections of the correlation functions, which leads to a ballistic behavior of spin-spin correlation functions. In order to show this, we introduce the three point vertex functions de ned as,

Thus it has a non-di usive pole at $! = (v_p = E_p)q$ which can not be removed by nite temperature e ects. This pole gives a logarithm ic singularity log ! of $1=T_1$ which signi es the ballistic spin transport. The result is basically equivalent to that obtained for the free boson model by Jolicoeur and Golinelli.²⁴ This ballistic behavior is due to the cancellation between the damping e ect and the vertex corrections. A lithough we have demonstrated the cancellation only up to the lowest order in 1=N, we expect that the cancellation holds in all orders. In this model the forward scattering is the dominant low energy process. Thus the quasiparticle damping does not give rise a di usive behavior, if one takes into account the vertex corrections which preserve the current conservation law. The above result is consistent with the Bethe ansatz solution obtained in Sec. II. Therefore we can conclude that the spin di usion is absent in the 1D quantum non-linear sigm a model itself.

IV.COUPLING W ITH PHONONS

In this section, we will discuss about the origin of spin di usion observed experimentally in the Haldane gap system, $A \text{gVP}_2 S_6$. The important feature observed in this experiment is that there exists the cuto frequency $!_c$ which depends on temperatures like $\exp(=T)$ with a constant. At $! > !_c$, the spin di usion is observed. One possible mechanism of the spin di usion may be a coupling with some other degrees of freedom, such as phonons, as discussed by N arozhny for the s = 1=2 Heisenberg spin chain.⁴ Here we will investigate this possibility. In order to treat the interaction between spin and phonon, we invoke the 1=N -expansion for the O (N) sigm a model. We add the following term to the Ham iltonian which represents the spin-phonon interaction,

where $b(x)(b^{y}(x))$ is an annihilation (creation) operator for phonons, and g^{0} is a coupling constant. For the case of N = 3, this term comes from the continuum limit of the spin-phonon interaction de ned on lattices,

We expect that the analysis for the O (N) sigm a model gives a qualitative understanding for the e ect of this term. For N ! 1, we can treat the spin-phonon interaction eq.(61) perturbatively. The diagram for the lowest order self-energy correction is shown in Fig.2. We can easily evaluate this diagram using the G reen's functions for massive m agnons (52) and free phonons given by,

where c is the velocity of phonons. Then the in aginary part of the retarded self-energy reads,

for sm all!. Here $m = m = \frac{P}{1} \frac{1}{(v^2 = c^2)}$. Then, if C(I) > E_q holds, the retarded G reen's function of massive N-plet n has a di usive pole,

where $D_s = v^2=C(T)$. In contrast to the case without phonons discussed in Sec. III, this damping e ect does not cancel with vertex corrections of the spin-spin correlation function, eq.(51), since the spin current operator is not conserved. Neglecting vertex corrections and using the di usive propagator (65), we evaluate the RPA type diagram s for the spin correlation function (51). The result is given by,

for sm all q and !. Here D_s^0 , !, and Z have the same tem perature-dependence as D_s . Thus we have a di usive behavior of the spin-spin correlation function. The Fourier transform ation of eq.(66) with respect to ! leads to,

Therefore, $!_{c}$ gives a cuto frequency. For $! > !_{c}$ the di usive behavior appears. The important point is that $!_{c}$ depends on temperatures, $!_{c}$ T sinh (m =2T), if we neglect the temperature dependence of the mass gap m. These results seem to give a qualitatively satisfying explanation for the spin di usion and the temperature-dependent cuto observed in AgVP₂S₆. Note that the presence of the temperature-dependent cuto frequency is quite due to the mass gap of the spin excitations. The above argument is applicable only if the damping elect eq.(64) is large enough to give rise to a di usive pole. In this case, the perturbative approach m ay break down, and the corrections due to higher order processes are not negligible, though it is expected that the propagator has a di usive form, eq.(65), for sm all m on entum and energy. Thus it m ay be di cult to tour result to the experimental data precisely. How ever tuning the parameters, v, c, g⁰ properly, we obtain the temperature dependence of !_c which is qualitatively consistent with the experimental results.

In this paper, we have shown that the spin transport of the 1D quantum non-linear sigm a model is ballistic even at nite temperatures, and that the spin di usion does not exist. We have also argued a possible mechanism for the spin di usion observed experimentally in the Haldane gap system $A gV P_2 S_6$. It has been shown that the coupling with phonons accounts for the experimental results qualitatively.

O ur study is based upon the non-linear sigm a model which is believed to be a low-energy elective theory for Hakane gap systems. We can not answer the question whether the spin dilusion intrinsically exists or not in the s = 1 Heisenberg spin chain model. A coording to de A kantara Bon m and Reiter, the 1D classical Heisenberg spin m odel does not show the spin dilusion even in the high temperature limit²⁷. The result for the classical spin system m ay be independent of whether the spin s is an integer or a half-integer, and generally quantum elects m ay suppress the therm all spin dilusion. Thus it is unlikely that the spin dilusion appears in the s = 1 quantum Heisenberg spin chain itself. We speculate that the spin dilusion observed in AgV P₂S₆ may be due to a coupling with some other degrees of freedom. How ever we need further investigations in order to reveal whether the spin dilusion is possible or not in the pure Heisenberg spin chains with an integer spin s.
