# D ynam ics of the N um ber of T rades of F inancial Securities

We perform a parallel analysis of the spectral density of (i) the logarithm of price and (ii) the daily number of trades of a set of stocks traded in the New York Stock Exchange. The stocks are selected to be representative of a wide range of stock capitalization. The observed spectral densities show a di erent power-law behavior. We con m the  $1=f^2$  behavior for the spectral density of the logarithm of stock price whereas we detect a 1=f-like behavior for the spectral density of the daily number of trades.

#### I. IN TRODUCTION

eld of econophysics [1] several em pirical re-In the searches have been perform ed to investigate the statistical properties of stock price and volatility tim e series of assets traded in nancialm arkets (for a recent overview see for example [2,3]). Comparably less attention has been devoted to the investigation of statistical properties of the dynam ics of the num ber of trades of a given asset. A sim ilar investigation is relevant for the basic problem of a quantitative assessment of the liquidity of the considered asset. There are two general aspects of liquidity for an asset traded in a market. The rst concerns how easily assets can be converted back into cash in a m arket, whereas the second refers to the general problem of the ability of the market to absorb a given amount of buying and selling of shares of a given security at reasonable price changes. In the present study we consider the statistical properties of trading related to the second aspect of liquidity cited above. Speci cally we investigate the tem poral dynam ics of the num ber of daily trades of 88 stocks traded in the New York Stock Exchange. The 88 stocks are selected at di erent values of their capitalization to provide a set of stocks representative of di erent levels of capitalizations. The interval of capitalization of our set is spanning m ore than three orders of m agnitude in capitalization. With this choice we are able to investigate both heavily traded and less frequently traded stocks. In the present study we focus our attention on the tim em em ory of the dynam ics of the num ber of trades of a set of nancial securities. We nd that most capitalized stocks are characterized by a dynam ics of the number of trades having interesting statistical properties. The time evolution of the number of trades has associated a power spectrum which is well approximated by a 1=flike behavior. We interpret this result as a quantitative evidence that the level of activity of highly capitalized and frequently traded stocks in a nancial market does not possess a typical time scale. The same behavior is also qualitatively detected in less capitalized stocks although the value of the exponent of the power spectrum S (f) / 1=f deviates from the value = 1 and m oves to lower values for stocks with lower capitalization. The m odeling of system s with 1=f power spectra is still a theoretical unsolved problem. Hence the level of activity of a given asset in a nancialm arket presents a statistical behavior whose theoreticalm odeling is certainly challenging. The paper is organized as follows: in the next section we illustrate the analyses perform ed by discussing the results obtained for one of the m ost capitalized stocks of the New York Stock Exchange. Section 3 presents the results obtained by investigating the selected set of stocks and in Section 4 we brie y state our conclusions.

#### II.SINGLE STOCK ANALYSIS




FIG.1. Log-log plot of the spectral density S (f) of the logarithm of price (bottom curve) and of the number of daily trades (top curve) of the G eneral E lectrics Co. (GE). The two spectral densities are well approximated by a power-law behavior S (f) / 1=f with = 1:93 and = 1:19, respectively. The two straight lines are our best t performed as explained in the text. In the inset we show the time evolution of the number of daily trades of GE (in thousands of trades) in the three-year investigated period.

W e analyze the number of daily trades for a selected set of securities traded in the New York Stock Exchange (NYSE). Our database is the trade and quote (TAQ) database [4] for the three-year period from Jan. 1995 to Dec. 1997. The typical number of daily trades n (t) depends on the stock considered and varies from a few to few thousands units per day. We st analyze the dynam ics of the num ber of daily trades for the General Electrics Co. (GE), which is one of the most capitalized stocks in the NYSE in the investigated period. The time series of the daily num ber of trades is shown in the inset of Fig. 1. The number of daily trades uctuates and the time series is non-stationary. In order to test the presence of long range correlation in this time series, we determ ine its spectral density. The spectral density for the tim e series of the num ber of trades of the GE is show n in the upper curve of Fig. 1. For comparison we also show the spectral density of the logarithm of the daily price of the same security. We tboth spectral densities with a power-law function S(f) / 1=f using a logarithm ic binnig in order to not overestim ate the high-frequency components. Our best estimation for the exponent of the spectral density of the logarithm of the price is = 1:93.




FIG.2. Spectral densities of the num ber of daily trades obtained by detrending the original time series. The detrending is obtained by dividing the time series by the running average in a time window of length L. In the four panels we show the spectral densities obtained by detrending the original time series with averaging windows of length L = 11 (top left), L = 21 (top right), L = 41 (bottom left) and L = 81 (bottom right) trading days. In the regions not a ected by the detrending procedure (f > 1=L) a 1=f-like behavior is always observed (solid line).

Hence, the spectral density is well approximated by  $S(f) = 1 = f^2$ , which is the prediction for the spectral density of a random walk. This form of the spectral density is related to the fact that returns of the price are short time correlated. This result is well-established in

nancial literature [5,6]. W e observe a di erent behavior for the spectral density of the daily num ber of trades. Ourbest tfor the exponent gives = 1:19. This value of the exponent is compatible with a 1=f noise [7,8]. The time series of the GE daily trades is non stationary and shows a clear trend. We check the e ect of these features on the tting of the spectral density by investigating surrogate data obtained rem oving the trend by evaluating a running average of the original time series computed using a window of length L. W ith this procedure, we obtain a detrended time series by dividing the original num ber of trades at a given day t by the average of the number of trades in a period of length L centered in t. W e take the values of L equal to 11;21;41 and 81 trading days. The new time series do not present a global trend. In Fig. 2 we scomponents lower than 1=L are a ected by the running average procedure. W e perform a power law

t in the interval of frequency higher than 1=L and our best t for the exponent gives = 1:09;0:85;0:85;0:91for L = 11;21;41;81, respectively. The estimation of the exponent is weakly a ected by the running averaging procedure. These results for the spectral density in the original and detrended time series indicate that the number of trades is intrinsically long-range correlated.

# III.COM PAR ISON BETW EEN STOCKS

In this section we study the general validity of the results illustrated in the previous section by studying a speci c stock. In particular we determ ine the spectral density of the logarithm of the price and of the number of daily trades for a set of 88 selected stocks traded in the NYSE.W e select the stocks random ly in a wide range of capitalization. The capitalization of our set ranges from 10 U SD, which is the capitalization of the Sun En-32 ergy (SLP), to 80 10USD for the GE.W e determ in e the spectral density for the  $\ln S_i$  (t) and of the  $n_i$  (t), where  $S_i(t)$  and  $n_i(t)$  are the closure price and the number of trades of com pany i at day t, respectively. The subscript i = 1; ...; 88 labels the com pany. For each spectral density we perform a power-law tS(f) / 1=f.We check the robustness of our ttings by determ ining their correlation coe cient and we nd absolute values ranging from 0:87 to 0:99 (average value 0:97) for the logarithm of the price and from 0:56 to 0:96 (average value 0:86) for the num ber of trades. In Fig. 3 we show the two exponents as a function of the capitalization of the investigated security. The large majority of values of the exponent of the spectral densities of the logarithm of the price is close to the value = 2.0 n the other hand the large majority of values of the exponent of the spectral densities of the number of daily trades is close to the value = 1, in particular for the most capitalized stocks. Moreover, the exponent increases tow ards the value = 1 as far as the capitalization increases. W hen we consider less capitalized stocks the typical num ber of daily trades can be very sm all, of the order of 10 or less. This fact leads to a problem of high digitalization noise of the time series,




FIG. 3. Plot of the exponent of the power-law t S (f) / 1=f of the spectral density of the number of trades ( led circle) and of the logarithm of the price (empty circle) as a function of the capitalization of the investigated company. The exponent for the logarithm of the price is almost constant for the majority of stocks and clusters in the neighborhood of = 2.0 n the contrary, for the number of trades, the exponent slow ly increases by increasing the capitalization and clusters in the neighborhood of = 1 for the most capitalized stocks.

because the number of trades is an integer and the quantization noise is relevant. As a consequence the statistical analysis on these time series may present a non negligible white noise contribution. This fact may be one reason for the observed decreases of the value of the exponent in less capitalized stocks.

#### $\ensuremath{\operatorname{IV}}$ . C O N C LU S IO N

The statistical properties of (i) the logarithm of the price and (ii) the number of daily trades of a security traded in a nancialm arket are quite di erent. Specifically, we con m that the time series of the logarithm of the price are characterized by a  $1=f^2$  spectral density, whereas we observe that the time series of the daily num ber of trades show a 1=f-like spectral density. The  $1=f^2$ behavior observed in the time evolution of the logarithm of the price re ects the short time tem poralm em ory of price returns. This kind of short-range time memory is needed to ensure absence of arbitrage opportunities in the market. On the other hand the 1=f-like behavior observed in the daily number of trades manifests the absence of a typical scale in the time memory of this variable. In other words the activity of trading is not constant in time even for most capitalized stocks and its modeling needs to take into account phenom ena occurring at a variety of time scales. Realistic models of

trading activities in nancial markets should take into account this feature empirically observed.
