DRIVING FORCE IN INVESTMENT

W e study investment strategy in di erent models of nancialmarkets, where the investors cannot reach a perfect know ledge about available assets. The investor spends a certain e ort to get information; this allows him to better choose the investment strategy, and puts a selective pressure upon assets. The best strategy is then a comprom ise between diversi cation and e ort to get information.

1. Introduction

Standard theory in nance assumes perfect information. For example, portfolio theories and CAPM (Capital A set Pricing Model) reduce investment strategies to a mechanic optimization problem, with a given set of parameters like expected returns and volatility (see [2]). In real life the property of an asset, say a stock, cannot be characterized simply by a few parameters. In fact the possible sources of in uence on a stocks pricemust be unlimited. On the other hand, not all parameters are as important and nobody has in nite e ort to study all of them.

We present an alternative study of investment strategies. We consider all the information is imperfect, but upon the investor's diligent e ort, the precision can be improved. But there is a limit: even with in nite e ort precise prediction is not possible. This is similar in spirit with the approach followed by G rossman and Stiglitz [4], but our approach is simpler and has wider applicability. The important di erence separates ours from [4] is that we do not equalize information cost and its monetary value. We use instead the concept of e ort, which cannot always be bought | having to do with an investor's experience and quality. These hum an factors were consistently om itted in econom ics literature.

We use two sets of parameters (i.e. information): one is the reality which can never be known exactly; the other the perceived values which are always distorted by investors. W ith increased e ort an investor can improve the precision of information, leading to better gains. Not only an investor gains, thanks to his diligent e ort, he does also a social service by putting pressure on the worse performing opportunity (e.g. a stock), whereas encouraging the better opportunity to grow with increased capital. In a sense every increase in e ort puts additional evolutionary pressure among the opportunities.

Hum an e ort is always nite. Be it a big investment bank or a day trader, the e ort (including monetary cost) that can be used to search out more precise inform ation about investm ent opportunities. If this sounds evident, then we are led to the inevitable conclusion that a rational investor should not diversify too much. The logic runs as follows: an investor has the total e ort to spend on nding out information. There are a su ciently large number of opportunities available. If he concentrate on only one of them, then he can expect to obtain good quality of inform ation on that one, while remains ignorant of all the others. We know that diversi cation is a good thing: it reduces uctuation with the same expected \gain". Thus more leverage can be used to achieve higher gain, with the same volatility. So our investor would heed the advice from standard theory to diversify but only to a point. In fact, the rational way for him is diversify som ewhat, to still obtain a reasonable estimate of the considered options. There is a comprom ise between the bene tofdiversi cation and deepened know ledge. Too much diversi cation dilutes his e ort since he has to divide his total available e ort am ong the alternatives. Of course the total diversi cation is also a strategy, if he has no e ort/time to study the investment opportunities, then he is well advised to buy into an index fund. But, on the other hand, if everybody does the same: i.e. uses no-e ort strategy, then the evolutionary pressure is no longer there, and the index (i.e. the average expected gain of all the opportunities) would not even be there!

We also consider the structure of an investment network. In investment there are so-called Favorable G ames (FG s), provided by producers (see [3]). However, producers cannot keep all the potential benet to them selves since the initial uctuations are very large. There is a sym biosis between the producers and speculators, in fact they form a network. The network as a whole acts as an organism of digesting the original FG s, with successive levels absorbing the initial shocks, transmitted from the producers downstream. Farther away from the initial producer level, the shocks are more and more attenuated, but the expected gains also get reduced. In a society som ebody may nd him self sitting com fortably at the "safer" levels, while som e otherm ight be interested in nding a place on the front "producer line". This web-like network in fact can be argued as the most e cient system in nding and exploiting the original FG s.

2. Inform ation and D iversi cation

A reasonable way to describe assets price variations (on a given time-scale) is to assume them to be multiplicative random walks with log-normal step. This comes from the assumption that growth rates of prices are more signi cant that their absolute variations. So, we describe the price of a nancial assets as a time-dependent multiplicative random process. We introduce a set of N G aussian random variables x_i (t) depending on a time parameter t. By this set, we de ne N independent multiplicative G aussian random walks, whose assigned discrete time evolution is given by

for i = 1; :::; N, where each x_i (t) is not correlated in time. To optim ize an investment, one can choose di erent risk-return strategies. Here, by optim ization we will mean the maximization of the typical capital grow thrate of a portfolio. In [1] it was shown that a capital W (t), invested into di erent nancial assets who behave as multiplicative random walks, grows almost certainly at an exponential rate hh $\frac{W_{-}(t+1)}{W_{-}(t)}$ i, where one must average over the distribution of the single multiplicative step. We assume that an investment is diversile ed according to the K elly's optimum investment fraction, in order to maximize the typical capital grow thrate over N assets with identical average return = he^{x_i(t)} i 1 and squared volatility = he^{2x_i(t)} i he^{x_i(t)} i². On each asset, the investor will allocate a fraction f_i of his capital, according to the return expected from that asset. The time evolution of the total capital is ruled by the follow ing multiplicative process

F irst, we consider the case of an unlimited investment, i.e. we put no restriction to the value of $P_{i=1}^{N} f_i$. The typical growth rate

of the investor's capital can be calculated through the following 2nd-order expansion in e^{x_1} 1 if we assume that uctuations of prices are small and uncorrelated, that seems to be quite reasonable (see also [1]):

By solving $\frac{d}{dt}V_{typ} = 0$, it easy to show that the optim alvalue for f_i is $f_i^{opt}(;) = \frac{1}{2_+}$ for all i. We assume that the investor has a little ignorance about the real value of , that we represent by a Gaussian uctuation around the real value of . In the investor'sm ind, each asset is di erent, because of this uctuation $_i = +_i$. The $_i$ are drawn from the same distribution, with $h_i i = 0$ as errors are normally distributed around the real value. We suppose that the investor makes an e ort E to investigate and get information about the statistical parameters of the N assets upon which he will spread his capital. So, his ignorance (i.e. the width of the distribution of the $_i$) about the real value of $_i$ will be a decreasing function of the e ort \per asset" $\frac{E}{N}$; m ore, we suppose that an even in nite e ort will not make this ignorance vanish. In order to plug these assumptions in the model, we write the width of the distribution of the distribution of as

w ith > 0. A s one can see, the greater is E , the m ore exact is the perception, and better is the investment. D $_0$ is the asymptotic ignorance. All the invested fraction

 $f^{opt}(\ _i;\)$ will be di erent, according to the investor's perception. A ssum ing that the $_i$ are small, we expand all $f_i(\ +\ _i)$ in equation (2.4) up to the 2nd order in $_i$, and after averaging over the distribution of $_i$, we obtain the mean value of the typical capital grow the rate for an investor who provides a given e ort E :

We are now able to nd the optim alnum ber of assets to be included in the portfolio (i.e., for which the investment is more advantageous, taken into account the e ort provided to get inform ation), by solving $\frac{d}{dN}V_{typ} = 0$; it easy to see that the optim al num ber of assets is given by

that is an increasing function of the e ort E, as one can see in the example of F ig. 1. Notice that if the investor has no lim it in the total capital fraction invested in the portfolio (so that it can be greater than 1, i.e. the investor can invest m ore m oney than he has, borrowing it from an external source), the capital can take negative values, if the assets included in the portfolio encounter a simultaneous negative step. So, if the total investment fraction is greater than 1, we should take into account also the cost of refunding loss to the bank, to predict the typical grow th rate of the capital.

3. K now ledge drives Selective P ressure

W e suppose that the investor can choose among N di erent option with di erent average returns. We assume that each asset has an average return $i = he^{x_i} i = 1$, with $i = 1; \dots; N$, and a volatility . As a reasonable hypothesis, we assume that in a market, good and bad stocks are equally distributed, but most of them behave in an interm ediate way. We suppose that the $_{i}$ are drawn from a Gaussian distribution with mean m and variance D, whose density function is written (). Here, m plays the role of a market index. Moreover, the investor's perception is not of realization of the market, i.e. a set of i, the investor adds exact: given a set a little \error" $_{\rm i}$ on each asset: from the investor's point of view, the set appears to be the set ${}^{0} = f {}^{0}_{i} = {}_{i} + {}_{i}g_{i}$. The ${}_{i}$ are independent random variables draw n from a Gaussian distribution with zero mean and variance d. d is then a measure of the precision of the investor. The smaller is d, the clearer is the investor's perception of the assets. One can give a rough estimate of the typical growth rate of an investor who can choose among the N assets to diversify his portfolio. First of all, the investor will bok for assets with positive average return: in his perception, he will then include in his portfolio only the assets with a positive ${}^{0}_{i}$. As the ${}_{i}$ and

the $_{i}$ are G aussian distributed, the $_{i}^{0}$ will be distributed as a G aussian variable with mean m and variance d + D. Thus, to estimate the number \overline{n} of assets to be included in the portfolio, we will use is expectation value \overline{n} ' N P rob($^{0} > 0$), where P rob($^{0} > 0$) is the probability to have a value of 0 greater than 0. G iven a set $_{i}$, we put them in a decreasing order, so that $_{1} > _{2} > :::> _{N}$. One can estimate the value of the $_{i}$, that we note where now the index i is referred to the order, by means of the condition P ($> _{i}$) = $\frac{i}{N}$, that is

i.e. the \inverse function" of the gaussian cum ulative distribution. As in [1], one will allocate a fraction $f_{opt}() = \frac{1}{2+1}$ on an asset with average return and volatility

. The average value (i.e. with respect to the distribution of errors and over all the possible realization of the market) of the typical grow th rate of an investor who provides a given e ort E is given by eq. 2.4, who can be written, in case of sm all returns, as

A gain, we expand $f^{opt}(+)$ up to 2nd order in , and take the average with respect of the distribution of the $_{i}$, to obtains the expressions for the m on ents of f_{i} . If we note $V_{0} = \overline{W_{typ}(; 0)}$ i, the typical growth rate of an investor provided with a perfect know ledge of the assets, we are then able to write

where d is a decreasing function of the e ort. So, as expected, M_{yp} (;d(E)) i is a increasing function of the e ort provided to get a better know ledge of the m arket, as it is shown in Fig. 2 referring to a ten assets m arket with a average grow th rate of 0.5%.

4. Fixed Investm ent Fraction

An investment must be diversi ed upon di erent assets, to reduce uctuation and increase typical growth. But in order to reduce uctuations, the investor must include less advantageous assets in his portfolio, in a realistic case. This leads to an optim al number of assets included in the portfolio. This mechanism has been described by [1]. If the investment is diversi ed upon n di erent assets with the

following set of average returns and volatilities f_i ; g for i 1, a priori the investors should put a fraction $r_i = \frac{1}{2+1}$. We assume that $+ \frac{2}{2}$ as it is often the case in real nance. Thus, the investor should allocate the capital fraction $r_i(i;)' - (i)$ on each asset. If the total invested fraction is xed, and equal to C, we have to satisfy the condition $\sum_{i=1}^{p} r_i = C$. This can be done by introducing a Lagrange multiplier (n) with the condition $\sum_{i=1}^{n} (r_i) = C$, (n)) = C, and then the optim al fraction to be invested on asset i is $f_i = -$ (n). A sets available on m arket are not all equal. W e suppose to have N assets whose average return and squared volatility are f_i ; g. Again, we can reorder the i to have $1 > 2 > \ldots > N$. We suppose that the i are distributed as a G aussian variable around a mean value m with a square deviation equal to D. The mean value acts as an average variation of the market index, and the deviation D is a measure of the market volatility. M oreover, investor hasn't got an exact perception of the real value i: in his perception, the i-th assets has an average return $\int_{i}^{0} = i + i$, where i are drawn from a Gaussian distribution, with mean value h i = 0 and square deviation $h^2 i = d$. The more exact is the perception, the smaller is the d. So, in the investor's perception, assets drift values 🕴 are still distributed as a Gaussian variable, with the samemean valuem and variance D + d, as it is the variance of the sum of two Gaussian variables. Thus, the investor is led to put on the i-th assets a fraction $r_i(_i^0;$). To have the maximal diversication, the investor has to choose the \best" n assets satisfying the condition that the related investment fraction r_i is bigger that the Lagrange multiplier (n) built upon the n assets, as seen in [1]. For a given n, we have n (n) = $\int_{i=1}^{n} r_i = C$. The condition to have n assets included in the portfolio, is that $r_n > (n)$ and $r_{n+1} < (n_n+1)$. Then, the optimal value of n is given by the self-consistent equation $nr_n = \prod_{i=1}^{r} r_i$ C.To evaluate r_i , we use a rough estimate for ${}_i^0$, that we note $\overline{}_i^0$, obtained through the condition P rob($\binom{0}{i} > \frac{-0}{i}$) = $\frac{i}{N}$. Recalling to the reader the de nition (3.10) of the function T, we can write

By solving this equation, one obtains an estimate of the number of assets upon which an investor with an \ignorance" d will invest. The dependence on N shows that in a more populated market there will be more assets on which it could be worth to invest, rather than a less populated one, so that the diversi cation of the portfolio can be made over all \good" assets.

5. K now ledge is a D riving Force: a Single C ell case

Now we look with more detail the case of an investor forced to put all his capital on two assets $(f_1 + f_2 = 1)$, that we still represent as multiplicative G aussian random

W e assume that the investor has a wrong perception of the real statistical parameters m_1 and m_2 of the assets. Then, in his perception $m_1^0 = m_1 + 1$ and $m_2^0 = m_2 + 2$ are the mean values of the random walks, then he will allocate a fraction equal to $f^{opt}(m_1^0; i)$. If 1 and 2 are G aussian variables with $h_1 i = 0$ and $h_1^2 i = d$, V_{typ} too becomes a random variable, whose density function is easily calculated by means of standard probability relations for functions of random variable.

If A and B are small, the last two terms in the density function can be dropped and we obtain the following derivative, as shown in Fig. 3, where we have xed the average growth rates equal to 1% (for both assets), and volatilities to 30% (for both assets):

6. Investm ent N etw ork

walks

We introduce a set of identically distributed multiplicative random walks, to describe price variations:

for i = 1; :::; N. We note by $_0$ and $_0$ their average return and volatility, as de ned above. We note by hi the average over the distribution of the x. The web-like model is built in the following way. Starting from i = 1, each pair of consecutive assets $p_i(t)$ and $p_{i+1}(t)$ becomes a two-assets portfolio for an investor, whose capital stock follows a random walk driven by the \basic" random walksp_i(t). In this way, we obtain a new set of N investor (one for each pair of subsequent assets), whose capitals describes a multiplicative random walk \driven" by the basic one. Iterating this process of \two-assets investing" over this new set of random walk, and assuming periodic boundary conditions (i.e., we add a N + 1-th site at each level identical to the rst site), we build a network made of subsequent levels of N investors, that we note W $_{i}^{(1)}$ where 1 stands for the level and i is the site index. The capital of each investors then follows a multiplicative random walk. W e introduce a generalized multiplicative step, or \return", by the de nition

The set of the N basic random walks $p_i(t)$ is the 0-th level, so that $W_i^{(0)}(t) = p_i(t)$ and $R_i^{(0)}(t) = e^{x_i(t)}$. Even if the model still remains a simple description of economical systems, it takes into account two factors: 1) the need of diversi cation of a portfolio, in order to absorb the shocks; 2) the impossibility of getting a perfect know ledge about all economic factors, that leads to an upper limit for the diversi cation itself. If one could get information \for free", he could invest on all the favorable assets, (see Fig. 4). In our model, each agent invests a constant fraction f of his capital in each of the two assets who stand below him. So, investors at the H 1-th level are ruled by the following set of equations of motion:





One can see in g. 5, where we have plotted a case in which the basic random walks have an average return of 1%, a volatility of 10% and agents invest a 20% fraction of their capital on each assets, that investors belonging to upper levels can take advantage of the lower ones, who dump the uctuations coming of the basic random walks, but also get a lower gain, since their capital evolution has a weaker dependence on the basic, and hopefully favorable, price variations.








Typical growth rate

Here, information is free and investors can choose to diversify portfolios over all available assets (as other investors' capital)



This model takes into account both the need of diversification and the cost of getting information about assets, that prevents from investing over all favourable games.
