# A duality between Schrödinger operators on graphs and certain Jacobi matrices

The known correspondence between the Kronig-Penney model and certain Jacobi matrices is extended to a wide class of Schrödinger operators on graphs. Examples include rectangular lattices with and without a magnetic field, or comb-shaped graphs leading to a Maryland-type model.

## I Introduction

Schrödinger operators on $L^{2}(\Gamma)$, where $\Gamma$ is a graph, were introduced into quantum mechanics long time ago []]. In recent years we have wittnessed of a renewed interest
 quoted in these papers - motivated mostly by the fact that they provide a natural, if idealized, model of semiconductor "quantum wire" structures.

Jacobi matrices, on the other hand, attracted a lot of attention in the last decade, in particular, as a laboratory for random and almost periodic systems. The most popular examples are the Harper and related almost Mathieu equation dating back to [13, 14, 15]; for more recent results and an extensive bibliography see, e.g., [16, 17, 18, 19, 20, 21]. The underlying lattices are mostly periodic of dimension one or two; however, more complicated examples have also been studied [22, 23].

In case when $\Gamma$ is a line with an array of point interactions, i.e., the Schrödinger operator in question is a Kronig-Penney-type Hamiltonian, there is a bijective correspondence - dubbed the French connection by B. Simon [16] - between such systems and certain Jacobi matrices [18, 24, 25, 26, 27, 28]. The aim of this paper is to show that the same duality can be established for a wide class of Schrödinger operators on graphs, including the case of a nonempty boundary. In general, the resulting Jacobi matrices exhibit a varying "mass".

## II Preliminaries

Let $\Gamma$ be a connected graph consisting of at most countable families of vertices $\mathcal{V}=\left\{\mathcal{X}_{j}: j \in I\right\}$ and links (edges) $\mathcal{L}=\left\{\mathcal{L}_{j n}:(j, n) \in I_{\mathcal{L}} \subset I \times I\right\}$. We suppose that each pair of vertices is connected by not more than one link. The set $\mathcal{N}\left(\mathcal{X}_{j}\right)=\left\{\mathcal{X}_{n}: n \in \nu(j) \subset I \backslash\{j\}\right\}$ of neighbors of $\mathcal{X}_{j}$, i.e., the vertices connected with $\mathcal{X}_{j}$ by a single link, is nonempty by hypothesis. The graph boundary $\mathcal{B}$ consists of vertices having a single neighbor; it may be empty. We denote by $I_{\mathcal{B}}$ and $I_{\mathcal{I}}$ the index subsets in $I$ corresponding to $\mathcal{B}$ and the graph interior $\mathcal{I}:=\mathcal{V} \backslash \mathcal{B}$, respectively.
$\Gamma$ has a natural ordering by inclusions between vertex subsets. We assume that it has a local metric structure in the sense that each link $\mathcal{L}_{j n}$ is isometric with a line segment $\left[0, \ell_{j n}\right]$. The graph can be also equipped with a global metric, for instance, if it is identified with a subset of $\mathbb{R}^{\nu}$. Of course, the two metrics may differ at a single link. Using the local metric, we are able to introduce the Hilbert space $L^{2}(\Gamma):=\bigoplus_{(j, n) \in I_{\mathcal{L}}} L^{2}\left(0, \ell_{j n}\right) ;$ its elements will be written as $\psi=\left\{\psi_{j n}:(j, n) \in I_{\mathcal{L}}\right\}$ or simply as $\left\{\psi_{j n}\right\}$. Given a family of functions $V:=\left\{V_{j n}\right\}$ with $V_{j n} \in L^{\infty}\left(0, \ell_{j n}\right)$, we define the operator $H_{\mathcal{C}} \equiv H(\Gamma, \mathcal{C}, V)$ by

H_{\mathcal{C}}\left\{\psi_{j n}\right\}:=\left\{-\psi_{j n}^{\prime \prime}+V_{j n} \psi_{j n}:(j, n) \in I_{\mathcal{L}}\right\} \tag{2.1}
\end{equation*}

with the domain consisting of all $\psi$ with $\psi_{j n} \in W^{2,2}\left(0, \ell_{j n}\right)$ subject to a set $\mathcal{C}$ of boundary conditions at the vertices which connect the boundary values

\begin{equation*}
\psi_{j n}(j):=\lim _{x \rightarrow 0+} \psi_{j n}(x), \quad \psi_{j n}^{\prime}(j):=\lim _{x \rightarrow 0+} \psi_{j n}^{\prime}(x) \tag{2.2}
\end{equation*}
$$

we identify here the point $x=0$ with $\mathcal{X}_{j}$.
There are many ways how to make the operator (2.1) self-adjoint; by standard results [18, 29] each vertex $\mathcal{X}_{j}$ may support an $N_{j}^{2}$ parameter family of boundary conditions, where $N_{j}:=\operatorname{card} \nu(j)$. These self-adjoint extensions were discussed in detail in [4]; here we restrict ourselves to one of the following two possibilities which represent in a sense extreme cases 10, 11]:
(a) $\delta$ coupling: at any $\mathcal{X}_{j} \in \mathcal{I}$ we have $\psi_{j n}(j)=\psi_{j m}(j)=: \psi_{j}$ for all $n, m \in \nu(j)$, and

for some $\alpha_{j} \in \mathbb{R}$.
(b) $\delta_{s}^{\prime}$ coupling: $\psi_{j n}^{\prime}(j)=\psi_{j m}^{\prime}(j)=: \psi_{j}^{\prime}$ for all $n, m \in \nu(j)$, and

\sum_{n \in \nu(j)} \psi_{j n}(j)=\beta_{j} \psi_{j}^{\prime} \tag{2.4}
\end{equation*}
$$

for $\beta_{j} \in \mathbb{R}$.
The relations (2.3) and (2.4) are independent of $V$, since potentials are supposed to be essentially bounded. At the graph boundary we employ the usual conditions,

which can be written in either form (infinite values allowed); for the sake of brevity we denote the set $\mathcal{C}$ as $\alpha=\left\{\alpha_{j}\right\}$ or $\beta=\left\{\beta_{j}\right\}$, respectively, with the index running over $\mathcal{V}$, and use the shorthands $H_{\alpha}:=H\left(\Gamma,\left\{\alpha_{j}\right\}, V\right)$ and $H_{\beta}:=H\left(\Gamma,\left\{\beta_{j}\right\}, V\right)$. Looking for solutions to the equations

H_{\mathcal{C}} \psi=k^{2} \psi, \quad \mathcal{C}=\alpha, \beta \tag{2.6}
\end{equation*}
$$

we shall consider the class $D_{l o c}\left(H_{\mathcal{C}}\right)$ which is the subset in $\bigvee_{(j, n) \in I_{\mathcal{L}}} L^{2}\left(0, \ell_{j n}\right)$ (the direct sum) consisting of the functions which satisfy all requirements imposed at $\psi \in D\left(H_{\mathcal{C}}\right)$ except the global square integrability.

The conditions (2.3) and (2.4) define self-adjoint operators also if the coupling constants are formally put equal to infinity. We exclude this possibility, which corresponds, respectively, to the Dirichlet and Neumann decoupling of the operator at $\mathcal{X}_{j}$ turning the vertex effectively into $N_{j}$ points of the boundary. On the other hand, we need it to state the result. Let $H_{\alpha}^{D}$ and $H_{\beta}^{N}$ be the operators obtained from $H_{\alpha}, H_{\beta}$ by changing the conditions (2.3), (2.4) at the points of $\mathcal{I}$ to Dirichlet and Neumann, respectively, while at the boundary they are kept fixed. We define $\mathcal{K}_{\alpha}:=\left\{k: k^{2} \in \sigma\left(H_{\alpha}^{D}\right), \operatorname{Im} k \geq 0\right\}$ and $\mathcal{K}_{\beta}$ in a similar way.

## III Main result

Consider the operators $H_{\alpha}, H_{\beta}$ defined above. We shall adopt the following assumptions:
(i) There is $C>0$ such that $\left\|V_{j n}\right\|_{\infty} \leq C$ for all $(j, n) \in I_{\mathcal{L}}$.
(ii) $\ell_{0}:=\inf \left\{\ell_{j n}:(j, n) \in I_{\mathcal{L}}\right\}>0$.
(iii) $L_{0}:=\sup \left\{\ell_{j_{n}}:(j, n) \in I_{\mathcal{L}}\right\}<\infty$.
(iv) $N_{0}:=\max \{\operatorname{card} \nu(j): j \in I\}<\infty$.

On $\mathcal{L}_{n j} \equiv\left[0, \ell_{j n}\right]$ (the right endpoint identified with $\mathcal{X}_{j}$ ) we shall denote as $u_{j n}^{\mathcal{C}}, \mathcal{C}=\alpha, \beta$, the solutions to $-f^{\prime \prime}+V_{j n} f=k^{2} f$ which satisfy the boundary conditions

u_{j n}^{\alpha}\left(\ell_{j n}\right)=1-\left(u_{j n}^{\alpha}\right)^{\prime}\left(\ell_{j n}\right)=0, \quad 1-u_{j n}^{\beta}\left(\ell_{j n}\right)=\left(u_{j n}^{\beta}\right)^{\prime}\left(\ell_{j n}\right)=0
$$

and

$$
\begin{aligned}
v_{j n}^{\alpha}(0)=1-\left(v_{j n}^{\alpha}\right)^{\prime}(0)=0, \quad 1-v_{j n}^{\beta}(0)=\left(v_{j n}^{\beta}\right)^{\prime}(0)=0 & \text { if } n \in I_{\mathcal{I}}, \\
v_{j n}^{\mathcal{C}}(0)=\sin \omega_{n}, \quad\left(v_{j n}^{\mathcal{C}}\right)^{\prime}(0)=-\cos \omega_{n} & \text { if } n \in I_{\mathcal{B}} ;
\end{aligned}
$$

their Wronskians are

$$
W_{j n}^{\alpha}=-v_{j n}^{\alpha}\left(\ell_{j n}\right), \quad W_{j n}^{\beta}=\left(v_{j n}^{\beta}\right)^{\prime}\left(\ell_{j n}\right),
$$

respectively, or

$$
\begin{array}{cl}
W_{j n}^{\alpha}=u_{j n}^{\alpha}(0), \quad W_{j n}^{\beta}=-\left(u_{j n}^{\beta}\right)^{\prime}(0) & \text { if } \quad n \in I_{\mathcal{I}}, \\
W_{j n}^{\mathcal{C}}=-u_{j n}^{\mathcal{C}}(0) \cos \omega_{n}-\left(u_{j n}^{\mathcal{C}}\right)^{\prime}(0) \sin \omega_{n} & \text { if } \quad n \in I_{\mathcal{B}} .
\end{array}
$$

If not necessary we do not mark explicitly the dependence of these quantities on $k$.
Theorem III. 1 (a) Let $\psi \in D_{\text {loc }}\left(H_{\alpha}\right)$ solve (2.6) for some $k \notin \mathcal{K}_{\alpha}$ with $k^{2} \in \mathbb{R}$, $\operatorname{Im} k \geq 0$. Then the corresponding boundary values (2.2) satisfy the equation

\sum_{n \in \nu(j) \cap I_{\mathcal{I}}} \frac{\psi_{n}}{W_{j n}^{\alpha}}-\left(\sum_{n \in \nu(j)} \frac{\left(v_{j n}^{\alpha}\right)^{\prime}\left(\ell_{j n}\right)}{W_{j n}^{\alpha}}-\alpha_{j}\right) \psi_{j}=0 \tag{3.7}
\end{equation*}
$$

Conversely, any solution $\left\{\psi_{j}: j \in I_{\mathcal{I}}\right\}$ to (3.7) determines a solution of (2.6) by

\psi_{j n}(x)=\frac{\psi_{n}}{W_{j n}^{\alpha}} u_{j n}^{\alpha}(x)-\frac{\psi_{j}}{W_{j n}^{\alpha}} v_{j n}^{\alpha}(x) & \text { if } \quad n \in \nu(j) \cap I_{\mathcal{I}},  \tag{3.8}\\
\psi_{j n}(x)=-\frac{\psi_{j}}{W_{j n}^{\alpha}} v_{j n}^{\alpha}(x) & \text { if } \quad n \in \nu(j) \cap I_{\mathcal{B}} . \tag{3.9}
\end{align*}
$$

(b) For a solution $\psi \in D_{\text {loc }}\left(H_{\beta}\right)$ of (2.6) with $k \notin \mathcal{K}_{\beta}$, the above formulae are replaced by

\sum_{n \in \nu(j) \cap \cap_{\mathcal{I}}} \frac{\psi_{n}^{\prime}}{W_{j n}^{\beta}}+\left(\sum_{n \in \nu(j)} \frac{v_{j n}^{\beta}\left(\ell_{j n}\right)}{W_{j n}^{\beta}}+\beta_{j}\right) \psi_{j}^{\prime}=0 . \tag{3.10}
\end{equation*}
$$

and

$$
\begin{align*}
\psi_{j n}(x)=-\frac{\psi_{n}^{\prime}}{W_{j n}^{\beta}} u_{j n}^{\beta}(x)+\frac{\psi_{j}^{\prime}}{W_{j n}^{\beta}} v_{j n}^{\beta}(x) & \text { if } n \in \nu(j) \cap I_{\mathcal{I}},  \tag{3.11}\\
\psi_{j n}(x)=\frac{\psi_{j}^{\prime}}{W_{j n}^{\beta}} v_{j n}^{\beta}(x) & \text { if } \quad n \in \nu(j) \cap I_{\mathcal{B}} . \tag{3.12}
\end{align*}
$$

(c) Under (i), (ii), $\psi \in L^{2}(\Gamma)$ implies that the solution $\left\{\psi_{j}\right\},\left\{\psi_{j}^{\prime}\right\}$ of (3.7) and (3.19), respectively, belongs to $\ell^{2}\left(I_{\mathcal{I}}\right)$.
(d) The opposite implication is valid provided (iii), (iv) also hold, and $k$ has a positive distance from from $\mathcal{K}_{\mathcal{C}}$.

Proof. (a,b) We shall consider $H_{\alpha}$ throughout, the argument for $H_{\beta}$ is analogous; for simplicity we drop the superscript $\alpha$. If $n \in I_{\mathcal{I}}$, the transfer matrix on $\mathcal{L}_{n j}$ is

T_{n j}(x, 0)=W_{j n}^{-1}\left(\begin{array}{cc}
u_{j n}(x)-u_{j n}^{\prime}(0) v_{j n}(x) & u_{j n}(0) v_{j n}(x) \\
u_{j n}^{\prime}(x)-u_{j n}^{\prime}(0) v_{j n}^{\prime}(x) & u_{j n}(0) v_{j n}^{\prime}(x)
\end{array}\right)
$$

the Wronskian is nonzero for $k \notin \mathcal{K}_{\alpha}$. This yields an expression of $\psi_{j n}(x)$ in terms of $\psi_{j n}(n)=: \psi_{n}$ and $\psi_{j n}^{\prime}(n)$, in particular,

\psi_{j} & :=\psi_{j n}(j)=u_{j n}^{\prime}(0) \psi_{n}+v_{j n}\left(\ell_{j n}\right) \psi_{j n}^{\prime}(n) \\
-\psi_{j n}^{\prime}(j) & =\frac{1-u_{j n}^{\prime}(0) v_{j n}^{\prime}\left(\ell_{j n}\right)}{W_{j n}} \psi_{n}+v_{j n}^{\prime}\left(\ell_{j n}\right) \psi_{j n}^{\prime}(n)
\end{aligned}
$$

the sign change at the lhs of the last condition reflects the fact that (2.2) defines the outward derivative at $\mathcal{X}_{j}$. We express $\psi_{j n}^{\prime}(n)$ from the first relation and substitute to the second one; this yields

\psi_{j n}^{\prime}(j)=-\frac{\psi_{n}}{W_{j n}}+\frac{v_{j n}^{\prime}\left(\ell_{j n}\right)}{W_{j n}} \psi_{j}
$$

If $n \in I_{\mathcal{B}}$ we have instead

\begin{gathered}
\psi_{j}=u_{j n}^{\prime}(0) \psi_{n}-u_{j n}(0) \psi_{j n}^{\prime}(n) \\
-\psi_{j n}^{\prime}(j)=\frac{u_{j n}^{\prime}(0) v_{j n}^{\prime}\left(\ell_{j n}\right)-\cos \omega_{n}}{W_{j n}} \psi_{n}+\frac{u_{j n}(0) v_{j n}^{\prime}\left(\ell_{j n}\right)-\sin \omega_{n}}{W_{j n}} \psi_{j n}^{\prime}(n) ;
\end{gathered}
$$

we may write, of course, $\psi_{n}^{\prime}:=\psi_{j n}^{\prime}(n)$. Using the relations $\psi_{n} \cos \omega_{n}+\psi_{n}^{\prime} \sin \omega_{n}=0$, we find

\psi_{j n}^{\prime}(j)=\frac{v_{j n}^{\prime}\left(\ell_{j n}\right)}{W_{j n}} \psi_{j}
$$

so (3.7) follows from (2.2). The transfer-matrix expression of $\psi_{j n}(x)$ together with the mentioned formula for $\psi_{j n}^{\prime}(n)$ yield (3.8); (3.9) is checked in the same way.
(c) Without loss of generality we may consider real $\psi$ only. Any solution to the Schrödinger equation on $\mathcal{L}_{n j}$ can also be written as

\psi_{j n}(x)=\psi_{j n}(n) w_{j n}(x)+\psi_{j n}^{\prime}(n) v_{j n}(x),
$$

where $w_{j n}$ is the normalized Neumann solution at $\mathcal{X}_{n}, w_{j n}^{\prime}(0)=1-w_{j n}(0)=0$. The argument of [18, Sec.III.2.1] cannot be used here, even in the classically allowed region. Instead we employ a standard result of the Sturm-Liouville theory [30, Sec.1.2] by which

\end{equation*}

and similar representations are valid for $w_{j n}$ and their derivatives; the kernels have an explicit bound in terms of the potential $V_{j n}$. The latter is essentially bounded, by (i) uniformly over $\mathcal{L}$. Hence there is a positive $\ell_{1}<\frac{1}{2} \ell_{0}$ such that

\max \left\{\left|v_{j n}(x)\right|,\left|v_{j n}^{\prime}(x)-1\right|,\left|w_{j n}(x)-1\right|,\left|w_{j n}^{\prime}(x)\right|\right\}<\frac{1}{10}
$$

for $x \in\left[0, \ell_{1}\right)$ and any $(j, n) \in I_{\mathcal{L}}$; we infer that

\begin{aligned}
\psi_{j n}(x)^{2} & =\psi_{j n}(n)^{2} w_{j n}(x)^{2}+\psi_{j n}^{\prime}(n)^{2} v_{j n}(x)^{2}+2 \psi_{j n}(n) \psi_{j n}^{\prime}(n) w_{j n}(x) v_{j n}(x) \\
& \geq \frac{9}{20} \psi_{j n}(n)^{2}-\frac{37}{100} \psi_{j n}^{\prime}(n)^{2}
\end{aligned}
$$

An analogous estimate can be made for $\psi_{j n}^{\prime}(n)^{2}$; summing both of them we get

\psi_{j n}(x)^{2}+\psi_{j n}^{\prime}(x)^{2} \geq \frac{2}{25}\left(\psi_{j n}(n)^{2}+\psi_{j n}^{\prime}(n)^{2}\right)
$$

If $\psi \in L^{2}(\Gamma)$, it belongs to $D\left(H_{\alpha}\right)$, so $\psi^{\prime} \in L^{2}(\Gamma)$ also holds. Let $\mathcal{L}_{j n}\left(\ell_{1}\right)$ be the link $\mathcal{L}_{j n}$ with the middle part $\left(\ell_{1}, \ell_{j n}-\ell_{1}\right)$ deleted; then

\|\psi\|_{L^{2}(\Gamma)}^{2}+\left\|\psi^{\prime}\right\|_{L^{2}(\Gamma)}^{2} & =\sum_{(j, n) \in I_{\mathcal{L}}} \int_{\mathcal{L}_{j n}}\left(\psi_{j n}(x)^{2}+\psi_{j n}^{\prime}(x)^{2}\right) d x \\
& \geq \sum_{(j, n) \in I_{\mathcal{L}}} \int_{\mathcal{L}_{j n}\left(\ell_{1}\right)}\left(\psi_{j n}(x)^{2}+\psi_{j n}^{\prime}(x)^{2}\right) d x \\
& \geq \frac{4 \ell_{1}}{25} \sum_{(j, n) \in I_{\mathcal{L}}}\left(\psi_{j n}(n)^{2}+\psi_{j n}^{\prime}(n)^{2}\right) \geq \frac{4 \ell_{1}}{25} \sum_{j \in I_{\mathcal{I}}} \psi_{j}^{2}
\end{aligned}
$$

which yields the result.
(d) First we need to show that $W_{j n}^{-1}$ has a uniform bound for $k \notin \overline{\mathcal{K}}_{\alpha}$ Without loss of generality we may suppose that $\inf \mathcal{K}_{\alpha}>0$; otherwise we shift all potentials by a constant. In view of the Sturm comparison theorem [31, Sec.V.6], see also [29, Secs.XIII.1,15], the zeros of $v_{j n}\left(\ell_{j n}, \cdot\right)$ and $v_{j n}^{\prime}\left(\ell_{j n}, \cdot\right)$ form a switching sequence; hence it is sufficient to prove that $\frac{d W_{j n}(k)}{d k}$ is bounded uniformly away from zero around each root $k_{0} \in \mathcal{K}_{\alpha}$ of $W_{j n}(k)=0$. Using the known identity [19, Sec.I.5], [29, Sec.XIII.3],

\frac{d v_{j n}(x, k)}{d k^{2}} v_{j n}^{\prime}(x, k)-\frac{d v_{j n}^{\prime}(x, k)}{d k^{2}} v_{j n}(x, k)=\int_{0}^{x} v_{j n}(x, k)^{2} d x,
$$

at $x=\ell_{n j}, k=k_{0}$, we find

\frac{d v_{j n}\left(\ell_{j n}, k_{0}\right)}{d k}=\frac{2 k_{0}}{v_{j n}^{\prime}\left(\ell_{j n}, k_{0}\right)} \int_{\mathcal{L}_{j n}} v_{j n}\left(x, k_{0}\right)^{2} d x
$$

We have supposed that $k_{0} \geq \inf \mathcal{K}_{\alpha}>0$; furthermore, by the argument of the preceding part we have $\int_{\mathcal{L}_{j n}} v_{j n}\left(x, k_{0}\right)^{2} d x \geq \frac{81}{200} \ell_{1}^{2}$. At the same time, using the representation (3.13) we find that $\left|v_{j n}^{\prime}\left(\ell_{j n}, k_{0}\right)\right| \leq C_{1}$ for a positive $C_{1}$ independent of $j, n$. Hence to a given $k \notin \overline{\mathcal{K}}_{\alpha}$ there is a $C_{2}>0$, again independent of $j, n$, such that $W_{j n} \geq C_{2}$. The representation (3.13) also yields another uniform bound,

C_{3}:=\sup \left\{\left\|u_{j n}\right\|_{L^{2}},\left\|v_{j n}\right\|_{L^{2}},:(j, n) \in I_{\mathcal{L}}\right\}<\infty
$$

The relations (3.8) and (3.9) together with (iv) now yield

\|\psi\|^{2}= & \sum_{(j, n) \in I_{\mathcal{L}}}\left\|\psi_{j n}\right\|^{2} \leq \sum_{j, n \in I_{\mathcal{I}}}\left|W_{j n}\right|^{-2}\left\{\left|\psi_{n}\right|^{2}\left\|u_{j n}\right\|^{2}+\left|\psi_{j}\right|^{2}\left\|v_{j n}\right\|^{2}\right\} \\
& +\sum_{n \in I_{\mathcal{B}}}\left|\psi_{j}\right|^{2} \frac{\left\|v_{j n}\right\|^{2}}{\left|W_{j n}\right|^{2}} \leq 2 N_{0}\left(\frac{C_{3}}{C_{2}}\right)^{2} \sum_{j \in I_{\mathcal{I}}}\left|\psi_{j}\right|^{2}
\end{aligned}
$$

so the result follows.
Remarks. 1. Since the operators $H_{\mathcal{C}}$ are below bounded, one can express for $k^{2} \in \rho\left(H_{\mathcal{C}}\right) \cap \rho\left(H_{0}\right)$ the resolvent difference $\left(H_{\mathcal{C}}-k^{2}\right)^{-1}-\left(H_{0}-k^{2}\right)^{-1}$, where $H_{0}=$ $H_{\alpha}^{D}, H_{\beta}^{N}$, by Krein's formula [32, 33, 34]; this expression becomes singular under the condition (3.7) or (3.10), respectively.
2. If two vertices are joined by more than a single link, the theorem can be applied if a vertex with the free $\delta$ coupling, $\alpha_{j}=0$, is added at each extra link. Vertices with just two neighbors are also useful, if we want to amend the potentials $V_{j n}$ with a family of point interactions - for an example see [35].
3. If (i)-(iv) are relaxed, the implications (b), (c) may still hold with $\ell^{2}\left(I_{\mathcal{I}}\right)$ replaced by a weighted $\ell^{2}$ space. If $\Gamma$ is equipped with a global metric, one can establish a relation between the exponential decay of $\psi$ and of the boundary-value sequences.

## IV Examples

Example IV. 1 (rectangular lattices): Let $\Gamma$ be a planar lattice graph whose basic cell is a rectangle of sides $\ell_{j}, j=1,2$, and suppose that apart of the junctions, the motion on $\Gamma$ is free, $V_{j n}=0$. By the proved theorem, the equation (2.6) leads in this case to

$$
\begin{array}{r}
\left(\phi_{n, m+1}+\phi_{n, m-1}\right) \sin k \ell_{1}+\left(\phi_{n+1, m}+\phi_{n-1, m}\right) \sin k \ell_{2} \\
+\left(V_{n m}^{\mathcal{C}}(k) \mp 2 \sin k\left(\ell_{1}+\ell_{2}\right)\right) \phi_{n m}=0 \tag{4.14}
\end{array}
$$

in the $\delta$ and $\delta_{s}^{\prime}$ case, respectively, where

$$
\begin{equation*}
V_{n m}^{\alpha}(k):=-\frac{\alpha_{n m}}{k} \sin k \ell_{1} \sin k \ell_{2}, \quad V_{n m}^{\beta}(k):=-\beta_{n m} k \sin k \ell_{1} \sin k \ell_{2}, \tag{4.15}
\end{equation*}
$$

and $\phi_{n m}=\psi_{n m}, \psi_{n m}^{\prime}$. In particular, for a square lattice we get

$$
\left(h_{0} \psi\right)_{n m}-\left(4 \cos k \ell+\frac{\alpha_{n m}}{k} \sin k \ell\right) \psi_{n m}=0
$$

and an analogous equation in the $\delta_{s}^{\prime}$ case, where $h_{0}$ is the conventional twodimensional Laplacian on $\ell^{2}\left(\mathbb{Z}^{2}\right)$. On the other hand, if $\ell_{1} \neq \ell_{2}$, the free operator has a periodically modulated "mass" which leads to nontrivial spectral properties even if the underlying graph Hamiltonian is periodic, i.e., $\alpha_{n m}=\alpha$ or $\beta_{n m}=\beta$, with a non-zero coupling parameter. A detailed discussion of this situation can be found in [10, 11, 12].

Example IV. 2 (magnetic field added): Suppose that $\Gamma$ is embedded into $\mathbb{R}^{\nu}$ in which there is a magnetic field described by a vector potential $A$. The boundary conditions (2.3) and (2.4) are modified replacing $\psi_{j n}^{\prime}(j)$ by $\psi_{j n}^{\prime}(j)+i A_{j n}(j)$, where $A_{j n}(j)$ is the tangent component of $A$ to $\mathcal{L}_{j n}$ at $\mathcal{X}_{j}$; we suppose conventionally that $e=-1$. For the $\delta$ coupling this is well known [2]; in the $\delta_{s}^{\prime}$ case one can check it easily.

There in no need to repeat the above argument, however, since the magnetic case can be handled with the help of the unitary operator $U: L^{2}(\Gamma) \rightarrow L^{2}(\Gamma)$ defined by

$$
(U \psi)_{j n}(x):=\exp \left(i \int_{x_{j n}}^{x} A_{j n}(y) d y\right) \psi_{j n}(x)
$$

where $A_{j n}$ is again the tangent component of the vector potential and $x_{j n}$ are fixed reference points. Then the functions $(U \psi)_{j n}$ satisfy (2.3) and (2.4), respectively, and the equations (3.7) and (3.10) are replaced by

$$
\begin{aligned}
\sum_{n \in \nu(j) \cap I_{\mathcal{I}}} \frac{e^{i A_{n}}}{W_{j n}^{\alpha}} \psi_{n}-\left(\sum_{n \in \nu(j)} \frac{\left(v_{j n}^{\alpha}\right)^{\prime}\left(\ell_{j n}\right)}{W_{j n}^{\alpha}}-\alpha_{j}\right) e^{i A_{j}} \psi_{j} & =0 \\
\sum_{n \in \nu(j) \cap I_{\mathcal{I}}} & \frac{e^{i A_{n}}}{W_{j n}^{\beta}} \psi_{n}^{\prime}+\left(\sum_{n \in \nu(j)} \frac{v_{j n}^{\beta}\left(\ell_{j n}\right)}{W_{j n}^{\beta}}+\beta_{j}\right) e^{i A_{j}} \psi_{j}^{\prime}
\end{aligned}=0,
$$

provided the magnetic phase factors $A_{j}$ obey the consistency conditions

$$
A_{j}-A_{n}=\int_{\mathcal{L}_{j n}} A_{j n}(y) d y
$$

following from the continuity requirement.
In particular, if $\Gamma$ is a rectangular lattice considered above, $A_{n m}:=\Phi(n-m) / 2$ corresponds to a homogeneous magnetic field in the circular gauge, with the flux $\Phi:=B \ell_{1} \ell_{2}$ through a cell, and no other potential is present, the equation (4.14) is replaced by

$$
\begin{gather*}
\left(e^{i \Phi m / 2} \phi_{n, m+1}+\right.  \tag{4.16}\\
\left.e^{-i \Phi m / 2} \phi_{n, m-1}\right) \sin k \ell_{1}+\left(e^{-i \Phi n / 2} \phi_{n+1, m}+e^{i \Phi n / 2} \phi_{n-1, m}\right) \sin k \ell_{2} \\
\\
+\left(V_{n m}^{\mathcal{C}}(k) \mp 2 \sin k\left(\ell_{1}+\ell_{2}\right)\right) \phi_{n m}=0
\end{gather*}
$$

where the discrete potential is again given by (4.15). If $\ell_{1}=\ell_{2}$ and the coupling constants vanish, $\alpha_{n m}=\beta_{n m}=0$, we obtain in this way the discrete magnetic Laplacian of [21] (or the Harper operator of [13, 19] for the Landau gauge), while for a general rectangle the parameter $\lambda$ representing the anisotropy in [21] is replaced again by the periodically modulated "mass".

Example IV. 3 (comb-shaped graphs): Let $\Gamma$ consist of a line to which at the points $\mathcal{X}_{j}:=j L$ line segments of lengths $\ell_{j}$ are joined; at their ends we impose the conditions (2.5). The equation (2.6) now yields

$$
\begin{equation*}
\left(h_{0} \phi\right)_{j}+\left(V_{j}^{\mathcal{C}}(k) \mp 2 \cos k L\right) \phi_{j}=0 \tag{4.17}
\end{equation*}
$$

in the $\delta$ and $\delta_{s}^{\prime}$ case, respectively, where $\phi_{j}=\psi_{j}, \psi_{j}^{\prime}$, and

$$
V_{j}^{\alpha}(k):=-\left(\frac{v_{j}^{\prime}\left(\ell_{j}\right)}{v_{j}\left(\ell_{j}\right)}+\alpha_{j}\right) \frac{\sin k L}{k}, \quad V_{j}^{\beta}(k):=-\left(\frac{v_{j}\left(\ell_{j}\right)}{v_{j}^{\prime}\left(\ell_{j}\right)}+\beta_{j}\right) k \sin k L .
$$

In particular, in the absence of an external potential on $\Gamma$ the last relations become

$$
V_{j}^{\alpha}(k)=-\left(\cot \left(k \ell_{j}+\eta_{j}\right)+\frac{\alpha_{j}}{k}\right) \sin k L, \quad V_{j}^{\beta}(k)=-\left(\tan \left(k \ell_{j}+\eta_{j}\right)+\beta_{j} k\right) \sin k L
$$

where $\eta_{j}:=\arctan \left(k \tan \omega_{j}\right)$. If the coupling is ideal, $\alpha_{j}=0$ or $\beta_{j}=0$, the loose ends correspond to the Dirichlet condition, $\omega_{j}=0$, and the "tooth" lengths are $\ell_{j}:=|j| \ell$, we get thus an equation reminiscent of the Maryland model [17, 36] with a fixed coupling strength and an additional periodic modulation of the potential.
