# The A sym ptotic B ehaviour of $T$ ilted B ianchitype V Io U niverses

#### Abstract

W e study the asym ptotic behaviour of the $B$ ianchi type $V I_{0}$ universes w ith a tilted -law perfect uid. The late-tim e attractors are found for the full 7-dim ensional state space and for several interesting invariant subspaces. In particular, it is found that for the particular value of the equation of state param eter, $=6=5$, there exists a bifurcation line which signals a transition of stability betw een a non-tilted equilibrium point to an extrem ely tilted equilibrium point. T he initial singular regim e is also discussed and we argue that the initial behaviour is chaotic for $<2$.


## 1 Introduction

In a recent paper we analysed how tilted uids a ect the general late-tim e behaviour ofcosm ologicalm odels ofB ianchitype [1]-1]. A s the asym ptotic behaviour of allB ianchim odels w ith a non-tilted -law perfect uid are determ ined [and [ill $]$, the sensitivity of the non-tilted equilibrium points was checked w ith regards to inclusion of tilted uids. In this paper, wew ill consider one of the m odels in full generality; nam ely the $B$ ianchitype $V I_{0} m$ odelcontaining a tilted -law perfect uid.

The last decades, there have been som e investigations of $B$ ianchim odels
 from these special B ianchi types, the general behaviour of tilted B ianchi universes seem s to be poorly understood. The work [1] [1] gave us som e hints where interesting behaviour $m$ ay occur, but a more elaborate analysis is needed in

[^0]order to understand the $m$ ore general behaviour of universes $w$ ith tilted $u$ ids. $M$ ore speci cally, in [in] it was show $n$ that for the $B$ ianchitype $V I_{0} m$ odel there are no stable non-tilted equilibrium points for equation of state param eter obeying $>6=5$. The value $=6=5$ signals the onset of an instability w ith respect to tilt im plying that at late tim es the peculiar velocities of the uid is a $m$ a jor contributor to the cosm ological shear. $T$ he $B$ ianchitype $V I_{0}$ is not the m ost general m odel but is su ciently general to account for $m$ any interesting phenom ena. Thus we will assum e that the universe contains a -law perfect
uid $(0<\quad \leq 2)$ which in general can be tilted. T he state space is thus 7dim ensional $\left.{ }^{[12}\right]$ (com pared to the 8 -dim ensional state space for the $m$ ost general m odels).

The dynam ical system $s$ approach \{ which is the m ethod adopted here \{ requires that we nd all equilibrium points for the system of equations. These equilibrium points play a special role in the evolution of the system. N ot only do they correspond to exact self-sim ilar solutions to E instein's equations, but som e of them $m$ ay even serve as attractors form ore general solutions. H ow ever, not $m$ any exact solutions with tilted uids are known for the $B$ ianchim odels. Som e type II solutions have been found [12], and R osquist and Jantzen found som e type $V I_{0}$ solutions [1]
< 3=2) found by Rosquist and Jantzen are attractors in a four-dim ensional invariant subspace of the fill state space. H ow ever, in the full state space, there alw ays exists an unstable $m$ ode. In the fill state space, the future attractor for $6=5<\quad$ is an extrem ely tilted m odel which is connected via a line bifurcation at $=6=5$ to a non-tilted equilibrium point. This $=6=5$ bifurcation, which correspond to a one-param eter fam ily of exact tilted solutions, seem $s$ to have been rst discussed in a recent paper by A postolopoulos [1] [1]. H ow ever, not much discussion is devoted to this solution as the solution itself is im plicitly given in term s of a cubic. H ere, we have introduced a di erent param eterisation which $m$ akes it possible to explicitly w rite down the solution in tem $s$ of the expansion-norm alised variables.
$W$ e also discuss the in itial singular regim $e$, which is a lot $m$ ore com plicated. In fact, there are indications that the in itial singular regim e possesses an oscillatory, very_likely even a chaotic behaviour sim ilar to that found in other B ianchi m odels [16 (2)

The paper is organised as follow s. N ext, in section we w rite down the equations of $m$ otion using the orthonorm al fram e form alism. In section we discuss the equilibrium points which are im portant for the late-tim e asym ptotic behaviour. Then, in section ' 4 , we discuss their stability and present som e general results regarding the asym ptotic behaviour of the tilted type $V I_{0} m$ odel. The in itial singular regim e is discussed in section '巨ָ'l before we nally sum $m$ arise our results in section 'G.

## 2 Equations of $m$ otion

The energy m om entum tensor for a tilted perfect uid is

The param eter $w$ illbe assum ed to be in the interval $2(0 ; 2)$.
$N$ ote that $R_{1}, w h i c h$ is the com ponent of the rotation tensor describing rotations $w$ ith respect to the axis $e_{1}$, is implicitly de ned via eq. ( $25_{1}^{1}$ ) . For
the type $V I_{0} \mathrm{~m}$ odel we will in practioe solve this equation by introducing the param eter instead of N , by $\mathrm{N}=\mathrm{N}$. For the type $\mathrm{V} \mathrm{I}_{0} \mathrm{~m}$ odel, this param eter is bounded by ${ }^{2} 1$.

### 2.1 T he state space

Thus if the initial data have $\mathrm{N}^{2}<\mathrm{N}^{2}$, then this w ill hold for all tim es. H ence, for type $\mathrm{VI}_{0}, \mathrm{~N}$ w ill be bounded as well. T he invariant subspaces $\mathrm{N} \quad \mathrm{N}=0$ correspond to B ianchi type II universes. N ote that, given the set ( ; 12; $13 ; 23 ; N ; N$ ) we can determ ine from eq. H ow ever, as can be show $n$, the last of these inequalities is redundant due to the fact that the rst tw o im ply the third (see A ppendix ${ }^{\text {A }}$ '). H ence, the state space can be considered a subspace of a com pact region in $\mathrm{R}^{7}$.

Hence, these discrete sym $m$ etries correspond to di erent perm utation and inversions of the axes. T hese sym $m$ etries are intrinsic to the type $V I_{0}$ geom etry.

### 2.2 Invariant subspaces

$T$ he invariant subspaces play an im portant role in the evolution of $B$ ianchitype $V I_{0}$ universes. They are im portant to study since they are invariant under the

evolution of the system ; i.e. if a point p lie in one invariant subspace, then also the $m$ axim al extended evolution of $p \mathrm{w}$ ill lie entirely inside it.

Som e of the physically interesting invariant subspaces are as follow s (we w ill also assum e that the boundaries are included):

## 3 Equilibrium points of im portance for the latetim e behaviour

The system of equations has num erous equilibrium points which correspond to xed points in the evolution of the system. That is, if the state variables are
written as a vector $X$, and we w rite the system of equations as

These equilibrium points usually play a particular role in the evolution of the system. N ot only are they exact solutions, but som e of these equilibrium points $m$ ay act as past or fiuture attractors for the set of solutions. H ence, for exam ple, at late tim es these equilibrium points $m$ ay be a good approxim ation of $m$ ore general solutions.

Som e of the physically interesting equilibrium points for the future evolution are given below. If som e equilibrium points are related via one of the discrete sym $m$ etries, perm utations, or other gauge sym $m$ etries, we only give one of them because the solutions they represent are equivalent. W e also indicate the sm allest invariant subspace $m$ entioned in section 2

## 4 The late-tim e asym ptotic behaviour

An im portant key to understanding the late-tim e behaviour of the dynam ical system is to consider the future stable equilibrium points. A ssum e that $X_{0}$ is an equilibrium point; i.e. $F\left(X_{0}\right)=0$. Then we can write the equations of $m$ otion as

The local stability of the equilibrium point, $\mathrm{X}_{0}$, depends on the eigenvalues of $A$; if all eigenvalues have negative real parts, then $X_{0}$ is a future attractor. Every eigenvalue w th a positive realpart signals an unstable mode.

The (local) future stable equilibrium points are for the di erent invariant subspaces given in $T$ able ${ }_{2}$ lustrated in $F$ ig '11. T he eigenvalues of the linearised system are discussed in A ppendix ${ }^{2}$

For the non-tilted subspaces $B$ (I), $B$ (II), and $B\left(V I_{0}\right)$, it is proven that generic solutions approach the respective local future attractors $\overline{\mathcal{Z}}]$. In the

tilted case we can only partially prove that the local attractors are also global attractors. The subspace T (II) was discussed in [8]-1]. W ew ill use these results in the follow ing way. If ！ 0 ，the non－tilted analysis can again be applied．The case $+=1$ is unstable in the future so this cannot happen for generalsolutions．If $N^{2} N^{2}$ ！ 0 ，the tilted analysis of type II can be applied．All the late－tim e asym ptotes of the type II case have an unstable direction into the interior of $\mathrm{T}_{1}\left(\mathrm{~V} \mathrm{I}_{0}\right)$（w hich exactly corresponds to $\mathrm{N}^{2} \mathrm{~N}^{2}$ ）．Unfortunately，for the tilted type II m odel the local attractors have not been rigorously proven to be globalattractors［8－1］

A part from these two theorem s we have not been able to show any global late tim e attractors for the various（sub）spaces．H ow ever，num erical analysis seem s to im ply that the local attractors also are global attractors．

## 5 The in itial singular regim e

Let us consider the initial singular regim e；i．e．where ！ 1 ．This case is a lot $m$ ore subtle than at late tim es due to the oscillatory behaviour of the system ofequations as one approach ！ 1 ．In fact，the tilted type II seem $s$ to have an in itial oscillatory regim e［q⿴囗⿰丨丨⿱一⿴⿻儿口一寸 ］，and hence，one would expect a sim ilar $\{$ if not $m$ ore com plex \｛ behaviour for the tilted type $V I_{0} m$ odel．

In the follow ing we should em phasise that we consider a non－sti uid．For a sti uid $(=2)$ it has been pointed out that the B ianchim odels allow for a stable past attractor which would rem ove this chaotic behaviour into the past $[2,2$ 2d］．

In the study of the initialsingular regim e it is usefulto introduce the variable ，instead of $N$ ，as

Each of them also have extrem ely tilted $K$ asner sets and corresponding bi－ furcations．These are discussed in detail in $\left[30_{1}^{\prime}\right]$ ．W e w ill not discuss these here

as they do not change our conclusion radically. H ow ever, bear in $m$ ind that these equilibrium points exist and that there are transitions betw een them .

The behaviour near the initial depends on three types of heteroclinic orbits. $T$ hese are

1. $\mathrm{T}_{\mathrm{R}_{\mathrm{i}}}$ : Fram e rotations.
2. $\mathrm{T}_{\mathrm{N}}:$ Taub type II vacuum orbits.
3. T : Fram e rotations betw een $K$ (II) and $K\left(V I_{0}\right)$.

Let us consider, for illustration, the $K$ asner circle $K^{+}$(II). $T$ he analysis for the $K$ asner circle $K$ (II) can be obtained from $K^{+}$(II) by using the $m a p \quad 2$ (or 3).

For the $K$ asner circle $K\left(V I_{0}\right)$ there are tw o fram e rotations of a sim ilar kind as for K (II); nam ely the ones given by $+\mathrm{P}_{\overline{3}}=\mathrm{C}$. These onbits also $m$ aps the $K$ asner circle onto itself: $K\left(N I_{0}\right) \geqslant K\left(V I_{0}\right)$.

A ow diagram for this system projected onto the (; 23)-plane is shown in F ig ${ }_{2}^{\prime 2}$. W e can see that there are hom oclin ic orbits betw een $K$ (II) and $K\left(N I_{0}\right)$. H ow ever, these only form a set of $m$ easure zero. M ost orbits connect $K$ (II). N onetheless, orbits can com e arbitrary close to $\mathrm{K}\left(\mathrm{V} \mathrm{I}_{0}\right)$ and hence, there m ight be fram e rotations $w$ ith in the $K$ asner circle $K\left(N I_{0}\right)$ before the orbit go back to K (II).

From this fairly sim ple, but far from com plete analysis, we believe that the initialbehaviour of the tilted type $V I_{0} \mathrm{~m}$ odels is fairly com plicated. There are in nite sequences of hom oclinic orbits which consists of fram e rotations and Taub vacuum orbits. These orbits are believed to be chaotic in general and thus we con jecture that the tilted type V Io has a chaotic behaviour to the past.

## 6 Sum m ary

Here, for the rst time, we have analysed the late-tim e behaviour of general tilted $B$ ianchitype $V I_{0}$ universes. O ur results are sum $m$ arised in $T a b l e \overline{1} \cdot \mathrm{~W}$ e perform ed a local analysis and found all the future stable equilibrium points for various subclasses of tilted type $V I_{0} \mathrm{~m}$ odels as well as for the general tilted type $V I_{0}$. In particular, we con m ed the observation in [1] $\left.\underline{11}_{1}^{1}\right]$ on the existence of new self-sim ilar solutions for $6=5$. These solutions also proved to be im portant for the late-tim e behaviour; the R osquist-Jantzen solutions are latetim e attractors for a certain class ofm odels $w$ th a tw o-com ponent tilted uid; and the line bifurcation at $=6=5$ is, in fact, the late-tim e attractor for general tilted type $V I_{0}$ solutions. For $>6=5$, the late-tim e attractor is an extrem ely tilted $m$ odel $l_{-1}^{\overline{1}_{1}^{\prime}}$

It is interesting to note that the general late-tim e attactors lie in the xed-point-set of 1 . This $m$ eans that in general the solutions are asym ptotically ${ }_{1}$-sym $m$ etric. $M$ ore speci cally, ${ }_{1}$-sym $m$ etric im plies $v_{1}=0$, and $v_{2}^{2}=v_{3}^{2}$.

At early tim es the analysis suggests chaotic behaviour as ! 1 . This behaviour seem $s$ to be a generic property of tilted B ianchim odels [ ${ }^{[3} \mathbf{N}_{1}^{\prime \prime}$. So this behaviour was not very surprising, in particular considering the fact that the tilted type II model \{ which is part of the boundary of type $V I_{0}\{$ was known

Let us nish 0 with some comments about fiuture research and how this work $m$ ay relate to other $B$ ianchi types. Firstly, the work $\left[\begin{array}{ll}{[1]} \\ ]\end{array}\right.$ indicates that there $m$ ay be som e sim ilarities betw een the $m$ ore general type $V I_{h} m$ odels and the type $V I_{0}$. H ence, som e of the features of the late-tim e behaviour found in this work $m$ ay also appear in the type $V I_{h} m$ odels. A s goes for the class $V I_{0}$ m odel, which is given by $\mathrm{N}^{2}>\mathrm{N}^{2}$, there is one obvious di erence. The general non-tilted $V I_{0} \mathrm{~m}$ odel is not asym ptotically self-sim ilar [ $\left.31,1,3 \frac{1}{2}\right]$. This happens because the type $V I_{0}$ state space is not com pact; there is no upper bound on N . In the term inology of $\left[\begin{array}{ll}{[3} \\ 3\end{array}\right]$, the type $\mathrm{V} \mathrm{II}_{0} \mathrm{~m}$ odel is extrem ely W eyldom inant while the type $V I_{0} m$ odel is $W$ eylR iocibalanced at late tim es. Hence, we w ould expect a fairly di erent behaviour for the tilted type $V I_{0} \mathrm{~m}$ odel at late tim es than that found here. M oreover, in this work the extrem ely tilted invariant sets have not been em phasised. For exam ple, a two- uid modelwhere one uid is extrem ely tilted is if particular interest. Further investigations in this case is required.
$N$ onetheless, there are quite a few unansw ered questions regarding B ianchi $m$ odels $w$ ith a perfect uid. This work has answered som e of them. H opefiully, fiuture work will answer m ore of them.
