The A sym ptotic B ehaviour of T ilted B ianchi type V I₀ U niverses

A bstract

We study the asymptotic behaviour of the B ianchi type V I₀ universes with a tilted -law perfect uid. The late-time attractors are found for the full 7-dimensional state space and for several interesting invariant subspaces. In particular, it is found that for the particular value of the equation of state parameter, = 6=5, there exists a bifurcation line which signals a transition of stability between a non-tilted equilibrium point to an extrem ely tilted equilibrium point. The initial singular regime is also discussed and we argue that the initial behaviour is chaotic for < 2.

1 Introduction

In a recent paper we analysed how tilted uids a ect the general late-time behaviour of $\cos m$ obgicalm odels of B ianchitype [1]. A sthe asymptotic behaviour of all B ianchim odels with a non-tilted -law perfect uid are determined [2{4], the sensitivity of the non-tilted equilibrium points was checked with regards to inclusion of tilted uids. In this paper, we will consider one of the m odels in full generality; namely the B ianchitype V I₀ m odel containing a tilted -law perfect uid.

The last decades, there have been some investigations of B ianchi m odels with a tilted uid $[5{7}]$; in particular, type II [8] and type V [9{11}]. Apart from these special B ianchi types, the general behaviour of tilted B ianchi universes seems to be poorly understood. The work [1] gave us some hints where interesting behaviour m ay occur, but a more elaborate analysis is needed in

order to understand the more general behaviour of universes with tilted uids. More speci cally, in [1] it was shown that for the Bianchi type VI₀ model there are no stable non-tilted equilibrium points for equation of state parameter obeying > 6=5. The value = 6=5 signals the onset of an instability with respect to tilt in plying that at late times the peculiar velocities of the uid is a major contributor to the cosm ological shear. The Bianchi type VI₀ is not the most general model but is su ciently general to account for many interesting phenomena. Thus we will assume that the universe contains a -law perfect uid (0 < < 2) which in general can be tilted. The state space is thus 7dimensional [2] (compared to the 8-dimensional state space for the most general models).

The dynamical systems approach { which is the method adopted here { requires that we nd all equilibrium points for the system of equations. These equilibrium points play a special role in the evolution of the system. Not only do they correspond to exact self-sim ilar solutions to E instein's equations, but some of them may even serve as attractors form ore general solutions. How ever, not many exact solutions with tilted uids are known for the B ianchim odels. Some type II solutions have been found [12], and R osquist and Jantzen found som e type V $\rm I_0$ solutions [13,14]. Here, we will show that the solutions (for 6=5 <

< 3=2) found by Rosquist and Jantzen are attractors in a four-dimensional invariant subspace of the full state space. However, in the full state space, there always exists an unstable mode. In the full state space, the future attractor for 6=5 < is an extrem ely tilted model which is connected via a line bifurcation at = 6=5 to a non-tilted equilibrium point. This = 6=5 bifurcation, which correspond to a one-parameter family of exact tilted solutions, seem s to have been rst discussed in a recent paper by Apostolopoulos [15]. However, not much discussion is devoted to this solution as the solution itself is implicitly given in term s of a cubic. Here, we have introduced a di erent parameterisation which makes it possible to explicitly write down the solution in term s of the expansion-norm alised variables.

W e also discuss the initial singular regim e, which is a lot m ore complicated. In fact, there are indications that the initial singular regim e possesses an oscillatory, very likely even a chaotic behaviour sim ilar to that found in other B ianchi m odels [16{24}].

The paper is organised as follows. Next, in section 2, we write down the equations of motion using the orthonormal frame form alism. In section 3 we discuss the equilibrium points which are in portant for the late-time asymptotic behaviour. Then, in section 4, we discuss their stability and present some general results regarding the asymptotic behaviour of the tilted type V I_0 model. The initial singular regime is discussed in section 5 before we nally summarise our results in section 6.

2 Equations of m otion

The energy-momentum tensor for a tilted perfect uid is

For the type V $I_0\,$ m odel, $a_c\,=\,0$ and n_{ab} has two non-zero eigenvalues with opposite sign. This implies that we can choose a frame such that the structure constants can be written

The parameter will be assumed to be in the interval 2(0;2).

Note that R_1 , which is the component of the rotation tensor describing rotations with respect to the axis e_1 , is implicitly de ned via eq.(25). For

the type V I_0 m odel we will in practice solve this equation by introducing the parameter instead of N, by N = N. For the type V I_0 m odel, this parameter is bounded by 2 1.

2.1 The state space

The constraint (21) in plies that ; $_{12}$; $_{13}$; $_{23}$; N and are all bounded. C om bining the equations for N and N we get the equations

Thus if the initial data have N² < N², then this will hold for all times. Hence, for type V I₀, N will be bounded as well. The invariant subspaces N N = 0 correspond to Bianchi type II universes. Note that, given the set ($; 1_2; 1_3; 2_3; N; N$) we can determ ine from eq. (21), and v¹, v² and v³ from eqs. (22), (23) and (24), respectively. We also require 0 V 1 for physical reasons (we are not allowing superlum inal velocities). This in plies the bounds

However, as can be shown, the last of these inequalities is redundant due to the fact that the rst two imply the third (see Appendix A). Hence, the state space can be considered a subspace of a compact region in \mathbb{R}^7 .

There are also some discrete symmetries under which this system is invariant. These are (of course, also compositions of these maps are symmetries)

To understand the physical importance of these maps we can apply them to the vector \boldsymbol{v}^a :

Hence, these discrete symmetries correspond to dimension permutation and inversions of the axes. These symmetries are intrinsic to the type V I_0 geometry.

2.2 Invariant subspaces

The invariant subspaces play an important role in the evolution of B ianchi type V I_0 universes. They are important to study since they are invariant under the

evolution of the system ; i.e. if a point p lie in one invariant subspace, then also the maxim alextended evolution of p will lie entirely inside it.

Some of the physically interesting invariant subspaces are as follows (we will also assume that the boundaries are included):

- 1. T (V I_0): The full state space of tilted type V I_0 .
- 2. F (V I₀): The set of xed points of the map $_1$. Given by = 0, $_{12} = _{13}$.
- 3. T_2 (V I_0): A Bianchi type V I_0 with a two-component tilted uid. It is the set of xed points of $_2$ (or $_3$). Given by $_{12} = _{23} = N = 0$ (or $_{13} = _{23} = N = 0$).
- 4. T_1 (V I_0): B ianchi type V I_0 with a one-component tilted uid. G iven by $_{12} = _{13} = 0$. This is the xed-point-set of $_2$ 3.
- 5. B (V I_0): N on-tilted B ianchi type V I_0 . G iven by = 12 = 13 = 13 = 13 = 0.
- 6. T (II): The tilted type II boundary. G iven by N = N. Note that these two subspaces can be mapped onto each other using 2 or 3. Because of this, we will in most cases not di erentiate between these two invariant subspaces.
- 7. B (II): Non-tilted type II. G iven by N² = N² and V = 0.
- 8. B (I): Bianchitype I universes. G iven by N = N = V = 0.
- 9. $\mathcal{O}_V B$ (I): The Bianchitype I vacuum boundary. G iven by N = N = V = = 0.

3 Equilibrium points of importance for the latetime behaviour

The system of equations has num erous equilibrium points which correspond to xed points in the evolution of the system. That is, if the state variables are

written as a vector X, and we write the system of equations as

These equilibrium points usually play a particular role in the evolution of the system . Not only are they exact solutions, but some of these equilibrium points m ay act as past or future attractors for the set of solutions. Hence, for exam ple, at late times these equilibrium points m ay be a good approximation of more general solutions.

Some of the physically interesting equilibrium points for the future evolution are given below. If some equilibrium points are related via one of the discrete symmetries, permutations, or other gauge symmetries, we only give one of them because the solutions they represent are equivalent. We also indicate the smallest invariant subspace mentioned in section 2.2 to which they belong.

4 The late-time asymptotic behaviour

An important key to understanding the late-time behaviour of the dynamical system is to consider the future stable equilibrium points. A ssume that X_0 is an equilibrium point; i.e. $F(X_0) = 0$. Then we can write the equations of motion as

The local stability of the equilibrium point, X_0 , depends on the eigenvalues of A; if all eigenvalues have negative real parts, then X_0 is a future attractor. Every eigenvalue with a positive real part signals an unstable mode.

The (local) future stable equilibrium points are for the di erent invariant subspaces given in Table 2 and the various connections between them are illustrated in Fig.1. The eigenvalues of the linearised system are discussed in Appendix B.

For the non-tilted subspaces B (I), B (II), and B (V I_0), it is proven that generic solutions approach the respective local future attractors [2]. In the

tilted case we can only partially prove that the local attractors are also global attractors. The subspace T (II) was discussed in [8]. We will use these results in the following way. So suppose the solution curves have the property $y \, ! \, 0$, then after su cently long time the function Z will be monotonic along the solution curves. The late time analysis can therefore to some extent be extracted from the monotonic functions in S.

In the following, ! (p) will mean the future asymptotic set; i.e. for a solution curve c() having c(0) = p, then ! (p) = $\lim_{t \to 1} c()$.

Proof. Part of the proof relies on the observation that the function $S = {}_{ab}c^ac^b$ obeys the bound 5j 2 (see Appendix A). From the equation for V we thus have

Hence, for < 4=3, V will be monotonically decreasing for > 1, and lim ! 1 V = 0. This means that the solutions will approach the non-tilted subspace B (V I₀) in the lim it ! 1. Thus after su ciently long time, the monotone functions in B (V I₀) (given in [2]) will also be monotone along orbits in T (V I₀). The point C is an isolated equilibrium point, thus we can use the monotone functions which im plies ! (p) = C.

There are strong reasons to believe that C is a global attractor in T_1 (V I_0) for all 0 < < 2. As evidence for this is the existence of a monotonic function in T_1 (V I_0). Dence = $^2 + ^2_{23}$, which in T_1 (V I_0) has the evolution equation

If ! 0, the non-tilted analysis can again be applied. The case $_{+} = 1$ is unstable in the future so this cannot happen for general solutions. If N² N² ! 0, the tilted analysis of type II can be applied. All the late-time asymptotes of the type II case have an unstable direction into the interior of T₁ (V I₀) (which exactly corresponds to N² N²). Unfortunately, for the tilted type II m odel the local attractors have not been rigorously proven to be global attractors [8].

Apart from these two theorems we have not been able to show any global late time attractors for the various (sub) spaces. However, numerical analysis seems to imply that the local attractors also are global attractors.

5 The initial singular regime

Let us consider the initial singular regime; i.e. where ! 1. This case is a lot more subtle than at late times due to the oscillatory behaviour of the system of equations as one approach ! 1. In fact, the tilted type II seems to have an initial oscillatory regime [8], and hence, one would expect a similar { if not more complex { behaviour for the tilted type V I₀ m odel.

In the following we should emphasise that we consider a non-sti uid. For a sti uid (= 2) it has been pointed out that the Bianchim odels allow for a stable past attractor which would remove this chaotic behaviour into the past [28,29].

In the study of the initial singular regime it is useful to introduce the variable , instead of N , as

In this case, the invariant subspaces = 1 correspond to T (II). In this case, there are two K asner circles, which di er by an orientation of fram e. They are as follow s.³

Each of them also have extremely tilted K as ner sets and corresponding bifurcations. These are discussed in detail in [30]. We will not discuss these here

as they do not change our conclusion radically. However, bear in m ind that these equilibrium points exist and that there are transitions between them .

The behaviour near the initial depends on three types of heteroclinic orbits. These are

1. T_{R_i} : Fram e rotations.

2. T_N : Taub type \amalg vacuum orbits.

3. T: Frame rotations between K (II) and K (V I_0).

Let us consider, for illustration, the K asner circle K $^+$ (II). The analysis for the K asner circle K $\,$ (II) can be obtained from K $^+$ (II) by using the m ap $_2\,$ (or $_3).$

K^+ (II)

Here, the frame rotations, and Taub type Π orbits are given by (when projected onto the ($_+$; $_{23}$)-plane):

1. Three fram e rotations:

All of these orbits m aps the K asner circle onto itself: K^+ (II) 7 K^+ (II). The fram e rotations are illustrated in Fig.2 and the Taub orbits are illustrated in Fig.3.

For the K asner circle K (V I_0) there are two frame rotations of a similar kind as for K (II); namely the ones given by $_+$ $\overline{3} = C$. These orbits also maps the K asner circle onto itself: K (V I_0) 7 K (V I_0).

In addition to these hom oclinic orbits there are hom oclinic orbits between the three types of K asner circles. They are given by the set of di erential equations

A ow diagram for this system projected onto the (; $_{23}$)-plane is shown in Fig.4. We can see that there are hom oclinic orbits between K (II) and K (V I₀). However, these only form a set of measure zero. Most orbits connect K (II). Nonetheless, orbits can come arbitrary close to K (V I₀) and hence, there m ight be fram e rotations within the K asner circle K (V I₀) before the orbit go back to K (II).

From this fairly simple, but far from complete analysis, we believe that the initial behaviour of the tilted type V I_0 models is fairly complicated. There are in nite sequences of hom oclinic orbits which consists of frame rotations and Taub vacuum orbits. These orbits are believed to be chaotic in general and thus we conjecture that the tilted type V I_0 has a chaotic behaviour to the past.

6 Summary

Here, for the st time, we have analysed the late-time behaviour of general tilted B ianchi type V I₀ universes. Our results are summarised in Table 2. We performed a local analysis and found all the future stable equilibrium points for various subclasses of tilted type V I₀ models as well as for the general tilted type V I₀. In particular, we can med the observation in [1] on the existence of new self-sim ilar solutions for 6=5. These solutions also proved to be important for the late-time behaviour; the Rosquist-Jantzen solutions are late-time attractors for a certain class of models with a two-component tilted uid; and the line bifurcation at = 6=5 is, in fact, the late-time attractor for general tilted type V I₀ solutions. For > 6=5, the late-time attractor is an extremely tilted model.⁴

It is interesting to note that the general late-time attactors lie in the xedpoint-set of 1. This means that in general the solutions are asymptotically 1-symmetric. More speci cally, 1-symmetric implies $v_1 = 0$, and $v_2^2 = v_3^2$.

At early times the analysis suggests chaotic behaviour as ! 1. This behaviour seems to be a generic property of tilted B ianchim odels [30]. So this behaviour was not very surprising, in particular considering the fact that the tilted type II m odel { which is part of the boundary of type V I₀ { was known

⁴ It should be noted that the = 6=5 line bifurcation looks remarkably similar to the W ainwright = 10=9 line bifurcation of the exceptional model [27]. This makes us wonder if there are unknown line bifurcations along the entire line given by = 2(3 + h) = (5 + 3 h) for the more general type V I_h models [1].

to be chaotic [8].

Let us nish o with some comments about future research and how this work m ay relate to other B ianchi types. Firstly, the work [1] indicates that there m ay be some e sim ilarities between the m ore general type V I_h m odels and the type V I₀. Hence, some of the features of the late-tim e behaviour found in this work m ay also appear in the type V I_h m odels. As goes for the class V II₀ m odel, which is given by N² > N², there is one obvious di erence. The general non-tilted V II₀ m odel is not asym ptotically self-sim ilar [31,32]. This happens because the type V II₀ m odel is weyl R include the type V II₀ m odel at late times. Hence, we would expect a fairly di erent behaviour for the tilted type V II₀ m odel at late times than that found here. M oreover, in this work the extrem ely tilted invariant sets have not been emphasised. For example, a two- uid m odel where one uid is required.

N onetheless, there are quite a few unanswered questions regarding B ianchi m odels with a perfect uid. This work has answered some of them . H opefully, future work will answer m ore of them .
