# W orld function and tim e transfer: general post-M inkow skian expansions

## A bstract.

In suitably chosen dom ains of space-tim e, the world function $m$ ay be a pow erfultool form odelling the de ection of light and the tim e/frequency transfer. In this paper we work out a recursive procedure for expanding the world function into a perturbative series of ascending powers of the N ew tonian gravitational constant G. W e show rigorously that each perturbation term is given by a line integraltaken along the unpertunbed geodesic betw een tw o points. O nce the w orld function is know $n$, it becom es possible to determ ine the tim e transfer functions giving the propagation tim e of a photon between its em ission and its reception. W e establish that the direction of a light ray as $m$ easured in the 3-space relative to an observer can be derived from these time transfer functions, even if the $m$ etric is not stationary. We show how to derive these functions up to any given order in $G$ from the perturbative expansion of the world function. To illustrate the $m$ ethod, we carry out the calculation of the world function and of the tim $e$ transfer function outside a static, spherically sym $m$ etric body up to the order $\mathrm{G}^{2}$, the $m$ etric containing three anbitrary param eters , , .

## 1. Introduction

W ith advances in technology, it will becom e indispensable to determ ine som e of the relativistic e ects in the propagation of light beyond the rst order in the $N$ ew tonian gravitational constant $G$, in particular in the area of space astrom etry. T he G lobal A strom etric Interferom eter for A strophysics (G A IA ) [1] and the Space Interferom etric $M$ ission (SIM ) [2] are already planned to $m$ easure the positions and/or the parallaxes of celestial ob jects w ith typical uncertainties in the range 1-10 arcsecond (as). The Laser A strom etric Test $O f$ Relativity (LATOR) mission is an even more ambitious program since its prim ary ob jective is to $m$ easure the bending of light near the Sun to an accuracy of 0.02 as [3]. W ith such requirem ents in experim entalprecision, it is clear that the e ects of the second order in $G$ m ust be taken into account in the near future since they result in several as de ection for a light ray grazing the Sun [4\{7].

In order to obtain a convenient $m$ odelling of the above-m entioned projects, it is necesssary to determ ine the de ection of light rays betw een two points $x_{A}$ and $x_{B}$ of space-tim e. In alm ost all of the theoretical studies devoted to this problem, the properties of light rays are determ ined by integrating the di erential equations of the null geodesics. This procedure is workable as long as one contents oneself $w$ ith analyzing the e ects of rst order in $G$, as it is proven by the generality of the results obtained in [8\{15]. U nfortunately, analytical solution of the geodesic equations requires cum bersom e calculations when term s of second order in $G$ are taken into account, even in the case of a static, spherically sym $m$ etric space-tim e [4\{6,16]. The goalof the present paper is to develop a procedure allow ing to determ ine the de ection of light and the traveltim e of photons w ithout integrating the geodesic equations.
$W$ e assum $e$ that space-tim $e$ is globally regular w th the topology $R \quad R^{3}$, i.e. w ithout event horizon. A ccording to these assum ptions, we adm it that the Lorentzian $m$ etric is represented at any point $x$ by a series in ascending pow ers of $G$

in any quasi C artesian coordinates. N eglecting all term $s$ involving $g^{(n+1)}, g^{(n+2)}, \ldots$ de nes the so-called nth post -M inkow skian approxim ation.

Essentially, our m ethod uses the notion of world function as developed by Ruse [17] and Synge $[18,19]$. The world function $\left(x_{A} ; x_{B}\right)$ is de ned as half the squared geodesic distance betw een tw o points $x_{A}$ and $x_{B}$. B efore entering into the presentation of the $m$ ethod, it $m$ ust be noted that this de nition raises a serious problem, since there could exist points $x_{A}$ and $x_{B}$ connected by several geodesics. $G$ iven a point $x_{A}$, it is usual to de ne the norm al convex neighbourhood of $\mathrm{x}_{\mathrm{A}}$, say $\mathrm{N}_{\mathrm{x}_{\mathrm{A}}}$, as the set of all points $x$ joined to $x_{A}$ by a unique geodesic path [20]. The world function ( $x_{A} ; x$ ) is then well de ned for $\mathrm{x} 2 \mathrm{~N}_{\mathrm{x}_{\mathrm{A}}}$. In agreem ent w th the assum ptions mentioned in the previous paragraph, we suppose that if $x_{B}$ is joined to $x_{A}$ by a null geodesic, then this geodesic is unique. Denoting the light cone at $x_{A}$ by $C_{x_{A}}$, this $m$ eans that $\mathrm{C}_{\mathrm{x}_{\mathrm{A}}} \quad \mathrm{N}_{\mathrm{x}_{\mathrm{A}}}$. Thuswe can use the w orld function to study the de ection of the light and the traveltim e of photons betw een $x_{A}$ and $x_{B}$. Let us point out that our assum ptions are com patible w ith the existence of m ultiple-im ages e ects involving di erent travel tim es for the photons (see, e.g., [21] and references therein).

W e shall see in section 2 that the invariant two-point function $\left(\mathrm{x}_{\mathrm{A}} ; \mathrm{x}_{\mathrm{B}}\right)$ has very interesting properties. $F$ irst of all, considering the geodesic path connecting $x_{A}$ and $x_{B}$, it $m$ ay be show $n$ that the tangent vectors at $x_{A}$ and $x_{B}$ are provided by the gradients of the world fiunction. Second, it is clear that $x_{A}$ and $x_{B}$ are joined by a null geodesic if and only if $\left(x_{A} ; x_{B}\right)=0$. A s a consequence, the de ection of a light ray em itted at a nite distance $m$ ay be easily determ ined when the world function of a given space-tim e is know $n$, just as the traveltim e ofa photon betw een tw o points. $T$ his $m$ eans that the w orld function allow s to calculate the tim e/frequency transfer functions and can be extrem ely usefulin situations involving a com parison betw een tw o distant clocks, as it has been show $n$ by tw o of us in a recent work [22] extending the results obtained in [23] and [24]. O ther possible applications deserve to be em phasized. For exam ple, the quantum phase accum ulated by a freely falling particle is proportional to the geodesic distance covered through space-tim e [25]. So, the world function can be relevant for $m$ odelling situations like neutrino oscillations [26].

Taking equation into account, it is possible to assume that $\left(x_{A} ; x_{B}\right)$ adm its an expansion as follow $S$

The prim ary ob jective of the paper is to yield a recursive procedure for determ in ing each term ${ }^{(n)}\left(X_{A} ; X_{B}\right)$ w thin the $n$th post $M$ inkow skian approxim ation w ithout calculating the geodesic joining $x_{A}$ and $x_{B}$.

O ur method is inspired by a procedure found by Buchdahl [27] for optaining the perturbative expansion of the characteristic function de ned as $V=\overline{2 j j}$. $H$ ow ever, the gradients ofV $\left(x_{A} ; x_{B}\right)$ are not de ned when $x_{A}$ and $x_{B}$ are linked by a nullgeodesic. So we prefer developing a new procedure involving itself. C onsidering that $x_{A}$ and $x_{B}$ are xed points, we use the $H$ am ilton-Jacobi equation satis ed by
( $\mathrm{x}_{\mathrm{A}} ; \mathrm{x}$ ) at point x . It is easily seen that this equation $m$ ay be replaced by an in nite set of ordinary di erential equations for the perturbation term $s{ }^{(n)}\left(x_{A} ; x\right)$ when $x$ is constrained to $m$ ove along the zeroth-order geodesic connecting $x_{A}$ and $x_{B}$. As a consequence, each term ${ }^{(n)}\left(x_{A} ; x_{B}\right)$ is obtained in the form of a line integral along a straight line in the background $M$ inkow skimetric. Thus, we obtain a recursive procedure which com pletely avoids the calculation of the perturbation of the geodesic joining the given end points.

W ithin the rst post -M inkow skian approxim ation, we recover a sim ple integral expression of (1) already given by Synge [28]. In contrast, the fact that one has to calculate line integrals with integrands containing products of the rst-order derivatives of term $s{ }^{(n)}, p=1, \ldots, n \quad 1$ proves to be aw kward in attem pts at getting explicit expressions of ${ }^{(n)}$ for $n$ 2. Fortunately, at least in the case where $\mathrm{n}=2$, we obtain a simpli ed formula for ${ }^{(2)}$ where the quadratic term $s$ in the rst derivatives of ${ }^{(1)}$ appear only as boundary term $s$. Then, we develop an iterative procedure allow ing to deduce the propagation time of a photon correct to within $(n+1)$ th-order term $s$ from the expressions of ${ }^{(n)},\left(\begin{array}{ll}(n) & 1) \\ (0)\end{array}\right.$.
$F$ inally, we derive the w orld function and the propagation tim e of light in a static, spherically sym $m$ etric space-tim ew ithin the second post $-M$ inkow skian approxim ation. In order to get expressions valid for a wide class of gravitational theories, we assum $e$ that the $m$ etric involves three anbitrary param eters: the usualpost -N ew tonian param eters and [29], and a supplem entary param eter, introduced to take into account the term of order $\mathrm{G}^{2}$ in spatial com ponents $g_{i j}$ (see, e.g., [30] and references
therein). C om plete results were obtained by John [31] involving quite cum bersome calculations. W thout any reference to this earlier paper, a com plicated integration of the geodesic equations was perform ed by $R$ ichter and $M$ atzner [16] in order to calculate the time delay for a special coordinate system adapted to the direction of the light ray at the em ission point. M ore recently, B rum berg [32] has used the Euler-Lagrange equations of null geodesics to nd the propagation tim e of light as a function of the boundary conditions in the second post -M inkow skian approxim ation of the Schw arzschild $m$ etric. For our part, we do not need determ ining the nullgeodesics to get the w orld function and the propagation tim e of light and we use only elem entary quadratures to perform the calculations.

The paper is organized as follow s . In section 2 the generalde nition of the w orld function and its fundam ental properties are recalled. In section 3 we introduce two distinct tim e transfer functions and we give their general relations w th the world function. W e establish that all the calculations relative to the direction of a light ray or to the frequency transfers can be perform ed when one of the two tim e transfer functions is explicitly known. In section 4 we set out the recursive $m$ ethod which allow s to determ ine the world function in the nth postM inkow skian approxim ation for any n 2. In section 5 we show how to deduce the tim e transfer functions from the world function at any post-M inkow skian order of approxim ation. In section 6 we determ ine explicitly the world function and the tim e transfer outside a static, spherically sym $m$ etric body $w$ ithin the second post -M inkow skian approxim ation. Som e concluding rem anks are given in section 7. In A ppendix A we give an altemative derivation of the integral expression for ${ }^{(2)}\left(x_{A} ; x_{B}\right)$, based on an integration of the Euler-Lagrange equations of geodesics.

In this paper c is the speed of light in a vacuum . T he Lorentzian $m$ etric of spacetim $e V_{4}$ is denoted by $g$. The signature adopted for $g$ is ( $+\quad$ ). We suppose that space-tim $e$ is covered by som e globalquasi-G alilean coordinate system $(x)=\left(x^{0} ; x\right)$, where $x^{0}=c t$, $t$ being a tim e coordinate, and $x=\left(x^{i}\right) . W$ e assum $e$ that the curves of equations $x^{i}=$ const are tim elike, which $m$ eans that $g_{00}>0$ anyw here. $W$ e em ploy the vector notation $a$ in order to denote $\left(a^{1} ; a^{2} ; a^{3}\right)=\left(a^{i}\right)$. C onsidering two such quantities $a$ and $b$ we use $a b$ to denote $b^{i} b^{i}$ (E instein convention on repeated indices is used). The quantity $\dot{\beta} j$ stands for the ordinary Euclidean norm of a. For any quantity $f(x), f$; denotes the partialderivative of $f w$ ith respect to $x$. The indices in parentheses characterize the order of perturbation. They are set up or down, depending on the convenience.

## 2. De nition and fundam ental properties of Synge's world function

Since Synge's world function is not widely em ployed, we brie y recall how its fundam entalproperties can be straightforw ardly derived from the variationalprinciple de ning the geodesic curves (for the characteristic function $V=\overline{2 j j}$ see e.g. Buchdahl [33\{35]). W e begin with recalling som e useful results conceming the general variation of a functionalde ned as an action in classicalm echanics.

Let $x_{A}$ and $x_{B}$ be two points of space-tim e connected by a di erentiable curve $C_{A B}$ de ned by the param etric equations $x=x(), w_{\text {ith }}^{A} \quad$ B. Given a Lagrangian function $L(x ; \underline{x})$ with $\underline{x}()=d x()=d$, one can de ne the functional

from which it is easily deduced that $H=L$ on any geodesic path. O w ing to the fact that $L$ does not contain as an explicit variable, this last equality im plies that the Lagrangian $L$ de ned by is a constant of the $m$ otion.
W e are only concemed here with a weak- eld metric represented by equation throughout space-tim e. So we henceforth restrict our attention to the dom ains $D=N_{x_{A}}, N_{x_{A}}$ being de ned in Introduction. Then whatever $x_{B} 2 N_{x_{A}}$, there exists a unique geodesic path $A B$ connecting $x_{A}$ and $x_{B}$. Let us denote by $b$ the chamcteristic function belonging to the Lagrangian adapted to $N_{x_{A}}$. A ccording we have

The relevance of the w orld fiunction in the problem s related to the light de ection, the time delay or the gravitational frequency shift is justi ed by the follow ing properties, which are easily deduced from the above-m entioned theory.

In the present paper, we alw ays consider $x_{A}$ as the point ofem ission of the photon and $x_{B}$ as the point of reception, and we focus our attention on the determ ination of $t_{B}^{+}$$t_{A}$ (clearly, the determ ination of $t_{B} \quad t_{A}$ com es within the sam e m ethodology). For the sake of brevily, we shall henceforth w rite $t_{B}$ instead of $t_{B}^{+}$.

## 7. C onclusion

The central result of this paper is given by Theorem 2. A ssum ing that $x_{B}$ is in the norm al convex neighbourhood of $x_{A}$, we have shown that ( $\mathrm{x}_{\mathrm{A}} ; \mathrm{x}_{\mathrm{B}}$ ) can be obtained in the nth post $M$ inkow skian approxim ation by a recursive procedure which spares the trouble of solving the geodesic equations. A ny nth-order perturbation
${ }^{(n)}\left(x_{A} ; x_{B}\right)$ is an integral taken along the zeroth-order straight line joining $x_{A}$ and $x_{B}$. M oreover, in $T$ heorem 3 we have found a rem arkable sim pli cation of the integral giving ${ }^{(2)}\left(x_{A} ; x_{B}\right)$. In $T$ heorem $s 4$ and 4 a we have outlined a recursive procedure enabling to obtain the perturbations of the tim e transfer fiunctionsw hen the perturbations of ( $x_{A} ; x_{B}$ ) are known, assum ing that the null cone at $x_{A}$ is included in the norm al convex neighbourhood of $x_{A}$. Since the time transfer functions are su cient to determ ine the direction of a light ray in the 3 -space relative to a given observer (see Theorem 1), the system atic $m$ ethods explored here seem very prom ising to tackle the relativistic problem s raised by highly accurate astrom etry in space.

U sing the sim pli cation found in the second post $M$ inkow skian approxim ation, we have shown that the calculation of ${ }^{(2)}\left(x_{A} ; x_{B}\right)$ and $T^{(2)}\left(x_{A} ; x_{B}\right)$ reduces to elem entary integrations in the case of a static, spherically sym $m$ etric space-tim e. The simpli cation within the second order works out so well that the question whether it works also for the higher-order term s naturally arises. $W$ e hope to retum to this problem later. For the tim e being, we are applying the results obtained in the static, spherically sym $m$ etric case to the description of the light de ection betw een tw o points located at a nite distance.
