## MultiShellM odel for Majum dar-Papapetrou Spacetim es

Exact solutions to static and non-static E instein-M axwell equations in the presence of extrem ely charged dust embedded on thin shells are constructed. Singularities of multi-black hole M a jum dar-P apapetrou and K astor-T raschen solutions are rem oved by placing the matter on thin shells. D ouble spherical thin shell solution is given as an illustration and the matter densities on the shells are derived.

## I. IN TRODUCTION

It was shown that the M a jum dar-Papapetrou (M P) solution [1]-[2] describes a spacetim e possessing N extrem ely charged black holes [3]. Later, extrem ely charged static dust sources for M P spacetim eswere considered [4]-[5] and it was shown that solutions to E instein-M axwell equations with extrem ely charged dust restricted to thin shells exist. M oreover, solutions for various geom etries including planar, spherical and cylindrical shells were obtained [5]. It was also shown that spherical shells can be used as sources for the Extrem e R eissner-N ordstrom (ERN) spacetim es [5]. The cosm ological black-hole solutions which are time dependent generalizations of the M P solution were also studied [6]-[7] and generalizations with discussions on non-radiative character of these spacetim es were discussed in [8].

In linear theories m ass density of point particle distribution can be expressed as  $(r) = {}_{i}m_{i}$   $(r a_{i})$  where m<sub>i</sub>'s are the masses of each particle, (r) is the D irac delta function and  $a_{i}$ 's are the locations of the point particles. This expression is in consistence with the Poisson's equation,

Such a point particle representation of the mass density is not valid in nonlinear theories. For instance, in a nonlinear theory pike  $r^2V + 4$   $V^3 = 0$ , there exists no solution V for  $= {}_im_i$  (r  $a_i$ ). We overcome the above problem by replacing massive particles by spherical thin shells with centers at  $r = a_i$  and radii  $r_i$ . Then the mass density can now be represented as  $(r) = {}_{i=1}^{N} {}_{0i}$  (F<sub>i</sub>) where  $F_i(r) = 0$  (i = 1; 2; ::; N) represents the positions of the shells and  ${}_{0i}$  are the mass density of each thin shell. The space is divided into N + 1 spaces. In our

proposed m ethod we shall solve such potential problem s where the solutions are continuous everywhere.

In this work, we will rst review the solutions to E instein-M axwell equations in the presence of extrem ely charged static dusts restricted to thin shells that are given in [5]. Then we will generalize the m ethods in [5] to nd solutions possessing extrem ely charged dusts restricted to multiple shells and obtain singularity free versions of M P-solutions given in [3]. We will also work out the double shell problem explicitly and show that the matter distributions on the shells are not uniform and that interior of the shells are not at unlike the single shells in [5]. Finally we will work on cosm ological M P solutions discussed in [6]-[7]-[8] and develop sim ilar multi shellm odels.

II. SHELL M ODELS FOR THE M AJUM DAR PAPAPETRAU SPACET IM ES

Let M be a four dimensional spacetime with the metric,

where  $h_{ij}$  is an Euclidean 3-m etric and is a function of spatial coordinates  $x^i$  only. W ith thism etric assumption, we consider a charged static dust source with the matter part of the energy-m om entum tensor given by,

where  $u = \frac{1}{2} \circ since$  the dust is static. The fourpotential due to the static charged dust is in the form  $A = A_0 (x^i)^0$ , so the current four-vector is given by,

where  $(x^i)$  is the charge density of the dust. Therefore the electrom agnetic and the M axwell energy-m om entum tensors are given by,

U sing the E instein tensor calculated from the metric (2) and the eld equations  $G = 8 (T^{M} + M)$  with (3)-(6) we get,

Then plugging the above equation back into the E instein equations give,

Therefore the Einstein-M axwell equations reduce to a nonlinear type of Poisson's equation. To nd the equation satisfies d by the charge density  $(x^i)$  we use the M axwell equations r F = 4 J with (4) and (5) to get,

C om paring (8) and (9) gives = which shows that the dust source is extremely charged.

O ne can solve the reduced E instein-M axwell equations (8)-(9) for the extrem ely charged dust restricted to a thin shell as given in [5]. Letting S be a regular surface in R<sup>3</sup> de ned by S =  $[(x;y;z) 2 R^3; F(x;y;z) = 0]$ , the m atter density can be written as,

where  $_0$  is the m atter distribution on the shell S.G eneralizing the m ethod given in [5] we can set,

where (F) is the Heaviside step function. The above choice can be made since the spacetim eM is now divided into two disjoint spacetim eSM<sup>+</sup> and M by S where the metric functions are  $_0$   $_1$  and  $_0$   $_2$  respectively. W e also require that the following equations are satis ed,

These follow from the fact that in M  $^+$  and M the Laplace's equation is satisfied as can be seen from (8) (Since = 0 in M  $^+$  and M ) and the metric must be continuous across the shell. Inserting (11) into (8) and using the conditions (12)-(13) we get,

Let S be the sphere F = r a = 0. One can choose  $_2 = 0$ ,  $_1 = _3$  (;)  $\frac{1}{a} = \frac{1}{r}$ ) which clearly satisfies (12)-(13). Using (14) gives,

At this point we would like to remark that the above equation (15) can also be obtained by using the Israel junction conditions [9]. However, when Israel junction conditions are used the surface energy-m om entum tensor has the components,

As can be seen from (17) in Israelm ethod we get  $\frac{2}{0}$  in the denom inator instead of  $\frac{3}{0}$  as in (15) which is due to a dimensional scaling. The total mass on the shell can be written as an integral of  $_0$  (F) over the 3 spatial dimensions which is equal to the integral of  $_{\rm I}$  over the 2 dimensional surface, that is,

So we get the same total mass on the shell in either method which means that there is no ambiguity.

W hen the interior of the sphere S is chosen as a at spacetime, we can set  $_0 = 1$  and  $_3 = m_0$  as constant which turns out to be the mass of the shell. So (15) becomes,

So the interior and exterior metric functions are given by,

where  $m_0$  is the mass of the shell as can clearly be seen from (19). This solution represents the ERN solution exterior to a spherical shell with at interior. Letting  $r = (R m_0) =$  where  $1 m_0 = a \text{ with } m_0 \notin a \text{ assumed}$ , the exterior metric can be written as,

which is the conventional form of ERN metric (after a scaling). As we noted earlier, we aim to remove the singularity of an ERN spacetime. Choosing  $m_0 < a$  we see from (20) that  $_{out} > 0$  is always satised. Comparing (22), the relation  $r = (R m_0) = and$  (20) one can realize that the singularity of ERN spacetime is at  $_{out} = 0$  (which corresponds to R = 0) and the horizon is at r = 0 (which corresponds to  $R = m_0$ ). This means that by restricting the matter on the shell with  $m_0 < a$ we remove the both the singularity and the horizon of the ERN spacetime. In the case  $m_0 > a$  (20),  $_{out} = 0$  is not excluded. The case m<sub>0</sub> = a represents the Levi-C ivita-Bertotti-R obinson (LCBR) spacetime outside the shell and at spacetime inside. By letting  $r = m_0^2 = R$  the exterior metric is obtained as,

as the usual conform ally at LCBR m etric. At this point we would like to note that in our analysis the lim iting case a! 0 does not exist since in that lim it the m atter density (10) would become  $(r) = _0(r)$  (r) and this choice is inconsistent with the E instein-M axwell equations (8)-(9). If we had the N ew tonian theory, such a lim it m athem atically would be consistent with the P oisson's equation. The non-existence of the a! 0 lim it is in agreem ent with the results of [10].

To remove the singularities of a MP spacetime possessing N ERN black holes discussed in [3], we place the matter source on thin shells. A MP spacetime possessing N ERN black holes has the metric function given by,

where  $a_i$  is the position of the i<sup>th</sup> ERN black hole. Such a spacetime contains N number of singularities. We can place the extremely charged dust on N spatially separated shells that do not intersect, instead of considering point sources. Generalizing the choice we made in (10) we can write the matter density of the spacetime as,

where  $_{0j}$  is the matter distribution on the j<sup>th</sup> shell dened by  $S_j$ :  $F_j(r) = 0$ . We can also generalize the choice for as,

where we again use the fact that the Laplace's equation is satis ed in source free regions and the metric across the shells must be continuous. U sing (26)-(29) and (30) we calculate r  $^2\,$  as,

Then inserting (31) and (32) into (8) we get,

As an illustration we consider the case of two spherical shells with radii  $r_1$  and  $r_2$  and the centers located at  $a_1$  and  $a_2$ . Our aim is to obtain the exterior MP solution with the metric function given in (24) so that the singularities can be removed. The equations de ning the spherical shells are given by  $F_1 = jr$   $a_1 j$   $r_1 = 0$  and  $F_2 = jr$   $a_2 j$   $r_2 = 0$ . Making analogy with (24) and the single shell solution (20) we choose,

Appropriate choices for  $_1$  and  $_2$  can be made by the following form s using (29) and (30),

The above choices describe an exterior M P spacetime and ERN spacetimes inside each shell. Let  $a_1 = ae_z$  and  $a_2 = ae_z$  so that the centers of the shells are on the z-axis with  $r_1 + r_2 < 2a$ . The surface matter distributions are obtained from (33) with N = 2 as,

where  $_1$  and  $_2$  are spherical coordinates on  $S_1$  and  $S_2$ with their centers are taken as if origin. It can clearly be seen from (40) and (41) that the existence of a second shell disturbs the uniform matter distribution on the other shell so that the system stays at equilibrium. The above equations can be obtained by Israelm ethod as we discussed before, where one obtains the second power of the term in the denominator instead of the third power as in (40) and (41) which is due to dimensional scaling. One can obtain (24) by letting  $1 \frac{m_1}{r_1} \frac{m_2}{r_2}$  in (37) so <sup>ext</sup> becomes,

where  $m_1 = m_1 = and m_2 = m_2 = .$  The MP spacetime possessing two ERN black holes has two horizons each described as a surface enclosing the points where the black holes are located [3]. These singularities are de ned by the vanishing of <sup>ext</sup>. So choosing the masses and the radii of the shells such that  $m_1 = r_1 + m_2 = r_2 < 1$ , we quarantee that ext > 0 from (37), which m eans that by this choice we rem ove the singularities. Note that  $\frac{in}{1}$ in (38) and  $\frac{in}{2}$  in (39) can never vanish in their dom ains of de nition. The case  $m_1=r_1 + m_2=r_2 > 1$  is irrelevant since we can not rem ove the singularities of the M P spacetime. The case  $m_1=r_1 + m_2=r_2 = 1$  should correspond to two mass generalization of the LCBR metric. Thus we obtained the double ERN black hole solutions with singularities removed. (Note that we obtained the solution with a re-scaling factor ). At this point we remark that MP-solutions with multiple spherical dust shells as sources, can not have at interiors as we showed in (38) and (39). M oreover, the shells disturb each other and cause angular dependence of matter density on the shells. One can see from (40) and (41) that the second shell(S2) has maximum matter density at its north pole and the rst shell(S1) has its maximum matter density at its south pole. Such a con guration puts the system in equilibrium. One can also calculate the masses of the shells by integrating (40) and (41) on  $S_1$  and  $S_2$  respectively as in (18) which gives the mass of the rst shell as m  $_1$  and the second shell as m  $_2$  w hich is expected. W e again note that the lim its  $r_1! 0$  and  $r_2! 0$  do not exist since the matter density (25) is not consistent with the E instein-M axwell equations (8)-(9). This means that we can not have a source density of the form ,

This is again in total agreem ent with [10].

O ne can also consider other solutions to the Laplace's equation for the metric function to obtain various spacetimes. It was shown that such spacetimes possess naked singularities [3]. O ne can remove these naked singularities by placing the extrem ely charged source on thin shells as we did in this work form ultiple ERN black hole solutions. The same procedure can also be applied to the stationary generalization of MP-spacetimes given by

Israel-W ilson [11] and Perjes [12] to remove the naked singularities of these spacetimes.

## III. SHELL MODELS FOR THE KASTOR-TRASCHEN SPACET IM ES

It was shown that time-dependent generalizations of M P spacetimes exist and solutions corresponding to N extremely charged co-moving black holes in a de-Sitter background were considered in [6]-[7]-[8]. The idea of removing the singularities of N co-moving black hole solutions by this shells were considered brie y in [7] for testing the cosm ic censorship conjecture. At this point we would like to extend the discussion given in [7] by the methods we discussed above.

The  $\cos m$  obgical M P solution which is a timedependent generalization of the M P solution with m etric (2) in  $\cos m$  obgical coordinates is given by,

where R (t) is the scale factor and  $h_{ij}$  is an Euclidean m etric. For a single extrem e Reissner-Nordstrom -de-Sitter (ERNdS) black hole with its charge equal to its mass (Q = M) the metric function  $\mathcal{T}$  in the metric (43) is given by,

We can obtain the ERN dS solution in static coordinates by following the transformation given in [6] G iven the metric (43) with U being arbitrary we consider a comoving charged dust as source. A sbefore, we assume the four-potential of the form  $A = A_0^{0}$  and  $u = \frac{1}{U}^{0}$  since the dust is co-moving (i.e. static in cosm ological coordinates). Then the E instein equations with positive cosm ological constant becom e,

where M is the Maxwell tensor given as in (6). The the Einstein equations (45) give,

where dot over R represents derivative with respect to t and (x) is independent of t. The above equations are obtained by separating the cosm obgical and electrom agnetic-m atter parts of the E instein equations. One can note that (46) is just the Friedm ann equation for a at cosm obgy. Solving (46) yields R (t) =  $e^{H t}$  where H = 3. A s discussed in [6]-[7]-[8] negative H corresponds to black hole spacetimes while positive H corresponds to white hole spacetimes. We consider negative H for the rest of the paper (H =  $\frac{1}{2}$ ). The M axwell equations r F = 4 J give,

with = 1 and being the charge density of the  $\infty$ m oving dust. C om paring (47) and (49) we get = as before, so we conclude that the dust is extremely charged. Letting d = R (t) dt we can write the metric (43) as,

O ne can see from the E instein equations (52) that the product  $U^3$  must be time independent. This is clear from the fact  $r^2U$  is time independent as can be seen from (51) and to have the equation (52) satisfied for all times we must have  $U^3$  to be time independent.

The above derivation of Einstein-Maxwell equations for a charged dust was given in [7]. Our treatment of the shellm odelw ill be parallel to which we considered in the previous part of this work, that is di erent from the shells considered in [7]. We start with a dust model and then take its lim it to thin shells with the use of D irac delta functions for the matter density. Since (47) and (49) are totally same with equations (8) and (9) we can consider sim ilar multi-shell models with the matter density given in (25) and the metric function U as in (26) (Clearly we just replace with U). One di erence is that the metric function U is time dependent via H However, as can be seen from (51) and (52) this time dependence does not a ect E instein-M axwell equations. In source free regions we again have the Laplace's equation satis ed. The equation of each surface de ning the shells are again given by  $F_{i}(r) = 0$ . Thus we follow the lines (25) to (33) to get the sam e dependence for the surface m atter density.

As an example, we again consider two spherical shells with radii  $r_1$ ,  $r_2$  and with centers located at  $a_1$ ,  $a_2$ . The equations describing the shells are given by,

Due to linearity of Laplace's equation, we extend the single ERNdS solution in cosm ological coordinates given in (50) to the double ERNdS case for the exterior metric function as,

where we have chosen  $U_0 = H$  in (28). Then (38) and (39) suggests,

for the metrics inside the rst and the second shells. Clearly the choices (54)-(55)-(56) satisfy the required conditions (29) and (30) for N = 2. We have mentioned above that U<sup>3</sup> must be time independent which is satisfied in our multi-shell model since this product is given with the use of (25), (26), (55) and (56) as,

Since  $F_{1;2}$  are time independent and  $_{01;2}U_{1;2}^{in}$  will be shown to be time independent below.

A gain choosing  $a_1 = ae_z$  and  $a_2 = ae_z$  such that  $r_1 + r_2 < 2a$  the surface m atter distributions are calculated from (33) as,

where the de nitions of  $_1$  and  $_2$  are given as before. As can be seen from above,  $_{01}$  and  $_{02}$  are time dependent but when they are integrated on the surface of each shell (the term  $_{01,2}U_{1,2}^{in}$  will appear in the integral which is time independent), they give constant masses for the shells as m  $_1$  and m  $_2$  which is in consistence with the result of B onnor [8]. If we had a single shell, the interior of the shell would be de-Sitter. But for the case of double shells (and for N > 2 also) as can be seen from (55) and (56) the interior of the shells are ERNdS.Unless this choice is made, the continuity condition of the metric across the shells will be violated. This fact was not realized in [7] where the interior of the shells were considered as de-Sitter.

To rem ove the singularities of the cosm ological multi black hole solutions we again restrict the matter on thin shells. For that purpose, we assume that the thin shells are form ed at = 0 with H < 0 so from 54) one can see that U<sup>ext</sup> never vanishes for later times 0. Thism eans that the exterior metric is singularity free for all times. M oreover the interior of the shells described by (55) and (56) can also never vanish for the choice we made. Thus the whole spacetime becomes regular. The spacetime distances jp Q jj, between two neighboring (space) points P and Q is given by jp Q jj = jJ jjp Q jjw here jp Q jj is the distance in  $\mathbb{R}^3$ , and U is given in (51). Hence in exterior and interior spacetimes the space distances increase with constant (Hubble) speed. For this reason the shells in ate without collision, because the distances among them also increase.

There is also another interesting possibility of constructing regular spacetimes by considering H > 0 for

0 and H < 0 for 0. W ith these choices one can see that  $U^{\text{ext}}$ ,  $U_1^{\text{in}}$  and  $U_2^{\text{in}}$  never vanishes and the spacetime m etric is continuous at = 0. In this m odel, the H ubble constant H changes sign in each universe separated by

= 0 which causes a delta-function type of singularity

at this hypersurface. Spacetimes (interior and exterior spacetime regions) are contracting for 0 and expanding for 0.

O urm ethod can be applied also to higher dimensional generalizations of the Majum dar-Papapetrau-Kastor-Traschen solutions [13] to study brane world creations and collisions [14].

## IV. CONCLUSION

We considered thin mass shell models for the Majum dar-Papapetrou and Kastor-Traschen spacetimes. In both cases we found exact solutions of the eld equations describing gravitational elds of the extremely charged N -number mass shells. Shell interiors are also curved spacetimes matching smoothly to the exteriors through (three dimensional) in nitely thin shells. We found the mass (also the charge) densities on each shell. The solutions obtained this way are free of singularities. For the case of K astor-T raschen spacetimes choosing the sign of the H ubble constant H properly we showed that shells are moving away from each other with constant velocity.

Shellm odels in higher dimensional theories seem to be also very interesting. In order that ourm ethod to be applicable to such theories one has to modify E instein eld equations with the inclusion of a dust matter as we did in this work where the mass is distributed on thin shells. In this case the shells are also higher dimensional. In the case of ve dimensions for instance the thin shells are four dimensional spacetimes. Our work on this matter will be communicated elsewhere.
