NONPERTURBATIVE AMPLIFICATION OF INHOMOGENEITIES IN A SELF-REPRODUCING UNIVERSE

ABSTRACT

We investigate the distribution of energy density in a stationary self-reproducing in ationary universe. We show that the main fraction of volume of the universe in a state with a given density at any given m om ent of proper tim e t is concentrated near the centers of deep exponentially wide spherically symmetric wells in the density distribution. Since this statem ent is very surprising and counterintuitive, we perform our investigation by three di erent analytical methods to verify our conclusions, and then con m our analytical results by computer simulations. If one assumes that we are typical observers living in the universe at a given m om ent of time, then our results m ay im ply that we should live near the center of a deep and exponentially large void, which we will call in oid. Validity of this particular interpretation of our results is not quite clear since it depends on the as-yet unsolved problem of measure in quantum cosmology. Therefore at the moment we would prefer to consider our results simply as a demonstration of nontrivial properties of the hypersurface of a given time in the fractal self-reproducing universe, without making any far-reaching conclusions concerning the structure of our own part of the universe. Still we believe that our results m ay be of som e in portance since they dem onstrate that nonperturbative effects in quantum cosm ology, at least in principle, may have signi cant observational consequences, including an apparent violation of the Copernican principle.

1 Introduction

A coording to the Copernican principle, the only special thing about the Earth is that we are living here. We are not at the center of the universe, as people thought before. This point of view is rejected also in the so-called cosm ological principle, which asserts that our place in the universe is by no means special and that the space around us has to be hom ogeneous and isotropic after sm oothing over sm all lum ps of m atter. This principle lies in the foundation of contemporary cosmology [1] since it has not only de nite philosophical appeal but also an apparent observational con mation by a host of data on large scale structure of the universe. However, theoretical interpretation of this principle is usually based on the big bang picture of the universe and its evolution, inherently related to simple geometry of Friedmann-Robertson-W alker type. The only theoretical justi cation of hom ogeneity and isotropy of the universe which is known to us at present is based on in ationary cosm ology. But this theory simultaneously with explaining why our universe locally looks so hom ogeneous predicts that on an extrem ely large scale the universe must be extrem ely inhom ogeneous [2]. Thus, after providing certain support to the cosm ological principle, in ationary theory eventually removes it as having only limited validity. But until very recently we did not suspect that in ation may invalidate the Copernican principle as well, since there is nothing about in ation which would require us to live in the center of the universe.

The situation became less obvious when we studied the global structure of in ationary universe in the chaotic in ation scenario, and found that according to a very wide class of in ationary theories, the main fraction of volume of the universe in a state with a given density — at any given moment of time t (during or after in ation) should be concentrated near the centers of deep exponentially wide spherically symmetric wells in the density distribution [3]. This result is based on investigation of nonperturbative e ects in the theory of a fractal self-reproducing universe in the chaotic in ation scenario [4].¹

O bærvational implications of this result depend on its interpretation. If we assume that we live in a part which is typical, and by \typical" we mean those parts of the universe which have the greatest volum e with other parameters (time and density) being equal, then our result implies that we should live near the center of one of the wells in the density distribution. There should be many such wells in the universe, but each of them should be exponentially wide. In what follows we will call these wells \in oids." An observer living near the center of an in oid will see him self \in the center of the world," which would obviously contradict the Copernican principle.

One should clearly distinguish between the validity of our result and the validity of its interpretation suggested above. Even though the e ect by itself is rather surprising we think that it is correct. We veried its validity by three independent analytical methods, as well as by computer simulations. Meanwhile the validity of its interpretation is much less clear. The main problem is related to the ambiguity in the choice of measure in quantum cosm ology [6]. There are in nitely

m any dom ains with similar properties in a self-reproducing in ationary universe. When we are trying to compare their volumes, we are comparing in nities. The results of this comparison depend on the choice of the regularization procedure. The prescription that we should compare volumes at a given time tin synchronous coordinates is intuitively appealing, but there exist other prescriptions which lead to dimense of the say for sure whether in ationary cosmology actually predicts that we should live in a center of a spherically symmetric well. Still this possibility is so interesting that it deserves a detailed investigation even at our present, admittedly rather incomplete level of understanding of quantum cosmology. This is the main purpose of our paper.

In Section 2 we will give a short review of the theory of self-reproducing universe in the chaotic in ation scenario and discuss which type of phenom ena should be called typical in such universe. Then we will describe two approaches to the problem of estimating the typical magnitude of the quantum uctuations under the volume weighted measure. The rst is based on counting the balance of probability factors. The second is based on the investigation of the probability distribution $P_{p}(;t)$. This distribution describes the portion of the physical volume of the universe which contains the eld at the time t. A coording to [6], this distribution rapidly approaches a stationary regime, where the portion of the physical volume of the universe containing the becomes independent on time. Investigation of this distribution in Section 3 will allow eld us to derive our result in a di erent way. In Section 5 we will develop a path integral approach to the investigation of P_{p} (;t). The new method provides another way to con m our results. However, this method is interesting by itself. It gives us a new powerful tool for investigation of the global structure of the self-reproducing universe, which may be useful independently of existence of the e ect discussed in this paper. In Section 6 we will describe computer simulations which we used to verify our analytical results. Only then, after we make sure that our rather counterintuitive results are actually correct, we will describe their possible interpretation and their observational consequences. In Section 7 we will describe the structure of in oids, their evolution after the end of in ation and their observational manifestations. In Section 8 we will discuss our results, am biguities of their interpretation, and form ulate our conclusions. In Appendix we present generalization of our results for di erent tim e param etrizations.

2 The Self-Reproducing Universe

Let us consider the simplest model of chaotic in ation based on the theory of a scalar eld m inim ally coupled to gravity, with the elective potential V (). If the classical eld (the in aton eld) is su ciently hom ogeneous in some dom ain of the Universe, then its behavior inside this dom ain is governed by the equations

Here $H = \underline{a}=a; a(t)$ is the scale factor of the Universe, k = +1; 1; or 0 for a closed, open or at Universe, respectively. M_p is the Planck mass, which we will put equal to one in the rest of the paper.

Investigation of these equations has shown that for m any potentials V () (e.g., in all powerlaw V () ⁿ and exponential V () e potentials) there exists an interm ediate asymptotic regime of slow rolling of the eld and quasi-exponential expansion (in ation) of the Universe [2]. At this stage, which is called in ation, one can neglect the term in (2), as well as the term s $\frac{k}{a^2}$ and $\frac{4}{3}$ $-\frac{2}{3}$ in (2). Therefore during in ation

In the theories V () is in ation ends at $= -e_{e}$, where $e_{e} = 10^{1}$ n.

In ation stretches all initial inhom ogeneities. Therefore, if the evolution of the Universe were governed solely by classical equations of motion, we would end up with an extrem ely smooth Universe with no primordial uctuations to initiate the growth of galaxies. Fortunately, new density perturbations are generated during in ation due to quantum elects. The wavelengths of all vacuum uctuations of the scalar eld grow exponentially in the expanding Universe. When the wavelength of any particular uctuation becomes greater than H⁻¹, this uctuation stops oscillating, and its amplitude freezes at some nonzero value (x) because of the large friction term 3H — in the equation of motion of the eld. The amplitude of this uctuation then remains alm ost unchanged for a very long time, whereas its wavelength grows exponentially. Therefore, the appearance of such a frozen uctuation is equivalent to the appearance of a classical eld (x) that does not vanish after averaging over macroscopic intervals of space and time.

Because the vacuum contains uctuations of all wavelengths, in ation leads to the creation of m ore and m ore perturbations of the classical eld with wavelengths greater than H¹. The average amplitude of such perturbations generated during a time interval H¹ (in which the Universe expands by a factor of e) is given by

The phases of each wave are random. It is important also that quantum uctuations occur independently in all domains of in ationary universe of a size greater than the radius of the event horizon H¹. Therefore, the sum of all waves at any given region of a size O (H¹) uctuates and experiences Brownian jumps in all directions in the space of elds. The standard way of description of the stochastic behavior of the in atom eld during the slow-rolling stage is to coarse-grain it over separate dom ains of radius H¹</sup> (we will call these dom ains h-regions" [9,10],

to indicate that each of them has the radius coinciding with the radius of the event horizon H $^{-1}$) and consider the electric equation of motion of the long-wavelength eld [11, 4]:

Here (t) is the e ective white noise generated by quantum uctuations.

Let us not the critical value such that for V () < V () the classical slow rolldom in test the evolution of the in aton, while for V () > V () the quantum uctuations are more in portant. Within the characteristic time interval $t = H^{-1}$ for values of in aton near the critical value the classical decrease = - t of the in aton, de ned through (3), is of the same magnitude as the typical quantum uctuation generated during the same period, given by (4). A fler some algebra we get from equations (3) and (4) the relation de ning implicitly:

Let us consider for de niteness the theory V () = ⁴=4. In this case equation (6) yields ¹⁼⁶. One can easily see that if < , then the decrease of the eld due to its classical motion = 1=2 is much greater than the average amplitude of the quantum uctuations = ⁻⁶ ² generated during the same characteristic time interval H⁻¹. But for > , (x) will exceed , i.e. the Brownian motion of the eld will become more rapid than its classical motion. Because the typical wavelength of the uctuations (x) generated during this time is H⁻¹, the whole Hubble dom ain after the time H⁻¹ becomes eld the ectively divided into e³ h-regions, each containing alm ost hom ogeneous (but di erent from each other) eld + .

In alm ost half of these dom ains (i.e. in $e^3=2$ 10 h-regions) the eld grow sby j (x) j j (x) j= H=2, rather than decreases. During the next time interval t = H⁻¹ the eld grow s again in the half of the new h-regions. Thus, the total number of h-regions containing growing eld becomes equal to $(e^3=2)^2 = e^{2(3 \ln 2)}$. This means that until the uctuations of eld grow su ciently large, the total physical volume occupied by permanently growing eld (i.e. the total number of h-regions containing the growing eld) increases with time like exp[(3 ln 2) H t]. This leads to the self-reproduction of in ationary domains with > in the chaotic in ation scenario [4].

Note, that the greater is the value of the elective potential, the greater is the rate of exponential expansion of the universe. As a result, the main growth of the total volume of the universe occurs due to exponential expansion of the domains with the greatest possible values of the Hubble constant $H = H_{max}$ [4, 6]. In some models there is no upper bound to the value of H [12, 13]. However, in the simplest versions of chaotic in ation based on the Einstein theory of gravity there are several reasons to expect that there exists an upper bound for the rate of in ation [6, 14, 15].

In what follows we will assume that there is an upper bound H_{max} on the value of the Hubble constant during in ation. For deniteness we will assume that $H_{max} = \frac{1}{8} = 3$, which corresponds to the P lanck boundary V ($_{p}$) = 1. This is a rather natural assumption for chaotic in ation. However, one should note that d_{qin} some m odels H_{max} may be much smaller. In particular, in the new in ation scenario $H_{max} = \frac{1}{8} V(0)=3$ is many orders of magnitude smaller than 1.

The independence of the subsequent evolution of the h-region on its previous history, the dom inance of the dom ains where the in aton eld energy grows rather than decreases in the volum eweighted measure and the upper bound for the energies at which the in ation can proceed are the three main features inherent to many models of in ation. When all these features are present the evolution of the in ationary universe as a whole approaches regime which we called global stationarity in [6]. This stage is characterized by the stability of the distribution of regions with various local values of energy density and other parameters, while the number of such regions grows exponentially with a constant coe cient, proportional to the maximal possible rate of in ation $_1 = d_{fr} H_{max}$. Here d_{fr} is a model dependent fractal dimension of the classical space [9, 6], which is very close to 3 for small coupling constants of the in atom eld.

The new picture of the universe is extremely unusual, and it may force us to reconsider our de nition of what is typical and what is not. In particular, the standard theory of the large scale structure of the universe is based on the assumption that a typical behavior of the scalar eld at the last stages of in ation is described by equations (3), (4). This is indeed the case if one studies a single branch of in ationary universe beginning at . However, if one investigates the global structure of the universes at all and tries to not the typical behavior of all in ationary dom ains with a volume weighted measure, the result may appear to be somewhat di erent.

3 Stationary In ation and Nonperturbative E ects

Suppose that we have one in ationary dom ain of initial size H¹, containing scalar eld > . Let us wait 15 billion years (in synchronous time t in each part of this dom ain) and see what are the typical properties of those parts of our original dom ain which at the present moment have some particular value of density, e.g. = 10^{29} g cm³. The answer to this question proves to be rather unexpected.

This dom ain exponentially expands, and becomes divided into many new domains of size H 1 , which evolve independently of each other. In many new domains the scalar eld decreases because of classical rolling and quantum uctuations. The rate of expansion of these domains rapidly decreases, and they give a relatively small contribution to the total volume of those parts of the universe which will have density 10 29 g cm³ 15 billion years later. Meanwhile those domains where quantum jumps occur in the direction of growth of the eld gradually push this eld towards the upper bound where in ation can possibly exist, which is presumably close to the P lanck boundary V ($_p$) 1. Such domains for a long time stay near the P lanck boundary,

and exponentially grow with the Planckian speed. Thus, the longer they stay near the Planck boundary, the greater contribution to the volum e of the universe they give.

However, the domains of interest for us eventually should roll down and evolve into the regions with density 10^{29} g $\,\mathrm{cm}^3$. Thus, these domains cannot stay near the P lanck boundary for inde nitely long time, producing new volume with the P lanckian speed. However, they will do their best if they stay there as long as it is possible, so that to roll down at the latest possible moment. In fact they will do even better if they stay near the P lanck boundary even longer, to save time for additional rapid in ation, and then rush down with the speed exceeding the speed of classical rolling. This may happen if quantum uctuations coherently add up to large quantum jumps towards small . This process is dual to the process of perpetual climbing up, which leads to the self-reproduction of in ationary universe.

O focurse, the probability of large quantum jumps down is exponentially suppressed. However, by staying longer near the P lanck boundary in ationary domains get an additional exponentially large contribution to their volume. These two exponential factors compete with each other to give us an optim altrajectory by which the scalar eld rushes down in those domains which eventually give the leading contribution to the volume of the universe. From what we are saying it should be clear that the quantum jumps of the scalar eld along such optim altrajectories should have a greater amplitude than their regular value $\frac{H}{2}$, and they should preferably occur downwards. As a result, the energy density along these optim al trajectories will be smaller than the energy density of their lazy neighbors which prefer to slide down without too much of jumping. This creates wells in the distribution of energy density, which we called in oids [3].

Suppose that the extra time interval spent at highest energies is \mathfrak{t} . Then we win the volume by factor of exp $d_{fr}H_{max}\mathfrak{t}$. However, to compensate for the lost time the in atom eld has to jump at least once (let us say, when it reaches the value) with the amplitude $\sim = n()H()=2$ such that it covers in one jump the distance which would otherwise require time \mathfrak{t} to slow ly roll down:

where we introduced the factor n () by which the jump is amplied, i.e. by which it is greater than the standard jump H ()=2. The probability of such jump is suppressed by the factor exp $\frac{1}{2}n^2$ (). The leading contribution to the volume of the universe occurs due to the jumps which maxim ize the volume weighted probability:

Maxim izing with respect to n () gives the amplication factor as a function of the location of the jump on the in atom trajectory:

In fact, we have found [3] that the typical trajectories which give the leading contribution to the volum e of the universe consist entirely of such subsequent jumps. In what follows we will give an alternative derivation of this result. Meanwhile, comparing with (6) one immediately sees that n() = 1 for <, since $d_{fr} = 3$ and $H_{max} = H()$ for such values of in atom eld in chaotic in ation. Therefore, our treatment of these quantum uctuations as large and rear quantum jumps is self-consistent.

To avoid m isunderstandings one should note that a more accurate de nition of am pli cation $\cos c$ cient would be n() + 1. Indeed, in the absence of nonperturbative e ects we would have n() = 0 since perturbative jumps occur in both directions with equal probability. The $\cos c$ cient n() relates an additional am plitude of jumps down to the regular perturbative am plitude of the jumps in both directions. This subtlety will not be important for us here since we are interested in the case n 1.

It is interesting that the coe cient of am pli cation n () can be directly related to the ratio of am plitudes of conventional scalar and tensor perturbations generated at the same scale at which the jump occurs. The am plitudes of these perturbations can be written as follow s:

Here c_s and c_r are some coecients of the order of unity. Using these expressions we can rewrite (9) for d_{fr} 3 in the form:

In the same way as the conventional amplitude of jumps H = 2 is related with the well known perturbations of the background energy density, the \nonperturbatively amplied" jumps which we have just described are related to the \nonperturbative" contribution to deviations of the background energy density from its average value. A possible interpretation of this result is that at the length scale associated with the value of the eld there is an additional nonperturbative contribution to the monopole amplitude:

W e will discuss the structure of in oids and their possible observational consequences in Section 7. Here we only note that eq. (11) gives a simple tool for understanding of the possible

signi cance of the e ect under consideration. Indeed, in the simplest chaotic in ation models, such as the theory $\frac{1}{n}$ ⁿ, one has H_{max} M_p and A_s^{pert} () A_T^{pert} (); thus one has n () 1. On the other hand, in the versions of chaotic in ation scenario where in ation occurs near a local maximum of the e ective potential (as in the new in ation models) H_{max} is many orders of magnitude smaller than M_p , and therefore the non-perturbative e ects discussed above are negligibly small. Thus, investigation of nonperturbative e ects can give us a rather unexpected possibility to distinguish between various classes of in ationary models. We will return to this issue in the end of the paper.

4 Nonperturbative e ects and branching di usion

One of the best ways to exam ine nonperturbative e ects is to investigate the probability distribution $P_p(;t)$ to nd a domain of a given physical volume in a state with a given eld at some moment of time t. The distribution $P_p(;t)$ obeys the following branching distribution equation [10, 16, 6]:

This equation is valid only during in ation, which typically occurs within some limited interval of values of the eld : $_{m in} < _{m ax}$. In the simplest versions of chaotic in ation model $_{m in}$ e 1, where e is the boundary at which in ation ends. Meanwhile, as we argued in the previous section, $_{m ax}$ is close to the P lanck boundary $_{p}$, where V ($_{p}$) = 1. To indisolutions of this equation one must specify boundary conditions. Behavior of solutions typically is not very sensitive to the boundary conditions at $_{e}$; it is su cient to assume that the di usion coe cient (and, correspondingly, the double derivative term in the r.h.s. of equation (13)) vanishes for $< _{e}$ [6]. The conditions near the P lanck boundary play a more important role. In this paper we will assume, that there can be no in ation at V () > 1, which corresponds to the boundary conditions of the paper we will discuss possible modi cations of our results if $_{max}$ di ers from $_{p}$.

One may try to obtain solutions of equation (13) in the form of the eigenfunction series:

where, in the lim it of large time t, only the term with the largest eigenvalue $_1$ survives. The function $_1$ () in the lim it t ! 1 has a meaning of a norm alized time-independent probability distribution (so called invariant probability density of the branching di usion) to nd a given eld in a unit physical volume, whereas the factor e^{1t} shows the overall grow the of the volume

of all parts of the universe, which does not depend on in the limit t! 1. This \ground state" eigenfunction satis as the following equation:

In the lim it when we can neglect the di usion (second derivative) term it is easy to solve this equation:

where we chose some starting point $_0$ and the corresponding normalization constant C ($_0$) which should match this approximate solution to the exact one at this point. As before, let us introduce the fractal dimension of classical space-time through $_1 = d_{\rm fr}H_{\rm max}$ (see [9, 6] for detailed discussion of the fractal structure of self-reproducing universe). Let us also introduce the critical value of in aton $_{\rm fr}$ at which the no-di usion approximation for (15) breaks. Then, since $H_{\rm max}$ H () for chaotic in ation, we can rewrite (16) as:

Substituting (17) into (15) we get the de ning relation for the value of in aton eld $_{\rm fr}$ at which the no-di usion approximation breaks:

We can rewrite (the square root of) this relation in a form which makes the comparison with the de nition of the other critical value more apparent:

C om paring (19) with (6), one nds that for all chaotic in ation models $_{\rm fr}$ < (one can assume self-consistently that H $_{\rm max}$ H ($_{\rm fr}$) in such models). The value of in (6) comes from comparing the slow roll rate in a given h-region with the typical amplitude of quantum uctuations while considering only the h-regions generated locally from the region which we picked. On

the other hand, the value fr com es from comparing the slow roll rate to the typical amplitude of uctuations considering all h-regions in the whole universe which happen to have the same value of in aton eld inside. The fact that the second constraint is more stringent is yet another indication of the considerably larger magnitude of the quantum uctuations when we take into account the whole stationary universe.

In the particular case of the simplest theory with V () = 4 =4, we have H = 2 =3 2 , fr ${}^{1=8}$, and the dependence of the solution (17) on is [6]:

This is an extrem ely strong dependence. For example, for the realistic value of the coupling constant 10^{13} chosen to t the observable large scale structure of the universe one has d_{fr} 3. One may assume for de niteness that $H_{max} = \frac{1}{8} = 3$, corresponding to in ation with V() = 1 (P lanck density). Then one has an extrem ely sharp dependence $1^{12 \ 10^6}$. All supprising results we are going to obtain are rooted in this e ect. One of the consequences is the distribution of energy density . For example, during in ation 4=4. Equation (20) in plies that the distribution of density is

Thus at each moment of time t the universe consists of inde nitely large number of dom ains containing matter with all possible values of density, the total volume of all dom ains with density 2 being approximately 10^{10^7} times greater than the total volume of all dom ains with density !

Let us consider now all in ationary domains which contain a given eld at a given moment of time t. One may ask the question, what was the value of this eld in those domains at the moment t H¹? In order to answer this question one should add to the value of its classical. drift $-H^{-1}$ and the amplitude of quantum jumps . The typical jump is given by = H=2. At the last stages of in ation this quantity is by many orders of magnitude smaller than -H 1 . But in which sense jumps H=2 are typical? If we consider any particular initial value of the eld , then the typical jump from this point is indeed given by H = 2 under the conventional com oving m easure. How ever, if we are considering all dom ains with a given and trying to nd all those domains from which the eld could originate back in time, the answermay be quite dierent. Indeed, the total volume of all dom ains with a given eld at any moment of time t depends on extrem ely strongly: the dependence is exponential in general case (17), or a power law with a huge power, like in the case of 4=4 theory (20). This means that the total volume of all domains which could jump towards the given eld from the value + will be enhanced by a large additional factor $P_p(+) = P_p() \cdot 0$ n the other hand, the probability of large jumps

is suppressed by the Gaussian factor exp $(2^2 ()^2 = H^2)$. Thus, under the established stationary probability distribution the probability of the in atom eld in a given dom ain to have experienced a quantum jump is given by:

5 Volum e W eighted Slow Rolling Approxim ation

We learned in the previous section that quantum uctuations in volum e weighted measure have pretty large expectation value, which makes the jumps to go preferentially downwards (unlike in com oving measure where there is no preferred direction of the uctuations and therefore they have zero expectation value). Indeed, such was the very meaning of our derivation of large jumps that they had to occur in the direction of usual slow roll in order to make up the extra time spent by in atom at higher energies. Therefore, we can conclude that the slow rolling speed itself gets a correction corresponding to the rate at which such large jumps occur and their size. Since each such jump of the size n() H()=2 occurs during time interval H¹ (), we can estimate the additional speed gained by the in atom as n() \dot{H} ()=2, thus bringing the overall slow roll speed to the volum e weighted value (we substituted (9) for the value of n(), the amplication factor):

Here the m inus sign in front of the correction term is due to the preferred direction of the jum ps, bringing the slow roll speed to higher absolute value.

The lim its of applicability of this expression are the same as for (23), i.e. below energy density corresponding to the critical value $_{\rm fr}$ of in atom eld, de ned by (18), (19). However, those lim its simply tell where the approximate expression (27) is valid, while the elect of speeding up the slow roll of the in atom is valid in a much wider range.

Let us derive a more general version of this result and, correspondingly, a more general expression for amplied quantum jumps (9), (23) which will be valid for almost whole range of variation of the in atom eld. The volume weighted probability distribution can be de ned as the path integral over all realizations of noise taken with gaussian weight modied by the volume factor [10, 6]:

The Jacobian J[z] of the transform ation from to and then to z is pre-exponential [17] and unimportant for our current investigation. We will neglect it in what follows.

Let us nd the trajectory z(t) [which we will translate later into trajectory (t)] which contributes most to the path integral (33). Such saddle point trajectory will correspond to the typical history of evolution of in aton under volum e weighted measure. The exponent in the path integral (33) looks like a Euclidean version of Lagrangian action, which corresponds to interpretation of di usion equation (13) as a Euclidean Schrodinger equation for a point particle. We can rewrite this action in Ham iltonian form using the conventional relation:

The reason why the conserved H am iltonian is equal to the highest eigenvalue is that at the end we should get the time dependence of a type exp ($_1$ t) as warranted by the stationary solution (14). Meanwhile, the $_{\rm P}^{\rm R}$ pdz term of the action should give us the correct (sem i-classical) eld dependence of the probability density $P_{\rm p}$ (z();t) (see below).

Solving the H am iltonian constraint (36) with respect to p (we have to choose the positive solution of the equation for rolling down), and using (35), we obtain the equation for the typical volume weighted trajectory:

For most of the in atom range of variation (except very close to P lanck boundary) we can ignore 3H term with respect to $d_{fr}H_{max}$ term. The relative importance of the two remaining terms under the square root is governed by the critical value f_{fr} | below this level the rst term is more important, while above it the second one dom inates. Not surprisingly, below f_{fr} this equation coincides with (27). However, its validity lim its are much wider, allowing us to use it beyond f_{fr} , to which the applicability of (27) was limited.

We can write down a good approximation for the eld dependent normalized probability density $_1$ (), om itting the less important pre-exponential term s:

Of course, below $f_{\rm fr}$ this expression also coincides with its counterpart (17) derived previously. This result has remarkable properties which will be studied further in [18].

U sing the volum e weighted slow roll equation (38) we can derive a general expression for the ampli ed quantum jump size. It is given by the change in within time interval H¹ calculated according to (38), less the regular expression for the change of eld due to the slow roll in com oving m easure:

This gives the following expression for the amplication factor (the ration of $_{np}$ and the conventional amplitude H =2):

The consistency conditions for our results (38) { (41) arise from several assumptions which we made in their derivation and whose validity should be maintained. The set one is that the

slow rolling approximation is valid, i.e. $3H() \rightarrow The second is that the amplication factor is greater than one. The third condition is that the saddle-point approximation used to derive these results is valid, which means that p 1. And the nal, fourth condition is the implicit assumption that large quantum jumps which occur in a single h-region do not make the gradient energy inside that region greater than the potential energy of the in atom eld (which, of course, would immediately invalidate the in ationary approximation). One can easily check that all four conditions lead to the same, very relaxed restrictions | the energy density of the in atom eld <math display="inline">V()$ must be lower than the P lanck density (or, more precisely, lower than the energy density corresponding to the maximal rate of expansion H_{max}). Thus, we can use the results obtained above in most of the variation range for the in atom eld in chaotic in ation.

One can easily check that for $< f_{\rm fr}$, H () H $_{\rm max}$ eq. (41) yields

6 Num erical Sim ulations

6.1 The basic idea of computer simulations

Even though we veried our results by several dierent methods, they are still very unusual and counterintuitive. Therefore we performed a computer simulation of stochastic processes in in ationary universe, which allows to obtain an additional veri cation of our results and to calculate the ampli cation factor n() numerically. We have used two dierent methods of computer simulations. The rst one is more direct and easy to understand. Its basic idea can be explained as follows.

We have studied a set of domains of initial size H¹ led with large hom ogeneous eld . We considered large initial values of , which leads to the self-reproduction of in ationary domains. From the point of view of stochastic processes which we study, each domain can be modelled by a single point with the eld in it. Our purpose was to study the typical amplitude of quantum jumps of the scalar eld in those domains which reached some value $_0 = 0$ (1) close to the end of in ation. Then we calculate the amplication factor n ($_0$) for various $_0$.




Figure 1: Probability distribution P () for $V = {}^{4}=4$, = 0:1. The dashed line is the num erical solution to a di erential equation describing P (). The solid curve is obtained using computer simulations described in this paper. A sm all deviation between the solid curve and the dashed line is due to the nite size of each step and the nite grid size.

Each step of our calculations corresponds to a time change $t = uH_0^{-1}$. Here $H_0 = H(_0)$, and u is some number, u < 1. The results do not depend on u if it is small enough. The evolution of the eld in each domain consists of several independent parts. First of all, the eld evolves according to classical equations of motion during in ation, which means that it decreases by $\frac{uV^0}{3H H_0}$ during each time interval uH₀⁻¹. Secondly, it makes quantum jumps by $=\frac{H}{2}^{q} \frac{\frac{dH}{H_{0}}}{r_{1}} r_{1}$. Here r_{1} is a set of norm alrandom numbers, which are dimensional for each in ationary domain. To account for the growth of physical volume of each domain we used the following procedure. We followed each domain until its radius grows two times, and after that we considered it as 8 independent domains. In accordance with our condition $P_{p}(;t)j_{>p}=0$, we removed all domains where the eld jumped to the super-Planckian densities V() > 1. Therefore our method removes the overall growth factore ^{1t} in the expression $P_{p} = e^{1t}$ () and directly gives the time-independent function $_{1}()$ which we are looking for. Indeed we have checked that after a su ciently large time t the distribution of domains followed by the computer with a good accuracy approached the stationary distribution $_{1}()$ which we have obtained in [6] by a completely diment method, see Fig. 1. We used it as a consistency check for our calculations. In what follows we will not distinguish between P_{p} and the time-independent factor $_{1}()$.

We kept in the computer memory information about all jumps of each domain during the last time interval H₀¹ before the eld inside this domain becomes smaller than ₀. This made it possible to evaluate an average sum of all jumps of those domains in which the scalar eld became smaller than ₀ within the last time interval H₀¹. Naively, one could expect this value to be smaller than $\frac{H_0}{2}$, since the average amplitude of the jumps is $\frac{H_0}{2}$, but they occur both in the positive and negative directions. However, our simulations con med our analytical result = $1 \frac{H_0}{2}$. In other words, we have found that most of the domains which reach the hypersurface = 0 within a time interval t = H₀¹ do it by rolling accompanied by persistent jumps down, which have a combined amplitude 1 0 times greater than $\frac{H_0}{2}$.

6.2 Details of the method

Even though this method of calculations may seem quite straightforward, (it is the so-called event-tracing M onte-C arlo method) in reality it must be somewhat modiled. The main problem is obvious if one recalls our expression for the probability distribution $P_p = e^{1t}_{1}$ () at small $P_p = e^{1t}_{1}$. A swe already mentioned, (om itting the time-dependent factor) this yields $P_p = 10^8$ for the realistic value 10^{13} . It is extremely discult to work with distributions which are so sharp.

Therefore in our computer simulations we have studied models with 0:1, which makes computations possible. On the other hand, when one increases the value of an additional problem arises. Our simple expression P_p ¹ has been obtained in the limit of very small , which is not perfectly accurate for 0:1. Therefore we will represent P_p in a more general form $P() = \frac{g()}{g}$, where g() approaches a constant value $\frac{G}{G}_{1}$ for ¹⁼⁸. One should also take into account that the classical decrease $c() = \frac{V^0()}{3H H_0}$ of the eld during the time H_0^1 and the standard deviation $s() = \frac{H}{2} \frac{G}{H_0}$ (the average am plitude of quantum uctuations during the time H_0^1) are not constant throughout the region where the e ect takes place. In

such a situation an expression for the ampli cation coe cient n() will be slightly di erent from our simple expression n = 1. Therefore we should rst derive here a more accurate expression for n(), and then compare it with the results of our simulations.

Consider a point for which $= _0$ at some time t, at which the stationary regime is already established. At the earlier time t H_0^{-1} this point was approximately at $= _0 + c(_0) + x$, where $x = _$ is the sum of all quantum jumps experienced by the eld at this point during the last time interval H_0^{-1} . Consider the probability P () that the eld jumped to $_0$ from the point $_0 + c(_0) + x$. This probability distribution is equal to the distribution $P_p()$ times the probability of undergoing a quantum uctuation of length .

To solve this equation for x we need to know $P_p()$. As earlier we assume $P_p() = g()$ where g() varies slow ly with . If $g^0 \ln \frac{1}{2} \ln g$ (which happens to be a good approximation for 1), eq. (44) can be easily solved, and the expression for $n(_0)$ looks as follow s:

O ne can obtain a slightly m ore accurate expression by taking into account dependence of g, c and s on . Note that in the situation which we are going to investigate $_0$ c($_0$) x s($_0$). In the limit when g, s, and c can be considered constant, and $_0$ s; c this equation leads to our earlier expression n($_0$) = $_1$ $_0$.

In order to use (45) we also need to know g() for our problem . We approximate g() by a second order polynomial in and substitute P () = $a_0 + a_1 + a_2^2$ into the dimensional equation for P (). Local analysis around = $_0$ shows P () $56\ 23\ 4\ ^2$. This approximation is accurate for 1.

6.3 Numerical Calculation of n()

Even for not very small the distribution P_p remains extremely sharp. We have made our simulations with = 0.1, in which case P_p ⁶⁰. This means that if we want to follow evolution of a single domain with = 0.5, then we should simultaneously keep track of 2⁶⁰ 10^8 domains with = 1. Therefore the simple event-tracing M onte-C arb approach which we described above can be quite adequate for the investigation of P_p near its maximum, but not for the study of P_p far away from the maximum of the distribution.

A more advanced approach is to represent the distribution by evenly spaced points with weight proportional to the distribution. In other words, we rewrite the probability distribution as a nite sum of nearly delta-functional distributions,

At each step of the simulation we investigate the evolution of the distributions p_i during the time t = uH $_0^{-1}$. The following equation takes into account classical decrease of the eld , quantum uctuations, and in ation.

We nd P_p (;t+ t) by computing the sum of p_i (;t+ t). Then we norm alize the distribution P_p (;t+ t) and again subdivide into a new set of p_i , in accordance with (46). We repeat this process until the resulting distribution P_p approaches a stationary regime.

The most tricky part of the algorithm is to nd the ampli cation factor n ($_0$). To do that, we associate another distribution x_i (;t) with each $_i$. Here x_i (;t) is the sum of quantum uctuations during the last time interval H 1 , along all trajectories which ended up in the interval $_i < _{i+1}$ at the time t. We combine all x_i (;t) into a single distribution X (;t), and evolve it in the same way as P_p (;t), dividing it into the nearly delta-functional distributions x_i (;t) at every iteration. This is possible because x_i (;t) is approximately gaussian and its standard deviation is small compared with its mean. When the P_p (;t) converges, x_0 ($_0$;t) approximates x, from which n ($_0$) can be calculated.

Decreasing step size u increases accuracy of P_p () until some point, after which the accuracy starts to decrease. This decrease is explained by the fact that evolved p_i 's are too sharp and therefore are represented inaccurately. To avoid this, having xed N, we must keep u high enough, so that the smallest quantum uctuation s is wider than the grid spacing. G rid spacing is proportional to 1=N and s is proportional to P_u , so the minimal P_u is proportional to 1=N. Execution time until convergence is proportional to N² = \overline{u} , or for them inim alu it is proportional to N³. In practice the largest N for which the algorithm converges in a reasonable amount of time is of the order of 10³.

6.4 Results of Numerical Calculations

The rst step is to verify the num erical algorithm by comparing the probability distribution P() it computes with a solution obtained by solving equation (15) obtained in [6]. Figure 1 shows

that P () is very close to the correct probability distribution. The deviation between the two decreases with step-size.




Figure 2: C on parison between the analytical expression for n() (dashed line) and the values for n() obtained by computer simulations. While the analytical expression is not absolutely precise due to various assumptions (such as constancy of g;c;s during the time H 1), it does give approximately correct values for n.

The second step is to verify out form ula for n. Figure 2 shows that num erically computed values of n for di erent $_0$ are close to the ones predicted by the analytical result. The deviation is explained by the approximations made in the analytical solution (constancy of g;c;s during time H 1). We have found also, that the typical deviation of the amplitude of jumps from their average value nH =2 is of the order of H =2, as suggested by eq. (22). This will be important for our subsequent considerations.

7 The Spatial Structure of In oids

As one can see from eq. (38), the value of the eld (t) corresponding to the typical volum e weighted trajectories moves down more rapidly that one would expect from the classical slow roll equation $-=\frac{V^{0}()}{3H()}$. This is exactly the reason why such nonperturbatively enhanced trajectories, being surrounded by usual classical neighbors, should correspond to the minim a

in the distribution of density. To analyse the spatial structure of the universe near the points corresponding to the optim alvolum e-weighted trajectory (38) one should remember that in terms of the ordinary comoving measure P_c the probability of large uctuations is suppressed by the factor exp (r^2 ()=2). It is well known that exponentially suppressed perturbations typically give rise to spherically symmetric bubbles [19]. Let us show rst of all that the main part of the volume of the universe in a state with a given (or with a given density) corresponds to the centers of these bubbles, which we called in oids.

Consider again the collection of all parts of the universe with a given (or a given density) at a given time t. We have found that most of the jumps producing this eld during the previous time interval H¹ occurred from domains containing the eld in a narrow interval of values near _=H + n() ${\rm H}$ =2 $% 10^{-1}$. The width of this interval was found to be of the order of H =2 $% 10^{-1}$, which is much smaller than the typical depth of our bubble n() H = 2 , since we have n() 1 for all chaotic in ation models. Now suppose that the domain containing the eld appears not at the center of the bubble, but at its wall. This would mean that the eld near the center of the bubble is even smaller than . Such a con quration could be created by a jump from -=H + n()H = 2 only if the amplitude of the jump is greater than n() H=2. However, we have found that the main contribution to the volume of domains with a given is produced by jumps of an amplitude (n() 1) H = 2, the greater deviation from the typical am plitude n () H = 2 being exponentially suppressed. This means that the scalar eld can

di er from its value at the center of the bubble by no more than the usual amplitude of scalar eld perturbations H = 2, which is smaller than the depth of the bubble by a factor n¹ (). Thus, the main fraction of the volume of the universe with a given (or with a given density of matter) can be only slightly outside the center. This may lead to a small contribution to anisotropy of the microw ave background radiation.

We should emphasize that allour results are based on the investigation of the global structure of the universe rather than of the structure of each particular bubble. This is why we assert that our elect is non-perturbative. If one neglects that the universe is a fractal and boks only at one particular bubble (i.e. at the one in which we live now), then one can not that inside each bubble there is a plenty of space far away from its center. Therefore one could conclude that there is nothing special about the centers of the bubbles. However, when determ ining the fraction of domains near the centers we were comparing the volum es of all regions of equal density at equal time. Meanwhile, the density wall of matter on the walls of a bubble is greater than the density center in its center. A swe have emphasized in the discussion after eq. (20), the total volum e of all domains of density wall is greater than the total volum e of space outside the center of the bubble is not smaller than the space near the center. However, going outside the center of the bubble is not smaller than the space near the center. Our results in ply that one can not much more space with $u_{uall} = u_{uall}$ not at the walls of our bubble, but near the centers of other bubbles.




Figure 3: A schematic illustration which shows the number of in oids with given density and distribution of matter near their centers.

This situation can be very schematically illustrated by Fig. 3. We do not make an attempt to show the spatial distribution of in oids. Rather we show the density distribution near the center of each of them . All these regions basically are very similar, but at any particular moment of time t there are much more regions with large density since they appeared from the regions which in a ted at the nearly Planckian density for a longer time. With time the whole set of curves should go lower, to smaller . However, at each moment of time there will be domains with all possible values of , so that the distribution of all curves does not change in time (stationarity). If one boks at the whole picture without discriminating between states with di erent values of density, it may seem that there is much more space outside of the centers of the bubbles. However, at any given moment of time t the main fraction of volume of the universe in a state with a given is concentrated near the centers of spherically symmetric bubbles. One may look, for densitv example, at the density corresponding to the centers of the third row of curves. At this density one may live either near the center of any of the eleven in oids, or at the walls of only three of them. The fraction of the volum e near the centers would be much greater if we try to show the ^{3 10'} of the number of domains with a given density in the theory realistic distribution $P_{p}()$ $^{4}=4$.

The nonperturbative jumps down should occur on all scales independently. One may visualize the whole process as follows. At each given moment most of the volume of the universe where the eld takes some particular value appear close to the centers of in oids created by the nonperturbative jumps by n () H = 2. The new jumps occur each time H^{-1} independently of the previous history of the regions with a given . Therefore the leading contribution to the volume with be given by those rare centers of in oids where the eld jumps down by n () H = 2 again

and again. That is why the typical volum e weighted trajectories perm anently go down with the speed exceeding the speed of classical rolling by n ()H $^2=2$, see eqs. (38), (41).

One may visualize the resulting distribution of the scalar eld in the following way. At some scale r the deviation of the eld from hom ogeneity can be approximately represented as a well of a radius r with the depth n () $\frac{H}{2}$. Near the bottom of this well there is another well of a smaller radius e¹ r and approximately of the same depth n () $\frac{H}{2}$. Near the center of this well there is another well of a radius e² r, etc. In particular, in the theory ⁴=4 the depth of each well will be $\frac{3H_{max}H}{2}$. O f course, this is just a discrete m odel. The shape of the sm ooth distribution of the scalar eld is determined by the equation

Note that (r) (0) for $r < H^{-1}$ (there are no perturbations of the classical eld on this scale).

This distribution is slightly altered by the usual small perturbations of the scalar edd. At a distance much greater than their wavelength from the center of the well these perturbations have the usual magnitude $\frac{H}{2}$. Thus, our results do not lead to considerable modi cations of the usual density perturbations which lead to galaxy form ation. However, the presence of the deep well (50) can signi cantly change the local geom etry of the universe.

In the in ationary scenario with V () = $\frac{4}{4}$ uctuations which presently have the scale comparable with the horizon radius r_h 10^{28} cm have been formed at 5 (in the units 5 (in the units $M_p = 1$). As we have mentioned already $3H_{max}$ $2^{\prime}\overline{6}$ 8:68 for our choice of boundary conditions [6], and the typical nonperturbative jump down on the scale of the present horizon 40 times greater than the standard jump, see eq. (26). In the theory $\frac{1}{4}$ should be $3H_{max}$ the standard jumps lead to density perturbations of the amplitude -5 10 (in the norm alization of [2]). Thus, according to our analysis, the nonperturbative decrease of density on each length scale di erent from the previous one by the factor e should be about $H_{max} \frac{6^{1}}{5} \frac{4}{5}$ 10. This allows one to evaluate the shape of the resulting well in the 2 density distribution as a function of the distance from its center. One can write the following equation for the scale dependence of density:

where r is the distance from the center of the well. Note that $=\frac{p^{1}}{r_{0}}\left(\ln\frac{r}{r_{0}}\right)^{\frac{1}{2}}$ in the theory $\frac{4}{4}$ [2]. Here r_{0} corresponds to the smallest scale at which in ationary perturbations have been produced. This scale is model-dependent, but typically at present it is about 1 cm. This yields

This gives the typical deviation of the density on the scale of the horizon (where $\ln \frac{r_h}{r_0}$ 60) from the density at the center: $-\frac{1}{r_0}$ 750 - 4 1²0.

It is very tempting to interpret this e ect in such a way that the universe around us becomes locally open, with 1 10^1 . Indeed, our e ect is very similar to the one discussed in [20, 21], where it was shown that the universe becomes open if it is contained in the interior of a bubble created by the O (4) symmetric tunneling. Our nonperturbative jumps look very similar to tunneling with the bubble formation. However, unlike in the case considered in [20, 21], our bubbles appear on all length scales.

The results discussed above refer to the density distribution at the moment when the corresponding wavelengths were entering horizon. At the later stages gravitational instability should lead to grow th of the corresponding density perturbations. Indeed, we know that density perturbations on the galaxy scale have grow n m ore than 10^4 times in the linear grow th regime until they reached the amplitude — 1, and then continued growing even further. The same can be expected in our case, but even in a more dramatic way since our \density perturbations" on all scales are much greater than the usual density perturbations which are responsible for galaxy formation. This would make the center of the well very deep; its density should be m any orders of m agnitude sm aller than the density of the universe on the scale of horizon. This is not what we see around.

This problem can be easily resolved. Indeed, our e ect (but not the am plitude of the usual density perturbations) is proportional to H_{max} , which is the maximal value of the Hubble constant compatible with in ation. If, for example, the maximal energy scale in quantum gravity or in string theory is given not by 10^{19} GeV, but by 10^{18} GeV, then the parameter H_{max} will decrease by a factor 10^{-2} . As we already mentioned, even smaller nonperturbative e ects are expected in new in ation where H_{max} is always many orders of magnitude smaller than 1. In ationary B rans-D icke cosm obgy in cases when the probability distribution P_p is stationary also leads to negligibly small nonperturbative e ects [13]. Thus it is easy to make our e ect very small without disturbing the standard predictions of in ationary cosm obgy. However, it is quite possible that we will not have any di culties even with very large n () if we interpret our results more carefully.

8 Interpretation and possible improvements of the probability measure

An implicit hypothesis behind our interpretation is that we are typical, and therefore we live and make observations in those parts of the universe where most other people do. One may argue that the total number of observers which can live in domains with given properties (e.g. in domains with a given density) should be proportional to the total volume of these domains at a given time. However, our existence is determined not only by the local density of the universe but by the possibility for life to evolve for about 5 billion years on a planet of our type in a vicinity of a star of the type of the Sun. If, for example, we have density 10²⁹ g cm³ in a small vicinity of the center of the in oid, and density 10²⁷ g cm³ on the horizon scale, then the age of our part of the universe (or, to be more accurate, the time after the end of in ation) will be determined not by the density near the center of the in oid, by the large-scale density 10²⁷ g cm³, and it will be only about one billion years.

M oreover, any structures such as galaxies or clusters cannot be form ed near the centers of the in oids since the density there is very small. Indeed, on each particular scale the jump down completely overwhelms the amplitude of usual density perturbations. The bubble cannot contain any galaxies at the distance from the center comparable with the galaxy scale, it cannot contain any clusters at the distance comparable with the size of a cluster, etc. In other words, the center would be devoid of any structures necessary for the existence of our life.

Thus, the naive idea that the number of observers is proportional to volum e does not work at the distances from the centers which are sm aller than the present size of the horizon. Even though at any given m om ent of time m ost of the volum e of the universe at the density 10^{29} g cm³ is concentrated near the centers of in oids, the corresponding parts of the universe are too young and do not have any structures necessary for our existence. Volum e alone does not m ean m uch. We live on the surface of the Earth even though the volum e of empty space around us is incom parably greater.

O nem ay argue, that the disparity between the age of the local part of the universe and its density appears only if one considers perturbations on a scale smaller than the horizon. Therefore it still may be true that we should live in the centers of huge bubbles, which have a shape (52) for $r > H_0^{-1}$, where H_0^{-1} is the size of the present horizon. If the cut-o occurs at $r = H_0^{-1}$, this may not lead to any observable consequences at all. However, if the cut-o occurs at $r = H_0^{-1}$, the resulting geometry may resemble an open universe with a scale-dependent elective parameter (r) [3].

In order to make any de nite conclusions about the preferable parts of the universe one should study probability distributions which include several other factors in addition to density. This should be a subject of a separate investigation. An additional ambiguity in interpretation of our results appears due to the dependence of the distribution P_p on the choice of time parametrization.

Indeed, there are many di erent ways to de ne \time" in general relativity. If, for example, one m easures time not by clock but by rulers and determ ines time by the degree of a local expansion of the universe, then in this \time" the rate of expansion of the universe does not depend on its density. As a result, our e ect is absent in this time parametrization [3]. The reason why the results depend on the time parametrization is deeply related to the properties of a selfreproducing universe. The total volum e of all parts of such a universe diverges in the large time lim it. Therefore when we are trying to nd which parts of the universe have greater volum e we are comparing in nities. There are some methods to requiarize these in nities in a way that would make the nal results only mildly dependent on the choice of time parametrization [7, 8]. However, there are many such methods, and the nal results are exponentially sensitive to the choice of the m ethod [8]. In this paper we used the standard time param etrization which is most closely related to our own nature (tim e measured by number of oscillations rather than by the distance to the nearby galaxies). But maybe we should use another time parametrization, see Appendix, or even integrate over all possible time parametrizations? Right now we still do not know what is the right way to go. We do not even know if it is right that we are typical and that we should live in domains of the greatest volume, see the discussion of this problem in [6, 8, 15].

Therefore at present we would prefer to consider our results simply as a demonstration of nontrivial properties of the hypersurface of a given time in the fractal self-reproducing universe, without making any far-reaching conclusions concerning the structure of our own part of the universe. However, we must admit that we are an azed by the fact that the main fraction of volume of in ationary universe in a state with a given density at any given moment of proper time t should be concentrated near the centers of deep spherically symmetric wells. We done meet this result by four diment methods, and we believe that it is correct. Until the interpretation problem is resolved, it will remain unclear whether our result is just a mathematical curiosity, or it can be considered as a real prediction of properties of our own part of the universe. At present we can neither prove nor disprove the last possibility that we live in a local \center of the world" de nitely contradicts basic principles of cosm ology. Now we can only say that it is an open question to be studied both theoretically and experimentally. If somebody asks whether we should live in the center of the world, we will be unable to give a de nite answer. But if observations show us that the answer is yes, we will know why.

Let us consider a di erent tim e param etrization, related to the proper tim e by local path dependent transform ation:

where T() is a positive function, and its argument in (53) is a solution of (5) with a particular realization of the white noise. The stochastic Langevin equation in this parametrization looks like follows:

The branching di usion equation in arbitrary time parametrization can be written as:

Its solution will generally be a stationary probability function with an overall constant expansion factor just like in (14). The value of the constant $_1$ will depend on the parametrization.

We can not the volume weighted slow rolltrajectory of the in atom eld in arbitrary parametrization very similarly to the approach used for proper time, but have to keep in m ind that it is no longer true that $_1 = d_{fr}H_{max}$. The result is:

Since the conventional (i.e. calculated under the com oving probability) am plitude of the quantum jumps generated during the typical time interval $T()H^{-1}()$ in the given time parametrization is still given by the usual quantity H = 2 (see the Langevin equation (54) above) then the denition for amplication factor becomes:

In the particular case of the time parametrization T = H, which corresponds to the scale factor a(t) playing the role of time , we get:

Since $_1 < 3$, in this time parametrization the volume weighted slow roll (58) is not faster but slightly slower than the conventional slow roll. As a result, most of the volume on the hypersurfaces of constant \time" will be concentrated near the spherically symmetric hills (rather than wells) in energy density. However, the amplication factor is always very small.

The change of time parametrization (53) corresponds to one of the possible ways to choose regularization procedure for evaluation of divergent probabilities in eternally expanding universe [8]. O ther types of regularization procedure were proposed in [7, 8]. In particular, the regularization scheme suggested in [7] is essentially equivalent to choosing the T = H parametrization which we discussed above [8]. O ne can easily verify that in the lim it fr our equations for the T = H parametrization (58), (59) yield the same results for the nonperturbative jumps as the ones obtained in [7]. As it is argued in [8], from the point of view of interpretation of our results it is not obvious that this regularization has any advantages as compared to a more intuitive and straightforward approach used in the main part of this paper. However, each regularization scheme e and each time parametrization gives an additional interesting information about the structure of in ationary universe. Therefore we presented in this Appendix an extension of our results for the more general class of time parametrizations (57).
