Exclusive Sem ileptonic b! u' Decays at CLEO

Updated CLEO results are presented for branching ratios and four-momentum transfer, q^2 , dependence of exclusive charm less sem ileptonic B decays, where the nalstate hadron is either a , , !, or ⁰. These results have comparable accuracies with those of other experiments. We address the issue of avor singlet couplings by limiting (B⁺! ⁰x⁺) = (B⁺! ^{v⁺}) > 2.5 at 90% CL. We also extract a value of $y_{ub} j = (43 \ 0.4 \ 0.2^{+0.6})_{0.4}^{0.6})$ 10 ³ in one particular unquenched lattice QCD m odel using ^{v⁺} data above q^2 of 16 G eV².

I. IN TRODUCTION

In this paper I present improved measurements of B^0 ! " and " branching ratios and fourmomentum transfer, q², dependencies. Also shown is evidence for $B(B^+$! ⁰ ") and an upper limit for B^+ ! " . These result use a \neutrino reconstruction" technique that is an extension of a previous CLEO analyses [1], based on CLEO II and ILV data. Here we include CLEO III data, representing an increase of 60% in the sample, for a total of 15.4 10⁶ BB events.

Sem ileptonic B decays proceed when the bquark transform s to a c or u quark em itting a virtual W that m anifests itself as a lepton-neutrino pair. For a B m eson decaying into a single hadron (h), the decay rate can be written exactly in term s of the four-m om entum transfer de ned as:

For decays to light pseudoscalar hadrons, via the b! u transition, and \virtually m assless" leptons, the decay width is given by:

where p_P is the three-momentum of P in the D rest frame, and f_+ (q²) is a \form -factor," whose normalization must be calculated theoretically, although its shape can be measured, in principle.

For B decays into a vector meson nal state we measure both q^2 and $\cos_{W \ L}$, where $_{W \ L}$ is the angle between the " direction in the W rest frame and the W direction in the B rest frame. The double di erential decay rate then is related to the helicity amplitudes, H $_{i}$

as

II. EXPERIMENTALMETHODS

We rst select events with either an e or with momenta greater than 1 GeV/c. Events with more than one such lepton are rejected, since multiple leptons are indicative of more than one sem ileptonic decay. We also require the events to be of spherical shape in momentum space, and to have a net observed charge of zero except in modes with a single pseudoscalar hadron where the requirement is loosened to 1.

The technique of neutrino reconstruction m akes use of the energy and m om entum deposited by all found (i. e. visible) charged tracks and photons in the event. Then the neutrino four-vector is form ed from the m issing energy and m om entum as:

The resolution in $p_{m iss}$ is 0.1 GeV/c, rm s. Since the missing-mass-squared

should peak at zero, we require M M $^2{=}2E_{\,m\,\,iss}<$ 0.5 GeV. This requirem ent takes into account the scaling of the M M 2 resolution proportional to $E_{\,m\,\,iss}$.

Then we look at signals in the $\mbox{ E-invariant }m$ as splane (M $_{\rm h}$ \cdot), where

here $E_{m iss}$ is replaced with $\dot{p}_{m iss}$ j because the latter has better resolution, and the parameter is adjusted for each hypothesis in order ensure that E is zero.

The '' data are analyzed in four separate bins of q^2 . For '', the models di er greatly on their $\cos_{W L}$ dependencies. Fig. 1 shows the ratio of the predicted form -factors for $\cos_{W L} < 0 = \cos_{W L} > 0$, as a function of q^2 . These di erences can lead to substantial system atic errors. We reduce these by analyzing the data in two separate $\cos_{W L}$ bins, one above and one below zero and four q^2 bins for a total of 8 intervals.

The $^{0+}$ data are split into two q² bins at 10 G eV², while the $^{+}$ sample is integrated over all q².

M onte Carlo simulation of signal sem ileptonic events and generic b ! c backgrounds in terms of the kinematic variables M $_{\rm h}$, and E is shown in Fig. 2. The backgrounds peak at low values of M $_{\rm h}$, and E, and are well separated from the signal which peaks at the B m ass and E of zero.

The data are t simultaneous for all modes in the separate bins of q² and cos $_{W \ L}$ discussed above. The projections of the ts for ", (+!)" and ⁽⁰⁾" are shown in Figs. 3, 4 and 5, respectively. For the ⁰ nal state only data for q² < 10 G eV² is used, while the other modes are shown sum med over all q².

The branching fractions, integrated over q^2 are given in Table I. The $0v^+$ is observed at the 3 level, while for

* we have a substantially sm aller upper lim it. Thus we can quote the ratio

$$R^{0} = \frac{(B^{+}!^{0^{+}})}{(B^{+}!^{-^{+}})} > 2:5 \text{ at } 90\% \text{ CL}; \quad (7)$$

A nom alously large inclusive production of 0 at high momentum has been observed in B decays [6]. Severalm odels have attempted to explain this phenom ena by an enhanced gluonic form -factor [7], or by avor singlet coupling [8]. M easurement of inclusive 0 production from the (1S) has ruled out the form -factor explanation [9]. O ur limit on R⁰ supports an enhanced avor singlet coupling.

The system atic errors in these measurements are dominated by the uncertainty on neutrino reconstruction, which is particular large in the and 0 modes due to shower resolution.

These branching fractions are of comparable precision to other results, some of which used much larger data samples. They have been tabulated by the Heavy F lavor A veraging G roup [12].

The results for the q^2 dependence of the branching ratios are shown in Fig. 6 and compared with two theoretical predictions.

We can translate these measurements into values of \dot{y}_{ub} jusing theoretical models. For example, using our B ! ^{v+} rate in the $q^2 > 16 \text{ GeV}^2$ range, and the HPQCD unquenched lattice QCD calculation [10], results in

approximately a factor of two less precise statistically than the current b-factory results [11].

III. CONCLUSIONS

We nd B (B⁰! $^{+}$) = (1:37 0:15 0:12 0:01) 10 ⁴ and B (B⁰! $^{+}$) = (2:93 0:37 0:39 0:04) 10 ⁴. The model dependent system atic errors have been greatly reduced by determ ining the partial branching ratios in bins of q² and cos _{WL}.

We extract a value of $y_{ub}j = 4.3 \quad 0.4 \quad 0.2^{+0.6}_{-0.4}$ 10⁻³ using the unquenched lattice QCD model of HPQCD with our ^{v+} data above q² of 16 GeV².

We also show that $^{0,+}$ is more than 2.5 times larger than $^{+}$ leading credence to an enhanced avor singlet coupling.
