THE ELECTROW EAK PHASE TRANSITION: A NON-PERTURBATIVE ANALYSIS

A bstract

We study on the lattice the 3d SU (2)+ Higgs model, which is an elective theory of a large class of 4d high temperature gauge theories. Using the exact constant physics curve, continuum (V! 1; a! 0) results for the properties of the phase transition (critical temperature, latent heat, interface tension) are given. The 3-loop correction to the elective potential of the scalar eld is determined. The masses of scalar and vector excitations are determined and found to be larger in the symmetric than in the broken phase. The vector mass is considerably larger than the scalar one, which suggests a further simplication to a scalar elective theory at large m $_{\rm H}$. The use of consistent 1-loop relations between 3d parameters and 4d physics permits one to convert the 3d simulation results to quantitatively accurate numbers for different physical theories, such as the Standard Model (excluding possible nonperturbative elects of the U(1) subgroup (for Higgs masses up to about 70 GeV. The applications of our results to cosmology are discussed.

1 Introduction

The 3d SU (2) U (1)+ H iggs m odel is a universal theory for the description of the electroweak phase transition in the standard electroweak theory and many extensions thereof, including the M SSM [1{5}] (for a motivation of the study of the electroweak phase transition, see [1{4}). In the present paper, we study with lattice simulations the dominant SU (2)+ H iggs part of the theory, de ned by the Lagrangian

The procedure of dimensional reduction [2], [6{13] allows one to compute perturbatively the relationship between the temperature T and the physical parameters of the underlying 4d electroweak theory or its extensions, and the parameters of the 3d theory. Concrete formulae for the SU (2)+ Higgs model and MSM can be found in [5] (see also below).

The aim of the present paper is to study the 3d SU (2)+ H iggs m odel, especially its phase diagram , on the lattice. We can neourselves to a small ratio $_3\!=\!g_3^2<1\!=\!8$, which in 4d terms corresponds to the case of small H iggs masses, m $_{\rm H}$
<m $_{\rm W}$
80 G eV . This case seems to be the most interesting one for cosmological applications, because the phase transition at least in this region is of rst order.

First M onte C arlo results on the electroweak phase transition using a 3d e ective theory have already been given in [1, 3], see also [14, 15]. In comparison with [1, 3] we considerably extend numerical calculations. This makes it possible to determine for the 1st time or more accurately than previously a number of nite T quantities such as latent heat, correlation lengths, interface tension, magnitude of the higher order perturbative terms, etc. An essential ingredient in the increased accuracy is that the continuum lattice mapping formulae, which are exact in 3d, are now known [4, 16]. Thus the continuum limit V! 1; a! 0 can be carried out under controlled conditions. P reliminary results of the simulations described here were published in [17].

Lattice M onte C arlo studies of the 4d SU (2) + H iggs m odel have been reported in [18 { 23]. W henever comparison can be made, the results are in agreement within errorbars. However, the 3d approach used in this paper gives much smaller errors than the 4d one. Monte C arlo simulations of the O (4) pure scalar theory in 3d with a non-analytic cubic term have been performed in [14]. The spectrum of excitations in this theory, however, is very dierent from that of the SU (2) model, so that comparison is not possible.

The paper is organized as follows. In Section 2 we present the basic relations for the 3d SU (2)+ Higgsmodel in continuum and on lattice. In Section 3 we describe the Monte Carlo update algorithm. In Section 4 we study the properties of the broken phase and the convergence of perturbation theory there. Section 5 is a lattice investigation of the phase transition for dierent values of the scalar self-coupling. In Section 6 we measure the dierent correlation lengths, and in Section 7 we study the metastability region and

the properties of the sym metric phase. Section 8 contains a short account of simulations with a larger Higgs mass, and in Section 9 we discuss the problem of studying large Higgs masses more generally. In Section 10 we sum marize the information acquired on lattice about the properties of the 3d SU (2) + Higgs theory, and compare to perturbation theory and to some non-perturbative approaches. In Section 11 we relate the 3d lattice results to 4d continuum physics. Section 12 is a discussion of some implications of our results to cosmology. The conclusions and proposals for future work are in Section 13.

Readers not interested in details of lattice simulations could check tables 5-7, and go directly to Section 10, which contains a sum mary of the non-perturbative results.

In this paper we use results from [2] and [4]. All references to specic form ulae from these papers are indicated by I and II followed by the number of the corresponding expression.

2 3d theory in continuum and on lattice

To make the paper self-contained, we sum marize here the essential properties of the 3d theory in continuum and on lattice. A more detailed discussion can be found in [4, 5, 16].

The two couplings g_3^2 and $_3$ of the theory in eq. (1.1) have the dimensionality of mass. They do not possess ultraviolet renormalization and, say, in the \overline{MS} scheme are scale () independent. The mass squared of the scalar eld has a linear and logarithmic divergence on the 1- and 2-loop levels, respectively. In the \overline{MS} scheme the relation between the scalar mass and the renormalization-group invariant parameter $_m$ is

Since all the three parameters of the 3d theory are dimensionful, the theory is uniquely xed by giving three parameters, the gauge coupling of dimension mass and two dimensionless ratios:

Renormalization introduces an intermediate mass scale on which the physics does not depend.

The 3d theory of eq. (1.1) is described on a lattice with the lattice constant a by the action

The three dimensionless parameters $_{G}$; $_{H}$; $_{R}$ of eq. (2.4) are in the continuum limit a! 0 related to the three dimensionless parameters $g_{3}^{2}a_{i}x_{i}y_{i}$ by the following equations:

Eq. (2.7) depends on several constants arising from lattice perturbation theory; = 3:17591, = 0:09 and the two numbers 5.0 and 5.2, speci c for SU (2)+ H iggs theory, and computed in [16]. This reference also gives the analogous numbers for some other relevant 3d theories. Note that the logarithm ic 2-loop term on the second line in eq. (2.7) is absolutely necessary with the accuracy which we have in our lattice simulations. For instance, changing the number 5.0 in the 2-loop part by 0.05 changes the critical temperature by an amount equal to the statistical uncertainty in one of our lattice simulations $(138.38 \quad 0.05 \, \text{GeV})$.

When the lattice constant a is varied, eqs. (2.5{2.7}) define for the fixed parameters g_3^2 , x, y of eq. (2.3) a curve, the constant physics curve (CPC), in the space of $_G$; $_H$; $_R$. All the curves end in the point (1;1=3;0) for a! 0.

The above discussion was entirely con ned to the 3d theory. As explained in [5], a single 3d theory is the electric theory of a large class of nite T eld theories and we shall later give several quantitative examples of this. For each 4d theory one separately has to establish the transformation from the physical parameters of the 4d theory to q_3^2 ; x; y. For the Standard M odel these are given in [5].

Since the use of the 3d param eters g_3^2 ; x; y is rather unillum inating, we shall in the presentation of lattice results replace them by a \H iggs m ass" m_H and \tem perature" T using the following equations:

from a form ula relating m $_3^2$ () to 4d quantities (I.66), and from a subsequent integration over the A $_0-$ eld [2]. Each quoted set of (m $_{\rm H}$;T) can with eqs. (2.8{2.10}) be converted to a set of ${\rm g}_3^2$;x;y, which for a given theory can, as discussed in Sec. 11, in turn be converted to a precise set of values for the zero-tem perature pole H iggs m ass and the physical tem perature. For the SU (2)+H iggs theory without ferm ions the di erence between the simplied parameters m $_{\rm H}$, T and the physical parameters is relatively sm all.

In studying the phase structure of the 3d theory we search for a critical curve in the (x;y)-plane. On the tree level this curve is the line y=0: for y>0 the theory is in a symmetric, for y<0 in a broken phase. In 1- or 2-loop perturbation theory the line splits in three: a critical curve $y=y_c(x)$ and upper and lower ends y=y (x) of metastability branches. On the critical curve the system can exist in two dierent phases with the same vacuum energy $_{vac}$ but dierent values of various gauge invariant condensates like y=y. The broken phase exists for y>y. One knows that perturbation theory can never conclusively determine the curve $y=y_c(x)$ or the jumps of various gauge invariant condensates like $y=y_c(x)$ or the jumps of various gauge invariant condensates like $y=y_c(x)$ or the jumps of various gauge invariant condensates like $y=y_c(x)$ continues to large $y=y_c(x)$ values of x or whether it term inates. Our present simulations do not provide an answer to the last question.

When performing simulations with the action (2.4), the procedure is somewhat different depending on whether one is performing simulations at some xed (x;y) or whether one is searching for the critical curve $y = y_c(x)$.

Assume rst that one is studying the system, e.g., determining correlation lengths or the value of h $^{\rm y}$ i, at some xed (x;y). The procedure then is as follows. Choose some $_{\rm G}$ which then gives the lattice constant a. The value of $_{\rm G}$ on an N $^{\rm 3}$ lattice should satisfy the constraints that the smallest correlation length is larger than a and

the largest correlation length is smaller than N a. The form errequirement gives a lower limit for $_{\rm G}$ and the latter a lower limit for N . Since (x;y) are xed, eq. (2.7) gives the value of $_{\rm H}$ and eq. (2.6) the value of $_{\rm R}$. Simulate the system with these values for larger and larger N and perform an extrapolation to N ! 1 . Choose then larger and larger values of $_{\rm G}$ (smaller and smaller a) doing always the same. The set of dierent extrapolations to N ! 1 can then be extrapolated to $_{\rm G}$! 1 (a! 0), which is the nal continuum limit.

3 The Monte Carlo update algorithm

The lattice spacing a and the linear lattice size N a are constrained by the length scales set by the W and H iggs masses: a $1=m_W$ (T) < $1=m_H$ (T) N a (assuming m_H (T) < m_W (T)). Even though this requirement is much milder than the 4d one (a 1=T) [4], in many cases it still mandates quite large lattice sizes (our largest volume is 50^2 200). Therefore, it is important that the update algorithm be as e cient as possible.

The gauge eld update is not qualitatively di erent from the standard SU (2) pure gauge update, in spite of the hopping term ${\rm Tr}^{-y}(x){\rm U}_i(x)$ (x + i) in the action. To update the gauge links we use the conventional re-ection overrelaxation and K ennedy-Pendleton heat bath [24] m ethods. All the gauge eld modes are much 'faster' than the Higgs modes, i.e., they have much shorter autocorrelation times.

Due to the atness of the Higgs potential, the 'slow' modes of the system are associated with the radial sector of the Higgs eld = RV, R 0, V 2 SU (2). In what follows we sum marize the more non-standard methods we use to increase the eciency of the update program.

G lobal radial update. First improvement comes from multiplying the radial part of the Higgs eld at all locations simultaneously by the same factor: R(x)! e R(x), where is randomly chosen from a constant distribution around zero: 2 [;]. Under this update, the action (2.4) changes as S() = $ae^2 + be^4$ a b, where a and b are the sums of the terms proportional to R^2 and R^4 in the action. A counting for the measure factors, the update is accepted with the Metropolis probability p() = m in (1; exp [4V S()]), where V is the volume of the system.

The multiplication factore has to be very close to unity in order for p() to be non-negligible. In practice, we choose from a window of width 0:05 { 0.001 around zero, depending on the volume. The width of the window is chosen so that the acceptance is approximately 60 {70%.

In g.1 we show the autocorrelation functions for an m $_{\rm H}=60$, $_{\rm G}=8$ system on a 14^3 lattice with both (a) localM etropolis and (b) local+ global update. Even though the change in R (x) in each global multiplication is very small, the gain over only local M etropolis/heat bath is about a factor of 5. The additional cost of the global update in terms of cpu time is negligible, since it involves only one accept/reject step for the whole volume.

H iggs eld overrelaxation. Let us param etrize the H iggs eld as = , = 0:::3, 2 R, where $_i$ are Pauli m atrices and $_0$ is the 2 2 unit m atrix. From eq. (2.4) we see that the local potential of the H iggs eld at location x is

This form seems to suggest separate update steps for the radial and SU (2)-components of the Higgs eld. However, this is not the optimal method: even though the overrelaxation for the SU (2) direction can be readily performed, updating the radial component becomes quite complicated. In this case the overrelaxation step R! R^0 would require nding R^0 so that

rem ains invariant (here we use a notation where the x-dependence of the variables is suppressed). This can be approximated by anding a solution R 0 to the equation G (R 0) = G (R), and performing a M etropolis accept/reject step using the probability weight [dG (R)=dR]=[dG (R 0)=dR 0]. This update has been used in 4d H iggs model simulations [25, 21]. However, the acceptance rate is only 80%, and the algorithm behaves dynamically rather like a heat bath or M etropolis update.

A more e cient method is to update the Higgs variables in the plane de ned by 4-dimensional vectors and F , using the Cartesian components of parallel and perpendicular to F:

Now we can update the X and Y components of separately: overrelaxation in Y is $\sin p \ln p$ the re-ection Y ! Y 0 = Y, or 0 = + 2X f (this is exactly equivalent to the conventional SU (2) re-ection overrelaxation procedure). In order to perform an exact overrelaxation to the X-component, we need to $\ln X$ so that

To solve this equation we would have to resort to iterative numerical methods, which can be costly in terms of cpu-time. Instead, we used the following approximation to the overrelaxation (3.6): we not the solution to equation $V(X^0) = V(X)$ and accept X^0 with the probability

Since V (X) is a fourth order polynom ial, solving the equation V (X 0) = V (X) boils down to nding zeros to a third order polynom ial (we already know one zero X 0 = X , which can be factored out). In all realistic cases the parameters of V (X) are such that there always is only one other real root, and it is straightforward to write a closed expression for X 0 . This update is an almost perfect overrelaxation: in our simulations the acceptance rate varies between 99.7% { 99.98% , depending on the $_{\rm G}$ used. The acceptance is high enough so that the \di usive" update dynam ics inherent in the M etropolis acceptance step does not play any role, and the evolution of the eld con gurations is almost determ inistic. A di erent but related overrelaxation schem a to the one described here has also been used in 4d simulations [22].

W avefront update. Let us next consider the order in which the lattice variables are traversed. In the conventional even-odd update, the lattice is decomposed into even and odd sectors $\{$ in our 3d case, to two sets with x + y + z even and odd. The variables are rst updated on all the even points before updating the odd points. U sing this schema it takes L=2 whole lattice updates before any kind of signal from a given location on the lattice can propagate through the whole volume.

In the wavefront traversal we pick an arbitrary 2-dim ensional plane from the system, de ned by one of the conditions x y z = const. (modulo periodic boundary conditions). We select one of the directions perpendicular to the plane to be the positive direction. The update proceeds in two stages: rst, we update the Higgs variables on this plane, and second, the gauge matrices U on the links emanating from this plane to the positive direction. Both updates are performed with the overrelaxation algorithms. A fler the gauge eld update we move up to the next plane to the positive direction, and start the updates again. With this method, a planar wave of overrelaxation updates propagates through the volume in a single update sweep. In our implementation we keep the same orientation of the plane until the volume has been swept through 4{9} times.




Figure 1: The autocorrelation function of the observable $L = V^{\gamma}(x)U_{i}(x)V(x+i)$ calculated from an $m_{H} = 60\,\text{GeV}$, $V = 14^3$ lattice. (a) Heat bath/M etropolis, (b) Heat bath/M etropolis with global R-update, (c) 4 (overrelaxation with even-odd traversal) + 1 (heat bath + global update), and (d) 4 (wavefront overrelaxation) + 1 (heat bath + global update). In all the cases, one update means going once through all the lattice points.

The particular diagonal orientation of the plane is chosen in order to simplify the update: the spins and gauge links on the plane can be updated independently of each other, and all the gauge links have an equal footing with respect to the plane | there are no link variables within the plane, as would be the case if the plane was oriented along the principal axes.

In g.1 we compare the autocorrelation functions of the standard even-odd overrelaxation (c) and the wavefront overrelaxation (d). In both cases we perform four overrelaxation sweeps through the volume, followed by one heat bath/Metropolis update and one global radial update. For both cases the individual Higgs variable overrelaxation step is the XY overrelaxation described in paragraph II above. The overrelaxation methods perform much better than the pure heat bath algorithms (a and b). The wavefront overrelaxation has much better initial decorrelation, as seen from the very rapid decrease in the autocorrelation function, even though it seems to have roughly the same exponential autocorrelation time as the conventional even-odd method. However, this rapid initial decrease means that the integrated autocorrelation time into small, giving correspondingly small statistical errors for the observables. In our tests the wavefront overrelaxation had typically 1.5{3 times smaller into that the even-odd overrelaxation.

Multicanonical update. Multicanonical update [26] is essential for the interface tension calculations with the histogram method (see Sec. 5.3). At the transition temperature the probability distribution of some order parameter, say R², has two distinct peaks corresponding to the two pure phases. The probability that the system resides in a mixed state, consisting of domains of the two phases separated by phase interfaces, is suppressed by the interface tension times the area of the interface (see, for example, q.5).

To enhance the probability of the m ixed states the action eq. (2.4) is modilied with the multicanonical weight function W:

The weight function W (R_S^2) is chosen so that the resulting distribution $p(R_S^2)$ is approximately constant in the interval $R_{S;1}^2$ R_S^2 $R_{S;2}^2$, where $R_{S;1}^2$ and $R_{S;2}^2$ denote the pure phase peak locations. This is the main disadvantage of the multicanonical method: a priori, the weight function is not known; an exact know ledge of the weight function is equivalent to knowing the probability distribution of the order parameter, which is one of the quantities we attempt to calculate with the Monte Carlo simulation.

The canonical expectation value of an operator 0 can be calculated by reweighting the individual multicanonical measurements 0_k with the weight function:

where the sum s go over all measurements of 0 and R $_{\rm S}^2$.

The choice of R $_S^2$ for the argument of the weight function is by no means unique; equally well one could use, for example, the hopping term $_{x,i}^{p}\frac{1}{2}\mathrm{Tr}^{y}(x)U_{i}(x)$ (x + i). The advantage of R $_S^2$ is that in this case the weight function does not modify the update of the gauge elds U and the SU (2)-direction of the Higgs eld V. However, the XY overrelaxation described above has to be modified.

We parametrize W with a continuous piecewise linear function:

An initial guess for the param eters w_i can be obtained by nite size scaling the probability distributions obtained from simulations using smaller lattice sizes. If deemed necessary, the param eters are further adjusted after prelim in any runs.

Since we perform most of the simulations with vector supercomputers, it is important to vectorize the multicanonical update. This is achieved with the following steps:

(i) If r_i R_S^2 < r_{i+1} initially, the weight function is xed to the linear form $W^0(R_S^2) = w_i + (w_{i+1} - w_i) (R_S^2 - r_i) = (r_{i+1} - r_i)$ for all R_S^2 .

- (ii) A number of H iggs variables are updated with the action $S^0 = S + W^0$. Since W^0 is linear in R^2 , it is straightforward to do this with a fully vectorized algorithm. We update in 100{200 points in one vector.
- (iii) The whole vector of updates is accepted with the probability $p_{mc} = m \text{ in (1;} \exp [W^0(R_S^2)] \cdot W^0(R_S^2)]$.

O bviously, the acceptance in the step (iii) decreases when the number of variables updated in a single vector increases. Here the vector length 100 is short enough so that R_S^2 in practice often remains between the limits r_i and r_{i+1} after the update, and the acceptance is exceptionally good: in our runs the rejection rate was only 10^6 ! At the same time the vector length is long enough so that increasing it does not give any signicant gain in computational speed. Thus, the performance hit caused by the implementation of the multicanonical algorithm is negligible.

The simulations were performed with Cray C-90 and X-MP supercomputers and, for the smaller volumes, with IBM RS6000 and HP 9000/735 workstations. The total amount of computing power used was about 5 $1\frac{1}{0}$ op = 160 M ops year.

4 Properties of the broken phase: the 3-loop e ective potential

We shall rst study the 3d SU (2)+ Higgs system when it is in the broken phase. This will perm it us to show the accuracy of the method and, in particular, to determ ine the size of the so far uncomputed 3-loop term in the elective potential (see (I.73), (II.151-152)), and verify that it is linear in .

Although the object of study is the 3d theory, we use the simple parametrisation in eqs. (2.8{2.10}) to perm it one to use the 4d quantities m_H ; T in xing the 3d parameters x; y. Whenever m_H ; T are quoted, the values of g_3^2 ; x; y are to be computed from eqs. (2.8{2.10}). The same values of m_H ; T can correspond to dierent physical parameters in dierent theories.

We study the e ective potential in the broken phase with the help of the scalar condensate h $^{\rm Y}$ i [4]. Eq. (II.139) relates the value of the scalar condensate in the $\overline{\rm M}$ S scheme, where

to the corresponding lattice quantity hR^2i . The relation, in which the correction term vanishes in the continuum lim it, is

Here num erically $+\frac{1}{4}$ 2 = 0:67. Thus, the extrapolation of lattice m easurements of the quantity hR 2 i to the lim it $_G$! 1 allows one to determ ine an "exact" value of the scalar condensate which then m ay be confronted with the perturbative expression.

We use the strategy appropriate for simulations at T < T_c as explained in Sec. 2. We take $m_H=80~G\,eV$ and select several temperatures for which the system is in the broken phase: $T=110;145;155;165;166;167~G\,eV$. For each temperature we choose dierent values of $_G$ (usually, 6 $_G$ 32). These numbers completely de ne the parameters of simulation through the constant physics curve (2.5-2.7). For every simulation, the volume of the system was large enough to make nite size e ects smaller than the statistical uncertainty in hR^2i .

Examples of measurements at T=110; $145\,\mathrm{GeV}$ and $165\,\mathrm{GeV}$ are shown in gs. 2{ 3, and the values of h y (T) i=T in the continuum limit are collected in table 1. The range of the temperatures used is quite wide, the expectation value of the Higgs eld varies (in 4d units) from $_{b}$ =T 2 to $_{b}$ =T 0:6.

The perturbative 2-loop computations were done with two methods, described in Sec. 5 of II. The rst method is based on a straightforward hexpansion of the condensate. The result is given in Appendix A (eq.(A 22)) and shown in g.4. Fig. 4 contains the tree, 1-loop and 2-loop terms (eqs. (II.76-78)) but also that part of the 3-loop term which is known because it is related to lower order potentials. In the second method (which we call the CW { Coleman-Weinberg { type of computation}, one numerically nds the location of the broken minimum of the 2-loop elective potential, determines the ground state energy, and then computes the condensate with the help of (II.42) as $(V_b)=0$ m $(V_$

The expansion parameter of the hexpansion is $g = m_3^2$ and thus it converges the better the deeper one is in the broken phase. This also means that the signal for




Figure 2: Data for h $^{\rm y}$ (T)i=T as a function of 1= $_{\rm G}$ for m $_{\rm H}$ = 80, T = 110 GeV computed from measured values of hR 2 i using eq. (4.2) with = T , g_3^2 = 0:44015T (parametrisation in eq. (2.8)). The perturbative values corresponding to = 0;20;40;50, calculated with the CW -m ethod at the scale = 2:37m $_{\rm T}$ and then run to = T with eq. (4.1), are shown on the vertical axis.




Figure 3: As g.2, but for T = 145 GeV and T = 165 GeV.




Figure 4: The values of h y (T) i=T in the h expansion as a function of tem perature for $m_{\rm H}=80$ GeV from eq. (A 22). The 3-loop curve contains the known part thereof, with (h) = 0. It is seen that the h-calculation becomes increasingly unreliable as one approaches the critical tem perature.

the 3-loop term vanishes if one goes too deep into the broken phase. Since one cannot be too close to m $_3^2$ = 0 (or T = 173:5 GeV in table 1) either, there is an optim alregion in between. The numerical CW method works also at T_c and is thus more accurate. We include the harmainly since the formulas are very explicit.

When all orders of perturbation theory are summed, h y ()i depends on according to eq. (4.1). At a nite order in perturbation theory, however, there is extradependence which can be used as an indication of the accuracy of the calculation. In table 1 the parameter—used in the calculation of h y ()i was varied within the limits 0:5 2:37 < =m < 2 2:37, the central value 2:37 (table 2 of I) being determined by the requirement of the "best" convergence of perturbation theory for the elective potential in the vicinity of the minimum. Then h y ()i was run to = T according to the exact running in eq. (4.1).

Inspection of table 1 shows that the CW values of the condensate are practically independent of so that the convergence of CW type perturbation theory is better than that of the ordinary one. The di erence between these two methods is due to higher order corrections; the CW method sums a subset of them and can be used at the phase transition, where the rst method fails⁵. One can see that the CW values of the condensate are larger than the corresponding lattice values, and that the di erence

between the two is statistically signi cant. This proves the necessity of higher order e ects and singles out their sign: the \exact" vev of the Higgs eld at some xed temperature is smaller than that given by 2-loop perturbation theory.

The study of the di erence between the 2-loop and lattice values of the scalar condensate allows one to determ ine the magnitude and the structure of the 3-loop term. In CW perturbation theory for the scalar condensate we add to the 2-loop e ective potential a linear term, expected on the 3-loop level (see (I.73)): 6

Here is a constant to be determined by thing the prediction to the lattice number at each temperature (for constant m_H)⁷. In the hexpansion method the procedure is extremely simple: one takes h y () i from eq. (A 22) of Appendix A, runs it to the scale T using eq.(4.1) and to the constant to get agreement with data. In other words, is linearly proportional to the difference of the perturbative and the lattice value in table 1. The outcome of this procedure is in table 2.

W ithin the T range discussed the vev of the scalar eld varies from 0.6T to 2T . Since the value of does not depend on T within error bars, one may conclude on the basis of the lattice data that for m $_{\rm H}$ around 80 GeV there exists in the elective potential a 3-loop linear term with positive sign and '50.

We estimated at dierent Higgs masses also by another method. We computed on the lattice the continuum limit of the critical temperature and the value of the condensate at T_c (the methods are described in detail in the next section). We found for $m_H=60~{\rm G\,eV}$ that $T_c=138.38\,(5)~{\rm G\,eV}$ and h^y (T_c) $i=T_c=0.227\,(6)$; and for $m_H=70~{\rm G\,eV}$ that $T_c=154.52\,(10)~{\rm G\,eV}$ and h^y (T_c) $i=T_c=0.162\,(12)$. These numbers may be reproduced with the 3-loop elective potential with $m_H=1.00$ and with $m_H=1.00$ and $m_H=1.00$ are spectively. The small Higgs mass $m_H=1.00$ is not informative

since higher order corrections at the critical tem perature are num erically small and the extraction of with any reasonable accuracy is not possible with the data we have.

Results at $m_H = 60;70$ GeV indicate that within errorbars, does not depend on m_H . This is what one expects: in the abelian U (1)+ H iggs model there is no linear term [27], so that its coe cient should be proportional to the non-abelian gauge coupling.

5 The phase transition

Since we are mostly interested in the properties of the phase transition, most of our simulations are performed at and immediately around the transition temperature. We study three dierent Higgsmass parameters $m_{\rm H}=35$, 60 and 70 GeV. We have mostly concentrated on 60 GeV. Higgs, since it is close to the physically allowed mass range, but the transition is not yet too weakly instance to be studied with moderately sized lattices.

For each of the three values of m $_{\rm H}$ we use the gauge couplings $_{\rm G}$ = 8, 12 and 20, and for m $_{\rm H}$ = 60 G eV also $_{\rm G}$ = 5 (rem em ber that $_{\rm G}$ is directly related to the

lattice spacing through $_{\rm G}=4=(g_3^2a))$. In table 3 we list the lattice sizes for each $(m_{\rm H};_{\rm G})$ -pair. Each lattice has several runs with dierent values for $_{\rm H}$ in order to accurately locate the transition; typically smaller lattices have 5{20 and larger ones 1{3 values of $_{\rm H}$. Separate runs are then joined together with the Ferrenberg-Swendsen multihistogram method [28]. When the interface tension causes noticeable supercritical slowing down, the multicanonical algorithm is used. All in all, the total number of separate runs' dierent combinations of lattice sizes and coupling constants described in this paper is 289; this includes also runs away from the transition region.

The large number of lattice volumes with several lattice spacings makes it possible to accurately extract continuum values of the physical observables:

- (1) For xed lattice spacing a (xed $_{\rm G}$), we extrapolate the lattice m easurements to the therm odynam ical lim it V ! 1 .
- (2) Each of the V=1 values are in turn extrapolated to the continuum $\lim it a ! 0$ ($_{G} ! 1$).

Note that in the 3d continuum theory the lowest-dimensional gauge-invariant operator y has the dimensionality GeV. This means that the scaling violations in physical quantities start from the rst power of the lattice spacing a (in the 4d theory, scaling violations are proportional to a^{2}).

The transition becomes weaker | the latent heat and the interface tension becomes maller | when m_H increases. Measured in dimensionless lattice units, the transition also becomes weaker when the lattice spacing a decreases for xed m_H. This can be observed from the probability distributions of the average Higgs eld squared: $R^2 = \frac{1}{V} x^2 R(x)^2$. In g. 5 we show the distributions for some of the largest volumes for m_H = 60 GeV, G = 5, 8, 12 and 20. When G increases, the separation between the peaks becomes an aller and the minimum between the peaks becomes shallower. As we will explain in Secs. 52 and 53, these features are directly related to the latent heat and the interface tension, respectively.

In g.6 the corresponding $_{\rm G}$ = 8 histograms are shown for m $_{\rm H}$ = 35 and 70 GeV. The dram atic e ect of the H iggs m ass to the strength of the phase transition is clearly evident. Note that all the distributions in gs.5 and 6 correspond to dierent values of $_{\rm H}$; each of the histograms has been reweighted to the \equalweight" $_{\rm H}$ -value (see Sec.5.1).

5.1 The critical tem perature

The critical tem perature can be determ ined extremely accurately from the Monte Carlo data. In the SU (2)+ Higgs model there are no known local order parameters, which would acquire a non-zero value only in one of the two phases of the model. Instead, we use order parameter like quantities which display a discontinuity at the transition




Figure 5: The probability distribution of the average Higgs length squared R 2 for m $_{\rm H}$ = 60 and $_{\rm G}$ = 5, 8, 12 and 20.

point (when V! 1). The quantities we use are R2 and the hopping term

where V (x) is the SU (2) direction of the H iggs variable (x) = R (x)V (x). The behaviour of hLi as a function of H is shown in g.7 for m $_{\rm H}$ = 60 G eV, $_{\rm G}$ = 8 case




Figure 6: R 2 distributions for $_{\rm G}$ = 8, m $_{\rm H}$ = 35 and 70 G eV .

for lattice sizes up to 32^3 . The development of the discontinuity is clearly visible. The continuous lines are a result of the multihistogram method calculation.

For each individual lattice volume and $(m_H; G)$ -pair, we locate the pseudocritical coupling $_{H,C}$ with several dierent methods (see, for example, [29] and references therein):

- (1) maximum of the L-susceptibility C (L) = h(L hLi)i
- (2) maximum of $(\mathbb{R}^2) = h(\mathbb{R}^2 + \mathbb{R}^2)^2$ i
- (3) m in im um of the 4th order B inder cum u lant of L: B (L) = 1 $hL^4i = (3hL^2i^2)$
- (4) \equal weight" $_{\rm H}$ -value of the distribution p (R 2)
- (5) \equal height" H -value of the distribution p(L)

The locations of the extrem a of the observables C (L), C (R 2) and B (L) are computed by reweighting the original measurements; the error analysis is performed with the jackknife method, using independent reweighting for each of the jackknife blocks. As an example, we show C (R 2) and B (L) for m $_{\rm H}=60$ G eV, $_{\rm G}=8$ lattices in g.8 as functions of $_{\rm H}$. For clarity, the errors are omitted from the gures. Again, we would like to point out the unambiguous rst order scaling displayed by the data in these gures.

The $_{\rm H}$ -values for the \equal weight" and the \equal height" distributions are also found by reweighting the histogram s independently for each jackknife block. The histogram s in $_{\rm H}$ gs. 5 and 6 are all equal weight R 2 histogram s; that is, the areas in the sym m etric phase and broken phase peaks are equal. The calculation of the peak area




Figure 7: The hopping term hLi as a function of $_{\rm H}$ for dierent lattice sizes, for m $_{\rm H}$ = 60 GeV, $_{\rm G}$ = 8.

requires an arbitrary selection of the value of R 2 which is used to separate the peaks; we used a xed value for all the lattices in each (m $_{\rm H}$; $_{\rm G}$)—set, de ned by the m in im um of the distribution of the largest volume.

The in nite volume lim it: The values of $_{\rm H,c}$ determined with them ethods (1) { (5) above dier for each individual lattice, but the V ! 1 extrapolations are very well compatible within the statistical errors. It should be noted that the dierent methods for determining $_{\rm H,c}$ do not give statistically independent results, and it is not justified to combine the values given by dierent methods together. However, they serve the purpose of checking the consistency of the in nite volume and continuum limits.

In gs. 9{10 we show the in nite volume limits for m $_{\rm H}=60$ GeV and $_{\rm G}=8$, 12 and 20. As can be observed, dierent methods converge extremely well (the intercepts of the dashed lines at 1=V = 0 are nearly equal). The same holds true for Higgs masses m $_{\rm H}=35$ and 70 GeV, which are not shown here. In table 4 we show the V! 1 extrapolations of $_{\rm H,C}$, using the data obtained with the equal weight of p(R 2) method. The corresponding values of the critical temperature $\rm T_c$, calculated with eqs. (2.7), (2.10), are also shown.

The continuum lim it: In g.11 the V = 1 values of T_c are extrapolated to the continuum lim it a! 0 for m_H = 60 GeV. We expect the leading deviation from the




Figure 8: C (\mathbb{R}^2), the susceptibility of the order parameter \mathbb{R}^2 (top), and the Binder cumulant B (L) of the order parameter L (bottom), plotted as a function of $_{\rm H}$ for m $_{\rm H}$ = 60 G eV and $_{\rm G}$ = 8 runs.

continuum lim it value to be of order O (a); in this case, there are 4 values for $_{\rm G}$, and the accuracy of the data is high enough that quadratic ts are needed in order to have good $^2/{\rm d}\, \rm o.f.$ values for the ts. The quality of the ts is very good for the T $_{\rm c}$ values calculated with any of the ve criteria, and the nal extrapolations are statistically




Figure 9: The V = 1 \lim it of the pseudocritical couplings $_{\rm H,C}$ for $\rm m_{\rm H}$ = 60 GeV, $_{\rm G}$ = 8, calculated with ve di erent methods. All the methods give compatible V = 1 \lim its; the point near 1=V = 0 is the result from linear extrapolation of the \equal weight of p (R 2)" -values. Only the largest volumes are shown.

compatible. For concreteness, we use the equal weight of p(R2) -results for our nal




Figure 10: The same as g.9 for $_{G} = 12$ and $_{G} = 20$.




Figure 11: The continuum limit ($_{\rm G}$! 1) of the critical temperature for m $_{\rm H}$ = 60 GeV. A quadratic t (dotted line) in 1= $_{\rm G}$ to all four $_{\rm G}$ -values gives good $^2/{\rm d.o.f.}$, whereas a linear t (dashed line) using only $_{\rm G}$ 8 does not have acceptable 2 . The extrapolations shown are for \equal weight of p(R 2)" data.

num bers.

In g.12 we show the corresponding extrapolations for m $_{\rm H}$ = 35 and 70 GeV. In these cases we use linear ts. The nal results are sum m arized in table 5, together with the perturbative values of $T_{\rm c}$.

There is a system atic di erence between the perturbative and the lattice results; the perturbative $T_{\rm c}$ is considerably larger. The values are closest to each other when $m_{\rm H}=35~{\rm G\,eV}$, but for $m_{\rm H}=60$ and $70~{\rm G\,eV}$ the di erence is more than 20 standard deviations. These results agree qualitatively with the results from the simulations with the A_0 eld [1,3], but the errors here are almost an order of magnitude smaller.




Figure 12: The same as g.11 form $_{\rm H}$ = 35 GeV and 70 GeV, using linear ts.

They also agree qualitatively with 4d simulations [21, 22] and recent 3d simulations by Ilgenfritz et al. [15]. Note, however, than in 4d case the errors are considerably larger, and in [15] the extrapolation to continuum limit is not taken.

5.2 The latent heat and $v(T_c)$

The latent heat L | the energy released in the transition | can be calculated from

where the derivatives are evaluated at the critical temperature, p is the dierence of the pressures of the sym metric and broken phases, and P is the dierence of the probabilities of the phases in volum eV. In eq. $(5\,2)$, T is the physical (4d) temperature; for simplicity, in the following we substitute T! T. In Sec. 11 we discuss how the correct physical result can be obtained. The quantity P is directly proportional to the dierence of the areas of the two peaks in the order parameter distributions near T_{c} , and d(P)=dT is readily calculable by reweighting.

An alternative m ethod is to evaluate d(p)=dT directly from the action in eq. (1.1):

Both m ethods give compatible results in the V ! 1 lim it. The results shown here have been calculated with eq. (5.2).




Figure 13: Extrapolation of the latent heat to V ! 1 lim it (left gure) and to the continuum lim it a ! 0 (right gure) for $m_H = 60 G eV$ lattices.

Fig. 13 displays the lim its V ! 1 and a ! 0 for the latent heat for m $_{\rm H}$ = 60 GeV system s. The in nite volume lim it is taken by extrapolating linearly with respect to the inverse area 1=(AT 2) = (L_xaT) 2 of the system , where L_xa is the linear length of the lattice (one of the short dimensions for the cylindrical volumes). The extrapolation with respect to the inverse volume would fail to accommodate the cubical and cylindrical lattices simultaneously with the same scaling ansatz. The inverse area type behaviour of the latent heat is known to occur for the Pottsmodels in 2 dimensions [30, 31] (the area in this case being the linear dimension of the lattice).

The Higgs eld expectation value in the broken phase v (T), de ned here by

can be calculated from hR 2 i using eq.(42). Because of the close relation between the equations (52) and (42), the lim its are very sim ilar in both cases. In g.14 we show the approach of v^2 (T_c) to the continuum lim it.

Higgs masses 35 and 70 GeV are analyzed in a similar way; the results for $v(T_c)$ and the latent heat are shown in table 6.

Note that the values for both v and L are quite close to the perturbative values, evaluated at the perturbative critical tem perature T_c^p . If we use the lattice critical tem perature v^p becomes larger, as can be seen from the last column in table 6. This shows the presence of higher-loop perturbative corrections in the broken phase, discussed in detail in the previous section.




Figure 14: The continuum lim it of the square of the Higgs eld vev v^2 (T_c).

5.3 The interface tension

The interface tension is one of the prim ary quantities which characterize the strength of the phase transition. We measure it with the histogram method [32]: at the pseudocritical temperature, a system in a nite volume predominantly resides in either the broken or the symmetric phase, but it can also exist in a mixed state consisting of domains of the two states. The probability of the mixed state is suppressed by the extra free energy associated with the interfaces between the phases. This causes the typical 2-peak structure of the probability distribution of the order parameter at the critical temperature (see gs. 5 and 6): the midpoint between the peaks corresponds to a state which consists of equal volumes of the symmetric and broken phases. Because of the associated extra free energy, the area of the interfaces tends to minimize. A ssuming a lattice with periodic boundary conditions and geometry $L_{\rm x}^2$ $L_{\rm z}$, where $L_{\rm x}$ $L_{\rm z}$, the minimum area is 2 $A = 2 (L_{\rm x}a)^2$ the number 2 appears because there are two




Figure 15: The interface tension for $m_H = 60 \text{ GeV}$ extrapolated to V ! 1 (left) and a! 0 (right).

In practice, the in nite volume value of is reached in such large volumes that careful nite size analysis of eq. (5.5) is necessary. Numerous studies exist in the literature [33, 34, 35]; here we follow [35]:

The function G interpolates between lattice geometries; the limiting values are G = log 3 for cubical volumes ($L_z = L_x$) and G = 0 for long cylinders ($L_z = L_x$).

The nite size scaling ansatz (5.6) assumes that the two interfaces are far enough apart from each other that their mutual interaction is negligible. In practice, this is very dicult to achieve in cubical volumes and usually requires the use of long cylindrical lattices. The order parameter histograms develop a at minimum when this condition is full led: the atness signals a constant free energy when the volume fractions of the two phases slightly change, and the interfaces move with respect to each other.

In order to nd the at part of the histogram s we use large cylindrical volum es for all $_{\rm G}$ values for m $_{\rm H}$ = 60 G eV . The volum es included for the analysis are: $_{\rm G}$ = 5:

12² 72 and 16⁶ 80; $_{G}$ = 8: 20² 140, 24⁶ 120, and 36⁶ 120; $_{G}$ = 12: 26² 156, 30² 150, and 36⁶ 144; $_{G}$ = 20: 40² 200 and 56⁶ 200. In g. 5 we show the equal weight histogram s of p (R²) for these lattices.

In the interface tension analysis we use equal height histogram s of p(L). Equal height histogram s were chosen instead of equal weight because the determ ination of P_{max} in equation 5.6 then becomes unambiguous; and p(L) instead of p(R²) since the form er histogram s have more symmetric shapes than the latter, and the equal height and equal weight $_{H,C}$ values are quite close to each other. Nevertheless, we check the measurements with equal weight p(R²) histograms (using P_{max} which is a linear interpolation of the two peak heights to the R² value of the minimum); the results are very well compatible within statistical errors.

A comment about extracting the extrem a from the histograms is in order: we not the maximum values by thing a parabola close around the peaks of the histograms, and the value of the atminimum by thing a constant. This method gives much smaller errors and more reliable results than simply using the absolute extrem a values, which are very prone to statistical noise. The same method was used also to locate the equal height of the same with the same method was used also to locate the equal height of the same method was used also to locate the equal height.

In the left part of g.15 we show the interface tension measurements from each lattice. The values shown here include the nite size scaling correction $1=L_x^2\,(\frac{3}{2}\log L_z\,\frac{1}{2}\log L_x)$ from eq. (5.6), so that only a factor const:= L_x^2 remains. For each $_{\rm G}$, the behaviour of the data is linear in $1=L_x^2$. On the right part of g.15 we extrapolate to the continuum \lim it. The results are shown in table 7.

The m $_{\rm H}=60$ GeV continuum limit result in table 7 is obtained by a linear extrapolation in 1= $_{\rm G}$. However, on closer inspection the data from $_{\rm G}=12$ and 20 lattices on the left part of g.15 seem to indicate that the interface tension is already scaling when $_{\rm G}=12$, even in nite volumes. If we use the nite volume $_{\rm G}=8$ and 12 data and extrapolate to in nite volume, we obtain the result $=(T_{\rm C})^3=0.9042$ (3), which is not compatible with the result in table 7. Nevertheless, since the data for the latent heat or v (T) do not display similar scaling behaviour, we use the linear extrapolation in 1= $_{\rm G}$ in all cases.

For $m_H = 35$ GeV, only $_G = 8$ lattices are cylindrical enough so that we can estimate the $V \,! \, 1$ limit. However, the continuum value can not be extrapolated.

For $m_H = 70$ GeV we did not observe good enough at parts in the order parameter histogram s, and we do not attempt to estimate the interface tension.

6 The correlation lengths for $m_{H} = 60 \text{ G eV}$

The m easurem ent of the H iggs and W m assess around the transition temperature is somewhat orthogonal to the measurements of the quantities directly associated with the transition itself: instead of attempting to enhance the tunnelling of the system from one phase to another, in this case it is imperative that the system stays in one homogenous phase throughout the measurement. This is due to the spurious signal caused by the tunnelling correlations: m_{tunnel} / exp(A=T) [29]. Even an incomplete tunnelling can make the extraction of the physical mass very complicated. Since the tunnellings are suppressed by the exponential factor exp(A=T), we perform a separate set of simulations around the critical temperature using large volumes and monitor the simulation time history of order parameters in order to ensure that the system stays in a single phase throughout the measurement.

We perform the measurement only for m $_{\rm H}=60~{\rm GeV}$ systems, using lattice sizes $30^2-60~{\rm and}~40^2-80~{\rm for}_{\rm G}=8~{\rm and}~40^2-80~{\rm and}~50^3~{\rm for}_{\rm G}=12$. Let us de ne operators

The masses m $_{\rm H}$ (T) and m $_{\rm W}$ (T) are found from the exponential fall-o of h $_{\rm d}$ and w $_{\rm d}$. The results are independent of the parameter d, and it is chosen to m in in ize the statistical errors. We obtain best results with d = 0 for h $_{\rm d}$ (c $_{\rm d}^0$ = $^{\rm y}$) and d = 4 for w $_{\rm d}$.

The measured values of m $_{\rm H}$ (T) and m $_{\rm W}$ (T) are shown in g.16. The scaling between $_{\rm G}$ = 8 and 12 is very good, and both m $_{\rm H}$ and m $_{\rm W}$ display a discontinuity at the transition. At the transition temperature we are able to maintain the systems in either the broken or the symmetric phase throughout the measurement, so that immediately around $T_{\rm c}$ we have two values for the masses. Both m $_{\rm H}$ (T) and m $_{\rm W}$ (T) are higher in the symmetric phase than in the broken phase.




Figure 16: The Higgs m asses (top) and the W m asses (bottom) for m $_{\rm H}=60~{\rm G\,eV}$, $_{\rm G}=8$ and 12 systems as functions of the temperature. The perturbative results are shown for m $_{\rm H}$ with solid (tree-level value), dashed (1-loop pole) and dot-dashed (some 2-loop corrections, see Sec. 10.1) lines; for m $_{\rm W}$ with solid (tree-level) and dashed (1-loop) lines. Note that the ratio m $_{\rm W}$ =m $_{\rm H}$ is much larger than indicated by the tree-level curves, since radiative corrections make m $_{\rm W}$ larger and m $_{\rm H}$ smaller.

7 The m etastability ranges and scaling properties of the sym m etric phase

An important characteristic of the phase transition is the range of metastability of the broken and symmetric phases. The symmetric phase is metastable below the critical temperature down to T=T, and the broken phase is metastable above the critical temperature up to $T=T_+$. The aim of the present section is to estimate the metastability range, and to study the dynamics of the composite eld h y i by determining its elective action. We shall concentrate on the case m $_{H}=60~\text{GeV}$ (x=0.06444) and T near T_{c} (y yj<0:06).

7.1 The m etastability range from the correlation lengths

Consider the behaviour of the scalar mass near the phase transition, g.16. When the temperature decreases, m $_{\rm H}$ in the symmetric phase rapidly decreases. This behaviour suggests that it reaches zero at some point, and the symmetric correlation length diverges. This is the lower spinoidal decomposition point and corresponds to the temperature at which the symmetric phase ceases to be metastable, T. Similar behaviour takes place in the broken phase, when the temperature increases towards T_+ . This observation allows us to estimate the metastability range, i.e., the upper and lower spinoidal decomposition temperatures. In general, one would expect the following dependence of the Higgs correlation lengths on the temperature:

where i=b; slabels the broken and sym metric phases, and T_b $T_{\rm i}$, $T_{\rm s}$ $T_{\rm i}$. The data we have does not allow one to determ ine the critical exponents and the temperatures $T_{\rm i}$ simultaneously with good accuracy, so that we have chosen $t_i=1=2$, following the guidance from mean eld theory. The results for the metastability region are given in table 8, using the $t_{\rm i}=1$ 0 GeV, $t_{\rm i}=1$ 0 and 12 results from $t_{\rm i}=1$ 1.




Figure 17: Evolution of the potential U () for the elective eld = y , related to the lattice variable R 2 through relation (42), in the vicinity of the phase transition for m $_{H}$ = 60 G eV and $_{G}$ = 8. D i erent $_{H}$ values are reached by reweighting a single (multicanonical) simulation.

7.2 M etastability from reweighting

A direct method to measure the metastability range is to use the order parameter distributions and reweighting. Let us de ne an elective variable $\frac{y}{2a} = \frac{H}{2a}R^2 + \cos x$, where the last equality follows from eq. (42). A round the pure phase peaks, the probability distribution p(R²) is related to an elective potential U ():

where V is the volume of the system. Eq. (72) has pre-exponential corrections; however, to the accuracy we are working here the above formula is su cient [36]. By reweighting the distribution $p(R^2)$ we obtain the temperature dependence of the potential. It should be noted that eq. (72) is only valid in the immediate neighbourhood of the pure phases; it does not correctly describe the mixed state between the pure phases.

The endpoints of the metastability branches can be found by locating the temperature at which the barrier against the tunnelling vanishes | the minimum of the potential in eq. (7.2) turns into an in ection point. We present the evolution of the




Figure 18: The m etastability range for $m_H = 60 \text{ G eV}$ Higgs systems, calculated with the reweighting analysis and extrapolated to a! 0.

potential in g.17 for the sym m etric and the H iggs phases for an m $_{\rm H}$ = 60 GeV, $_{\rm G}$ = 8 system . These potentials are reweighted from the 30^2 120 lattice histogram s shown in g.5. In g.18 we extrapolate the tem peratures T and T $_{+}$ to the continuum lim it, with the result

The m etastability range here is smaller than the range determined by thing the correlation lengths (table 8). We believe that the values in eq. (7.3) are more reliable, because the power law extrapolation of the correlation lengths is very sensitive to statistical errors and nite volume e ects. Note also that the range of $_{\rm H}$ over which reweighting is carried out is very small.

7.3 The e ective theory description

M ore information on the dynamics of the composite eld is contained in its elective action. We shall write it separately for each phase in the form




Figure 19: The wave function normalization of the scalar eld near the phase transition for $m_H = 60$ GeV and $_G = 8$, 12. The horizontal lines are constant to the sym metric phase data. The dashed curves labeled $v^2 = g_3^2 T$ connect the MC datapoints for that quantity.

The wave function normalization. The lattice data for the quantity $Z^2=g_3^2$ is shown in g.19 for m $_{\rm H}=60$ GeV and for T near $T_{\rm c}$. One can see that Z depends considerably on T in the broken phase, but is very accurately constant in the symmetric phase. The value of Z^2 in the symmetric phase is

The potential. The potential part U () of the elective theory can be derived from the probability distribution p (R 2) using the relation (7.2) and by thing the parameters R_{min}^2 and V_i in (7.12) 8 . Using again the m $_{\rm H}$ = 60 GeV , $_{\rm G}$ = 8 data we are able to determ ine the three parameters R_{min}^2 , V_2 and V_3 ; the statistical accuracy does not allow one to \times V_4 with reasonable precision. The results of the ts are shown in g.20.




Figure 20: The lattice results for the e ective potential coe cients, determ ined from m $_{\rm H}$ = 60 GeV , $_{\rm G}$ = 8 system s.




Figure 21: The lattice results for the test of the e ective theory description.

Let us turn now to the discussion of the behaviour of the coe cients V $_2$ and V $_3$. When the temperature decreases (increases), V $_2$ in the symmetric (broken) phase rapidly decreases, in fact repeating the behaviour of the scalarm ass from the correlation function measurements. This gives another method for the metastability range determination. We write

These values are quite consistent with the numbers in Sec. 72. However, in the broken phase we could not obtain acceptable ts.

It is interesting to note that the coe cient V $_3$ has a strong dependence on temperature in the symmetric phase. This suggests that the elective potential U () has a scale-invariant form in the vicinity of the lower spinoidal decomposition point. If we introduce the dimensionless variables




Figure 22: The temperature dependence of the elective coupling constants h_3 and h_4 .

Now, if h_3 and h_4 do not depend on the tem perature, then the system has scale-invariant behaviour near the point of absolute m etastability. The lattice data is shown in g.22. Indeed, h_3 is reasonably tem perature independent, while the quality of the data does not allow to make a de nite conclusion on the higher interactions. The values of the coupling constants are completely dierent in distinct phases; they are larger in the symmetric phase, showing that interactions are strong there.

8 Simulations with A_0 eld, $m_H = 80 \text{ GeV}$

In [3] M onte Carlo studies of the m_H = 80 GeV system, using a lattice action which includes the adjoint Higgs eld A₀, were reported. The A₀ eld, a remnant of the timelike component of the gauge eld, is a heavy eld of mass gT, and has been integrated out in the theory of eq. (1.1). The lattice action is




Figure 23: The p (\mathbb{R}^2) distributions form $_{\mathrm{H}}=80\,\mathrm{GeV}$, $_{\mathrm{G}}=12$ lattices. The histogram s are evaluated at $_{\mathrm{H}}=0.34771$. The double-peak structure of the histogram s becomes less pronounced when the volume becomes larger than 32^3 .

In $[\beta]$ lattices of sizes up to 32^3 , with $_G=12$ and 20, were studied. Clear double-peak histogram swere observed for both values of $_G$, signaling a rst order transition. However, since the publication of $[\beta]$ we have performed simulations using lattice volumes up to 48^3 . Surprisingly, with increasing volume the double-peak feature of the histograms becomes less pronounced, in contrast to the expected behaviour in rst order transitions (see g. 23). The most striking nite volume e ect is the shift of the peak positions towards each other when the volume is increased. Qualitatively similar nite volume behaviour occurs also in several other systems, which can exhibit either rst or second order phase transitions in the in nite volume limit (for example, the 2-dimensional 7-state and 4-state Potts models, which have respectively rst and second order transitions [30,31]). Thus we cannot yet make definite conclusions about the order of the phase transition.




Figure 24: The Higgs and W masses of $m_H = 80 \, \text{GeV}$, $_G = 12$, and $V = 40^3$ lattices around the transition temperature.

However, a note about the computer simulations is in order: the action (8.1) used in these simulations includes the A_0 eld, and because of the A_0 hopping term in the action it is dicult to write an elcient overrelaxation algorithm. The algorithm we use here uses heat bath and M etropolis updates, and it performs more than an order of magnitude worse than the overrelaxation described in Sec. 3. Therefore, the statistical accuracy of the $m_H=80$ GeV results is not nearly comparable to the $m_H=70$ GeV results, described in Secs. 5{6. There are also more systematic uncertainties than in the simulations in Secs. 5{6, since the relations of lattice and \overline{M} S schemes were not fully known at the time of the $m_H=80$ GeV simulations.

In g.24 we show the Higgs and W m asses around the transition temperature. To the accuracy of our data, we do not observe any discontinuities at the transition, as opposed to the m $_{\rm H}$ = 60 GeV m asses in g.16. However, the errors here are about a factor of 5 larger. In the immediate vicinity of the transition, the ratio of the W and Higgs masses is m $_{\rm W}$ = m $_{\rm H}$ 4.

We measure the critical coupling $_{\rm H,c}$ for each individual volume as described in Sec. 5. The in nite volume extrapolation is done using volumes larger than 20³, with the results $_{\rm H,c}=0.347715\,(8)$ for $_{\rm G}=12$, and $_{\rm H,c}=0.341700\,(10)$ for $_{\rm G}=20$. In contrast to simulations with m $_{\rm H}$ 70 GeV, in these simulations m was not kept constant, but instead the coupling constant $_{\rm R}$ was xed to values $_{\rm R}=0.90124$ and $_{\rm R}=0.900712$, respectively. Using the relation m $_{\rm H}$ 2 m $^2_{\rm W}=8$ $_{\rm R}$ $_{\rm G}=^2_{\rm H}$, these correspond to m $_{\rm H}=79.98$ and $79.62\,{\rm G\,eV}$. The transition temperatures and the linear extrapolations to the continuum limit are given in table 9. The numbers are somewhat

di erent from those presented in β]. The discrepancy is due to an error in the 2-loop term of the constant physics curve in β].

Table 9: Results from m $_{\rm H}$ 80 GeV simulations, together with the extrapolations to the continuum limit. The perturbative critical temperature corresponding to m $_{\rm H}$ = 79:072 GeV is about 171.5 GeV.

The continuum \lim it T_c is som ewhat below the perturbative value; however, the statistical errors are too large for the di erence to be signi cant. To resolve the situation at $m_H=80\,\text{GeV}$ requires \sin ulations perform ed without the A_0 eld. Let us note that the value of x corresponding to $m_H=80\,\text{GeV}$ is $x_c=0.1188$, and the physical H iggs m ass in the Standard M odel corresponding this x_c is about 81 GeV.

9 W hat happens at large H iggs m asses

The phase transition in the 3d SU (2)+ Higgs system becomes weaker and weaker with increasing scalar self-coupling $x = m_H^2$. An important question is whether the transition for some value of x term inates in a 2nd order transition or whether it continues as a 1st order one for all x.

The main disculty in resolving the order of the phase transition at large scalar self-coupling is the presence of the two distinct physical mass scales (inverse correlation lengths, m (T) = 1=). In fact, inspection of g.16 shows that for $m_{\rm H}$ = 60 GeV near the transition point,

Furtherm ore, g.24 indicates that this ratio is even smaller for larger m $_{\rm H}$, and data for smaller m $_{\rm H}$ indicates that it is larger for them . Note also that vector masses do not seem to go to zero at the points of absolute metastability de ned in Sec. 7.

Given the observed hierarchy $_{\rm H}$ > $_{\rm W}$, the lattice spacing must be much smaller than the vector correlation length, while the lattice size must be much larger than the scalar correlation length. This puts stringent constraints on the lattice size and makes de nite numerical conclusions more and more dicult with increasing m $_{\rm H}$ (see the discussion of the simulations with m $_{\rm H}$ = 80 GeV in Sec. 8).

However, if the ratio m $_{\rm H}$ (T)=m $_{\rm W}$ (T) continues decreasing with increasing m $_{\rm H}$, a solution to the problem im mediately suggests itself: the vector degrees of freedom

become relatively heavy, decouple, and should be integrated out. From the elective 3d SU (2)+ Higgs theory one thus at large m $_{\rm H}$ proceeds to an elective 3d scalar theory with just one degree of freedom. The transition to the scalar theory cannot be carried out by integrating out A $_{\rm i}$ perturbatively, and we instructed the relevant degrees of freedom in more detail.

The 3d Euclidean SU (2)+ H iggs theory originating from dimensional reduction corresponds to a (2+1)-dimensional M inkowskian SU (2)+ H iggs theory. This theory has an analogy with QCD: we have doublets of scalar \quarks" bound together by an SU (2) triplet of \gluons". We have chosen a M inkowskian language in order to keep the analogy with QCD transparent.

Then, one would expect that the lowest lying particle states in the symmetric phase are the spin zero scalar bound state and the three degenerate vector bound states, with quantum numbers corresponding to the composite operators

correspondingly. Here $\tilde{\ }=i_2$. Note that these operators provide also a gauge—invariant description of the H iggs particle and interm ediate vector bosons in the broken phase. In other words, the particle degrees of freedom are the same in both phases. This fact alone suggests that there is no distinction between the two phases, so that in some region in the parameter space [37, 38] there may be no phase transition at all. However, it does not exclude the situation that going from one phase to another is only possible through a phase transition.

The most general renormalizable local scalar eld theory in 3d has the action

One of the constants (say, c_4) xes the scale, and the other four (say, $c_2=c_4^2$; $c_3^2=c_4^2$; $c_5^2=c_4$ and c_6) are dimensionless numbers completely xing the dynamics of the theory. If the assumption on the elective theory is correct, then all the four parameters are some functions of the dimensionless ratios x and y characterizing the SU (2)+ Higgs theory. In the vicinity of the phase transition, the rst of the ratios ($c_2=c_4^2$) is xed, and there is a mapping of the three last ones to the single parameter x of the gauge-Higgs system

⁹Note that there is no symmetry (discrete or continuous) which forbids odd powers of Z ¹

at $T=T_c$. Clearly, these relations cannot be computed in perturbation theory, since at large m_H the phase transition occurs in the strong coupling regime. A fter they have been found by some nonperturbative means, resolving the order of the phase transition on the lattice at large m_H becomes a much easier task, because only one essential scale is present.

Finally, note that the action proposed here has a dierent number of degrees of freedom, dierent symmetries, and a dierent range of validity than the scalar action used in the simulations of [14].

10 W hat did we learn from the lattice simulations?

The non-perturbative information we acquired by doing lattice simulations can be confronted with dierent hypotheses on the nature of the phase transition existing in literature. It can be used as a test of validity of a number non-perturbative approaches, such as the -expansion [39], the renormalization group approach [40], and the Dyson-Schwinger equations [42]. In this section we provide a summary of our notings and compare them with some of the mentioned approaches.

10.1 Comparison with perturbation theory

Perturbation theory can be used for the computation of dierent quantities in the broken phase. Not many quantities are known to high order in perturbation theory in the 3d SU (2)+ Higgs theory, though. The whole list consists of the 2-loop e ective potential for the scalar eld in dierent gauges [2, 43, 44] (and the values of dierent condensates related to the ective potential, see [3]), and the 1-loop pole masses of the gauge and Higgs particles (see [42] and below).

The e ective potential. If the temperature is xed to some value, the vev of the Higgs eld, de ned by eq. (5.4), can be computed with the use of the 2-loop e ective potential. At the same time, the \exact" vev of the Higgs eld can be found on the lattice (after appropriate extrapolation to the continuum limit). The 2-loop e ective potential gives a reasonably good prediction for v=T. For example, v=v 0:3% for the vev of the Higgs eld when v=T '2, and v=v 10% for v=T ' 0:64 (these numbers refer to $m_H = 80 \text{ GeV}$). Here $v = v_{2 \text{ loop}}$ v_{xact}. The exact vev is found to be smaller than that from 2-loop perturbation theory. This proves that the 3-loop linear correction to the e ective potential comes with a positive sign. If the term in eq. (4.3) is added to the 2-loop e ective potential with = 50, then the agreem ent between the exact and 3-loop results is within 1% even for v=T as small as 0.6. In other words, the temperature dependence of the vev of the Higgs eld can now be found analytically with 1% accuracy up to rather small values of v. This result is even m ore non-trivial than a direct analytical 3-loop computation of the e ective potential, because it indicates that higher loop corrections are indeed small in this region of vevs.

The determ ination of 3-loop corrections to the e ective potential allows one to get a better idea of the expansion parameter of the SU (2)+ H iggs theory. As we have discussed in [2] it is dicult to get a reliable estimate of the expansion parameter for the elective potential on the basis of 2-loop perturbative computations. The expansion parameter (see Sec. 10.1) is proportional to g_3^2 =(m_T) = 2g_3=(), but how big is the constant of proportionality? Indeed, the loop expansion may be reliable in the broken phase in spite of the fact that the 1-loop correction is comparable with the tree term, just because the scalar self-coupling constant is small. Moreover, the magnitude of the 2-loop correction may be changed by adjusting the scale, so that the 2-loop correction may even be tuned to zero by some choice of . Hence the determination of the 3-loop correction to the elective potential is important.

Let us take for de niteness m $_{\rm H}$ = 82 GeV, i.e., $_3$ = g_3^2 = 1=8 according to eq. (2.9). In addition, consider the region near T_c (take m $_3^2$ = 0) and include only gauge eld loops (neglect m $_1$ and m $_2$). Then the estimates of the dierent contributions to the elective potential are

where m $_{\rm T}$ () = g_3 =2. Inspection of these relations immediately shows that a reasonable estimate of the expansion parameter is $\frac{g_3^2}{m_{\rm T}()}$. This quantity is rather large (0.8) in the vicinity of the phase transition for $m_{\rm H}=70~{\rm G\,eV}$, and the convergence of perturbation theory is expected to be quite bad. The main reason why the vev of the Higgs eld can be found with a pretty high accuracy is that the elective potential is known up to a high order in perturbation theory.

Perturbative correlators in the broken phase. The next two quantities characterizing the broken phase are the vector and scalar correlation lengths.

As in Sec. 4, at a nite order in perturbation theory there are dierent methods of calculating the correlators. In principle, the most straightforward is a strict perturbative calculation in powers of h in the loop expansion. Such a calculation can be done by shifting the Higgs eld to the classical broken minimum where the Goldstone boson mass m₂ vanishes, and by then calculating all the 1-loop diagrams, including the reducible tadpoles (the calculation in [42] is organized in this way). This method gives an explicitly gauge-independent results for the pole masses. Unfortunately, such a calculation gets increasingly unreliable as one approaches the phase transition, since

the tree-level results m $_1$, m $_T$ for the H iggs and W correlators, respectively, go to zero. The same problem was met in Sec. 4 in connection with the elective potential. One should therefore solve the relevant equations numerically, hoping that the higher-order corrections included are the essential ones. With this method, a small residual gauge—and—dependence remains, and its magnitude can be used as an estimate of the consistency of the approximation. We note that the gauge-dependence of the nal results for the correlators is numerically small, at most of the order $0.93g_3^2$. Below we give results in the Landau gauge. The—dependence is also brie y discussed.

To calculate the correlators, we set solve for the radiatively corrected location of the broken m in im um $_{\rm b}$ from the RG-im proved 2-loop elective potential V () [2]. The requirement of RG-improvement used here for the renormalization scale () is that the 2-loop contribution to the derivative of the elective potential, (elevery), vanishes. With $_{\rm b}$ xed, we calculate the inverse propagator, and solve numerically for the real part of the location of the pole. Since $_{\rm b}$ is an approximation to the exact minimum of V (), no reducible tadpole diagrams are needed in the calculation of the propagator in contrast to the h-calculation. The renormalization scale used in the calculation of the propagators is chosen to be ($_{\rm b}$). The dependence on is formally of higher order than the accuracy of the 1-loop calculation, but is numerically visible, see below. The details of the calculation are in Appendix C .

The pole mass obtained from the correlator for the W particle is shown in g.16. In this gure we also show the tree-level value m $_{\rm T}$. It is seen that in the broken phase, 1-loop perturbation theory gives excellent results. This is quite unexpected since the expansion parameter is rather large at the transition point. In g.16, we show also the pole m ass of the H iggs particle, together with the tree-level value. There is also a third curve: from the known 2-loop contribution V_2 () to the e ective potential, one can derive the m om entum -independent part of the 2-loop self-energy: $\frac{H}{2}$ (0) = When this is added to the complete 1-loop result, one gets the dotted curve. It is seen that the discrepancy between lattice and perturbation theory is larger than for the W correlator. The e ect of V_2^{0} suggests that a complete 2-loop calculation of the Higgs self-energy might give a better estimate. The importance of 2-loop corrections for the Higgs particle is in accordance with experience from the elective potential, see [2]. Finally, let us point out that the tree-and 1-loop W masses, as well as the the Higgs mass with the 2-loop contribution included, are practically independent of . For the tree-and 1-loop Higgs masses, the -dependence in varying in the range $0.5 \text{ (}_{b}):::2.0 \text{ (}_{b}) \text{ is of the order of } 0.03g_3^2.$

Attempts to describe the correlation lengths in the symmetric phase can be found in [42, 45].

Param eters of the phase transition The characteristics of the phase transition, such as the critical temperature, latent heat, bubble nucleation rate, surface tension, and correlation lengths in the symmetric phase cannot be de ned in the perturbative fram ework only, because the symmetric phase is in the strong coupling regime. The

failure of perturbation theory is clearly seen in order by order com putations. For example, the vector 4-loop contribution has a logarithm ic singularity at = 0. Nevertheless, it is still interesting to compare 2-loop and 3-loop predictions with the results of lattice simulations. The RG-improved 2-loop excitive potential is real in the vicinity of the critical temperature for the whole range of and is regular at the origin. Hence, the computation of the above-mentioned characteristics of the phase transition is not faced with form alm athem atical disculties.

The critical tem perature of the phase transition derived by 2-loop perturbation theory is presented in table 5. It is somewhat larger than that derived on the lattice. The vev of the scalar eld at T_c for $m_H=60$; 70 GeV coincides with the lattice value within errorbars. This perfect agreement, however, is an incident, since the comparison of vevs is done at dierent temperatures. The same is true also for the latent heat, since it is mainly determined by the value of the scalar condensate in the broken phase. We do not expect the same coincidence at larger Higgs masses.

One of the crucial quantities for the computation of the bubble nucleation rate is the surface tension. For m $_{\rm H}=60$ GeV, its value on the lattice is considerably (about 3 times) smaller than that derived from perturbation theory as

Note that this equation is valid to leading order only; in higher orders the wave function renormalization must be taken into account. However, the huge discrepancy with the lattice result shows that perturbation theory is not applicable at all for the computation of the surface tension, at least for m $_{\rm H} > 60$ GeV .

To sum m arize, the computation of the characteristics of the phase transition from 2-loop perturbation theory (for 35 GeV < m $_{\rm H}$ < 70 GeV) is accurate for the critical temperature within 0.8 $\,$ 1.6% and for the ratio v=T within 6% . Perturbation theory fails to describe the surface tension (and, therefore, the bubble nucleation rate) at least for m $_{\rm H}$ = 60 GeV .

Adding to the e ective potential the 3-loop linear term determ ined in Sec. 4 does not in prove the accuracy of perturbative predictions. We take as an example m_H = 60 GeV and = 50, as follows from lattice simulations. The critical temperature remains roughly as far from the lattice T_c as at 2-loop level, being now smaller than the lattice value, $T_c^{3-loop} = 136.8 \ GeV$. The 3-loop ratio $v^{3-loop} (T_c^{3-loop}) = T_c^{3-loop}$ is about 20% larger than the exact value. The 3-loop perturbative latent heat is away from the lattice results by almost 50%. The most drastic deviation is in the surface tension. The 3-loop value of it is $= (T_c)^3$ on 0.018 - a factor 7 larger than the lattice number! The behaviour of the elective potential in two different situations is illustrated in

 $^{^{10}}$ The estim ate of v=T in the broken phase at a given tem perature of course does in prove, since the 3-loop part is determined by just this requirement. The discrepancy is due to the fact that the exact and 3-loop critical tem peratures are dierent, and v=T is strongly tem perature dependent near T_c .




Figure 25: The RG-im proved 2-loop e ective potential (dashed line) and the 3-loop e ective potential with = 50 (solid line) for m $_{\rm H}$ = 60 GeV at the non-perturbative critical tem perature $T_{\rm c}$ = 138:38 GeV. Note that in this gure we have expressed in 4d units [$_{\rm 4d}$ = $_{\rm 3d}$ (T) $^{\rm 1=2}$].

gs. 25, 26. It is clearly seen that perturbation theory cannot quantitatively describe the phase transition.

10.2 Com parison with other non-perturbative approaches

We were not able to make a detailed comparison of the results of lattice simulations with all the non-perturbative approaches suggested in literature. For example, in [39] devoted to the application of the expansion, the authors compare their results to 1-loop e ective potential predictions. As we argued in [2], 1-loop computations in 3d have a considerable unphysical scale dependence, and this fact makes a direct comparison dicult. We could not make a comparison with the renormalization group approach in [40], either, nor with [45]. Hence we discuss here [41] and [42, 46, 47].

In [41] it was suggested that the non-perturbative e ects may considerably modify the e ective potential of the Higgs eld near the origin. Assuming that perturbation theory works in the broken phase, a measure of the non-perturbative energy shift at

= 0 was introduced, $A_F = \frac{12^h}{g_3^6} V (0; T_c) V (b; T_c)$:




Figure 26: The 2-loop and 3-loop e ective potentials at the corresponding perturbative critical tem peratures, $T_c^p = 140.25 \text{ GeV}$ and 136.82 GeV, respectively.

Here T_c is the exact value of the critical tem perature. It was conjectured in [41] that if A_F is positive then the phase transition is stronger than predicted by perturbation theory. In particular, if A_F is su ciently large (say, $A_F = 0.4$), then the lower metastability tem perature is considerably smaller than the critical tem perature, and the vev of the Higgs eld at T is substantially larger than it is at the critical tem perature. The lattice simulations allow to check the validity of this hypothesis. Let us take for deniteness $m_H = 60 \text{ GeV}$. Then, A_F is to be found from 3-loop perturbation theory (2-loop perturbation theory gives a result oby 20% for the vev of the Higgs eld and therefore is not to be used). We get A_F o.08, see g.25¹¹. In other words, the phase transition is weaker than predicted by 3-loop perturbation theory. Hence the assumption of the dominance of the gluonic condensate contribution to the vacuum energy in the symmetric phase, used in [41], appears not to be satis ed.

In [42] it was suggested that a reasonable description of the sym m etric phase can be achieved with the 1-loop Schwinger-D yson equation. From the analysis of this equation it was anticipated that the sym m etric phase can be interpreted as a Higgs phase whose param eters are determined non-perturbatively. One of the predictions of this approach

¹¹ In [3] we had another estim ate of the param eter A_F , $A_F = 0.2$. The di erence is because in [3] 2-loop perturbation theory was used, the 2-loop relations of the lattice and \overline{MS} schem as were not fully available, and the proper extrapolation of the lattice results to the continuum limit was not done due to the limited amount of data.

is that the vector boson m ass in the symmetric phase is smaller than $0.27g_3^2$, what is to be confronted with the lattice value m $_{\rm W}$ 1:1 g_3^2 . We believe that the main reason why this approach does not work is because it relies on an accurate description of the symmetric phase by 1-bop perturbation theory. In particular, it was estimated in [42] that the expansion parameter in the 3d theory is $\frac{1}{6} \frac{g_3^2}{m_T}$, while we not it to be about 6 times larger.

In [46, 47] it was suggested that the introduction of a \m agnetic m ass" m $_{\rm M}$ = 3 in the propagator of the gauge boson will cure the infrared problem and allow one to estimate the magnitude of non-perturbative e ects. This recipe would e ectively produce a linear 3-loop term with a negative coe cient:

where $m_T = g_3 = 2$. This is clearly in contradiction to the existence of the positive linear term we found in the simulations.

11 Results for dierent physical 4d theories

So far we have given results for the characteristics of the phase transition in the SU (2)+ H iggs model using the simplied relations of 4d and 3d parameters given in eqs. (2.8)-(2.10). Here we explain how these results can be converted into characteristics of nite-temperature phase transitions in physical theories where the relations between 4d and 3d are more complicated. We also give explicit results for the phase transition in the 4d SU (2)+ H iggs theory without fermions, in the 4d SU (2)+ H iggs theory with the fermionic content of the Standard M odel, and in the Standard M odel.

To begin with, let us restate the observables relevant for the phase transition in terms of properties of the 3d theory alone. The parameters of the 3d theory are $g_3^2; x; y$, defined in eqs. (2.8) { (2.10). From lattice measurements, one can derive the expectation value of dimensionless gauge—invariant observables, like h^y (g_3^2) $i=g_3^2$ (one must use eq. (4.2) to change scheme from lattice to \overline{MS} at g_3^2 . Let us denote this particular expectation value by f_3^2 , f_3^2 , f_3^2 , f_3^2 , let f_3^2 be the value of f_3^2 in the broken phase at the critical point (f_3^2), and f_3^2 , be the difference of the values of f_3^2 in the broken and symmetric phases at the critical point, f_3^2 , f_3^2 . The critical point (f_3^2) is determined as explained in Sec. 5.1. The observable f_3^2 is related to the dimensionless quantity f_3^2 (f_3^2) defined by

Next, one needs the relations to 4d. The relations to 4d consist of two parts:

- (a) One needs the expressions of the parameters g_3^2 , x and y of the 3d theory in terms of tem perature and the physical parameters of the 4d theory. For de niteness, let us take as one of the physical parameters the pole mass of the Higgs eld, m_H . Then the parameters of the 3d theory are of the form $g_3^2 = g_3^2 (m_H; T)$, $x = x (m_H; T)$ and $y = y (m_H; T)$.
- (b) One needs the relation of 3d observables to 4d therm odynam ics. This relation is completely determined by the equation $p(T) = T \oint_{0.3}^{c} x_i(x;y)$, which holds apart from inessential mass-independent terms.

U sing the relations in (a) and (b), one can relate x_c , y_c , $\frac{1}{3}$, $\frac{1}{3}$ and $\frac{1}{3}$ to 4d quantities characterizing the therm odynam ics of the phase transition. First, from the equations

Note that both dx=dT and dy_c=dx_c in eq. (11.7) are non-zero through loop corrections: dx=dT is non-vanishing due to logarithm ic 1-loop corrections to the dimensional reduction of the coupling constants g_3^2 , 3, and dy_c=dx_c is non-zero due to loop corrections inside the 3d theory (at tree-level, the phase transition takes place at y = 0 independent of x). Numerically, dy_c=dx_c 1 but dx=dT dy=dT, so that in realistic cases

Hence one does not need to determ ine the derivative of the critical line $y = y_c(x)$ with as good a relative accuracy as the jump $_3$ of the order parameter at the point $(x_c; y_c)$. If one uses the parametrization of eqs. (2.8)–(2.10) in eq. (11.7), then dx=dT = 0 and one gets the expression in eq. (5.3).

To get the values of $^{10}_{3}$, $^{1}_{3}$ and $^{3}_{3}$ from the results given in Sec. 5, one has to use eqs. (11.5)-(11.7) in the inverse direction, employing the parametrization of eqs. (2.8)-(2.10). For instance, the surface tension $=T_{c}^{3}=0.0023$ for $m_{H}=60$ GeV given in table 7 corresponds to $_{3}=0.0023=0.44015^{2}=0.0119$ according to eqs. (11.6) and (2.8). The values of x_{c} , y_{c} , $^{10}_{3}$, $^{1}_{3}$ and $^{3}_{3}$ obtained this way are shown in the second block in table 10. To go back to 4d units for di erent physical theories, one needs the true values of $g_{3}^{2}=T_{c}$, $x^{0}(T_{c})$ and $y^{0}(T_{c})$. In general, the value of $g_{3}^{2}=T_{c}$ di ers from 0.44015, so that $=T_{c}^{3}$ di ers from the value in table 7, see table 10.

The explicit form of the expressions for g_3^2 , x and y in term s of tem perature and the physical 4d param eters of the Standard M odel to order g^4 have been given in [5], using the approximation $g^2 = g^3$. With these relations, we can give results for the them odynam ical properties of the EW phase transition. To be more precise, we will consider three dierent theories reminiscent of the EW sector of the Standard M odel. As a starting point, we consider the case $m_Z = m_W$ so that $g^0 = 0$. This is a SU (2)+ H iggs theory with the fermionic content of the Standard M odel. The functions x (m_H ; T), y (m_H ; T) and g_3^2 (m_H ; T) in this theory, with $m_{top} = 175$ GeV, have been given in gs. 7-8 of [5]. The results for the phase transition, obtained from the values in the second block in table 10 using eqs. (11.4)-(11.7), are shown in the fourth block in table 10. Results for the fill Standard M odel can be obtained from the SU (2)+ H iggs+ fermions model by taking into account the U (1)-subgroup perturbatively with the help of g. 9 in [5]. The results are in the bottom block in table 10. Finally, we give results also for the SU (2)+ H iggs+ fermions model of the SU (2)+ H iggs+ fermions model

by putting $g_Y = n_F = _S = 0$ and xing m $_W = 80.22$ GeV. The results are shown in the third block in table 10. In principle, the results for the SU (2)+ H iggs theory should allow a comparison with the 4d lattice simulations in [21, 22, 23]. At present such a comparison is not rigorously possible, however, since the relation of the gauge coupling g_R^2 used in 4d simulations to continuum physics is not known.

12 Applications to cosm ology

12.1 The phase transition

The results of non-perturbative lattice M C simulations allow one to considerably reduce the uncertainties associated with the dynamics of the electroweak phase transition. Strictly speaking, they still refer to a somewhat unphysical situation, since the U (1) subgroup present in the electroweak theory is omitted. As we discussed in the previous section, the perturbative elects associated with the U (1) subgroup are rather small; the estimate of the non-perturbative elects requires lattice simulations in the complete 3d SU (2) U (1)+ Higgs model. All specic estimates in this section are based on the assumption (quite reasonable, though) that all perturbative and non-perturbative elects of the U (1) subgroup are small.

Let us reconstruct the picture of the phase transition for m $_{\rm H}=60~{\rm G\,eV}$, for which we have the best lattice data. For the M SM $\,$ with the top mass m $_{\rm t}=175~{\rm G\,eV}$ this corresponds to the pole H iggs mass of m $_{\rm H}=51.2~{\rm G\,eV}$, excluded experimentally, but for a number of extensions of the Standard M odel this may be quite realistic. To make the discussion less model dependent we will use the variable T ; with the help of the results of [5] and Sec. 11 everything can be re-computed for any species model. We shall omit here the errorbars from the numbers.

The critical tem perature of the phase transition is $T_c=138.4~{\rm GeV}$, and the vevtem perature ratio at T_c is $v=T_c=0.67$. The scalar correlation length in the sym metric phase is $_{\rm S}=6=T_c$, and in the broken phase $_{\rm b}=8=T_c$. The corresponding vector correlation lengths are a factor of three shorter. The domain wall separating the broken and sym metric phases has the surface tension $0.002T_c^{-3}$, and the prole of the scalar eld has asym metric tails on the dierent sides of the domain wall, (x) exp($_{\rm J}$ x $_{\rm J}$ = $_{\rm S}$). At $T>T_+=138.7~{\rm GeV}$ only the sym metric phase is stable, and at $T< T=137.4~{\rm only}$ the broken phase is stable, while in between both phases can exist simultaneously 12 . The bubble nucleation temperature $T_{\rm bubble}$ lies somewhere between T_c and T and may be estimated with the use of the surface tension and latent heat found on the lattice.

The simulations with m $_{\rm H}$ = 35 GeV do not correspond to any physical pole H iggs m ass in the SU (2)+ H iggs+ ferm ions m odel, at least according to the 1-loop form what for the couplings used in [5]. The errors for the 2-loop perturbative results in the rst block indicate the e ect of varying in the range 0.5 opt :::2.0 opt. The error estimates for the 3d lattice SU (2)+ H iggs model follow from the error estimates in Secs. 5.1-5.3. The surface tension measurements for m $_{\rm H}$ = 35 GeV are in parentheses for reasons explained in Sec. 5.3. In the 4d results, we only show the central value. For the 4d SU (2)+ H iggs model, the additional relative error from the relations to 4d should be below 1%, and for the SU (2)+ H iggs+ ferm ions model, it may be a few percent (in the critical temperature, the error is an order of magnitude smaller) [5]. The last block concerning the Standard M odel is based on a purely perturbative estimate of the e ect of the U (1)-subgroup [5, g. 9], and the errors may be large if the non-perturbative e ects related to the U (1)-sector are signicant.

The thin wall bubble nucleation rate is given by

where $R_c = 2$ = is the radius of the critical bubble, = $I_{T_c}^{T}$ is the pressure difference between the broken and symmetric phases, $T = T_c$ T_{bubble} , L is the latent heat of the transition, and is the prefactor. Estimates for in different models and approximations can be found in [48, 49]. The bubble nucleation temperature is roughly determined from the condition

Inserting the lattice numbers to these relations gives an estimate $\frac{T}{T_c}$ ' 0:001, i.e., the bubble nucleation temperature is very close to the critical one, $T_{\rm bubble}=138:3~{\rm G~eV}$. The smallness of $T=T_c$ is due to fact that the ratio $^3=L^2T_c$ 10^5 is so small [50]. Since $T=(T_c-T_c)$ ' 0:1 is also small, one is in the thin-wall regime; indeed, the size of the bubbles when they nucleate is at least R_c ' $110=T_c$ which is much larger than the scalar correlation lengths in the broken and symmetric phases at $T_{\rm bubble}$. Since $T_{\rm bubble}$ is very close to the critical temperature, the vev of the Higgs-eld at $T_{\rm bubble}$ is almost the same as at T_c .

12.2 The out of equilibrium condition for electroweak baryogenesis

One of the motivations for the study of the electroweak phase transition is its application to electroweak baryogenesis. The rate of the anomalous baryon number non-conserving processes is high in the symmetric phase [51], but is suppressed by the Boltzmann exponent in the broken phase [51]. Baryogenesis occurs at the 1st order electroweak phase transition, and the mechanism-independent constraint on the strength of the phase transition is that the rate of fermion number non-conservation in the broken phase at the bubble nucleation temperature be smaller than the rate of universe expansion [52].

We parametrize the rate of sphaleron transitions in the broken phase as

where the factors N $_{\rm tr}$ ' 26 and N $_{\rm rot}$ ' 5:3 10° are zero m ode norm alizations [53] and E $_{\rm sph}$ (T) is the e ective sphaleron m ass at tem perature T . Then the out of equilibrium constraint reads [52]:

In principle, this bound can be converted into an upper bound on the parameter $_3=g_3^2$, completely dening the dynamics of the 3d theory. An exact determination of this bound would require a non-perturbative evaluation of the sphaleron rate in the broken phase (for lattice simulations of topology changing processes in the symmetric phase, see [54,55]). Unfortunately, this problem has not been solved yet. Below we will estimate the critical value of $_3=g_3^2$ assuming that the expansion parameter in the broken phase is $g_3^2=(m_T)=2g_3=(b)$ a value inspired by the higher order computations and lattice simulations.

The best estimate of the sphaleron rate available now is the 1-loop computation in [56], where the determinant of small uctuations was computed numerically in a bosonic theory 13 . A coording to [56], the rate in 1-loop approximation is just given by eq. (12.3), where

and $_{\rm b}$ is the vev to be determ ined from the 1-loop e ective potential (m easured here in 4d units). A rgum ents in favour of absorption of the 1-loop e ects into the vev of the scalar eld have been presented in [59]. Some num erical values of the function B are: form $_{\rm H}=0;40;45;50$, ${\rm B}=3:04;3:41;3:44;3:48$, correspondingly [60]. We assume then that the exact value of the sphaleron m ass is given by (12.5) plus corrections, and that $_{\rm b}$ -T is to be replaced by the exact gauge-invariant value v=T determined on lattice. Then the rst correction is of the order A $(g_3^2=(m_{\rm T}))^2$, where A is a number of the order of unity. A conservative limit on the ratio v=T is obtained when A is positive, so that v=T > 1.22 (we take B corresponding to $m_{\rm H}=50~{\rm GeV}$). At this value the 2-loop correction is about 10% and the 3-loop correction is expected to be of the order of 4% and can be neglected. If, in the contrary, A is negative, we get v=T > 1:49.

Now, we choose the weaker constraint v=T > 1.22 and convert it into an upper lim it on m $_{\rm H}$. Since we do not have lattice simulations for the whole range of m $_{\rm H}$ values from 35 GeV to 60 GeV, we take the 2-loop predictions for v=T; as we discussed, this is accurate within a few percent. We not that if m $_{\rm H}$ ' 42 GeV then v=T $_{\rm c}$ = 1.22. The bubble nucleation tem perature is somewhat smaller than the critical tem perature. The thin wall approximation for the tunneling rate is not applicable here. A ssuming that the perturbative description of bubble nucleation is valid in this region of the Higgs masses, we estimate that v=T at the nucleation temperature is about 20% larger than at the critical temperature. This is derived by dening the bounce for the action

The authors concluded that the ferm ionic contribution suppresses the rate and is numerically very important. However, the elect of fermions can be absorbed into the de nition of the 3d coupling constants; after this the fermionic contribution is negligible, see [58].

num erically, and requiring that the value of the bounce action is ' 140 (see, e.g., [61]). For example, for m $_{\rm H}=43$ GeV , $T_{\rm c}=108$:6 GeV , $v(T_{\rm c})=T_{\rm c}=1:16$, $T_{\rm bubble}=106:3$ GeV , $v(T_{\rm bubble})=T_{\rm bubble}=1:43$. Then the requirement v=T > 1:22 gives m $_{\rm H}<46$ GeV . The perturbative account of the U (1) factor m akes the phase transition stronger rst order, correcting this bound by a factor

following from the 1-loop e ective potential. We then nally get m $_{\rm H}$ < 50 GeV. If the correction to the sphaleron rate is in fact negative, then the number is smaller, about 45 GeV. It is interesting to note that this bound is very close to the initial 1-loop computation in [52]. We stress, however, that these estimates are subject to veri cation by the future lattice simulations of the theory with the U (1) subgroup and to non-perturbative evaluation of the sphaleron rate.

From eq. (2.9), m $_{\rm H}$ < 50 G eV corresponds to x < 0.043 and m $_{\rm H}$ < 45 G eV to x < 0.034. To sum marize, the upper lim it to the parameter $_3=g_3^2$ in the 3d SU (2) U (1)+ H iggs theory is likely to be

In order to de ne the constraints following from this requirement on the particle spectrum of the underlying 4d theory, one has to express this ratio through the physical parameters of the 4d theory at the critical temperature. This computation may be quite involved [5], but it is very clean from the physics point of view and does not contain any infrared divergencies. An essential point is that only 1-loop graphs need be computed. Indeed, a 1-loop computation provides 0 (2) accuracy in the coupling constants of the elective theory. Moreover, the critical temperature enters to the ratio (12.8) only through logarithms, so that even a 1-loop estimate of it will give su cient accuracy.

The application of the constraint of eq. (12.8) to the case of the M in im all Standard M odel follows in mediately from g. 8 of [5]. Indeed, if m $_{\rm t}$ = 175 GeV, then no H iggs m ass can ensure the necessary requirement of eq. $(12.8)^{14}$. If the top quark were lighter, then some low H iggs mass value might be possible, see g. 27.

A coording to [62] the phase transition in the M SSM occurs in the sameway as it does in the M SM. If true, then M SSM also fails in generating a su ciently strong rst order phase transition. The two H iggs doublet model has more freedom, and the results of [63] indicate that the constraint (12.8) can be satisfied there.

 $^{^{14}}$ To be more precise, the computations in [5] relating the physical masses of the W boson and H iggs particle to the parameters of $\overline{\text{M S}}$ scheme break down if the physical H iggs mass is close to the Coleman-Weinberg limit. In this limit the higher order Yukawa corrections start to be important in the procedure of dimensional reduction as well. So, it is not excluded that H iggs masses close to the Coleman-Weinberg limit are still possible.




Figure 27: The critical value $x_c = _3 = g_3^2$ as a function of the physical Higgs mass m_H and the top quark mass m_{top}. In general, x depends on the Higgs mass, the top mass and logarithmically on the temperature. In calculating x_c , we have solved the temperature from the equation y = 0, which according to table 10 is very close to the true critical value of y_c . The small error in T_c does not a ect x_c much due to the logarithmic dependence. The value of the dimensionless U (1)-coupling $g_3^{\Omega} = g_3^2$ is not shown in this gure; it is $g_3^{\Omega} = g_3^2$ 03.

13 Conclusions

The 3d form alism, developed in the series of papers [1]-[5],[16] provides a powerful tool for the study of phase transitions in weakly coupled gauge theories. It factorizes the perturbative and non-perturbative physics and allows one to construct e ective 3d theories, describing in a universal way phase transitions in a large class of underlying 4d theories. The e ective theories in 3d contain bosons only, and may be used for high precision lattice M onte C arlo simulations.

In this paper we reported on lattice simulations in the 3d SU (2)+ H iggs model, which is an elective theory for the SU (2) sector of the M SM and its extensions. The nature of the phase transition at moderate H iggs masses $m_{\rm H} < m_{\rm W}$ is clarified, and the results presented here form an \experimental" basis for different theoretical schemes attempting to describe strong coupling phenomena at T $T_{\rm c}$.

From the phenom enological point of view, to our mind, the most interesting further problems to be solved are the role of the U (1) factor in the phase transition, and the

rate of the sphaleron transitions in the broken phase near T_c . The solution of the rst problem on the lattice is a straightforward generalization of the SU (2) case considered in this paper. The non-perturbative estimate of the sphaleron rate is a much more complicated problem, and it is even not clear how it can be solved in principle.

Appendix B

In this appendix we describe an \improved" version of the 2-loop e ective potential in Landau gauge used for the computation of the scalar condensate at dierent temperatures by the \C oleman-W einberg" method.

It was pointed out in [4] (see also Appendix A) that the elective potential in the Landau gauge contains singularities at the classical treem in imum, where the Goldstone mass

vanishes. The order of leading singularities on the n-loop level can be found from power counting:

where the C_n are some coe cients. These terms are not dangerous if the location of the minimum of the extrive potential is far enough from the tree-level value (this is the Colem an-W einberg regime). However, deep in the broken phase the quantum corrections are small, the Goldstone mass m_2 is close to zero and terms like (B2) may become important. As we discussed in Sec. 5 of [4], due to the singular terms the computation of the ground state energy by the CW method, needed for the estimate of the value of the condensate h^y i, diers from the straightforward hexpansion described in Appendix A by fractional powers of h; at n loops, the dierence is of order $h^{(n+\frac{1}{2})}$. In particular, since the extrive potential is known up to two loops, the dierence between the two methods is of order $h^{\frac{5}{2}}$. This is unacceptable since the h^3 -contribution to the excrive potential is to be determined.

Below we show how this disadvantage of the CW method can be removed, so that the CW method can be used both near and far from the critical temperature.

The main idea is to rede ne the 2-loop potential, including in it all leading singularities:

In this way, the expression for the ground state energy becomes analytic in h, as it must be in the broken phase, where there are no massless physical excitations. It is interesting that the requirement that the $h^{\frac{5}{2}}$ correction be absent in the expression for the ground state energy is powerful enough to determine the structure of the leading singularities.

Let us rewrite the tree and 1-loop e ective potentials in the following form:




Figure 28: The diagram s needed for calculating (a) the self-energy of the W boson, and (b) the self-energy of the H iggs particle. D ashed line is a scalar propagator, w iggly line a vector propagator, and double line a ghost propagator.
