## A Lattice ChiralGauge Theory with Multiferm ion Couplings

## Abstract

Analyzing an SU<sub>L</sub> (2)-chiral gauge theory with external multiferm ion couplings, we nd a possible scaling region where doublers decouple by acquiring chiral-invariant masses and  $_{\rm R}$  is free mode owing to the  $_{\rm R}$ -shift-symmetry, the chiral continuum theory of  $_{\rm L}$  can be dened. This is not in agreement with the general belief of the failure of theories so constructed.

1. It is a long standing problem to regularize chiral gauge theories (CGT) on a lattice and it seems that none of the methods proposed has been consistently and completely demonstrated both to ensure that an asymptotically chiral gauge theory in the continuum limit really exists and to provide a fram ework for doing nonperturbative calculation in these theories [1]. It is generally believed that the constructions [2, 3] of CGT on the lattice with external multiferm ion couplings fail to give chiral gauged ferm ions in the continuum limit for the reason [4] that the theories so constructed undergo spontaneous symmetry breaking and their phase structure is similar to that of the Smit-Swift model[5], which has been very carefully studied and shown to fail. Nevertheless, we believe that further considerations of constructing CGT on a lattice with external multiferm ion couplings and careful studies of the spectrum in each phase of such a constructed theory are necessary. In fact, we nd the possible scaling region of de ning continuum chiral ferm ion in such a formulation of CGT on the lattice.

Let us consider the following ferm ion action of the  $SU_L$  (2) CGT on a lattice with two external multiferm ion couplings.

where \a" is the lattice spacing;  ${}_{\rm L}^{i}$  (i = 1;2) is an SU<sub>L</sub> (2) gauged doublet,  ${}_{\rm R}$  is an SU<sub>L</sub> (2) singlet<sup>1</sup> and both are two-component W eylferm ions. where  $p + \frac{q}{2}$  and  $p^0 + \frac{q}{2}$  are the momenta of the external  $_R$ . All other one-particle irreducible vertices  ${}^{(3)}_{LLR} = {}^{(3)}_{LRR} = {}^{(n)}_{R} = 0 (n > 4)$  identically. We may here  $q_1 = 0$ , the  ${}^{(2)}_{LR}$  and  ${}^{(4)}_{LLRR}$  for the norm almode of the  $_R$  are vanishing at least 0 ((m a)<sup>2</sup>), where m is the scale of the continuum limit. This indicates that when  $q_1 = 0$ , the norm almode of the  $_R$  com pletely decouples and dose not form any bound states with other modes.

2. Our goal is to seek a possible regime, where an undoubled SU (2)-chiral gauged ferm ion content is exhibited in the continuum limit in the phase space  $(g_1;g_2;g)$ , where g'' is the gauge coupling, regarded to be a truly small perturbation g ! 0 at the scale of the continuum limit we consider. In the weak coupling limit,  $g_1 = 1$  and  $g_2 = 1$  (indicated 1 in g.1), the action (1) de nes an  $SU_L(2) = U_R(1)$  chiral continuum theory with a doubled and weakly interacting ferm ion spectrum that is not the continuum theory we seek.

Let us consider the phase of spontaneous symmetry breaking in the weakcoupling  $g_1;g_2$  limit. Based on the analysis of large N<sub>f</sub> (N<sub>f</sub> is an extra ferm ion index, e.g., color, N<sub>c</sub>) weak coupling expansion, we show that the multiferm ion couplings in (1) undergo Nambu-Jona Lasinio (NJL) spontaneous chiral-symmetry breaking[7]. In this symmetry breaking phase (indicated 2 in g.1) the  $\frac{i}{L}$  and  $_R$  in (1) pair up to be a massive D irac ferm ion violating SU (2)-chiral symmetry. The spectrum of the theory (1) can be written as,

where the functions  $I_n = 4 \frac{R}{q} \frac{w^n (q)}{den (q)}$ . Eq.(6) leads to  $g_1 = 0$ ; = 0 and i(0) = 0, this result is due to the W and identity (2). This means that on the line  $g_1 = 0$ ,

norm alm odes p = p' 0 of the  $_{L}^{i}$  and  $_{R}$  are massless and their 15 doublers  $p = p + _{A}$  acquire chiral-variant masses  $^{i}(p)$  through the multiferm ion coupling  $g_{2}$  only (1  $4g_{I_{2}} = 0$ ).

As for the function  $f_L(p)^{ij}$  in eq.(4), it depends on the dynam ics of the lefthanded W eylferm ion  $\stackrel{i}{_{L}}$  in this region. In large N<sub>f</sub> calculation at weak couplings we are able to evaluate the function  $f_L(p)^{ij} = _{ij} \sin p Z_2(p)$  (see g.2) and the wave function renorm alization is given by

A ssum ing the sym m etry breaking takes place in the direction 1 in the 2-dim ensional space of the SU (2)-chiral sym m etry ( $v^1 \notin 0$ ;  $v^2 = 0$ ), we not the following ferm ion spectrum, containing a doubled W eyl ferm ion  $^2_L$  and a undoubled D irac ferm ion m ade by the W eyl ferm ions  $^1_L$  and  $_R$ ,

The SU<sub>L</sub> (2) U<sub>R</sub> (1) chiral symmetry is realized to be U<sub>L</sub> (1) U (1) with three G oldstone modes and a massive H iggs mode that are not presented in this short report. As v<sup>1</sup> ! 0, eq.(6) gives a critical line  $g_1^c(g_2^c)$  of characterizing NJL spontaneous chiral symmetry breaking and  $g_1^c = 0.4$ ;  $g_2^c = 0$ ;  $g_1^c = 0$ ;  $g_2^c = 0.0055$  (indicated 2 in g.1). These critical values are su ciently small evenfor N  $_f = 1$ .

This broken phase cannot be a candidate for a real chiral gauge theory (e.g., the Standard M odel) for the reasons that (i)  $_{\rm L}^2$  is doubled (9); (ii) the spontaneous sym m etry breakdown of the SU<sub>L</sub> (2)-chiral sym m etry is caused by the hard breaking W ilson term [8] (8) (dimension-5 operator), which must contribute the interm ediate gauge boson m asses through the perturbative gauge interaction and disposal of G oldstonem odes. The interm ediate gauge boson m asses turn out to be O  $(\frac{1}{a})$ . This, how ever, is phenom enologically unacceptable.

3. We turn to the strong coupling region, where  $g_1(g_2)$  is su ciently larger than a certain critical value  $g_1^c(g_2^c)$  (indicated 3 in g.1). A nalogously to the analysis and discussions of E idnten and P reskill (EP) [2], we can show that the  $\frac{i}{L}$  and  $_R$ in (1) are bound up to form the composite W eylferm ions ( $\frac{i}{L} = _R$ )  $\frac{i}{L}$  (left-handed  $SU_L$  (2)-neutral) and ( $_R = \frac{i}{L}$ )  $_R$  (right-handed  $SU_L$  (2)-charged) and these bound ferm ion states respectively pair up with the  $_R$  and  $\frac{i}{L}$  to be massive, neutral  $_{\rm n}$  and charged  ${}^{\rm i}_{\rm c}$  D irac modes consistently with the SU  $_{\rm L}$  (2)  $\;$  U  $_{\!\!R}$  (1) chiral symmetry.

The second multiferm ion coupling  $4g_2w (p + \frac{q}{2})w (p^0 + \frac{q}{2})$  in (3) gives dimensional event in the electric value of  $g_1$  at large distance for sixteen modes of the  $_{L}^{i}$  and  $_{R}$  in the action (1). Let us consider the multiferm ion couplings of each mode \p" of the  $_{L}^{i}$  and  $_{R}$ , namely, we set  $p = p^0; q = q - 1$  in the four-point vertex (3). Using strong multiferm ion coupling,  $_{LLRR}^{(4)} = g_1 + 4g_2w^2(p) - 1$ , expansion<sup>2</sup> and recursion relation [9] for each mode \p" of the  $_{L}^{i}$  and  $_{R}$ , in the low est nontrivial order we calculate the propagators of neutral and charged D irac modes to be

where the chiral-invariant m asses M  $^2 = 16a^2 (g_1 + 4g_2w^2 (p))^2$  and the spectrum is vector-like.

The critical value  $g_1^c(g_2^c)$  can be determined by considering [4] the propagators  $G_{1;2}^{ij}(q)$  of four composite scalars  $A_1^i = \frac{p^1}{2}(\begin{array}{cc}i\\L & R \end{array} + \begin{array}{cc}R & i\\L\end{array})$  and  $A_2^i = \frac{p^i}{2}(\begin{array}{cc}i\\L & R\end{array})$ , which are the real and in aginary parts of a complex composite eld  $A^i = \begin{array}{cc}R & i\\L & L\\R & R\end{array}$ ,  $\begin{array}{cc}i\\L & L\\L & R\end{array}$ ,  $\begin{array}{cc}a\\L & R\end{array}$

which are degenerate owing to the exact SU (2)-chiral symmetry. A spontaneous symmetry breaking SU (2) ! U (1) occurs, where  $^2 > 0$  turns to  $^2 < 0$ . Eq.(12) for  $^2 = 0$  gives rise to the critical lines:  $g_1^c a^2 = 0.5; g_2 = 0; g_1 = 0; a^2 g_2^{cb} = 0.002$  where the  $\,$ rst binding threshold of the doubler  $p = (\ ; \ ; \ ; \ )$  is, and  $g_1 = 0; a^2 g_2^{ca} = 0.031$  where the last binding threshold of the doublers  $p = (\ ; \ ; \ ; \ )$  is, and  $g_1 = 0; a^2 g_2^{ca} = 0.031$  where the last binding threshold of the doublers  $p = (\ ; \ ; 0; 0)$  and  $p = (\ ; \ ; \ ; 0)$ , and the binding thresholds of the doublers  $p = (\ ; \ ; 0; 0)$  and  $p = (\ ; \ ; \ ; 0)$ , and the binding thresholds of the doublers are supposed to be bound, as indicated 5 in g.1. As for the norm alm odes of the  $\frac{i}{L}$  and  $_R$ , when  $g_1$  1, the multiferm ion coupling,  $\binom{40}{LLRR} = g_1 + 4g_2w^2$  (p), is no longer strong enough to form the bound states ( $\frac{i}{L}$   $_R$ )  $\frac{i}{L}$ , ( $_R$   $\frac{i}{L}$ )  $_R$  and  $A^i$  unless  $a^2g_2$  ! 1. It is conceivable that the critical line for norm alm odes  $g_1 + ag_20$  ((m a)<sup>4</sup>)  $\frac{1}{2a^2} = 0$  analytically continues to the lim it  $g_2^{c;1} = g_1$  !  $0;g_2$  ! 1.

Thus, as expected in ref.[2], several wedges open up as  $g_1;g_2$  increase in the NJL phase (indicated 5 in g.1), inbetween the critical lines along which bound states of norm alm odes and doublers of the  $_{\rm L}^{i}$  and  $_{\rm R}$  respectively approach their thresholds. In the initial part of the NJL phase, the norm alm odes and doublers of the  $_{\rm L}^{i}$  and  $_{\rm R}$  undergo the NJL phase, the norm alm odes and doublers of the  $_{\rm L}^{i}$  and  $_{\rm R}$  undergo the NJL phenom enon and contribute to eq.(4) as discussed in section 2. As  $g_1;g_2$  increase, all these modes, one after another, gradually disassociate from the NJL phenom enon and no longer contribute to eqs.(4). Instead, they turn to associate with the EP phenom enon and contribute to eqs.(10,11). The rst and last doublers of the  $_{\rm L}^{i}$  and  $_{\rm R}$  making this transition are p = (; ; ; ; ) and p = (;0;0;0) respectively. At the end of this sequence, norm alm odes (p = p) m ake this transition, due to the fact that they possess the di erent e ective multiferm ion coupling  $_{\rm LLRR}^{(4)} = g_1 + 4g_2w^2$  (p).

H ad these critical lines separated the two sym metric phases, (strong couplings and the weak coupling sym metric phases) we would have found a threshold over which all doublers of the  $\frac{i}{L}$  and R decouple by acquiring chiral invariant masses (10,11) and norm almodes of the  $\frac{i}{L}$  and R remain massless and free, and we might obtain a theory of massless free chiral fermions [2]. However, this is not real case [4]. As has been seen in eq.(12), turning 2 > 0 to 2 < 0 indicates a phase transition between the strong coupling sym metric phase to the spontaneous chiral sym metric phases.

The possible resolution of this undesired situation is that we nd a wedge in which the doublers of the  $_{\rm L}^{i}$  and  $_{\rm R}$  have form ed bound states ( $_{\rm R}$   $_{\rm L}^{i}$ )  $_{\rm R}$  and ( $_{\rm L}^{i}$   $_{\rm R}$ )  $_{\rm L}^{i}$  via the EP phenom enon, while the norm alm odes of the  $_{\rm L}^{i}$  and  $_{\rm R}$  have neither form ed such bound states yet and nor are they associated with the NJL-phenom enon.

W ithin the last wedge (indicated 5 in g.1) between two the thresholds  $g_2^{c,a}$  and  $g_2^{c,1}$ , all doublers of the  $\frac{i}{L}$  and R acquire chiral-invariant m assess and decouple (considering eqs.(10,11) as the propagators for doublers p = p + R only) and we have the undoubled low energy spectrum that involves only the norm all modes of the  $\frac{i}{L}$  and R. However, because of the multiferm ion coupling  $g_1 \notin 0$ , these normal modes of  $\frac{i}{L}$  and R still remain in the NJL broken phase, the SU (2)-chiral symmetry is violated by  $1(0) = v^1$ , to which only normalm odes contribute. The propagators of the normal modes in this wedge should be the same as eqs.(8,9) for p = p. However, when  $g_1 \notin 0$ , the normalm ode of the R is not guaranteed to completely decouple from that of the  $\frac{i}{L}$ .

Once we go onto the line A  $(g_1 = 0; g_2^{c;a} < g_2 < g_2^{c;1})$  as indicated in g.1), the spectrum is undoubled for  $g_2 > g_2^{ca}$  and as the results of the R -shift-symmetry of the action (1): (i) the norm alm ode of the R is a free mode; (ii) the interacting vertex  ${}^{(4)}_{LLRR} = 4g_2w^2$  (p) 1 for the norm alm odes, which prevent the norm alm odes of the  ${}^{i}_{L}$  and R from binding up bound states ( ${}^{i}_{L}$  R)  ${}^{i}_{L}$ , (R  ${}^{i}_{L}$ ) R and A  ${}^{i}$ ; (iii) the NJL mass term  ${}^{(2)}_{LR} = {}^{1}(0) = 0$  for which the SU<sub>L</sub> (2) U<sub>R</sub> (1)-chiral

sym m etry is completely restored. In this scaling region, the spectrum consists of the doublers eq.(10,11) for  $g_1 = 0$  and p = p + A, the massless norm almodes eqs.(8,9) for  $g_1 = 0$  and p = p,

which is in agreement with the  $SU_L(2)$   $U_R(1)$  symmetry. Namely, this normal mode of the  $\frac{i}{L}$  is self-scattering via the multifermion coupling  $g_2$  (see  $g_2$ ) without pairing up with any other modes. The wave function renormalization  $Z_2$  can be considered as an interpolating constant of  $Z_2(p)$  eq.(7) for p = p' = 0.

In sum m ary, in the scaling region for the long distance, we have the spectrum that contains the SU<sub>L</sub> (2)-invariant and U<sub>R</sub> (1)-covariant neutral D irac m ode  $_{n}$  eq.(10) (p  $\notin$  p); the U<sub>R</sub> (1)-invariant and SU<sub>L</sub> (2)-covariant charged D irac m ode  $_{c}^{i}$  eq.(11) (p  $\notin$  p); the U<sub>R</sub> (1)-covariant W eylm ode  $_{R}$  and the SU<sub>L</sub> (2)-covariant W eylm ode  $_{L}^{i}$  eq.(12) (q = q). In order to see all possible interactions between these m odes in the scaling region, we consider the one-particle irreducible vertex functions of these m odes. In the light of the exact SU<sub>L</sub> (2) U<sub>R</sub> (1) chiral symmetry and  $_{R}$  - shift-symmetry, one can straightforwardlly obtain non-vanishing vertex functions (d= dimensions) at physical m om enta (p = p;q = q): (i) A  $^{j}A {}^{jy}A {}^{i}A {}^{iy}$  (d = 4); (ii)  $_{L}^{i} {}^{i}_{L}A {}^{j}A {}^{jy}$ ,  $_{c}^{i} {}^{i}_{C}A {}^{j}A {}^{jy}$  and  $_{n} {}^{n}A {}^{jy}A {}^{jy}$  (d = 5), as well as d > 5 vertex functions. The vertex functions with dimensions d > 4 vanish in the scaling region as O (a<sup>d 4</sup>) and we are left with the self-interacting vertex A  ${}^{j}A {}^{jy}A {}^{i}A {}^{iy}$ .

In this scaling region, the chiral continuum limit is very much like that of lattice QCD.We need to tune only one coupling  $g_1 ! 0$  in the neighborhood of  $g_2^{c;a} < g_2 < g_2^{c;1}$ . For  $g_1 ! 0$ , the <sub>R</sub>-shift-symmetry is slightly violated, the norm almodes of the  $\frac{i}{L}$  and <sub>R</sub> would couple together to form the chiral symmetry breaking term  $i(0) = \frac{i}{L} R$ , which is a dimension-3 renormalized operator and thus irrelevant at the short distance. We desire this scaling region to be ultraviolet stable, in which the multiferm ion coupling  $g_1$  turns out to be an elective renormalized dimension-4 operator[12].

4. The conclusion of the existence of a possible scaling region for the continuum chiral theory is plausible and it is worthwhile to con m this scenario in di erent approaches. However, we are still left with several problems. Their possible resolutions are m entioned and discussed in this section, and deserve to be studied in future work.

The question is whether this chiral continuum theory in the scaling region could be the correct chiral gauge theory, as the SU (2)-chiral gauge coupling g perturbatively is turned on in the theory (1). One should expect a slight change of critical lines (points). We should be able to re-tune them ultiferm ion couplings  $(g_1;g_2)$  to compensate these perturbative changes. In the scaling regime, disre-

garding those uninteresting neutralm odes, we have the charged m odes including both the SU (2)-chiral-gauged, massless norm almode (13) of the  $\frac{i}{L}$  and the SU (2)-vectorial-gauged, massive doublers of the D irac ferm ion  $\frac{i}{c}$  (11), which is m ade by the 15 doublers of the  $_{\rm L}^{\rm i}$  and the 15 doublers of the bound W eyl ferm ion  $\begin{pmatrix} 1 \\ R \end{pmatrix}$ , The gauge eld should not only chirally couple to the massless normalmode of the  $\frac{1}{L}$  in the low-energy regime, but also vectorially couple to the m assive doublers of D irac ferm ion  $\frac{i}{c}$  in the high-energy regime. Thus, we expect the coupling vertex of the SU<sub>L</sub> (2)-gauge eld and the norm alm ode of the  $\frac{1}{L}$  to be chiral at the continuum limit. We are supposed to be able to dem onstrate this point on the basis of the W ard identities associating with the SU (2)-chiral gauge symmetry that is respected by the spectrum in the scaling regime. In fact, due to the reinstating of the manifest SU (2)-chiral gauge symmetry and corresponding W ard identities of the undoubled spectrum in this scaling regime, we should then apply the Rom e approach [11] (which is based on the conventional wisdom of quantum eld theory) to perturbation theory in the small gauge coupling. It is expected that the Rom e approach would work in the sam e way but all gaugevariant counterterm s are prohibited; the gauge boson m asses vanish to all orders of gauge coupling perturbation theory for  $g_1 = 0$ .

A nother in portant question remaining is how chiral gauge anom alies emerge, although in this short report the chiral gauge anom aly is cancelled by purposely choosing an appropriate ferm ion representation of the SU<sub>L</sub> (2) chiral gauge group. We know that in the doubled spectrum of naive lattice chiral gauge theory, the reason for the correct anom aly disappearing in the continuum limit is that the norm almode and doublers of Weyl ferm ion produce the same anom aly these anom alies eliminate them selves [13]. As a consequence of decoupled doublers being given chiral-invariant mass ( $O(\frac{1}{2})$ ), the survival norm almode of the Weyl ferm ion (chiral-gauged, e.g., U<sub>L</sub> (1)) should produce the correct anom aly in the continuum limit. We also have the question of whether the conservation of ferm ion number would be violated by the correct anom aly [2, 14] structure trF F<sup>\*</sup> that is generated by the SU (2) instanton in the continuum limit.
