# The Standard M odel from a New Phase Transition on the Lattice

Several years ago it was conjectured in the so-called Rom a Approach [1], that gauge xing is an essential ingredient in the lattice form ulation of chiral gauge theories. In this paper we discuss in detail how the gauge- xing approach may be realized. As in the usual (gauge invariant) lattice form ulation, the continuum lim it corresponds to a gaussian xed point, that now controls both the transversal and the longitudinal modes of the gauge eld. A key role is played by a new phase transition separating a conventional Higgs or Higgs-con nem ent phase, from a phase with broken rotational invariance. In the continuum lim it we expect to nd a scaling region, where the lattice correlators reproduce the euclidean correlation functions of the target (chiral) gauge theory, in the corresponding continuum gauge.

I. IN TRODUCTION

The great di culty in constructing chiral gauge theories, such as the Standard M odel, using the lattice regularization is related to the doubling problem [2{5]. In lattice QCD, species doubling occurs when the discretized ferm ion action has an unwanted symmetry that should be anom alous in the continuum. W hen one uses W ilson ferm ions, the W ilson term elim inates the doublers, at the price of breaking all the axial symmetries explicitly. In the continuum limit, one expects to recover the axial symmetries, except the anom alous U (1), by tuning the ferm ion hopping parameter to a critical value.

In the lattice discretization of a chiral gauge theory, one has to account for the fact that a W eyl ferm ion in a complex representation contributes to the gauge anom aly. This means that a lattice action for a single chiral ferm ion cannot be gauge invariant. W e will assume below that, as in the continuum, the lattice ferm ion action involves a sum over di erent complex representations, whose total gauge anom aly is zero. The question is to what extent the violations of gauge invariance, com ing from the individual representations, cancel each other.

Consider the regularized e ective action obtained by integrating out an anom aly-free set of chiral ferm ions. In the continuum, one can use D in ensional Regularization to de ne the e ective action for smooth gauge elds that vanish rapidly at in nity. U sing the freedom to add local counter-term s, the violations of gauge invariance are proportional to the dimensionless parameter = d - 4, and so they vanish in the lim it ! = 0. This extends to topologically non-trivial background elds, using for example the -function regularization [6].

On the lattice one encounters a fundam entally di erent situation. The lattice spacing is a dimensionful param eter that plays a dual role. First, it provide a UV cuto, by replacing the in nite range of momentum integrals with an integration over the periodic B rillouin zone. In addition, the lattice spacing enters the (multi-valued) m apping from the compact link variables  $U_{x,i}$ , to the Lie-

algebra valued A eld. These di erences in the global structure in ply that a generic lattice gauge transform ation, considered as a mapping that acts on the Fourier space of the lattice A - eld, is qualitatively di erent from the corresponding mapping de ned by a continuum gauge transform ation. The result is that the lattice e ective action su ers from generic violations of gauge invariance which are not controlled by any sm all param eter. W e know of no method that ensures the sm allness of these violations on the entire lattice gauge orbit, at the price of tuning any nite number of param eters (see Sect. IV C or the review article [7] for m ore details).

In the so-called R om a Approach [1], it was conjectured that gauge xing is a crucial ingredient in the lattice formulation of chiral gauge theories. A gauge xing action should assign a bigger Boltzm ann weight to a sm ooth gauge eld, relative to a rough eld that belongs to the sam e gauge orbit. This should reduce lattice-artefact violations of gauge invariance, because the latter are associated with the roughness of the lattice gauge eld.

In spite of this prom ising picture, the gauge- xing approach has rem ained elusive. A naive discretization of the Lorentz gauge- xing action leads to a lattice action that has a dense set of lattice G ribov copies with no continuum counterparts. These lattice artefact G ribov copies exist even for the classical vacuum. (Rem arkably, the proliferation of G ribov copies on the lattice resembles the ferm ion doubling problem in a number of ways.) As a result, the Boltzm ann weight of too m any rough lattice con gurations is not suppressed.

In this paper we construct a lattice gauge-xing action that accommodates this problem. (See ref. [8] for a preliminary version of this work.) The gauge-xing action is associated with a new generic phase diagram. We argue that, in this phase diagram, there is a gaussian critical point that belongs to the universality class of a gauge-xed continuum theory. In comparison with the gauge-invariant lattice de nition of QCD, the weak coupling limit here controls not only the transversalm odes of the gauge eld, but also the longitudinal ones.

As discussed above, gauge invariance of the target continuum theory, as well as the residual BRST invariance, are both explicitly broken on the lattice. By tuning a nite num ber of counter-term s, one hopes to recover BR ST invariance in the continuum lim it, provided the ferm ion spectrum is anom aly-free [1]. The BRST identity that requires the vanishing of the renorm alized gauge boson m ass,  $m_r^2 = 0$ , plays a key role. Since the regularization is not gauge invariant, a m ass counter-term has to be introduced, and its parameter needs to be tuned, in order to enforce this BRST identity. U sually, a negative renormalized mass-squared indicates spontaneous symmetry breaking. Here we encounter a new feature, namely, the gauge eld condenses if its mass-squared parameter becom es too negative. This im plies that the new critical point is located on the boundary between a conventional phase, which is invariant under lattice rotations, and a new phase where the lattice rotation symmetry is broken spontaneously by the VEV of the gauge eld.

The construction of the gauge-xing action is presented in Sect. II. The main results are (a) the gaugexing action has a unique absolute m inimum ,  $U_{x;} = I$ , and (b) perturbation theory around this m inimum is m anifestly renorm alizable. In Sect. III we discuss a sim – ple chiral ferm ion action. The validity of perturbation theory im plies the onset of a scaling behaviour in the weak-coupling limit. Up to the regularization-dependent counter-terms, the continuum lagrangian that controls the scaling behaviour can be read o from the marginal and relevant terms of the lattice action. The scaling region should therefore faithfully reproduce the correlation functions of the target chiral gauge theory, in the corresponding gauge.

W ithout the new gauge- xing action, the ferm ion action of Sect. III does not lead to a chiral gauge theory in the continuum limit. The longitudinal modes uctuate strongly, and their non-perturbative dynam ics ultim ately renders the ferm ion spectrum vector-like. (This applies to m any other chiral ferm ion proposals, see ref. [7,9].) In the second part of this paper, we exam ine the dynam ics of the lattice longitudinal modes from a broader point of view. We explain the problem s created by this dynam ics, and how they may be solved within the present approach.

In Sect. IV we discuss the lattice e ective action, and the role of lattice artefact G ribov copies. In Sect. V we discuss the complete phase diagram in the lim it of a vanishing gauge coupling. In Sect. V I we explain how our approach evades the No-G o theorem s. Several open questions are discussed in Sect. V II, and our conclusions are o ered in Sect. V III.

# II. CONSTRUCTING THE LATTICE GAUGE FIXING ACTION

# A . The phase transition associated with a critical vector boson

This section is devoted to a step-by-step construction of the gauge- xing action. As discussed in the introduction, the lattice-regularized theory has no sym metry that protects the masslessness of the vector bosons. Therefore, in the relevant part of the phase diagram, the lattice vector eld is generically not critical. Now, according to the standard lore, the correlation length should diverge close to a continuous phase transition associated with the condensation a Bose eld. In this paper we wish to apply this to the lattice vector eld.

As a prelim inary requirement for a continuous transition, one needs a higher-power term, that stabilizes the classical potential  $V_{\rm cl}\,(A_{\rm cl})$  when the coe cient of the quadratic term changes sign. In a weakly-coupled theory, the actual location of the transition should be close to its tree-level value, and near the transition one expects the onset of a scaling behaviour governed by renorm alized (continuum) perturbation theory.

O ur aim is to achieve criticality of the lattice vector ekd, very much like the way this is done in the fam iliar  $^4$  theory. However, going from a spin-0 to a spin-1 ekd presents new di culties. The lattice theory is formulated in terms of the link variables  $U_{\rm x;}$ , which are group-valued parallel transporters. On the other hand, renorm alized perturbation theory, that governs the scaling region, is more naturally formulated in terms of the Lie-algebra valued A ekd. Thus, it takes som e trial and error to nd the U -dependent action that best suits our purpose.

A nother com plication arises because not every renorm alizable vector theory is unitary. A unitary, physical H ibert space exists if and only if the vector theory is actually an anom aly-free gauge theory in a gauge xed form. This requires us to choose the lattice action, such that the marginal gauge sym m etry breaking term s in the tree-level vector lagrangian have the form

An appropriate Faddeev-Popov ghost action will be necessary too.

B.A higher-derivative H iggs action

Our starting point is the lattice action

Here  $S_{\rm G}$  (U ) is the usual plaquette action. The Higgs action is

is the standard nearest-neighbour covariant laplacian. The lattice spacing a is equal to one. Both U<sub>x</sub>; and <sub>x</sub> take values in a Lie group G. The rst term on the rhs. of eq. (2.3) is a conventional lattice H iggs action, whereas the second term is a higher derivative (HD) action.

(HD actions were recently discussed by Jansen, K uti and Liu [10]. Here we are interested in a di erent critical point from the one studied in ref. [10]. At the technical level, this allow s us to introduced only a laplaciansquared HD term, whereas for the purpose of ref. [10] it was crucial to introduce also a laplacian-cubed one.)

The action eq. (2.2) is gauge invariant, where the lattice gauge transform ation is given by U<sub>x</sub>; !  $g_x U_x$ ;  $g_{x+^{\wedge}}^y$  and  $_x$  !  $g_x \ _x$  for  $g_x \ 2 \ G$ . Now, since  $_x \ 2 \ G$  too, we may use the lattice gauge invariance to completely elim - inate the  $_x$  eld. Note that this operation a ects only  $S_H$ . We introduce the notation

The subscript of  $S_V$  stands for <code>\vector". S\_H</code> can be recovered from  $S_V$  by making the substitution  $U_x;$  !  $_x^yU_x; x_{+} \wedge .$  (The signi cance of the  $_x$  eld, which is associated with the longitudinal degrees of freedom, is discussed in Sect.V and Sect.VI.)

We will denote the rst formulation of the theory (eq. (2.2)) as the H iggs picture. The alternative formulation (eq. (2.5)) where only  $U_x$ ; (but not  $_x$ ) is present, is called the vector picture. The equality of the partition functions in the two pictures extends to observables. A ny observable in the vector picture is mapped to a gauge invariant observable in H iggs picture, and vice versa. Thus, we are dealing with two mathematically equivalent formulations of the same theory [11].

In this section we assume ~ 1. The physics in this parameter range is more easily accounted for in the vector picture, which is used below to study the classical potential, and to set up the weak-coupling expansion. In the vector picture, the gauge non-invariance of the action resides in  $S_V$ . Therefore, we will ultimately demand that the marginal terms in  $S_V$  have the form of a gauge xing action, cf. (2.1).

#### C.The classical potential

For sim plicity we consider the classical potential in the U (1) case. The essential features generalize to the nonabelian case. M aking use of the standard weak-coupling expansion

and considering a constant A = e d , the action  $S_{\rm V}$  leads to the following classical potential

Note that  $S_G$  is zero for a constant abelian eld.

For > 0, the absolute m inim um of the classical potential is  $A = 0 \pmod{2} = g_0$ . Since the quadratic term in  $V_{c1}$  comes only from the -term, a non-zero vector condensate arises for < 0. The classical features of the transition can be determined by keeping only the leading term in the expansion of F ( $g_0A$ ), separately for the - and ~term s. (This approximation is consistent for j j ~.) The result is the quartic potential

Eq. (2.9) closely resembles the potential of a  $\,^4$  theory. For small negative , the minimum is

Eq. (2.10) exhibits the mean-eld critical exponent 1=2. It is easy to check that this is the absolute minimum of the classical potential.

W e note that eq. (2.10) is invariant under arbitrary SO (4) rotations, re ecting the sym m etry of the approxim ate potential eq. (2.9). W hen higher-order corrections are taken into account, the rotational sym m etry of the potential is reduced to the lattice hypercubic sym m etry.

Below, the phase with a non-zero vector condensate will be denoted as the FM D phase. We will speak about the FM D transition, referring to the transition from the rotationally invariant phase to the FM D phase in the large- region. FM D stands for ferrom agnetic directional. The preferred spacetime direction of the FM D phase is de ned by the vectorial VEV. For  $g_0 \notin 0$ , there are no G oldstone bosons in the FM D phase, because the lattice rotation group is discrete. The limiting  $g_0 = 0$  theory is discussed in Sect. V, and in particular we explain there in what sense the FM D phase is ferrom agnetic.

#### D. The weak-coupling expansion

We now want to study uctuations around the classical vacuum  $U_{x;} = I$  (equivalently A = 0) in the rotationally-invariant phase, close to the FM D transition where the theory de ned by eqs. (2-5) is expected to be critical. The FM D transition is given by = 0 in the

classical approximation. As mentioned earlier, we are assuming ~ 1. We therefore focus on the HD term in its vector picture form. Relaxing the assumption of a constant A eld, we nd

where the dots stand for irrelevant operators. is the backward lattice derivative, de ned as  $f_x = f_x f_x f_x$  for any function  $f_x$ .

Eq. (2.11) contains a longitudinal kinetic term . We de ne

and we will assume that  $_0$  is an O (1) parameter. This means that the longitudinal kinetic term belongs to the tree-level lagrangian. Remember that a transversal kinetic term is provided by the gauge invariant plaquette action  $S_G$ . Finally, we assume that the tree-level vector boson mass is zero. Under these assumptions, the tree-level vector propagator is

M assless weak-coupling perturbation theory is de ned by the vector propagator eq. (2.13), and by a set of vertices which can be read o from the lattice action using eq. (2.6) in the usual way.

#### E. The gauge- xing action

In view of the presence of kinetic terms for all polarizations, lattice perturbation theory is manifestly renorm alizable. A coording to the standard lore, renorm alizability in plies a Lorentz invariant scaling behaviour in the vicinity of the gaussian critical point  $g_0 = 1 = -0$ . The scaling behaviour is achieved by tuning a nite number of counter-terms, that correspond to the relevant and the marginal operators.

At this stage, the marginal gauge symmetry breaking terms in the tree-level vector action (see eq. (2.11)) do not have the form of a gauge-xing action, cf. (2.1). The way to remedy this is to add another term to the HD action. There are two options. The new term can be chosen to cancel the quartic term in eq. (2.11). The remaining m arginal term { the longitudinal kinetic term { has the form of a gauge- xing action for the linear Lorentz gauge @ A = 0.A Iternatively, the new HD term can lead to a m ixed m arginal term proportional to (@ A)Å. In this case one recovers the non-linear gauge @ A + gÅ = 0.

The linear gauge @ A = 0 is more familiar, and less complicated to implement in perturbation theory. Moreover, the above non-linear gauge is consistent only for U (1) or SU (N) U (1), whereas the linear gauge is consistent for any gauge group. The linear gauge has, how ever, one technical disadvantage. The quartic term in eq. (2.11) is the stabilizing term of the classical potential (see eq. (2.9)). In its absence, one has to reanalyze the classical potential, and m ake sure that it is stabilized by a higher-power term (in practice this is an  $A^6$  term). This task is done in ref. [12], which is henceforth referred to as II.

Here we will consider only the non-linear gauge. Since the necessary mixed term contains a derivative, one can modify the HD action while leaving the classical potential intact. This simpli es our task, as the large- study of the phase diagram in Sect. IIC remains valid. The new HD action is

Going to the vector picture and applying the weakcoupling expansion, we have

It is easy to check that the desired mixed term is now present in the tree-level vector action. We comment that, in the Higgs picture, V is a gauge-invariant local vector eld, whose expectation value serves as an order parameter for the FMD phase. (The corresponding order parameter in the vector picture is the expectation value of  $V_{x=1}$ .) At the classical level, hV i =  $g_0$  hA i, where the latter is given by eq. (2.10).

For the laplacian-squared HD action (see eq. (2.3)), it is evident that  $U_x$ ; = I is the unique absolute m inimum for all con gurations, and not only for the constant ones considered in the classical potential (we assume  $_x = I$ ). This property, which is necessary to validate the weak-coupling expansion, applies to the new HD action (2.16) as well. The proof is given in II. The symmetric combination used in the denition of  $B_x$  (eq. (2.17)), which does not a ect the marginal term contained in B  $\,$  V , is essential for the proof.

W e de ne the lattice gauge- xing action to be

As expected,  $S_{gf}^{n:l:}$  has the classical continuum limit  $(1=2_0)$  (@ A + gÅ)<sup>2</sup>. Because of the irrelevant term s it contains, one cannot write  $S_{gf}^{n:l:}$  as the (sum over x of the) square of a local function of the U -s. Consequently, the gauge- xed lattice action is not invariant under BRST transform ations.

It is interesting that the breaking of (gauge and) BRST invariance is a common feature of the chiral ferm ion action and the gauge-xing action. In the case of the gaugexing action, it has to be so because of a theorem by Neuberger [13], which asserts that any lattice BRST invariant (gauge-xed) partition function must vanish due to lattice artefact G ribov copies. We return to the role of lattice G ribov copies in Sect. IV.

Before we introduce ferm ions, the complete lattice action (in the vector picture) is therefore

For the non-linear gauge, the continuum Faddeev-Popov action involves the operator (we suppress the group structure constants)  $Q^2$  + igA 0 + gfA;0 + igAg. The last term is absent in the case of the linear gauge. For the discretization of  $Q^2$  we take the standard (free) lattice laplacian. W e are discretizing a second order operator, and our choice avoids the appearance of any FP doublers. For the interaction terms, any lattice operator with the correct classical continuum limit should do. For the discretization of qA Q, for example, one can take V where is the antisymm etric di erence operator. (Since BRST symmetry is broken anyway by the gauge-xing action, we make no attempt to preserve any exact relation between the discretized versions of  $Q^2$  and Q.) We note that the ghost elds contribute to the Α e ective potential only through loops, and so they do not m odify the tree-level considerations.

 $\rm S_{ct}$  is the counter-term action. The role of  $\rm S_{ct}$  is to enforce BRST invariance in the low momentum limit of lattice perturbation theory [1]. The BRST symmetry is violated in particular by (marginal) SO (4)-breaking lattice operators. Therefore, enforcing BRST invariance should also restore full SO (4)-invariance in the continuum limit. The counter-term action is more naturally written in terms of A . We de ne  $\rm S_{ct}$  as a local functional of the U -sby trading A with V using eq. (2.19). (The second term in the expansion of V , which breaks SO (4) invariance, is needed only for the dimension-two m ass counter-term . In all other cases one simply replaces  $q_0\rm A$  with V .)

The BRST identity  $m_r^2 = 0$ , which says that the (renorm alized) vector boson m ass m ust vanish to all orders in perturbation theory, is consistent with taking the continuum limit at the FM D transition. As a mass counterterm one can take the -term in eq. (2.3). This means that is tuned to c:l: (g<sub>0</sub>; 0), where in perturbation theory c:l: =  $\Pr_{n=1}^{P} c_n (0) g_0^{2(n-1)}$ . Note that the coe cient of the mass term in eq. (2.9) is  $g_0^2$ . The absence of an O (1= $g_0^2$ ) term in the expansion of c:l: is in agreement with the vanishing of the tree-level vector boson mass.

In this paper we have simplied things by considering only the most important counter-term, namely, the dimension-two mass term . In the case of the nonlinear gauge, the next most important counter-term is the dimension-four SO (4)-breaking term  $A^4$ . As for the linear gauge, the classical potential is stabilized by an  $A^6$  term, and  $(A^2)^2$  too occurs only as a counterterm . In this case, the e ect of the dimension-four nonderivative counter-terms is discussed in II. One nds that the conventional (hyper-cubic invariant) phase and the FM D phase both extend into the higher-dimensional phase diagram . A lso, the FM D transition remains continuouswhen the dimension-four counter-term sare tuned to their critical values. The crucial features leading to these conclusions are (a) it is justilled to expand U up to a nite order in A (equal to the dimension of the stabilizing term ) when looking for the absolute m in im um of the potential; (b) the coe cients of the counter-term sare 0 (1), whereas the coe cient of the gauge- xing action is  $0 (1=g_0^2)$ . Since these features are true in the case of the non-linear gauge as well, we expect a sim ilar robustness against the inclusion of additional counter-term s.

In this section we have discussed the phase diagram only in the large-~ lim it. The phase diagram for arbitrary and ~ is studied in Sect.VA. This study, as well as additional arguments presented in Sect.VIA, further clarify why the continuum lim it of the gauge- xing approach should be de ned at the FMD transition.

#### III.CHIRAL FERM IONS

In a gauge invariant lattice theory, the minimum of the plaquette action is unique up to a gauge transform ation, and the transversal kinetic term is su cient to de ne a valid weak-coupling expansion. In the absence of gauge invariance, there exists a valid weak-coupling expansion provided the gauge-xing action of Sect. IIE is added to the plaquette action. This applies also to the gaugexing action presented in II for the linear gauge 0 = 0. U sing either of these gauge- xing actions, there is a lot of freedom in the choice of the chiral ferm ion action. We consider here (in the vector picture) an action which is the most econom ic in the number of ferm ionic degrees of freedom [14]. (For related work see ref. [15,16].) Other ferm ion actions have certain advantages over the one presented here, and in particular they can reduce the required ne-tuning.

A coording to ref. [14], one introduces a two-com ponent

lattice ferm ion eld  $_{\rm x}$ , to account for a single W eyl ferm ion in the target continuum theory. The ferm ion action is (suppressing coordinates sum m ations)

Here  $2_{xy}$  is the free lattice laplacian (eq. (2.4) for  $U_{x;} = I$ ), and  $x_{y}$   $x_{;}$   $y_{;} = \frac{T}{x}$  y where is the antisymm etric two-by-two matrix. We assume w = 0 (1). The rst term in eq. (3.1) is the naive lattice discretization of the continuum W eyl action. The second term is a M a jurana-W ilson (MW) term, that breaks explicitly gauge invariance as well as the ferm ion number symmetry. The latter is unwanted, because ferm ion number is not conserved in the continuum theory.

In order to understand the properties of the lattice ferm ion path integral, it is convenient to recast the ferm ion action eq. (3.1) in terms of four components elds  $_{\rm M}$  and  $_{\rm M}$ . By de nition, P<sub>L M</sub> = and P<sub>R M</sub> =  $^{\rm T}$ , where P<sub>R,L</sub> =  $\frac{1}{2}$ (1  $_{5}$ ) denote chirality projectors.  $_{\rm M}$  is not an independent eld, and is given by

Here C is the antisymmetric four-by-four charge conju-gation matrix, obeying  $C^2 = 1$ ,  ${}^{T}C = C$  and  ${}_{5}C = C {}_{5}$ . In terms of these four component elds, the ferm ion action takes the form

Let us rst examine eq. (3.4) in perturbation theory. The tree-level ferm ion propagator is the (m assless) W ilson propagator [14]. Because of the Majorana-like condition eq. (3.3), the sym m etry factors in Feynm an graphs are the same as for M a prana ferm ions. Now, if we go to the small momentum limit, we nd that the two chiralities of  $_{\rm M}$  couple to the gauge eld according to com plex conjugate representations of the gauge group. One sees that the role of eq. (3.3) is to consistently maintain the identication  $P_{L M}$  \$,  $P_{R M}$  \$, at the level of Feynm an diagram s. That eq. (3.4) correctly describes a single left-handed W eyl ferm ion, can be veried by calculating the non-analytic part of one-ferm ionloop diagrams, that should agree with the continuum result in the limit of a vanishing external momentum (the role of counter-term s is discussed below). A s usual, the non-analytic contribution com es from an in nitesimal neighbourhood of the origin in the Brillouin zone. In this neighbourhood one can neglect the W ilson term

in both numerators and denom inators. The left-handed and right-handed components of  $_{\rm M}$  are no longer coupled, and one can reexpress the Feynm an integrand in terms of the continuum propagator for a single W eyl ferm ion. (A left-handed ferm ion loop is equal to a right-handed ferm ion loop in the complex conjugate representation. The \double-counting" is compensated by a one-half symmetry factor for each closed ferm ion loop, which arises from the M a prana-like condition eq. (3.3).)

W e next discuss the rigorous de nition of the ferm ionic path integral. W e introduce the 2N 2N ferm ion matrix Q by writing the action in the generic form  $S_F=\frac{1}{2}$ ; MQ M. (The charge conjugation matrix C is absorbed into the de nition of Q.) It is easy to check that Q is antisymmetric. The ferm ion path integral takes the following form [17]

There is no integration over the (dependent) variables  $_{\rm M}$ . According to eq. (3.5), the ferm ionic path integral is a Pfa an. In general, pf(Q =2) is complex, as expected from the euclidean path integral for a single W eyl ferm ion.

(As a further check that our fem ion path integral describes a W eyl fem ion, we can consider a \two-generation" model, where each complex representation occurs twice in the ferm ion spectrum. U sing the identity  $pf^2(Q=2) = det(Q)$ , that holds for a general antisymmetric matrix, this two-generation model can be dened by an action similar to eq. (3.4), where we now drop an overall one-half factor, substitute  $_M ! _D$ ,  $_M ! _D$ , and regard  $_D$  and  $_D$  as independent D iraclike variables. The counting of degrees of freedom is now straightforward. Since the two chiralities of  $_D$  belong to complex conjugate representations, this action actually describes two left-handed W eyl ferm ions in the same complex representation.)

Until now we have implicitly discussed the fermions in the background of a xed external gauge ekd. The main result of the previous section is that, with the gauge-xing action, perturbation theory is valid for a dynamical gauge ekd as well. Therefore, with appropriate counter-terms, the continuum ekds describing the scaling behaviour are in one-to-one correspondence with the m assless poles of the various tree-kevel propagators. If we choose an anom aly-free ferm ion spectrum, the scaling region should be governed by a continuum chiral gauge theory, in the relevant gauge. We note that if one chooses an anom alous ferm ion spectrum, the scaling region will still be governed by a renorm alizable lagrangian, but BR ST invariance and, hence, unitarity will be violated.

F inally, let us discuss the ferm ion m ass counter-term s. As with ordinary W ilson ferm ions, a mass counter-term m  $_0$  M  $_{\rm M}$  is necessary to maintain the masslessness of each chiral ferm ion. (A dierent ferm ion action that does not require mass counter-terms will be discussed elsewhere [36].) The renormalized Majorana-like mass is proportional to  $(m_0 m_c)$ , where  $m_c$  is (m inus) the uctuations-induced m ass. If  $(m_0 m_c)$  is sm allbut nonzero, BRST invariance will be explicitly broken in the scaling region. The scaling behaviour is then governed by a renorm alizable continuum theory which is not gauge invariant (hence also non-unitary). By tuning  $m_0$  to  $m_{cr}$ assum ing all other counter-term s already have their critical values, we recover BRST invariance simultaneously with the masslessness of the chiral ferm ions. (The situation on the lattice is sim ilar to what one would encounter in the continuum, if a gauge non-invariant regularization is employed for a chiral gauge theory. As on the lattice, M a prana-like m ass counter-term s m ay be needed, alongside with other gauge non-invariant counter-term s, to cancel the breaking of gauge invariance induced by the regularization, and to ensure that the renorm alized am plitudes are gauge invariant.)

An important question in the literature on lattice chiralgauge theories, is how to correctly reproduce ferm ion number violation in the continuum limit. Dierent solutions have been proposed to the problem [18{21]. We hope that the present approach can shed new light on it.

For de niteness, we adopt the strategy of ref. [14]. Namely, we demand that the lattice ferm ion action should have no symmetry which is not present in the target continuum theory. Now, while the action eq. (3.1) is not invariant under globalU (1) transform ations with an arbitrary phase, it is still invariant under the residual discrete symmetry ! , ! . This symmetry im plies a (m od 2) conservation law for each ferm ion species, which still causes a problem . Consider for de niteness an SU (5) GUT, with one generation that contains a  $\overline{5}$  and a 10. In an instanton background, the numbers of zero m odes for these representations are respectively one and three. This is in con ict with the above (mod 2) conservation laws. Thus, on top of the MW terms present in eq. (3.1) for each representation, one has to introduce an additional gauge-non invariant MW term that couples the  $\overline{5}$  and the 10. (As a result, a M a prana-like mass counter-term that m ixes the  $\overline{5}$  and the 10 will be necessary too.) With this new MW term, the remaining discrete symmetry leads only to (mod 2) conservation of the total ferm ion number for each generation.

## IV.W HY GAUGE FIX ING

W e now return to the lattice e ective action, and consider som e of its properties in m ore detail. W e keep the discussion at an inform al level. Our approach has been presented in detail in the previous sections, and the aim here is to clarify the nature of the problems that it is meant to solve.

In this section we assume that the lattice chiral ferm ion action  $S_F$  is bilinear in the ferm ion elds, and that it depends in addition only on the link variables  $U_{x;}$ . (This corresponds to the vector picture.) It is also assumed that  $S_F$  is (mildly) local. The lattice spacing a will be shown explicitly in this section.

The di culties encountered in the construction of lattice chiral gauge theories can be addressed at a m ore rigorous level [5,7]. This com plem entary discussion, which focuses on the robustness of the Nielsen-Ninom iya theorem, is given in Sect.VI.

# A . R ough lattice gauge transform ations and the need for gauge xing

The lattice e ective action is de ned by integrating out the ferm ions

C learly, the well-de ned object is exp( $S_e$ ), rather than  $S_e$  itself. For our purpose it will be su cient to consider the perturbative e ective action, and so we will ignore the problem s associated with the global de nition of  $S_e$ .

The variation of  $S_{\rm e}$  , in response to an in nitesimal lattice gauge transform ation at the point  $x_0$ , has the following general form

The sign indicates that the rh.s. is computed perturbatively. Note that the gauge eld is external, and so the gauge-eld action is not needed at this stage.  $O_x^{con}$  and  $O_x^{n,i}$  are local lattice operators that depend on A , cf. eq. (2.6). The dimension of  $O_x^{n,i}$  is 4 + n, and the issum mation is over linearly independent operators of this dimension.  $O_x^{con}$  is some discretized version of the consistent anomaly. We assume that all operators of dimension less than or equal to four, other than  $O_x^{con}$ , have been cancelled by counter-terms. If, moreover, we choose a set of com plex representations that satis es the anomaly cancellation condition, then  $c_0 = 0$ .

The in nite sum on the rhs. of eq. (42) accounts for lattice artifact violations of gauge invariance. The precise form of these violations is model dependent, but their existence is generic. As can be easily seen by going to momentum space, which is the usual setting for a perturbative computation, this sum represents a double expansion in  $j_0aA$  jand jap j.

Let us rst consider a smooth gauge eld A<sup>0</sup> which is characterized by some physical scale <sub>phys</sub> a <sup>1</sup>, and the corresponding con guration of link variables U<sup>0</sup><sub>x</sub>; dened via eq. (2.6). Since the dimensionful quantities A and p are O (  $_{\rm phys}$ ), both of the above expansion param eters are small. Eq. (4.2) is the gradient of  $S_{\rm e}~$  with respect to a motion inside the lattice gauge orbit. Therefore,  $S_{\rm e}~$  is (approximately) constant on the orbit in the vicinity  $U_{x_1}^0$ . The constancy of  $S_{\rm e}~$  extends to that portion of the orbit which is reachable from  $U_{x_1}^0$  by a sm ooth gauge transform ation.

The problem is that, on the lattice, smooth gauge transform ations represent a tiny part of the local gauge group. Let  $U_{x;}^{(g)} = g_x U_{x;}^0 g_{x+}^y$  be a generic con guration in the orbit of  $U_{x;}^0$ , and let  $A^{(g)}$  be related to  $U_{x;}^{(g)}$  via eq. (2.6). Since the operators that occur on the rhs. of eq. (4.2) are not gauge-invariant, they are sensitive to the value of  $g_x$  for x in the vicinity of  $x_0$ . Now, the  $g_x$ -s on di erent sites a uncorrelated. As a result, the expansion param eters  $j_0 a A^{(g)} j and j a A^{(g)} = A^{(g)} j are O (1)$  for a generic lattice gauge transform ation. We conclude that  $S_e$  fails to be (approximately) constant on most of the lattice gauge orbit. This is true for any orbit, including orbits that have a smooth representative.

## B.Proliferation of lattice G ribov copies

The above problem stems from the roughness of generic lattice gauge transform ations. Follow ing ref. [1] we make no attempt to reduce the violations of gauge invariance at the level of the elective action. Instead, our aim is to suppress the Boltzm ann weight of rough gauge eld congurations (relative to sm ooth con gurations that belong to the same orbit) consistently with the gauge invariance of the physical H ilbert space, namely, via gauge xing.

In lattice QCD, gauge xing is a matter of choice, since it has no e ect on the gauge-invariant observables. Here, the ferm ion action is not gauge invariant. As a result, the gauge- xing m ethod is an integral part of the de nition of the theory. D i erent gauge- xing m ethods m ay in general give rise to di erent phase diagram s with different critical points. There is no guarantee that every gauge- xing m ethod will lead to a non-trivial continuum lim it, let alone to a chiral gauge theory.

Still, in order to make progress, one has to choose som e gauge-xingm ethod. V ink [22] proposed to use the laplacian gauge, where a maxim ally-sm ooth representative is chosen on each gauge orbit by globalm inim ization. The laplacian gauge is highly non-local, and this creates difculties both in the analytic and in the num erical study of this m ethod.

As discussed in detail in Sect. II, we build a local gauge-xing lattice action, that (a) has the unique absolute m inim um  $U_x$ ; = I, and (b) reduces to a covariant gauge-xing action in the classical continuum limit. O ur gauge-xing actions (eqs. (16-18) for the non-linear gauge, see II for the linear gauge) are clearly not the most naive discretizations of the corresponding continuum actions. Focusing for simplicity on the linear gauge

@ A = 0, let us exam ine w hat goes w rong w ith a naivelydiscretized gauge- xing action. W e thus consider the follow ing action

Note that  $g_0^{1}$  V<sub>x</sub>; reduces in the classical continuum limit to  $\ell$  A, as it should.

W hat is common to our gauge-xing action (s) and to the naive gauge-xing action eq. (4.3), is that they contain a longitudinal kinetic term . The trouble with  $S_{qf}^{naive}$  is that it supports a dense set of G ribov copies for the identity eld  $U_x$ ; = I. Each of these G ribov copies is a classical vacuum of  $S_{\rm G}$  +  $S_{\rm qf}^{\rm naive}.$  The superposition of contributions com ing from all these classical vacua, which cannot be calculated perturbatively, m ay ultim ately render the ferm ion spectrum vector-like. Even without ferm ions, stability of the classical potential is lost, and it is unclear whether the FM -FM D transition (associated with a divergent vector-eld correlation length) can be maintained in the weak-coupling lim it. (If the gauge- xing action in eq. (2.21) is replaced by  $S_{af}^{naive}$ , the resulting classical potential is identically zero. If we assume =  $0 (1=q_0^2)$ , which implies the presence of a tree-level mass term, one has  $V_{c1}^{naive} = F(g_0A)$  (com pare eq. (2.7)). The minimum of  $V_{cl}^{naive}$  is A = 0 for > 0, and  $A = = -g_0$  for < 0.)

We now demonstrate the existence of a dense set of lattice G ribov copies for the identity eld. Consider rst the U (1) case. The condition  $G_x = 0$  is satis ed if the imaginary part of  $U_x$ ; is zero everywhere. The latter is true if we consider only lattice gauge transform ations where  $g_x = 1$ . In other words, in spite of the presence of the gauge- xing action  $S_{gf}^{naive}$ , the G ribov copies of the identity eld still exhibit a local  $Z_2$  symmetry. (This is also true for the non-linear gauge, if one replaces  $G_x$  in eq. (4.3) by  $G_x^{n:1:} = (V_x; + V_x^2)$ .) An \elementary G ribov copy is created if we choose  $g_x = 1$  for  $x = x_0$ , and  $g_x = 1$  elsewhere. This clearly shows that the G ribov copies are local lattice artefacts.

A number of remarkable similarities draw us to say that the proliferation of Gribov copies is the spin-1 counter-part of the ferm ion doubling problem. In both cases, one deals with the discretization of a rst-order

di erential operator: in the spin $-\frac{1}{2}$  case, this is the D irac (or W eyl) equation; in the spin-1 case, this is a covariant gauge condition (see Sect. IIE). In both cases the problem arises when a non-compact continuum variable is replaced with a compact lattice variable: ferm ion doubling arises because, unlike in the continuum, the lattice momentum is periodic; in the spin-1 case, also the noncom pact continuum gauge eld is replaced with com pact group variables. In both cases, there are theorem s that establish an impasse under certain mild-looking conditions: the Karsten-Sm it [3] and Nielsen-Ninom iya [4] theorem s which predict ferm ion doubling, and Neuberger's theorem [13] which asserts that any BRST -invariant partition function must vanish identically. Finally, in both cases the solution is to reduce the symmetry of the lattice theory, by adding irrelevant terms to the naivelydiscretized action. In the case of W ilson ferm ions, this is the role of the W ilson term . As for our gauge-xing action (s), one can show (see II) that it is equal to the square of a discretized gauge condition, plus irrelevant term s. Thus, again, the irrelevant term s reduce the sym metry, this time by breaking explicitly BRST invariance.

### C.Other approaches

A di erent approach to the dynam ical problem s created by rough lattice gauge transform ations is to adopt a m ore sophisticated de nition for the e ective action. The prom inent representatives of this approach are the interpolation m ethod [24,25] and the overlap form alism [26].

In the interpolation m ethod, one constructs a continuum interpolating eld A<sup>cont</sup> = A<sup>cont</sup>(y;U<sub>x;</sub>), y 2 R<sup>4</sup>, for each con guration of the lattice gauge eld. The determ inant of the W eyl operator, ( $(2 + igA^{ont})$ ), is then de ned using a separate regulator. A sociated with the ferm ion regularization is a new cuto parameter, denoted generically f, which m ust be sent to in nity before the lattice spacing a is sent to zero. (A concrete m ethod [25] is to discretize the W eyl action on a ner lattice with a lattice spacing  $a_f$  a, using e.g. the ferm ion action of ref. [14] (eq. (3.1)). In this case  $f = a_f^{-1}$ .)

Consistent regularizations of the W eyl determ inant break gauge invariance for nite values of the cuto, even when the ferm ion spectrum is anom aly-free. Therefore, gauge-noninvariant counter-term s are needed in the interpolation m ethod too. (It has been proposed that gauge-noninvariant counter-term s m ay be avoided, if the real part of the e ective action is regulated separately from the in aginary part [27]. In spite of attem pts in this direction [25], it rem ains unclear w hether this procedure can be in plem ented beyond perturbation theory w ithout violating locality, and, eventually, unitarity.)

For given  $U_x$ ; -s, the interpolating eld assigns a local winding number to each hypercube (in the non-abelian case), or to each plaquette (in the abelian case). In the non-abelian case, this is the winding number of the con-

tinuum gauge transform ation de ned on the faces of the hypercube, that brings the interpolating eld to a prescribed axial gauge; in the abelian case, the continuum gauge transform ation is de ned on the perim eter of each plaquette. Now, a fundam ental requirem ent is that the ferm ion determ inant should be gauge invariant in the lim it f! 1. Gauge invariance can be established only if A cont (y) is globally bounded [24,25]. Gauge-invariance is therefore recovered in the lim it f! only on that portion of the lattice gauge orbit, where all the local winding numbers are zero [7]. The solution is to apply a gauge transform ation that sets all local winding num bers to zero before com puting the ferm ion determ inant (for simplicity we consider a trivial global topology). We note that the sm oothing gauge transform ation is non-local, and so a careful study of potential problem s associated with the in nite-volum e lim it is required.

In the overlap approach, while the real part of the e ective action is gauge invariant by construction, the imaginary part is not. Again, we expect that gaugenoninvariant counter-terms will be needed, starting at some nite loop order. Potentially severe problems with the overlap approach were pointed out in ref. [28]. A ccording to our judgement, subsequent works (including in particular ref. [29]) fail to address the issues raised in ref. [28]. Num erical evidence for the lack of gauge invariance (in the non-abelian case) has been found in ref. [30] (see g.1 therein).

## V.THE REDUCED MODEL

Returning to our approach, we consider in this section the limit of a vanishing gauge coupling. Since  $1=g_0^2$  is the coeccient of the plaquette action, the  $g_0 = 0$  limit constrains the lattice gauge eld to the trivial orbit.

The theory de ned by  $g_0 = 0$  limit is called the reduced model. If we use the vector picture, the reduced model is obtained by substituting  $U_x$ ;  $! \stackrel{y}{_{X}} \underbrace{\mathcal{O}}_{R}$  in the lattice action. The lattice gauge eld measure  $dU_x$ ; is replaced by  $d_x$ . (Alternatively, starting from the Higgs picture that already involves both  $U_x$ ; and  $_x$  (see Sect. IIB), one obtains the reduced model by simply setting  $U_{xi} = I$ .)

In the weak gauge-coupling limit, the transversal m odes are perturbative at the lattice scale. M any important features, including the ferm ion spectrum, are determ ined by the dynam ics of the longitudinal m odes. The utility of the reduced m odel is that it allows us to study the longitudinal dynam ics in isolation, without m aking any a-priori assumption. The reduced m odel accounts for dynam ical situations ranging from a divergent longitudinal correlation length, as in our approach, down to a very short correlation length. In this section we study a prototype reduced m odel. The entire dynam ical range is realized in di erent regions of its phase diagram. In Sect.VIwe discuss the e ects of the longitudinal dynam – ics on the ferm ion spectrum, rst in general term s and then in our approach.

#### A. The phase diagram

In this subsection (and the next one) we discuss the reduced model related to the lattice action of Sect. IIB, for  $_{\rm X}$  2 U (1). Since eq. (2.3) is written in the Higgs picture, the reduced model is obtained by setting U<sub>x;</sub> = 1. This leads to the action

Our rst task is to derive the m ean-eld phase diagram in the (~; )-plane. This phase diagram is in fact generic, and pertains also to the m ore relevant theories de ned in Sect. IIE and in II.

Let us rst consider the ordinary VEV, v, as an order parameter (or the staggered VEV  $v_{\rm A\,M}$ ). An additional order parameter will be introduced shortly. By de nition

where  $_{x} = (1)^{x}$ . For  $\sim = 0$ , we recover the familiar non-linear sigm a model. On the -axis there is a symmetric (PM) phase for j j < c, a ferrom agnetic (FM) phase for > c, and an antiferrom agnetic (AM) phase for < c. The eld rede nition  $_{x} ! x x$ maps to , thus implying a symmetry of the -axis.

W e now extend the discussion to the full (~; )-plane. M ean-eld approximation in d-dimensions yields the following equation for the FM -PM line

The FM  $\rightarrow$ PM and AM  $\rightarrow$ PM transitions are continuous. The symmetry of the -axis extends to ~  $\stackrel{\leftarrow}{\bullet}$  0. Under the eld rede nition \_x ! \_x , the point (~; ) is mapped in four dimensions to (~; 32~). This implies that the linear equation

de nes a sym m etry line of the phase diagram. The FM – PM and AM –PM lines m eet in the second quadrant, at the point ( $\frac{c}{7}$ ;  $\frac{16}{7}$ ) on the sym m etry line. It can be shown that, beyond this point, the sym m etry line is a rst-order transition line separating the FM and AM phases [31].

In condensed m atter physics, it is well-known that spin m odels with competing interactions tend to develop a ground state that breaks translation and rotation invariance. If a sm all antiferrom agnetic interaction is added to a dom inant ferrom agnetic one, the spin orientation of the ground state will rotate slow ly with a wave vector  $q \in 0$  (see ref. [32] for a recent review).

In the reduced model de ned by eq. (5.1), competing interactions occur when and ~ have opposite signs. In order to look for a similar phenom enon, we introduce the m ean-eld ansatz

W e assume 0 q < 2. A non-zero q signals the spontaneous breaking of translation and rotation invariance. M ore precisely, translation invariance is broken in the direction de ned by q, but it remains unbroken in the transversal directions. In condensed m atter, phases with a non-zero q are known as helicoidal-ferrom agnetic ones. H ere, the helicoidal-ferrom agnetic phase of the reduced m odel is the  $g_0 = 0$  boundary of the FM D phase of the full theory (see Sect. IIC), and the name FM D will be used both in the full theory and in the reduced m odel.

A simple mean-eld method is based on a factorized probability measure (see e.g. ref. [33]). For the FM -PM transition, one can use the following factorized probability measure

In order to accommodate a non-zero  $\mathbf{q}$  , we generalize this to

O ne has  $\text{hli}_p = 1$  and  $e^{i_x}_p = ve^{iq_x}$  (in agreement with eq. (5.7)). Because of its factorized nature, the q - dependence of P (<sub>x</sub>) a ects only the internal energy, but not the entropy. Introducing the notation  $S_H^0 = \int_x H_x$ , we nd

where the function F is de ned in eq. (2.8). While the choice of the factorized probability measures eqs. (5.8) and (5.9) is somewhat arbitrary, the internal energy (5.10) is a universal feature of any mean-eld approximation for  $S^0_{\rm H}$ .

If we consider a point in the phase diagram well to the right of the FM -PM line, the value of v is nite in lattice units. Making the self-consistent assumption that q is small, the location of the FM -FM D transition can be determ ined by m inimizing the internal energy with respect to q. Remarkably, the q-dependent part of the internal energy coincides with the classical potential (2.7), if we make the identication  $g_0A \$  q . Consequently, there is complete agreement between the mean- eld properties of the FM -FM D transition in the reduced model, and the classical properties of the FM D transition in the  $g_0 \in 0$ 

theory. The mean-eld location of the FM FM D transition is = 0. For > 0 one is in the FM phase, whereas for < 0 one is in the FM D phase. Close to the FM FM D line, q is given by eq. (2.10) where  $g_0A$ is replaced by q (after this replacement  $g_0$  drops out, and one has  $q^2 = = 2^{-2}$  for a small negative ). The FM -FM D line ends when it hits the FM -PM line. The multi-critical point where the PM, FM and FM D phases meet is known as a Lifshitz point [34]. Its mean-eld value is  $(-\frac{6}{9}; 0)$ . (Lifshitz points exhibit rich critical behaviour. This was discussed recently in a eld theoretic context by J.K uti [35].)

The remaining features of the mean-eld phase diagram are as follows (see FIG.1). The transformation  $_x$  !  $_x$  maps q to q + . This implies the existence of a second FMD region (and another Lifshitz point) below the symmetry line in the fourth quadrant. The PM -FMD line, separating the param agnetic phase from the FMD phase, can be determined by rst minimizing the (internal) energy with respect to q, and then the (free) energy with respect to v. The PM phase occupies a bounded region in the phase diagram. The two FMD regions above and below the symmetry line belong to a single FMD phase. The PM -FMD line lies on an ellipse, with the FM -PM and AM -PM lines tangent to it at the two Lifshitz points. A more detailed mean-eld calculation will be presented elsewhere [31].

The m ean-eld ansatz (5.7) in plies the simultaneous breaking of the internal U (1) symmetry, as well as of rotation and translation invariance. We believe that one cannot break translation invariance without at the same time breaking an internal symmetry. However, one can conceive of a phase (denoted PM D) where only rotation symmetry is broken, while the internal symmetries as well as translations are unbroken. The order parameter for a PM D phase of the reduced model is the expectation value of the composite vector eld (com pare eq. (2.18))

At the m om ent, how ever, we have no evidence for a PM D phase.

The phases of the reduced m odel are depicted in TA-BLE I. The order parameter  $v_{\rm H}$  is dened as  $v_{\rm H}$  =  $_{\rm x}$  e  $^{\rm iq~x}$ . Note that in the special case q = (0;0;0;0) (q = ( ; ; ; )),  $v_{\rm H}$  coincides with v ( $v_{\rm A\,M}$ ). In this paper we usually do not distinguish between v and  $v_{\rm H}$ , since the correct meaning can be understood from the context. However, this distinction is in portant in numerical simulation. The value of q, to be used in the measurem ent of  $v_{\rm H}$ , can be determined for example by measuring  $\frac{y}{x}$   $_{\rm x+}$   $^{\rm x}$  and extracting its phase.

The relation between the  $(\sim; )$ -phase diagram of the reduced model and the  $(\sim; ;g_{0})$ -phase diagram of the full theory is the following. In the U (1) case, the sym - m etric (PM) phase is the boundary of a C oulom b phase, and the broken (FM or AM) phase is the boundary of a Higgs phase. In the non-abelian case, the PM, FM and

AM phases correspond to the boundary of a single H iggscon nem ent phase. Finally, the helicoidal-ferrom agnetic (FM D) phase of the reduced m odel is the boundary of the FM D phase of the full theory.

In the  $g_0$  ! 0 lim it of the full theory, we nd (approximately) massless gauge bosons close to the FM -FM D line, as well as close to the PM -FM line, and in the entire PM phase. An interesting observation is that, even without fermions, if we want to study a Lorentz gauge- xed Y ang-M ills theory on the lattice, then the appropriate critical line is the FM -FM D line. The reason is that, in order to keep the longitudinal kinetic term in the tree-level action, ~ must scale like  $1=g_0^2$  (see Sect. II). In the large- lim it, a PM phase does not exist, and criticality can only be achieved by approaching the FM -FM D line.

## B.The weak-coupling expansion in the reduced model

In view of the properties of the weak-coupling expansion in the full theory (Sect. II), and in particular eq. (2.12), one expects that 1=~ will play the role of a coupling constant in the reduced model. We will now demonstrate this explicitly. We do not carry out here any detailed calculations that require the full lattice Feynm an rules. Therefore, we work in the continuum approxim ation, i.e. we extract from the lattice action the marginal and relevant terms, that control the critical behaviour in the vicinity of the gaussian critical point 1=~ = 0.

The weak-coupling expansion is facilitated by expanding around a broken symmetry vacuum. We rst introduce the Goldstone boson (GB) eld  $_x$  via  $_x = e^{i \times}$ . (This classical expansion is consistent with the meaneld ansatz (5.7), because v ! 1 for ~! 1 .) Rescaling !  $(1=2^{\circ})$  we nd, in the continuum approximation, the following GB lagrangian

Eq. (5.12) is valid on the FM side of the transition line. On the FMD side, one rst looks for the classical vacuum by assuming = q x and minimizing for q. The result is the same as in the mean-eld approximation. The weak-coupling expansion on the FMD side is then de ned via  $! q x + (1 = 2^{-})$ .

W e will consider here only the FM side. Taking the Fourier transform of the bilinear part of the lagrangian, we nd the following GB propagator

where m $_0^2 = -$ . A nalytical continuation to M inkowski space shows the existence of a positive-residue pole at  $p_M^2 = 0$ , and a negative-residue (ghost) pole at  $p_M^2 = m_0^2$ . These poles m erge into a quartic singularity in the lim it

 $m_0^2$  ! 0. The continuum limit of the reduced model is therefore not unitary. (In Sect. VIB we discuss the interaction of the GB eld with fermions. The crucial requirement is that the non-unitary GB sector, which accounts for the two unphysical polarizations of the gauge bosons, will decouple from the fermions in the continuum limit. This decoupling is discussed in detail in ref. [36].)

Because of the quartic kinetic term in the GB lagrangian, the canonical dimension of the GB eld (x) is zero. The GB lagrangian is invariant under the shift sym – metry (x)! (x) + const, which forbids the appearance of non-derivative term s under renorm alization. In addition, the GB lagrangian is invariant under the discrete sym metry (x)! (x). Eq. (5.12) is the most general renorm alizable lagrangian allowed by these sym metries.

W hat marks the Feynman rules of the GB lagrangian, is that one derivative acts on every line attached to a vertex. The derivatives acting on the two ends of each internal line e ectively cancel one factor of  $1=p^2$  in the propagator. The result is that the UV power counting of the GB m odel is the same as in an ordinary <sup>4</sup> theory. If we ignore the vector index carried by the partial derivatives, one can match each term in the GB lagrangian with a corresponding term in the <sup>4</sup> lagrangian according to the rule  $\ell$  !

In the <sup>4</sup> theory, at the one loop level only the m ass term is renorm alized, but not the kinetic term. By analogy, in the GB lagrangian only ((l),  $l^2$ , but not (2),  $l^2$ , is renorm alized at the one-loop level. The induced one-loop ((l),  $l^2$ -term has a positive sign. This in plies

(N ote that the coe cient of  $((l)^2)$  in eq. (5.12) is  $=\sim$ .) The dimension of the positive constant c is two. Its numerical value, which is O ( $l=a^2$ ), has to be determined by a lattice calculation. Finally, as in the <sup>4</sup> theory, the one-bop beta-function is determined by the vertex renormalization, and is found to be positive. Explicitly

where is the UV cuto (the inverse lattice spacing in a lattice calculation).

### C . In fra-R ed divergences of the critical theory

If we tune to  $_{c:l:}(\sim)$ , the quadratic kinetic term in eq. (5.13) vanishes, and the renorm alized G B propagator reads

where Z accounts for the wave-fuction renormalization. This quartic propagator leads to IR divergences in four dimensions, like massless bosons with an ordinary kinetic term do in two dimensions. The IR divergences of massless G oldstone bosons lead to the restoration of continuous symmetries in two dimensions [37]. Only symmetric observables, which are invariant under all the continuous symmetries, can have a non-zero value. There are theorem s [38{40}] that guarantee the IR - niteness of the symmetric observables.

Here the quartic propagator (5.16) does not characterize a whole phase, but only the FM -FM D line itself. The order parameter  $v_{\rm H}~({\rm or}~v)$  dips close to the FM -FM D line, and vanishes on that line in several (m ay be in all) interesting cases [31,36]. The theorems on the niteness of symmetric observables, in particular ref. [40], generalize to four dimensions. Also, as in two dimensions, the predictions of the weak-coupling expansion are offen valid, if interpreted carefully [41]. This will be important in Sect. VIB.

### D.Realistic reduced models

The key features of the sim pli ed reduced model studied in this section extend to the realistic reduced models, de ned from the (gauge-xing and ghost) action of Sect. IIE for the non-linear gauge, or the action of II for the linear gauge. This includes the qualitative structure of the phase diagram and in particular the FM and FM D phases, the gaussian critical point at  $\sim = 1$ , and the IR divergences on the FM -FM D line.

Particularly interesting are the critical FM -FM D theories in the reduced m odels that correspond to the linear gauge (A = 0. In the abelian case, the linear-gauge reduced m odel leads to a free theory with a  $1=(p^2)^2$  propagator. The properties of this critical theory are analogous to the spin-wave phase of a two-dimensional abelian theory. This will be discussed in detail elsewhere [31,36]. The critical theory for a non-abelian gauge group was investigated by H ata [42] in the continuum approximation. H is main result is that, like non-abelian sigm a m odels in two dimensions, these four-dimensional non-linear m odels are asymptotically-free. It will be interesting to investigate the signi cance of this result for the construction of gauge- xed non-abelian lattice theories via our approach.

#### VI.FERM IONS IN THE REDUCED MODEL

In a manifestly gauge invariant theory like QCD, the ferm ion spectrum can be read o from the lattice action by going to the free eld limit  $g_0 = 0$ . Here, the ferm ion action is not gauge invariant (in the vector picture), and the limit  $g_0 = 0$  gives rise to an interacting theory, namely, to the reduced model. We identify the elementary ferm ions of a general lattice gauge theory with the independent ferm ionic massless poles of the associated reduced model. (If the ferm ion action is gauge invariant, any x-dependence of its reduced-model form can be eliminated by a eld rede nition.) It is justified to

determ ine the matter spectrum by setting  $g_0 = 0$ , since, in a scaling region, the transversal degrees of freedom are perturbative at the lattice scale.

## A . The robustness of the N o-G o theorem ${\rm s}$

Let the gauge eld belong to a Lie group G. By construction, the associated reduced model has a global G – sym metry, denoted  $G_L$ , that acts on  $_x$  by left multiplication. (The reduced model is obtained from the vector picture via  $U_x$ ; !  $\stackrel{y}{_x}_{x+}$ , and the product  $\stackrel{y}{_x}_{x+}$  is invariant under left multiplication. Notice also that the gauge-invariant Higgs picture can be obtained by gauging the  $G_L$  symmetry of the reduced model.) Now, we dem and the existence of massless vector bosons in the scaling region, which can be identied with the gauge bosons of the target continuum theory. These vector bosons couple to the Noether current associated with the  $G_L$  symmetry. Thus, assigning the fermions to representations of  $G_L$  determines whether the continuum limit is chiral or vector-like.

In previous chiral ferm ion proposals, it was usually attempted to take the continuum limit in a symmetric phase, where the G<sub>L</sub> symmetry is not broken spontaneously. (Physical gauge invariance is restored dynam ically in a symmetric phase, when we consider the full  $g_0 \in 0$  theory. This means that there are no light unphysical states, whose decoupling in the continuum lim it requires ne-tuning. Since the VEV of the x eld is zero, the physics in a symmetric phase is more easily accounted for in the gauge-invariant Higgs picture.) In a symmetric phase, the uctuations of the  $_{\rm x}$  eld are usually not controlled by any sm all parameter. As a result, non-perturbative m ethods had to be invoked in order to determ ine the ferm ion spectrum . W here available, it was always found that the true ferm ion spectrum is vectorlike (see ref. [7,9,43] for details).

W e have discussed this phenom enon in ref. [5,7], and argued that it has a simple physical explanation. Here we can only outline the key considerations leading to this conclusion, and we refer the reader to ref. [5,7] for the details. One starts with the observation that, in a symmetric phase of the reduced model, there are generically no m assless scalars. Therefore, the only m assless particles (if any) are ferm ions. (It could be [43] that no massless fermions are present unless a mass term if ne-tuned. Since we are in symmetric phase, a massless fermion obtained by ne-tuning is necessarily a D irac ferm ion.) Now, in four dimensions, there are no renorm alizable interactions involving only ferm ion elds. The continuum lim it de ned by a generic point inside a sym m etric phase is therefore a theory of free massless fermions (if it is not empty). One can then construct an e ective lattice ham iltonian for the ferm ions, that satis es all the assumptions of the Nielsen-Ninomiya theorem . (The effective ham iltonian is de ned as the  $p_0 = 0$  lim it of the

inverse of a suitable two-point function.) We refer here in particular to the analytic structure near the zeros of the e ective ham iltonian, and to the existence of a sm ooth interpolation throughout the rest of the Brillouin zone. This leads to the conclusion that the ferm ion spectrum is vector-like in a symm etric phase, provided the underlying theory is local. (In the case of a non-local theory one expects violations of unitarity and/or Lorentz invariance, see ref. [7] for references to the original literature.)

This impasse extends, by continuity, to the ferm ion spectrum on any phase transition line that separates a symmetric phase from a broken phase. In particular, even though the gauge boson mass vanishes on the PM – FM line, we do not expect to nd a chiral gauge theory by taking the continuum limit at the PM – FM line. The ferm ion spectrum will be vector-like if the PM – FM line is approached from the PM phase. If we approach the PM – FM line from the FM phase, we can only obtain a mirror ferm ion m odel [44], but we cannot decouple the unwanted mirror ferm ions.

#### B.Evading the No-Go theorem s

Let us now investigate what changes when the continuum limit is taken at the FM -FM D line. We will consider the simplest case, namely a U (1) gauge group with the gauge-xing action pertaining to the linear gauge, cf. II. A smentioned in Sect. V D, the properties of the critical FM -FM D theory are analogous to the spin-wave phase of a two-dimensional abelian theory.

We go from (the vector picture of) the full theory to the reduced m odel according to the rule  $U_x$ ; !  $y_{x + ^{, }}$ . The ferm ion action eq. (3.1) becomes (we use the two-component notation)

The ferm ion variables in eq. (6.1) are neutral with respect to G  $_{\rm L}$  . If, instead, we use the charged variables  $_{\rm c}$  =  $\,$  , the ferm ion action reads

A coording to the rules of the weak-coupling expansion (see Sect.VB), the tree-level ferm ion action is obtained by substituting the classical vacuum  $_x = 1$ . Using eq. (62) for de niteness, we get

In the lim it w = 0, only the kinetic term  $c_{c}$  is left. Thus, the w = 0 action exhibits the infamous doubling, with sixteen W eyl ferm ions altogether. (Each

ferm ion is associated with a point in the Brillouin zone, whose lattice momentum components are equal to either 0 or .) Since we take w = O(1), the MW term elim inates the doublers, and the pole in the tree-level ferm ion propagator describes a single W eyl eld (see Sect. III).

Had we started from the ferm ion action written in terms of the neutral variables (eq. (6.1)), the substitution  $_x = 1$  would lead to a tree-level action identical to eq. (6.3), but with the neutral eld replacing the charged eld  $_c$ . Now, deep in the FM phase this makes no di erence, because the G  $_L$  sym m etry is broken anyway by the  $_x$ -VEV, which is O (1) in lattice units. How - ever, the G  $_L$  sym m etry is restored right on the FM -FM D line [31,36]. It is therefore a meaningful (and im portant) question to ask what are the G  $_L$  -quantum num bers of the m assless ferm ions.

The fact that one cannot simply read o the quantum numbers of one-ferm ion states from the tree-level action, is a consequence of the IR-divergent nature of the GB propagator,  $1=(p^2)^2$ . The way to proceed is to examine a family of fermionic two-point functions n = (n) (yn). Assuming all mass parameters have been tuned to their critical values, n will in general contain terms proportional to  $(p)^{-1} \log^{k} (p^{2})$  for any k. The presence of logarithm ic terms (which typically lead to power law corrections when summed over all orders) m eans that the operator " does not create a oneparticle state [41,43]. Only when there are no logarithm ic corrections do we have a simple massless pole, and the quantum numbers of the intermediate one-fermion state must coincide with the quantum numbers of the interpolating ferm ion eld.

The fermion spectrum in the reduced model can be studied in detail using the weak-coupling expansion. W hile the actual calculations require a substantial am ount of work, the conclusions are robust, as they really depend on universal properties of the low energy e ective (continuum) lagrangian. A one-loop calculation, which is also supported by num erical simulations, w illbe presented elsewhere [36]. Here we w ill list the key results, as they apply to the MW fermion action.

Logarithm ic terms are absent only for n = 1, namely in the two-point function  $h_c_c$ i. Consequently, the massless ferm ion has the quantum numbers of the  $_c$  eld. The latter is charged, which m eans that the  $_c$  W eyl ferm ion will couple to the transversal gauge eld, when the latter is turned on.

As can be expected on general grounds (see Sect. III), divergent M a prana-like m ass term s are induced at the one-loop level. These m ust be cancelled by suitable counter-term s, to m aintain the m asslessness of each chiral ferm ion.

W hen the Majorana-like mass counter-terms are tuned to their critical values, the unphysical GB eld decouples from the  $_{\rm c}$ -ferm ions. The continuum limit is a direct product of (in general) several free theories, one associated with the unphysical GB eld, and one associated with every species of chiral  $_{\rm c}$ -ferm ions.

This establishes an agreem ent between the predictions of the weak-coupling expansion in the full theory and in the reduced model, thus supporting the consistency of our approach. The properties of the reduced model are true for an arbitrary ferm ion spectrum, and this is consistent with the vanishing of the anomaly in the absence of a transversal gauge ekd.

In comparison with previous chiral ferm ion proposals (see Sect. VIA) we note two key di erences that allow us to escape from a similar impasse. First, one may worry that the need to tune mass counter-term s may indicate that we got the wrong spectrum (e.g. Dirac instead of Weyl ferm ions). Now, when the (Majorana-like) mass counter-term s are not tuned to their critical values, the ferm ions remain coupled to the IR-singular GB eld in the low-energy lim it. Due to potential IR divergences, it is not at all clear that (m assive) one-ferm ion states could be consistently de ned in this case, nor that such states would have well-de ned G  $_{\rm L}$  -quantum numbers. The o critical theory remains to be investigated in the future. However, in view of the above IR subtleties, the general conclusion is that by considering the role of ferm ion m ass perturbations, one does not end up with an argument against the existence of a chiral spectrum at the critical point. (See also the discussion of ferm ion mass counterterm s in Sect. III.)

The other key di erence is that the continuum limit is now taken at the phase transition separating two broken phases of the reduced model. O the FM -FM D line (on both sides) the  $G_L$  symmetry is broken spontaneously, and all asymptotic states do not have well-de ned  $G_L$  quantum numbers. On the FM -FM D line itself, the  $G_L$ symmetry is restored, and the question arises whether we do not run into the same old con ict with the No-G o theorem s. The answer is contained in the analytic structure discussed above. Thanks to the presence of the highly IR-singular GB eld, a zero in the inverse propagator does not necessarily in ply the existence of a one-ferm ion state with the same quantum numbers. As an illustration, consider the four-component unit-charge eld \_c, whose left-handed component is  $P_L_c = c$ ,

and whose right-handed component is  $P_R_c = {}^2_c$ . If we consider the inverse two-point function of  $_c$ , we may erroneously conclude that it interpolates a massless D irac ferm ion. In reality, only the left-handed channel of this inverse propagator has a simple zero p, in plying the existence of a unit-charge left-handed ferm ion. In the right-handed channel, one nds a  $p \log (p^2)$  correction in the one-loop approximation, which in plies the absence of a right-handed ferm ion with the same charge.

## VII.OPEN QUESTIONS

In Sect. IIE, the criterion for xing the counter-term s was to enforce BRST invariance (and, hence, unitarity) order by order. This perturbative prescription is incom – plete. Ultimately, the counter-term s should be determined by a non-perturbative method. To rigorously dene the continuum limit, one has to specify a trajectory in the Higgs (or Higgs-con nement) phase, that ends at the gaussian point  $g_0 = 1 = - 0$  on the FMD boundary. (See Sect. V A for the phase diagram.) In addition, one has to construct a BRST operator, and prove its nilpotency in the continuum limit. Enforcing BRST invariance should also lead to the restoration of full SO (4) invariance, because the marginal SO (4)-breaking operators violate the BRST symmetry too.

We comment that similar problems are encountered in lattice QCD with W ilson fermions, where the axialavour symmetries are broken on the lattice, in analogy with the BRST symmetry in our gauge-xing approach. When using W ilson fermions, tuning is required not only at the level of the lattice action, but also in the construction of renorm alized operators with well dened axial- avour transform ation properties [45]. This is analogous to the problem of de ning BRST-invariant operators in our gauge-xing approach. (In QCD, the netuning problem can be solved using domain-wall fermions [46[48]. Whether a similar solution exists for the tuning problem in the gauge-xing approach, is an interesting question.)

O ur gauge- xing form ulation can be tested by applying it to asymptotically-free gauge theories which are not chiral. In particular, in the absence of ferm ions, one should study whether the con ning behaviour and the mass gap of Y ang-M ills theories are reproduced. O ne possibility is that the FM D transition becomes weakly rst-order due to non-perturbative e ects. This scenario is favourable, at least from the point of view of num erical simulations. A nother possibility is that the correlation length of the vector eld strictly diverges at the FM D transition, already for  $g_0 \notin 0$ . In this case, a consistent continuum lim it may exist provided all the massless excitations are unphysical.

## V III. C O N C LU S IO N S

In a regularized chiral gauge theory, the longitudinal modes of the gauge ekd couple to the fermions. Before the regularization is removed, there are violations of gauge invariance even if the fermion spectrum is anom aly-free. W hen we use the lattice regularization, the longitudinal modes should decouple in the continuum limit, but it may be too much to expect for exact decoupling when the lattice spacing is still nite.

The gauge-xing approach aims to decouple the longitudinal modes in the continuum limit. In this paper we have discussed how the gauge- xing approach may be realized, thus making the rst step of a system atic investigation of the gauge xing approach. We have constructed a lattice gauge- xing action that has a unique classical vacuum. The gauge- xing action contains a longitudinal kinetic term, and leads to a renorm alizable weak-coupling expansion, which is valid even if the lattice ferm ion action is not gauge invariant. We have argued that the continuum elds, needed to describe the scaling behaviour, are in one-to-one correspondence with the poles of the tree-level lattice propagators. This should accom m odate any consistent theory, including anom alyfree chiral gauge theories.




FIG.1. Mean-eld phase diagram. See TABLE I for the de nition of the various phases.
