E lectrom agnetic Splittings and Light Quark M asses in Lattice QCD

A bstract

A method for computing electron agnetic properties of hadrons in lattice QCD is described and prelim inary numerical results are presented. The electrom agnetic eld is introduced dynamically, using a noncompact formulation. Employing enhanced electric charges, the dependence of the pseudoscalar meson mass on the (anti)quark charges and masses can be accurately calculated. At = 5:7 with W ilson action, the $^+$ 0 splitting is found to be 4:9(3) M eV.U sing the measured K 0 K $^+$ splitting, we also nd m $_u$ =m $_d$ = :512(6). System atic errors are discussed.

If a fundam ental theory of quark m asses ever em erges, it m ay be as im portant to resolve the theoretical uncertainty in the light quark masses as it is to accurately measure the top quark mass. Moreover, an accurate determ ination of the up quark mass might nally resolve the question of whether nature avoids the strong CP problem via a massless up quark. The particle data tables [1] give wide ranges for the up ($2 < m_u < 8$ M eV) and down (5 < m_d < 15 M eV) quarks, while lowest order chiral perturbation theory [2, 3, 4] gives $m_u = m_d = 0.57$ 0.04. Num erical lattice calculations provide, in principle, a very precise way of studying the dependence of hadron masses on the lagrangian quark mass param eters [5]. How ever, the contribution to hadronic mass splittings within isom ultiplets from electrom agnetic (virtual photon) e ects is com parable to the size of the up-down quark m ass di erence. Thus an accurate determ ination of the light quark m asses requires the calculation of electrom agnetic e ects in the context of nonperturbative QCD dynam ics. In this letter, we discuss a method for studying electrom agnetic elects in the hadron spectrum. In addition to the SU (3) color gauge eld, we introduce a U (1) electrom agnetic eld on the lattice which is also treated by M onte Carlo m ethods. The resulting SU (3) U (1) gauge con gurations are then analyzed by standard hadron propagator techniques.

The small size of electrom agnetic mass splittings makes their accurate determ ination by conventional lattice techniques di cult if the electrom agnetic coupling is taken at its physical value. One of the main results of this paper is to demonstrate that calculations done at larger values of the quark electric charges (roughly 2 to 6 times physical values) lead to accurately measurable electrom agnetic splittings in the light pseudoscalar meson spectrum, while still allow ing perturbative extrapolation to physical values.

The strategy of the calculation is as follows. Quark propagators are generated in the presence of background SU (3) U (1) elds where the SU (3) component represents the usual gluonic gauge degrees of freedom, while the U (1) component incorporates an abelian photon eld (with a noncompact gauge action) which interacts with quarks of speci ed electric charge. All calculations are performed in the quenched approximation and C oulom b gauge is used throughout for both components. Quark propagators are calculated for a variety of electric charges and light quark mass values. The gauge congurations were generated at

= 5:7 on a 12^3 24 lattice. 200 con gurations each separated by 1000 M onte C arlo sweeps were used. In the results reported here, we have used four di erent values of charge given by $e_q = 0, -0.4, +0.8$, and -1.2 in units in which the electron charge is $e_q = \frac{p}{4} = 137 = 3028 :::.$

For each quark charge we calculate propagators for three light quark m ass values in order to allow a chiral extrapolation. From the resulting 12 quark propagators, 144 quark-antiquark com binations can be form ed. The m eson propagators are then com puted and m asses for the 78 independent states extracted.

Once the full set of m eson m asses is computed, the analysis proceeds by a combination of chiral and QED perturbation theory. In pure QCD it is known that, in the range of m asses considered here, the square of the pseudoscalar m eson m ass is quite accurately t by a linear function of the bare quark m asses[6]. We have found that this linearity in the bare quark m ass persists even in the presence of electrom agnetism. For each of the charge combinations studied, the dependence of the squared m eson m ass on the bare quark m ass is well described by lowest order chiral perturbation theory. Thus we write the pseudoscalar m ass squared as




Figure 1: The mass squared, M $_{\rm P}^2$, (in GeV²) for neutral pseudoscalar meson versus lattice bare quark masses m $_{\rm q}$ + m $_{\rm q}$ (in GeV) is shown for various quark charges $e_{\rm q} = 0.0$; 0:4;0:8 and 12.

where $e_q; e_q$ are the quark and antiquark charges, and $m_q; m_q$ are the bare quark m asses, de ned in terms of the W ilson hopping parameter by $\begin{pmatrix} 1 & c \\ & c \end{pmatrix}$ =2a. (Here a is the lattice spacing.) Because of the electrom agnetic self-energy shift, the value of the critical hopping parameter must be determined independently for each quark charge. This is done by requiring that the mass of the neutral pseudoscalar meson vanish at = c, as discussed below. The results for the neutral pseudoscalars are shown in Figure 1. For the physical values of the quark charges, we expect that an expansion of the coe cients A and B in (1) to rst order in e^2 should be quite accurate. For the larger values of QED coupling that we use in our num erical investigation, the accuracy of rst order perturbation theory is less clear: in fact, a good t to allour data requires sm allout nonzero term s of order e^4 , corresponding to two-photon diagram s. C om parison of the order e^4 term s with those of order e^2 provides a quantitative check on the accuracy of QED perturbation theory. We have tried including all possible e^4 term s in the t, but only retained those which signi cantly reduce the 2^2 per degree of freedom.

A coording to a theorem of D ashen [7], in the lim it of vanishing quark mass, the value of m_P^2 is proportional to the square of the total charge. Thus, we have also allowed the values of the critical hopping parameters for each of the quark charges to be t parameters, requiring that the mass of the neutral mesons vanish in the chiral lim it. Thus A takes the form A ⁽¹⁾ (e_q + e_q)² to order e². (O rder e⁴ terms were not found unnecessary to t the

data.) The coe cient B in (1) which parametrizes the slope of m_p^2 may also be expanded in perturbation theory. Of the vepossible e^4 terms in B⁽²⁾ ($e_q; e_q$), only the $e_q^4; e_q^3 e_q$ and $e_q^2 e_q^2$ terms were found to improve the ². The coe cients in A and B, along with the four values of _c for the four quark charges, constitute a 12-parameter t to the meson mass values.

Before discussing the numerical results, we brie y describe the formulation of lattice QED which we have employed in these calculations. The gauge group in this case is abelian, and one has the choice of either a compact or noncompact formulation for the abelian gauge action. Lattice gauge invariance still requires a compact gauge-ferm ion coupling, but we are at liberty to employ a noncompact form of the pure photon action S_{em} . Then the theory is free in the absence of fermions, and is always in the noncompact noncompact. We use QCD lattice congurations which have all been converted to C oulom b gauge for previous studies of heavy-light mesons. C oulom b gauge turns out to be both practically and conceptually convenient in the QED sector as well.

For the electrom agnetic action, we take

with e the bare electric coupling, n speci es a lattice site, r the discrete lattice rightgradient in the direction and A_n takes on values between 1 and +1. Electrom agnetic con gurations were generated using (2) as a Boltzm ann weight, subject to the linear C oulom b constraint

with r a lattice left-gradient operator. The action is G aussian-distributed so it is a trivial matter to generate a completely independent set in momentum space, recovering the real space C oulom b-gauge con guration by Fast Fourier transform. We will be global gauge freedom remaining after the condition (3) is imposed by setting the p = 0 mode equal to zero for the transverse modes, and the p = 0 mode to zero for the C oulom b modes on each time-slice. (This implies a specie treatment of nite volume e ects which will be discussed below). The resulting C oulom b gauge eld A_n is then promoted to a compact link variable $U_n^{em} = e^{-iqA_n}$ coupled to the quark eld in order to describe a quark of electric charge qe. Q uark propagators are then computed for propagation through the combined SU (3) U (1) gauge eld.

Next we discuss the evaluation of critical hopping parameters for nonzero quark charge. The self energy shift induced by electrom agnetic tadpole graphs m ay be computed perturbatively. The one-loop tadpole graph is (for W ilson parameter r=1 and at zero m om entum in C oulom b gauge)

where k are the discrete lattice m om entum components for a L⁴ lattice and $\hat{k} = \sin (k = 2)$. This is entirely analogous to the well known QCD term m_{QCD} [8]. The mass shift is then given by the sum over multiple insertions at the same point, which exponentiates the oneloop graph. The usual strong QCD corrections at = 5:7 are given in this approximation by an overall multiplicative factor of $1=(8 \ c^{e=0})$. Together this produces a shift of the critical inverse hopping parameter of

The contribution from the conventional one loop radiative correction graph is found to be about one third the size of the tadpole. In Table 1, our num erical results for $_{\rm c}$ and the associated m $_{\rm c}$ is compared with the results using only the perturbative tadpole resummed result for the EM interactions(5).

For charge zero quarks, propagators were calculated at hopping parameter 0.161, 0.165, and 0.1667, corresponding to bare quark masses of 175, 83, and 53 MeV respectively. The gauge congurations are generated at = 5:7, and we have taken the lattice spacing to be a $^{1} = 1:15$ GeV as determined in Ref. [9]. A fter shifting by the improved perturbative values listed in Table 1, we select the same three hopping parameters for the nonzero charge quarks.

Because this shift turns out to be very close to the observed shift of $_{\rm c}$, the quark m asses for nonzero charge are nearly the same as those for zero charge. For all charge combinations, m eson m asses were extracted by a two-exponential t to the pseudoscalar propagator over the time range t = 3 to 11. Sm eared as well as local quark propagator sources were used to improve the accuracy of the ground state m esons m asses extracted. E mors on each m ass value are obtained by a single-elimination jackknife. The resulting data is tted to the chiral/QED perturbative form ula (1) by ² m inimization. The tted parameters are given in Table 2. E mors were obtained by perform ing the t on each jackknifed subensem ble.

A side from very small corrections of order $(m_d m_u)^2$, the ^{+ 0} m ass splitting is of purely electrom agnetic origin, and thus should be directly calculable by our method. Because we have used the quenched approximation, uu and dd mesons do not mix. The neutral pion mass is obtained by averaging the squared masses of the uu and dd states. (In fullQCD the uu and dd mix in such a way that the neutral octet state remains a G oldstone boson of approximate chiral SU (3) SU (3). By averaging the squared masses of uu and dd in the quenched calculation, we respect the chiral symmetry expected from the full theory. By contrast, linear averaging of the masses would give a ⁰ mass squared nonanalytic in the quark masses). Thus, to zeroth order in e^2 , the terms proportional to quark mass [2] cancel in the di erence m². m²₀. This di erence is then given quite accurately by the single term

U sing the coe cients listed in Table 2, and the experimental values of the 0 ; K 0 ; and K ${}^{+}$ m asses, we may directly solve the resulting three equations for the up, down, and strange m asses. The ${}^{+}$ 0 splitting may then be calculated, including the very sm all contributions from the order ${}^{2}m$ g term s. W e obtain

com pared to the experim ental value of 4:6 M eV. (The electrom agnetic contribution to this splitting is estimated [10] to be 4:43 0:03 M eV.) Our calculation can be compared to the value 4:4 M eV (for $_{QCD} = 0:3$ G eV and $m_s = 120$ M eV) obtained by Bardeen, B ijnens and G erard [11] using large N m ethods. The values obtained for the bare quark m asses are

$$m_u = 3.86(3); m_d = 7.54(5); m_s = 147(1)$$

The errors quoted are statistical only, and are computed by a standard jackknife procedure. The extrem ely small statistical errors relect the accuracy of the pseudoscalar mass determ inations, and should facilitate the future study of system atic errors (primarily nite volume, continuum extrapolation [13] and quark loop elects), which are expected to be considerably larger. The relationship between lattice bare quark masses and the familiar current quark masses in the \overline{MS} continuum regularization is perturbatively calculable [14].

The presence of massless, uncon ned degrees of freedom in plies that the nite volume e ects in the presence of electrom agnetism may be much larger than for pure QCD. In fact, the corrections are expected to fall as inverse powers of the lattice size, instead of exponentially. We have estimated the size of the nite volume correction phenom enologically by considering the discussion of Bardeen, et al[11], which models the low $-q^2$ contribution to the $^+$ ⁰ splitting in terms of ; , and A1 intermediate states. This gives the splitting as an integral,

If the upper lim it M² is taken to in nity, this reproduces the result of Ref.[12], which gives m = 5:1M eV. Even better agreem ent with experiment is obtained by matching the low - q² behavior with the large-q² behavior from large N perturbative QCD [11]. Here we only use the expression to estimate the nite volume correction, for which the low -q² expression above should be adequate. To estimate the nite volume e ect, we cast this expression as a four-dimensional integral over d⁴q and then construct the nite volume e version of it by replacing the integrals with discrete sums (excluding the q = 0 mode). For a 12³ 24 box with a ¹ = 1:15 G eV, we not that the in nite volume value of 5:1 M eV is changed to m = 4:8 M eV, indicating that the result we have obtained in our lattice calculation should be able to determ ine the accuracy of this estimate directly by calculations on larger box sizes. A study of other system atics such as nite lattice spacing e ects is also in progress, and will be reported in a subsequent publication.

For comparison with other results, [2, 3, 4] we quote the following mass ratios, which are independent of renormalization prescription,

W ith the errors shown, which are statistical only, these results di er signi cantly from

the low est order estim ate [2] which uses D ashen's theorem to estim ate the electrom agnetic contribution to the kaon splitting to zeroth order. This low est order estim ate neglects the quark m ass dependence of the electrom agnetic term s, which we have determ ined by our procedure. Speci cally, the important corrections to the low est order result come from term s involving the strange quark m ass times the di erence of up and down quark charges. These corrections are determined by the second and third terms in B⁽¹⁾ in Table 2. The W einberg analysis predicts that the 4.0 M eV kaon splitting consists of 5.3 M eV from the up-down m ass di erence and -1.3 M eV from EM. In our results, the up-down m ass di erence contributes 5.9 M eV, with -1.9 M eV from EM. This goes in the direction indicated by the . 3 decay rate [4], although our results do not deviate as much from the low est order

analysis as those of R ef. [4], where the quark mass contribution to the kaon splitting is estimated to be 7.0 MeV.

In the present work we have focused on the pseudoscalar meson masses. This is the most precise way of determining the quark masses as well as providing an important test of the method in the + ⁰ splitting. Further calculations of electrom agnetic splittings in the vector mesons and the baryons, as well as in heavy-light systems, are possible using the present method. This will provide an extensive opportunity to test the precision of the method and gain condence in the results. Further study of electrom agnetic properties of hadrons in lattice QCD, such as magnetic moments and form factors, is also anticipated.
