# CHIRAL ANOMALY ON A LATTICE

ABSTRACT A calculation of the chiral anomaly on a nite lattice without ferm ion doubling is presented. The lattice gauge eld is de ned in the spirit of noncommutative geometry. Standard formulas for the continuum anomaly are obtained as a limit.

## 1. THE FINITE LATTICE EFFECTIVE ACTION

Chiral ferm ions have been the A chilles' heel of lattice approximations in QCD. In standard lattice method one uses a nearest neighbor approximation to the derivative of a ferm ion eld, the gauge eld is represented by the Wilson link variables for nearest neighbor lattice points. In this approach one cannot avoid an unphysical doubling of ferm ion degrees of freedom. In the present paper I want to propose an alternative lattice approximation which uses not only the nearest neighbors but all points on the nite lattice in the construction of the (chiral) Dirac operator. This may sound a bit clumsy, but actually we shall see that it is quite natural, and what is most inportant, it leads to the correct continuum limit without a ferm ion doubling.

We study chiral ferm ions in euclidean space in 2n dimensions. In the continuum the ferm ions are functions in  $R^{2n}$  taking values in  $C^{2^n}$   $C^N$ : The euclidean — matrices operate on the rst factor and the compact gauge group G on the second factor. The matrices satisfy

The matrix  $_{2n+1}=$  (i)  $_{1}^{n}$   $_{2}:::$   $_{2n}$  anticom mutes with the other matrices. We denote the chiral projections  $P=\frac{1}{2}$  (1  $_{2n+1}$ ) and consider the chiral Dirac operator

coupled to a vector potential A = A with A functions on  $R^{2n}$  taking values in the Lie algebra g of the gauge group G:

On a nite lattice L R  $^{2n}$  consisting of points x=m; where the lattice spacing is some xed positive real number and  $m=(m_1;m_2;\dots;m_{2n})$  is a vector with integer components  $n=q; q+1;\dots;q;$  any function is a linear combination of the Fourier modes  $f_p(x)=\frac{1}{(2q)^{2n}}e^{ip}$  with  $p=\frac{2}{2q}k$  and  $k=q; q+1;\dots;q$ : Thus the vector space of massless fermions on the lattice L has dimension  $K=2^n$  N ( $2^n$ ): Note that at the end points, corresponding to k=q; in the momentum space lattice the Fourier modes are identical; we have periodicity with period 2q in the momentum index k:W e shall later break this periodicity.

When studying the nite volume continuum  $\lim$  it one lets q! 1 and ! 0 such that '=2q is xed. However, we shall not insist on this but we keep the option open for an in nite volume  $\lim$  it.

Now our approach departs from the usual setting. Normally, the D irac operator is written using the principle that partial derivatives on a lattice are certain nite di erence operators involving nearest neighbor points. Here we de ne the free D irac operator through the Fourier transform  $D_0$  7 p: The vector potential A = A; thought of as an operator in the one-particle H ilbert space, is de ned as a K K m atrix with m atrix elements

where  $ss^0$  denote both the spin and gauge indices and the ambiguity in the Fourier transform  $\hat{A}$  (when restricting the continuum potential to the nite lattice) is resolved by requiring that both  $k; k^0 = q; q+1; \ldots; q$  for p=k  $\frac{2}{2q}: N$  ote that in general the Fourier transform is not periodic and therefore the matrix elements  $\hat{A}_{sp;s^0p^0}$  for  $p; p^0 = \frac{2}{2q} q$  are all independent. The number of lattice sites is

lattice operator A (in m om entum space) as a K K submatrix of the corresponding continuum operator by restricting the m om entum indices to the given range.

We shall generalize the above setting in the spirit of noncom mutative geometry, [C]. The reason for doing it here is purely technical: We do not need to think all the time whether the matrix representing a vector potential really represents a multiplication by a Lie algebra valued function. A vector potential in the generalized sense is any herm itean K K matrix of the form A where the A 's are herm itean matrices acting in  $C^N$  (2q+1)<sup>2n</sup>: A gauge transformation is then an unitary K K matrix g which commutes with the 's. The action of g on a potential A is given as

W e de ne the lattice e ective action

where  $\det_{\text{ren}}$  is a renormalized determinant. Even on a nite lattice we want to use certain renormalized determinants in order that in the  $\lim$  it q;1=! 1 the excitive action remains nite and leads to the continuum excitive action.

In continuum the rst renormalization ('vacuum subtraction') is to replace the determinant  $\det(p+A\!\!\!\!+\!\!\!\!+\!\!\!\!+\!\!\!\!+)$  by  $\det(\frac{1}{p+i}(p+A\!\!\!\!+\!\!\!+\!\!\!\!+\!\!\!+\!\!\!+))$   $\det(1+T)$ ; where T is an operator of order 1 in momenta. The term i, for a real nonzero parameter; is introduced as an infrared regularization. From now on any p in the denominator stands for p+i: U sing the formula log det = trlog and the expansion of the logarithm

one localizes the potentially diverging term s as the traces of  $T^k$  for k = 1; 2; ...; 2n:

that the potential A vanishes more rapidly than jkj 2n at in nity, the trace of these terms is nite. In terms of a momentum space cut-o one can write an asymptotic expansion

The scale xing constant  $_0$  is determined by the physical requirement that the strength and location of the pole at q=0 of the boson propagator is not a ected by the loop diagrams. The renormalized trace is defined as the coefcient a  $_0$  in the asymptotic expansion.

It follows that we can de ne the e ective action as proposed by Seiler [Se],

with k = 2n + 1: The nite set of (renormalized) Feynman diagrams comes from the renormalized traces of  $T^k$  for k = 2n: For example, when 2n = 4 the only diverging diagrams are the vacuum polarization terms with at most four external gauge boson lines.

In the lattice the modi ed Fredholm determ in ant  $\det_k (1 + T)$  is de ned exactly as in the continuum case. The renormalized determinant is

where the renormalized trace TR is dened as follows.

C ase of 2n=2: The continuum  $\lim$  it of tr  $(\frac{1}{p}\mathbb{A}_+)$  vanishes by a  $\lim$  ple parity argument. Thus no renormalization is needed for this term. The next term tr  $(T^2)$  is potentially logarithmically diverging. However, by the trace properties of products of matrices and parity this term is actually of order 3 and gives a nite trace. Thus the elective action is completely determined by  $\det_3(1+T)$  and the nite 1-loop diagram, TR  $(T-\frac{1}{2}T^2)=\frac{1}{2}\mathrm{tr}_{\mathbb{C}}T^2$ ; where  $\mathrm{tr}_{\mathbb{C}}$  stands for the

indices, then integrates over momentum variables with pj ; followed by the lim it ! 1 and the integration over x:

C ase of 2n = 4: The rst term trT vanishes as in the previous case. The next is the 1-loop diagram  $trT^2$  with two external boson lines. In the continuum we must compute traces of operators which are composed of products of G reen's functions (the operators 1=(p+i)) and and of smooth functions A=: They are examples of pseudodi erential operators. The algebraic manipulations involving PSDO's are most conveniently performed using the symbol calculus. First let us recall the basic rule of symbol calculus: A pseudodi erential operator is represented by a smooth function of coordinates and momenta, its symbol. The symbola b for a product of operators is computed from the symbols  $a_i$ b of the factors as

Now the 1st term in the expansion of the PSDO  $(\frac{1}{p}A+P_+)^2$  leads to both quadratic and logarithm ic divergencies which are given by the integral

The lattice version of this is simply

In addition, there is are logarithm ic divergencies arising from the next term s in the expansion of  $T^2$  as well as contributions from the higher order term s which involve the traces  $tr(T^k)$  for k=3;4: In the continuum case, by a standard Feynman integral calculation carried out in [SABJ], one obtains ( is a num erical constant) as the total logarithm ic divergence

where o is a renormalization constant and F is the dual of the eld tensor. A ctually, in our case the second term involving F F vanishes because we are not considering instanton backgrounds, the vector potential is globally de ned and vanishes at ixi! 1:A lattice version of this is

$$tr \frac{1}{(x^2 + y^2)^2} (F^2 + F - F)$$

modulo nite terms in the continuum limit. Thus for 2n=4 the elective action is given by  $Z(A)=\det_5(1+T)=e^{(A)}$ ; where A is the ordinary trace  $P_{k=1}=\frac{(-1)^k}{k}\operatorname{tr}(\frac{1}{p}A_+)^k$  minus the diverging terms discussed above.

General case. In 2n dimensions there is a nite number of both polynomially and logarithmically diverging terms. A derivative in momentum space makes the diagram better converging. A derivative in momentum space is associated with a dierentiation in x space of one of the A's in the expansion of the trace. Since for diverging diagrams we can have only a nite number of dierentiations, the coe cient of  $^k$  or of log will be a nite dierential polynomial in A: The lattice renormalization is obtained by subtracting these diverging terms from the naive e ective action in such a way that the partial derivatives  $\frac{\theta}{\theta \times}$  are replaced by the multiplication operators ip:

### 2. THE ANOMALY

Next we shall compute the gauge variation of the (lattice) elective action. For that we need some properties of the generalized Fredholm determinants. A coording to our denition, [S],

The rst nonzero multiplicative anomaly is  $_2(X;Y) = tr(XY)$ ; the next is  $_3(X;Y) = tr(X^2Y + Y^2X + \frac{1}{2}(XY)^2)$ : We shall also need the derivative  $H_k = _k^{(1)}$  with respect to the rst argument at (X;Y) = (0;Y): Its value for a variation X is easily computed to be

The gauge variation of  $S_{eff}$  (A) can be computed as follows. Modulo a variation of a nite polynomial in A; the anomaly is given by the gauge variation of the functional  $Z_k$  (A) =  $\det_k (1 + \frac{1}{p} A_+)$ ;  $A_+ = A_+ P_+ : D$  enote  $g = gP_+ + P$  and  $g_+ = gP_+ + P$ : We obtain

Example 2n = 2 Because of the accidental property of the two dimensional elective action,  $(\frac{1}{p}A=P_+)^2$  is conditionally convergent, we may use the determinant  $\det_2$  (instead of the more complicated  $\det_3$ ). The anomaly is then computed from the multiplicative anomaly  $_2$ : Both on the lattice and the continuum the anomaly is

The second term is a trivial cocycle, it is the gauge variation of the local functional

The rst term is the nontrivial part of the anomaly. On the lattice the local formula does not make sense, but we still have the trace formula (20), which in the continuum lim it leads to an integration in momentum and con guration space, giving the formula (21).

The general case. The nontrivial part of the anomaly comes from the dierence

This follows from the fact that the unrenormalized determinant is perfectly gauge symmetry; the gauge symmetry is spoiled by the renormalization. In the continuum the dierence above is in nite, but we may use this formula on the nite lattice, giving

Inserting  $T = \frac{1}{p} A_+$  and  $X A_- = [A_-; X] + [p; X]$  in (23) we obtain once more the form (19) of the anomaly.

In the case of periodic boundary conditions in the continuum version (or more generally, with an enough rapid decrease of the gauge elds at  $j \times j$ ! 1) we can prove that (23) has a continuum limit as the momentum space lattice size is increased (the cut-o  $j \cdot j$  is removed). This follows from a simple Holder inequality argument: If W is any operator such that  $j \in W$  is a trace-class operator, that is W 2 L<sub>n</sub>; and W<sub>i</sub> is a sequence of operators in L<sub>n</sub> converging to W with respect to the L<sub>n</sub> norm then  $\lim_{n \to \infty} \operatorname{tr}(W_i)^n = \operatorname{tr}W^n : Now W = T$  and the W<sub>i</sub>'s are i i lattice approximations to the continuum operator T;  $\lim_{n \to \infty} \int_{W} W_i \cdot j_n = 0$ :

The operators under the trace map in (23) become conditionally trace-class for 2n, [LM 1], and the trace of the in nite dimensional matrices (continuum  $\lim_{n \to \infty} \frac{1}{n}$ ) is given by a local formula, the eq. (21) in the case 2n = 2:

3. HAM ILTONIAN FORMULATION: ANOMALY OF THE CURRENT AL-

The same nite lattice approximation can be used also in the real time ham iltonian formulation for ferm ions in background gauge elds. The ham ilton operator  $D_A$  in 2n-1 dimensions is dened exactly in the same way as the 2n-1 irac operator earlier,

sum over k=1;2;:::;2n-1: The dimension of the space lattice is now  $K=2^n-N-(2q+2T)^{-1}$ , in case of D irac ferm ions; for W eyl ferm ions the ham iltonian above must be multiplied by the chiral projection  $P_+$  and the dimension of the projected subspace is  $K=2^{n-1}-N-(2q+2T)^{-1}$ :

We shall consider the gauge currents for massless fermions. The left and right components of fermions decouple and we may restrict to (left-handed) Weyl fermions. The current algebra for Dirac fermions becomes just the direct sum of left and right current algebras.

In continuum the current algebra is anom alous. There are Schwinger term swhich in the case 2n 1 = 1 can be written as

where the integral is over the one dimensional space M: When M is a unit circle (25) gives an a ne Kac-Moody algebra. Here (X) denotes the charge density integrated with a smooth Lie algebra valued test function X;

where k is a Lie algebra index, k = 1;2;:::;dim g: The trace under the integral sign in (25) refers to the representation of the gauge group acting on ferm ion components. In the case <math>2n = 1 = 3 one has, [M 1], [F-Sh],

where the 3-form under the integral is de ned as an exterior product of the 1-form s A; dX; dY:

There are alternative, but equivalent, form ulas for the Schwinger term s. Equivalent means again that the dierence between the Schwinger term s is a gauge vari-

and X; linear in the latter argument. In the case 2n 1 = 1 one has in fact an exact formula, [L],

where is the sign of the free 1-particle ham ilton operator. In three space dim ensions we have, [MR], [LM1],

where now F is the sign of the 1-particle ham iltonian  $D_A$  in the external gauge eld A: The conditional trace is de ned as  $tr_C K = \frac{1}{2}tr(K + K)$ :

These formulas, and the corresponding formulas in higher dimensions, can be directly translated to the lattice. When dening the sign operators F; one should be careful in order to have the right continuum limit. We have to split (somewhat articially) the energy spectrum even in the nite case to positive and negative parts. As before we dene the momentum components as  $p_i = \frac{2}{2q}k$  with k = 0; 1; 2;:::; q for some positive integer q. The energy eigenvalues for the free ham iltonian become then  $E = (p_i p_i)^{1=2}$  and so the spectrum is symmetric around zero.

In the case of periodic boundary conditions (in x space) in the continuum theory it is simple to prove that one obtains the right continuum lim it as the size of the momentum space lattice is increased, that is, when the cut-o £ j is removed. This follows again from a standard Holder inequality argument. The trace in (28) is convergent, it is known that the operators [;X]; [;Y] belong to the Schatten ideal  $L_4$  of operators T such that jT j is trace-class; furthermore, the diagonal blocks (F)+(F) of F (the only part of the operator which contributes to (28)) are Hilbert-Schmidt. All these operators can be approximated by nite-dimensional matrices (in the appropriate  $L_k$  norms) and therefore the trace of the product is a limit of traces of nite-dimensional (cut-o) matrices.

We have discussed above the abstract commutation relations of the current algebra but we have said nothing about an operator realization of the currents. In 1+1 dim ensions the theory is well understood; a physically acceptable realization is obtained using highest weight representations of a ne algebras. An important

space. This construction has been generalized to the 3 + 1 dimensional case (and the method works in higher dimensions), [M 2]. That representation is also suitable for a lattice approximation, as will be brea y explained below.

The basic idea is to de ne a continuous fam ily  $T_A$  of unitary conjugations in the one-particle ferm ionic H ilbert space such that the o-diagonal blocks (with respect to the energy polarization ) of currents are reduced such that the resulting (unitarily equivalent) G auss law generators can be quantized by canonicalm ethods. M ore precisely, we have to require that

where X is any in nitesim algauge transform ation and

Note that the modi ed G auss law generators  $G_X = T_A^{-1}G_X T_A$ ; with  $G_X = _X + X$ ; autom atically satisfy the same commutation relations as the generators X: The construction of the operators  $T_A$  is best understood through an (asymptotic) expansion in powers of the inverse momenta 1=p: In three space dimensions the rst terms of the symbol are, [M 2],

and the resulting gauge currents

where we have used the herm itean Paulim atrices as the 3-space D irac matrices, p = p: In all form ulas it is implicitely assumed that an infrared regularization 1=pj? 1=(pj+) is performed. The terms which are of order strictly lower than 1 in momenta are Hilbert-Schmidt and therefore not critical for the current renormalization. With the renormalized current operators in hand, one can compute the quantum commutation relations in a straight-forward way. The resulting Schwinger term was calculated in [M 2] and found to be equivalent with (26).

These formulas can be translated im mediately to the lattice. One replaces the derivatives  $(X \times Y)$  and the momentum symbols in the PSDO's become
