B Decay Constants from NRQCD with Dynamical Fermions

Abstract

We present a lattice investigation of the heavy-light meson decay constants using W ilson light quarks and NRQCD heavy quarks, partially including the e ects of dynam ical sea quarks. We calculate the pseudoscalar and vector decay constants over a wide range in heavy quark mass and are able to perform a detailed analysis of heavy quark sym m etry. We nd consistency between the extrapolation of the NRQCD results and the static case, as expected. We nd the slope of the decay constants with 1=M is signi cantly larger than naive expectations and the results of previous lattice calculations. For the st time we extract the non-perturbative coe cients of the slope arising from the O (1=M) heavy quark interactions separately and show the kinetic energy of the heavy quark is dom inant and responsible for the large slope. In addition, we nd that signi cant system atic errors rem ain in the decay constant extracted around the B m eson m ass due to truncating the NRQCD series at O (1=M). We estim ate the higher order contributions to f_B are approximately 20%; roughly the same size as the system atic errors introduced by using the W ilson action for light quarks.

1 Introduction

The decay constant of the B m eson, $f_{\rm B}$, is of fundam ental importance to tests of the Standard M odel because it is needed in the determ ination of the CKM m atrix. W hile one of the simplest weak m atrix elements to study, it is not very well known and dom inates the uncertainty in extracting $V_{\rm td}$, one of the sm allest CKM elements, from B B m ixing. The best chance of an experimental measurement of $f_{\rm B}$ lies in the decay B $^+$! $^+$ + . However, this decay has yet to be observed, and $f_{\rm B}$ appears in combination with $V_{\rm ub}$, which is only known to within a factor of 2.

Theoretical calculations using for example QCD sum rules within the fram ework of Heavy Quark E ective Theory (HQET) [1,2] and lattice eld theory have been actively pursued over the last few years with the current world average standing at $f_B = 200$ 20% MeV [3, 4]. As a rst principles approach, lattice simulations o erultim ately the most reliable calculation of f_B . The initial problem of simulating a b quark with C ompton wavelength of the order of the typical lattice spacing presently achievable was rst solved by using the static approximation [5, 17], where the heavy quark is treated as a static colour source within the heavy-light meson. Simulations using conventional relativistic m ethods around the D m eson showed the corrections to the static approximation in this region, and hence also at the B meson, are much larger than naively expected. This has contributed to the sizable uncertainty remaining in f_B , shown above. The determination of f_B directly at $M_{\rm B}$ on the lattice is required, and this is now possible with the developm ent of Non Relativistic QCD (NRQCD) [7,8]. Using this approach the error in the decay constant can be signi cantly reduced with the computational power currently available. Initial calculations have already been perform ed by Hashim oto [9] and Davies [10].

This analysis forms the second stage of a project applying NRQCD to heavy-light systems and studying heavy quark symmetry at the B meson. Our previous papers have dealt with the B meson spectrum in both the quenched approximation [11] and partially including the elects of sea quarks [12]. We now present our results for the decay constants of the heavy-light mesons from dynamical con gurations. Note that the combination $f_B^2 B_B$, where B_B is the mixing parameter for the B system, is the experimentally relevant quantity, and thus a calculation of B_B is also needed.

The paper is organised as follows. In section 2 we describe the simulation

details including the system atic errors associated with the calculation. The m eson operators required to compute the decay constant to 0 (1=M) are set out in section 3 and we discuss computing the decay constant consistently to this order in terms of the evolution equation used. Next, we exam ine the predictions of heavy quark symmetry for the behaviour of the decay constant in the heavy quark m ass lim it. The contributions from the interactions of the heavy quark at 0 (1=M) are analysed and combinations of decay constants which isolate these individual contributions are discussed. Section 5 illustrates our results and tting analysis with a subset of the data. The heavy quark m ass dependence of the decay constants are investigated in section 5.2; the individual non-perturbative 0 (1=M) coe cients of the slope of the decay constant are extracted. Finally we present our conclusions in section 6.

2 Simulation Details

The simulations were performed using 100 16^3 32 gauge congurations at = 5.6 with two avours of staggered dynamical sea quarks with a bare quark mass of am_{sea} = 0.01. These congurations were generously made available by the HEMCGC collaboration; more details can be found in [13]. We xed the congurations to the Coulomb gauge. The light quark propagators were generated using the W ilson fermion action, without an O (a) improvement term, at two values of the hopping parameter, = 0.1585 and 0.1600. The former corresponds to a quark mass close to strange, where s = 0.1577 from M, while 0.1600 is somewhat lighter, with c = 0.1610.

W ith only two values of light quark mass it is not possible to perform a trustworthy chiral extrapolation. In addition, the system atic errors associated with the light quarks, discussed below, a ect the determ ination of the bare strange quark mass; s extracted from pseudoscalar mesons, using the lowest order chiral mass dependence to not the experimental mass' of the pure ss pseudoscalar, di ers from s obtained from the vector meson . Thus, most of the results will be presented for $_1 = 0.1585$.

In this simulation we truncate the NRQCD series at 0 (1=M $_0$), where M $_0$ is the bare heavy quark mass, and the action takes the form :

Tadpole in provement of the gauge links is used throughout i.e. they are divided by u_0 , where we use $u_0 = 0.367$ measured from the plaquette, and the hyper ne coe cient is given the tree-level value $c_B = 1$. We use the standard C lover-leaf operator for the B eld. The heavy quark propagators were computed using the evolution equation [14]:

where n is the stabilising parameter. In the static lim it this reduces to

We generated heavy quark propagators at 11 values of (aM $_0$,n) corresponding to (0.8,5), (1.0,4), (1.2,3), (1.7,2), (2.0,2), (2.5,2), (3.0,2), (3.5,1), (4.0,1), (7.0,1) and (10.0,1), and the static lim it. This roughly corresponds to a range of meson m asses from M $_{\rm B}$ =3 to 4M $_{\rm B}$ and is su cient for a reasonable investigation of heavy quark symmetry. However, it is not possible to simulate the D meson on this lattice using NRQCD; a larger lattice spacing is required, $n_{\rm f}=2<5.5$ or $n_{\rm f}=0<5.85$.

Details of the construction of meson operators, the smearing functions used and our thing analysis can be found in [12]. As discussed in this reference there are large system atic errors associated with this simulation arising from the use of W ilson light fermions. The emphasis of our analysis will be on determining the heavy quark mass dependence of the decay constants and extracting the nonperturbative coe cients of the heavy quark expansion to O(1=M). The system atic error arising from the light quark in these $O(\frac{2}{QCD})$ coe cients is naively estimated to be a relative error of $O(\frac{2}{QCD}a) = 20\%$ for this ensemble (where we take a $_{QCD} = a_{V} = 0.185$ for these con gurations). The truncation of the NRQCD series and the use of the tree-level value for the hyper ne coe cient introduce absolute errors of $O(\frac{2}{QCD} = M)^{2}$) and $O(s_{QCD} = M)$ respectively. Both correspond to approximately 1% errors in the value and 10% errors in the slope of the decay constant at

M_B. The coe cients of the quadratic term in the heavy quark expansion cannot be correctly determ ined in this analysis. The size of the system atic errors induced by the light quark action are indicated by the large uncertainty in the lattice spacing; we use a $^1 = 1.8$ 2.4 GeV. This gives aM₀ = 2.4 1.7 as corresponding to the bare b quark mass. We are currently repeating our analysis using tadpole-in proved C lover light ferm ions [15].

3 M eson O perators

The pseudoscalar decay constant is de ned by

where $A_0 = q_{5}_{0}$ hat tree level and q and h represent 4-com ponent light and heavy quark elds respectively. In this convention the experimental value of f is 131 M eV. Similarly, the vector decay constant is given by

where $V_i = q_ih$ at tree level. The calculation of these m atrix elements, and thus decay constants, to 0 (1=M) in NRQCD requires several operators. At tree level these can be obtained by relating h of fullQCD to the 2-com ponent NRQCD elds, Q and Q for heavy quarks and heavy antiquarks respectively, using the Foldy-W outhuysen transform ation. To 0 (1=M),

W ith the convention that our meson states be built out of a heavy quark and a light antiquark, the Q' eld will not contribute to the above matrix elements through 0 (1=M), and we obtain

where ${}^{(4)} = {}_{5\ 0}$ and ${}^{(2)} = 1$ for the axial current, and ${}^{(4)} = {}_{i}$ and ${}^{(2)} = i {}_{i}$ for the vector current. q_{12} and q_{34} denote the upper and low er two components of q respectively. Our Euclidean space matrices are chosen as,

Beyond tree level all operators with the same quantum numbers can m ix under renorm alisation. Thus at O (=M) the basis of operators for the axial current, is given by 4

U sing translation invariance, the zero m om entum currents involving O₂ and O₃ are identical on the lattice and comparing with equation 8 it is su cient to calculate m atrix elements of the tree level operators O₁ and O₂. Sim ilarly, the basis of operators for the vector current,

is reduced, for the num erical computation, to O_1 , O_2 and O_2 O_4 , where m atrix properties have also been used. We computed the pseudoscalar and vector m atrix elements corresponding to this m inim all set of operators by inserting a smeared interpolating eld with the same quantum numbers as O_1 at the source and all combinations of local currents at the sink for each m eson.

The perturbative calculation of the renorm alisation factors needed to relate the matrix elements in NRQCD to the currents in fullQCD has not yet been completed [16]. Thus, we use the static renorm alisation factors [17] and are restricted to the tree levelO (1=M) corrections; we om $\pm O_4$ for the vector m eson. Since this correction is of O ($_{S_QCD}$ ($_{QCD}=M$)) \pm is roughly the sam e size as that induced by unknown perturbative matching corrections in

the coe cient c_B , which are not included in the analysis. The renorm alisation factors in NRQCD depend on the heavy quark mass and hence using the static value introduces an O ($_S$) 20% error into the O (1=M) coe cients extracted from our results.

It is possible that the power divergences which appear in NRQCD may lead to signi cant non-perturbative contributions to the renorm alisation factors [18]. No clear indication of 'renorm alon' e ects has been found in other quantities calculated perturbatively in NRQCD [14], however, we intend to compute the renorm alisation factors non-perturbatively to check this.

Strictly, our analysis is not fully consistent to O (1=M). Note that the evolution equation given in equation 3 induces an O (a ($_{QCD} = M$)) system – atic error in the currents. This is because it does not apply the relativistic correction operator (1 H) on the initial timeslice. Since all subsequent timeslices include this operator the transferm atrix is consistent to O (1=M). Thus, it is only in the amplitude of the meson correlator, i.e. the decay constant, that is missing this O (a ($_{QCD} = M$)) contribution. A better but computationally more costly evolution equation is given by

for all timeslices. Since our use of the W ilson action for light quarks also induces errors of this order of magnitude, we used equation 3 in this project. In a comparison of these evolution equations using C lover ferm ions for the light quarks [15] we found the insertion of (1 H) on the source timeslice introduces 4% correction to $h0 jO_1 \ PSi_{N RQCD}$ and 3% correction to $h0 jO_2 \ PSi_{N RQCD}$ around M_b. Considering the system atic errors inherent in this calculation and our statistical accuracy of 2%, the om ission of this correction w ill not signi cantly a ect our ndings.

4 Heavy Quark Symmetry

In the heavy quark lim it the decay constant can be parameterised in terms of an expansion in 1=M :

The coe cient c_P is determined by nonperturbative contributions arising from the hyper ne interaction (G_{hyp}) and the kinetic energy of the heavy quark (G_{kin}), which appear in the NRQCD action, and the corrections to the current arising from the Foldy-W outhuysen transformation. From rst order perturbation theory in 1=M about the static limit:

where $d_M = 3$ and 1 for pseudoscalar and vector m esons respectively. The integer factors in this equation are introduced for convenience when com paring with HQET.

where \mathcal{P} i₁ represents the meson in the limit of in nite heavy quark mass, and equations 16-18 are tree level expressions. Note that the kinetic and hyper ne terms contribute to the decay constant through the correction to the meson wavefunction.

Equation 15 suggests that the individual contribution from each O (1=M) term can be obtained separately by taking appropriate combinations of the pseudoscalar and vector decay constants, (f \overline{M})_{PS} and (f \overline{M})_V respectively. For clarity below, we denote

with similar quantities de ned for the vector particle by replacing PS with V.W e also denote the spin-average of the decay constants,

Table 1 displays our notations for the expansions in 1=M and the corresponding coe cients of (f $\stackrel{P}{M}$) and the ratio of the pseudoscalar to vector decay constants, with and without the current correction. It is easy to see from this that both G_{kin} and G_{hyp} can be extracted in a simple way from c_p^0 and c_p^0 respectively; G_{corr} must be obtained from the combination c_p^{00} c_p^0 . Since we compute h0j0₂ p i separately, however, G_{corr} can be more accurately found by examining the current correction in the in nite heavy quark m ass lim it:

HQET provides an analogous decomposition of these coe cients [19]. However, since HQET constructs an elective theory in terms of the heavy quark polem ass, as opposed to the bare quark mass in NRQCD, only physical combinations of G's, i.e. q_P , c_P^{00} and $c_P^0 = G_{kin}$, can be compared. Note that while these coe cients are expected to be of O ($_{QCD}$) 200 500 M eV (and thus the corrections to the static limit at M_B O ($_{QCD} = M_B$) 10%); the unphysical quantities G_{hyp} and G_{corr} need not be of this order.

In HQET G_{corr} is related to the meson binding energy, $G_{corr} = [19]$. This follows from the observation

where v is the velocity of the heavy quark, and using the equations of motion of the heavy and light quark. Note that in NRQCD the RHS. of equation 25 becomes $E_{sim}^1 v h 0 jq^{(4)} h p i_1$ and following the arguments of [19] the analogous expression in NRQCD can be obtained:

At nite heavy quark m ass this relation is broken by term s of 0 (1=M). Sim – ilarly, on the lattice, discretisation m odi es 26 and the operators in equation 23 m ust be renorm alised.

5 Results

5.1 Fitting results for the decay constants

To begin with we extract the decay constant without the correction to the current, i.e. from $h0j0_1 \ P$ i. We performed a single exponential vector t to C $(1; l_{0_1})$ and C (1; 1) for the pseudoscalar and vector mesons. C $(1; l_{0_1})$ denotes a correlation function constructed at the source from an interpolating eld with appropriate quantum numbers for the vector or pseudoscalar state and the heavy quark smeared with a ground S-state smearing function (described in [12]); at the sink the local current 0_i is inserted. In the limit of large values of t

By taking a bootstrap ratio of the amplitudes of these correlators the decay constant can be obtained:

To illustrate our results we use the data at aM $_0 = 1.0$ and $_1 = 0.1585$. The elective masses of the pseudoscalar C $(1;l_{0_1})$ and C (1;1) correlators, presented in gure 1, show a clear signal out to approximately timeslice 20. A one exponential $(n_{exp} = 1)$ simultaneous t to both correlators that satis es the t criteria Q⁵ > 0:1 is possible from an initial timeslice $(t_{m in})$ of 4 out to timeslice 20 $(t_{m ax})$. The variation of E_{sim} with the trange is 2 for $t_{m in}$ > 4 and this is taken to be the tting error in our analysis. A nal tting range of 7 20 is chosen, for which Q is judged to be roughly stable to increases in $t_{m in}$.

To estim ate the remaining excited state contribution to the tting param – eters extracted the results are compared in table 2 with a multi-exponential analysis using a vector and matrix of sm eared correlators [12]. The agreement, to within the tting error, of the energies and amplitudes provides con dence that we have isolated the ground state. Since the overlaps of both C $(1; l_{0_1})$ and C (1; 1) with the rst excited state are sm all, $n_{exp} = 2$ ts could not be perform ed successfully to these correlators.

In the static case, it is more di cult to obtain a satisfactory t. From gure 2 the signal for the C (1;1) dies away as C (1; $l_{0,1}$) appears to be reaching a plateau. W hile a $n_{exp} = 1$ to both correlators is possible from $t_{m in} = 4$ for Q > 0:1, gure 2 shows the ground state energy is not stable to changes in the tting range. In addition, it was not possible to bootstrap the ts for $t_{m in} < 9$. Thus, we choose 9 11 for which E_{sim} is consistent with the results from di erent tting ranges. A green ent is found when comparing with the energy and am plitudes obtained from ts to other combinations of correlators, detailed in table 3. However, a better tuned ground state smearing function would enable the t parameters to be extracted with greater condence. As noted in reference [12], even for the heaviest nite heavy quark




Figure 1: The elective masses of the pseudoscalar C $(1;l_{0_1})$ (circles) and C (1;1) (diamonds) correlators, and the corresponding ground state energy extracted as a function of $t_{m in}$ from a $n_{exp} = 1$ vector t for aM $_0 = 1.0$ and $_1 = 0.1585$. The elective mass of the C $(1;l_{0_1})$ correlator is o set by +0.2. A lso shown are the values of Q for the vector t; E $_{sim}^{PS}$ is only presented for those values of t_m in which satisfy Q > 0:1. t_m ax is xed at 20.

The heavy quark is expected to be alm ost a spectator in the heavy-light m eson and so the wavefunction changes very little with M₀ or the spin content of the m eson. We ind it is su cient to use the same ting range, 7 20, for the pseudoscalar m esons for all nite values of the heavy quark m ass. This tting range is also used for the vector m esons, apart from M₀ = 0.8 1.2 where it was necessary to use 9 20. The corresponding values of E_{sim} and the pseudoscalar and vector decay constants (without the current correction) are given in table 4 for $_1 = 0.1585$. The pseudoscalar m eson m ass, M PS, also shown in the table, is calculated using the m ass shifts, M PS E_{sim} , given in reference [12]. Repeating the analysis for the results at $_1 = 0.1600$, we found 7 20 is the optim all thing range for all M₀.

The current correction is extracted separately by taking the jackhnife ratio of the pseudoscalar C $(1; l_{0_2})$ and C $(1; l_{0_1})$ correlators. In the lim it of large times, the ratio tends to a constant:

This ratio is shown in gure 4 for aM $_0 = 1.0$ and $_1 = 0.1585$. W hile a plateau seem s to be reached around timeslice 5, Q does not stabilise until $t_{m in} = 12$. Thus, we choose a tting range of 12 20; this was found to be optimal for all M $_0$. In addition, picking an earlier $t_{m in}$ leads to diculties when investigating the heavy quark mass dependence of the current correction. The statistical uncertainty becomes so sm all that terms above 0 (1=M⁴) in the




Figure 2: The elective masses of the pseudoscalar C $(1;l_{0_1})$ (circles) and C (1;1) (diamonds) correlators, and the corresponding ground state energy extracted as a function of $t_{m in}$ from a $n_{exp} = 1$ vector t for aM $_0 = 1$ and $_1 = 0.1585$. The elective mass of the C $(1;l_{0_1})$ correlator is o set by +0.2. Also shown are the values of Q for the vector t. $t_{m ax}$ is xed at 11.




Figure 3: The e ective m asses of the pseudoscalar C $(1; l_{0_1})$ (circles) and C (1; 1) (diam onds) m eson correlators for aM $_0 = 10.0$ and $_1 = 0.1585$.

heavy quark expansion of this quantity are required, and it becomes $\underline{\text{gli}}$ cult to extract the coe cients reliably. Using the previous results for $(f \ M)_{PS}$ we obtain the values of $(f \ M)_{PS}$ shown in table 4 for $_1 = 0.1585$. It is clear that as $(f \ M)_{PS}$ is a 15% correction to $(f \ M)_{PS}^{uncorr}$ around M $_b$ (2.0), it is essential to include the current correction when calculating f_B and investigating its corresponding heavy quark m ass dependence, especially when other sources of error from light quarks etc are under control.

A s stated in equations 14 and 15, group theory relates the spin dependent contributions to the slopes of the vector and pseudoscalar decay constants in the continuum. In terms of the current correction:

On the lattice this relation only holds in the lim it of in nite statistics. Figure 5 shows $\frac{[C (1;b_2)=C (1;b_1)]_{b,S}}{[C (1;b_2)=C (1;b_1)]_{b}}$ for aM₀ = 1:0 and ₁ = 0:1585. In the lim it of large times this ratio of correlators tends to the R H S. of equation 31. We not equation 31 is satisfied to within 1 2 and thus, we can further reduce the number of matrix elements that need to be calculated by using $\frac{1}{3}$ [(f M)_{PS} = (f M)_{PS}^{uncorr}](f M)_V^{uncorr} for the vector current correction.




Figure 4: The jackknife ratio of the pseudoscalar C $(1;l_{0.2})$ and C $(1;l_{0.1})$ correlators and the corresponding am plitude, (f M)_{PS} = (f M)^{uncorr}, as a function of $t_{m in}$ obtained from a constant t for aM $_0 = 1.0$ and $_1 = 0.1585$. The values of Q for the ts are also shown. $t_{m ax}$ is xed at 20.

We compare E_{sim}^{PS} with $2M_0 h0jO_2^{PS} \not PSi_{NRQCD} = h0jO_1^{PS} \not PSi_{NRQCD}$ in table 5. The 20% O(s) disagreement between these two quantities is approximately independent of heavy quark mass, and hence is most likely to be due to the om ission of the lattice renormalisation factors rather than O(1=M) terms. Note that both quantities are roughly a factor of 2 larger than i.e. quite different from the analogous quantities in HQET.

The spin-average of the vector and pseudoscalar decay constants, as well as the ratio, with and without the current correction were computed. The results are given in table 6. In order to investigate the heavy quark mass dependence of these quantities, detailed in the next section, 100 bootstrap ensembles were generated for each correlated t. The bootstrap averages of the t parameters are consistent with the corresponding unbooted values given in the tables. In the static case we obtain,

These values are consistent, but with much larger errors than those obtained from unbooted data. This underscores the signal=noise problems and the




Figure 5: The jackknife ratio of C $(1; l_{0}) = C (1; l_{0})$ for the vector and pseudoscalar m esons for aM $_0 = 1.0$ and $_1 = 0.1585$.

rough nature of our determ inations of $(f \stackrel{p}{M})^{\text{static}}$. The corresponding estimate of $(f \stackrel{P}{M})^{\text{stat}} = 0.4(1)$ is so uncertain as not to be useful. Since the purpose of our static result is to compare with the more accurate extrapolation to the in nite mass limit of the NRQCD results, a rough value is su cient and we use a value consistent with the unbooted ts, $(f \stackrel{P}{M})^{\text{stat}} = 0.341(37)$, which has smaller error bars.

W hile the one loop correction to the decay constant is not included in this analysis, the size of the vector matrix element h0jO₄ jV i_{NRQCD} is shown in gure 6 as a percentage of h0jO₁ jV i_{NRQCD} for aM₀ = 1.0 and ₁ = 0.1585. This is roughly the same size as the tree level matrix element,

Since the one loop contributions should be suppressed by a factor of 0 ($_{\rm S}$) 20%, the contribution to the vector decay constant is around 2% ${\rm pf}_{\rm N\,R\,Q\,C\,D}$. This is of order 2 in the statistical errors of (f M) $_{\rm V}^{\rm un\,corr}$ at this m ass. The one loop correction to the pseudoscalar decay constant is sim ilarly sm all.




Figure 6: The jackknife ratio of C $(1; l_{0,4})=C (1; l_{0,1})$ for the vector m eson at aM $_0 = 1.0$ and $_1 = 0.1585$.

5.2 Heavy quark mass dependence of the decay constants




Figure 7: $a^{3=2}$ (f^p M)^{tot}_{PS} vs 1= (aM_{PS}) for $_1 = 0:1585$. The solid line indicates a quadratic t to the heaviest six points and 1=(aM_P) 0:4. The static data point, shown as a burst, is not included in the t. Note that the renorm alisation factors are not included.

The decay constants have been computed over a wide range of heavy quark m ass and this is ideal for investigating heavy quark symmetry. Figure 7 presents the results for $(f \ M \)_{PS}^{tot}$ as a function of $1=M_{PS}$ for $_{1} = 0.1585$. The static result is also included in the plot. A correlated t to the data was perform ed using the functional form :

The tting range was varied keeping the starting point xed at the heaviest data point, $aM_0 = 10.0$. Beginning with a linear function, the tting procedure was repeated adding quadratic and cubic terms. In general, in order to have condence in the value for C_1 a quadratic t is required. Note that in reference [12] we found when performing correlated to the results as a function of 1=M the values of n used in the evolution equation for $aM_0 = 3.5$

and 4:0 are too low; the results for these data points are not included in any of the ts.

Table 7 sum marises the coe cients extracted from various ts. A 'good t' is de ned in the same way as for the propagator ts: Q > 0:1. The tting range for which Q falls below this cut-o is taken to signify when higher terms can be resolved. Thus, we do not present ts including an additional term over a smaller tting range. The decay constant is only consistent with a linear dependence on 1=M $_{PS}$ for the rst three data points, for which 1=M $_{PS}$ < 0:3. The quadratic term is needed for 1=M $_{PS}$ < 0:6, i.e. there are signi cant 0 (1=M 2) contributions to the decay constant in the region of the B m eson (1=(aM $_{PS})$) 0:4). Since only the 0 (1=M) contributions are correctly included in this analysis it is necessary to go to the next order in the NRQCD expansion to calculate f_B accurately. A to all the data points is possible including the cubic term .

A quadratic t to the heaviest six data points is shown in gure 7. The extrapolation of the NRQCD results at nite heavy quark mass is clearly consistent with the static data point. Since the static theory is the heavy quark mass limit of NRQCD this is expected and we assume this is not spoilt

by the inclusion of the renorm alisation factors. A striking feature of the plot is the very large slope and the corresponding large deviations from the static limit of 50% around $1=M_B$.

Note that with only the last two data points requiring a cubic t, the coe cient C₁ is not as well determined as for the quadratic t. Hence, we only consider the quadratic ts and nd $a^{3=2}C_0 = 0.34$ (1). Similarly, $a^{5=2}C_1$

0:46(5). Thus, we arrive at $a_{\varphi} = aC_1 = C_0$ 1:35(15), much larger than the naive expectation of 0 (a $_{QCD}$) 0:2. Converting to physical units, c_P 2:8(5) G eV, using $a^1 = 1$:8 2:4. We found the slope parameters do not depend signi cantly on the light quark mass.

This slope is signi cantly larger than that found in previous lattice simulations which found c_p 0.8 GeV [20] and 1:14 GeV [21]. We believe the discrepancy is due to previous results being obtained by extrapolation from around the D m eson with too smalla range of m asses when using W ilson or C lover heavy quarks; consistency between the static limit and results in this region has not been shown. In addition, our results indicate the deviations from the static limit may be so large at M_D that a heavy quark expansion is not valid in this region.

O nogiet al, using the Ferm ilab approach to an order equivalent to O (1=M)

in NRQCD, also nd a slope around 1 GeV [22]; data points around the B and D m eson are used. The pseudoscalar renorm alisation factors for this m ethod have not yet been calculated and a proper comparison of the extrapolation of the results with the static limit cannot yet be m ade. Consistency should be found between this m ethod and NRQCD, and it is important to con m the slope in the large m ass region, $M_{\rm PS}$ $M_{\rm B}$.




Figure 8: The pseudoscalar decay constant both with (crosses) and without (pluses) the current correction and the spin-average decay constant (circles) as a function of $1=(aM_{PS})$ for $_1 = 0.1585$. The solid lines indicate cubic ts to all the data points. Note that the renorm alisation factors are not included.

To exam ine the large slope of the decay constant further we obtained the individual contributions to the pseudoscalar and vectorm atrix elements from each of the O (1=M) interactions. Figure 8 shows (f \overline{M}), (f \overline{M})^{tot}_{PS} and (f \overline{M})^{uncorr} as a function of 1=M_{PS}. From section 4 the slope of the spin-average decay constant depends only on the kinetic energy of the heavy quark, while the other two quantities include contributions from the spin dependent interactions. It is clear from the large m ass region where the slope is linear that G_{kin} is much greater than G_{hyp} or G_{corr}, and is the source of the large slope. Qualitatively, the spin dependent term s are expected to be suppressed since they break spin as well as avour symmetry. Performing correlated ts to (f \overline{M}), detailed in table 8, we nd aG_{kin} = C₁=C₀ 1:26(15) or 2:6(5) G eV.

This result agrees with Hashimoto [9], who calculates the pseudoscalar decay constant at = 6.0 in the quenched approximation and nds the coe cient of the slope at 0 (1=M) roughly 2:4 (1:1) G eV. Since the correction to the current is om itted in his calculation, this coe cient corresponds to $G_{kin} + 6G_{hyp}$.

Note that even though only O (1=M) terms are included in the NRQCD action we see quadratic and cubic behaviour in the decay constant in gure 7; this is due to higher powers of the existing O (1=M) terms. These higher order powers are dominated by powers of the kinetic energy terms as is clear from gure 8, which shows that the spin-dependent and spin-independent slopes of f^{-} M show little di erence even at relatively small values of M. Also, the m issing O (1=M²) terms in the NRQCD action are all spin-dependent so they cannot contribute to the spin-independent slope at O (1=M²). We would therefore expect that our spin-independent slope was correct even through O (1=M²) except that there are spin-independent m atrix element corrections at this order. We do not know the size of these corrections, but it is unlikely that they would be larger than the spin-independent 1=M² terms that are present in our calculation already. Later we will allow for this by taking a

rather pessim istic 100% error in our $1=M^2$ coe cient.

To isolate the e ects of G _{hyp} and G _{corr}, consider the ratio of the pseudoscalar and vector decay constants, with and without the current corrections, shown in gure 9. Both data sets are consistent with 1 in the static limit, as expected. Note that without the current corrections the ratio, which is determined solely by the hyper ne interaction, is greater than 1 indicating G _{hyp} is positive. We nd $ac_p^{00} + 0.11(1)$ or 23(4) G eV in physical junits, and hence $aG_{hyp} = c_p^{00} = 8$ 0.014(1) or 0.029(5) G eV. Including (f M), the slope is a physical quantity and $ac_p^{00} = 0.40(4)$ or 0.85(15) G eV.

By subtracting c_p^{00} and c_p^{00} we estimate aG _{corr} 0:77(8). However, the correction to the current can be extracted directly and more accurately as the intercept of 2M ₀ (f \overline{M})_{PS} = (f \overline{M})_{PS} shown in gure 10. From table 8, we obtain consistent results, aG _{corr} = 0:675(7) or 1:42(20) GeV. As in the nite heavy quark mass case, G _{corr} agrees with $E_{sim}^1 = 0.528(5)$ to within approximately 0 ($_{S}$).

A comparison can be made with the predictions of QCD sum rules. The results obtained by Neubert [19] using HQET, shown in table 9, are in good




Figure 9: The ratio of the pseudoscalar to vector decay constant both with (crosses) and without (pluses) the current correction as a function of $1 = (aM_{PS})$ for 1 = 0.1585. The solid lines indicate a linear t to $((f \ M \)_{PS} = (f \ M \)_V)^{uncorr}$ and a quadratic t to $((f \ M \)_{PS} = (f \ M \)_V)^{uoc}$, where all data points are included in the ts. The error in the extrapolation to the static limit is indicated for both ts. Note that the renorm alisation factors are not included.




Figure 10: 2M $_{0}a$ (f \overline{M})_{PS} = (f \overline{M})^{uncorr} vs 1= (aM $_{PS}$) for $_{1}$ = 0:1585. The solid line indicates a linear t to the six heaviest data points. Note that the renorm alisation factors are not included.

agreem ent with our analysis. A snoted previously, the unphysical parameters $G_{\rm hyp}$ and $G_{\rm corr}$ dier; from table 9 the former diers in sign as well as in magnitude with our result. It remains unclear, however, why the slope, and thus $G_{\rm kin}$, is much larger than naively expected; a similar analysis of the spectrum [12] showed deviations from the static limit in agreement with naive expectations. The decay constant may be unique in this respect, however, it is clear this should not be assumed, particularly for quantities such as semi-leptonic form factors of B mesons which are not protected by Luke's theorem.

By chirally extrapolating the results and interpolating to $1 = (aM_B)$, we nd f_B 126 166 MeV. The static renorm alisation factor, $Z_A^{\text{stat}} = 0.73 [17]^6$, is used, where we guess $aq_{Z_A} = 2.0$ at $aM_0 = 1$. To estimate the error in f_B due to the truncation of the NRQCD series we assume a 100% error in the quadratic coe cients of the heavy quark mass expansion. Thus, we nd a 20% uncertainty in f_B , which is comparable to the uncertainties arising from the light quark sector. This is likely to be an overestimate;

since the contributions from the kinetic energy term in the NRQCD action dom inate the slope, the corrections to the matrix element at O (1=M²) are unlikely to be larger than the quadratic contributions already present. Sim – ilarly, from the size of G_{kin} the next order spin-independent terms in the action, p^4 =8M³, are expected to lead to larger contributions to f_B than naively predicted, but this is unlikely to be larger than the lower order contributions. The O ($_{\rm S}$) 20% error in the slope introduced by using the static renorm alisation factor is less signi cant. In the static limit, we obtain $f_{\rm PS}^{\rm stat} = 237$ 295 MeV at $_1 = 0.1585$ which is close to $_{\rm S}$.

Our determination of f_B is consistent with the current world average of 200 (40) MeV [3]. Our analysis is being performed in conjunction with a simulation using = 6:0 quenched con gurations [24]. With such large system atic errors it is not possible to discern any di erence between the partial inclusion of dynam ical quarks in this analysis and quenched results. However, the decay constant is related to the wavefunction at the origin, $f_{\rm B} \stackrel{\prime}{\longrightarrow} \overline{M_{\rm B}} = \frac{1}{12} j$ (0) j and thus it is expected to be sensitive to short distance physics and the quenched approximation. Booth [23] has estimated 15% in $f_{\rm B}$ and the e ect of quenching to be 10 5% in $f_{B_{a}}=f_{B}$ using chiral perturbation theory coupled with HQET. However, the prediction is fairly dependent on the light quark mass. In the future we aim to reduce the system atic errors in both our quenched and dynam ical simulations by using tadpole in proved clover light ferm ions and including higher orders term s in the NRQCD expansion. Thus, we expect to isolate and rem ove the fulle ects of quenching.

With an experimental measurement of mixing also in the B_s^0 B_s^0 system only the ratio $f_{B_s}B_{B_s}=f_BB_B$ is required to extract $j_{ts}=V_{td}j$. Some cancellation of systematic errors is expected for this ratio, and hence it should be determined more accurately. Table 10 presents the results for $((f M)_s = (f M)_d)^{tot}$, where s and d denote results for a light quark mass extrapolated to the strange quark mass and the chiral limit respectively. The expected 0 (m s=M) dependence on the heavy quark mass is not resolved in our results and the ratio is independent of M₀. The error indicated is purely statistical. There is an additional 1 error due to the uncertainty in s.

6 Conclusions

W e presented a lattice study, partially including the e ects of dynamical quarks, of the heavy-light pseudoscalar and vector decay constants using W ilson light quarks and NRQCD heavy quarks. AllO (1=M) terms in the NRQCD action and matrix elements were included; an O (a $_{QCD}$ =M) wave-function renorm alization induced by the evolution equation is the same order as the light quark discretization errors. We indicate the extrapolation of the NRQCD result and the static case, as expected, although the static result is not very well determ ined. There are signi cant O (1=M²) corrections to f¹ M around M_B, and this leads to a large system atic error in extracting f_B; the use of W ilson light quarks introduces a system atic error of roughly the same magnitude. It is necessary to go to the next order in

 $N\,R\,Q\,C\,D$ and use an improved light quark action in order to reliably extract f_B .

We found the slope of the decay constants with 1=M to be signi cantly larger than that found in previous lattice simulations. We believe this is because we are closer to the static limit. In particular, for the 1st time we obtained the three O (1=M) contributions to the linear component of the slope separately. We found that G_{kin} dominates and thus is responsible for the large slope. Good agreement is found between our results for G_{kin} and physical combinations of G_{hyp} and G_{corr} and a prediction of QCD sum rules. The results show that the kinetic energy of the heavy quark gives rise to contributions to f^M much greater than O ($_{QCD}$), contrary to naive expectations.
