## Scalar Quarkonium Masses

We evaluate the valence approximation to the mass of scalar quarkonium for a range of dierent parameters. Our results strongly suggest that the in nite volume continuum limit of the mass of  $s\bar{s}$  scalar quarkonium lies well below the mass of  $f_J$  (1710). The resonance  $f_0$  (1500) appears to the best candidate for  $s\bar{s}$  scalar quarkonium.

For the valence approximation to the in nite volume continuum limit of the lightest scalar glueball mass, a calculation on GF11 [1] gives 1740 71 M eV, favoring  $f_J$  (1710) as the lightest scalar glueball. Am ong other observed resonances which could have scalar glueball quantum num bers, only  $f_0$  (1500) is near enough to 1740 MeV to be a possible alternate glueball candidate. Ref. [2] suggests that  $f_0$  (1500) is dominantly  $s\bar{s}$ scalar quarkonium. Evidence for this identi cation is given in Ref. [3]. As a test of the interpretation of  $f_0$  (1500) as  $s\bar{s}$  scalar quarkonium, we have now calculated, for W ilson quarks in the valence approximation, the mass of scalar quarkonium with two di erent values of lattice spacing and a range of di erent quark masses. Although the data we have is not su cient to perm it an extrapolation of scalar quarkonium masses to the continuum limit or to in nite volume, it is su cient to show that the continuum in nite volume value for the valence approximation to the  $s\bar{s}$  mass lies well below the mass of  $f_J$  (1710). This result, combined with the discussion of Ref. [3], favors  $f_0\,(1500)$  as  $s\overline{s}$  scalar quarkonium and m akes this interpretation for  $f_J$  (1710) appear im probable.

The calculations reported here were done on the GF11 parallel computer and required about 5 m onths of operation at a sustained speed of approximation 6 G ops.

To evaluate the mass of scalar quark-antiquark states, we de ne operators for these states by rst xing each gauge con guration to lattice C oulomb gauge, then convoluting, in the space direction, the W ilson quark eld  $_{\rm sc}$  (x) with a gaussian G  $^{\rm r}$  (x) with root-mean-squared radius r to produce a smeared C oulomb gauge quark eld

 $_{\rm sc}^{\rm r}$  (x) [4]. Here 1 s 4 and 1 c 3 are spin and color indices, respectively. We assume only a single avor of quark. In a gam ma-matrix representation with 5 given by the diagonal entries 1, 1, -1, -1, de ne the upper and lower quark elds

and de ne  $_{c}^{-ru}$  (x) and  $_{c}^{-rd}$  (x), similarly from  $_{sc}^{-r}$  (x) with  $_{s}$  in place of  $_{s}$ . Here the  $_{s}$ , for each s, are independent random cube roots of 1. The scalar operator

$$S^{r}(x) = -ru(x) ru(x) + -rd(x) rd(x);$$

when averaged over becomes the more familiar

$$S^{r}(x) = -r(x) r(x)$$

A pseudoscalar P  $^{\rm r}$  (x) and its average P  $^{\rm r}$  (x) can be de ned in analogy to S  $^{\rm r}$  (x) and S  $^{\rm r}$  (x).

For scalar correlation functions we choose




Figure 1. For the scalar propagator on a  $16^3$  24 lattice with of 5.70 and of 0.1650, the performance gain of a random source in comparison to a causal source.




Figure 2. For the pseudoscalar propagator on a  $16^3$  24 lattice with of 5.70 and of 0.1650, the perform ance gain of a random source in comparison to a causal source.

where averages are over and gauge eld congurations, with one random vector (1;:::4) for each eld. A pseudoscalar  $C_p^r$  (t) can be de ned similarly. The correlations  $C_S^r$  (t) and  $C_p^r$  (t) together require a factor of six fewer quark matrix inversions per gauge con guration than needed for  $C_S^{0r}$  (t) and  $C_p^{0r}$  (t) de ned with  $S^r$  (x) and  $P^r$  (x), respectively, used as both source and

sink operators. To obtain propagators with a xed statistical uncertainty, however, some of this factor of six will be lost to the additional noise arising from . Figure 1 shows the actual gain in arithmetic work for the scalar correlation,  $6\mathbb{D}_{S}^{0}$  (t)=D<sub>S</sub> (t)]<sup>2</sup>, where D<sub>S</sub> (t) and D<sub>S</sub><sup>0</sup> (t) are the statistical dispersions in C  $_{\rm S}^{\rm r}$  (t) and C  $_{\rm S}^{\rm (ir)}$  (t) respectively. Figure 2 shows the corresponding actual gain in arithmetic work for the pseudoscalar correlation. The values in Figures 1 and 2 were found from 188 independent gauge con gurations on a lattice 163 24 with of 5.70 and of 0.1650. For smaller we expect the gain to be greater. For the time intervals of our scalar mass ts, the actual gain turns out to be about a factor of 2. Without this factor, our vemonths of calculation would have required ten.

The cost of generating gauge eld con gurations and gauge xing we found could be reduced, for the scalar correlation function, by evaluating propagators for several di erent source time values on each lattice.




Figure 3. E ective scalar mass, tted mass and tting range for a  $1\hat{\theta}$  24 lattice with of 5.70 and of 0.1650.




Figure 4. E ective scalar mass, tted mass and tting range for a 24 lattice with of 5.93 and of 0.1567.

Figure 3 shows e ective masses, the tted mass, and the tting range for the scalar correlation function given by 1972 gauge con gurations on a lattice  $16^3$  24 w ith of 5.70, of 0.1650 and sm earing radius r of 6. For each gauge con quration, propagators were found from six di erent starting times. Figures 4 shows e ective masses, the tted mass and the tting range for the scalar correlation function given by 1733 gauge con qurations on a lattice 24<sup>4</sup> with of 5.93, of 0.1567 and r of 27=2. For each gauge con quration, propagators were found from four di erent starting times. In physical units, the quark mass and smearing radius in Figures 3 and 4 are nearly equal. Scalar and pseudoscalar m asses for several di erent at each are given in Tables 1 and 2. In Ref. [4], the rho mass in lattice units for  $16^3$  24 w ith of 5.70 and for  $24^4$  w ith of 5.93 was reported to be 0.5676 (79) and 0.3851 (79), respectively. Thus in physical units the lattice period at the two di erent values of we consider are nearly equal.

The  $s\bar{s}$  scalar m ass we found by interpolation in quark mass to the strange quark mass corresponding to hopping constants determined in Ref. [4] to be 0.16404 at of 5.70 and 0.15620




Figure 5. Scalar  $s\overline{s}$  quarkonium masses for two di erent values of lattice spacing.

of 5.93. The resulting masses, in units of [4], are shown in Figure 5 as a function of lattice spacing in comparison to the predicted scalar glueball m ass and the m asses of  $f_{\rm J}$  (1710) and  $f_0$  (1500). Figure 5 stongly suggests that for the xed volume we are using, the continuum value of the ss scalar mass will lie well below the mass of  $f_J$  (1710). Since the  $s\bar{s}$  scalar has one unit of orbital angular m om entum, its physics radius should be larger than that of the  $s\overline{s}$  m eson with no orbital angular m om entum. The scalar m ass divided by m should therefore fall with volume. Volum e dependence data for m in Ref. [4] then implies that in nite volume values of the scalar mass divided by m will be at most 2.8% above the numbers shown in Figure 5. Our qualitative conclusion about the scalar ss m ass remains the same in in nite volume. Thus for (1500) appears to be a likely candidate for the the ss scalar, while this assignment for f, (1710) appears quite unlikely.
