Random matrix triality at nonzero chemical potential

We introduce three universality classes of chiral random matrix ensembles with a nonzero chemical potential and real, complex or quaternion real matrix elements. In the thermodynamic limit we not that the distribution of the eigenvalues in the complex plane does not depend on the Dyson index, and is given by the solution proposed by Stephanov. For a nite number of degrees of freedom, N, we not an accumulation of eigenvalues on the imaginary axis for real matrices, whereas for quaternion real matrices we not a depletion of eigenvalues in this domain. This e ectpis of order 1=N. In particular for the real case the resolvent shows a discontinuity of order 1=N. These results are in agreement with lattice QCD simulations with staggered fermions and recent instanton liquid simulations both for two colors and a nonzero chemical potential.

Recently, nonherm itean random matrices with eigenvalues scattered in the complex plane have received a great deal of attention in both condensed matter [1{5] and QCD [6,7]. In condensed matter they have been used in problems ranging from neural networks [1] to the depinning transition of vortices in disordered superconductors [4,5]. In QCD, they are relevant at nonzero chemical potential when the Dirac operator is nonherm itean. In this letter we introduce three universality classes of nonherm itean random matrices with the global symmetries of the QCD partition function. This allow sus to interpret certain characteristic features of quenched D irac spectra at nonzero chemical potential (i.e. with the fermion determ inant ignored in generating the eld con gurations) as signatures of anti-unitary sym m etries. Such signatures have been found in condensed matter applications as well [2**,**3**,**5].

In quenched simulations of QCD it appears that the critical chem ical potential $_{\rm c}$ is proportional to the pion mass which vanishes in the chiral limit as $^{\rm D}$ m (m is the quark mass) rather than to the baryon mass which remains nonzero form ! 0 [8,9]. This long-standing puzzle has been resolved in a rst successful application of random matrix theory to QCD at nonzero chemical potential [6]. The explanation [10,6] is that the quenched limit is the limit N $_{\rm f}$! 0 of a partition function with the fermion determinant to the power N $_{\rm f}$ replaced by its absolute value. Such partition function develops a condensate with G oldstone bosons consisting of a quark and a conjugate quark. Meanwhile, several other studies have con med this work [7].

The above discussion was for N $_{\rm C}=3$. For N $_{\rm C}=2$ the situation is dierent [11]. Then the D irac operator is self-conjugate leading to a real ferm ion determ inant. Because in this case also baryons can be Goldstone bosons, we expect a critical chemical potential of $_{\rm C}$ $^{\rm P}$ $^{\rm m}$. M athematically, the D irac operator for N $_{\rm C}=2$ has an additional anti-unitary symmetry. As is well-known in random matrix theory, the anti-unitary symmetries lead to

three di erent universality classes [12,13] characterized by the so called Dyson index (= 1 for real, = 2 for complex, and = 4 for quaternion real matrix elements). In this letter we study a random matrix model of the QCD partition function at nonzero chemical potential for all three values of .

The continuum Euclidean QCD partition function for N $_{\rm f}$ avors with m asses m $_{\rm f}$, and them ical potential can be written as an average over the Y ang-M ills action,

where D is the Euclidean D irac operator and are Euclidean D irac matrices. In lattice QCD, the chem ical potential is incorporated by including a factor e in the forward time links and a factor e in the backward time links. This implementation does not a ect the symmetry relations discussed below.

To obtain a random matrix theory corresponding to (1) we set write the D irac operator in a chiral basis. Then the independent nonzero matrix elements are replaced by G aussian distributed random variables corresponding to the anti-unitary symmetries of the QCD partition function. In analogy with the random matrix partition function at zero [17] and nonzero temperature [14], for N $_{\rm f}$ avors, this partition function is de ned as (see [15] for a review)

Here, C is an arbitrary N N m atrix with real, complex or quaternion realmatrix elements. The integration measure D C is the Haarmeasure. The probability distribution P(C) is given by

From now on we will work in units where = 1.

In the case of N $_{\rm c}$ 3 (= 2) there are no anti-unitary sym m etries and the D irac operator is given by [6]

$$D () = \begin{cases} 0 & iC + \\ iC^{y} + 0 \end{cases} : (4)$$

Here, and in (6,8) below, is proportional to the identity. For N $_{\rm C}=$ 2, the D irac operator in (1) is subject to an additional anti-unitary sym metry [13]. We stress that a nonzero chemical potential does not violate this sym metry. For continuum fermions (and naive lattice fermions [16]) in the fundamental representation we have

where C is the charge conjugation matrix, and i D () is the continuum D irac operator at \bigcirc 0. B ecause (C $_2$ K) 2 = 1, it is possible to nd a basis in which the D irac operator is real. If we notice that $_0$ is H em itean we arrive at the following random matrix D irac operator

where C is an arbitrary real matrix. Quenched instanton $\sin u$ lations at 60 are in this class [18].

For staggered firm ions the gam m a m atrices are absent and for N $_{\rm c}$ = 2 the anti-unitary sym m etry is given by [19].

where D $^{\rm S}$ () is the staggered D irac operator at $\, \in \, 0$. Because ($_2$ K) 2 = 1, we can organize the matrix elements of the D irac operator into real quaternions. For an (anti-)H erm itean D irac operator the anti-unitary symmetry results in a pairwise degeneracy of the eigenvalues. This degeneracy is broken at $\, \in \, 0$. Then the eigenvalues of D $^{\rm S}$ occur in complex conjugate pairs. In this symmetry class with $\, = \, 4$ the random matrix model is given by

where the matrix elements of C are real quaternions and 1 is the unit quaternion. In addition to D S for N $_{C}$ = 2, this class also contains the D irac operator for gauge elds in the adjoint representation [13] for N $_{C}$ 2.

In all three cases the spectral density at = 0 is a sem icircle which in the normalization dened by (3) (with = 1) is given by

The above random m atrix m odels apply to universality classes in which the eigenfunctions at = 0 are extended.

The eigenvalues corresponding to localized wave functions are statistically independent with spectral correlations given by the Poisson ensemble. A random matrix m odel in this class without a chiral structure was recently considered in [4,5]. At & 0, it was found that eigenfunctions with complex eigenvalues are extended whereas eigenfunctions with real eigenvalues remain localized as for = 0. The surprising result of this study was that a localization transition was observed in one dimension. In the present context the extended states can be interpreted as the em ergence of a nonzero baryon number density when the eigenvalues scatter in the complex plane at 6 0. A nother remarkable result of this study [4] was that in the therm odynam ic lim it a nite number of eigenvalues remained on the real axis for below a criticalvalue. Below we will show that the fraction of purely im aginary eigenvalues of the model (6) with = 1 scales 1= N (Our convention and the conventions of [4,5] for the eigenvalues di er by a factor i.)

However, spectral correlations of the lattice QCD Dirac operator in four dimensions are given by the invariant random matrix ensembles [20] even for relatively weak coupling. Moreover, explicit calculations of the inverse participation ratio in an instanton liquid model shows delocalized Dirac eigenfunctions [21]. Therefore, it seems that the models in which the states are localized at = 0 are inappropriate for QCD applications.

In the rem ainder of this paper we study the spectrum of the random matrix model (2). The generating function is given by

The resolvent is de ned as G(z) = $Q_2 \log Z = n$ and the spectral density in the complex plane is given by $(x;y) = e_z G(z) = .$ The quenched approximation is obtained as the lim it n! 0 at the end of the calculation. For integer n, this partition function can be analyzed in standard fashion [22,6]. First we write the determinants as Grassmann integrals. Then we perform the average over the random matrices resulting in a 4-ferm ion interaction. If we bosonize this interaction and integrate out the ferm ions we arrive at a partition function that is am enable to a saddle point approximation. At θ 0 this analysis was performed by Stephanov for Hermitean random matrices. The analysis for = 1 and = 4is somewhat more complicated [22]. However, in both cases we succeeded to solve the saddle-point equations with the remarkable result that for the normalization dened by (3), the solution coincides with the one obtained for = 2. For all values of , the resolvent can be evaluated for arbitrary integer values of n. To leading order in 1=N we not the result is independent of n. Because of the absolute value of the determ in ant in (10) the generating function is a smooth function of n. This guarantees the existence of the replica lim it.




FIG. 1. Scatter plot of the real (x), and the imaginary parts (y) of the eigenvalues of the random matrix Dirac operator. The values of and are given in the labels of the gure. The full curve shows the analytical result for the boundary.

Numerical results for the random matrix ensembles dened in (4,6,8) are shown in Fig. 1. We show results for = 0:15 and = 0:5. The dots represent the eigenvalues in the complex plane. The full line is the analytical result [6] for the boundary of the eigenvalues given by the algebraic curve $(y^2 + 4^{-2})(^{-2} - x^2)^2 + x^2 = 4^{-2}(^{-2} - x^2)$. For = 1 and = 4 we observe that the spectral density deviates signicantly from the saddle-point result. For = 1 we nd an accumulation of eigenvalues on the imaginary axis whereas for = 4 we nd a depletion of eigenvalues in this domain. This depletion can be understood as follows. For = 0 all eigenvalues are doubly degenerate. This degeneracy is broken at 60 which produces the observed repulsion of the eigenvalues.

The number of purely in aginary eigenvalues appears to scale as \overline{N} , which explains that this e ect is not visible in a leading order saddle point analysis. From a perturbative analysis of $(\underline{1}0)$ one obtains a power series in 1=N. Clearly, the \overline{N} dependence requires a truly nonperturbative analysis of (2). Such a \overline{N} scaling behavior is typical for the regime of weak non-herm iticity rst identied by Fyodorov et al. [3].

A similar cut below a cloud of eigenvalues was found in instanton liquid simulations for N $_{\rm c}=2$ at 60 [18] and in a random matrix model of arbitrary real matrices [2]. The depletion of the eigenvalues along the imaginary axis was observed earlier in lattice QCD simulations with staggered fermions [23].




FIG.2. The fraction of real eigenvalues, $_0$ versus $^{\Gamma}$ N for three di erent values of and matrices ranging from N = 10 to N = 1000. The full line shows E fetov's result [12].

In Fig. 2 we plot the fraction of imaginary eigenvalues versus \overline{N} for equal to 0.05, 0.1 and 0.2 and \overline{N} range

ing from ten to one thousand. The full line represents the analytical result due to E fetov [5]

where $_{SC}$ is de ned in (9). This result was obtained for an ensemble of independent real symmetric matrices perturbed by an anti-symmetric matrix in the limit that the norm of the perturbing operator is of the order of the level spacing of the unperturbed matrix (his conventions dier from ours by a factor i). Apparently, the fraction of purely in aginary eigenvalues is not modified by the chiral structure of the ensemble (6). A symptotically, for \overline{N} 1, this fraction is given by 0 1= \overline{N} .

It is well known that the replica trick fails in some cases [24]. For example, it fails for the unquenched partition function [6]. More typically, it fails in cases where the the saddle-point is given by a nontrivial manifold [24]. In the limit! 0 and z real, the partition function has a higher degree of sym m etry. Therefore, in the lim it N! 1 with 2N xed, the solution of the saddle point equations is given by a nontrivial manifold, and there is no guarantee that the replica trick willwork. In order to obtain truly nonperturbative results one has to rely on the supersymmetric method for random matrix theory [25]. This method was extended to non-herm itean complex matrices in [26,3] and to arbitrary real matrices in [5]. The application of the supersymmetric method to the chiral ensembles will eventually provide us with an explanation of the scaling behavior of the number of purely imaginary eigenvalues ([27]).

Stephanov has shown analytically that the quenched approximation does not work for = 2. Specically, the unquenched partition function (2) for N $_{\rm f}$ 6 0 results in a nonzero chiral condensate below a critical value of . However in the quenched case, given by the n ! 0 $\lim_{t\to\infty} f(10)$, the chiral condensate is zero at any θ 0. The situation for = 1 and = 4 is di erent. Then in both cases the ferm ion determ inant is real for real z. (For = 4 this follows by using the identity $q = 2q_2$ for a quaternion real element q.) Therefore, for real z, the generating function (10) for n replicas is identical to the partition function (2) for 2n avors with mass z. As m entioned above, the saddle point result for the resolvent de ned by the generating function (10) does not depend on n and gives the quenched result for n! 0. We thus conclude that quenching works for an even number of avors. Consequently, chiral sym metry will be restored for arbitrarily small nonzero, whereas a condensate of a quark and a conjugate quark develops. Indeed, this phenomenon has been observed in the strong coupling lim it of lattice QCD with two colors [19,28].

In conclusion, at 60 we have found that the depletion of D irac eigenvalues on the imaginary axis observed in lattice QCD simulations and the accumulation of D irac eigenvalues found in instanton liquid simulations (both for two colors and quenched) is a generic feature related to the anti-unitary symmetries of the D irac operator. If it turns out that the D irac eigenfunctions are localized at =0 (see [29] for lattice results in this direction) the fraction of purely imaginary eigenvalues at 60 m ight remain nite in the thermodynamic limit. For two colors, this might lead to unexpected chiral properties in the continuum limit at 60. C learly, this possibility deserves further attention.
