B ! X_s ⁺ in a C P spontaneously broken two H iggs doublet m odel

The di erential branching ratio, CP asym metry and lepton polarization P_N for B ! X_s ⁺ in a CP spotaneously broken two H iggs doublet model are com - puted. It is shown that contributions of neutral H iggs bosons to the decay are quite signi cant when tan is large and P_N can reach ve persent.

The origin of the CP violation has been one of main issues in high energy physics. The measurements of electric dipole moments of the neutron and electron and the matter-antimatter asymmetry in the universe indicate that one needs new sources of CP violation in addition to the CP violation come from CKM matrix, which has been one of motivations to search new theoretical models beyond the standard model (SM).

The minim alextension of the SM is to enlarge the H iggs sectors of the SM. It has been shown that if one adheres to the natural avor conservation (NFC) in the H iggs sector, then a minimum of three H iggs doublets are necessary in order to have spontaneous CP violations¹. However, the constraint can be evaded if one allows the real and in age parts of $\begin{pmatrix} + \\ 1 & 2 \end{pmatrix}$ have di erent self-couplings and adds a linear term of Re($\begin{pmatrix} + \\ 1 & 2 \end{pmatrix}$) in the H iggs potential (see below Eq. (1)). Then, one can construct a CP spontaneously broken (and Z₂-symmetry softly broken) two H iggs doublet (2HDM), which is the minimal among the extensions of the SM that provide new source of CP violation.

R are decays B ! $X_s I^{\dagger} l$ ($l = e_i$) have been extensively investigated in both SM and the beyond ^{2;3}. The inclusive decay B ! X_s ⁺ has also been investigated in the SM, the model II 2HDM and SUSY models with and without including the contributions of NHB ^{4;5}. In this note we investigate the inclusive decay B ! X_s ⁺ with emphasis on CP violation e ect in a CP spontaniously broken 2HDM in which the up-type quarks get m asses from Yukawa couplings to the one Higgs doublet H₂ and down-type quarks and leptons get m asses from Yukawa couplings to the another Higgs doublet H₁. The contributions from exchanging neutral Higgs bosons now is enhanced roughly by a factor of tg² and can compete with those from exchanging ; Z when tg is large enough. We shall be interested in the large tan limit in this note.

Consider two complex $Y = 1 \text{ SU } (2)_w$ doublet scalar elds, 1 and 2. The Higgs potential which spontaneously breaks SU (2) U (1) down to U (1)_{EM} can be written in the following form ^{5;6}:

Herm iticity requires that all parameters are real so that the potential is CP conservative. It is easy to see that the minimum of the potential is at < $_1 > = v_1$ and < $_2 > = v_2 e^i$; thus breaking SU (2) U (1) down to U (1)_{EM} and simutaneously breaking CP, as desired.

In the case of large tan , if we neglect all term sproptional to c and taken s = 1 in the mass-squared matrix of neutral H iggs, one would get that one of the H iggs boson mass is 0, obviously which is conict with current experiments. So instead, below we will discuss a special case in which a analytical solution of the mass matrix can be obtained.

A ssum ing $4_{1}c^{2} = 4_{5}$ and neglecting other terms proptional to c in the mass-squared matrix, one obtains the masses of neutral H iggs bosons

with the mixing angle = $\frac{1}{2}$.

Then it is straightforward to obtain the couplings of neutral ${\rm H}\,i\!ggs$ to ferm ions

where f represents down-type quarks and leptons. The coupling of H $_3^0$ to f is not enhenced by tan and will not be given explicitly. The couplings of the charged H iggs bosons to ferm ions are the sam e as those in the m odel II 2HDM. This is in contrary with the m odel III⁷ in which the couplings of the charged H iggs to ferm ions are quite di erent from m odel II. It is easy to see from Eq. (3) that the contributions come from exchanging NHB is proportional to $2G_F s_{=2}c_{=2}m_f^2 = \cos^2$, so that we have the constraint pisin jtan < 50 from the neutron EDM, and the constraint from the electron EDM is not stronger this. The constraints on tan due to e ects arising from the charged H iggs are the sam e as those in the m odel II and can be found in ref.^{8;4}.

The transition rate for b! s + can be computed in the fram ework of

the QCD corrected e ective weak Ham iltonian

where O_i (i = 1; ;10) is the same as that given in the $2\pi g_{i}$'s come from exchanging the neutral H iggs bosons and are de ned in Ref.⁴.

The coe cients C $_{i}$'s at $= m_{W}$ have been given in the ref² and C_{Q i}'s are (neglecting the O (tg) term)

The QCD corrections to coe cients C $_i$ and C_{Qi} can be incooperated in the standard way by using the renorm alization group equations 4 . The explicit expressions of the invariant dilepton m ass distribution, CP asym m etries $A_{CP}^{\,i}$ (i= 1,2) in branching ratio and in forward-backward (F-B) asymmetry and norm alpolarization of lepton $P_{\rm N}$ for B ! X $_{\rm s}$ $^+$ can be found in ref. 5 .

The following parameters have been used in the numerical calculations: $m_t = 175G \text{ ev}; m_b = 5.0G \text{ ev}; m_c = 1.6G \text{ ev}; m = 1.77G \text{ ev}; = 1.724;$ $m_{H_1} = 100G \text{ ev}; m_H = 200G \text{ ev}:$ From the num erical results, the following conclusions can be drawn.A.The contributions of NHB to the di erential branching ratio d =ds are signi cant when tan is not smaller than 30 and the masses of NHB are in the reasonable region. For tan = 30, d =ds is enhenced by a factor of 6 compared to SM .B. The direct CP violation in branching ratio $A_{\rm CP}^1$ is of order 10 4 which is hard to be measured. C. The direct CP violation in F-B $A_{\rm CP}^2$ can reach about a few percents and is strongly dependent of the CP violation phase and com es mainly from exchanging NHBs, as expected. D. The CP-violating polarization $P_{\rm N}$ is also strongly dependent of the CP violation phase and can be as large as 5% for some values of , which should be within the lum inosity reach of coming B factord com es mainly from NHB contributions in the most of range of . So it is possible to discriminate the model from the other 2HDM s by measuring the CP-violated observables such as $A_{\rm CP}^2$, $P_{\rm N}$ if the nature chooses large tan $.^b$
