A generating function for all-orders skym ions

W e nd the generating functions for the Lagrangians of all-orders sum m able SU (2) Skyrm ions. W e then proceed to construct the explicit form of the Lagrangian, order by order in the derivatives of the pion eld for two classes of m odels.

I. IN TRODUCTION

A coording to the $1=N_c$ analysis [1,2], if an elective Lagrangian is to represent accurately the low-energy limit of QCD, it should behave as an elective theory of in nitely many mesons and include all orders of derivative of the elds. In that sense, the Skymemodel [3] represents a naive (fourth order in derivatives) attempt to provide such a description. Yet, stable solitonic pion eld con gurations (Skymions) emerge from this simple model. These solitons are interpreted as baryons and a number of their properties can be computed leading to many successful predictions. Unfortunately, the exact form of such a solution for the low-energy elective Lagrangian is out our reach for the moment and indeed, would be equivalent to a noting a solution for the low-energy limit of QCD and perhaps would provide an explanation to con nement. In the absence of such solutions, one must rely on more elaborate elective Lagrangians but in doing so one faces problem s: (i) the number of possible extensions, i.e. the number of possible terms at higher orders become es increasingly large, (ii) the degree of the equation of motion becomes any predictive power. Any one of these problem s causes the general approach to become e too com plex and its treatment intractable.

A suitable alternative is to impose symmetries or constraints that reduce this degree of arbitrariness and complexity but still retain the more interesting features and perhaps introduce new ones. A few years ago, we proposed such a class of tractable all-orders e ective Lagrangians [4]: Using the hedgehog ansatz for static solution, we required that the degree of the di erential equation for the prole function remains two. This induces all-orders Skymmions with a number of interesting properties: (i) they come from all-orders e ective Lagrangians that could account for in nitely many mesons, (ii) the Lagrangians being chirally invariant by construction, it allow sm ore control over chiral symmetry breaking since they can be implemented by hand afterwards, (iii) there remains some liberty in this class of models so that the physical constraints can be satis ed properly and predictions can be signi cantly improved [5,6], (iv) their topological and stability properties are similar and (v) in some cases new interesting features such as a two-phase structure [7] arise.

D espite these relative successes, an all-orders Lagrangian written in a closed form remained to be found. M ost of the calculations and constraints relied on an expression for the energy density of the static hedgehog solution. A full know ledge of the all-orders Lagrangian is required to analyze other types of solutions, generalize the m odel to SU (3) and hopefully nd a link to low energy QCD. In this work, we construct the most general all-orders Lagrangians for the class ofm odel introduced in [4] using a generating function. We then proceed to calculate the coe cients for the Lagrangian for any arbitrary order. This is done in Section III after a brief introduction of the all-orders Lagrangian in Section II. A sim ilar procedure is repeated for e ective Lagrangians induced by hidden gauge symmetry [8] and again, the coe cients for the Lagrangian are found for any arbitrary order in Section IV. This construction m ay have m uch deeper consequences since it is directly associated to an underlying gauge theory. Finally, the last section contains a brief discussion of the results and prospects for further analysis.

II. M ORE TERM S TO THE SKYRME LAGRANG IAN

Let us recall the Skyrm e Lagrangian density for zero pion m ass:

with the notation $L = U^{y}(0)$ and f [L;L]. The rst term, L_1 ; coincides with the non-linear -m odel when one substitutes the degrees of freedom in the SU (2) matrix U by - and - elds according to $U = \frac{2}{F}$ (+i). The second term, L_2 , contains higher order derivatives in the pion eld and can account for nucleon-nucleon interactions via pion exchange. L_2 was originally added by Skym e to allow for solitonic solutions. F is the pion decay constant (186 M eV) and e is the so-called Skym e parameter. Unless F and e are explicitly mentionned, we shall use more appropriate units in which the Lagrangian rescale as

and the unit of length is now $\frac{2^{p} \overline{2}}{e^{F}}$ and the unit of energy is $\frac{F}{2^{p} \overline{2}e}$:

In its fam iliar hedgehog form , the SU (2) matrix U is expressed as follows:

where F(r) is called the chiral angle or probe function of the solution. This eld conguration constitutes a map from physical space R³ onto the group manifold SU (2) and is assumed to go to the trivial vacuum for asymptotically large distances. We therefore impose U (r ! 1) ! 1. From this last condition, one may derive the existence of a topological invariant associated with the mapping. The originality of Skymme's idea was to identify this invariant, i.e. the winding number, with the baryon number.

For a static hedgehog solution, the energy density is given by $E = E_1 + E_2$ where the srt contribution comes from the non-linear -m odel

with a $\frac{\sin^2 F}{r^2}$ and b $F^{(2)}$: Although L_2 is quartic in the derivatives of the pion eld, E_2 adds only a quadratic contribution in F° to the Lagrangian for the static hedgehog solution.

D expite the relative successes of the Skyrm e model, it can only be considered as a prototype of an elective theory of QCD. For example, there is no compelling reason or physical grounds for excluding higher order derivatives in the pion eld from the elective Lagrangian. Indeed, large N_c analysis suggests that bosonization of QCD would most likely involve an in nite number of mesons. If this is the case, then taking the appropriate decoupling limits (or large mass limit) for higher spin mesons leads to an all-orders Lagrangian for pions. One example of higher order terms is a piece involving B ; the topological charge density [6],

leads to a sim ilar results.

Several attempts were made to incorporate vector mesons in the Skymme picture. Following this approach, we have proposed [5] a procedure to generalize the Lagrangian density to include all orders in the derivatives of the pioneld in a computationally tractable way. In this work, we go a step further and will not the exact form of Lagrangian density at any arbitrary order.

At this point however, it is useful to invoke some relevant links noticed by M anton [9] between an elective SU (2) scalar Lagrangian and the strain tensor in the theory of elasticity. As in nonlinear elasticity theory, the energy density of a Skyrm electron eld depends on the local stretching associated with the map $U : \mathbb{R}^3$ 7 S^3 : This is related to the strain tensor at a point in \mathbb{R}^3 which is defined as

where i; j refers to the cartesian space coordinates. M_{ij} is a 3 3 sym metric matrix with three positive eigenvalues X^2 ; Y^2 ; Z^2 . The vectors X; Y; Z are orthogonal here since they are the principal axes of the strain ellipsoid in this context. There is a simple geometrical interpretation (due to M anton) for these objects. They correspond to the changes of length of the images of any orthogonal system in the space manifold. There are only three fundamental invariants of M_{ij} with each a simple geometric meaning

Som etim es, it is convenient to use a more general ansatz [10] in which case the energy contributions to the st three orders take the form

Since these are the three fundam ental invariants in an orthogonal system, all higher-order Lagrangians can be constructed out of these invariants. Another important quantity can also be written in term of these objects, the topological charge density

The angular integration is trivial in this case.

Let us consider the Lagrangian of an all-orders Skyrm e-like model. In general, it contains even powers of the left-handed current L , but in an orthogonal system, the static energy density is always a combination of the three invariants e.g. E_1 ; E_2 and E_3 : It turns out that one can construct a special class [4] of models whose energy density E is at most linear in b (or of degree two in derivatives of F). The static energy density coming from the Lagrangian of order 2m in derivatives of the form

for the hedgehog ansatz. The full Lagrangian leads to

where $(x) = \int_{m=1}^{P} h_m x^m$ and $(x) = \frac{d}{dx}$ and to a prole equation which is computationally tractable since it is of degree two. In some cases, it is more appropriate to construct Lagrangians as m powers of the commutators f [L ; L]; this leads to vanishing energy density E_{2m} form odd 5. Jackson et al [6] found an elegant expression for the total energy density in terms of the vectors X ; Y ; Z

where a;b;c are de ned in (7). Note that both the numerator and the denom inator are antisymmetric in a;b;c but the total expression is symmetric as should be expected since E is a combination of the three invariants E_1 ; E_2 and E_3 : A s far as we know however, there seems to be no fundamental or geometric grounds that would justify such a form. Moreover, (10) is not very practical for our purposes since it cannot be easily converted to an expression in terms of the three invariants E_1 ; E_2 and E_3 :

The mass of the soliton is then written as:

with a $\frac{\sin^2 F}{r^2}$: The Skym e Lagrangian corresponds to the case (a) = $_{\rm S}$ (a) $a + \frac{1}{2}a^2$. In the absence of an exact solution for QCD that would provide a link to a Skym e-like Lagrangian, one could consider the toy models in the form of an exponential or a truncated geom etric series:

whose phenom enological in plications can dier signi cantly from the original Skyrm em odel.

It should be emphasized that although this class of tractable Lagrangians was originally de ned assuming the hedgehog ansatz (i.e. spherically symmetric solution), the same conditions apply for any orthogonal system (i.e. X = Y = X = 0) as long as any two of the three invariants are equal in which case one can write $a = \frac{2}{5} X^2$; $b = Y^2$ or $a = Y^2 = Z^2$; $b = X^2$ or $a = X^2 = Y^2$; $b = Z^2$. One can easily construct such a solution by making a conform altransform ation on the hedgehog ansatz for example.

As was pointed out by Jackson et al. in ref. [6], E_m is a function of the three invariants E_1 ; E_2 and E_3 which obeys the recursion relation

Extending this result, it is easy to see that a similar relation holds for the Lagrangians (since $L_m ! E_m$ in the static limit)

At this point, we must stress on the importance of being able to construct the Lagrangian L_m at an arbitrary order 2m. First the Lagrangian L_m is evidently a more fundam ental object than the energy density E_m since it de nes how the scalar elds interact with each other. Secondly, the recursion relation (12) only holds for the hedgehog ansatz but it is su cient to impose the condition (13) on the Lagrangians. Finally, once the Lagrangian is known at any arbitrary order, it is possible to not other solitonic solutions, compute their time dependence and, generalize the model from SU (2) to SU (3) case or exam ine other extensions of the Skyrm emodel.

Let us rewrite the recursion relation (13) as

Here x is an auxiliary variable introduced for calculational purposes but one could interpret this variable as a scaling factor in the Skyrm e model. Indeed, under a scale transform ation r! r, the Lagrangian u_m which is of order 2m in derivatives scales as

The coe cients C $n_1n_2n_3$ for $m = n_1 + 2n_2 + 3n_3 < 4$ are easy to nd by inspection

Sum m ing up, the full all-orders Lagrangian giving an energy density at m ost quadratic in F 0 has the form

IV.HIDDEN GAUGE SYMMETRY

In this section, we exam ine the construction of a generalized Skyrm e Lagrangian based on the hidden gauge symmetry (HGS) formalism [8,4,11]. The procedure consist in introducing higher-order gauge terms to the Lagrangian to describe free vector mesons (for example SU (2) gauge eld kinetic Lagrangian $\frac{1}{4}$ TrF F) and in the substitution of the derivative by a covariant derivative to account for scalar-vector interactions. For SU (2) chiral symmetry, the HGS formalism is based on the SU (2)_L SU (2)_R SU (2)_V manifold where SU (2)_V is gauged. The most general Lagrangian involving only two eld derivatives is expressed as

$$L_{1}^{HGS} = \frac{F^{2}}{16} [Tr L^{y}D L R^{y}D R^{2} Tr L^{y}D L + R^{y}D R^{2}]$$

where $L(x) \ 2 \ SU(2)_L$ and $R(x) \ 2 \ SU(2)_R$. D stands for the covariant derivative @ $igV^k \frac{k}{2}$ where V is the hidden gauge eld. When the gauge vector eld is dynamical then a second piece $L_2^V = \frac{1}{4} \operatorname{TrF} F$ is added to the Lagrangian. The vector boson V acquires its mass from the same mechanism as the standard gauge bosons with result $m_V^2 = 4 \ g^2 F^2$. In the large mass lim it of the vector mesons, they decouple and an elective self-interaction for scalarm esons arise as $F = [D \ ;D \]! f \quad [L \ ;L \]. Finally, in that lim it, <math>L_1^{HGS}$ becomes the non-linear -m odel L_1 whereas L_2^V coincides with the Skyrm eterm L_2 .

Following this approach, we have proposed to represent contributions of order 2n in the derivatives of the pioneld in terms of the trace of a product of n f 's. Such terms would presumably come from gauge invariant quantities involving a similar expression with n eld strengths F and would describe exchanges of higher spin mesons. For example, the lowest-order gauge invariant contributions may have the form

The choice of such combinations is motivated by the possibility that they could be induced by hidden gauge sym metry (HGS) term sbut they also correspond to exchanges of higher spin particles. They are autom atically chirally invariant. Chiral sym metry breaking must be introduced independently, usually by adding a pion mass term, which means that in principle, one has more control on the sym metry breaking mechanism. As we can see from the rst of the above expressions, the Skymmeterm itself emerges from the gauge eld kinetic term in the limit of large gauge vector mass in this form ulation.

Furtherm ore, one can construct a special class [4] of such combinations which is at most linear in b (or of degree two in derivatives of F). These Lagrangians are a subset of those described in the previous section. They give a very simple form for the hedgehog energy density (sim ilar to eq. (9))

$$\mathbf{\hat{E}}_{2m} = a^{2m} \, \left[\beta a + 2m \, (b \ a) \right] \tag{20}$$

where m is an integer. It leads to a chiral angle equation which is tractable since it is of degree two.

It turns out that for this class of Lagrangians $\mathbf{\hat{E}}_m = 0$ for m odd 5 so we only need to consider Lagrangians which are of order 4m in derivatives of the pion eld and have the form $\mathbf{\hat{E}}_{2m}$ Tr(f)^{2m}. Although the constraints look sim ilar, the Lagrangian $\mathbf{\hat{E}}_{2m}$ is dimensioned in a Lagrangian of the same order in derivatives L_{2m} described in the previous section since the latter being a combination of L_1 Tr(L_1L_1) whereas $\mathbf{\hat{E}}_{2m}$ only involves f 's: Yet it possible to write a recursion relation sim ilar to (12) for the static energies

in terms of the three fundam ental invariants \mathbb{E}_2 ; \mathbb{E}_4 and \mathbb{E}_6 : \mathbb{E}_{2m} arises from the Lagrangian \mathbb{E}_{2m} which obeys

w ith

$$\begin{split} \mathbf{\hat{F}}_{2} &= \frac{1}{16} \, \mathrm{Trf} \ \mathbf{f} \\ \mathbf{\hat{F}}_{4} &= \frac{1}{64} \ \mathrm{Trf} \ \mathbf{f} \ \mathbf{f}$$

Again we are interested in a closed form for \mathbb{P}_{2m} at any arbitrary order, i.e.

$$\mathbf{\hat{E}}_{2m} = \sum_{\substack{n_1, n_2, n_3 = 0}}^{X^1} \mathbf{C}_{n_1, n_2, n_3} \mathbf{\hat{E}}_{2}^{n_1} \mathbf{\hat{E}}_{4}^{n_2} \mathbf{\hat{E}}_{6}^{n_3}$$

with $m = n_1 + 2n_2 + 3n_3$: Using the generating function technique, we see that the procedure is identical to that in the Section III upon the substitution $u_m = I_{2m}^0$ for any integer m: The full all-orders Lagrangian in derivatives of the pion eld give rise to an energy density at most quadratic in F⁰ and has the form

$$\mathbf{E} = \mathbf{L}_{1} + \sum_{\substack{m = 1 \\ m = 1}}^{N} \mathbf{E}_{2m} \tag{21}$$

where the st term is the nonlinear sign a model and the remaining of the expression accounts for the Skyrm e term and higher-order term s. In this class of models, contributions of order 4m + 2 in derivatives of the pion eld are absent.

Following the HGS form alism, this Lagrangian corresponds to the large mass limit of the vector mesons of a class of scalar gauged eld theory described by the Lagrangian

$$L = L_1^{H G S} + \sum_{m = 1}^{X^{1}} h_{2m} L_{2m}^{V}$$

where L_{2m}^{V} is obtained from B_{2m} upon substitution f ! F : The study of such theories and their justi cation based on physical grounds remains to be addressed.

V.CONCLUSION

Under their respective constraints, both (18) and (21) describe the most general all-orders Lagrangians. However some speci c models are worth mentionning. For example, a simple choice of coe cients $h_m = 1$ corresponds to static energy densities

respectively and are induced by the Lagrangians written only in term s of the generating function

$$\mathbf{E} = \mathbf{L}_{1} + \mathbf{G} (\mathbf{L}_{2}; \mathbf{L}_{4}; \mathbf{L}_{6}; 1) = \mathbf{L}_{1} + \frac{\mathbf{E}_{2} + (\mathbf{E}_{2}^{2} + \mathbf{E}_{4}) + \mathbf{E}_{6}}{1 + \mathbf{E}_{2} - \mathbf{E}_{4} + \frac{1}{3}\mathbf{E}_{6}}$$

In general, the term in the numerator of the generating function is not analytic so the expression must be understood as the correct analytic continuation of its series representation. In both cases, we chose $c_1 = 0$ since it only adds a constant piece to the full Lagrangian and otherwise would lead to an in nite energy solution. This result is easily generalized to the model with coe cients $h_m = h^m$ since it is equivalent to a scale transformation and may be performed through the change of variables a ! ha; L_1 ! L_1h ; L_2 ! L_2h^2 ; L_3 ! L_3h^3 in the above expressions.

Let us now exam ine the Lagrangian in expression (22). For the hedgehog ansatz, we nd an energy density

$$E = \frac{E_1 + (E_1^2 - E_2) - E_3}{1 - E_1 + E_2 - \frac{1}{3}E_3}$$
(24)

where $E_1; E_2$ and E_3 are given by (8). This energy density E is obviously symmetric in a;b;c (for the hedgehog ansatz a = c) yet, it coincides with the energy density E_J given by the formula (10) of Jackson et al, i.e. the ratio of two antisymmetric expressions. For this rather simple model, it turns out to be possible to proceed backwards and deduce the full Lagrangian from E_J : Starting from

$$E_{J} = \frac{(a \ b)^{3} \ \frac{c}{1 \ c}}{(a \ b) \ (b \ c) \ (c \ a)} + (c \ a)^{3} \ \frac{b}{1 \ b}}{(a \ b) \ (b \ c) \ (c \ a)}$$

and collecting terms which scale identically in the numerator and in the denominator, one can recast the energy density as

$$E_{J} = \frac{(a + b + c) + (a^{2} + ab + ca + b^{2} + bc + c^{2})}{(1 + (a + b + c) + (ab + bc + ca) - abc)}$$

This is equivalent to (24) and suggest that the full Lagrangian has precisely the form in (22). A similar procedure can also be used for models where (a) is a rational function (quotient of two polynomials in a) e.g. $_{II;M}$ (a); $_{V}$ (a) and $_{VI}$ (a) in (11) but the complexity of calculations rises as the degree of the polynomials increases. On the other hand, these models are also easy to obtain in terms of the generating function G: M ore elaborate models requires the general expressions (18) and (21).

It is easy to show $E = E_J$ holds for any model represented by a function $(x) = \prod_{m=1}^{P} h_m x^m$ in (10) using the most general form

and (8). C learly, this result was to be expected since both constructions are based on the same constraints for the energy density. So besides noting the complete form of the most general all-orders Lagrangians, we have come up with a way to write the energy density in terms of polynom ials symmetric in a;b;c.

In principle, it is possible to get an expression for the full Lagrangians written in term of the generating function G only, for any model in this class, e.g. models de ned in p(11). Note that in some cases, it may be more convenient to work with the exponential generating function, $E(x) = \int_{m=1}^{1} \frac{1}{m!} u_m x^m$.

In sum mary, the generating function G was constructed for the class of models in which the energy density for the hedgehog ansatz is at most quadratic in F⁰ and therefore computationally tractable. It led to an explicit expression for the coe cients C $_{n_1;n_2;n_3}$ in (18) and (21). But now that the full Lagrangians are known, a number of questions remain to be addressed: (a) Solutions other than the N = 1 static hedgehog can now be analyzed thoroughly. For example, one can propose a di erent or a more general ansatz according to (6). (b) A lso, solutions for N > 1 skyrm ions should be exam ined either by a direct numerical calculation or a convenient ansatz (such as rational maps [12]). (c) It is now possible to write the time dependence for this class of models for which perhaps one could eventually provide a proper description.(d) The all-orders Lagrangians also allow to study analytically the identity m ap and to construct the mode spectrum in a closed form. Finally, the know ledge of this class of Lagrangians allows (e) to extend the models, for example in an extension from the SU (2) to the SU (3) symmetry group or (f) to use it in other areas, such as in weak skyrm ions, baby skyrm ions, etc...
