A Possible Universal Treatment of the Field Strength Correlator in the Abelian-Projected SU (2)-Theory

A bstract

An integral relation between two functions parametrizing the bibcal eld strength correlator within the Stochastic Vacuum M odel is obtained in the elective A belian-projected SU (2)-theory. This relation is independent of the concrete properties of the ensemble of vortex loops, which are present in the theory under study. By virtue of the lattice result stating that the infrared asym ptotic behaviours of these functions should have the same functional form, the obtained relation enables one to ind these behaviours, as well as the infrared asym ptotics of the bibcal correlator of densities of the vortex loops. Those turn out to be exponentials, decreasing at the inverse m ass of the dual vector boson, times certain polynom ials in the inverse integer powers of the distance. This result agrees with the general predictions and the existing lattice data better than the results of previous calculations, where these powers were found to be half-integer ones.

Stochastic Vacuum M odel (SVM) [1] (see [2] for reviews) is now adays commonly argued to be one of the most successful nonperturbative approaches to QCD. However, an important problem still requiring its clarication is the derivation of the bibcal eld strength correlator, which is the main quantity in SVM, from the QCD Lagrangian. To simplify this problem it is natural to consider such a correlator in Abelian-type models, which allow for the analytical description of con nement. In this way, in the recent paper β], the bibcal correlator has been calculated in the e ective Abelian-projected [4] SU (2)- and SU (3)-theories. Those are just the 4D dual G inzburg-Landau (type theories, in which con nement is realized as the dual M eissner e ect according to the 't Hooff-M andelstam scenario [5]. The main di erence of the calculation perform ed in Ref. [3] w.r.t. the pure classical calculations perform ed before [6] was the account for quantum vortex loops present in the above-m entioned theories. Being virtual (and therefore sm all-sized) objects, these loops have been treated within the natural, from the point of view of the standard superconductivity [7], m odel in which they form a dilute gas [8].

The aim of the present Letter is to improve on the calculation performed in Ref. [3] and to nd the bilocal eld strength correlator without any assumptions imposed on the ensemble of vortex loops. Such a model-independent study may become possible by virtue of the lattice data on the SVM correlator [9, 10, 11] (see [12, 13] for recent reviews). The present approach is based on the above-mentioned commonly accepted belief that con nement can really be viewed as the dual superconductivity. Clearly, it is this statement which enables one to employ the lattice results on the SVM correlator in QCD for the evaluation of an analogous quantity in the dual G inzburg-Landau (type theories. In this respect, it is worth noting that recently a new support was given to the 't Hooff-M andelstam scenario of con nement (and consequently to the dual A belian-type m odels) by the evidence of monopole condensation on the lattice [14] (see Ref. [12] for a review).

In what follows, we shall carry out our analysis for the simplest SU (2)-case, although the generalization to the SU (3)-case along with the lines of Ref. [3] is straightforward. Within the so-called Abelian dominance hypothesis [15], stating that the o -diagonal degrees of freedom are irrelevant to con nement, the electric IR theory under study can be shown (see e.g. [16]) to be nothing else, but the dual Abelian H iggs model with external electrically charged particles (quarks). In the London limit, i.e. the limit when the mass of the dual H iggs eld is much larger than the mass of the dual vector boson, the respective action reads 1

Here, is the phase of the dual Higgs eld describing the condensate of monopole C ooper pairs, is the v.e.v. of this eld, and $2g_h$ is its magnetic charge with g_m being the magnetic coupling constant related to the electric one, g, as $g_m g = 4$. Next, in Eq. (1), B stands for the gauge eld dual to the diagonal gluonic eld \vec{A} , and F^e is a eld strength tensor of an external quark obeying the equation (e $F^{e}(x) = g_{c}^{H} dx$ () (x x()), where $\tilde{O} = \frac{1}{2}$ " O. Note that the eld contains the multivalued part which describes dual A brikosov-Nielsen-O lesen strings [17].

The latter ones can either be open (those end up at the contour C and provide the con nem ent of a quark m oving along this contour) or closed. Such closed strings with m inim al opposite winding num bers couple to each other and form virtual bound states, called vortex loops [7, 8].

W ithin the SVM, the (irreducible) bilocal eld strength correlator can be param etrized by the two coe cient functions, D (x^2) and D₁ (x^2), as follows:

Note that it isthe coupling of the dual eld B to the currents of C ooper pairs j^m's, which yields nonperturbativecontents of the functions D and D₁ in the m odel under study.

In Ref. [3], the following system of equations for the functions D and D $_1$ has been obtained:

Here, D_m (x) $\frac{m}{4^{-2}x_1}K_1$ (m jx) is the propagator of the dual vector boson of the mass m, $m = 2g_m$, $^{+R}_{x^2}$ dtD 1 (t). Finally, in K 's henceforth stand for the modi ed Bessel functions, and G $(x^{\! 2})$ Eqs. (3) and (4), g(x) denotes a scalar function param etrizing the bilocal correlator of densities of the vortex loops, h (y)i (with the average taken over the ensemble of these loops), as (x) (y)i= " $Q^{x}Q^{y}g(x y)$. Although the tensor structure of this expression follows:h (x) " xed by the condition of closeness of the vortex loops, @ is unam biquously = 0, the form of the function g(x) depends on the properties of the ensemble of these objects.² (In particular, in Ref. [3], this function has been found in the fram ework of a dilute gas model for the ensemble of vortex loops.) As we shall see below, the IR asymptotics of the function q(x) can be found without any model assumptions, but rather on the basis of the statem ent that the respective asymptotics of the D – and D $_1$ -functions have the same fall o $\,$, as it is suggested by the lattice data [9, 10, 11, 12, 13].

To proceed with the study of the system (3)-(4), notice that the integrals over z standing in these equations can be carried out [in Eq. (3), by doing rstly the double partial integration] by virtue of the form ula d^4uD_m (x u) D_m (y u) = $\frac{1}{8^{-2}}K_0$ (m jx y).³ This yields

D i eventiating Eq. (6) w.r.t. x^2 , one can completely eliminate the g(x)-dependence from the resulting system of equations without solving them w.r.t. this function. This yields the following relation between D and D₁, which is thus independent of the properties of the ensemble of vortex loops:

By imposing some relation on the IR asymptotics D^{as} and D_{1}^{as} of the functions D and D_{1} , one can employ Eq. (7) in order to ind these asymptotics explicitly. The simplest relation of this kind can be imposed by disregarding the perturbative-type contributions to D^{as} and D_{1}^{as} , which yields $D_{1}^{as} = D^{as}$ with ' 0:3 [10]. Implementing this relation into Eq. (7) and dimensioning the IR asymptotics of that equation wirt. x^{2} we get

The details of calculation of the last integral up to the term s of the order of 1 = are outlined in the Appendix, and the result has the form

The coe cients here read: $C_1 = \frac{1}{21 (3-4)}$, $C_2 = \frac{4^p \overline{a}}{15 (1-4)}$, $C_3 = \frac{4a}{77 (3-4)}$, $C = C_1 + C_2 + C_3$ with \ denoting the gamma function. Thus we see that the lattice-inspired suggestion that the IR asymptotic behaviours of both functions D and D₁ are proportional to each other yields for those the exponential fallo at the inverse m ass of the dual vector boson times some polynom ial in the inverse integer powers of the distance. Such a preexponential behaviour diers from that of the classical calculation [6] and the one which was obtained in the dilute gas model of the ensemble of vortex bops [3]. Indeed, in that cases the preexponentials were half-integer inverse powers of the distance, which is less favourable from the point of view of the lattice data [9, 10, 11, 12, 13].

Let us now investigate the stability of the obtained solution (10) w.r.t. som e possible power-like corrections. Namely, let us insert into Eq. (8) the following modiled Ansatz:

(12) in the form $D_1^{as} = D_1^{as(0)} + "D_1^{as(1)}$. Thus, to check the stability of the obtained solution (10), one should nd $D_1^{as(1)}$ and prove that it is not dram atically large w.r.t. $D_1^{as(0)}$. The leading term of the latter one reads Be , where B $\frac{8^P 2a^{7-4}Cm^4}{3=2}$, and for the desired function $D_1^{as(1)}$ we get the following equation:

This equation is straightforward to be integrated, and the resulting integral can be evaluated in the large- lim it by virtue of the known asymptotics for the probability integral [19]: $p^2 = \int_{0}^{R} dt e^{-t^2}$! $1 = p^2 = \frac{e^{-x^2}}{x}$ at x 1. In this way, we obtain $D_1^{as(1)} = D_1^{as(0)}$, and thus nally $D_1^{as} = B(1 = 0)^{as(1)}$. We conclude that while " 1, i.e. for small enough , namely (ln ²) ¹, contributions to the obtained solution (10) stemming from the power-like correction (11) are small, and thus this solution is stable.

It is also worth making the following comment. In previous calculations, the functions D (x^2) and G (x^2) were obviously proportional to some propagators. For example, in the classical approximation those were just D_m [see the set terms on the R H S.'s of Eqs. (3)-(4)]. However, this fact is not valid any more in the present approach. W hile this statement is obvious for the D-function whose IR asymptotics is given by Eq. (10), some comment is in order for the function G (x^2) . Namely, we should check that the leading term in the IR asymptotics of this function di ers from the respective asymptotics of any propagator. In this way, we have

which explicitly proves our statem ent⁴. The fact that in the present approach the functions D and G are not proportional to any (m assive) propagator m akes it closer to QCD than the previous ones. Indeed, would such a proportionality takes place in QCD, it m ight be suspicious of the appearance of an asymptotic state carrying colour in some processes involving the bilocal eld strength correlator.

A nother comment which is in order concerns the comparison of the preexponent in Eq. (10) with the respective value known from the lattice measurements. In this way, we immediately face the following problem. Namely, in our calculation we employed the assumption that D^{as} D_1^{as} at 1. This relation has been checked on the lattice for the quenched SU (3) QCD in Ref. [10] within the interval of distances between 0.4 fm and 1 fm, which corresponds to the values of in

 $^{^{4}}$ M oreover, assuming that Eqs. (10) and (13) remain valid also for jxj m 1 , one can explicitly see that the Fourier transforms of these functions possess only cuts rather than poles. Indeed, in that case we have for the leading terms of the D - and G -functions:

the range between 1.8 and 4.6. However, it is straightforward to see that the $\frac{1}{2}$ -term on the R H S. of Eq. (10) becomes smaller than C only for 5:3. This means that the assumption on the proportionality of D^{as} and D^{as}₁, which led to Eq. (10), should be extended to the distances exceeding those which were used up to now in the lattice measurements. Thus, since these measurements yield the preexponential factor at the distances where the next-to-constant terms on the R H S. of Eq. (10) are important, the only way to get this factor within our approach is to integrate numerically the exact (rather than the asymptotic) equation for the function D down to that distances. Such an equation is given by the form ula (8) with the asymptotic function F replaced by the exact one:

By virtue of the MATHEMATICA program, one gets for the quantity D (2) e =m 4 at $j_x j$ = 0.4 fm the value 0.03, which di ers in one order from the lattice result [10] equal to 0.32 (3). Clari cation of the origin of this num erical discrepancy requires more precise investigations, which will be performed in future publications.

Finally, by virtue of the obtained results it is also possible to derive the IR asymptotics of the bilocal correlator of densities of the vortex bops, i.e. the function g(x). To this end, let us apply the operator ($Q^2 = m^2$) to both sides of Eq. (6) di erentiated w.r.t. x^2 , which yields

This IR behaviour of the function g(x) di ers from the one obtained in Ref. [3] within the dilute gas model for the ensemble of vortex loops. In particular, the obtained expression does not contain the asymptotics of the massless propagator, which in that case was the origin of a novel nonperturbative $1=jxj^4$ -term in the D₁-function. In fact, this term in the function D₁ is now absent, which could be anticipated beforehand owing to the equation $D_1^{as} = D^{as}$. Clearly, due to this equation, if such a term was present in the function D₁, it would unavoidably appear in the function D as well. The latter fact would how ever contradict the general principles of SVM [1, 2], which state that the nonperturbative part of the function D cannot contain any $1=jxj^4$ -term.

In conclusion of the present Letter, on the basis of the 't Hooff-M andelstam scenario of connem ent [which suggests that the dual Abelian Higgs model is relevant to the description of con nem ent in the SU (2)-QCD] and the lattice result on the bilocal eld strength correlator in QCD (which states that the IR asymptotic behaviours of the two coe cient functions param etrizing this correlator in SVM have the same exponential form), we have derived the IR asymptotics of this quantity in the London lim it of the dual Abelian Higgs model. In this way, the dem and of correspondence with the above-mentioned lattice result enabled not to employ any particular model of the ensemble of vortex loops, present in the theory under study. It rather occurred that the proposed approach yielded as a by-product the bilocal correlator of densities of the vortex bops itself. As far as the eld strength correlator is concerned, it turned out to decrease exponentially at the inverse mass of the dual vector boson with the preexponential given by a certain polynom ial in the inverse powers of the distance. These powers were found to be integer ones, which is in the better agreement with the existing lattice data than the half-integer powers found in the previous calculations. Besides that, the obtained leading terms in the IR asymptotic behaviours of the functions describing the surface and contour exchanges by means of the bilocal

eld strength correlator have been found to be di erent from that of the massive propagator. This result is more favourable from the point of view of QCD than the opposite one obtained in the previous approaches.

The constants C_1 , C_2 , and C_3 entering this result, are introduced after Eq. (10). Finally, taking into account that $1 \quad \frac{1}{a} \frac{\theta}{\theta^2} \stackrel{q}{=} e = 1 + \frac{q}{2a} + 0 \quad \frac{1}{2} \quad e$, we arrive at Eq. (10) of the main text.
