# A P ossible U niversal Treatm ent of the F ield Strength C orrelator in the A belian -P ro jected SU (2)-T heory

## A bstract

An integral relation betw een two functions param etrizing the bilocal eld strength correlator w ithin the Stochastic Vacuum $M$ odel is obtained in the e ective Abelian-pro jected SU (2)-theory. This relation is independent of the concrete properties of the ensemble of vortex loops, which are present in the theory under study. By virtue of the lattioe result stating that the infrared asym ptotic behaviours of these functions should have the sam e functional form, the obtained relation enables one to nd these behaviours, as well as the infrared asym ptotics of the bilocal correlator of densities of the vortex loops. Those tum out to be exponentials, decreasing at the inverse $m$ ass of the dual vector boson, tim es certain polynom ials in the inverse integer pow ers of the distance. This result agrees w ith the general predictions and the existing lattioe data better than the results of previous calculations, where these powers were found to be half-integer ones.

[^0] one of the $m$ ost successful nonperturbative approaches to $Q C D . H$ ow ever, an im portant problem still requiring its clari cation is the derivation of the bilocal eld strength correlator, which is the $m$ ain quantity in SVM, from the QCD Lagrangian. To sim plify this problem it is natural to consider such a correlator in A belian-type $m$ odels, which allow for the analytical description of con nem ent. In this way, in the recent paper'[ ${ }_{-1}$ ] $]$, the bilocal correlator has been calculated in the e ective A belian-projected $\left.{ }_{[1]}^{[1]}\right] S U(2)$-and SU (3)-theories. Those are just the 4D dualG inzburgLandau\{type theories, in which con nem ent is realized as the dual M eissner e ect according to the 't H ooft M andelstam scenario [E] ]. The m ain di erence of the calculation perform ed in R ef. [6] w r.r.t. the pure classical calculations perform ed before [G]] was the account for quantum vortex loops present in the above-m entioned theories. Being virtual (and therefore sm all-sized) ob jects, these loops have been treated w ithin the natural, from the point of view of the standard superconductivity $\left[\begin{array}{l}\bar{\lambda}\end{array}\right], \mathrm{m}$ odel in which they form a dilute gas $[\overline{\overline{8}}]$.

The aim of the present Letter is to im prove on the calculation perform ed in Ref. ${ }_{1+1]}^{[3}$ and to nd the bilocal eld strength correlator w ithout any assum ptions im posed on the ensem ble of vortex loops. Such a m odel-independent study $m$ ay becom e possible by virtue of the lattice data on the
 the above-m entioned com $m$ only accepted belief that con nem ent can really be view ed as the dual superconductivity. C learly, it is this statem ent whid enables one to em ploy the lattice results on the SVM correlator in QCD for the evaluation of an analogous quantity in the dual G inzburgLandau\{type theories. In this respect, it is worth noting that recently a new support was given to the 't H ooft M andelstam scenario of con nem ent (and consequently to the dual Abelian-type $m$ odels) by the evidence ofm onopole condensation on the lattice

In what follow $S$, we shall carry out our analysis for the simplest SU (2)-case, although the generalization to the SU (3)-case along w th the lines of Ref. [3i-1] is straightforw ard. W thin the so-called A belian dom inance hypothesis [i] irrelevant to con nem ent, the e ective $\mathbb{R}$ theory under study can be shown (see e.g.' $\left.{ }^{-1}[]^{-1} 6\right]$ ) to be nothing else, but the dual Abelian $H$ iggs $m$ odel w ith extemal electrically charged particles (quarks). In the London $\lim$ it, i.e. the $\lim$ it when the $m$ ass of the dualH iggs eld is $m$ uch larger than the $m$ ass of the dual vector boson, the respective action reads

W ithin the SVM, the (irreducible) bilocal eld strength correlator can be param etrized by the two coe cient functions, $D\left(x^{2}\right)$ and $D_{1}\left(x^{2}\right)$, as follow $s$ :

 just the standard $G$ aussian average over free diagonalgluons, whereas $h:: \mathrm{i}_{\mathrm{j} m}$ is a certain average over tra jectories ofm onopole C ooper pairs the coupling of the dual eld B to the currents ofC ooper pairs $\mathrm{j}^{\mathrm{m}}$ 's, which yields nonperturbative contents of the functions $D$ and $D_{1}$ in the $m$ odel under study.

Here, $\left.D_{m}(x) \quad \frac{m}{4^{2} \dot{x}_{j}} K_{1}(m \dot{X}\rangle\right)$ is the propagator of the dualvectorboson ofthem assm, $m=2 g_{m}$, $K$ 's henceforth stand for the m odi ed Bessel functions, and $G\left(x^{2}\right) \int_{x^{2}}^{+R^{2}} d t D_{1}(t)$. Finally, in
 of the vortex loops, $h$ ( $x$ ) (y)i (w ith the average taken over the ensem ble of these loops), as
 is unam biguously xed by the condition of closeness of the vortex loops, $@=0$, the form of the function $g(x)$ depends on the properties of the ensem ble of these ob jects. ? (In particular, in Ref. ${ }_{-1}^{-1}$, this function has been found in the fram ew ork of a dihute gas model for the ensemble of vortex loops.) A s we shall see below, the $\mathbb{R}$ asym ptotics of the function $g(x)$ can be found w thout any m odel assum ptions, but rather on the basis of the statem ent that the respective asym ptotics of the $D$ - and $D_{1}$-functions have the same fall 0 , as it is suggested by the lattice

D i erentiating Eq. ' ${ }^{\prime}(\bar{\beta})$ w.r.t. $x^{2}$, one can com pletely elim inate the $g(x)$-dependence from the resulting system of equations without solving them w.r.t. this function. T his yields the follow ing relation betw een $D$ and $D_{1}$, which is thus independent of the properties of the ensem ble of vortex loops:

By im posing som e relation on the $\mathbb{R}$ asym ptotics $D^{\text {as }}$ and $D_{1}^{\text {as }}$ of the functions $D$ and $D_{1}$, one can em ploy Eq. ( $\bar{\eta}_{1}$ ) in order to nd these asym ptotics explicitly. The sim plest relation of this kind can be im posed by disregarding the perturbative-type contributions to $D^{\text {as }}$ and $D_{1}^{\text {as }}$, which yields

Thus we see that the lattioe-inspired suggestion that the $\mathbb{R}$ asym ptotic behaviours ofboth functions $D$ and $D_{1}$ are proportional to each other yields for those the exponential fallo at the inverse $m$ ass of the dual vector boson tim es som e polynom ial in the inverse integer pow ers of the distance. Such a preexponential behaviour di ers from that of the classical calculation [ब़్] and the one which was obtained in the dilute gas model of the ensem ble of vortex loops 鲉]. Indeed, in that cases the preexponentials were half-integer inverse powers of the distance, which is less favourable from the point of view of the lattioe data ${ }_{6} \overline{9}, 10$

Let us now investigate the stability of the obtained solution ( $1 \mathbf{1} 0 \overline{1}$ ) w .r.t. som e possible pow er-like corrections. N am ely, let us insert into Eq. ( $\overline{-1})$ ) the follow ing m odi ed A nsatz:

This equation is straightforw ard to be integrated, and the resulting integral can be evaluated in the large- lim it by virtue of the know $n$ asym ptotics for the probability integral $[\underline{10} 9]: p^{2}={ }_{0}^{R} d t e{ }^{E}$ ! $1 p^{1}=\frac{e^{x^{2}}}{x}$ at $x \quad$. In thisway, we obtain $D_{1}^{\text {as (1) }}=D_{1}^{\text {as (0) }}$, and thus nally $D_{1}^{\text {as }}=B(1 \quad$ ")e. W e conclude that while " 1, i.e. for sm all enough , nam ely (ln ${ }^{2}$ ) ${ }^{1}$, contributions to the obtained solution ( $\overline{1} \overline{\mathrm{O}})$ ) stem m ing from the power-like correction ( $\overline{1} \overline{1} \overline{1})$ ) are $s m$ all, and thus this solution is stable.

It is also worth $m$ aking the follow ing com $m$ ent. In previous calculations, the functions $D\left(x^{2}\right)$ and $G\left(x^{2}\right)$ were obviously proportional to som e propagators. For exam ple, in the classical approxim ation those were just $D_{m}$ [see the rst term $s$ on the R H S.'s of Eqs. ${ }_{(1)}^{(1)} 1$ this fact is not valid any more in the present approach. W hile this statem ent is obvious for the D -function whose $\mathbb{R}$ asym ptotics is given by Eq. (1̄ $\overline{\mathrm{q}})$, som e com m ent is in order for the function $G\left(x^{2}\right)$. N am ely, we should check that the leading term in the $\mathbb{R}$ asym ptotics of this function di ers from the respective asym ptotics of any propagator. In this way, we have
which explicitly proves our statem ent $t_{1}^{t_{1}}$. The fact that in the present approach the functions $D$ and $G$ are not proportional to any ( $m$ assive) propagator $m$ akes it closer to QCD than the previous ones. Indeed, would such a proportionality takes place in $Q C D$, it $m$ ight be suspicious of the appearance of an asym ptotic state carrying colour in som e processes involving the bilocal eld strength correlator.

A nother com $m$ ent which is in order concems the com parison of the preexponent in Eq. ( $\overline{1} \overline{0}$ ) w th the respective value know $n$ from the lattioe $m$ easurem ents. In this way, we im $m$ ediately face the follow ing problem. N am ely, in our calculation we em ployed the assum ption that $\mathrm{D}^{\text {as }} \mathrm{D}_{1}^{\text {as }}$
 $w$ thin the interval of distances betw een 0.4 fm and 1 fm , which corresponds to the values of in

[^3]the range betw een 1.8 and 4.6. H ow ever, it is straightforw ard to see that the ${ }^{1}$-term on the R H S. of Eq. ( $\overline{1}-1 \overline{-1}$ ) becom es sm aller than $C$ only for $5: 3$. This $m$ eans that the assum ption on the proportionality ofD as and $\mathrm{D}_{1}^{\text {as }}$, which led to Eq. ( $\left.1 \overline{1} \overline{-}\right)$, should be extended to the distances exceeding those which were used up to now in the lattice $m$ easurem ents. Thus, since these $m$ easurem ents yield the preexponential factor at the distances where the next-to-constant term s on the R H S. of Eq. ( $\overline{1} \overline{\mathrm{I}})$ are im portant, the only way to get this factor within our approach is to integrate num erically the exact (rather than the asym ptotic) equation for the function $D$ down to that distances. Such an equation is given by the form ula ( $\overline{\underline{Q}}$ ) w ith the asym ptotic function $F$ replaced by the exact one:

By virtue of the M ATHEMATICA program, one gets for the quantity $D\left({ }^{2}\right) e=m^{4}$ at $\dot{x} j=0: 4 \mathrm{fm}$ the value 0.03 , which di ers in one order from the lattice result'[1] $\overline{1}]$ equal to 0.32 (3). C lari cation of the origin of this num erical discrepancy requires m ore precise investigations, which will be perform ed in fiuture publications.

F inally, by virtue of the obtained results it is also possible to derive the $\mathbb{R}$ asym ptotics of the bilocal correlator of densities of the vortex loops, i.e. the function $g(x)$. To this end, let us apply the operator ( $@^{2} \mathrm{~m}^{2}$ ) to both sides of Eq. ( $(\bar{\sigma})$ ) di erentiated w.r.t. $\mathrm{x}^{2}$, which yields

This $\mathbb{R}$ behaviour of the function $g(x)$ di ers from the one obtained in Ref.' $\left[\begin{array}{l}{[\beta]} \\ \hline\end{array}\right]$ with in the dilute gas model for the ensemble of vortex loops. In particular, the obtained expression does not contain the asym ptotics of the $m$ assless propagator, which in that case was the origin of a novel nonperturbative $1=\dot{x} \tilde{J}^{4}$-term in the $D_{1}$-fiunction. In fact, this term in the function $D_{1}$ is now absent, which could be anticipated beforehand ow ing to the equation $D_{1}^{\text {as }}=D{ }^{\text {as }}$. C learly, due to this equation, if such a term was present in the function $D_{1}$, it would unavoidably appear in the
 which state that the nonperturbative part of the function $D$ cannot contain any $1=\frac{j}{x} \mathcal{J}^{4}$-term.

In conclusion of the present Letter, on the basis of the 't H ooft -M andelstam scenario of connem ent which suggests that the dual Abelian $H$ iggs $m$ odel is relevant to the description of con nem ent in the SU (2)-QCD ] and the lattice result on the bilocal eld strength correlator in QCD (which states that the $\mathbb{R}$ asym ptotic behaviours of the two coe cient functions param etrizing this correlator in SVM have the sam e exponential form ), we have derived the $\mathbb{R}$ asym ptotics of this quantity in the London lim it of the dual Abelian $H$ iggs model. In this way, the dem and of correspondence w ith the above-m entioned lattice result enabled not to em ploy any particular m odel of the ensemble of vortex loops, present in the theory under study. It rather occurred
that the proposed approach yielded as a by-product the bilocal correlator of densities of the vortex loops itself. As far as the eld strength correlator is concemed, it tumed out to decrease exponentially at the inverse $m$ ass of the dual vector boson $w$ ith the preexponential given by a certain polynom ial in the inverse powers of the distanc. These pow ers were found to be integer ones, which is in the better agreem ent w ith the existing lattice data than the half-integer pow ers found in the previous calculations. B esides that, the obtained leading term $s$ in the $\mathbb{R}$ asym ptotic behaviours of the functions describing the surface and contour exchanges by $m$ eans of the bilocal eld strength correlator have been found to be di erent from that of the m assive propagator. T his result is $m$ ore favourable from the point of view of QCD than the opposite one obtained in the previous approaches.
